## **SENATE BILL NO. 949**

AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the Senate Committee on Rules

on February 2, 2007)

(Patron Prior to Substitute—Senator Quayle)

5 6 A BILL to amend and reenact § 2.2-2101, as it is currently effective and as it shall become effective, of 7 the Code of Virginia and to amend the Code of Virginia by adding in Chapter 25 of Title 2.2 an 8 article numbered 8 consisting of sections numbered 2.2-2530 through 2.2-2534, relating to the 9 Virginia Commission on Incarceration and Reentry.

10 Be it enacted by the General Assembly of Virginia:

1. That § 2.2-2101, as it is currently effective and as it shall become effective, of the Code of 11 Virginia is amended and reenacted and that the Code of Virginia is amended by adding in 12 Chapter 25 of Title 2.2 an article numbered 8 consisting of sections numbered 2.2-2530 through 13 2.2-2534 as follows: 14

15 § 2.2-2101. (Effective until July 1, 2008) Prohibition against service by legislators on boards, 16 commissions, and councils within the executive branch; exceptions.

17 Members of the General Assembly shall be ineligible to serve on boards, commissions, and councils within the executive branch of state government who are responsible for administering programs 18 established by the General Assembly. Such prohibition shall not extend to boards, commissions, and 19 20 councils engaged solely in policy studies or commemorative activities. If any law directs the 21 appointment of any member of the General Assembly to a board, commission, or council in the 22 executive branch of state government that is responsible for administering programs established by the 23 General Assembly, such portion of such law shall be void, and the Governor shall appoint another 24 person from the Commonwealth at large to fill such a position.

51 § 2.2-2101. (Effective July 1, 2008) Prohibition against service by legislators on boards, commissions, and councils within the executive branch; exceptions. 52

53 Members of the General Assembly shall be ineligible to serve on boards, commissions, and councils 54 within the executive branch of state government who are responsible for administering programs established by the General Assembly. Such prohibition shall not extend to boards, commissions, and 55 councils engaged solely in policy studies or commemorative activities. Commission on Incarceration and Reentry.

§ 2.2-2530. Virginia Commission on Incarceration and Reentry; purpose; membership; terms;
 sompensation; staff.

A. The Virginia Commission on Incarceration and Reentry (the Commission) is established as an advisory commission within the meaning of § 2.2-2100, in the executive branch of state government. The purpose of the Commission shall be to study, report, and make recommendations for dealing with the impact of incarceration and prisoner reentry to society and related policies of the Commonwealth. The Commission may make recommendations to the Secretary of Public Safety and coordinate the proposals of all state agencies as to legislation and policies affecting prisoners in the Commonwealth.

96 B. The Commission shall consist of 20 members that include eight legislative members and 12 97 nonlegislative citizen members as follows: five members of the House of Delegates appointed by the 98 Speaker of the House in accordance with the principles of proportional representation contained in the 99 Rules of the House of Delegates; three members of the Senate appointed by the Senate Committee on 100 Rules; 12 nonlegislative citizen members appointed by the Governor that include one resident of the 101 Commonwealth with an immediate family member who is incarcerated, a resident of the Commonwealth 102 who has previously been incarcerated, a representative of a community organization with a program for previously incarcerated individuals, a health care provider, a licensed educator, a representative of an 103 104 organization for correctional officers, a representative of an organization for minorities, and an active 105 or retired law-enforcement officer.

106 C. After the initial staggering of terms, nonlegislative citizen members shall be appointed for terms 107 of four years. Legislative members shall serve terms coincident with their terms of office. All members 108 may be reappointed. However, no House member shall serve more than four consecutive two-year terms, 109 no Senate member shall serve more than two consecutive four-year terms, and no nonlegislative citizen 110 member shall serve more than two consecutive four-year terms. Vacancies occurring other than by 111 expiration of a term shall be filled for the unexpired term. Vacancies shall be filled in the manner as 112 the original appointments. The remainder of any term to which a member is appointed to fill a vacancy 113 shall not constitute a term in determining the member's eligibility for reappointment.

D. The members of the Commission shall elect a chairman and a vice-chairman from among its
members. The Commission shall meet at the request of the chairman, the majority of the voting
members, or the Governor. A majority of the members of the Commission shall constitute a quorum.

E. Legislative members of the Commission shall receive such compensation as provided in \$30-19.12, and nonlegislative citizen members shall receive such compensation for the performance of their duties as provided in \$2.2-2813. All members shall be reimbursed for all reasonable and necessary expenses incurred in the performance of their duties as provided in \$\$2.2-2813. 123 § 2.2-2531. Powers and duties of the Commission. 124

The Commission shall have the power and duty to:

125 1. Identify and develop strategies to (i) address key needs and overcome the barriers for offenders, 126 both prior to and upon leaving prison, (ii) reduce the incidence of reincarceration and increase the 127 successful social adaptation and integration of such individuals into the community, and (iii) address the 128 effects of incarceration on children, families, communities, and the economy;

129 2. Gather and analyze information and data to accomplish its purposes as set forth in § 2.2-2530;

3. Monitor budget provisions and changes in the law to ensure maximum effectiveness;

131 4. Monitor prosecutorial practices and identify the extent to which racial and ethnic disparity can be 132 reduced in the criminal justice system; and

133 5. Provide recommendations to the appropriate executive branch agency regarding the operations, 134 management, jurisdiction, powers, and interrelationships of any department, board, bureau, commission, 135 authority, or other agency with any direct responsibility for setting policy and managing services for 136 incarcerated individuals in the Commonwealth.

§ 2.2-2532. Staff; cooperation and assistance. 137

138 The Secretary of Public Safety shall provide staff assistance to the Commission. All agencies, 139 authorities, and institutions of the Commonwealth shall cooperate and provide such assistance to the 140 *Commission as the Commission may request.* 

141 § 2.2-2533. Chairman's executive summary of activity and work of the Commission.

142 The chairman of the Commission shall submit to the Governor and the General Assembly an annual 143 executive summary of the interim activity and work of the Commission no later than the first day of 144 each regular session of the General Assembly. The executive summary shall be submitted for publication 145 as a report document as provided in the procedures of the Division of Legislative Automated Systems 146 for the processing of legislative documents and reports and shall be posted on the General Assembly's 147 website. The Commission may make such interim reports to the Governor and the General Assembly as

148 it deems advisable.

150 This chapter shall expire on July 1, 2010.

151 2. That the initial appointments of nonlegislative citizen members in accordance with this act shall

152 be staggered as follows: four members shall be appointed for a two-year term, four members shall

153 be appointed for a three-year term, and four members shall be appointed for a four-year term.
