VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact § 2.2-306 of the Code of Virginia, relating to the Secure Commonwealth 3 Panel; membership.

Be it enacted by the General Assembly of Virginia: 6

7 1. That § 2.2-306 of the Code of Virginia is amended and reenacted as follows: 8

§ 2.2-306. Secure Commonwealth Panel; membership; duties; compensation; staff.

9 A. The Secure Commonwealth Panel (the Panel), is established as an advisory board, within the 10 meaning of § 2.2-2100, in the executive branch of state government. The Panel shall consist of 29 30 members as follows: three members of the House of Delegates and two nonlegislative citizens to be 11 12 appointed by the Speaker of the House of Delegates; three members of the Senate of Virginia and two nonlegislative citizens to be appointed by the Senate Committee on Rules; the Lieutenant Governor;, the 13 Attorney General;, the Executive Secretary of the Supreme Court of Virginia, the Assistant to the 14 15 Governor for Commonwealth Preparedness, the Secretaries Secretary of Commerce and Trade, the Secretary of Health and Human Resources, the Secretary of Public Safety, the Secretary of Technology 16 and the Secretary of Transportation or their designees; two local first responders; three local government 17 18 representatives; two physicians with knowledge of public health; and four additional members from the private sector. Except for appointments made by the Speaker of the House of Delegates and the Senate 19 20 Committee on Rules, all other appointments shall be made by the Governor. Additional ex officio 21 members may be appointed to the Panel by the Governor at his discretion. Legislative members shall 22 serve terms coincident with their terms of office or until their successors shall qualify. Nonlegislative 23 citizen members shall serve for terms of four years. The Assistant to the Governor of the Office shall be 24 the chairman of the Panel.

25 B. The Panel shall monitor and assess the implementation of statewide prevention, preparedness, 26 response, and recovery initiatives and where necessary to review, evaluate, and make recommendations 27 relating to the emergency preparedness of government at all levels in the Commonwealth. Additionally, the Panel shall facilitate cabinet-level coordination among the various agencies of state government 28 29 related to emergency preparedness and shall facilitate private sector preparedness and communication. 30 The Panel shall make quarterly reports to the Governor concerning the state's emergency preparedness, 31 response, recovery, and prevention efforts.

32 C. Members of the Panel shall serve without compensation but shall be reimbursed for all reasonable 33 and necessary expenses incurred in the discharge of their duties as provided in § 2.2-2825.

34 D. Staff support for the Panel and funding for the costs of expenses of the members shall be 35 provided by the Office of Commonwealth Preparedness.
