AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the Senate Committee on Rules on February 2, 2007)

(Patron Prior to Substitute—Senator Deeds)

234567 A BILL to amend and reenact § 2.2-306 of the Code of Virginia, relating to the Secure Commonwealth

Panel; membership.

Be it enacted by the General Assembly of Virginia:

9 1. That § 2.2-306 of the Code of Virginia is amended and reenacted as follows:

10 § 2.2-306. Secure Commonwealth Panel; membership; duties; compensation; staff.

A. The Secure Commonwealth Panel (the Panel), is established as an advisory board, within the 11 12 meaning of § 2.2-2100, in the executive branch of state government. The Panel shall consist of 29 30 members as follows: three members of the House of Delegates and two nonlegislative citizens to be 13 appointed by the Speaker of the House of Delegates; three members of the Senate of Virginia and two 14 15 nonlegislative citizens to be appointed by the Senate Committee on Rules; the Lieutenant Governor;, the 16 Attorney General;, the Executive Secretary of the Supreme Court of Virginia, the Assistant to the Governor for Commonwealth Preparedness, the SecretariesSecretary of Commerce and Trade, the 17 18 Secretary of Health and Human Resources, the Secretary of Public Safety, the Secretary of Technology and the Secretary of Transportation or their designees; two local first responders; three local government 19 20 representatives; two physicians with knowledge of public health; and four additional members from the private sector. Except for appointments made by the Speaker of the House of Delegates and the Senate 21 Committee on Rules, all other appointments shall be made by the Governor. Additional ex officio 22 23 members may be appointed to the Panel by the Governor at his discretion. Legislative members shall 24 serve terms coincident with their terms of office or until their successors shall qualify. Nonlegislative 25 citizen members shall serve for terms of four years. The Assistant to the Governor of the Office shall be 26 the chairman of the Panel.

27 B. The Panel shall monitor and assess the implementation of statewide prevention, preparedness, 28 response, and recovery initiatives and where necessary to review, evaluate, and make recommendations 29 relating to the emergency preparedness of government at all levels in the Commonwealth. Additionally, 30 the Panel shall facilitate cabinet-level coordination among the various agencies of state government related to emergency preparedness and shall facilitate private sector preparedness and communication. 31 32 The Panel shall make quarterly reports to the Governor concerning the state's emergency preparedness, 33 response, recovery, and prevention efforts. 34

C. Members of the Panel shall serve without compensation but shall be reimbursed for all reasonable 35 and necessary expenses incurred in the discharge of their duties as provided in § 2.2-2825.

36 D. Staff support for the Panel and funding for the costs of expenses of the members shall be 37 provided by the Office of Commonwealth Preparedness.
