4. Title License plates for antique motor vehicles and antique trailers; penalties.
5. Summary/Purpose: License plates for antique motor vehicles and antique trailers; penalties. Restricts issuance of antique plates to persons who own or use another vehicle; increases the one-time $\$ 10$ fee to a one-time $\$ 50$ fee; corrects the dates for metal tabs; limits issuance of vintage plates with the same numbers to first-time applicants; prohibits commercial use of antique vehicles and antique trailers; limits use of these vehicles to carrying or transporting passengers, personal effects or other antique motor vehicles being transported for show purposes but allows vehicles to be used for general transportation purposes, subject to certain existing requirements; requires certification from owner that vehicle meets safety equipment requirements for model year in which the vehicle was manufactured and that it is capable of being safely operated on the highways; establishes a Class 3 misdemeanor penalty for violations of this act and requires the Department of Motor Vehicles to revoke and not reinstate the owner's privilege to register the vehicle with antique license plates for a period of five years; except for the onetime $\$ 50$ issuance fee, extends the compliance date to January 1, 2008, for those issued antique plates prior to July 1, 2007.

8. Fiscal implications: Beginning in $\mathrm{FY}^{\prime} 08$, net revenues associated with the proposed onetime $\$ 50$ registration fee are estimated to increase from approximately $\$ 750,000$ to approximately $\$ 929,000$ in $F Y$ ' 13 . In FY '06, new antique license plate registrations were estimated at about 25,000 . Costs associated with new antique license plate registrations are estimated at $\$ 11.72$ per transaction. There were approximately 109,000 active antique
license plate registrations as of July 1, 2006. Estimated net revenues are based on an estimated increase in antique license plate registrations of 4.4 percent each year. Fiscal impacts, if any, on law enforcement and the courts are not known.
