10	Be it enacted by the General Assembly of Virginia:
11 12	1. That § 23-9.2:3 of the Code of Virginia is amended and reenacted as follows:
12	§ 23-9.2:3. Power of governing body of educational institution to establish rules and regulations; offenses occurring on property of institution; state direct student financial assistance.
13 14	A. In addition to the powers now enjoyed by it, the board of visitors or other governing body of
15	every educational institution shall have the power:
16	1. To establish rules and regulations for the acceptance and assistance of students except that (i)
17	individuals who have failed to meet the federal requirement to register for the selective service shall not
18	be eligible to receive any state direct student assistance; (ii) the accreditation status of a Virginia public
19	high school shall not be considered in making admissions determinations for students who have earned a
20	diploma pursuant to the requirements established by the Board of Education; and (iii) the governing
21	boards of the four-year institutions shall establish policies providing for the admission of certain
22	graduates of Virginia community colleges as set forth in § 23-9.2:3.02.
23	2. To establish rules and regulations for the conduct of students while attending such institution.
24	3. To establish programs, in cooperation with the State Council of Higher Education and the Office
25	of the Attorney General, to promote compliance among students with the Commonwealth's laws relating
26	to the use of alcoholic beverages.
27	4. To establish rules and regulations for the rescission or restriction of financial aid, within the
28 29	discretionary authority provided to the institution by federal or state law and regulations, and the suspension and dismissal of students who fail or refuse to abide by such rules and regulations for the
30	conduct of students.
31	5. To establish rules and regulations for the employment of professors, teachers, instructors and all
32	other employees and provide for their dismissal for failure to abide by such rules and regulations.
33	6. To provide parking and traffic rules and regulations on property owned by such institution.
34	7. To establish guidelines for the initiation or induction into any social fraternity or sorority in
35	accordance with § 18.2-56.
36	8. To establish programs, in cooperation with the State Council of Higher Education for Virginia and
37	the Office of the Attorney General, to promote the awareness and prevention of sexual crimes
38	committed upon students.
39	B. Upon receipt of an appropriate resolution of the board of visitors or other governing body of an
40	educational institution, the governing body of a political subdivision which is contiguous to the
41 42	institution shall enforce state statutes and local ordinances with respect to offenses occurring on the
4 <u>4</u>	property of the institution. The governing bodies of the public institutions of higher education shall assist the State Council of
4 3 4 4	Higher Education in enforcing the provisions related to eligibility for financial aid.
45	C. In order to improve the quality of the Commonwealth's work force and educational programs, the
46	governing bodies of the public institutions of higher education shall establish programs to seek to ensure
47	that all graduates have the technology skills necessary to compete in the 21st Century and, particularly,
48	that all students matriculating in teacher-training programs receive instruction in the effective use of
49	educational technology.
50	D. The board of visitors or other governing body of any public institution of higher education in the
51	Commonwealth shall provide for the automatic acceptance of students applying for admission who (i)
52	are domiciled residents of Virginia as defined by § 23-7.4; (ii) have graduated from a public or private
53	high school in Virginia with a grade point average in the top 10 percent of such student's graduating
54 55	class; and (iii) have completed 320 hours of community service in a program approved by the Secretary
55	of Education, in the year preceding the academic year for which the student is seeking admission.
