11	1. That §§ 46.2-419 and 46.2-472 of the Code of Virginia are amended and reenacted as follows:
12	§ 46.2-419. When judgment satisfied.
13	A. Every judgment for damages in any motor vehicle accident referred to in this chapter shall, for
14	the purpose of this chapter, be satisfied:
15	1. When paid in full or when $\frac{25,000}{50,000}$ has been credited upon any judgment or judgments
16	rendered in excess of that amount because of bodily injury to or death of one person as the result of any
17 18	one accident; 2 When subject to the limit of \$25,000 because of bodily injury to or death of one person the
19	2. When, subject to the limit of \$25,000 because of bodily injury to or death of one person, the judgment has been paid in full or when the sum of \$50,000 has been credited upon any judgment or
20	judgments rendered in excess of that amount because of bodily injury to or death of two or more
21	persons as the result of any one accident;
22	3 2. When the judgment has been paid in full or when \$20,000 has been credited upon any judgment
23	or judgments rendered in excess of that amount because of injury to or destruction of property of others
24	as a result of any one accident; or
25	4 3. When the judgment has been discharged in bankruptcy.
26	B. Payments made in settlement of any claims because of bodily injury, death or property damage
27	arising from a motor vehicle accident shall be credited in reduction of the amount provided in this
28	section.
29	§ 46.2-472. Coverage of owner's policy.
30	Every motor vehicle owner's policy shall:
31 32	1. Designate by explicit description or by appropriate reference, all motor vehicles with respect to which coverage is intended to be granted
32 33	which coverage is intended to be granted. 2. Insure as insured the person named and any other person using or responsible for the use of the
33 34	motor vehicle or motor vehicles with the permission of the named insured.
35	3. Insure the insured or other person against loss from any liability imposed by law for damages,
36	including damages for care and loss of services, because of bodily injury to or death of any person, and
37	injury to or destruction of property caused by accident and arising out of the ownership, use, or
38	operation of such motor vehicles or motor vehicles within the Commonwealth, any other state in the
39	United States, or Canada, subject to a limit exclusive of interest and costs, with respect to each motor
40	vehicle, of \$25,000 \$50,000 because of bodily injury to or death of one person in any one accident and,
41	subject to the limit for one person, to a limit of \$50,000 because of bodily injury to or death of two or
42	more persons in any one accident, and to a limit of \$20,000 because of injury to or destruction of
43	property of others in any one accident.
