

## 1 VIRGINIA ACTS OF ASSEMBLY — CHAPTER

2 *An Act to amend and reenact § 22.1-209.2 of the Code of Virginia, relating to Board supervision of*  
3 *programs for school-age children in certain hospitals.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 22.1-209.2 of the Code of Virginia is amended and reenacted as follows:**

8 § 22.1-209.2. Programs and teachers in regional detention homes, certain local detention homes and  
9 state agencies and institutions.

10 The Board of Education shall prepare and supervise the implementation in the regional detention  
11 homes and those local detention homes having teachers whose salaries were being funded by the  
12 Commonwealth on January 1, 1984, a program designed to educate and train the children detained in the  
13 homes. In addition, the Board shall supervise those programs of evaluation, education and training  
14 provided to school-age children by the Department of Health, the Department of Mental Health, Mental  
15 Retardation and Substance Abuse Services, the children's teaching hospital associated with the Eastern  
16 Virginia Medical School, the Virginia Commonwealth University Health System Authority, *the children's*  
17 *teaching hospital associated with the Virginia Commonwealth University Health System Authority*, and  
18 the University of Virginia Hospitals pursuant to the Board's standards and regulations as required by  
19 § 22.1-7.

20 The Board shall promulgate such rules and regulations as may be necessary to conform these  
21 programs with the applicable federal and state laws and regulations including, but not limited to,  
22 teacher/student ratios and special education requirements for children with disabilities. The education  
23 programs in the relevant detention homes and state agencies and institutions shall be approved by the  
24 Board and the Board shall prepare a budget for these educational programs which shall be solely  
25 supported by such general funds as are appropriated by the General Assembly for this purpose. Teacher  
26 staffing ratios for regional or local detention homes shall be based on a ratio of one teacher for every  
27 twelve beds based on the capacity of the facility; however, if the previous year's average daily  
28 attendance exceeds this bed capacity, the ratio shall be based on the average daily attendance at the  
29 facility as calculated by the Department of Education from the previous school year.

30 The Board of Education shall enter into contracts with the relevant state agency or institution or  
31 detention facility or the local school divisions in which the state agencies or institutions or the regional  
32 detention homes and the relevant local detention homes are located for the hiring and supervision of  
33 teachers.

34 In any case in which the Board enters into a contract with the relevant state agency or institution, the  
35 Department of Human Resource Management shall establish salary schedules for the teachers which are  
36 competitive with those in effect for the school divisions in which the agency or institution is located.

37 **2. That an emergency exists and this act is in force from its passage.**
