6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 16.1-341 of the Code of Virginia is amended and reenacted as follows:**

8 § 16.1-341. Involuntary commitment; petition; hearing scheduled; notice and appointment of counsel.

9 A. A petition for the involuntary commitment of a minor may be filed with the juvenile and
10 domestic relations district court serving the jurisdiction in which the minor is located by a parent or, if
11 the parent is not available or is unable or unwilling to file a petition, by any responsible adult, including
12 the person having custody over a minor in detention or shelter care pursuant to an order of a juvenile
13 and domestic relations district court. The petition shall include the name and address of the petitioner
14 and the minor and shall set forth in specific terms why the petitioner believes the minor meets the
15 criteria for involuntary commitment specified in § 16.1-345. The petition shall be taken under oath.

16 If a commitment hearing has been scheduled pursuant to subdivision 3 of subsection C of § 16.1-339,
17 the petition for judicial approval filed by the facility under subsection C of § 16.1-339 shall serve as the
18 petition for involuntary commitment as long as such petition complies in substance with the provisions
19 of this subsection.

20 B. Upon the filing of a petition for involuntary commitment of a minor, the juvenile and domestic
21 relations district court serving the jurisdiction in which the minor is located may schedule a hearing
22 which shall occur no sooner than 24 hours and no later than 72 hours from the time the petition was
23 filed. If the 72-hour period expires on a Saturday, Sunday, legal holiday or day on which the court is
24 lawfully closed, the 72 hours shall be extended to the next day that is not a Saturday, Sunday, legal
25 holiday or day on which the court is lawfully closed. The attorney for the minor, the attorney for the
26 Commonwealth in the jurisdiction giving rise to the detention, and the juvenile and domestic relations
27 district court having jurisdiction over any minor in detention or shelter care shall be given notice prior
28 to the hearing.

29 If the petition is not dismissed *or withdrawn*, copies of the petition, together with a notice of the
30 hearing, shall be served immediately upon the minor and the minor's parents, if they are not petitioners.
31 No later than 24 hours before the hearing, the court shall appoint counsel to represent the minor, unless
32 it has determined that the minor has retained counsel. Upon the request of the minor's counsel, for good
33 cause shown, and after notice to the petitioner and all other persons receiving notice of the hearing, the
34 court may continue the hearing once for a period not to exceed 72 hours.

35 Any recommendation made by a state mental health facility or state hospital regarding the minor's
36 involuntary commitment may be admissible during the course of the hearing.
