12	Be it enacted by the General Assembly of Virginia:
13	1. That § 2 of the second enactment of Chapter 852 and § 6 of the first enactment of Chapter 918
14	of Acts of Assembly of 2006 are amended and reenacted as follows:
15	§ 2 Special license plates for immediate family members of persons who have died in military
16 17	service to their country; fees. The Commissioner of the Department of Motor Vehicles shall issue special license plates, as
18	prescribed herein, on receipt of an application and written evidence that the applicant is the owner of a
19	motor vehicle and is a member of the immediate family of a member of the armed forces of the United
20	States who lost his or her life under any of the following conditions:
21	1. During World War I, World War II, or any subsequent period of armed hostilities in which the
22 23	United States was engaged before July 1, 1958;
23 24	<ul><li>2. Anytime after June 30, 1958:</li><li>a. While engaged in an action against an enemy of the United States;</li></ul>
25	b. While engaged in military operations involving conflict with an opposing foreign force;
