Patron-Loupassi 7 8 Referred to Committee on Counties, Cities and Towns 9 10 Be it enacted by the General Assembly of Virginia: 1. That § 15.2-5113 of the Code of Virginia is amended and reenacted as follows: 11 § 15.2-5113. Members of authority board; chief administrative or executive officer. 12 13 A. The powers of each authority created by the governing body of a single locality shall be exercised 14 by an authority board of not less than five nor more than seven members, or at the option of the board 15 of supervisors of a county, a number of board members equal to the number of members of the board of supervisors. The powers of each authority created by the governing bodies of two or more localities 16 shall be exercised by the number of authority board members specified in its articles of incorporation, 17 which shall be not less than one member from each participating locality and not less than a total of 18 five members. The board members of an authority shall be selected in the manner and for the terms 19 20 provided by the agreement or ordinance or resolution or concurrent ordinances or resolutions creating 21 the authority. One or more members of the governing body of a locality may be appointed board 22 members of the authority, the provisions of any other law to the contrary notwithstanding. No board 23 member shall be appointed for a term of more than four years. When one or more additional political 24 subdivisions join an existing authority, each of such joining political subdivisions shall have at least one 25 member on the board. Board members shall hold office until their successors have been appointed and may succeed themselves. The board members of the authority shall elect one of their number chairman, 26 27 and shall elect a secretary and treasurer who need not be members. The offices of secretary and 28 treasurer may be combined. 29 B. A majority of board members shall constitute a quorum and the vote of a majority of board 30 members shall be necessary for any action taken by the authority. An authority may, by bylaw, provide 31 a method to resolve tie votes or deadlocked issues. C. No vacancy in the board membership of the authority shall impair the right of a quorum to 32 33 exercise all the rights and perform all the duties of the authority. If a vacancy occurs by reason of the 34 death, disqualification or resignation of a board member, the governing body of the political subdivision 35 which appointed the authority board member shall appoint a successor to fill the unexpired term. 36 Whenever a political subdivision withdraws its membership from an authority, the term of any board 37 member appointed to the board of the authority from such political subdivision shall immediately 38 terminate. Board members shall receive such compensation as fixed by resolution of the governing body 39 or bodies which are members of the authority, and shall be reimbursed for any actual expenses 40 necessarily incurred in the performance of their duties.

41 D. Alternate board members may also be selected. Such alternates shall be selected in the same manner and shall have the same qualifications as the board members except that an alternate for an 42 elected board member need not be an elected official. The term of each alternate shall be the same as 43 44 the term of the board member for whom each serves as an alternate; however, the alternate's term shall not expire because of the board member's death, disqualification, resignation, or termination of 45 employment with the member's political subdivision. If a board member is not present at a meeting of 46 47 the authority, the alternate for that board member shall have all the voting and other rights of a board 48 member and shall be counted for purposes of determining a quorum.

E. The board members may appoint a chief administrative or executive officer who shall serve at the pleasure of the board members. He shall execute and enforce the orders and resolutions adopted by the board members and perform such duties as may be delegated to him by the board members.
