A BILL to amend and reenact §§ 2.2-2004, 2.2-2452, 2.2-2715, and 2.2-2716 of the Code of Virginia, relating to the veterans services in the Commonwealth.

Be it enacted by the General Assembly of Virginia:

1. That §§ 2.2-2004, 2.2-2452, 2.2-2715, and 2.2-2716 of the Code of Virginia are amended and reenacted as follows:

§ 2.2-2004. Additional powers and duties of Commissioner.

The Commissioner shall have the following powers and duties related to veterans services:

1. Perform cost-benefit and value analysis of (i) existing programs and services, and (ii) new programs and services before establishing and implementing them;

2. Seek alternative funding sources for the Department's veterans service programs;

3. Cooperate with all relevant entities of the federal government, including, but not limited to, the United States Department of Veterans Affairs, the United States Department of Housing and Urban Development, and the United States Department of Labor in matters concerning veterans benefits and services;

4. Appoint a full-time coordinator to collaborate with the Joint Leadership Council of Veteran Service Organizations created in § 2.2-2681 on ways to provide both direct and indirect support of ongoing veterans programs, and to determine and address future veterans needs and concerns;

5. Initiate, conduct, and issue special studies on matters pertaining to veterans needs and priorities, as determined necessary by the Commissioner;

6. Evaluate veterans service efforts, practices, and programs of the agencies, political subdivisions or other entities and organizations of the government of the Commonwealth and make recommendations to the Secretary of Administration ~~Administration~~ Public Safety, the Governor, and the General Assembly on ways to increase awareness of the services available to veterans or improve veterans services;

7. Assist entities of state government and political subdivisions of the Commonwealth in enhancing their efforts to provide services to veterans, including the dissemination of relevant materials and the rendering of technical or other advice;

8. Assist counties, cities, and towns of the Commonwealth in the development, implementation, and review of local veterans services programs as part of the state program and establish as necessary, in consultation with the Board of Veterans Services and the Joint Leadership Council of Veterans Service Organizations, volunteer local and regional advisory committees to assist and support veterans service efforts;

9. Review the activities, roles, and contributions of various entities and organizations to the Commonwealth's veterans services programs and report on or before December 1 of each year in writing to the Governor and General Assembly on the status, progress, and prospects of veterans services in the Commonwealth, including performance measures and outcomes of veterans services programs;

10. Recommend to the Secretary of Administration ~~Administration~~ Public Safety, the Governor, and the General Assembly any corrective measures, policies, procedures, plans, and programs to make service to veterans and their surviving spouses, orphans, and dependents as efficient and effective as practicable;

11. Design, implement, administer, and review special programs or projects needed to promote veterans services in the Commonwealth;

12. Integrate veterans services activities into the framework of economic development activities in general;

13. Manage operational funds using accepted accounting principles and practices in order to provide for a sum sufficient to ensure continued, uninterrupted operations;

14. Engage Department personnel in training and educational activities aimed at enhancing veterans services; and

15. Develop a strategic plan to ensure efficient and effective utilization of resources, programs, and services.

§ 2.2-2452. Board of Veterans Services; membership; terms; quorum; compensation; staff.

A. The Board of Veterans Services (the Board) is established as a policy board, within the meaning of § 2.2-2100, in the executive branch of state government. The Board shall have a total membership of

59 19 members that shall consist of five legislative members, 11 nonlegislative citizen members, and three
60 ex officio members. Members shall be appointed as follows: three members of the House of Delegates
61 to be appointed by the Speaker of the House of Delegates in accordance with the principles of
62 proportional representation contained in the Rules of the House of Delegates; two members of the
63 Senate to be appointed by the Senate Committee on Rules; and 11 nonlegislative citizen members to be
64 appointed by the Governor. The Commissioner of the Department of Veterans Services shall serve ex
65 officio with full voting privileges; and the Chairman of the Board of Trustees of the Veterans Services
66 Foundation and the Chairman of the Joint Leadership Council of Veterans Service Organizations shall
67 serve ex officio without voting privileges. Nonlegislative citizen members of the Board shall be citizens
68 of the Commonwealth.

69 In making appointments, the Governor shall endeavor to ensure a balanced geographical
70 representation on the Board while at the same time selecting appointees of such qualifications and
71 experience as will allow them to provide expertise and insight into:

72 1. Best practices in benefits claims services, medical and health care management, or cemetery
73 operations;

74 2. Performance measurements and general management principles; and

75 3. Nonprofit volunteer operations and management.

76 Each of the three areas of expertise shall be represented on the Board by at least two different
77 appointees per area of expertise in order to allow for the Board to be capable of developing reasonable
78 and effective policy recommendations related to the services provided to veterans of the armed forces of
79 the United States and their Virginia-domiciled surviving spouses, orphans, and dependents by the
80 Department of Veterans Services.

81 Legislative members and the Commissioner of the Department of Veterans Services shall serve terms
82 coincident with their terms of office. After the initial staggering of terms, nonlegislative citizen members
83 shall be appointed for a term of four years. Appointments to fill vacancies, other than by expiration of a
84 term, shall be for the unexpired terms. All members may be reappointed. However, no House member
85 shall serve more than four consecutive two-year terms, no Senate member shall serve more than two
86 consecutive four-year terms, and no nonlegislative citizen member shall serve more than two consecutive
87 four-year terms.

88 The remainder of any term to which a member is appointed to fill a vacancy shall not constitute a
89 term in determining the member's eligibility for reappointment. Vacancies shall be filled in the same
90 manner as the original appointments.

91 B. The Board shall select a chairman from its membership and, pursuant to rules adopted by it, may
92 elect one of its members as vice-chairman. The Commissioner of the Department of Veterans Services
93 shall not be eligible to serve as chairman. The Board shall also elect one of its members as secretary.
94 The Board shall meet at least three times a year at such times as it deems appropriate or on call of the
95 chairman. A majority of the members of the Board shall constitute a quorum.

96 C. The Board shall be organized with at least three ~~subcommittees~~ *standing committees* that shall be
97 responsible for (i) veterans benefits, (ii) veterans care services, and (iii) veterans cemeteries.

98 D. The Department of Veterans Services shall provide staff to the Board.

99 § 2.2-2715. Veterans Services Foundation; purpose; membership; terms; compensation; staff.

100 A. The Veterans Services Foundation (the Foundation) is established to serve as an advisory
101 foundation, within the meaning of § 2.2-2100, in the executive branch of state government. The
102 Foundation shall be governed and administered by a board of trustees for the purpose of providing to
103 provide funding for veteran services and programs in the Commonwealth through the Veterans Services
104 Fund (the Fund). The Foundation shall submit a quarterly report to the Commissioner of Veterans
105 Services on the Foundation's funding levels and services.

106 B. The Foundation *board of trustees* shall consist of the Commissioner of Veterans Services and the
107 Chairman of the Board of Veterans Services, who shall serve as ex officio voting members, and eight
108 nonlegislative citizens appointed by the Governor, subject to confirmation by the General Assembly. A
109 majority of the trustees shall be active or retired chairmen, chief executive officers, or chief financial
110 officers for large private corporations or nonprofit organizations. Trustees appointed by the Governor
111 shall, insofar as possible, be veterans.

112 Initial appointments by the Governor shall be staggered as follows: two members for a term of one
113 year, three members for a term of two years, and three members for a term of four years. Thereafter,
114 members shall be appointed for a term of three years. Appointments to fill vacancies, other than by
115 expiration of a term, shall be for the unexpired terms. All members may be reappointed. However, no
116 member shall serve more than two consecutive three-year terms. The remainder of any term to which a
117 member is appointed to fill a vacancy shall not constitute a term in determining the member's eligibility
118 for reappointment. Vacancies shall be filled in the same manner as the original appointments. Any
119 member of the Board of Trustees may be removed by the Governor at his pleasure.

120 C. Trustees shall be reimbursed for their actual expenses incurred while attending meetings of the

121 trustees or performing other duties. However, such reimbursement shall not exceed the per diem rate
122 established for members of the General Assembly pursuant to § 30-19.12.

123 D. The Secretary of Public Safety shall designate a state agency to provide the Foundation with
124 administrative and other services.

125 E. The trustees shall adopt bylaws governing their organization and procedures and may amend the
126 same. The trustees shall elect from their number a chairman and such other officers as their bylaws may
127 provide.

128 F. Any person designated by the board of trustees to handle the funds of the Foundation or the Fund
129 shall give bond, with corporate surety, in a penalty fixed by the Governor, conditioned upon the faithful
130 discharge of his duties. Any premium on the bond shall be paid from funds available to the Foundation.

131 § 2.2-2716. Authority of Foundation.

132 The Foundation has the authority to:

133 1. Administer the Veterans Services Fund and make expenditures from the Fund to the Department
134 of Veterans Services to provide supplemental funding for the Department's services and programs;

135 2. Accept, hold, and administer gifts and bequests of money, securities, or other property, absolutely
136 or in trust, for the purposes for which the Foundation is created;

137 3. Enter into contracts and execute all instruments necessary and appropriate to carry out the
138 Foundation's purposes;

139 4. Take such actions as may be reasonably necessary to seek, promote, and stimulate contributions
140 for the Fund;

141 5. ~~Make recommendations concerning~~ *Develop* other possible dedicated revenue sources for the Fund;

143 6. Perform any lawful acts necessary or appropriate to carry out the purposes of the Foundation.
