6 WHEREAS, Jo Ann Davis, a dedicated and energetic four-term Representative for Virginia's First
7 Congressional District, died on October 6, 2007, in her Gloucester home after a valiant fight against
8 breast cancer; and

9 WHEREAS, the first elected Republican woman in Congress from Virginia, Jo Ann Davis came from10 humble roots and worked her way up to the halls of the United States Congress; and

WHEREAS, a successful real estate broker, Jo Ann Davis began her political career in 1997 when she won election to the House of Delegates; just three years later she was elected to the House of Representatives, where she was known for being honest, very hard working, and independent-minded; and

WHEREAS, during her tenure in the House of Representatives, Jo Ann Davis served as chair of the
House subcommittee that deals with federal workers' benefits and served on the House Intelligence
Committee, the House Armed Services Committee, and the House Foreign Affairs Committee; and

18 WHEREAS, Jo Ann Davis was a strong advocate for the many military bases and related industries
19 in her district, and her first piece of legislation, passed by the House in 2001, increased the life
20 insurance benefit paid to survivors of military members killed on duty; and
21 WHEREAS, Jo Ann Davis sponsored legislation in 2002 to rebuild the United States Navy fleet to

WHEREAS, Jo Ann Davis sponsored legislation in 2002 to rebuild the United States Navy fleet to no fewer than 375 vessels, including 15 aircraft carrier battle groups, and secured \$169 million for construction on the Navy's next-generation aircraft carrier, CVN-21; and

WHEREAS, Jo Ann Davis also worked tirelessly on behalf of federal employees, pushing the Bush
 administration to speed up federal hiring procedures and to create a more equitable system for
 compensating federal law-enforcement officers and insisting on legislative safeguards aimed at protecting
 basic employee rights; and

WHEREAS, closer to home, Jo Ann Davis fought for legislation to allow Virginia to regulate the
 trash shipped in from other states and to remove environmentally hazardous ships from the James
 River's "ghost fleet"; and

WHEREAS, a woman of great principle, clear judgment, and an indomitable spirit, Jo Ann Davis
will be fondly remembered and greatly missed by her husband of 33 years, Chuck Davis; their sons
Christopher and Charles; and numerous other family members, friends, and colleagues; now, therefore, be it

RESOLVED by the House of Delegates, the Senate concurring, That the General Assembly hereby
 note with great sadness the loss of Jo Ann Davis, an outstanding public servant and a fine Virginian;
 and, be it
