7	A BILL to amend and reenact § 9.1-902 of the Code of Virginia, relating to the Crimes Against Minors and Sex Offender Registry; penalties.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 9.1-902 of the Code of Virginia is amended and reenacted as follows:
10	§ 9.1-902. Offenses requiring registration.
11	A. For purposes of this chapter:
12	"Offense for which registration is required" includes:
13	1. Any offense listed in subsection B;
14 15	<ol> <li>Criminal homicide;</li> <li>Murder; and</li> </ol>
15 16	4. A sexually violent offense;
17	5. Any offense similar to those listed in subdivisions 1 through 4 under the laws of any foreign
18	country or any political subdivision thereof, the United States or any political subdivision thereof; and
19	6. Any offense for which registration in a sex offender and crimes against minors registry is required
20	under the laws of the jurisdiction where the offender was convicted.
21	B. The offenses included under this subsection include any violation of, attempted violation of, or
22 23	conspiracy to violate: 1. § 18.2-63, § 18.2-64.1, former § 18.2-67.2:1, § 18.2-90 with the intent to commit rape, or
23 24	subsection B or C of § 18.2-374.1:1, subsection D of § $18.2-374.1:1$ as it was in effect from July 1,
25	1994 through June 30, 2007, clause (iv) of subsection B of § 18.2-374.3 as it was in effect on June 30,
26	2007, or subsection C of § 18.2-374.3 ;or a third or subsequent conviction of (i) § 18.2-67.4, (ii)
27	§ 18.2-67.4:2, (iii) subsection C of § 18.2-67.5 or (iv) § 18.2-386.1;
28	If the offense was committed on or after July 1, 2006, (i) § 18.2-91 with the intent to commit any

40	E. "Sexually violent offense" means a violation of, attempted violation of, or conspiracy to violate:
41	1. Clause (ii) of § 18.2-48, § 18.2-61, § 18.2-67.1, § 18.2-67.2, § 18.2-67.3, § 18.2-67.4 where the
42	perpetrator is 18 years of age or older and the victim is under the age of six, subsections A and B of
43	§ 18.2-67.5, § 18.2-370, or § 18.2-370.1 or § 18.2-374.1; or
44 45	2. § 18.2-63, § 18.2-64.1, former § 18.2-67.2:1, § 18.2-90 with the intent to commit rape or, where
45 46	the victim is a minor or is physically helpless or mentally incapacitated as defined in § 18.2-67.10, subsection A of § 18.2-47, § 18.2-67.4, subsection C of § 18.2-67.5, clause (i) or (iii) of § 18.2-48,

57	F. "Offense for which registration is required" Any "offense listed in subsection B," "criminal
58 50	homicide" as defined in this section, "murder" as defined in this section, and "sexually violent offense"
59	as defined in this section includes (i) any similar offense under the laws of any foreign country or any

60 political subdivision thereof, the United States or any political subdivision thereof or (ii) any offense for 61 which registration in a sex offender and crimes against minors registry is required under the laws of the

61 which registration in a sex offender and crimes 62 jurisdiction where the offender was convicted.

63 G. Juveniles adjudicated delinquent shall not be required to register; however, where the offender is a 64 juvenile over the age of 13 at the time of the offense who is tried as a juvenile and is adjudicated 65 delinquent on or after July 1, 2005, of any offense for which registration is required, the court may, in 66 its discretion and upon motion of the attorney for the Commonwealth, find that the circumstances of the offense require offender registration. In making its determination, the court shall consider all of the 67 following factors that are relevant to the case: (i) the degree to which the delinquent act was committed 68 with the use of force, threat or intimidation, (ii) the age and maturity of the complaining witness, (iii) 69 the age and maturity of the offender, (iv) the difference in the ages of the complaining witness and the 70 71 offender, (v) the nature of the relationship between the complaining witness and the offender, (vi) the 72 offender's prior criminal history, and (vii) any other aggravating or mitigating factors relevant to the 73 case.
