6 7	A BILL to amend and reenact § 9.1-902 of the Code of Virginia, relating to the Sex Offender and Crimes Against Minors Registry; penalties.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 9.1-902 of the Code of Virginia is amended and reenacted as follows:
10	§ 9.1-902. Offenses requiring registration.
11	A. For purposes of this chapter:
12	"Offense for which registration is required" includes:
13	1. Any offense listed in subsection B;
14	2. Criminal homicide;
15	3. Murder; and
16 17	4. A sexually violent offense;
17 18	5. Any offense similar to those listed in subdivisions 1 through 4 under the laws of any foreign country or any political subdivision thereof, the United States or any political subdivision thereof; and
19	6. Any offense for which registration in a sex offender and crimes against minors registry is required
20	under the laws of the jurisdiction where the offender was convicted.
21	B. The offenses included under this subsection include any violation of, attempted violation of, or
22	conspiracy to violate:
23	1. § 18.2-63, § 18.2-64.1, former § 18.2-67.2:1, § 18.2-90 with the intent to commit rape, or
24	subsection B or C of § 18.2-374.1:1; or a third or subsequent conviction of (i) § 18.2-67.4, (ii) $\$ 18.2 \cdot 67.42$ (iii) subsection C of $\$ 18.2 \cdot 67.5$ or (iv) $\$ 18.2 \cdot 296.1$

36	§ 18.2-32 where the victim is (i) under 15 years of age or (ii) where the victim is at least 15 years of

38	E. "Sexually violent offense" means a violation of, attempted violation of, or conspiracy to violate:

54 55	described in § 1591 of Title 18, U.S.C.). F. "Offense for which registration is required" Any "offense listed in subsection B," "criminal
55 56	homicide" as defined in this section, "murder" as defined in this section, and "sexually violent offense"
57	as defined in this section includes (i) any similar offense under the laws of any foreign country or any
58	political subdivision thereof, the United States or any political subdivision thereof or (ii) any offense for
59	which registration in a sex offender and crimes against minors registry is required under the laws of the

60 jurisdiction where the offender was convicted.

G. Juveniles adjudicated delinquent shall not be required to register; however, where the offender is a 61 62 juvenile over the age of 13 at the time of the offense who is tried as a juvenile and is adjudicated 63 delinquent on or after July 1, 2005, of any offense for which registration is required, the court may, in its discretion and upon motion of the attorney for the Commonwealth, find that the circumstances of the 64 65 offense require offender registration. In making its determination, the court shall consider all of the following factors that are relevant to the case: (i) the degree to which the delinquent act was committed 66 67 with the use of force, threat or intimidation, (ii) the age and maturity of the complaining witness, (iii) the age and maturity of the offender, (iv) the difference in the ages of the complaining witness and the 68 69 offender, (v) the nature of the relationship between the complaining witness and the offender, (vi) the 70 offender's prior criminal history, and (vii) any other aggravating or mitigating factors relevant to the 71 case.
