That § 46.2-206.1 of the Code of Virginia is repealed. [2. That any person aggrieved by the imposition of civil remedial fees imposed under the provisions of § 46.2-206.1 of the Code of Virginia may file a petition with the General District 9 10 Court of the jurisdiction in which he resides or where he was adjudicated in order to have the 11 order vacated with respect to such fees. The General District Court shall provide a preprinted 12 13 form for purposes of filing the petition, and no filing fee shall be charged for such petition. Upon 14 vacation of the underlying order, no civil remedial fees shall be owed. 3. That the Comptroller shall, upon proof of payment of any civil remedial fee owed under 15 § 46.2-206.1 of the Code of Virginia, and upon proof of a vacation of the order imposing the civil 16 remedial fees from General District Court pursuant to the second enactment clause of this act, 17 draw a warrant for payment by the State Treasurer for a refund to such person. Such refund 18 shall be for the full amount paid for the civil remedial fee. All agencies of the Commonwealth, 19 20upon request of the Comptroller, shall provide him with all requested information reasonably 21 necessary for the payment of such refunds. 4. That the Department of Motor Vehicles shall issue notice to all persons subject to the civil 22 23 remedial fees pursuant to § 46.2-206.1 of the Code of Virginia of the right to petition for a 24 vacation of the order imposing the civil remedial fees through the General District Court and of 25 the right to a refund, as set forth in this act. 5. That no person shall have his driver's license or his privilege to drive a motor vehicle in 26 27 Virginia suspended solely for failure to pay a civil remedial fee imposed under the provisions of 28 § 46.2-206.1 of the Code of Virginia. 29
