§ 2.2-212. Position established; agencies for which responsible; additional powers.

54 The position of Secretary of Health and Human Resources (the Secretary) is created. The Secretary 55 of Health and Human Resources shall be responsible to the Governor for the following agencies: Department of Health, Department for the Blind and Vision Impaired, Department of Health Professions, 56 Department for the Aging, Department of Mental Health, Mental RetardationIntellectual Disability and 57 Substance Abuse Services, Department of Rehabilitative Services, Department of Social Services, Department of Medical Assistance Services, Child Day-Care Council, Virginia Department for the Deaf 58 59

60 and Hard-of-Hearing, the Office of Comprehensive Services for Youth and At-Risk Youth and Families,

61 and the Assistive Technology Loan Fund Authority. The Governor may, by executive order, assign any other state executive agency to the Secretary of Health and Human Resources, or reassign any agency 62

63 listed above to another Secretary.

Unless the Governor expressly reserves such power to himself, the Secretary shall (i) serve as the 64 65 lead Secretary for the coordination and implementation of the long-term care policy of the 66 Commonwealth, working with the Secretaries of Transportation, Commerce and Trade, and Education, and the Commissioner of Insurance, to facilitate interagency service development and implementation, 67 communication and cooperation, (ii) serve as the lead Secretary for the Comprehensive Services Act for 68 69 At-Risk Youth and Families, working with the Secretary of Education and the Secretary of Public Safety 70 to facilitate interagency service development and implementation, communication and cooperation, and (iii) coordinate the disease prevention activities of agencies in the Secretariat to ensure efficient, 71 72 effective delivery of health related services and financing. 73

§ 2.2-213. Secretary of Health and Human Resources to develop certain criteria.

74 In order to respond to the needs of substance abusing women and their children, the Secretary shall 75 develop criteria for (i) enhancing access to publicly funded substance abuse treatment programs in order to effectively serve pregnant substance abusers; (ii) determining when a drug-exposed child may be 76 referred to the early intervention services and tracking system available through Part C of the Individuals 77 78 with Disabilities Education Act, 20 U.S.C. § 1431 et seq.; (iii) determining the appropriate circumstances 79 for contact between hospital discharge planners and local departments of social services for referrals for 80 family-oriented prevention services, when such services are available and provided by the local social services agency; and (iv) determining when the parent of a drug-exposed infant, who may be endangering a child's health by failing to follow a discharge plan, may be referred to the child protective 81 82 83 services unit of a local department of social services.

84 The Secretary shall consult with the Commissioner of Mental Health, Mental RetardationIntellectual 85 Disability and Substance Abuse Services, the Commissioner of Social Services, the Commissioner of 86 Health, community services boards, behavioral health authorities local departments of social services, 87 and local departments of health in developing the criteria required by this section. 88

§ 2.2-214. Responsibility of certain agencies within the Secretariat; review of regulations.

89 The Boards of Health, Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 90 Services, Social Services, and Medical Assistance Services and the Department of Rehabilitative Services 91 shall review their regulations and policies related to service delivery in order to ascertain and eliminate 92 any discrimination against individuals infected with human immunodeficiency virus. 93

§ 2.2-223. Interagency Drug Offender Screening and Assessment Committee.

The Secretary shall establish and chair an Interagency Drug Offender Screening and Assessment 94 Committee to oversee the drug screening, assessment and treatment provisions of §§ 16.1-273, 16.1-278.1, 16.1-278.8, 18.2-251.01, 18.2-251, 18.2-252, 19.2-299 and 19.2-299.2 for defendants 95 96 convicted in the criminal courts of the Commonwealth. The Committee shall include the Directors or 97 98 Commissioners of the Department of Corrections; Department of Criminal Justice Services; Department 99 of Juvenile Justice; Department of Mental Health, Mental RetardationIntellectual Disability, and 100 Substance Abuse Services; the Virginia Alcohol Safety Action Program; and the Virginia Criminal Sentencing Commission. The Committee shall have the responsibility to: (i) assist and monitor agencies 101 102 in implementing the above-listed Code of Virginia sections, (ii) ensure quality and consistency in the screening and assessment process, (iii) promote interagency coordination and cooperation in the 103 identification and treatment of drug abusing or drug dependent offenders, (iv) implement an evaluation 104 105 process and conduct periodic program evaluations, and (v) make recommendations to the Governor and General Assembly regarding proposed expenditures from the Drug Assessment Fund. The Committee 106 shall report on the status and effectiveness of offender drug screening, assessment and treatment to the 107 108 Virginia State Crime Commission and the House Committees on Courts of Justice and Appropriations, 109 and the Senate Committees on Courts of Justice and Finance by January 1 of each year.

§ 2.2-507. Legal service in civil matters.

110

111 A. All legal service in civil matters for the Commonwealth, the Governor, and every state 112 department, institution, division, commission, board, bureau, agency, entity, official, court, or judge, 113 including the conduct of all civil litigation in which any of them are interested, shall be rendered and 114 performed by the Attorney General, except as provided in this chapter and except for any litigation concerning a justice or judge initiated by the Judicial Inquiry and Review Commission. No regular 115 counsel shall be employed for or by the Governor or any state department, institution, division, 116 commission, board, bureau, agency, entity, or official. The Attorney General may represent personally or 117 through one or more of his assistants any number of state departments, institutions, divisions, 118 commissions, boards, bureaus, agencies, entities, officials, courts, or judges that are parties to the same 119 120 transaction or that are parties in the same civil or administrative proceeding and may represent multiple interests within the same department, institution, division, commission, board, bureau, agency, or entity. 121

122 Upon request of the local attorney for the Commonwealth, the Attorney General may provide legal123 service in civil matters for soil and water conservation district directors or districts.

B. The Attorney General may represent personally or through one of his assistants any of the
 following persons who are made defendant in any civil action for damages arising out of any matter
 connected with their official duties:

127 1. Members, agents or employees of the Alcoholic Beverage Control Board;

128 2. Agents inspecting or investigators appointed by the State Corporation Commission;

129 3. Agents, investigators, or auditors employed by the Department of Taxation;

 4. Members, agents or employees of the State Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services Board, the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, the State Board of Health, the State
 Bepartment of Health, the Department of General Services, the State Board of Social Services, the Department of Social Services, the State Board of Corrections, the Department of Corrections, the State Board of Juvenile Justice, the Department of Juvenile Justice, the Virginia Parole Board, or the Department of Agriculture and Consumer Services;

- 137 5. Persons employed by the Commonwealth Transportation Board;
- **138** 6. Persons employed by the Commissioner of Motor Vehicles;
- **139** 7. Persons appointed by the Commissioner of Marine Resources;
- 140 8. Police officers appointed by the Superintendent of State Police;
- 141 9. Conservation police officers appointed by the Department of Game and Inland Fisheries;
- 142 10. Third impartial panel members appointed to hear a teacher's grievance pursuant to § 22.1-312;

143 11. Staff members or volunteers participating in a court-appointed special advocate program pursuant
144 to Article 5 (§ 9.1-151 et seq.) of Chapter 1 of Title 9.1;

145 12. Any emergency medical service agency that is a licensee of the Department of Health in any
civil matter and any guardian ad litem appointed by a court in a civil matter brought against him for
alleged errors or omissions in the discharge of his court-appointed duties; or

13. Conservation officers of the Department of Conservation and Recreation.

149 Upon request of the affected individual, the Attorney General may represent personally or through
150 one of his assistants any basic or advanced emergency medical care attendant or technician possessing a
151 valid certificate issued by authority of the State Board of Health in any civil matter in which a defense
152 of immunity from liability is raised pursuant to § 8.01-225.

153 C. If, in the opinion of the Attorney General, it is impracticable or uneconomical for such legal 154 service to be rendered by him or one of his assistants, he may employ special counsel for this purpose, 155 whose compensation shall be fixed by the Attorney General. The compensation for such special counsel 156 shall be paid out of the funds appropriated for the administration of the board, commission, division or 157 department being represented or whose members, officers, inspectors, investigators, or other employees 158 are being represented pursuant to this section. Notwithstanding any provision of this section to the 159 contrary, the Supreme Court may employ its own counsel in any matter arising out of its official duties 160 in which it, or any justice, is a party.

161 § 2.2-701. Nature of long-term care services.

A. The long-term care services shall include, but not be limited to, the following:

163 1. A balanced range of health, social, and supportive services to deliver long-term care services to 164 persons aged 60 and older with chronic illnesses or functional impairments;

165 2. Meaningful choice, increased functional ability, and affordability as determining factors in defining
166 long-term care service needs, which needs shall be determined by a uniform system for comprehensively
167 assessing the needs and preferences of individuals requiring such services;

3. Service delivery, consistent with the needs and preferences of individuals requiring such services,that occurs in the most independent, least restrictive, and most appropriate living situation possible; and

4. Opportunities for self-care and independent living, as appropriate, by encouraging all long-term
care programs to maximize self-care and independent living within the mainstream of life in the
community.

B. Such services shall include, but not be limited to, the following categories: socialization services, health care services, nutrition services, daily living services, educational services, housing services, transportation services, and supportive services.

C. As used in this section:

177 "Daily living services" includes homemaker, companion, personal care and chore services, home178 repair, weatherization and adult day care.

179 "Educational services" includes information on the long-term care services provided by agencies of
180 the Commonwealth, its localities and private sector agencies, and public information as provided in
181 § 2.2-213.1.

182 "Health care services" includes home health care and community medical care.

183 "Housing services" includes community-based residential opportunities and retrofitting existing 184 housing as needed.

185 "Nutrition services" includes home-delivered meals, food stamps, and congregate meals.

186 "Socialization services" includes telephone reassurance, friendly visiting, and congregate meals.

187 "Supportive services" includes adult protective services, mental health and mental retardation services, 188 services for persons with intellectual disability, counseling services and legal aid.

189 "Transportation services" includes readily available access to public transportation or area coordinated 190 para-transit systems. 191

§ 2.2-704. Responsibility of Department for complaints regarding long-term care services.

192 The Department or its designee shall investigate complaints regarding community services that are designed to provide long-term care to older persons and are rendered by the Department of Health, the 193 Department of Social Services, the Department of Mental Health, Mental RetardationIntellectual 194 Disability and Substance Abuse Services, the area agencies on aging or any private nonprofit or 195 196 proprietary agency.

197 Nothing in this section shall affect the services provided by local departments of welfare or social 198 services pursuant to § 63.2-1605.

199 § 2.2-705. Access to residents, facilities and patients' records by Office of State Long-Term Care 200 Ombudsman.

201 The entity designated by the Department to operate the programs of the Office of the State 202 Long-Term Care Ombudsman pursuant to the Older Americans Act, Public Law 100-175, shall, in the 203 investigation of complaints referred to the program, have the same access to (i) residents, facilities and 204 patients' records of licensed adult care residences in accordance with § 63.2-1706 and (ii) patients, facilities and patients' records of nursing facilities or nursing homes in accordance with § 32.1-25, and 205 shall have access to the patients, residents and patients' records of state hospitals operated by the 206 207 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services. However, if a patient is unable to consent to the review of his medical and social records and has no 208 209 legal guardian, such representatives shall have appropriate access to such records in accordance with this 210 section. Notwithstanding the provisions of  $\S$  32.1-125.1, the entity designated by the Department to operate the programs of the Office of the State Long-Term Care Ombudsman shall have access to 211 nursing facilities and nursing homes and state hospitals in accordance with this section. Access to 212 213 residents, facilities and patients' records shall be during normal working hours except in emergency 214 situations.

§ 2.2-1124. Disposition of surplus materials.

216 A. "Surplus materials" means personal property including, but not limited to, materials, supplies, equipment, and recyclable items, but shall not include property as defined in § 2.2-1147 that is 217 determined to be surplus. Surplus materials shall not include finished products that a mental health 218 219 facility or mental retardation facility for persons with intellectual disability sells for the benefit of its 220 patients or residents, provided that (i) most of the supplies, equipment, or products have been donated to 221 the facility; (ii) the patients or residents of the facility have substantially altered the supplies, equipment, 222 or products in the course of occupational or other therapy; and (iii) the substantial alterations have 223 resulted in a finished product.

224 B. The Department shall establish procedures for the disposition of surplus materials from 225 departments, divisions, institutions, and agencies of the Commonwealth. Such procedures shall:

226 1. Permit surplus materials to be transferred between or sold to departments, divisions, institutions, or 227 agencies of the Commonwealth;

228 2. Permit surplus materials to be sold to Virginia charitable corporations granted tax-exempt status 229 under § 501(c) (3) of the Internal Revenue Code and operating as clinics for the indigent and uninsured 230 that are organized for the delivery of primary health care services (i) as federally qualified health centers 231 designated by the Health Care Financing Administration or (ii) at a reduced or sliding fee scale or 232 without charge:

233 3. Permit public sales or auctions, including online public auctions, provided that the procedures 234 provide for sale to all political subdivisions and any volunteer rescue squad or volunteer fire department established pursuant to § 15.2-955 any surplus materials prior to such public sale or auction; 235

236 4. Permit surplus motor vehicles to be sold prior to public sale or auction to local social service 237 departments for the purpose of resale at cost to TANF recipients;

238 5. Permit surplus materials to be sold to Virginia charitable corporations granted tax-exempt status 239 under 501(c) (3) of the Internal Revenue Code and operating as children's homes;

240 6. Permit donations to political subdivisions of the Commonwealth under the circumstances specified 241 in this section;

7. Permit other methods of disposal when (a) the cost of the sale will exceed the potential revenue to 242 243 be derived therefrom or (b) the surplus material is not suitable for sale;

244 8. Permit any dog especially trained for police work to be sold at an appropriate price to the handler

245 who last was in control of the dog, which sale shall not be deemed a violation of the State and Local 246 Government Conflict of Interests Act (§ 2.2-3100 et seq.);

247 9. Permit the transfer of surplus clothing to an appropriate department, division, institution, or agency 248 of the Commonwealth for distribution to needy individuals by and through local social services boards;

249 10. Encourage the recycling of paper products, beverage containers, electronics, and used motor oil;

250 11. Require the proceeds from any sale or recycling of surplus materials be promptly deposited into 251 the state treasury in accordance with § 2.2-1802 and report the deposit to the State Comptroller;

252 12. Permit donations of surplus computers and related equipment to public schools in the 253 Commonwealth and Virginia charitable corporations granted tax-exempt status under 501(c) (3) of the 254 Internal Revenue Code and providing services to persons with disabilities, at-risk youths, or low-income families. For the purposes of this subdivision, "at-risk youths" means school-age children approved 255 256 eligible to receive free or reduced price meals in the federally funded lunch program;

257 13. Permit surplus materials to be transferred or sold, prior to public sale or auction, to public 258 television stations located in the state and other nonprofit organizations approved for the distribution of 259 federal surplus materials;

260 14. Permit a public institution of higher education to dispose of its surplus materials at the location 261 where the surplus materials are held and to retain any proceeds from such disposal, provided that the 262 institution meets the conditions prescribed in subsection B of § 23-38.88 and § 23-38.112 (regardless of 263 whether or not the institution has been granted any authority under Subchapter 3 (§ 23-38.91 et seq.) of 264 Chapter 4.10 of Title 23); and

265 15. Require, to the extent practicable, the recycling and disposal of computers and other information 266 technology assets. Additionally, for computers or information technology assets that may contain confidential state data or personal identifying information of citizens of the Commonwealth, the 267 268 Department shall ensure all policies for the transfer or other disposition of computers or information 269 technology assets are consistent with data and information security policies developed by the Virginia 270 Information Technologies Agency.

271 C. The Department shall dispose of surplus materials pursuant to the procedures established in 272 subsection B or permit any department, division, institution, or agency of the Commonwealth to dispose 273 of its surplus materials consistent with the procedures so established. No surplus materials shall be 274 disposed of without prior consent of the head of the department, division, institution, or agency of the 275 Commonwealth in possession of such surplus materials or the Governor.

276 D. Departments, divisions, institutions, or agencies of the Commonwealth or the Governor may 277 donate surplus materials only under the following circumstances: 278

1. Emergencies declared in accordance with § 44-146.18:2 or 44-146.28;

279 2. As set forth in the budget bill as defined by § 2.2-1509, provided that (a) the budget bill contains 280 a description of the surplus materials, the method by which the surplus materials shall be distributed, 281 and the anticipated recipients, and (b) such information shall be provided by the Department to the 282 Department of Planning and Budget in sufficient time for inclusion in the budget bill;

283 3. When the market value of the surplus materials, which shall be donated for a public purpose, is 284 less than \$500; however, the total market value of all surplus materials so donated by any department, division, institution, or agency shall not exceed 25 percent of the revenue generated by such 285 286 department's, division's, institution's, or agency's sale of surplus materials in the fiscal year, except these 287 limits shall not apply in the case of surplus computer equipment and related items donated to Virginia 288 public schools; or

289 4. During a local emergency, upon written request of the head of a local government or a political 290 subdivision in the Commonwealth to the head of a department, division, institution, or agency.

291 E. On or before October 1 of each year, the Department shall prepare, and file with the Secretary of 292 the Commonwealth, a plan that describes the expected disposition of surplus materials in the upcoming 293 fiscal year pursuant to subdivision B 6.

294 § 2.2-1204. Health insurance program for employees of local governments, local officers, teachers, 295 etc.; definitions.

296 A. The Department shall establish a plan or plans, hereinafter "plan" or "plans", subject to the 297 approval of the Governor, for providing health insurance coverage for employees of local governments, 298 local officers, teachers, and retirees, and the dependents of such employees, officers, teachers and 299 retirees. The plan or plans shall be rated separately from the plan established pursuant to § 2.2-2818 to 300 provide health and related insurance coverage for state employees. Participation in such insurance plan 301 or plans shall be (i) voluntary, (ii) approved by the participant's respective governing body, or by the 302 local school board in the case of teachers, and (iii) subject to regulations adopted by the Department. In 303 addition, at the option of a governing body or school board that has elected to participate in the health 304 insurance plan or plans offered by the Department, the governing body or school board may elect to 305 participate in the long-term care or other benefit program that the Department may make available to the

306 governing body or school board.

307 B. The plan established by the Department shall satisfy the requirements of the Virginia Public 308 Procurement Act (§ 2.2-4300 et seq.), shall consist of a flexible benefits structure that permits the 309 creation of multiple plans of benefits and may provide for separate rating groups based upon criteria 310 established by the Department. The Department shall adopt regulations regarding the establishment of 311 such a plan or plans, including, but not limited to, requirements for eligibility, participation, access and 312 egress, mandatory employer contributions and financial reserves, and the administration of the plan or 313 plans. The Department may engage the services of other professional advisors and vendors as necessary 314 for the prudent administration of the plan or plans. The assets of the plan or plans, together with all 315 appropriations, premiums and other payments, shall be deposited in the employee health insurance fund, from which payments for claims, premiums, cost containment programs and administrative expenses 316 shall be withdrawn from time to time. The assets of the fund shall be held for the sole benefit of the 317 318 employee health insurance fund. The fund shall be held in the state treasury. Any interest on unused 319 balances in the fund shall revert back to the credit of the fund. The State Treasurer shall charge 320 reasonable fees to recover the actual costs of investing the assets of the plan or plans.

321 In establishing the participation requirements, the Department may provide that those employees, 322 officers, and teachers without access to employer-sponsored health care coverage may participate in the 323 plan. It shall collect all premiums directly from the employers of such employees, officers, and teachers.

324 C. In the event that the financial reserves of the plan fall to an unacceptably low level as determined 325 by the Department, it shall have the authority to secure from the State Treasurer a loan sufficient to raise the reserve level to one that is considered adequate. The State Treasurer may make such a loan, to 326 327 be repaid on such terms and conditions as established by him. 328

D. For the purposes of this section:

337 "Local officer" means the treasurer, registrar, commissioner of the revenue, attorney for the 338 Commonwealth, clerk of a circuit court, sheriff, or constable of any county or city or deputies or 339 employees of any of the preceding local officers. 340

'Teacher" means any employee of a county, city, or other local public school board.

341 E. Any stock and cash distributed to the Commonwealth pursuant to the conversion of Blue Cross 342 and Blue Shield of Virginia, doing business as Trigon Blue Cross Blue Shield, from a mutual insurance 343 company to a stock corporation known as Trigon Healthcare, Inc., that is directly attributable to the 344 health insurance plan or plans established for employees of local governments, local officers, teachers, 345 and retirees, and the dependents of such employees, officers, teachers and retirees, pursuant to subsection A (hereinafter referred to as the "local choice plan distribution") shall be deposited in the 346 347 state treasury to the credit of the employee health insurance fund to be used as provided in this 348 subsection. Such distribution shall not include any cash paid by Blue Cross and Blue Shield of Virginia 349 or its successor to the Commonwealth in connection with such conversion that was assumed as general 350 fund revenue in Chapter 912 of the 1996 Acts of Assembly. All other stock and cash received by the 351 Commonwealth pursuant to such conversion of Blue Cross and Blue Shield of Virginia to a stock corporation shall be allocated as provided in subsection B of § 23-284. 352

353 The State Treasurer shall sell any stock received pursuant to the local choice plan distribution as 354 soon as practicable following its receipt, subject to any lockup period or other restriction on its sale, and 355 the proceeds therefrom shall be deposited in the state treasury to the credit of the employee health 356 insurance fund. Notwithstanding any other provision of law to the contrary, the State Treasurer shall not 357 be liable for any losses incurred from the sale or distribution of such stock.

358 The Department of Human Resource Management shall use any stock, or the proceeds therefrom, and 359 cash received pursuant to the local choice plan distribution to reduce premiums payable by employers 360 participating in a plan or plans established pursuant to subsection A. In setting health insurance premiums for such plan or plans, the Director of the Department of Human Resource Management shall 361 allocate the value of such stock, or proceeds therefrom, and cash among each participating employer. 362 Such allocation shall be based on the proportionate amounts of premiums previously paid by each 363 364 participating employer. If a participating employer withdraws from such plan or plans before all of the 365 value allocated to it has been used for the benefit of the participating employer, the remaining value shall be transferred to such participating employer upon his withdrawal. 366

367 § 2.2-1207. Long-term care insurance program for employees of local governments, local officers,

§ 2.2-2411. Public Guardian and Conservator Advisory Board; purpose; membership; terms.

514 A. The Public Guardian and Conservator Advisory Board (the "Board") is established as an advisory 515 board, within the meaning of § 2.2-2100, in the executive branch of state government. The purpose of 516 the Board shall be to report to and advise the Commissioner of the Department for the Aging on the 517 means for effectuating the purposes of this article and shall assist in the coordination and management 518 of the local and regional programs appointed to act as public guardians and conservators pursuant to 519 Chapter 10 (§ 37.2-1000 et seq.) of Title 37.2.

520 B. The Board shall consist of no more than fifteen members who shall be appointed by the Governor 521 as follows: one representative of the Virginia Guardianship Association, one representative of the 522 Virginia Area Agencies on Aging, one representative of the Virginia State Bar, one active or retired 523 circuit court judge upon recommendation of the Chief Justice of the Supreme Court, one representative 524 of the Association of Retarded Citizens, one representative of the Virginia Alliance for the Mentally III, 525 one representative of the Virginia League of Social Service Executives, one representative of the 526 Association of Community Service Boards, the Commissioner of the Department of Social Services or 527 his designee, the Commissioner of the Department of Mental Health, Mental RetardationIntellectual 528 Disability and Substance Abuse Services or his designee, the Director of the Virginia Office for 529 Protection and Advocacy or his designee, and one person who is a member of the Commonwealth 530 Council on Aging and such other individuals who may be qualified to assist in the duties of the Board.

531 C. The Commissioners of the Departments of Social Services and Mental Health, Mental 532 RetardationIntellectual Disability and Substance Abuse Services or their designees, the Director of the 533 Virginia Office for Protection and Advocacy or his designee, and the representative of the 534 Commonwealth Council on Aging, shall serve terms coincident with their terms of office or in the case 535 of designees, the term of the Commissioner or Director. Of the other members of the Board, five of the 536 appointees shall serve for four-year terms and the remainder shall serve for three-year terms. No 537 member shall serve more than two successive terms. A vacancy occurring other than by expiration of 538 term shall be filled for the unexpired term.

539 D. Each year, the Board shall elect a chairman and a vice-chairman from among its members. Five 540 members of the Board shall constitute a quorum.

541 E. Members shall receive no compensation for their services but shall be reimbursed for all 542 reasonable and necessary expenses incurred in the discharge of their duties as provided in § 2.2-2823. 543

§ 2.2-2525. (Expires July 1, 2009) Membership; terms; quorum; meetings.

544 The Commission shall have a total membership of 21 nonlegislative citizen members to be appointed 545 as follows: four nonlegislative citizen members, of whom two shall be persons with disabilities, one 546 shall be the relative of a citizen of the Commonwealth with a disability, and one shall be a provider of 547 services to citizens of the Commonwealth with disabilities or an advocate for persons with disabilities or for services to such persons to be appointed by the Senate Committee on Rules; six nonlegislative 548 549 citizen members, of whom three shall be persons with disabilities, one shall be the relative of a citizen 550 of the Commonwealth with a disability, and two shall be providers of services to citizens of the Commonwealth with disabilities or an advocate for persons with disabilities or for services to such 551

552 persons to be appointed by the Speaker of the House of Delegates; and 11 nonlegislative citizen 553 members, of whom three shall be persons with disabilities, one shall be a resident of a state mental health facility, one shall be a resident of a state mental retardation training facility for persons with 554 555 intellectual disability, one shall be a resident of a nursing facility, two shall be the relatives of citizens 556 of the Commonwealth with disabilities, and three shall be providers of services to citizens of the 557 Commonwealth with disabilities or an advocate for persons with disabilities or for services to such 558 persons to be appointed by the Governor. Nonlegislative citizen members of the Commission shall be 559 citizens of the Commonwealth.

560 Nonlegislative citizen members shall serve a term of four years; however, no nonlegislative citizen 561 member shall serve more than two consecutive four-year terms. Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms. Vacancies shall be filled in the same 562 manner as the original appointments. All members may be reappointed. The remainder of any term to 563 which a member is appointed to fill a vacancy shall not constitute a term in determining the member's 564 565 eligibility for reappointment.

The Commission shall elect a chairman and vice-chairman from among its membership. A majority 566 of the members shall constitute a quorum. The Commission shall meet not less than four times each 567 568 year. The meetings of the Commission shall be held at the call of the chairman or whenever the 569 majority of the members so request.

570 § 2.2-2648. State Executive Council for Comprehensive Services for At-Risk Youth and Families; 571 membership; meetings; powers and duties.

572 A. The State Executive Council for Comprehensive Services for At-Risk Youth and Families (the 573 Council) is established as a supervisory council, within the meaning of § 2.2-2100, in the executive 574 branch of state government.

B. The Council shall consist of one member of the House of Delegates to be appointed by the 575 576 Speaker of the House and one member of the Senate to be appointed by the Senate Committee on Rules; the Commissioners of Health, of Mental Health, Mental RetardationIntellectual Disability and 577 578 Substance Abuse Services, and of Social Services; the Superintendent of Public Instruction; the 579 Executive Secretary of the Virginia Supreme Court; the Director of the Department of Juvenile Justice; 580 the Director of the Department of Medical Assistance Services; the chairman of the state and local 581 advisory team established pursuant to § 2.2-5202; two local government representatives to include a 582 member of a county board of supervisors or a city council and a county administrator or city manager, 583 to be appointed by the Governor; a private provider representative from a facility that maintains 584 membership in an association of providers for children's or family services and receives funding as authorized by the Comprehensive Services Act (§ 2.2-5200 et seq.), to be appointed by the Governor, 585 who may appoint from nominees recommended by the Virginia Coalition of Private Provider 586 Associations; and a parent representative. The parent representative shall be appointed by the Governor 587 588 for a term not to exceed three years and shall not be an employee of any public or private program that 589 serves children and families. Appointments of legislative members shall be for terms coincident with 590 their terms of office. Legislative members shall not be included for the purposes of constituting a 591 quorum.

592 C. The Council shall be chaired by the Secretary of Health and Human Resources or a designated 593 deputy who shall be responsible for convening the council. The Council shall meet, at a minimum, 594 quarterly, to oversee the administration of this article and make such decisions as may be necessary to 595 carry out its purposes. Legislative members shall receive compensation as provided in § 30-19.12 and 596 nonlegislative citizen members shall receive compensation for their services as provided in §§ 2.2-2813 597 and 2.2-2825. 598

D. The Council shall have the following powers and duties:

599 1. Hire and supervise a director of the Office of Comprehensive Services for At-Risk Youth and 600 Families:

601 2. Appoint the members of the state and local advisory team in accordance with the requirements of 602 § 2.2-5201;

603 3. Provide for the establishment of interagency programmatic and fiscal policies developed by the 604 Office of Comprehensive Services for At-Risk Youth and Families, which support the purposes of the 605 Comprehensive Services Act (§ 2.2-5200 et seq.), through the promulgation of regulations by the 606 participating state boards or by administrative action, as appropriate;

607 4. Provide for a public participation process for programmatic and fiscal guidelines and dispute 608 resolution procedures developed for administrative actions that support the purposes of the Comprehensive Services Act (§ 2.2-5200 et seq.). The public participation process shall include, at a 609 610 minimum, 60 days of public comment and the distribution of these guidelines and procedures to all 611 interested parties:

5. Oversee the administration of and consult with the Virginia Municipal League and the Virginia 612 613 Association of Counties about state policies governing the use, distribution and monitoring of moneys in

619 governments, providers and parents;

620 8. Advise the Governor and appropriate Cabinet Secretaries on proposed policy and operational

623 9. Provide administrative support and fiscal incentives for the establishment and operation of local
 624 comprehensive service systems;

625 10. Oversee coordination of early intervention programs to promote comprehensive, coordinated

 627 communities. Early intervention programs include state programs under the administrative control of the

635 13. Oversee the development and implementation of uniform guidelines for documentation for 636 CSA-funded services;

637 14. Review and approve a request by a CPMT to establish a collaborative, multidisciplinary team638 process for referral and reviews of children and families pursuant to § 2.2-5209;

639 15. Oversee the development and implementation of mandatory uniform guidelines for utilization
640 management; each locality receiving funds for activities under the Comprehensive Services Act shall
641 have a locally determined utilization management plan following the guidelines or use of a process
642 approved by the Council for utilization management, covering all CSA-funded services;

643 16. Oversee the development, implementation, and collection of uniform data collection standards,
644 and the development of outcome measures; including, but not limited to, expenditures, number of youth
645 served in specific CSA activities, length of stay for residents in core licensed residential facilities, and
646 proportion of youth placed in treatment settings suggested by a uniform assessment instrument for
647 CSA-funded services;

648 17. Establish and oversee the operation of an informal review and negotiation process with the 649 Director of the Office of Comprehensive Services and a formal dispute resolution procedure before the 650 State Executive Council, which include formal notice and an appeals process, should the Director or 651 Council find, upon a formal written finding, that a CPMT failed to comply with any provision of this Act. "Formal notice" means the Director or Council provides a letter of notification, which 652 653 communicates the Director's or the Council's finding, explains the effect of the finding, and describes the 654 appeal process, to the chief administrative officer of the local government with a copy to the chair of the CPMT. The dispute resolution procedure shall also include provisions for remediation by the CPMT 655 656 that shall include a plan of correction recommended by the Council and submitted to the CPMT. If the 657 Council denies reimbursement from the state pool of funds, the Council and the locality shall develop a 658 plan of repayment;

659 18. Deny state funding to a locality where the CPMT fails to provide services that comply with the 660 Comprehensive Services Act (§ 2.2-5200 et seq.), in accordance with subdivision 17; and

661 19. Biennially publish and disseminate to members of the General Assembly and community policy
and management teams a state progress report on comprehensive services to children, youth and families
and a plan for such services for the next succeeding biennium. The state plan shall:

a. Provide a fiscal profile of current and previous years' federal and state expenditures for a comprehensive service system for children, youth and families;

b. Incorporate information and recommendations from local comprehensive service systems withresponsibility for planning and delivering services to children, youth and families;

668 c. Identify and establish goals for comprehensive services and the estimated costs of implementing
 669 these goals, report progress toward previously identified goals and establish priorities for the coming
 670 biennium; and

671 d. Include such other information or recommendations as may be necessary and appropriate for the 672 improvement and coordinated development of the state's comprehensive services system.

675 A. The Office of Comprehensive Services for At-Risk Youth and Families is hereby established to 676 serve as the administrative entity of the Council and to ensure that the decisions of the council are implemented. The director shall be hired by and subject to the direction and supervision of the Council 677 678 pursuant to § 2.2-2648.

679 B. The director of the Office of Comprehensive Services for At-Risk Youth and Families shall:

680 1. Develop and recommend to the state executive council programs and fiscal policies that promote 681 and support cooperation and collaboration in the provision of services to troubled and at-risk youths and **682** their families at the state and local levels;

683 2. Develop and recommend to the Council state interagency policies governing the use, distribution **684** and monitoring of moneys in the state pool of funds and the state trust fund;

685 3. Develop and provide for the consistent oversight for program administration and compliance with 686 state policies and procedures;

687 4. Provide for training and technical assistance to localities in the provision of efficient and effective 688 services that are responsive to the strengths and needs of troubled and at-risk youths and their families;

689 5. Serve as liaison to the participating state agencies that administratively support the Office and that 690 provide other necessary services;

691 6. Provide an informal review and negotiation process pursuant to subdivision D 17 of § 2.2-2648;

7. Implement, in collaboration with participating state agencies, policies, guidelines and procedures **692** 693 adopted by the State Executive Council;

694 8. Consult regularly with the Virginia Municipal League and the Virginia Association of Counties about implementation and operation of the Comprehensive Services Act (§ 2.2-5200 et seq.); 695 696

9. Hire appropriate staff as approved by the Council; and

10. Perform such other duties as may be assigned by the State Executive Council.

698 C. The director of the Office of Comprehensive Services, in order to provide support and assistance 699 to the Comprehensive Policy and Management Teams (CPMTs) and Family Assessment and Planning 700 Teams (FAPTs) established pursuant to the Comprehensive Services Act for At-Risk Youth and Families 701 (§ 2.2-5200 et seq.), shall:

702 1. Develop and maintain a web-based statewide automated database, with support from the 703 Department of Information Technology or its successor agency, of the authorized vendors of the 704 Comprehensive Services Act (CSA) services to include verification of a vendor's licensure status, a 705 listing of each discrete CSA service offered by the vendor, and the discrete CSA service's rate 706 determined in accordance with § 2.2-5214; and

707 2. Develop, in consultation with the Department of General Services, CPMTs, and vendors, a 708 standardized purchase of services contract, which in addition to general contract provisions when 709 utilizing state pool funds will enable localities to specify the discrete service or services they are 710 purchasing for the specified client, the required reporting of the client's service data, including types and 711 numbers of disabilities, mental health and mental retardationintellectual disability diagnoses, or 712 delinquent behaviors for which the purchased services are intended to address, the expected outcomes 713 resulting from these services and the performance timeframes mutually agreed to when the services are 714 purchased.

§ 2.2-2664. Virginia Interagency Coordinating Council; purpose; membership; duties.

A. The Virginia Interagency Coordinating Council (the Council) is established as an advisory council, 716 717 within the meaning of § 2.2-2100, in the executive branch of state government. The purpose of the Council shall be to promote and coordinate early intervention services in the Commonwealth. 718

719 B. The membership and operation of the Council shall be as required by Part C of the Individuals 720 with Disabilities Education Act (20 U.S.C. § 1431 et seq.). The Commissioner of the Department of Health, the Director of the Department for the Deaf and Hard-of-Hearing, the Superintendent of Public 721 722 Instruction, the Director of the Department of Medical Assistance Services, the Commissioner of the 723 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, 724 the Commissioner of the Department of Social Services, the Commissioner of the Department for the 725 Blind and Vision Impaired, the Director of the Virginia Office for Protection and Advocacy, and the 726 Commissioner of the Bureau of Insurance within the State Corporation Commission shall each appoint 727 one person from his agency to serve as the agency's representative on the Council.

Agency representatives shall regularly inform their agency head of the Council's activities and the 728 729 status of the implementation of an early intervention services system in the Commonwealth. 730

C. The Council's duties shall include advising and assisting the state lead agency in the following:

1. Performing its responsibilities for the early intervention services system;

732 2. Identifying sources of fiscal and other support for early intervention services, recommending 733 financial responsibility arrangements among agencies, and promoting interagency agreements;

3. Developing strategies to encourage full participation, coordination, and cooperation of all 734 735 appropriate agencies:

4. Resolving interagency disputes; 736

737 5. Gathering information about problems that impede timely and effective service delivery and taking738 steps to ensure that any identified policy problems are resolved;

**739** 6. Preparing federal grant applications; and

740 7. Preparing and submitting an annual report to the Governor and the U.S. Secretary of Education on741 the status of early intervention services within the Commonwealth.

**742** § 2.2-2696. Substance Abuse Services Council.

A. The Substance Abuse Services Council (the Council) is established as an advisory council, within
the meaning of § 2.2-2100, in the executive branch of state government. The purpose of the Council is
to advise and make recommendations to the Governor, the General Assembly, and the State Mental
Health, Mental RetardationIntellectual Disability and Substance Abuse Services Board on broad policies
and goals and on the coordination of the Commonwealth's public and private efforts to control substance
abuse, as defined in § 37.2-100.

749 B. The Council shall consist of 30 members. Four members of the House of Delegates shall be 750 appointed by the Speaker of the House of Delegates, in accordance with the principles of proportional 751 representation contained in the Rules of the House of Delegates, and two members of the Senate shall 752 be appointed by the Senate Committee on Rules. The Governor shall appoint one member representing 753 the Virginia Sheriffs' Association, one member representing the Virginia Drug Courts Association, one 754 member representing the Substance Abuse Certification Alliance of Virginia, two members representing 755 the Virginia Association of Community Services Boards, and two members representing statewide 756 consumer and advocacy organizations. The Council shall also include the Commissioner of the 757 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services; 758 the Commissioner of Health; the Commissioner of the Department of Motor Vehicles; the 759 Superintendent of Public Instruction; the Directors of the Departments of Juvenile Justice, Corrections, Criminal Justice Services, Medical Assistance Services, and Social Services; the Chief Operating Officer 760 of the Department of Alcoholic Beverage Control; the Executive Director of the Governor's Office for 761 Substance Abuse Prevention or his designee; the Executive Director of the Virginia Tobacco Settlement 762 763 Foundation or his designee; the Executive Director of the Commission on the Virginia Alcohol Safety Action Program or his designee; and the chairs or their designees of the Virginia Association of Drug 764 765 and Alcohol Programs, the Virginia Association of Alcoholism and Drug Abuse Counselors, and the 766 Substance Abuse Council and the Prevention Task Force of the Virginia Association of Community 767 Services Boards.

768 C. Appointments of legislative members and heads of agencies or representatives of organizations
769 shall be for terms consistent with their terms of office. All other appointments of nonlegislative
770 members shall be for terms of three years, except an appointment to fill a vacancy, which shall be for
771 the unexpired term. The Governor shall appoint a chairman from among the members.

772 No person shall be eligible to serve more than two successive terms, provided that a person 773 appointed to fill a vacancy may serve two full successive terms.

774 D. The Council shall meet at least four times annually and more often if deemed necessary or 775 advisable by the chairman.

E. Members of the Council shall receive no compensation for their services but shall be reimbursed for all reasonable and necessary expenses incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the cost of expenses shall be provided by the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services.

F. The duties of the Council shall be:

781 1. To recommend policies and goals to the Governor, the General Assembly, and the State Mental
 782 Health, Mental RetardationIntellectual Disability and Substance Abuse Services Board;

783 2. To coordinate agency programs and activities, to prevent duplication of functions, and to combine784 all agency plans into a comprehensive interagency state plan for substance abuse services;

785 3. To review and comment on annual state agency budget requests regarding substance abuse and on786 all applications for state or federal funds or services to be used in substance abuse programs;

787 4. To define responsibilities among state agencies for various programs for persons with substance788 abuse and to encourage cooperation among agencies; and

789 5. To make investigations, issue annual reports to the Governor and the General Assembly, and make790 recommendations relevant to substance abuse upon the request of the Governor.

791 G. Staff assistance shall be provided to the Council by the Office of Substance Abuse Services of the
792 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services.
793 § 2.2-2818. Health and related insurance for state employees.

A. The Department of Human Resource Management shall establish a plan, subject to the approval of the Governor, for providing health insurance coverage, including chiropractic treatment, hospitalization, medical, surgical and major medical coverage, for state employees and retired state employees with the Commonwealth paying the cost thereof to the extent of the coverage included in

798 such plan. The same plan shall be offered to all part-time state employees, but the total cost shall be 799 paid by such part-time employees. The Department of Human Resource Management shall administer 800 this section. The plan chosen shall provide means whereby coverage for the families or dependents of 801 state employees may be purchased. Except for part-time employees, the Commonwealth may pay all or a 802 portion of the cost thereof, and for such portion as the Commonwealth does not pay, the employee, 803 including a part-time employee, may purchase the coverage by paying the additional cost over the cost 804 of coverage for an employee.

805 Such contribution shall be financed through appropriations provided by law. 806

B. The plan shall:

807 1. Include coverage for low-dose screening mammograms for determining the presence of occult 808 breast cancer. Such coverage shall make available one screening mammogram to persons age 35 through 809 39, one such mammogram biennially to persons age 40 through 49, and one such mammogram annually 810 to persons age 50 and over and may be limited to a benefit of \$50 per mammogram subject to such 811 dollar limits, deductibles, and coinsurance factors as are no less favorable than for physical illness 812 generally.

813 The term "mammogram" shall mean an X-ray examination of the breast using equipment dedicated 814 specifically for mammography, including but not limited to the X-ray tube, filter, compression device, 815 screens, film, and cassettes, with an average radiation exposure of less than one rad mid-breast, two 816 views of each breast.

817 In order to be considered a screening mammogram for which coverage shall be made available under 818 this section:

819 a. The mammogram shall be (i) ordered by a health care practitioner acting within the scope of his 820 licensure and, in the case of an enrollee of a health maintenance organization, by the health maintenance 821 organization provider; (ii) performed by a registered technologist; (iii) interpreted by a qualified 822 radiologist; and (iv) performed under the direction of a person licensed to practice medicine and surgery 823 and certified by the American Board of Radiology or an equivalent examining body. A copy of the 824 mammogram report shall be sent or delivered to the health care practitioner who ordered it;

825 b. The equipment used to perform the mammogram shall meet the standards set forth by the Virginia 826 Department of Health in its radiation protection regulations; and

827 c. The mammography film shall be retained by the radiologic facility performing the examination in 828 accordance with the American College of Radiology guidelines or state law.

829 2. Include coverage for the treatment of breast cancer by dose-intensive chemotherapy with 830 autologous bone marrow transplants or stem cell support when performed at a clinical program 831 authorized to provide such therapies as a part of clinical trials sponsored by the National Cancer Institute. For persons previously covered under the plan, there shall be no denial of coverage due to the 832 833 existence of a preexisting condition.

834 3. Include coverage for postpartum services providing inpatient care and a home visit or visits that 835 shall be in accordance with the medical criteria, outlined in the most current version of or an official 836 update to the "Guidelines for Perinatal Care" prepared by the American Academy of Pediatrics and the 837 American College of Obstetricians and Gynecologists or the "Standards for Obstetric-Gynecologic 838 Services" prepared by the American College of Obstetricians and Gynecologists. Such coverage shall be 839 provided incorporating any changes in such Guidelines or Standards within six months of the publication 840 of such Guidelines or Standards or any official amendment thereto.

841 4. Include an appeals process for resolution of written complaints concerning denials or partial 842 denials of claims that shall provide reasonable procedures for resolution of such written complaints and 843 shall be published and disseminated to all covered state employees. The appeals process shall include a separate expedited emergency appeals procedure that shall provide resolution within one business day of 844 845 receipt of a complaint concerning situations requiring immediate medical care. For appeals involving 846 adverse decisions as defined in § 32.1-137.7, the Department shall contract with one or more impartial 847 health entities to review such decisions. Impartial health entities may include medical peer review 848 organizations and independent utilization review companies. The Department shall adopt regulations to 849 assure that the impartial health entity conducting the reviews has adequate standards, credentials and 850 experience for such review. The impartial health entity shall examine the final denial of claims to 851 determine whether the decision is objective, clinically valid, and compatible with established principles 852 of health care. The decision of the impartial health entity shall (i) be in writing, (ii) contain findings of 853 fact as to the material issues in the case and the basis for those findings, and (iii) be final and binding if 854 consistent with law and policy.

855 Prior to assigning an appeal to an impartial health entity, the Department shall verify that the 856 impartial health entity conducting the review of a denial of claims has no relationship or association 857 with (i) the covered employee; (ii) the treating health care provider, or any of its employees or affiliates; 858 (iii) the medical care facility at which the covered service would be provided, or any of its employees or 859 affiliates; or (iv) the development or manufacture of the drug, device, procedure or other therapy that is

the subject of the final denial of a claim. The impartial health entity shall not be a subsidiary of, nor
owned or controlled by, a health plan, a trade association of health plans, or a professional association
of health care providers. There shall be no liability on the part of and no cause of action shall arise
against any officer or employee of an impartial health entity for any actions taken or not taken or
statements made by such officer or employee in good faith in the performance of his powers and duties.

865 5. Include coverage for early intervention services. For purposes of this section, "early intervention 866 services" means medically necessary speech and language therapy, occupational therapy, physical therapy 867 and assistive technology services and devices for dependents from birth to age three who are certified by 868 the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 869 Services as eligible for services under Part H of the Individuals with Disabilities Education Act (20 870 U.S.C. § 1471 et seq.). Medically necessary early intervention services for the population certified by the 871 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services 872 shall mean those services designed to help an individual attain or retain the capability to function 873 age-appropriately within his environment, and shall include services that enhance functional ability 874 without effecting a cure.

875 For persons previously covered under the plan, there shall be no denial of coverage due to the
876 existence of a preexisting condition. The cost of early intervention services shall not be applied to any
877 contractual provision limiting the total amount of coverage paid by the insurer to or on behalf of the
878 insured during the insured's lifetime.

879 6. Include coverage for prescription drugs and devices approved by the United States Food and Drug880 Administration for use as contraceptives.

7. Not deny coverage for any drug approved by the United States Food and Drug Administration for
use in the treatment of cancer on the basis that the drug has not been approved by the United States
Food and Drug Administration for the treatment of the specific type of cancer for which the drug has
been prescribed, if the drug has been recognized as safe and effective for treatment of that specific type
of cancer in one of the standard reference compendia.

886 8. Not deny coverage for any drug prescribed to treat a covered indication so long as the drug has
887 been approved by the United States Food and Drug Administration for at least one indication and the
888 drug is recognized for treatment of the covered indication in one of the standard reference compendia or
889 in substantially accepted peer-reviewed medical literature.

9. Include coverage for equipment, supplies and outpatient self-management training and education,
including medical nutrition therapy, for the treatment of insulin-dependent diabetes, insulin-using
diabetes, gestational diabetes and noninsulin-using diabetes if prescribed by a healthcare professional
legally authorized to prescribe such items under law. To qualify for coverage under this subdivision,
diabetes outpatient self-management training and education shall be provided by a certified, registered or
licensed health care professional.

896 10. Include coverage for reconstructive breast surgery. For purposes of this section, "reconstructive breast surgery" means surgery performed on and after July 1, 1998, (i) coincident with a mastectomy performed for breast cancer or (ii) following a mastectomy performed for breast cancer to reestablish symmetry between the two breasts. For persons previously covered under the plan, there shall be no denial of coverage due to preexisting conditions.

901 11. Include coverage for annual pap smears, including coverage, on and after July 1, 1999, for902 annual testing performed by any FDA-approved gynecologic cytology screening technologies.

903 12. Include coverage providing a minimum stay in the hospital of not less than 48 hours for a patient 904 following a radical or modified radical mastectomy and 24 hours of inpatient care following a total 905 mastectomy or a partial mastectomy with lymph node dissection for treatment of breast cancer. Nothing 906 in this subdivision shall be construed as requiring the provision of inpatient coverage where the 907 attending physician in consultation with the patient determines that a shorter period of hospital stay is 908 appropriate.

909 13. Include coverage (i) to persons age 50 and over and (ii) to persons age 40 and over who are at high risk for prostate cancer, according to the most recent published guidelines of the American Cancer
911 Society, for one PSA test in a 12-month period and digital rectal examinations, all in accordance with
912 American Cancer Society guidelines. For the purpose of this subdivision, "PSA testing" means the analysis of a blood sample to determine the level of prostate specific antigen.

914 14. Permit any individual covered under the plan direct access to the health care services of a 915 participating specialist (i) authorized to provide services under the plan and (ii) selected by the covered 916 individual. The plan shall have a procedure by which an individual who has an ongoing special or condition may, after consultation with the primary care physician, receive a referral to a specialist for such condition who shall be responsible for and capable of providing and coordinating the individual's 919 primary and specialty care related to the initial specialty care referral. If such an individual to a specialist.

921 For the purposes of this subdivision, "special condition" means a condition or disease that is (i) 922 life-threatening, degenerative, or disabling and (ii) requires specialized medical care over a prolonged 923 period of time. Within the treatment period authorized by the referral, such specialist shall be permitted 924 to treat the individual without a further referral from the individual's primary care provider and may 925 authorize such referrals, procedures, tests, and other medical services related to the initial referral as the individual's primary care provider would otherwise be permitted to provide or authorize. The plan shall 926 927 have a procedure by which an individual who has an ongoing special condition that requires ongoing 928 care from a specialist may receive a standing referral to such specialist for the treatment of the special 929 condition. If the primary care provider, in consultation with the plan and the specialist, if any, 930 determines that such a standing referral is appropriate, the plan or issuer shall make such a referral to a 931 specialist. Nothing contained herein shall prohibit the plan from requiring a participating specialist to provide written notification to the covered individual's primary care physician of any visit to such 932 933 specialist. Such notification may include a description of the health care services rendered at the time of 934 the visit.

935 15. Include provisions allowing employees to continue receiving health care services for a period of up to 90 days from the date of the primary care physician's notice of termination from any of the plan's 936 937 provider panels. The plan shall notify any provider at least 90 days prior to the date of termination of 938 the provider, except when the provider is terminated for cause.

939 For a period of at least 90 days from the date of the notice of a provider's termination from any of 940 the plan's provider panels, except when a provider is terminated for cause, a provider shall be permitted 941 by the plan to render health care services to any of the covered employees who (i) were in an active 942 course of treatment from the provider prior to the notice of termination and (ii) request to continue receiving health care services from the provider. 943

944 Notwithstanding the provisions of this subdivision, any provider shall be permitted by the plan to 945 continue rendering health services to any covered employee who has entered the second trimester of 946 pregnancy at the time of the provider's termination of participation, except when a provider is terminated 947 for cause. Such treatment shall, at the covered employee's option, continue through the provision of 948 postpartum care directly related to the delivery.

949 Notwithstanding the provisions of this subdivision, any provider shall be permitted to continue 950 rendering health services to any covered employee who is determined to be terminally ill (as defined 951 under § 1861 (dd) (3) (A) of the Social Security Act) at the time of a provider's termination of 952 participation, except when a provider is terminated for cause. Such treatment shall, at the covered 953 employee's option, continue for the remainder of the employee's life for care directly related to the 954 treatment of the terminal illness.

955 A provider who continues to render health care services pursuant to this subdivision shall be 956 reimbursed in accordance with the carrier's agreement with such provider existing immediately before 957 the provider's termination of participation.

958 16. Include coverage for patient costs incurred during participation in clinical trials for treatment 959 studies on cancer, including ovarian cancer trials.

960 The reimbursement for patient costs incurred during participation in clinical trials for treatment 961 studies on cancer shall be determined in the same manner as reimbursement is determined for other 962 medical and surgical procedures. Such coverage shall have durational limits, dollar limits, deductibles, 963 copayments and coinsurance factors that are no less favorable than for physical illness generally. 964

For purposes of this subdivision:

"Cooperative group" means a formal network of facilities that collaborate on research projects and have an established NIH-approved peer review program operating within the group. "Cooperative group" 965 966 includes (i) the National Cancer Institute Clinical Cooperative Group and (ii) the National Cancer 967 Institute Community Clinical Oncology Program. 968 969

'FDA" means the Federal Food and Drug Administration.

"Multiple project assurance contract" means a contract between an institution and the federal 970 971 Department of Health and Human Services that defines the relationship of the institution to the federal 972 Department of Health and Human Services and sets out the responsibilities of the institution and the 973 procedures that will be used by the institution to protect human subjects.

- 974 "NCI" means the National Cancer Institute.
- 975 "NIH" means the National Institutes of Health.
- 976 "Patient" means a person covered under the plan established pursuant to this section.

977 "Patient cost" means the cost of a medically necessary health care service that is incurred as a result of the treatment being provided to a patient for purposes of a clinical trial. "Patient cost" does not 978 979 include (i) the cost of nonhealth care services that a patient may be required to receive as a result of the 980 treatment being provided for purposes of a clinical trial, (ii) costs associated with managing the research 981 associated with the clinical trial, or (iii) the cost of the investigational drug or device.

982 Coverage for patient costs incurred during clinical trials for treatment studies on cancer shall be

983 provided if the treatment is being conducted in a Phase II, Phase III, or Phase IV clinical trial. Such treatment may, however, be provided on a case-by-case basis if the treatment is being provided in a Phase I clinical trial.

**986** The treatment described in the previous paragraph shall be provided by a clinical trial approved by:

- **987** a. The National Cancer Institute;
- **988** b. An NCI cooperative group or an NCI center;
- 989 c. The FDA in the form of an investigational new drug application;
- d. The federal Department of Veterans Affairs; or
- e. An institutional review board of an institution in the Commonwealth that has a multiple projectassurance contract approved by the Office of Protection from Research Risks of the NCI.
- 993 The facility and personnel providing the treatment shall be capable of doing so by virtue of their 994 experience, training, and expertise.
- 995 Coverage under this subdivision shall apply only if:
- **996** (1) There is no clearly superior, noninvestigational treatment alternative;

997 (2) The available clinical or preclinical data provide a reasonable expectation that the treatment will998 be at least as effective as the noninvestigational alternative; and

(3) The patient and the physician or health care provider who provides services to the patient underthe plan conclude that the patient's participation in the clinical trial would be appropriate, pursuant toprocedures established by the plan.

1002 17. Include coverage providing a minimum stay in the hospital of not less than 23 hours for a 1003 covered employee following a laparoscopy-assisted vaginal hysterectomy and 48 hours for a covered 1004 employee following a vaginal hysterectomy, as outlined in Milliman & Robertson's nationally recognized 1005 guidelines. Nothing in this subdivision shall be construed as requiring the provision of the total hours 1006 referenced when the attending physician, in consultation with the covered employee, determines that a 1007 shorter hospital stay is appropriate.

1008

18. Include coverage for biologically based mental illness.

For purposes of this subdivision, a "biologically based mental illness" is any mental or nervous condition caused by a biological disorder of the brain that results in a clinically significant syndrome that substantially limits the person's functioning; specifically, the following diagnoses are defined as biologically based mental illness as they apply to adults and children: schizophrenia, schizoaffective disorder, bipolar disorder, major depressive disorder, panic disorder, obsessive-compulsive disorder, attention deficit hyperactivity disorder, autism, and drug and alcoholism addiction.

1015 Coverage for biologically based mental illnesses shall neither be different nor separate from coverage
1016 for any other illness, condition or disorder for purposes of determining deductibles, benefit year or
1017 lifetime durational limits, benefit year or lifetime dollar limits, lifetime episodes or treatment limits,
1018 copayment and coinsurance factors, and benefit year maximum for deductibles and copayment and
1019 coinsurance factors.

Nothing shall preclude the undertaking of usual and customary procedures to determine the appropriateness of, and medical necessity for, treatment of biologically based mental illnesses under this option, provided that all such appropriateness and medical necessity determinations are made in the same manner as those determinations made for the treatment of any other illness, condition or disorder to covered by such policy or contract.

1025 In no case, however, shall coverage for mental disorders provided pursuant to this section be diminished or reduced below the coverage in effect for such disorders on January 1, 1999.

1027 19. Offer and make available coverage for the treatment of morbid obesity through gastric bypass 1028 surgery or such other methods as may be recognized by the National Institutes of Health as effective for 1029 the long-term reversal of morbid obesity. Such coverage shall have durational limits, dollar limits, 1030 deductibles, copayments and coinsurance factors that are no less favorable than for physical illness 1031 generally. Access to surgery for morbid obesity shall not be restricted based upon dietary or any other 1032 criteria not approved by the National Institutes of Health. For purposes of this subdivision, "morbid 1033 obesity" means (i) a weight that is at least 100 pounds over or twice the ideal weight for frame, age, 1034 height, and gender as specified in the 1983 Metropolitan Life Insurance tables, (ii) a body mass index 1035 (BMI) equal to or greater than 35 kilograms per meter squared with comorbidity or coexisting medical 1036 conditions such as hypertension, cardiopulmonary conditions, sleep apnea, or diabetes, or (iii) a BMI of 1037 40 kilograms per meter squared without such comorbidity. As used herein, "BMI" equals weight in 1038 kilograms divided by height in meters squared.

1039 20. Include coverage for colorectal cancer screening, specifically screening with an annual fecal
1040 occult blood test, flexible sigmoidoscopy or colonoscopy, or in appropriate circumstances radiologic
1041 imaging, in accordance with the most recently published recommendations established by the American
1042 College of Gastroenterology, in consultation with the American Cancer Society, for the ages, family
1043 histories, and frequencies referenced in such recommendations. The coverage for colorectal cancer

screening shall not be more restrictive than or separate from coverage provided for any other illness,
condition or disorder for purposes of determining deductibles, benefit year or lifetime durational limits,
benefit year or lifetime dollar limits, lifetime episodes or treatment limits, copayment and coinsurance
factors, and benefit year maximum for deductibles and copayments and coinsurance factors.

1048 21. On and after July 1, 2002, require that a prescription benefit card, health insurance benefit card, 1049 or other technology that complies with the requirements set forth in § 38.2-3407.4:2 be issued to each 1050 employee provided coverage pursuant to this section, and shall upon any changes in the required data 1051 elements set forth in subsection A of § 38.2-3407.4:2, either reissue the card or provide employees 1052 covered under the plan such corrective information as may be required to electronically process a 1053 prescription claim.

1054 22. Include coverage for infant hearing screenings and all necessary audiological examinations 1055 provided pursuant to § 32.1-64.1 using any technology approved by the United States Food and Drug 1056 Administration, and as recommended by the national Joint Committee on Infant Hearing in its most 1057 current position statement addressing early hearing detection and intervention programs. Such coverage 1058 shall include follow-up audiological examinations as recommended by a physician, physician assistant, 1059 nurse practitioner or audiologist and performed by a licensed audiologist to confirm the existence or 1060 absence of hearing loss.

C. Claims incurred during a fiscal year but not reported during that fiscal year shall be paid from 1061 1062 such funds as shall be appropriated by law. Appropriations, premiums and other payments shall be 1063 deposited in the employee health insurance fund, from which payments for claims, premiums, cost 1064 containment programs and administrative expenses shall be withdrawn from time to time. The funds of 1065 the health insurance fund shall be deemed separate and independent trust funds, shall be segregated from 1066 all other funds of the Commonwealth, and shall be invested and administered solely in the interests of the employees and their beneficiaries. Neither the General Assembly nor any public officer, employee, 1067 1068 or agency shall use or authorize the use of such trust funds for any purpose other than as provided in 1069 law for benefits, refunds, and administrative expenses, including but not limited to legislative oversight 1070 of the health insurance fund.

D. For the purposes of this section:

1072 "Peer-reviewed medical literature" means a scientific study published only after having been critically
1073 reviewed for scientific accuracy, validity, and reliability by unbiased independent experts in a journal
1074 that has been determined by the International Committee of Medical Journal Editors to have met the
1075 Uniform Requirements for Manuscripts submitted to biomedical journals. Peer-reviewed medical
1076 literature does not include publications or supplements to publications that are sponsored to a significant
1077 extent by a pharmaceutical manufacturing company or health carrier.

1078 "Standard reference compendia" means the American Medical Association Drug Evaluations, the
 1079 American Hospital Formulary Service Drug Information, or the United States Pharmacopoeia Dispensing
 1080 Information.

1081 "State employee" means state employee as defined in § 51.1-124.3; employee as defined in
1082 § 51.1-201; the Governor, Lieutenant Governor and Attorney General; judge as defined in § 51.1-301
1083 and judges, clerks and deputy clerks of regional juvenile and domestic relations, county juvenile and
1084 domestic relations, and district courts of the Commonwealth; and interns and residents employed by the
1085 School of Medicine and Hospital of the University of Virginia, and interns, residents, and employees of
1086 the Virginia Commonwealth University Health System Authority as provided in § 23-50.16:24.

1087 "Part-time state employees" means classified or similarly situated employees in legislative, executive, judicial or independent agencies who are compensated on a salaried basis and work at least 20 hours, but less than 32 hours, per week.

E. Provisions shall be made for retired employees to obtain coverage under the above plan, including, as an option, coverage for vision and dental care. The Commonwealth may, but shall not be obligated to, pay all or any portion of the cost thereof.

F. Any self-insured group health insurance plan established by the Department of Human Resource
Management that utilizes a network of preferred providers shall not exclude any physician solely on the
basis of a reprimand or censure from the Board of Medicine, so long as the physician otherwise meets
the plan criteria established by the Department.

1097 G. The plan shall include, in each planning district, at least two health coverage options, each sponsored by unrelated entities. No later than July 1, 2006, one of the health coverage options to be available in each planning district shall be a high deductible health plan that would qualify for a health savings account pursuant to § 223 of the Internal Revenue Code of 1986, as amended.

1101 In each planning district that does not have an available health coverage alternative, the Department 1102 shall voluntarily enter into negotiations at any time with any health coverage provider who seeks to 1103 provide coverage under the plan.

1104 This subsection shall not apply to any state agency authorized by the Department to establish and 1105 administer its own health insurance coverage plan separate from the plan established by the Department. 1106 H. Any self-insured group health insurance plan established by the Department of Human Resource 1107 Management that includes coverage for prescription drugs on an outpatient basis may apply a formulary 1108 to the prescription drug benefits provided by the plan if the formulary is developed, reviewed at least 1109 annually, and updated as necessary in consultation with and with the approval of a pharmacy and 1110 therapeutics committee, a majority of whose members are actively practicing licensed (i) pharmacists, 1111 (ii) physicians, and (iii) other health care providers.

1112 If the plan maintains one or more drug formularies, the plan shall establish a process to allow a 1113 person to obtain, without additional cost-sharing beyond that provided for formulary prescription drugs 1114 in the plan, a specific, medically necessary nonformulary prescription drug if, after reasonable investigation and consultation with the prescriber, the formulary drug is determined to be an 1115 inappropriate therapy for the medical condition of the person. The plan shall act on such requests within 1116 1117 one business day of receipt of the request.

1118 I. Any plan established in accordance with this section requiring preauthorization prior to rendering 1119 medical treatment shall have personnel available to provide authorization at all times when such 1120 preauthorization is required.

1121 J. Any plan established in accordance with this section shall provide to all covered employees written 1122 notice of any benefit reductions during the contract period at least 30 days before such reductions 1123 become effective.

1124 K. No contract between a provider and any plan established in accordance with this section shall 1125 include provisions that require a health care provider or health care provider group to deny covered 1126 services that such provider or group knows to be medically necessary and appropriate that are provided 1127 with respect to a covered employee with similar medical conditions.

1128 L. The Department of Human Resource Management shall appoint an Ombudsman to promote and 1129 protect the interests of covered employees under any state employee's health plan.

1130 The Ombudsman shall:

1134

1131 1. Assist covered employees in understanding their rights and the processes available to them 1132 according to their state health plan. 1133

2. Answer inquiries from covered employees by telephone and electronic mail.

3. Provide to covered employees information concerning the state health plans.

1135 4. Develop information on the types of health plans available, including benefits and complaint 1136 procedures and appeals.

1137 5. Make available, either separately or through an existing Internet web site utilized by the 1138 Department of Human Resource Management, information as set forth in subdivision 4 and such 1139 additional information as he deems appropriate.

1140 6. Maintain data on inquiries received, the types of assistance requested, any actions taken and the 1141 disposition of each such matter.

1142 7. Upon request, assist covered employees in using the procedures and processes available to them from their health plan, including all appeal procedures. Such assistance may require the review of health 1143 1144 care records of a covered employee, which shall be done only with that employee's express written 1145 consent. The confidentiality of any such medical records shall be maintained in accordance with the 1146 confidentiality and disclosure laws of the Commonwealth.

1147 8. Ensure that covered employees have access to the services provided by the Ombudsman and that 1148 the covered employees receive timely responses from the Ombudsman or his representatives to the 1149 inquiries.

1150 9. Report annually on his activities to the standing committees of the General Assembly having 1151 jurisdiction over insurance and over health and the Joint Commission on Health Care by December 1 of 1152 each year.

1153 M. The plan established in accordance with this section shall not refuse to accept or make 1154 reimbursement pursuant to an assignment of benefits made to a dentist or oral surgeon by a covered 1155 employee.

1156 For purposes of this subsection, "assignment of benefits" means the transfer of dental care coverage 1157 reimbursement benefits or other rights under the plan. The assignment of benefits shall not be effective 1158 until the covered employee notifies the plan in writing of the assignment.

1159 N. Beginning July 1, 2006, any plan established pursuant to this section shall provide for an 1160 identification number, which shall be assigned to the covered employee and shall not be the same as the 1161 employee's social security number.

1162 O. Any group health insurance plan established by the Department of Human Resource Management 1163 that contains a coordination of benefits provision shall provide written notification to any eligible 1164 employee as a prominent part of its enrollment materials that if such eligible employee is covered under 1165 another group accident and sickness insurance policy, group accident and sickness subscription contract, 1166 or group health care plan for health care services, that insurance policy, subscription contract or health

1167 care plan may have primary responsibility for the covered expenses of other family members enrolled 1168 with the eligible employee. Such written notification shall describe generally the conditions upon which 1169 the other coverage would be primary for dependent children enrolled under the eligible employee's 1170 coverage and the method by which the eligible enrollee may verify from the plan that coverage would have primary responsibility for the covered expenses of each family member. 1171

1172 P. Any plan established by the Department of Human Resource Management pursuant to this section 1173 shall provide that coverage under such plan for family members enrolled under a participating state employee's coverage shall continue for a period of at least 30 days following the death of such state 1174 1175 employee.

1176 Q. The plan established in accordance with this section that follows a policy of sending its payment 1177 to the covered employee or covered family member for a claim for services received from a 1178 nonparticipating physician or osteopath shall (i) include language in the member handbook that notifies 1179 the covered employee of the responsibility to apply the plan payment to the claim from such nonparticipating provider, (ii) include this language with any such payment sent to the covered employee 1180 1181 or covered family member, and (iii) include the name and any last known address of the 1182 nonparticipating provider on the explanation of benefits statement.

1183 § 2.2-2905. Certain officers and employees exempt from chapter.

1184 The provisions of this chapter shall not apply to:

13. The employees of the Virginia Workers' Compensation Commission;

1204 14. The officers and employees of the Virginia Retirement System;

1205 15. Employees whose positions are identified by the State Council of Higher Education and the 1206 boards of the Virginia Museum of Fine Arts, The Science Museum of Virginia, the Jamestown-Yorktown Foundation, the Frontier Culture Museum of Virginia, the Virginia Museum of 1207 Natural History and The Library of Virginia, and approved by the Director of the Department of Human 1208 1209 Resource Management as requiring specialized and professional training;

- 1210 16. Employees of the State Lottery Department; 1211
  - 17. Production workers for the Virginia Industries for the Blind Sheltered Workshop programs;
  - 18. Employees of the Virginia Commonwealth University Health System Authority;

1213 19. Employees of the University of Virginia Medical Center. Any changes in compensation plans for such employees shall be subject to the review and approval of the Board of Visitors of the University of 1214 1215 Virginia. The University of Virginia shall ensure that its procedures for hiring University of Virginia 1216 Medical Center personnel are based on merit and fitness. Such employees shall remain subject to the 1217 provisions of the State Grievance Procedure (§ 2.2-3000 et seq.);

1218 20. In executive branch agencies the employee who has accepted serving in the capacity of chief 1219 deputy, or equivalent, and the employee who has accepted serving in the capacity of a confidential 1220 assistant for policy or administration. An employee serving in either one of these two positions shall be 1221 deemed to serve on an employment-at-will basis. An agency may not exceed two employees who serve 1222 in this exempt capacity;

1229 Commissioner after July 1, 1999, under a contract pursuant to § 37.2-707. Such employees shall remain1230 subject to the provisions of the State Grievance Procedure (§ 2.2-3000 et seq.);

**1231** 25. The Director of the Virginia Office for Protection and Advocacy;

1232 26. Employees of the Virginia Tobacco Settlement Foundation. Such employees shall be treated as
1233 state employees for purposes of participation in the Virginia Retirement System, health insurance, and
1234 all other employee benefits offered by the Commonwealth to its classified employees; and

- 1235 27. Employees of the Virginia Indigent Defense Commission.
- 1236 § 2.2-3705.3. Exclusions to application of chapter; records relating to administrative investigations.

1237 The following records are excluded from the provisions of this chapter but may be disclosed by the custodian in his discretion, except where such disclosure is prohibited by law:

Investigative notes and other correspondence and information furnished in confidence with respect 1255 to an investigation or conciliation process involving an alleged unlawful discriminatory practice under 1256 the Virginia Human Rights Act (§ 2.2-3900 et seq.) or under any local ordinance adopted in accordance with the authority specified in § 2.2-2638, or adopted pursuant to § 15.2-965, or adopted prior to July 1, 1257 1258 1987, in accordance with applicable law, relating to local human rights or human relations commissions. 1259 However, nothing in this section shall prohibit the distribution of information taken from inactive reports 1260 in a form that does not reveal the identity of the parties involved or other persons supplying 1261 information.

6. Records of studies and investigations by the State Lottery Department of (i) lottery agents, (ii)

Investigative notes, correspondence and information furnished in confidence, and records otherwise 1270 exempted by this chapter or any Virginia statute, provided to or produced by or for the (i) Auditor of 1271 Public Accounts; (ii) Joint Legislative Audit and Review Commission; (iii) Department of the State 1272 Internal Auditor with respect to an investigation initiated through the State Employee Fraud, Waste and 1273 Abuse Hotline; (iv) committee or the auditor with respect to an investigation or audit conducted pursuant to § 15.2-825; or (v) auditors, appointed by the local governing body of any county, city or 1274 1275 town or a school board, who by charter, ordinance, or statute have responsibility for conducting an 1276 investigation of any officer, department or program of such body. Records of completed investigations 1277 shall be disclosed in a form that does not reveal the identity of the complainants or persons supplying 1278 information to investigators. Unless disclosure is prohibited by this section, the records disclosed shall 1279 include, but not be limited to, the agency involved, the identity of the person who is the subject of the complaint, the nature of the complaint, and the actions taken to resolve the complaint. 1304 12. Records furnished to or prepared by the Board of Education pursuant to subsection D of 1305 § 22.1-253.13:3 in connection with the review or investigation of any alleged breach in security, 1306 unauthorized alteration, or improper administration of tests by local school board employees responsible 1307 for the distribution or administration of the tests. However, this section shall not prohibit the disclosure 1308 of records to (i) a local school board or division superintendent for the purpose of permitting such board 1309 or superintendent to consider or to take personnel action with regard to an employee or (ii) any 1310 requester, after the conclusion of a review or investigation, in a form that (a) does not reveal the identity 1311 of any person making a complaint or supplying information to the Board on a confidential basis and (b) 1312 does not compromise the security of any test mandated by the Board. 1313

§ 2.2-3705.5. Exclusions to application of chapter; health and social services records.

1314 The following records are excluded from the provisions of this chapter but may be disclosed by the 1315 custodian in his discretion, except where such disclosure is prohibited by law:

1316 1. Health records, except that such records may be personally reviewed by the individual who is the subject of such records, as provided in subsection F of § 32.1-127.1:03. 1317

1318 Where the person who is the subject of health records is confined in a state or local correctional 1319 facility, the administrator or chief medical officer of such facility may assert such confined person's right 1320 of access to the health records if the administrator or chief medical officer has reasonable cause to 1321 believe that such confined person has an infectious disease or other medical condition from which other 1322 persons so confined need to be protected. Health records shall only be reviewed and shall not be copied 1323 by such administrator or chief medical officer. The information in the health records of a person so 1324 confined shall continue to be confidential and shall not be disclosed by the administrator or chief 1325 medical officer of the facility to any person except the subject or except as provided by law.

1326 Where the person who is the subject of health records is under the age of 18, his right of access may 1327 be asserted only by his guardian or his parent, including a noncustodial parent, unless such parent's 1328 parental rights have been terminated, a court of competent jurisdiction has restricted or denied such 1329 access, or a parent has been denied access to the health record in accordance with § 20-124.6. In 1330 instances where the person who is the subject thereof is an emancipated minor, a student in a public 1331 institution of higher education, or is a minor who has consented to his own treatment as authorized by 1332 § 16.1-338 or 54.1-2969, the right of access may be asserted by the subject person.

1333 For the purposes of this chapter, statistical summaries of incidents and statistical data concerning 1334 patient abuse as may be compiled by the Commissioner of the Department of Mental Health, Mental 1335 RetardationIntellectual Disability and Substance Abuse Services shall be open to inspection and copying as provided in § 2.2-3704. No such summaries or data shall include any patient-identifying information. 1336

1337 2. Applications for admission to examinations or for licensure and scoring records maintained by the 1338 Department of Health Professions or any board in that department on individual licensees or applicants. 1339 However, such material may be made available during normal working hours for copying, at the 1340 requester's expense, by the individual who is the subject thereof, in the offices of the Department of 1341 Health Professions or in the offices of any health regulatory board, whichever may possess the material. 1342 3. Reports, documentary evidence and other information as specified in §§ 2.2-706 and 63.2-104.

1343 4. Investigative notes; proprietary information not published, copyrighted or patented; information 1344 obtained from employee personnel records; personally identifiable information regarding residents, 1345 clients or other recipients of services; and other correspondence and information furnished in confidence 1346 to the Department of Social Services in connection with an active investigation of an applicant or 1347 licensee pursuant to Chapters 17 (§ 63.2-1700 et seq.) and 18 (§ 63.2-1800 et seq.) of Title 63.2. 1348 However, nothing in this section shall prohibit disclosure of information from the records of completed 1349 investigations in a form that does not reveal the identity of complainants, persons supplying information, 1350 or other individuals involved in the investigation.

1351 5. Information and records collected for the designation and verification of trauma centers and other

9. All information and records acquired during a review of any child death by the State Child
Fatality Review team established pursuant to § 32.1-283.1, during a review of any child death by a local
or regional child fatality review team established pursuant to § 32.1-283.2, and all information and
records acquired during a review of any death by a family violence fatality review team established
pursuant to § 32.1-283.3.

1366 10. Patient level data collected by the Board of Health and not yet processed, verified, and released, pursuant to § 32.1-276.9, to the Board by the nonprofit organization with which the Commissioner of Health has contracted pursuant to § 32.1-276.4.

1369 11. Records of the Intervention Program Committee within the Department of Health Professions, to1370 the extent such records may identify any practitioner who may be, or who is actually, impaired to the1371 extent disclosure is prohibited by § 54.1-2517.

1372 12. Records submitted as a grant application, or accompanying a grant application, to the 1373 Commonwealth Neurotrauma Initiative Advisory Board pursuant to Chapter 3.1 (§ 51.5-12.1 et seq.) of 1374 Title 51.5, to the extent such records contain (i) medical or mental records, or other data identifying 1375 individual patients or (ii) proprietary business or research-related information produced or collected by 1376 the applicant in the conduct of or as a result of study or research on medical, rehabilitative, scientific, 1377 technical or scholarly issues, when such information has not been publicly released, published, 1378 copyrighted or patented, if the disclosure of such information would be harmful to the competitive 1379 position of the applicant.

1380 13. Any record copied, recorded or received by the Commissioner of Health in the course of an examination, investigation or review of a managed care health insurance plan licensee pursuant to \$\$ 32.1-137.4 and 32.1-137.5, including books, records, files, accounts, papers, documents, and any or all computer or other recordings.

**1384** 14. Records, information and statistical registries required to be kept confidential pursuant to **1385** §§ 63.2-102 and 63.2-104.

1386 15. All data, records, and reports relating to the prescribing and dispensing of covered substances to recipients and any abstracts from such data, records, and reports that are in the possession of the Prescription Monitoring Program pursuant to Chapter 25.2 (§ 54.1-2519 et seq.) of Title 54.1 and any material relating to the operation or security of the Program.

1390 16. Records of the Virginia Birth-Related Neurological Injury Compensation Program required to be 1391 kept confidential pursuant to § 38.2-5002.2.

1392 17. Records of the State Health Commissioner relating to the health of any person or persons subject
1393 to an order of quarantine or an order of isolation pursuant to Article 3.02 (§ 32.1-48.05 et seq.) of
1394 Chapter 2 of Title 32.1; this provision shall not, however, be construed to prohibit the disclosure of
1395 statistical summaries, abstracts or other information in aggregate form.

1396 18. Records containing the names and addresses or other contact information of persons receiving transportation services from a state or local public body or its designee under Title II of the Americans with Disabilities Act, (42 U.S.C. § 12131 et seq.) or funded by Temporary Assistance for Needy Families (TANF) created under § 63.2-600.

1400 § 2.2-4344. Exemptions from competition for certain transactions.

1401 A. Any public body may enter into contracts without competition for:

1402 1. The purchase of goods or services that are produced or performed by:

a. Persons, or in schools or workshops, under the supervision of the Virginia Department for theBlind and Vision Impaired; or

b. Nonprofit sheltered workshops or other nonprofit organizations that offer transitional or supportedemployment services serving the handicapped.

1407 2. The purchase of legal services, provided that the pertinent provisions of Chapter 5 (§ 2.2-500 et seq.) of this title remain applicable, or expert witnesses or other services associated with litigation or regulatory proceedings.

**1410** B. An industrial development authority may enter into contracts without competition with respect to **1411** any item of cost of "authority facilities" or "facilities" as defined in § 15.2-4902.

1412 C. A community development authority formed pursuant to Article 6 (§ 15.2-5152 et seq.) of Chapter

51 of Title 15.2, with members selected pursuant to such article, may enter into contracts without 1413 1414 competition with respect to the exercise of any of its powers permitted by § 15.2-5158. However, this exception shall not apply in cases where any public funds other than special assessments and 1415 incremental real property taxes levied pursuant to § 15.2-5158 are used as payment for such contract. 1416

D. The Inspector General for Mental Health, Mental RetardationIntellectual Disability and Substance 1417 1418 Abuse Services may enter into contracts without competition to obtain the services of licensed health 1419 care professionals or other experts to assist in carrying out the duties of the Office of the Inspector 1420 General for Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services. 1421

§ 2.2-5201. State and local advisory team; appointment; membership.

1422 The state and local advisory team is established to better serve the needs of troubled and at-risk 1423 youths and their families by advising the Council by managing cooperative efforts at the state level and providing support to community efforts. The team shall be appointed by and be responsible to the 1424 1425 Council. The team shall include one representative from each of the following state agencies: the 1426 Department of Health, Department of Juvenile Justice, Department of Social Services, Department of 1427 Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, the Department 1428 of Medical Assistance Services, and the Department of Education. The team shall also include a parent 1429 representative who is not an employee of any public or private program which serves children and 1430 families; a representative of a private organization or association of providers for children's or family 1431 services; a local Comprehensive Services Act coordinator or program manager; a juvenile and domestic 1432 relations district court judge; and one member from each of five different geographical areas of the 1433 Commonwealth and who serves on and is representative of the different participants of community 1434 policy and management teams. The nonstate agency members shall serve staggered terms of not more 1435 than three years, such terms to be determined by the Council.

The team shall annually elect a chairman from among the local government representatives who shall 1436 1437 be responsible for convening the team. The team shall develop and adopt bylaws to govern its 1438 operations that shall be subject to approval by the Council. Any person serving on such team who does 1439 not represent a public agency shall file a statement of economic interests as set out in § 2.2-3117 of the 1440 State and Local Government Conflict of Interests Act (§ 2.2-3100 et seq.). Persons representing public 1441 agencies shall file such statements if required to do so pursuant to the State and Local Government 1442 Conflict of Interests Act.

§ 2.2-5206. Community policy and management teams; powers and duties.

1444 The community policy and management team shall manage the cooperative effort in each community 1445 to better serve the needs of troubled and at-risk youths and their families and to maximize the use of 1446 state and community resources. Every such team shall:

1447 1. Develop interagency policies and procedures to govern the provision of services to children and 1448 families in its community;

1449 2. Develop interagency fiscal policies governing access to the state pool of funds by the eligible 1450 populations including immediate access to funds for emergency services and shelter care;

1451 3. Establish policies to assess the ability of parents or legal guardians to contribute financially to the 1452 cost of services to be provided and, when not specifically prohibited by federal or state law or 1453 regulation, provide for appropriate parental or legal guardian financial contribution, utilizing a standard 1454 sliding fee scale based upon ability to pay;

1455 4. Coordinate long-range, community-wide planning that ensures the development of resources and 1456 services needed by children and families in its community including consultation on the development of 1457 a community-based system of services established under § 16.1-309.3;

5. Establish policies governing referrals and reviews of children and families to the family 1458 assessment and planning teams or a collaborative, multidisciplinary team process approved by the 1459 1460 Council and a process to review the teams' recommendations and requests for funding;

1461 6. Establish quality assurance and accountability procedures for program utilization and funds 1462 management;

7. Establish procedures for obtaining bids on the development of new services;

1464 8. Manage funds in the interagency budget allocated to the community from the state pool of funds, 1465 the trust fund, and any other source;

1466 9. Authorize and monitor the expenditure of funds by each family assessment and planning team or a 1467 collaborative, multidisciplinary team process approved by the Council;

1468 10. Submit grant proposals that benefit its community to the state trust fund and enter into contracts 1469 for the provision or operation of services upon approval of the participating governing bodies;

11. Serve as its community's liaison to the Office of Comprehensive Services for At-Risk Youth and 1470 1471 Families, reporting on its programmatic and fiscal operations and on its recommendations for improving 1472 the service system, including consideration of realignment of geographical boundaries for providing 1473 human services; 1474

12. Collect and provide uniform data to the Council on, but not limited to, expenditures, number of

**1478** 13. Administer funds pursuant to § 16.1-309.3;

1479 14. Have authority, upon approval of the participating governing bodies, to enter into a contract with another community policy and management team to purchase coordination services provided that funds described as the state pool of funds under § 2.2-5211 are not used; and

1482 15. Submit to the Department of Mental Health, Mental RetardationIntellectual Disability and
1483 Substance Abuse Services information on children under the age of 14 and adolescents ages 14 through
1484 17 for whom an admission to an acute care psychiatric or residential treatment facility licensed pursuant
1485 to Article 2 (§ 37.2-403 et seq.) of Chapter 4 of Title 37.2, exclusive of group homes, was sought but
1486 was unable to be obtained by the reporting entities. Such information shall be gathered from the family
1487 assessment and planning team or participating community agencies authorized in § 2.2-5207. Information
1488 to be submitted shall include:

a. The child or adolescent's date of birth;

- b. Date admission was attempted; and
- 1491 c. Reason the patient could not be admitted into the hospital or facility.

1492 § 2.2-5300. Definitions.

1493 As used in this chapter, unless the context requires a different meaning:

1494 "Council" means the Virginia Interagency Coordinating Council created pursuant to § 2.2-2664.

1495 "Early intervention services" means services provided through Part C of the Individuals with 1496 Disabilities Education Act (20 U.S.C. § 1431 et seq.), as amended, designed to meet the developmental 1497 needs of each child and the needs of the family related to enhancing the child's development and 1498 provided to children from birth to age three who have (i) a 25 percent developmental delay in one or 1499 more areas of development, (ii) atypical development, or (iii) a diagnosed physical or mental condition 1500 that has a high probability of resulting in a developmental delay. Early intervention services provided in 1501 the child's home and in accordance with this chapter shall not be construed to be home health services 1502 as referenced in § 32.1-162.7.

"Participating agencies" means the Departments of Health, of Education, of Medical Assistance
Services, of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, and
of Social Services; the Departments for the Deaf and Hard-of-Hearing and for the Blind and Vision
Impaired; the Virginia Office for Protection and Advocacy; and the Bureau of Insurance within the State
Corporation Commission.

**1508** § 4.1-305. Purchasing or possessing alcoholic beverages unlawful in certain cases; venue; exceptions; **1509** penalty; forfeiture; deferred proceedings; treatment and education programs and services.

1510 A. No person to whom an alcoholic beverage may not lawfully be sold under § 4.1-304 shall 1511 consume, purchase or possess, or attempt to consume, purchase or possess, any alcoholic beverage, 1512 except (i) pursuant to subdivisions 1 through 7 of § 4.1-200; (ii) where possession of the alcoholic 1513 beverages by a person less than 21 years of age is due to such person's making a delivery of alcoholic 1514 beverages in pursuance of his employment or an order of his parent; or (iii) by any state, federal, or 1515 local law-enforcement officer when possession of an alcoholic beverage is necessary in the performance 1516 of his duties. Such person may be prosecuted either in the county or city in which the alcohol was 1517 possessed or consumed, or in the county or city in which the person exhibits evidence of physical 1518 indicia of consumption of alcohol.

B. No person under the age of 21 years shall use or attempt to use any (i) altered, fictitious, facsimile or simulated license to operate a motor vehicle, (ii) altered, fictitious, facsimile or simulated document, including, but not limited to a birth certificate or student identification card, or (iii) motor vehicle operator's license, birth certificate or student identification card of another person in order to establish a false identification or false age for himself to consume, purchase or attempt to consume or purchase an alcoholic beverage.

1525 C. Any person found guilty of a violation of this section shall be guilty of a Class 1 misdemeanor; 1526 and upon conviction, (i) such person shall be ordered to pay a mandatory minimum fine of \$500 or 1527 ordered to perform a mandatory minimum of 50 hours of community service as a condition of probation 1528 supervision and (ii) the license to operate a motor vehicle in the Commonwealth of any such person age 1529 18 or older shall be suspended for a period of not less than six months and not more than one year. The 1530 court, in its discretion and upon a demonstration of hardship, may authorize any person convicted of a 1531 violation of this section the use of a restricted permit to operate a motor vehicle in accordance with the 1532 provisions of subsection D of § 16.1-278.9 or subsection E of § 18.2-271.1 or when referred to a local 1533 community-based probation services agency established pursuant to Article 9 (§ 9.1-173 et seq.) of Chapter 1 of Title 9.1. During the period of license suspension, the court may require a person issued a 1534 1535 restricted permit under the provisions of this subsection to be (i) monitored by an alcohol safety action

1536 program, or (ii) supervised by a local community-based probation services agency established pursuant 1537 to Article 9 (§ 9.1-173 et seq.) of Chapter 1 of Title 9.1, if one has been established for the locality. The alcohol safety action program or local community-based probation services agency shall report to 1538 1539 the court any violation of the terms of the restricted permit, the required alcohol safety action program 1540 monitoring or local community-based probation services and any condition related thereto or any failure 1541 to remain alcohol-free during the suspension period.

1542 D. Any alcoholic beverage purchased or possessed in violation of this section shall be deemed 1543 contraband and forfeited to the Commonwealth in accordance with § 4.1-338.

1544 E. Any retail licensee who in good faith promptly notifies the Board or any state or local 1545 law-enforcement agency of a violation or suspected violation of this section shall be accorded immunity 1546 from an administrative penalty for a violation of 4.1-304.

1547 F. When any person who has not previously been convicted of underaged consumption, purchase or 1548 possession of alcoholic beverages in Virginia or any other state or the United States is before the court, 1549 the court may, upon entry of a plea of guilty or not guilty, if the facts found by the court would justify 1550 a finding of guilt of a violation of subsection A, without entering a judgment of guilt and with the 1551 consent of the accused, defer further proceedings and place him on probation subject to appropriate 1552 conditions. Such conditions may include the imposition of the license suspension and restricted license 1553 provisions in subsection C. However, in all such deferred proceedings, the court shall require the 1554 accused to enter a treatment or education program or both, if available, that in the opinion of the court 1555 best suits the needs of the accused. If the accused is placed on local community-based probation, the 1556 program or services shall be located in any of the judicial districts served by the local community-based 1557 probation services agency or in any judicial district ordered by the court when the placement is with an alcohol safety action program. The services shall be provided by (i) a program licensed by the 1558 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, 1559 1560 (ii) certified by the Commission on VASAP, or (iii) by a program or services made available through a community-based probation services agency established pursuant to Article 9 (§ 9.1-173 et seq.) of 1561 Chapter 1 of Title 9.1, if one has been established for the locality. When an offender is ordered to a 1562 1563 local community-based probation services rather than the alcohol safety action program, the local 1564 community-based probation services agency shall be responsible for providing for services or referring 1565 the offender to education or treatment services as a condition of probation.

1566 Upon violation of a condition, the court may enter an adjudication of guilt and proceed as otherwise 1567 provided. Upon fulfillment of the conditions, the court shall discharge the person and dismiss the 1568 proceedings against him without an adjudication of guilt. A discharge and dismissal hereunder shall be 1569 treated as a conviction for the purpose of applying this section in any subsequent proceedings.

1570 § 9.1-111. Advisory Committee on Juvenile Justice; membership; terms; quorum; compensation and 1571 expenses: duties.

1572 A. The Advisory Committee on Juvenile Justice (the Advisory Committee) is established as an 1573 advisory committee in the executive branch of state government. The Advisory Committee shall have 1574 the responsibility for advising and assisting the Board, the Department, all agencies, departments, boards 1575 and institutions of the Commonwealth, and units of local government, or combinations thereof, on 1576 matters related to the prevention and treatment of juvenile delinquency and the administration of juvenile 1577 iustice in the Commonwealth.

1578 The membership of the Advisory Committee shall comply with the membership requirements 1579 contained in the Juvenile Justice and Delinquency Prevention Act pursuant to 42 U.S.C. § 5633, as 1580 amended, and shall consist of: the Commissioner of the Department of Mental Health, Mental 1581 RetardationIntellectual Disability and Substance Abuse Services; the Commissioner of the Department of 1582 Social Services; the Director of the Department of Juvenile Justice; the Superintendent of Public 1583 Instruction; one member of the Senate Committee for Courts of Justice appointed by the Senate 1584 Committee on Rules after consideration of the recommendation of the Chairman of the Senate 1585 Committee for Courts of Justice; one member of the House Committee on Health, Welfare and 1586 Institutions appointed by the Speaker of the House of Delegates after consideration of the 1587 recommendation of the Chairman of the House Committee on Health, Welfare and Institutions; and such 1588 number of nonlegislative citizen members appointed by the Governor to comply with the membership 1589 range established by such federal act.

1590 Legislative members, the Superintendent of Public Instruction, and the agency directors shall serve 1591 terms coincident with their terms of office. All other members shall be citizens of the Commonwealth 1592 and be appointed by the Governor for a term of four years. However, no member shall serve beyond the 1593 time when he holds the office or employment by reason of which he was initially eligible for 1594 appointment. 1595

The Advisory Committee shall elect its chairman and vice-chairman from among its members.

1596 B. Gubernatorial appointed members of the Advisory Committee shall not be eligible to serve for 1597 more than two consecutive full terms. Three or more years within a four-year period shall be deemed a

1598 full term. Any vacancy on the Advisory Committee shall be filled in the same manner as the original 1599 appointment, but for the unexpired term.

1600 C. The majority of the members of the Advisory Committee shall constitute a quorum. The Advisory 1601 Committee shall hold no less than four regular meetings a year. Subject to the requirements of this 1602 subsection, the chairman shall fix the times and places of meetings, either on his own motion or upon 1603 written request of any five members of the Advisory Committee.

1604 D. The Advisory Committee may adopt bylaws for its operation.

1605 E. Members of the Advisory Committee shall not receive compensation, but shall be reimbursed for 1606 all reasonable and necessary expenses incurred in the performance of their duties as provided in 1607 §§ 2.2-2813 and 2.2-2825. Funding for the costs of the expenses shall be provided from federal funds 1608 received for such purposes by the Department of Criminal Justice Services. 1609

F. The Advisory Committee shall have the following duties and responsibilities to:

1610 1. Review the operation of the juvenile justice system in the Commonwealth, including facilities and 1611 programs, and prepare appropriate reports;

1612 2. Review statewide plans, conduct studies, and make recommendations on needs and priorities for 1613 the development and improvement of the juvenile justice system in the Commonwealth; and

1614 3. Advise on all matters related to the federal Juvenile Justice and Delinquency Prevention Act of 1615 1974 (P. L. 93-415, as amended), and recommend such actions on behalf of the Commonwealth as may 1616 seem desirable to secure benefits of that or other federal programs for delinquency prevention of the 1617 administration of juvenile justice.

1618 G. The Department of Criminal Justice Services shall provide staff support to the Advisory Committee. Upon request, each administrative entity or collegial body within the executive branch of the 1619 1620 state government shall cooperate with the Advisory Committee as it carries out its responsibilities.

1621 § 9.1-901. Persons for whom registration required.

1622 A. Every person convicted on or after July 1, 1994, including a juvenile tried and convicted in the 1623 circuit court pursuant to § 16.1-269.1, whether sentenced as an adult or juvenile, of an offense set forth 1624 in § 9.1-902 and every juvenile found delinquent of an offense for which registration is required under 1625 subsection G of § 9.1-902 shall register and reregister as required by this chapter. Every person serving 1626 a sentence of confinement on or after July 1, 1994, for a conviction of an offense set forth in § 9.1-902 1627 shall register and reregister as required by this chapter. Every person under community supervision as 1628 defined by § 53.1-1 or any similar form of supervision under the laws of the United States or any 1629 political subdivision thereof, on or after July 1, 1994, resulting from a conviction of an offense set forth 1630 in § 9.1-902 shall register and reregister as required by this chapter.

1631 B. Every person found not guilty by reason of insanity on or after July 1, 2007, of an offense set 1632 forth in § 9.1-902 shall register and reregister as required by this chapter. Every person in the custody of 1633 the Commissioner of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, or on conditional release on or after July 1, 2007, because of a finding of not guilty by reason 1634 1635 of insanity of an offense set forth in § 9.1-902 shall register and reregister as required by this chapter.

1636 C. Unless a specific effective date is otherwise provided, all provisions of the Sex Offender and 1637 Crimes Against Minors Registry Act shall apply retroactively. This subsection is declaratory of existing 1638 law.

1639 § 15.2-964. Organization of local human services activities; authorization of reorganization by 1640 Governor.

1641 A. Any city or county may prepare and submit to the Governor a plan to reorganize the 1642 governmental structures or administrative procedures and systems of human resources agencies should provisions of law or the rules, regulations and standards of any state agency prohibit or restrict the 1643 1644 implementation of such a reorganization. The plan shall set forth the proposed reorganization and the 1645 provisions of law or the rules, regulations or standards that prohibit or restrict the implementation of 1646 such proposed reorganization.

1647 B. The Governor shall prepare, and provide to those counties and cities which request them, 1648 guidelines for the preparation and submission to him of reorganization plans by a city or county. The 1649 Governor may consider only those reorganization plans adopted by resolution of the governing body of 1650 the city or county applying for approval to reorganize its human services agencies.

1651 C. The several state boards and commissions which are empowered to promulgate rules, regulations 1652 and guidelines affecting the organization or administration of local human service agencies are hereby 1653 authorized to modify their respective rules, regulations and guidelines at the direction of the Governor in 1654 furtherance of any reorganization plan approved by him.

1655 D. If a provision or provisions of law prohibit or restrict the implementation of all or part of such 1656 reorganization plan the Governor shall transmit such plan or such parts of such plan affected by such 1657 laws to each House of the General Assembly at least forty-five days prior to the commencement of a 1658 regular or special session of the General Assembly. Such plan or portions of such plan so transmitted by

1659 the Governor under this section shall not become effective unless it is introduced by bill and enacted 1660 into law.

1661 E. The plan or such portions of the plan transmitted by the Governor to the General Assembly shall 1662 set forth: (i) the provision or provisions of law that prohibit or restrict the implementation of such plan 1663 or parts of such plan; (ii) the changes in governmental structure or administrative procedure system of 1664 the human resources agencies affected; and (iii) the anticipated effects of such changes upon the 1665 efficiency and effectiveness of the agencies affected.

1666 F. Any reorganization authorized under the provision of this section shall be implemented within appropriations or other funds which may be made available to the city or county requesting such 1667 1668 reorganization approval.

G. Nothing in this section shall be interpreted to permit a city or county to eliminate the provision of 1669 1670 any service required by law or to reduce the level of service below any level required by law.

H. The localities shall be required to maintain financial and statistical records in accordance with the 1671 1672 guidelines issued by the Governor so as to allow responsible state agencies to review records and 1673 determine costs for programs for which the agency is responsible.

1674 I. For the purposes of this section the term "human resource agencies" means agencies which deliver 1675 social, employment, health, mental health and mental retardation, intellectual disability, rehabilitation, 1676 nursing, information and referral service, and such other related services. 1677

§ 15.2-2291. Group homes of eight or fewer single-family residence.

1678 A. Zoning ordinances for all purposes shall consider a residential facility in which no more than 1679 eight persons with mentally ill mental illness, mentally retarded intellectual disability, or 1680 developmentally disabled persons developmental disabilities reside, with one or more resident counselors 1681 or other staff persons, as residential occupancy by a single family. For the purposes of this subsection, mental illness and developmental disability shall not include current illegal use of or addiction to a 1682 controlled substance as defined in § 54.1-3401. No conditions more restrictive than those imposed on 1683 residences occupied by persons related by blood, marriage, or adoption shall be imposed on such 1684 1685 facility. For purposes of this subsection, "residential facility" means any group home or other residential 1686 facility for which the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services is the licensing authority pursuant to this Code. 1687

1688 B. Zoning ordinances in the Counties of Arlington, Henry, and York for all purposes shall consider a 1689 residential facility in which no more than eight aged, infirm or disabled persons reside, with one or 1690 more resident counselors or other staff persons, as residential occupancy by a single family. No conditions more restrictive than those imposed on residences occupied by persons related by blood, 1691 1692 marriage, or adoption shall be imposed on such facility. For purposes of this subsection, "residential facility" means any group home or residential facility in which aged, infirm or disabled persons reside 1693 1694 with one or more resident counselors or other staff persons and for which the Department of Social Services is the licensing authority pursuant to this Code. 1695

1696 C. Zoning ordinances in the Cities of Lynchburg and Suffolk for all purposes shall consider a 1697 residential facility in which no more than four aged, infirm or disabled persons reside, with one or more 1698 resident counselors or other staff persons, as residential occupancy by a single family. No conditions more restrictive than those imposed on residences occupied by persons related by blood, marriage or 1699 1700 adoption shall be imposed on such facility. For purposes of this subsection, "residential facility" means 1701 any group home or residential facility in which aged, infirm or disabled persons reside with one or more 1702 resident counselors or other staff persons and for which the Department of Social Services is the licensing authority pursuant to this Code. 1703 1704

§ 15.2-5386. Limitations of the Authority.

1705 A. No provision related to the establishment, powers, or authorities of the Southwest Virginia Health Facilities Authority, its subsidiaries, or successors, shall apply to the facilities, equipment, or appropriations of any state agency including, but not limited to, the Virginia Department of Health and 1706 1707 1708 the Department of Mental Health, Mental RetardationIntellectual Disability, and Substances Abuse 1709 Services.

1710 B. The Authority, its subsidiaries or successors, shall not be exempt from the Certificate of Public 1711 Need law and regulations or licensure standards of the Virginia Department of Health.

1712 C. No provision of this chapter related to the establishment, power or authority of the Authority or 1713 participating localities shall apply to or affect any hospital as defined in § 32.1-123. 1714

§ 16.1-241. Jurisdiction; consent for abortion.

The judges of the juvenile and domestic relations district court elected or appointed under this law 1715 1716 shall be conservators of the peace within the corporate limits of the cities and the boundaries of the 1717 counties for which they are respectively chosen and within one mile beyond the limits of such cities and counties. Except as hereinafter provided, each juvenile and domestic relations district court shall have, 1718 1719 within the limits of the territory for which it is created, exclusive original jurisdiction, and within one 1720 mile beyond the limits of said city or county, concurrent jurisdiction with the juvenile court or courts of

1721 the adjoining city or county, over all cases, matters and proceedings involving: 1722

A. The custody, visitation, support, control or disposition of a child:

1723 1. Who is alleged to be abused, neglected, in need of services, in need of supervision, a status 1724 offender, or delinquent except where the jurisdiction of the juvenile court has been terminated or 1725 divested;

1726 2. Who is abandoned by his parent or other custodian or who by reason of the absence or physical 1727 or mental incapacity of his parents is without parental care and guardianship;

1728 2a. Who is at risk of being abused or neglected by a parent or custodian who has been adjudicated 1729 as having abused or neglected another child in the care of the parent or custodian;

1730 3. Whose custody, visitation or support is a subject of controversy or requires determination. In such 1731 cases jurisdiction shall be concurrent with and not exclusive of courts having equity jurisdiction, except 1732 as provided in § 16.1-244;

1733 4. Who is the subject of an entrustment agreement entered into pursuant to § 63.2-903 or 63.2-1817 1734 or whose parent or parents for good cause desire to be relieved of his care and custody;

1735 5. Where the termination of residual parental rights and responsibilities is sought. In such cases 1736 jurisdiction shall be concurrent with and not exclusive of courts having equity jurisdiction, as provided 1737 in § 16.1-244; and 1738

6. Who is charged with a traffic infraction as defined in § 46.2-100.

1739 In any case in which the juvenile is alleged to have committed a violent juvenile felony enumerated 1740 in subsection B of § 16.1-269.1, and for any charges ancillary thereto, the jurisdiction of the juvenile 1741 court shall be limited to conducting a preliminary hearing to determine if there is probable cause to believe that the juvenile committed the act alleged and that the juvenile was 14 years of age or older at 1742 1743 the time of the commission of the alleged offense, and any matters related thereto. In any case in which 1744 the juvenile is alleged to have committed a violent juvenile felony enumerated in subsection C of § 16.1-269.1, and for all charges ancillary thereto, if the attorney for the Commonwealth has given 1745 notice as provided in subsection C of § 16.1-269.1, the jurisdiction of the juvenile court shall be limited 1746 1747 to conducting a preliminary hearing to determine if there is probable cause to believe that the juvenile 1748 committed the act alleged and that the juvenile was 14 years of age or older at the time of the 1749 commission of the alleged offense, and any matters related thereto. A determination by the juvenile 1750 court following a preliminary hearing pursuant to subsection B or C of § 16.1-269.1 to certify a charge 1751 to the grand jury shall divest the juvenile court of jurisdiction over the charge and any ancillary charge. 1752 In any case in which a transfer hearing is held pursuant to subsection A of § 16.1-269.1, if the juvenile 1753 court determines to transfer the case, jurisdiction of the juvenile court over the case shall be divested as 1754 provided in § 16.1-269.6.

1755 In all other cases involving delinquent acts, and in cases in which an ancillary charge remains after a 1756 violent juvenile felony charge has been dismissed or a violent juvenile felony has been reduced to a 1757 lesser offense not constituting a violent juvenile felony, the jurisdiction of the juvenile court shall not be 1758 divested unless there is a transfer pursuant to subsection A of § 16.1-269.1.

1759 The authority of the juvenile court to adjudicate matters involving the custody, visitation, support, 1760 control or disposition of a child shall not be limited to the consideration of petitions filed by a mother, 1761 father or legal guardian but shall include petitions filed at any time by any party with a legitimate 1762 interest therein. A party with a legitimate interest shall be broadly construed and shall include, but not 1763 be limited to, grandparents, stepparents, former stepparents, blood relatives and family members. A party 1764 with a legitimate interest shall not include any person (i) whose parental rights have been terminated by 1765 court order, either voluntarily or involuntarily, (ii) whose interest in the child derives from or through a 1766 person whose parental rights have been terminated by court order, either voluntarily or involuntarily, 1767 including, but not limited to, grandparents, stepparents, former stepparents, blood relatives and family 1768 members, if the child subsequently has been legally adopted, except where a final order of adoption is 1769 entered pursuant to § 63.2-1241, or (iii) who has been convicted of a violation of subsection A of 1770 § 18.2-61, § 18.2-63, subsection B of § 18.2-366, or an equivalent offense of another state, the United 1771 States, or any foreign jurisdiction, when the child who is the subject of the petition was conceived as a 1772 result of such violation. The authority of the juvenile court to consider a petition involving the custody 1773 of a child shall not be proscribed or limited where the child has previously been awarded to the custody 1774 of a local board of social services.

1775 B. The admission of minors for inpatient treatment in a mental health facility in accordance with the 1776 provisions of Article 16 (§ 16.1-335 et seq.) of this chapter and the involuntary admission of a person 1777 with mental illness or judicial certification of eligibility for admission to a training center for persons 1778 with mental retardation intellectual disability in accordance with the provisions of Chapters 1 (§ 37.2-100 1779 et seq.) and 8 (§ 37.2-800 et seq.) of Title 37.2. Jurisdiction of the involuntary admission and 1780 certification of adults shall be concurrent with the general district court.

1781 C. Except as provided in subsections D and H hereof, judicial consent to such activities as may 1794

1782 require parental consent may be given for a child who has been separated from his parents, guardian, 1783 legal custodian or other person standing in loco parentis and is in the custody of the court when such 1784 consent is required by law.

1785 D. Judicial consent for emergency surgical or medical treatment for a child who is neither married 1786 nor has ever been married, when the consent of his parent, guardian, legal custodian or other person 1787 standing in loco parentis is unobtainable because such parent, guardian, legal custodian or other person 1788 standing in loco parentis (i) is not a resident of the Commonwealth, (ii) has his whereabouts unknown, 1789 (iii) cannot be consulted with promptness, reasonable under the circumstances, or (iv) fails to give such 1790 consent or provide such treatment when requested by the judge to do so.

1791 E. Any person charged with deserting, abandoning or failing to provide support for any person in 1792 violation of law. 1793

F. Any parent, guardian, legal custodian or other person standing in loco parentis of a child:

1. Who has been abused or neglected;

1795 2. Who is the subject of an entrustment agreement entered into pursuant to § 63.2-903 or 63.2-1817 or is otherwise before the court pursuant to subdivision A 4 of this section; or 1796

1797 3. Who has been adjudicated in need of services, in need of supervision, or delinquent, if the court 1798 finds that such person has by overt act or omission induced, caused, encouraged or contributed to the 1799 conduct of the child complained of in the petition.

1800 G. Petitions filed by or on behalf of a child or such child's parent, guardian, legal custodian or other 1801 person standing in loco parentis for the purpose of obtaining treatment, rehabilitation or other services 1802 that are required by law to be provided for that child or such child's parent, guardian, legal custodian or 1803 other person standing in loco parentis. Jurisdiction in such cases shall be concurrent with and not 1804 exclusive of that of courts having equity jurisdiction as provided in § 16.1-244.

1805 H. Judicial consent to apply for a work permit for a child when such child is separated from his 1806 parents, legal guardian or other person standing in loco parentis.

1807 I. The prosecution and punishment of persons charged with ill-treatment, abuse, abandonment or 1808 neglect of children or with any violation of law that causes or tends to cause a child to come within the 1809 purview of this law, or with any other offense against the person of a child. In prosecution for felonies 1810 over which the court has jurisdiction, jurisdiction shall be limited to determining whether or not there is 1811 probable cause.

1812 J. All offenses in which one family or household member is charged with an offense in which 1813 another family or household member is the victim and all offenses under § 18.2-49.1.

1814 In prosecution for felonies over which the court has jurisdiction, jurisdiction shall be limited to 1815 determining whether or not there is probable cause. Any objection based on jurisdiction under this subsection shall be made before a jury is impaneled and sworn in a jury trial or, in a nonjury trial, 1816 before the earlier of when the court begins to hear or receive evidence or the first witness is sworn, or it 1817 1818 shall be conclusively waived for all purposes. Any such objection shall not affect or be grounds for 1819 challenging directly or collaterally the jurisdiction of the court in which the case is tried.

1820 K. Petitions filed by a natural parent, whose parental rights to a child have been voluntarily 1821 relinquished pursuant to a court proceeding, to seek a reversal of the court order terminating such 1822 parental rights. No such petition shall be accepted, however, after the child has been placed in the home 1823 of adoptive parents.

1824 L. Any person who seeks spousal support after having separated from his spouse. A decision under 1825 this subdivision shall not be res judicata in any subsequent action for spousal support in a circuit court. 1826 A circuit court shall have concurrent original jurisdiction in all causes of action under this subdivision.

1827 M. Petitions filed for the purpose of obtaining an order of protection pursuant to § 16.1-253.1 or 1828 16.1-279.1.

1829 N. Any person who escapes or remains away without proper authority from a residential care facility 1830 in which he had been placed by the court or as a result of his commitment to the Virginia Department 1831 of Juvenile Justice.

O. Petitions for emancipation of a minor pursuant to Article 15 (§ 16.1-331 et seq.) of this chapter.

1833 P. Petitions for enforcement of administrative support orders entered pursuant to Chapter 19 1834 (§ 63.2-1900 et seq.) of Title 63.2, or by another state in the same manner as if the orders were entered 1835 by a juvenile and domestic relations district court upon the filing of a certified copy of such order in the juvenile and domestic relations district court. 1836

1837 Q. Petitions for a determination of parentage pursuant to Chapter 3.1 (§ 20-49.1 et seq.) of Title 20.

1838 R. Petitions for the purpose of obtaining an emergency protective order pursuant to § 16.1-253.4.

1839 S. Petitions filed by school boards against parents pursuant to §§ 16.1-241.2 and 22.1-279.3.

1840 T. Petitions to enforce any request for information or subpoena that is not complied with or to 1841 review any refusal to issue a subpoena in an administrative appeal regarding child abuse and neglect pursuant to § 63.2-1526. 1842

1843 U. Petitions filed in connection with parental placement adoption consent hearings pursuant to

1844 § 63.2-1233. Such proceedings shall be advanced on the docket so as to be heard by the court within 10 1845 days of filing of the petition, or as soon thereafter as practicable so as to provide the earliest possible 1846 disposition.

1847 V. Petitions filed by a juvenile seeking judicial authorization for a physician to perform an abortion 1848 if a minor elects not to seek consent of an authorized person.

1849 After a hearing, a judge shall issue an order authorizing a physician to perform an abortion, without 1850 the consent of any authorized person, if he finds that (i) the minor is mature enough and well enough 1851 informed to make her abortion decision, in consultation with her physician, independent of the wishes of 1852 any authorized person, or (ii) the minor is not mature enough or well enough informed to make such 1853 decision, but the desired abortion would be in her best interest.

1854 If the judge authorizes an abortion based on the best interests of the minor, such order shall 1855 expressly state that such authorization is subject to the physician or his agent giving notice of intent to 1856 perform the abortion; however, no such notice shall be required if the judge finds that such notice would 1857 not be in the best interest of the minor. In determining whether notice is in the best interest of the 1858 minor, the judge shall consider the totality of the circumstances; however, he shall find that notice is not 1859 in the best interest of the minor if he finds that (i) one or more authorized persons with whom the 1860 minor regularly and customarily resides is abusive or neglectful, and (ii) every other authorized person, 1861 if any, is either abusive or neglectful or has refused to accept responsibility as parent, legal guardian, 1862 custodian or person standing in loco parentis.

1863 The minor may participate in the court proceedings on her own behalf, and the court may appoint a 1864 guardian ad litem for the minor. The court shall advise the minor that she has a right to counsel and 1865 shall, upon her request, appoint counsel for her.

1866 Notwithstanding any other provision of law, the provisions of this subsection shall govern proceedings relating to consent for a minor's abortion. Court proceedings under this subsection and 1867 1868 records of such proceedings shall be confidential. Such proceedings shall be given precedence over other 1869 pending matters so that the court may reach a decision promptly and without delay in order to serve the 1870 best interests of the minor. Court proceedings under this subsection shall be heard and decided as soon 1871 as practicable but in no event later than four days after the petition is filed.

1872 An expedited confidential appeal to the circuit court shall be available to any minor for whom the 1873 court denies an order authorizing an abortion without consent or without notice. Any such appeal shall 1874 be heard and decided no later than five days after the appeal is filed. The time periods required by this 1875 subsection shall be subject to subsection B of § 1-210. An order authorizing an abortion without consent 1876 or without notice shall not be subject to appeal. 1877

No filing fees shall be required of the minor at trial or upon appeal.

1878 If either the original court or the circuit court fails to act within the time periods required by this 1879 subsection, the court before which the proceeding is pending shall immediately authorize a physician to 1880 perform the abortion without consent of or notice to an authorized person.

1881 Nothing contained in this subsection shall be construed to authorize a physician to perform an 1882 abortion on a minor in circumstances or in a manner that would be unlawful if performed on an adult 1883 woman.

1884 A physician shall not knowingly perform an abortion upon an unemancipated minor unless consent 1885 has been obtained or the minor delivers to the physician a court order entered pursuant to this section 1886 and the physician or his agent provides such notice as such order may require. However, neither consent 1887 nor judicial authorization nor notice shall be required if the minor declares that she is abused or 1888 neglected and the attending physician has reason to suspect that the minor may be an abused or 1889 neglected child as defined in § 63.2-100 and reports the suspected abuse or neglect in accordance with 1890 § 63.2-1509; or if there is a medical emergency, in which case the attending physician shall certify the 1891 facts justifying the exception in the minor's medical record.

1892 For purposes of this subsection:

1893 "Authorization" means the minor has delivered to the physician a notarized, written statement signed 1894 by an authorized person that the authorized person knows of the minor's intent to have an abortion and 1895 consents to such abortion being performed on the minor.

1896 "Authorized person" means (i) a parent or duly appointed legal guardian or custodian of the minor or 1897 (ii) a person standing in loco parentis, including, but not limited to, a grandparent or adult sibling with 1898 whom the minor regularly and customarily resides and who has care and control of the minor. Any 1899 person who knows he is not an authorized person and who knowingly and willfully signs an 1900 authorization statement consenting to an abortion for a minor is guilty of a Class 3 misdemeanor.

1901 "Consent" means that (i) the physician has given notice of intent to perform the abortion and has 1902 received authorization from an authorized person, or (ii) at least one authorized person is present with 1903 the minor seeking the abortion and provides written authorization to the physician, which shall be 1904 witnessed by the physician or an agent thereof. In either case, the written authorization shall be

incorporated into the minor's medical record and maintained as a part thereof. 1905

1906 "Medical emergency" means any condition which, on the basis of the physician's good faith clinical 1907 judgment, so complicates the medical condition of the pregnant minor as to necessitate the immediate 1908 abortion of her pregnancy to avert her death or for which a delay will create a serious risk of substantial 1909 and irreversible impairment of a major bodily function.

1910 "Notice of intent to perform the abortion" means that (i) the physician or his agent has given actual 1911 notice of his intention to perform such abortion to an authorized person, either in person or by 1912 telephone, at least 24 hours previous to the performance of the abortion; or (ii) the physician or his 1913 agent, after a reasonable effort to notify an authorized person, has mailed notice to an authorized person 1914 by certified mail, addressed to such person at his usual place of abode, with return receipt requested, at 1915 least 72 hours prior to the performance of the abortion.

"Perform an abortion" means to interrupt or terminate a pregnancy by any surgical or nonsurgical 1916 1917 procedure or to induce a miscarriage as provided in § 18.2-72, 18.2-73, or 18.2-74.

1918 "Unemancipated minor" means a minor who has not been emancipated by (i) entry into a valid 1919 marriage, even though the marriage may have been terminated by dissolution; (ii) active duty with any 1920 of the Armed Forces of the United States; (iii) willingly living separate and apart from his or her 1921 parents or guardian, with the consent or acquiescence of the parents or guardian; or (iv) entry of an 1922 order of emancipation pursuant to Article 15 (§ 16.1-331 et seq.) of this chapter.

1923 W. Petitions filed pursuant to Article 17 (§ 16.1-349 et seq.) of this chapter relating to standby 1924 guardians for minor children.

1925 X. Petitions filed pursuant to § 18.2-370.5 for an order allowing the petitioner to enter and be present 1926 on school or child day center property. In such cases jurisdiction shall be concurrent with and not 1927 exclusive of circuit courts.

The ages specified in this law refer to the age of the child at the time of the acts complained of in 1928 1929 the petition.

1930 Notwithstanding any other provision of law, no fees shall be charged by a sheriff for the service of 1931 any process in a proceeding pursuant to subdivision 3 of subsection A, except as provided in subdivision 1932 A 6 of § 17.1-272, or subsection B, D, M or R of this section.

1933 Notwithstanding the provisions of § 18.2-71, any physician who performs an abortion in violation of 1934 subsection V shall be guilty of a Class 3 misdemeanor. 1935

§ 16.1-269.1. Trial in circuit court; preliminary hearing; direct indictment; remand.

1936 A. Except as provided in subsections B and C, if a juvenile fourteen years of age or older at the time 1937 of an alleged offense is charged with an offense which would be a felony if committed by an adult, the 1938 court shall, on motion of the attorney for the Commonwealth and prior to a hearing on the merits, hold 1939 a transfer hearing and may retain jurisdiction or transfer such juvenile for proper criminal proceedings to 1940 the appropriate circuit court having criminal jurisdiction of such offenses if committed by an adult. Any 1941 transfer to the appropriate circuit court shall be subject to the following conditions:

1942 1. Notice as prescribed in §§ 16.1-263 and 16.1-264 shall be given to the juvenile and his parent, 1943 guardian, legal custodian or other person standing in loco parentis; or attorney;

1944 2. The juvenile court finds that probable cause exists to believe that the juvenile committed the 1945 delinquent act as alleged or a lesser included delinquent act which would be a felony if committed by 1946 an adult:

1947 3. The juvenile is competent to stand trial. The juvenile is presumed to be competent and the burden 1948 is on the party alleging the juvenile is not competent to rebut the presumption by a preponderance of the 1949 evidence; and

1950 4. The court finds by a preponderance of the evidence that the juvenile is not a proper person to 1951 remain within the jurisdiction of the juvenile court. In determining whether a juvenile is a proper person 1952 to remain within the jurisdiction of the juvenile court, the court shall consider, but not be limited to, the 1953 following factors:

a. The juvenile's age;

1954

1955 b. The seriousness and number of alleged offenses, including (i) whether the alleged offense was 1956 committed in an aggressive, violent, premeditated, or willful manner; (ii) whether the alleged offense was against persons or property, with greater weight being given to offenses against persons, especially 1957 1958 if death or bodily injury resulted; (iii) whether the maximum punishment for such an offense is greater 1959 than twenty years confinement if committed by an adult; (iv) whether the alleged offense involved the 1960 use of a firearm or other dangerous weapon by brandishing, threatening, displaying or otherwise 1961 employing such weapon; and (v) the nature of the juvenile's participation in the alleged offense;

1962 c. Whether the juvenile can be retained in the juvenile justice system long enough for effective 1963 treatment and rehabilitation;

1964 d. The appropriateness and availability of the services and dispositional alternatives in both the 1965 criminal justice and juvenile justice systems for dealing with the juvenile's problems;

1966 e. The record and previous history of the juvenile in this or other jurisdictions, including (i) the

1967 number and nature of previous contacts with juvenile or circuit courts, (ii) the number and nature of 1968 prior periods of probation, (iii) the number and nature of prior commitments to juvenile correctional 1969 centers, (iv) the number and nature of previous residential and community-based treatments, (v) whether 1970 previous adjudications and commitments were for delinquent acts that involved the infliction of serious 1971 bodily injury, and (vi) whether the alleged offense is part of a repetitive pattern of similar adjudicated 1972 offenses;

1973 f. Whether the juvenile has previously absconded from the legal custody of a juvenile correctional 1974 entity in this or any other jurisdiction;

1975 g. The extent, if any, of the juvenile's degree of mental retardationintellectual disability or mental 1976 illness;

1977 h. The juvenile's school record and education;

1978 i. The juvenile's mental and emotional maturity; and

1979 j. The juvenile's physical condition and physical maturity.

1980 No transfer decision shall be precluded or reversed on the grounds that the court failed to consider 1981 any of the factors specified in subdivision A 4 of this section.

1982 B. The juvenile court shall conduct a preliminary hearing whenever a juvenile fourteen years of age 1983 or older is charged with murder in violation of §§ 18.2-31, 18.2-32 or § 18.2-40, or aggravated 1984 malicious wounding in violation of § 18.2-51.2.

1985 C. The juvenile court shall conduct a preliminary hearing whenever a juvenile fourteen years of age 1986 or older is charged with murder in violation of § 18.2-33, felonious injury by mob in violation of 1987 § 18.2-41, abduction in violation of § 18.2-48, malicious wounding in violation of § 18.2-51, malicious 1988 wounding of a law-enforcement officer in violation of § 18.2-51.1, felonious poisoning in violation of 1989 § 18.2-54.1, adulteration of products in violation of § 18.2-54.2, robbery in violation of § 18.2-58 or 1990 carjacking in violation of § 18.2-58.1, rape in violation of § 18.2-61, forcible sodomy in violation of 1991 § 18.2-67.1 or object sexual penetration in violation of § 18.2-67.2, provided the attorney for the 1992 Commonwealth gives written notice of his intent to proceed pursuant to this subsection. The notice shall 1993 be filed with the court and mailed or delivered to counsel for the juvenile or, if the juvenile is not then 1994 represented by counsel, to the juvenile and a parent, guardian or other person standing in loco parentis 1995 with respect to the juvenile at least seven days prior to the preliminary hearing. If the attorney for the 1996 Commonwealth elects not to give such notice, or if he elects to withdraw the notice prior to certification 1997 of the charge to the grand jury, he may proceed as provided in subsection A.

1998 D. Upon a finding of probable cause pursuant to a preliminary hearing under subsection B or C, the 1999 juvenile court shall certify the charge, and all ancillary charges, to the grand jury. Such certification 2000 shall divest the juvenile court of jurisdiction as to the charge and any ancillary charges. Nothing in this 2001 subsection shall divest the juvenile court of jurisdiction over any matters unrelated to such charge and 2002 ancillary charges which may otherwise be properly within the jurisdiction of the juvenile court.

2003 If the court does not find probable cause to believe that the juvenile has committed the violent 2004 juvenile felony as charged in the petition or warrant or if the petition or warrant is terminated by 2005 dismissal in the juvenile court, the attorney for the Commonwealth may seek a direct indictment in the 2006 circuit court. If the petition or warrant is terminated by nolle prosequi in the juvenile court, the attorney 2007 for the Commonwealth may seek an indictment only after a preliminary hearing in juvenile court.

2008 If the court finds that the juvenile was not fourteen years of age or older at the time of the alleged 2009 commission of the offense or that the conditions specified in subdivision 1, 2, or 3 of subsection A have 2010 not been met, the case shall proceed as otherwise provided for by law.

2011 E. An indictment in the circuit court cures any error or defect in any proceeding held in the juvenile 2012 court except with respect to the juvenile's age. If an indictment is terminated by nolle prosequi, the 2013 Commonwealth may reinstate the proceeding by seeking a subsequent indictment. 2014

§ 16.1-275. Physical and mental examinations and treatment; nursing and medical care.

2015 The juvenile court or the circuit court may cause any juvenile within its jurisdiction under the 2016 provisions of this law to be physically examined and treated by a physician or to be examined and 2017 treated at a local mental health center. If no such appropriate facility is available locally, the court may 2018 order the juvenile to be examined and treated by any physician or psychiatrist or examined by a clinical psychologist. The Commissioner of Mental Health, Mental RetardationIntellectual Disability and 2019 2020 Substance Abuse Services shall provide for distribution a list of appropriate mental health centers 2021 available throughout the Commonwealth. Upon the written recommendation of the person examining the 2022 juvenile that an adequate evaluation of the juvenile's treatment needs can only be performed in an 2023 inpatient hospital setting, the court shall have the power to send any such juvenile to a state mental 2024 hospital for not more than 10 days for the purpose of obtaining a recommendation for the treatment of 2025 the juvenile. No juvenile sent to a state mental hospital pursuant to this provision shall be held or cared 2026 for in any maximum security unit where adults determined to be criminally insane reside; the juvenile 2027 shall be kept separate and apart from such adults. Prior to such a placement, the Department shall 2042 determine that the personnel, services and space are available in the appropriate correctional facility for 2043 the care, supervision and study of such juvenile and that the juvenile's case is appropriate for referral for 2044 diagnostic services.

2045 Whenever a juvenile concerning whom a petition has been filed appears to be in need of nursing, 2046 medical or surgical care, the juvenile court or the circuit court may order the parent or other person 2047 responsible for the care and support of the juvenile to provide such care in a hospital or otherwise and 2048 to pay the expenses thereof. 1. Enter an order pursuant to the provisions of § 16.1-278;

Defer disposition and place the juvenile in the temporary custody of the Department to attend a 2068 2069 boot camp established pursuant to § 66-13 provided bed space is available for confinement and the 2070 juvenile (i) has been found delinquent for an offense that would be a Class 1 misdemeanor or felony if 2071 committed by an adult, (ii) has not previously been and is not currently being adjudicated delinquent or 2072 found guilty of a violent juvenile felony, (iii) has not previously attended a boot camp, (iv) has not previously been committed to and received by the Department, and (v) has had an assessment completed 2073 2074 by the Department or its contractor concerning the appropriateness of the candidate for a boot camp. 2075 Upon the juvenile's withdrawal, removal or refusal to comply with the terms and conditions of 2076 participation in the program, he shall be brought before the court for a hearing at which the court may 2077 impose any other disposition as authorized by this section which could have been imposed at the time 2078 the juvenile was placed in the custody of the Department;

2079 5. Without entering a judgment of guilty and with the consent of the juvenile and his attorney, defer 2080 disposition of the delinquency charge for a specific period of time established by the court with due 2081 regard for the gravity of the offense and the juvenile's history, and place the juvenile on probation under 2082 such conditions and limitations as the court may prescribe. Upon fulfillment of the terms and conditions, 2083 the court shall discharge the juvenile and dismiss the proceedings against him. Discharge and dismissal under these provisions shall be without adjudication of guilt; 2084

Order the parent of a juvenile with whom the juvenile does not reside to participate in such 2086 programs, cooperate in such treatment or be subject to such conditions and limitations as the court may order and as are designed for the rehabilitation of the juvenile where the court determines this 2087 2088 participation to be in the best interest of the juvenile and other parties concerned and where the court 2089 determines it reasonable to expect the parent to be able to comply with such order;

2090 7. Place the juvenile on probation under such conditions and limitations as the court may prescribe; 2091 7a. The plan shall be in writing and completed prior to the 2229 person's release. The purpose of the plan shall be to ensure continuity of necessary treatment and 2230 services.

2231 B. The mental health services transition plan shall identify the mental health, substance abuse, or 2232 other therapeutic needs of the person being released. Appropriate treatment providers and other persons 2233 from state and local agencies or entities, as defined by the Board, shall participate in the development of 2234 the plan. Appropriate family members, caregivers, or other persons, as defined by the Board, shall be 2235 invited to participate in the development of the person's plan.

Prior to the person's release from incarceration, the identified agency or agencies responsible for 2237 the case management of the mental health services transition plan shall make the necessary referrals 2238 specified in the plan and assist the person in applying for insurance and other services identified in the 2239 plan, including completing and submitting applications that may only be submitted upon release. 2240

§ 16.1-336. Definitions.

2241

When used in this article, unless the context otherwise requires:

2242 "Consent" means the voluntary, express, and informed agreement to treatment in a mental health 2243 facility by a minor fourteen years of age or older and by a parent or a legally authorized custodian.

2244 "Inpatient treatment" means placement for observation, diagnosis, or treatment of mental illness in a 2245 psychiatric hospital or in any other type of mental health facility determined by the State Mental Health, 2246 Mental RetardationIntellectual Disability and Substance Abuse Services Board to be substantially similar 2247 to a psychiatric hospital with respect to restrictions on freedom and therapeutic intrusiveness.

2248 "Judge" means a juvenile and domestic relations district judge. In addition, "judge" includes a retired 2249 judge sitting by designation pursuant to § 16.1-69.35, substitute judge, or special justice authorized by 2250 § 37.2-803 who has completed a training program regarding the provisions of this article, prescribed by 2251 the Executive Secretary of the Supreme Court.

2252 "Least restrictive alternative" means the treatment and conditions of treatment which, separately and 2253 in combination, are no more intrusive or restrictive of freedom than reasonably necessary to achieve a 2254 substantial therapeutic benefit or to protect the minor or others from physical injury.

2255 "Mental health facility" means a public or private facility for the treatment of mental illness operated 2256 or licensed by the Department of Mental Health, Mental RetardationIntellectual Disability and Substance 2257 Abuse Services.

2258 "Mental illness" means a substantial disorder of the minor's cognitive, volitional, or emotional 2259 processes that demonstrably and significantly impairs judgment or capacity to recognize reality or to 2260 control behavior. "Mental illness" may include substance abuse, which is the use, without compelling 2261 medical reason, of any substance which results in psychological or physiological dependency as a 2262 function of continued use in such a manner as to induce mental, emotional, or physical impairment and 2263 cause socially dysfunctional or socially disordering behavior. Mental retardationIntellectual disability, 2264 head injury, a learning disability, or a seizure disorder is not sufficient, in itself, to justify a finding of 2265 mental illness within the meaning of this article.

2266 "Minor" means a person less than eighteen years of age.

2267 "Parent" means (i) a biological or adoptive parent who has legal custody of the minor, including 2268 either parent if custody is shared under a joint decree or agreement, (ii) a biological or adoptive parent 2269 with whom the minor regularly resides, (iii) a person judicially appointed as a legal guardian of the minor, or (iv) a person who exercises the rights and responsibilities of legal custody by delegation from 2270 2271 a biological or adoptive parent, upon provisional adoption or otherwise by operation of law. The director 2272 of the local department of social services, or his designee, may stand as the minor's parent when the minor is in the legal custody of the local department of social services. 2273

2274 "Qualified evaluator" means a psychiatrist or a psychologist licensed in Virginia by either the Board of Medicine or the Board of Psychology who is skilled in the diagnosis and treatment of mental illness 2275 2276 in minors and familiar with the provisions of this article. If such psychiatrist or psychologist is 2277 unavailable, any mental health professional (i) licensed in Virginia through the Department of Health 2278 Professions or (ii) employed by a community services board who is skilled in the diagnosis and 2279 treatment of mental illness in minors and who is familiar with the provisions of this article may serve as 2280 the qualified evaluator.

2281 "Treatment" means any planned intervention intended to improve a minor's functioning in those areas 2282 which show impairment as a result of mental illness. 2283

§ 16.1-345. Învoluntary commitment; criteria.

2284 The court shall order the involuntary commitment of the minor to a mental health facility for 2285 treatment for a period not to exceed 90 days if it finds, by clear and convincing evidence, that:

2286 1. Because of mental illness, the minor (i) presents a serious danger to himself or others to the extent that severe or irremediable injury is likely to result, as evidenced by recent acts or threats or (ii) is 2287 experiencing a serious deterioration of his ability to care for himself in a developmentally 2288 2289 age-appropriate manner, as evidenced by delusionary thinking or by a significant impairment of 2290 functioning in hydration, nutrition, self-protection, or self-control;

2291 2. The minor is in need of compulsory treatment for a mental illness and is reasonably likely to 2292 benefit from the proposed treatment; and

2293 3. If inpatient treatment is ordered, such treatment is the least restrictive alternative that meets the 2294 minor's needs. If the court finds that inpatient treatment is not the least restrictive treatment, the court 2295 may order the minor to participate in outpatient or other clinically appropriate treatment.

2296 A minor who has been hospitalized while properly detained for a criminal offense by a juvenile and 2297 domestic relations district court shall be returned to the detention home following completion of a period 2298 of inpatient treatment, unless the court having jurisdiction over the criminal case orders that the minor 2299 be released from custody.

2300 In conducting an evaluation of a minor who has been properly detained, if the evaluator finds, 2301 irrespective of the fact that the minor has been detained, that the minor meets the criteria for involuntary 2302 commitment in this section, the evaluator shall recommend that the minor meets the criteria for 2303 involuntary commitment.

2304 In no event shall a minor who has been properly detained by a juvenile and domestic relations 2305 district court, and who meets criteria for involuntary commitment, have the right to make application for 2306 voluntary admission and treatment as may otherwise be provided for in this section.

2307 If the parent or parents with whom the minor resides are not willing to approve the proposed 2308 commitment, the court shall order inpatient treatment only if it finds, in addition to the criteria specified in this section, that such treatment is necessary to protect the minor's life, health, or normal 2309 2310 development, and that issuance of a removal order or protective order is authorized by § 16.1-252 or 2311 16.1-253.

2312 Upon finding that the best interests of the minor so require, the court may enter an order directing 2313 either or both of the minor's parents to comply with reasonable conditions relating to the minor's 2314 treatment.

2315 If the minor is committed to inpatient treatment, such placement shall be in a mental health facility 2316 for inpatient treatment designated by the community services board which serves the political subdivision in which the minor was evaluated pursuant to § 16.1-342. If the community services board 2317 2318 does not provide a placement recommendation at the hearing, the minor shall be placed in a mental 2319 health facility designated by the Commissioner of the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services. The judge shall order the sheriff to 2320 2321 transport the minor to the designated mental health facility as specified in § 37.2-829. The transportation 2322 of the committed minor by the minor's parent may be authorized at the discretion of the judge.

2323 § 16.1-356. Raising question of competency to stand trial; evaluation and determination of 2324 competency.

2325 A. If, at any time after the attorney for the juvenile has been retained or appointed pursuant to a 2326 delinquency proceeding and before the end of trial, the court finds, sua sponte or upon hearing evidence 2327 or representations of counsel for the juvenile or the attorney for the Commonwealth, that there is 2328 probable cause to believe that the juvenile lacks substantial capacity to understand the proceedings 2329 against him or to assist his attorney in his own defense, the court shall order that a competency 2330 evaluation be performed by at least one psychiatrist, clinical psychologist, licensed professional counselor, licensed clinical social worker, or licensed marriage and family therapist, who is qualified by 2331 2332 training and experience in the forensic evaluation of juveniles.

2333 The Commissioner of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 2334 Services shall approve the training and qualifications for individuals authorized to conduct juvenile 2335 competency evaluations and provide restoration services to juveniles pursuant to this article. The

2336 Commissioner shall also provide all juvenile courts with a list of guidelines for the court to use in the
2337 determination of qualifying individuals as experts in matters relating to juvenile competency and
2338 restoration.

2339 B. The evaluation shall be performed on an outpatient basis at a community services board or 2340 behavioral health authority, juvenile detention home or juvenile justice facility unless the court 2341 specifically finds that (i) the results of the outpatient competency evaluation indicate that hospitalization 2342 of the juvenile for evaluation of competency is necessary or (ii) the juvenile is currently hospitalized in 2343 a psychiatric hospital. If one of these findings is made, the court, under authority of this subsection, may 2344 order the juvenile sent to a hospital designated by the Commissioner of Mental Health, Mental 2345 RetardationIntellectual Disability and Substance Abuse Services as appropriate for the evaluation of 2346 juveniles against whom a delinquency petition has been filed.

2347 C. The court shall require the attorney for the Commonwealth to provide to the evaluators appointed 2348 under subsection A any information relevant to the evaluation, including, but not limited to (i) a copy of 2349 the warrant or petition, (ii) the names and addresses of the attorney for the Commonwealth, the attorney 2350 for the juvenile, and the judge ordering the evaluation; and (iii) information about the alleged offense. 2351 The court shall require the attorney for the juvenile to provide to the evaluator only the psychiatric 2352 records and other information that is deemed relevant to the evaluation of competency. The moving 2353 party shall provide the evaluator a summary of the reasons for the evaluation request. All information 2354 required by this subsection shall be provided to the evaluator within 96 hours of the issuance of the 2355 court order requiring the evaluation and when applicable, shall be submitted prior to admission to the 2356 facility providing the inpatient evaluation. If the 96-hour period expires on a Saturday, Sunday or other 2357 legal holiday, the 96 hours shall be extended to the next day which is not a Saturday, Sunday or legal 2358 holiday.

D. If the juvenile is hospitalized under the provisions of subsection B, the juvenile shall be hospitalized for such time as the director of the hospital deems necessary to perform an adequate evaluation of the juvenile's competency, but not to exceed 10 days from the date of admission to the hospital. All evaluations shall be completed and the report filed with the court within 14 days of receipt by the evaluator of all information required under subsection C.

E. Upon completion of the evaluation, the evaluator shall promptly and in no event exceeding 14 days after receipt of all required information submit the report in writing to the court and the attorneys of record concerning (i) the juvenile's capacity to understand the proceedings against him; (ii) his ability to assist his attorney; and (iii) his need for services in the event he is found incompetent, including a description of the suggested necessary services and least restrictive setting to assist the juvenile in restoration to competency. No statements of the juvenile relating to the alleged offense shall be included in the report.

F. After receiving the report described in subsection E, the court shall promptly determine whether the juvenile is competent to stand trial for adjudication or disposition. A hearing on the juvenile's competency is not required unless one is requested by the attorney for the Commonwealth or the attorney for the juvenile or when required under § 16.1-357 B. If a hearing is held, the party alleging that the juvenile is incompetent shall bear the burden of proving by a preponderance of the evidence the juvenile's incompetency. The juvenile shall have the right to notice of the hearing and the right to personally participate in and introduce evidence at the hearing.

2378 If the juvenile is otherwise able to understand the charges against him and assist in his defense, a
2379 finding of incompetency shall not be made based solely on any or all of the following: (i) the juvenile's
2380 age or developmental factors, (ii) the juvenile's claim to be unable to remember the time period
2381 surrounding the alleged offense, or (iii) the fact that the juvenile is under the influence of medication.
2382 § 16.1-357. Disposition when juvenile found incompetent.

A. Upon finding pursuant to subsection F of § 16.1-356 that the juvenile is incompetent, the court shall order that the juvenile receive services to restore his competency in either a nonsecure community setting or a secure facility as defined in § 16.1-228. A copy of the order shall be forwarded to the Commissioner of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, who shall arrange for the provision of restoration services in a manner consistent with the order. Any report submitted pursuant to subsection E of § 16.1-356 shall be made available to the agent providing restoration.

B. If the court finds the juvenile incompetent but restorable to competency in the foreseeable future,
it shall order restoration services for up to three months. At the end of three months from the date
restoration is ordered under subsection A of this section, if the juvenile remains incompetent in the
opinion of the agent providing restoration, the agent shall so notify the court and make recommendations
concerning disposition of the juvenile. The court shall hold a hearing according to the procedures
specified in subsection F of § 16.1-356 and, if it finds the juvenile unrestorably incompetent, shall order
one of the dispositions pursuant to § 16.1-358. If the court finds the juvenile incompetent but restorable

2397 to competency, it may order continued restoration services for additional three-month periods, provided a 2398 hearing pursuant to subsection F of § 16.1-356 is held at the completion of each such period and the 2399 juvenile continues to be incompetent but restorable to competency in the foreseeable future.

2400 C. If, at any time after the juvenile is ordered to undergo services under subsection A of this section, 2401 the agent providing restoration believes the juvenile's competency is restored, the agent shall 2402 immediately send a report to the court as prescribed in subsection E of § 16.1-356. The court shall make 2403 a ruling on the juvenile's competency according to the procedures specified in subsection F of 2404 § 16.1-356. 2405

§ 16.1-361. Compensation of experts.

2406 Each psychiatrist, clinical psychologist, licensed clinical social worker, licensed professional 2407 counselor, licensed marriage and family therapist, or other expert appointed by the court to render professional service pursuant to § 16.1-356, shall receive a reasonable fee for such service. With the 2408 2409 exception of services provided by state mental health or mental retardation facilities or facilities for 2410 persons with intellectual disability, the fee shall be determined in each instance by the court that 2411 appointed the expert, in accordance with guidelines established by the Supreme Court after consultation 2412 with the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 2413 Services. If any such expert is required to appear as a witness in any hearing held pursuant to 2414 § 16.1-356, he shall receive mileage and a fee of \$100 for each day during which he is required to 2415 serve. An itemized account of expenses, duly sworn to, must be presented to the court, and when 2416 allowed shall be certified to the Supreme Court for payment out of the state treasury, and be charged 2417 against the appropriations made to pay criminal charges. Allowance for the fee and for the per diem authorized shall also be made by order of the court, duly certified to the Supreme Court for payment out 2418 2419 of the appropriation to pay criminal charges. 2420

§ 18.2-73. When abortion lawful during second trimester of pregnancy.

2421 Notwithstanding any of the provisions of § 18.2-71 and in addition to the provisions of § 18.2-72, it 2422 shall be lawful for any physician licensed by the Board of Medicine to practice medicine and surgery, to 2423 terminate or attempt to terminate a human pregnancy or aid or assist in the termination of a human 2424 pregnancy by performing an abortion or causing a miscarriage on any woman during the second 2425 trimester of pregnancy and prior to the third trimester of pregnancy provided such procedure is performed in a hospital licensed by the State Department of Health or under the control of the State 2426 2427 Board of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services. 2428

§ 18.2-74. When abortion or termination of pregnancy lawful after second trimester of pregnancy.

2429 Notwithstanding any of the provisions of § 18.2-71 and in addition to the provisions of §§ 18.2-72 2430 and 18.2-73, it shall be lawful for any physician licensed by the Board of Medicine to practice medicine 2431 and surgery to terminate or attempt to terminate a human pregnancy or aid or assist in the termination 2432 of a human pregnancy by performing an abortion or causing a miscarriage on any woman in a stage of 2433 pregnancy subsequent to the second trimester provided the following conditions are met:

2434 (a) Said operation is performed in a hospital licensed by the Virginia State Department of Health or 2435 under the control of the State Board of Mental Health, Mental RetardationIntellectual Disability and 2436 Substance Abuse Services.

(b) The physician and two consulting physicians certify and so enter in the hospital record of the 2437 2438 woman, that in their medical opinion, based upon their best clinical judgment, the continuation of the 2439 pregnancy is likely to result in the death of the woman or substantially and irremediably impair the 2440 mental or physical health of the woman.

2441 (c) Measures for life support for the product of such abortion or miscarriage must be available and 2442 utilized if there is any clearly visible evidence of viability.

2443 § 18.2-251. Persons charged with first offense may be placed on probation; conditions; substance 2444 abuse screening, assessment treatment and education programs or services; drug tests; costs and fees; 2445 violations; discharge.

2446 Whenever any person who has not previously been convicted of any offense under this article or 2447 under any statute of the United States or of any state relating to narcotic drugs, marijuana, or stimulant, 2448 depressant, or hallucinogenic drugs, or has not previously had a proceeding against him for violation of such an offense dismissed as provided in this section, pleads guilty to or enters a plea of not guilty to 2449 2450 possession of a controlled substance under § 18.2-250 or to possession of marijuana under § 18.2-250.1, 2451 the court, upon such plea if the facts found by the court would justify a finding of guilt, without entering a judgment of guilt and with the consent of the accused, may defer further proceedings and 2452 2453 place him on probation upon terms and conditions.

2454 As a term or condition, the court shall require the accused to undergo a substance abuse assessment 2455 pursuant to § 18.2-251.01 or § 19.2-299.2, as appropriate, and enter treatment and/or education program 2456 or services, if available, such as, in the opinion of the court, may be best suited to the needs of the accused based upon consideration of the substance abuse assessment. The program or services may be 2457 2458 located in the judicial district in which the charge is brought or in any other judicial district as the court

2459 may provide. The services shall be provided by (i) a program licensed by the Department of Mental 2460 Health, Mental RetardationIntellectual Disability and Substance Abuse Services, by a similar program 2461 which is made available through the Department of Corrections, (ii) a local community-based probation 2462 services agency established pursuant to § 9.1-174, or (iii) an ASAP program certified by the 2463 Commission on VASAP.

2464 The court shall require the person entering such program under the provisions of this section to pay 2465 all or part of the costs of the program, including the costs of the screening, assessment, testing, and 2466 treatment, based upon the accused's ability to pay unless the person is determined by the court to be 2467 indigent.

As a condition of probation, the court shall require the accused (i) to successfully complete treatment 2468 2469 or education program or services, (ii) to remain drug and alcohol free during the period of probation and 2470 submit to such tests during that period as may be necessary and appropriate to determine if the accused 2471 is drug and alcohol free, (iii) to make reasonable efforts to secure and maintain employment, and (iv) to 2472 comply with a plan of at least 100 hours of community service for a felony and up to 24 hours of 2473 community service for a misdemeanor. Such testing shall be conducted by personnel of the supervising 2474 probation agency or personnel of any program or agency approved by the supervising probation agency.

2475 The court shall, unless done at arrest, order the accused to report to the original arresting 2476 law-enforcement agency to submit to fingerprinting.

2477 Upon violation of a term or condition, the court may enter an adjudication of guilt and proceed as 2478 otherwise provided. Upon fulfillment of the terms and conditions, the court shall discharge the person 2479 and dismiss the proceedings against him. Discharge and dismissal under this section shall be without 2480 adjudication of guilt and is a conviction only for the purposes of applying this section in subsequent 2481 proceedings.

2482 Notwithstanding any other provision of this section, whenever a court places an individual on 2483 probation upon terms and conditions pursuant to this section, such action shall be treated as a conviction 2484 for purposes of §§ 18.2-259.1, 22.1-315 and 46.2-390.1, and the driver's license forfeiture provisions of 2485 those sections shall be imposed. The provisions of this paragraph shall not be applicable to any offense 2486 for which a juvenile has had his license suspended or denied pursuant to § 16.1-278.9 for the same 2487 offense. 2488

§ 18.2-251.01. Substance abuse screening and assessment for felony convictions.

2489 A. When a person is convicted of a felony, not a capital offense, committed on or after January 1, 2490 2000, he shall be required to undergo a substance abuse screening and, if the screening indicates a 2491 substance abuse or dependence problem, an assessment by a certified substance abuse counselor as 2492 defined in § 54.1-3500 employed by the Department of Corrections or by an agency employee under the 2493 supervision of such counselor. If the person is determined to have a substance abuse problem, the court 2494 shall require him to enter treatment and/or education program or services, if available, which, in the 2495 opinion of the court, is best suited to the needs of the person. The program or services may be located 2496 in the judicial district in which the conviction was had or in any other judicial district as the court may 2497 provide. The treatment and/or education program or services shall be licensed by the Department of 2498 Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services or shall be a 2499 similar program or services which are made available through the Department of Corrections if the court 2500 imposes a sentence of one year or more or, if the court imposes a sentence of 12 months or less, by a 2501 similar program or services available through a local or regional jail, a local community-based probation 2502 services agency established pursuant to § 9.1-174, or an ASAP program certified by the Commission on 2503 VASAP. The services agency or program may require the person entering such program or services 2504 under the provisions of this section to pay a fee for the education and treatment component, or both, 2505 based upon the defendant's ability to pay.

2506 B. As a condition of any suspended sentence and probation, the court shall order the person to 2507 undergo periodic testing and treatment for substance abuse, if available, as the court deems appropriate 2508 based upon consideration of the substance abuse assessment.

2509 § 18.2-252. Suspended sentence conditioned upon substance abuse screening, assessment, testing, and 2510 treatment or education.

2511 The trial judge or court trying the case of any person found guilty of violating any law concerning 2512 the use, in any manner, of drugs, controlled substances, narcotics, marijuana, noxious chemical 2513 substances and like substances, shall condition any suspended sentence by first requiring such person to 2514 agree to undergo a substance abuse screening pursuant to § 18.2-251.01 and to submit to such periodic 2515 substance abuse testing, to include alcohol testing, as may be directed by the court. Such testing shall be 2516 conducted by the supervising probation agency or by personnel of any program or agency approved by 2517 the supervising probation agency. The cost of such testing ordered by the court shall be paid by the 2518 Commonwealth and taxed as a part of the costs of such criminal proceedings. The judge or court shall 2519 order the person, as a condition of any suspended sentence, to undergo such treatment or education for

2520 substance abuse, if available, as the judge or court deems appropriate based upon consideration of the 2521 substance abuse assessment. The treatment or education shall be provided by a program or agency 2522 licensed by the Department of Mental Health, Mental RetardationIntellectual Disability and Substance 2523 Abuse Services, by a similar program or services available through the Department of Corrections if the 2524 court imposes a sentence of one year or more or, if the court imposes a sentence of 12 months or less, 2525 by a similar program or services available through a local or regional jail, a local community-based 2526 probation services agency established pursuant to § 9.1-174, or an ASAP program certified by the 2527 Commission on VASAP.

§ 18.2-254. Commitment of convicted person for treatment for substance abuse.

2529 A. Whenever any person who has not previously been convicted of any offense under this article or 2530 under any statute of the United States or of any state relating to narcotic drugs, marijuana, stimulant, 2531 depressant, or hallucinogenic drugs or has not previously had a proceeding against him for violation of such an offense dismissed as provided in § 18.2-251 is found guilty of violating any law concerning the 2532 2533 use, in any manner, of drugs, controlled substances, narcotics, marijuana, noxious chemical substances, 2534 and like substances, the judge or court shall require such person to undergo a substance abuse screening 2535 pursuant to § 18.2-251.01 and to submit to such periodic substance abuse testing, to include alcohol 2536 testing, as may be directed by the court. The cost of such testing ordered by the court shall be paid by 2537 the Commonwealth and taxed as a part of the costs of the criminal proceedings. The judge or court shall 2538 also order the person to undergo such treatment or education for substance abuse, if available, as the 2539 judge or court deems appropriate based upon consideration of the substance abuse assessment. The 2540 treatment or education shall be provided by a program or agency licensed by the Department of Mental 2541 Health, Mental RetardationIntellectual Disability and Substance Abuse Services or by a similar program 2542 or services available through the Department of Corrections if the court imposes a sentence of one year 2543 or more or, if the court imposes a sentence of 12 months or less, by a similar program or services 2544 available through a local or regional jail, a local community-based probation services agency established 2545 pursuant to § 9.1-174, or an ASAP program certified by the Commission on VASAP.

B. The court trying the case of any person alleged to have committed any offense designated by this 2546 2547 article or by the Drug Control Act (§ 54.1-3400 et seq.) or in any other criminal case in which the commission of the offense was motivated by or closely related to the use of drugs and determined by 2548 2549 the court, pursuant to a substance abuse screening and assessment, to be in need of treatment for the use 2550 of drugs may commit, based upon a consideration of the substance abuse assessment, such person, upon 2551 his conviction, to any facility for the treatment of persons with substance abuse, licensed by the 2552 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, if 2553 space is available in such facility, for a period of time not in excess of the maximum term of 2554 imprisonment specified as the penalty for conviction of such offense or, if sentence was determined by a 2555 jury, not in excess of the term of imprisonment as set by such jury. Confinement under such 2556 commitment shall be, in all regards, treated as confinement in a penal institution and the person so 2557 committed may be convicted of escape if he leaves the place of commitment without authority. A charge 2558 of escape may be prosecuted in either the jurisdiction where the treatment facility is located or the 2559 jurisdiction where the person was sentenced to commitment. The court may revoke such commitment at 2560 any time and transfer the person to an appropriate state or local correctional facility. Upon presentation 2561 of a certified statement from the director of the treatment facility to the effect that the confined person 2562 has successfully responded to treatment, the court may release such confined person prior to the 2563 termination of the period of time for which such person was confined and may suspend the remainder of the term upon such conditions as the court may prescribe. 2564

2565 C. The court trying a case in which commission of the offense was related to the defendant's habitual 2566 abuse of alcohol and in which the court determines, pursuant to a substance abuse screening and 2567 assessment, that such defendant is in need of treatment, may commit, based upon a consideration of the 2568 substance abuse assessment, such person, upon his conviction, to any facility for the treatment of 2569 persons with substance abuse licensed by the Department of Mental Health, Mental 2570 RetardationIntellectual Disability and Substance Abuse Services, if space is available in such facility, for 2571 a period of time not in excess of the maximum term of imprisonment specified as the penalty for 2572 conviction. Confinement under such commitment shall be, in all regards, treated as confinement in a 2573 penal institution and the person so committed may be convicted of escape if he leaves the place of 2574 commitment without authority. The court may revoke such commitment at any time and transfer the 2575 person to an appropriate state or local correctional facility. Upon presentation of a certified statement 2576 from the director of the treatment facility to the effect that the confined person has successfully 2577 responded to treatment, the court may release such confined person prior to the termination of the period 2578 of time for which such person was confined and may suspend the remainder of the term upon such 2579 conditions as the court may prescribe.

**2580** § 18.2-254.1. Drug Treatment Court Act.

**2581** A. This section shall be known and may be cited as the "Drug Treatment Court Act."

Ŋ

B. The General Assembly recognizes that there is a critical need in the Commonwealth for effective treatment programs that reduce the incidence of drug use, drug addiction, family separation due to parental substance abuse, and drug-related crimes. It is the intent of the General Assembly by this section to enhance public safety by facilitating the creation of drug treatment courts as means by which to accomplish this purpose.

2587 C. The goals of drug treatment courts include: (i) reducing drug addiction and drug dependency
2588 among offenders; (ii) reducing recidivism; (iii) reducing drug-related court workloads; (iv) increasing
2589 personal, familial and societal accountability among offenders; and, (v) promoting effective planning and
2590 use of resources among the criminal justice system and community agencies.

D. Drug treatment courts are specialized court dockets within the existing structure of Virginia's court system offering judicial monitoring of intensive treatment and strict supervision of addicts in drug and drug-related cases. Local officials must complete a recognized planning process before establishing a drug treatment court program.

E. Administrative oversight for implementation of the Drug Treatment Court Act shall be conducted
by the Supreme Court of Virginia. The Supreme Court of Virginia shall be responsible for (i) providing
oversight for the distribution of funds for drug treatment courts; (ii) providing technical assistance to
drug treatment courts; (iii) providing training for judges who preside over drug treatment courts; (iv)
providing training to the providers of administrative, case management, and treatment services to drug
treatment courts; and (v) monitoring the completion of evaluations of the effectiveness and efficiency of
drug treatment courts in the Commonwealth.

2602 F. A state drug treatment court advisory committee shall be established to (i) evaluate and 2603 recommend standards for the planning and implementation of drug treatment courts; (ii) assist in the 2604 evaluation of their effectiveness and efficiency; and (iii) encourage and enhance cooperation among 2605 agencies that participate in their planning and implementation. The committee shall be chaired by the Chief Justice of the Supreme Court of Virginia or his designee and shall include a member of the 2606 Judicial Conference of Virginia who presides over a drug treatment court; a district court judge; the 2607 2608 Executive Secretary or his designee; the directors of the following executive branch agencies: 2609 Department of Corrections, Department of Criminal Justice Services, Department of Juvenile Justice, 2610 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, 2611 Department of Social Services; a representative of the following entities: a local community-based 2612 probation and pretrial services agency, the Commonwealth's Attorney's Association, the Virginia Indigent 2613 Defense Commission, the Circuit Court Clerk's Association, the Virginia Sheriff's Association, the 2614 Virginia Association of Chiefs of Police, the Commission on VASAP, and two representatives 2615 designated by the Virginia Drug Court Association.

2616 G. Each jurisdiction or combination of jurisdictions that intend to establish a drug treatment court or 2617 continue the operation of an existing one shall establish a local drug treatment court advisory committee. 2618 Jurisdictions that establish separate adult and juvenile drug treatment courts may establish an advisory 2619 committee for each such court. Each advisory committee shall ensure quality, efficiency, and fairness in 2620 the planning, implementation, and operation of the drug treatment court or courts that serve the 2621 jurisdiction or combination of jurisdictions. Advisory committee membership shall include, but shall not 2622 be limited to the following people or their designees: (i) the drug treatment court judge; (ii) the attorney 2623 for the Commonwealth, or, where applicable, the city or county attorney who has responsibility for the 2624 prosecution of misdemeanor offenses; (iii) the public defender or a member of the local criminal defense 2625 bar in jurisdictions in which there is no public defender; (iv) the clerk of the court in which the drug 2626 treatment court is located; (v) a representative of the Virginia Department of Corrections, or the Department of Juvenile Justice, or both, from the local office which serves the jurisdiction or 2627 2628 combination of jurisdictions; (vi) a representative of a local community-based probation and pretrial 2629 services agency; (vii) a local law-enforcement officer; (viii) a representative of the Department of Mental 2630 Health, Mental RetardationIntellectual Disability, and Substance Abuse Services or a representative of 2631 local drug treatment providers; (ix) the drug court administrator; (x) a representative of the Department 2632 of Social Services; (xi) county administrator or city manager; and (xii) any other people selected by the 2633 drug treatment court advisory committee.

2634 H. Each local drug treatment court advisory committee shall establish criteria for the eligibility and 2635 participation of offenders who have been determined to be addicted to or dependent upon drugs. Subject 2636 to the provisions of this section, neither the establishment of a drug treatment court nor anything herein 2637 shall be construed as limiting the discretion of the attorney for the Commonwealth to prosecute any 2638 criminal case arising therein which he deems advisable to prosecute, except to the extent the 2639 participating attorney for the Commonwealth agrees to do so. As defined in § 17.1-805 or 19.2-297.1, 2640 adult offenders who have been convicted of a violent criminal offense within the preceding 10 years, or 2641 juvenile offenders who previously have been adjudicated not innocent of any such offense within the 2642 preceding 10 years, shall not be eligible for participation in any drug treatment court established or

2643 continued in operation pursuant to this section.

2644 I. Each drug treatment court advisory committee shall establish policies and procedures for the 2645 operation of the court to attain the following goals: (i) effective integration of drug and alcohol 2646 treatment services with criminal justice system case processing; (ii) enhanced public safety through 2647 intensive offender supervision and drug treatment; (iii) prompt identification and placement of eligible 2648 participants; (iv) efficient access to a continuum of alcohol, drug, and related treatment and rehabilitation 2649 services; (v) verified participant abstinence through frequent alcohol and other drug testing; (vi) prompt 2650 response to participants' noncompliance with program requirements through a coordinated strategy; (vii) 2651 ongoing judicial interaction with each drug court participant; (viii) ongoing monitoring and evaluation of 2652 program effectiveness and efficiency; (ix) ongoing interdisciplinary education and training in support of 2653 program effectiveness and efficiency; and (x) ongoing collaboration among drug treatment courts, public 2654 agencies, and community-based organizations to enhance program effectiveness and efficiency.

2655 J. Participation by an offender in a drug treatment court shall be voluntary and made pursuant only2656 to a written agreement entered into by and between the offender and the Commonwealth with the2657 concurrence of the court.

**2658** K. Nothing in this section shall preclude the establishment of substance abuse treatment programs and services pursuant to the deferred judgment provisions of § 18.2-251.

2660 L. Each offender shall contribute to the cost of the substance abuse treatment he receives while
 2661 participating in a drug treatment court pursuant to guidelines developed by the drug treatment court
 2662 advisory committee.

2663 M. Nothing contained in this section shall confer a right or an expectation of a right to treatment for
 2664 an offender or be construed as requiring a local drug treatment court advisory committee to accept for
 2665 participation every offender.

N. The Office of the Executive Secretary shall, with the assistance of the state drug treatment court advisory committee, develop a statewide evaluation model and conduct ongoing evaluations of the effectiveness and efficiency of all local drug treatment courts. A report of these evaluations shall be submitted to the General Assembly by December 1 of each year. Each local drug treatment court advisory committee shall submit evaluative reports to the Office of the Executive Secretary as requested.

O. Notwithstanding any other provision of this section, no drug treatment court shall be established
subsequent to March 1, 2004, unless the jurisdiction or jurisdictions intending or proposing to establish
such court have been specifically granted permission under the Code of Virginia to establish such court.
The provisions of this subsection shall not apply to any drug treatment court established on or before
March 1, 2004, and operational as of July 1, 2004.

2676 P. Subject to the requirements and conditions established by the state Drug Treatment Court
2677 Advisory Committee, there shall be established a drug treatment court in the following jurisdictions: the
2678 City of Chesapeake and the City of Newport News.

2679 § 18.2-258.1. Obtaining drugs, procuring administration of controlled substances, etc., by fraud, deceit2680 or forgery.

A. It shall be unlawful for any person to obtain or attempt to obtain any drug or procure or attempt to procure the administration of any controlled substance or marijuana: (i) by fraud, deceit, misrepresentation, embezzlement, or subterfuge; or (ii) by the forgery or alteration of a prescription or of any written order; or (iii) by the concealment of a material fact; or (iv) by the use of a false name or the giving of a false address.

2686 B. It shall be unlawful for any person to furnish false or fraudulent information in or omit any information from, or willfully make a false statement in, any prescription, order, report, record, or other document required by Chapter 34 (§ 54.1-3400 et seq.) of Title 54.1.

2689 C. It shall be unlawful for any person to use in the course of the manufacture or distribution of a controlled substance or marijuana a license number which is fictitious, revoked, suspended, or issued to another person.

2692 D. It shall be unlawful for any person, for the purpose of obtaining any controlled substance or
2693 marijuana, to falsely assume the title of, or represent himself to be, a manufacturer, wholesaler,
2694 pharmacist, physician, dentist, veterinarian or other authorized person.

E. It shall be unlawful for any person to make or utter any false or forged prescription or false or forged written order.

**2697** F. It shall be unlawful for any person to affix any false or forged label to a package or receptacle containing any controlled substance.

G. This section shall not apply to officers and employees of the United States, of this
Commonwealth or of a political subdivision of this Commonwealth acting in the course of their
employment, who obtain such drugs for investigative, research or analytical purposes, or to the agents or
duly authorized representatives of any pharmaceutical manufacturer who obtain such drugs for
investigative, research or analytical purposes and who are acting in the course of their employment;
provided that such manufacturer is licensed under the provisions of the Federal Food, Drug and

2705 Cosmetic Act; and provided further, that such pharmaceutical manufacturer, its agents and duly2706 authorized representatives file with the Board such information as the Board may deem appropriate.

2707 H. Except as otherwise provided in this subsection, any person who shall violate any provision herein2708 shall be guilty of a Class 6 felony.

Whenever any person who has not previously been convicted of any offense under this article or under any statute of the United States or of any state relating to narcotic drugs, marijuana, or stimulant, depressant, or hallucinogenic drugs, or has not previously had a proceeding against him for violation of such an offense dismissed, or reduced as provided in this section, pleads guilty to or enters a plea of not guilty to the court for violating this section, upon such plea if the facts found by the court would justify a finding of guilt, the court may place him on probation upon terms and conditions.

2715 As a term or condition, the court shall require the accused to be evaluated and enter a treatment 2716 and/or education program, if available, such as, in the opinion of the court, may be best suited to the 2717 needs of the accused. This program may be located in the judicial circuit in which the charge is brought or in any other judicial circuit as the court may provide. The services shall be provided by a program 2718 2719 certified or licensed by the Department of Mental Health, Mental RetardationIntellectual Disability and 2720 Substance Abuse Services. The court shall require the person entering such program under the provisions 2721 of this section to pay all or part of the costs of the program, including the costs of the screening, 2722 evaluation, testing and education, based upon the person's ability to pay unless the person is determined 2723 by the court to be indigent.

As a condition of supervised probation, the court shall require the accused to remain drug free during the period of probation and submit to such tests during that period as may be necessary and appropriate to determine if the accused is drug free. Such testing may be conducted by the personnel of any screening, evaluation, and education program to which the person is referred or by the supervising agency.

Unless the accused was fingerprinted at the time of arrest, the court shall order the accused to report to the original arresting law-enforcement agency to submit to fingerprinting.

Upon violation of a term or condition, the court may enter an adjudication of guilt upon the felonyand proceed as otherwise provided. Upon fulfillment of the terms and conditions of probation, the courtshall find the defendant guilty of a Class 1 misdemeanor.

\$ 18.2-271.2. Commission on VASAP; purpose; membership; terms; meetings; staffing; compensation
and expenses; chairman's executive summary.

2736 A. There is hereby established in the legislative branch of state government the Commission on the 2737 Virginia Alcohol Safety Action Program (VASAP). The Commission shall administer and supervise the 2738 state system of local alcohol and safety action programs, develop and maintain operation and 2739 performance standards for local alcohol and safety action programs, and allocate funding to such 2740 programs. The Commission shall have a total membership of 15 members that shall consist of six 2741 legislative members and nine nonlegislative citizen members. Members shall be appointed as follows: 2742 four current or former members of the House Committee for Courts of Justice, to be appointed by the 2743 Speaker of the House of Delegates; two members of the Senate Committee for Courts of Justice, to be 2744 appointed by the Senate Committee on Rules; three sitting or retired judges, one each from the circuit, 2745 general district and juvenile and domestic relations district courts, who regularly hear or heard cases 2746 involving driving under the influence and are familiar with their local alcohol safety action programs, to 2747 be appointed by the Chairman of the Committee on District Courts; two directors of local alcohol safety 2748 action programs, to be appointed by the legislative members of the Commission; one representative from 2749 the law-enforcement profession, to be appointed by the Speaker of the House and one nonlegislative 2750 citizen at large, to be appointed by the Senate Committee on Rules; one representative from the Virginia 2751 Department of Motor Vehicles whose duties are substantially related to matters to be addressed by the 2752 Commission to be appointed by the Commissioner of the Department of Motor Vehicles, and one 2753 representative from the Department of Mental Health, Mental RetardationIntellectual Disability and 2754 Substance Abuse Services whose duties also substantially involve such matters, to be appointed by the 2755 Commissioner of the Department of Mental Health, Mental RetardationIntellectual Disability and 2756 Substance Abuse Services. Legislative members shall serve terms coincident with their terms of office. 2757 In accordance with the staggered terms previously established, nonlegislative citizen members shall serve 2758 two-year terms. All members may be reappointed. Appointments to fill vacancies, other than by 2759 expiration of a term, shall be made for the unexpired terms. Any appointment to fill a vacancy shall be 2760 made in the same manner as the original appointment.

2761 B. The Commission shall meet at least four times each year at such places as it may from time to
2762 time designate. A majority of the members shall constitute a quorum. The Commission shall elect a
2763 chairman and vice-chairman from among its membership.

The Commission shall be empowered to establish and ensure the maintenance of minimum standards and criteria for program operations and performance, accounting, auditing, public information and

administrative procedures for the various local alcohol safety action programs and shall be responsible
for overseeing the administration of the statewide VASAP system. Such programs shall be certified by
the Commission in accordance with procedures set forth in the Commission on VASAP Certification
Manual. The Commission shall also oversee program plans, operations and performance and a system
for allocating funds to cover deficits that may occur in the budgets of local programs.

2771 C. The Commission shall appoint and employ and, at its pleasure, remove an executive director and
2772 such other persons as it may deem necessary, and determine their duties and fix their salaries or
2773 compensation.

D. The Commission shall appoint a Virginia Alcohol Safety Action Program Advisory Board to make recommendations to the Commission regarding its duties and administrative functions. The membership of such Board shall be appointed in the discretion of the Commission and include personnel from (i) local safety action programs, (ii) state or local boards of mental health and mental retardationintellectual disability and (iii) other community mental health services organizations. An assistant attorney general who provides counsel in matters relating to driving under the influence shall also be appointed to the Board.

E. Legislative members of the Commission shall receive compensation as provided in § 30-19.12.
Funding for the costs of compensation of legislative members shall be provided by the Commission. All members shall be reimbursed for all reasonable and necessary expenses as provided in §§ 2.2-2813 and 2.2-2825 to be paid out of that portion of moneys paid in VASAP defendant entry fees which is forwarded to the Virginia Alcohol Safety Action Program.

F. The chairman of the Commission shall submit to the Governor and the General Assembly an annual executive summary of the interim activity and work of the Commission no later than the first day of each regular session of the General Assembly. The executive summary shall be submitted as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports and shall be posted on the General Assembly's website.

§ 18.2-308.1:1. Possession or transportation of firearms by persons acquitted by reason of insanity;
 penalty; permit.

2793 A. It shall be unlawful for any person acquitted by reason of insanity and committed to the custody 2794 of the Commissioner of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 2795 Services, pursuant to Chapter 11.1 (§ 19.2-182.2 et seq.) of Title 19.2, on a charge of treason, any 2796 felony or any offense punishable as a misdemeanor under Title 54.1 or a Class 1 or Class 2 2797 misdemeanor under this title, except those misdemeanor violations of (i) Article 2 (§ 18.2-266 et seq.) of 2798 Chapter 7 of this title, (ii) Article 2 (§ 18.2-415 et seq.) of Chapter 9 of this title, or (iii) § 18.2-119, or 2799 (iv) an ordinance of any county, city, or town similar to the offenses specified in (i), (ii), or (iii), to 2800 knowingly and intentionally possess or transport any firearm. A violation of this section shall be punishable as a Class 1 misdemeanor. 2801

2802 B. Any person so acquitted may, upon discharge from the custody of the Commissioner, petition the circuit court in which he resides for a permit to possess or carry a firearm. The court may, in its discretion and for good cause shown, grant the petition and issue a permit, in which event the provisions of subsection A do not apply.

2806 § 18.2-308.2:2. Criminal history record information check required for the transfer of certain firearms. 2807 A. Any person purchasing from a dealer a firearm as herein defined shall consent in writing, on a 2808 form to be provided by the Department of State Police, to have the dealer obtain criminal history record 2809 information. Such form shall include only the written consent; the name, birth date, gender, race, 2810 citizenship, and social security number and/or any other identification number; the number of firearms 2811 by category intended to be sold, rented, traded, or transferred; and answers by the applicant to the following questions: (i) has the applicant been convicted of a felony offense or found guilty or 2812 adjudicated delinquent as a juvenile 14 years of age or older at the time of the offense of a delinquent 2813 2814 act that would be a felony if committed by an adult and (ii) is the applicant subject to a court order 2815 restraining the applicant from harassing, stalking, or threatening the applicant's child or intimate partner, 2816 or a child of such partner, or is the applicant subject to a protective order.

2817 B. 1. No dealer shall sell, rent, trade or transfer from his inventory any such firearm to any other 2818 person who is a resident of Virginia until he has (i) obtained written consent and the other information 2819 on the consent form specified in subsection A, and provided the Department of State Police with the 2820 name, birth date, gender, race, citizenship, and social security and/or any other identification number and 2821 the number of firearms by category intended to be sold, rented, traded or transferred and (ii) requested 2822 criminal history record information by a telephone call to or other communication authorized by the State Police and is authorized by subdivision 2 of this subsection to complete the sale or other such 2823 2824 transfer. To establish personal identification and residence in Virginia for purposes of this section, a 2825 dealer must require any prospective purchaser to present one photo-identification form issued by a 2826 governmental agency of the Commonwealth or by the United States Department of Defense, and other 2827 documentation of residence. Except where the photo-identification was issued by the United States

2828 Department of Defense, the other documentation of residence shall show an address identical to that 2829 shown on the photo-identification form, such as evidence of currently paid personal property tax or real 2830 estate tax, or a current (a) lease, (b) utility or telephone bill, (c) voter registration card, (d) bank check, 2831 (e) passport, (f) automobile registration, or (g) hunting or fishing license; other current identification 2832 allowed as evidence of residency by Part 178.124 of Title 27 of the Code of Federal Regulations and 2833 ATF Ruling 2001-5; or other documentation of residence determined to be acceptable by the Department 2834 of Criminal Justice Services, that corroborates that the prospective purchaser currently resides in 2835 Virginia. Where the photo-identification was issued by the Department of Defense, permanent orders 2836 assigning the purchaser to a duty post in Virginia shall be the only other required documentation of 2837 residence. For the purposes of this section and establishment of residency for firearm purchase, 2838 residency shall be deemed to be the permanent duty post of a member of the armed forces. When the 2839 photo-identification presented to a dealer by the prospective purchaser is a driver's license or other 2840 photo-identification issued by the Department of Motor Vehicles, and such identification form contains a 2841 date of issue, the dealer shall not, except for a renewed driver's license or other photo-identification 2842 issued by the Department of Motor Vehicles, sell or otherwise transfer a firearm to the prospective 2843 purchaser until 30 days after the date of issue of an original or duplicate driver's license unless the 2844 prospective purchaser also presents a copy of his Virginia Department of Motor Vehicles driver's record 2845 showing that the original date of issue of the driver's license was more than 30 days prior to the 2846 attempted purchase.

2847 In addition, no dealer shall sell, rent, trade or transfer from his inventory any assault firearm to any 2848 person who is not a citizen of the United States or who is not a person lawfully admitted for permanent 2849 residence. To establish citizenship or lawful admission for a permanent residence for purposes of 2850 purchasing an assault firearm, a dealer shall require a prospective purchaser to present a certified birth 2851 certificate or a certificate of birth abroad issued by the United States State Department, a certificate of 2852 citizenship or a certificate of naturalization issued by the United States Citizenship and Immigration Services, an unexpired U.S. passport, a United States citizen identification card, a current voter 2853 registration card, a current selective service registration card, or an immigrant visa or other 2854 2855 documentation of status as a person lawfully admitted for permanent residence issued by the United 2856 States Citizenship and Immigration Services.

Upon receipt of the request for a criminal history record information check, the State Police shall (1)
review its criminal history record information to determine if the buyer or transferee is prohibited from possessing or transporting a firearm by state or federal law, (2) inform the dealer if its record indicates that the buyer or transferee is so prohibited, and (3) provide the dealer with a unique reference number for that inquiry.

2862 2. The State Police shall provide its response to the requesting dealer during the dealer's request, or 2863 by return call without delay. If the criminal history record information check indicates the prospective 2864 purchaser or transferee has a disqualifying criminal record or has been acquitted by reason of insanity 2865 and committed to the custody of the Commissioner of Mental Health, Mental RetardationIntellectual 2866 Disability and Substance Abuse Services, the State Police shall have until the end of the dealer's next 2867 business day to advise the dealer if its records indicate the buyer or transferee is prohibited from 2868 possessing or transporting a firearm by state or federal law. If not so advised by the end of the dealer's 2869 next business day, a dealer who has fulfilled the requirements of subdivision 1 of this subsection may 2870 immediately complete the sale or transfer and shall not be deemed in violation of this section with 2871 respect to such sale or transfer. In case of electronic failure or other circumstances beyond the control of 2872 the State Police, the dealer shall be advised immediately of the reason for such delay and be given an estimate of the length of such delay. After such notification, the State Police shall, as soon as possible 2873 2874 but in no event later than the end of the dealer's next business day, inform the requesting dealer if its 2875 records indicate the buyer or transferee is prohibited from possessing or transporting a firearm by state 2876 or federal law. A dealer who fulfills the requirements of subdivision 1 of this subsection and is told by 2877 the State Police that a response will not be available by the end of the dealer's next business day may 2878 immediately complete the sale or transfer and shall not be deemed in violation of this section with 2879 respect to such sale or transfer.

3. Except as required by subsection D of § 9.1-132, the State Police shall not maintain records longer than 30 days, except for multiple handgun transactions for which records shall be maintained for 12 months, from any dealer's request for a criminal history record information check pertaining to a buyer or transferee who is not found to be prohibited from possessing and transporting a firearm under state or federal law. However, the log on requests made may be maintained for a period of 12 months, and such log shall consist of the name of the purchaser, the dealer identification number, the unique approval number and the transaction date.

2887 4. On the last day of the week following the sale or transfer of any firearm, the dealer shall mail or2888 deliver the written consent form required by subsection A to the Department of State Police. The State

2889 Police shall immediately initiate a search of all available criminal history record information to 2890 determine if the purchaser is prohibited from possessing or transporting a firearm under state or federal 2891 law. If the search discloses information indicating that the buyer or transferee is so prohibited from 2892 possessing or transporting a firearm, the State Police shall inform the chief law-enforcement officer in 2893 the jurisdiction where the sale or transfer occurred and the dealer without delay.

2894 5. Notwithstanding any other provisions of this section, rifles and shotguns may be purchased by 2895 persons who are citizens of the United States or persons lawfully admitted for permanent residence but 2896 residents of other states under the terms of subsections A and B upon furnishing the dealer with proof 2897 of citizenship or status as a person lawfully admitted for permanent residence and one 2898 photo-identification form issued by a governmental agency of the person's state of residence and one other form of identification determined to be acceptable by the Department of Criminal Justice Services. 2899

6. For the purposes of this subsection, the phrase "dealer's next business day" shall not include 2900 2901 December 25.

2902 C. No dealer shall sell, rent, trade or transfer from his inventory any firearm, except when the 2903 transaction involves a rifle or a shotgun and can be accomplished pursuant to the provisions of 2904 subdivision B 5 to any person who is not a resident of Virginia unless he has first obtained from the 2905 Department of State Police a report indicating that a search of all available criminal history record 2906 information has not disclosed that the person is prohibited from possessing or transporting a firearm 2907 under state or federal law. The dealer shall obtain the required report by mailing or delivering the 2908 written consent form required under subsection A to the State Police within 24 hours of its execution. If 2909 the dealer has complied with the provisions of this subsection and has not received the required report 2910 from the State Police within 10 days from the date the written consent form was mailed to the 2911 Department of State Police, he shall not be deemed in violation of this section for thereafter completing 2912 the sale or transfer.

2913 D. Nothing herein shall prevent a resident of the Commonwealth, at his option, from buying, renting 2914 or receiving a firearm from a dealer in Virginia by obtaining a criminal history record information check 2915 through the dealer as provided in subsection C.

2916 E. If any buyer or transferee is denied the right to purchase a firearm under this section, he may 2917 exercise his right of access to and review and correction of criminal history record information under 2918 § 9.1-132 or institute a civil action as provided in § 9.1-135, provided any such action is initiated within 2919 30 days of such denial.

2920 F. Any dealer who willfully and intentionally requests, obtains, or seeks to obtain criminal history 2921 record information under false pretenses, or who willfully and intentionally disseminates or seeks to 2922 disseminate criminal history record information except as authorized in this section shall be guilty of a 2923 Class 2 misdemeanor. 2924

G. For purposes of this section:

2925 "Actual buyer" means a person who executes the consent form required in subsection B or C, or 2926 other such firearm transaction records as may be required by federal law. 2927

"Antique firearm" means:

2928 1. Any firearm (including any firearm with a matchlock, flintlock, percussion cap, or similar type of 2929 ignition system) manufactured in or before 1898;

2. Any replica of any firearm described in subdivision 1 of this definition if such replica (i) is not 2930 2931 designed or redesigned for using rimfire or conventional centerfire fixed ammunition or (ii) uses rimfire 2932 or conventional centerfire fixed ammunition that is no longer manufactured in the United States and that 2933 is not readily available in the ordinary channels of commercial trade;

2934 3. Any muzzle-loading rifle, muzzle-loading shotgun, or muzzle-loading pistol that is designed to use 2935 black powder, or a black powder substitute, and that cannot use fixed ammunition. For purposes of this subdivision, the term "antique firearm" shall not include any weapon that incorporates a firearm frame 2936 2937 or receiver, any firearm that is converted into a muzzle-loading weapon, or any muzzle-loading weapon 2938 that can be readily converted to fire fixed ammunition by replacing the barrel, bolt, breech-block, or any 2939 combination thereof; or 2940

4. Any curio or relic as defined in this subsection.

2941 "Assault firearm" means any semi-automatic center-fire rifle or pistol which expels single or multiple 2942 projectiles by action of an explosion of a combustible material and is equipped at the time of the 2943 offense with a magazine which will hold more than 20 rounds of ammunition or designed by the 2944 manufacturer to accommodate a silencer or equipped with a folding stock.

2945 "Curios or relics" means firearms that are of special interest to collectors by reason of some quality 2946 other than is associated with firearms intended for sporting use or as offensive or defensive weapons. To 2947 be recognized as curios or relics, firearms must fall within one of the following categories:

2948 1. Firearms that were manufactured at least 50 years prior to the current date, which use rimfire or 2949 conventional centerfire fixed ammunition that is no longer manufactured in the United States and that is 2950 not readily available in the ordinary channels of commercial trade, but not including replicas thereof;

Ŋ

2951 2. Firearms that are certified by the curator of a municipal, state, or federal museum that exhibits2952 firearms to be curios or relics of museum interest; and

3. Any other firearms that derive a substantial part of their monetary value from the fact that they are novel, rare, bizarre, or because of their association with some historical figure, period, or event.
Proof of qualification of a particular firearm under this category may be established by evidence of present value and evidence that like firearms are not available except as collectors' items, or that the value of like firearms available in ordinary commercial channels is substantially less.

2958

8 "Dealer" means any person licensed as a dealer pursuant to 18 U.S.C. § 921 et seq.

**2959** "Firearm" means any handgun, shotgun, or rifle that will or is designed to or may readily be converted to expel single or multiple projectiles by action of an explosion of a combustible material.

2961 "Handgun" means any pistol or revolver or other firearm originally designed, made and intended to
2962 fire single or multiple projectiles by means of an explosion of a combustible material from one or more
2963 barrels when held in one hand.

2964 "Lawfully admitted for permanent residence" means the status of having been lawfully accorded the2965 privilege of residing permanently in the United States as an immigrant in accordance with the2966 immigration laws, such status not having changed.

2967 H. The Department of Criminal Justice Services shall promulgate regulations to ensure the identity,2968 confidentiality and security of all records and data provided by the Department of State Police pursuant2969 to this section.

2970 I. The provisions of this section shall not apply to (i) transactions between persons who are licensed
2971 as firearms importers or collectors, manufacturers or dealers pursuant to 18 U.S.C. § 921 et seq.; (ii)
2972 purchases by or sales to any law-enforcement officer or agent of the United States, the Commonwealth
2973 or any local government; or (iii) antique firearms, curios or relics.

J. The provisions of this section shall not apply to restrict purchase, trade or transfer of firearms by a resident of Virginia when the resident of Virginia makes such purchase, trade or transfer in another state, in which case the laws and regulations of that state and the United States governing the purchase, trade or transfer of firearms shall apply. A National Instant Criminal Background Check System (NICS) check shall be performed prior to such purchase, trade or transfer of firearms.

2979 J1. All licensed firearms dealers shall collect a fee of \$2 for every transaction for which a criminal 2980 history record information check is required pursuant to this section, except that a fee of \$5 shall be 2981 collected for every transaction involving an out-of-state resident. Such fee shall be transmitted to the 2982 Department of State Police by the last day of the month following the sale for deposit in a special fund for use by the State Police to offset the cost of conducting criminal history record information checks 2984 under the provisions of this section.

2985 K. Any person willfully and intentionally making a materially false statement on the consent form
2986 required in subsection B or C or on such firearm transaction records as may be required by federal law,
2987 shall be guilty of a Class 5 felony.

**2988** L. Except as provided in § 18.2-308.2:1, any dealer who willfully and intentionally sells, rents, trades or transfers a firearm in violation of this section shall be guilty of a Class 6 felony.

L1. Any person who attempts to solicit, persuade, encourage, or entice any dealer to transfer or otherwise convey a firearm other than to the actual buyer, as well as any other person who willfully and intentionally aids or abets such person, shall be guilty of a Class 6 felony. This subsection shall not apply to a federal law-enforcement officer or a law-enforcement officer as defined in § 9.1-101, in the performance of his official duties, or other person under his direct supervision.

M. Any person who purchases a firearm with the intent to (i) resell or otherwise provide such firearm to any person who he knows or has reason to believe is ineligible to purchase or otherwise receive from a dealer a firearm for whatever reason or (ii) transport such firearm out of the Commonwealth to be resold or otherwise provided to another person who the transferor knows is ineligible to purchase or otherwise receive a firearm, shall be guilty of a Class 5 felony. However, if the violation of this subsection involves such a transfer of more than one firearm, the person shall be sentenced to a mandatory minimum term of imprisonment of five years.

3002 N. Any person who is ineligible to purchase or otherwise receive or possess a firearm in the
 3003 Commonwealth who solicits, employs or assists any person in violating subsection M shall be guilty of
 a Class 5 felony and shall be sentenced to a mandatory minimum term of imprisonment of five years.

3005 O. All driver's licenses issued on or after July 1, 1994, shall carry a letter designation indicating 3006 whether the driver's license is an original, duplicate or renewed driver's license.

P. Except as provided in subdivisions 1, 2 and 3 of this subsection, it shall be unlawful for any person who is not a licensed firearms dealer to purchase more than one handgun within any 30-day period. A violation of this subsection shall be punishable as a Class 1 misdemeanor.

**3010** 1. Purchases in excess of one handgun within a 30-day period may be made upon completion of an enhanced background check, as described herein, by special application to the Department of State

3012 Police listing the number and type of handguns to be purchased and transferred for lawful business or 3013 personal use, in a collector series, for collections, as a bulk purchase from estate sales and for similar 3014 purposes. Such applications shall be signed under oath by the applicant on forms provided by the 3015 Department of State Police, shall state the purpose for the purchase above the limit, and shall require satisfactory proof of residency and identity. Such application shall be in addition to the firearms sales 3016 3017 report required by the Bureau of Alcohol, Tobacco and Firearms (ATF). The Superintendent of State 3018 Police shall promulgate regulations, pursuant to the Administrative Process Act (§ 2.2-4000 et seq.), for 3019 the implementation of an application process for purchases of handguns above the limit.

3020 Upon being satisfied that these requirements have been met, the Department of State Police shall 3021 forthwith issue to the applicant a nontransferable certificate, which shall be valid for seven days from 3022 the date of issue. The certificate shall be surrendered to the dealer by the prospective purchaser prior to the consummation of such sale and shall be kept on file at the dealer's place of business for inspection 3023 3024 as provided in § 54.1-4201 for a period of not less than two years. Upon request of any local 3025 law-enforcement agency, and pursuant to its regulations, the Department of State Police may certify such 3026 local law-enforcement agency to serve as its agent to receive applications and, upon authorization by the 3027 Department of State Police, issue certificates forthwith pursuant to this subsection. Applications and 3028 certificates issued under this subsection shall be maintained as records as provided in subdivision B 3. 3029 The Department of State Police shall make available to local law-enforcement agencies all records 3030 concerning certificates issued pursuant to this subsection and all records provided for in subdivision B 3.

- 3031 2. The provisions of this subsection shall not apply to:
- 3032 a. A law-enforcement agency;
- 3033 b. An agency duly authorized to perform law-enforcement duties;
- 3034 c. State and local correctional facilities;
- d. A private security company licensed to do business within the Commonwealth: 3035
- 3036 e. The purchase of antique firearms as herein defined;

3037 f. A person whose handgun is stolen or irretrievably lost who deems it essential that such handgun 3038 be replaced immediately. Such person may purchase another handgun, even if the person has previously 3039 purchased a handgun within a 30-day period, provided (i) the person provides the firearms dealer with a 3040 copy of the official police report or a summary thereof, on forms provided by the Department of State 3041 Police, from the law-enforcement agency that took the report of the lost or stolen handgun; (ii) the 3042 official police report or summary thereof contains the name and address of the handgun owner, the 3043 description of the handgun, the location of the loss or theft, the date of the loss or theft, and the date 3044 the loss or theft was reported to the law-enforcement agency; and (iii) the date of the loss or theft as 3045 reflected on the official police report or summary thereof occurred within 30 days of the person's 3046 attempt to replace the handgun. The firearms dealer shall attach a copy of the official police report or 3047 summary thereof to the original copy of the Virginia firearms transaction report completed for the 3048 transaction and retain it for the period prescribed by the Department of State Police;

3049 g. A person who trades in a handgun at the same time he makes a handgun purchase and as a part of 3050 the same transaction, provided that no more than one transaction of this nature is completed per day; 3051

h. A person who holds a valid Virginia permit to carry a concealed handgun;

i. A person who purchases a handgun in a private sale. For purposes of this subdivision, a private 3052 3053 sale means purchase from a person who makes occasional sales, exchanges or purchases of firearms for 3054 the enhancement of a personal collection of curios or relics as herein defined, or who sells all or part of 3055 such collection of curios and relics; or

3056 j. A law-enforcement officer. For purposes of this subdivision, a law-enforcement officer means any 3057 employee of a police department or sheriff's office that is part of or administered by the Commonwealth 3058 or any political subdivision thereof, and who is responsible for the prevention and detection of crime 3059 and the enforcement of the penal, traffic or highway laws of the Commonwealth.

3. For the purposes of this subsection, "purchase" shall not include the exchange or replacement of a 3060 3061 handgun by a seller for a handgun purchased from such seller by the same person seeking the exchange 3062 or replacement within the 30-day period immediately preceding the date of exchange or replacement. 3063

§ 18.2-369. Abuse and neglect of incapacitated adults; penalty.

3064 A. It shall be unlawful for any responsible person to abuse or neglect any incapacitated adult as 3065 defined in this section. Any responsible person who abuses or neglects an incapacitated adult in 3066 violation of this section and the abuse or neglect does not result in serious bodily injury or disease to 3067 the incapacitated adult is guilty of a Class 1 misdemeanor. Any responsible person who is convicted of 3068 a second or subsequent offense under this subsection is guilty of a Class 6 felony.

3069 B. Any responsible person who abuses or neglects an incapacitated adult in violation of this section 3070 and the abuse or neglect results in serious bodily injury or disease to the incapacitated adult is guilty of 3071 a Class 4 felony. Any responsible person who abuses or neglects an incapacitated adult in violation of 3072 this section and the abuse or neglect results in the death of the incapacitated adult is guilty of a Class 3 3073 felony.

**3074** C. For purposes of this section:

3075 "Abuse" means (i) knowing and willful conduct that causes physical injury or pain or (ii) knowing
3076 and willful use of physical restraint, including confinement, as punishment, for convenience or as a
3077 substitute for treatment, except where such conduct or physical restraint, including confinement, is a part
3078 of care or treatment and is in furtherance of the health and safety of the incapacitated person.

3079 "Incapacitated adult" means any person 18 years or older who is impaired by reason of mental illness, mental retardation, physical illness or disability, *intellectual disability*, advanced age or other causes to the extent the adult lacks sufficient understanding or capacity to make, communicate or carry out reasonable decisions concerning his well-being.

3083 "Neglect" means the knowing and willful failure by a responsible person to provide treatment, care, goods or services which results in injury to the health or endangers the safety of an incapacitated adult.

3085 "Responsible person" means a person who has responsibility for the care, custody or control of an
 3086 incapacitated person by operation of law or who has assumed such responsibility voluntarily, by contract
 3087 or in fact.

3088 "Serious bodily injury or disease" shall include but not be limited to (i) disfigurement, (ii) a fracture, (iii) a severe burn or laceration, (iv) mutilation, (v) maiming, or (vi) life-threatening internal injuries or conditions, whether or not caused by trauma.

3091 D. No responsible person shall be in violation of this section whose conduct was (i) in accordance 3092 with the informed consent of the incapacitated person or a person authorized to consent on his behalf; 3093 (ii) in accordance with a declaration by the incapacitated person under the Natural Death Act of Virginia 3094 (§ 54.1-2981 et seq.) or with the provisions of a valid medical power of attorney; (iii) in accordance 3095 with the wishes of the incapacitated person or a person authorized to consent on behalf of the 3096 incapacitated person and in accord with the tenets and practices of a church or religious denomination; 3097 (iv) incident to necessary movement of, placement of or protection from harm to the incapacitated 3098 person; or (v) a bona fide, recognized or approved practice to provide medical care.

**3099** § 19.2-123. Release of accused on secured or unsecured bond or promise to appear; conditions of release.

A. Any person arrested for a felony who has previously been convicted of a felony, or who is presently on bond for an unrelated arrest in any jurisdiction, or who is on probation or parole, may be released only upon a secure bond. This provision may be waived with the approval of the judicial officer and with the concurrence of the attorney for the Commonwealth or the attorney for the county, city or town. Subject to the foregoing, when a person is arrested for either a felony or a misdemeanor, any judicial officer may impose any one or any combination of the following conditions of release:

3107 1. Place the person in the custody and supervision of a designated person, organization or pretrial
3108 services agency which, for the purposes of this section, shall not include a court services unit established
3109 pursuant to § 16.1-233;

3110 2. Place restrictions on the travel, association or place of abode of the person during the period of 3111 release and restrict contacts with household members for a period not to exceed seventy-two hours;

2a. Require the execution of an unsecured bond;

3112

3. Require the execution of a secure bond which at the option of the accused shall be satisfied with sufficient solvent sureties, or the deposit of cash in lieu thereof. Only the actual value of any interest in real estate or personal property owned by the proposed surety shall be considered in determining solvency and solvency shall be found if the value of the proposed surety's equity in the real estate or personal property equals or exceeds the amount of the bond;

31.8 3a. Require that the person do any or all of the following: (i) maintain employment or, if 31.9 unemployed, actively seek employment; (ii) maintain or commence an educational program; (iii) avoid 31.20 all contact with an alleged victim of the crime and with any potential witness who may testify 31.21 concerning the offense; (iv) comply with a specified curfew; (v) refrain from possessing a firearm, 31.22 destructive device, or other dangerous weapon; (vi) refrain from excessive use of alcohol, or use of any 31.23 illegal drug or any controlled substance not prescribed by a health care provider; and (vii) submit to 31.24 testing for drugs and alcohol until the final disposition of his case; or

4. Impose any other condition deemed reasonably necessary to assure appearance as required, and to assure his good behavior pending trial, including a condition requiring that the person return to custody after specified hours or be placed on home electronic incarceration pursuant to § 53.1-131.2.

**3128** Upon satisfaction of the terms of recognizance, the accused shall be released forthwith.

In addition, where the accused is a resident of a state training center for the mentally retarded *persons with intellectual disability*, the judicial officer may place the person in the custody of the director of the state facility, if the director agrees to accept custody. Such director is hereby authorized to take custody of such person and to maintain him at the training center prior to a trial or hearing under such circumstances as will reasonably assure the appearance of the accused for the trial or hearing.

3135 B. In any jurisdiction served by a pretrial services agency which offers a drug or alcohol screening 3136 or testing program approved for the purposes of this subsection by the chief general district court judge, any such person charged with a crime may be requested by such agency to give voluntarily a urine 3137 sample, submit to a drug or alcohol screening, or take a breath test for presence of alcohol. A sample 3138 3139 may be analyzed for the presence of phencyclidine (PCP), barbiturates, cocaine, opiates or such other 3140 drugs as the agency may deem appropriate prior to any hearing to establish bail. The judicial officer and 3141 agency shall inform the accused or juvenile being screened or tested that test results shall be used by a 3142 judicial officer only at a bail hearing and only to determine appropriate conditions of release or to 3143 reconsider the conditions of bail at a subsequent hearing. All screening or test results, and any pretrial 3144 investigation report containing the screening or test results, shall be confidential with access thereto limited to judicial officers, the attorney for the Commonwealth, defense counsel, other pretrial service 3145 agencies, any criminal justice agency as defined in § 9.1-101 and, in cases where a juvenile is screened 3146 3147 or tested, the parents or legal guardian or custodian of such juvenile. However, in no event shall the 3148 judicial officer have access to any screening or test result prior to making a bail release determination or 3149 to determining the amount of bond, if any. Following this determination, the judicial officer shall 3150 consider the screening or test results and the screening or testing agency's report and accompanying recommendations, if any, in setting appropriate conditions of release. In no event shall a decision 3151 3152 regarding a release determination be subject to reversal on the sole basis of such screening or test 3153 results. Any accused or juvenile whose urine sample has tested positive for such drugs and who is 3154 admitted to bail may, as a condition of release, be ordered to refrain from use of alcohol or illegal drugs 3155 and may be required to be tested on a periodic basis until final disposition of his case to ensure his compliance with the order. Sanctions for a violation of any condition of release, which violations shall 3156 3157 include subsequent positive drug or alcohol test results or failure to report as ordered for testing, may be imposed in the discretion of the judicial officer and may include imposition of more stringent conditions 3158 3159 of release, contempt of court proceedings or revocation of release. Any test given under the provisions 3160 of this subsection which yields a positive drug or alcohol test result shall be reconfirmed by a second 3161 test if the person tested denies or contests the initial drug or alcohol test positive result. The results of 3162 any drug or alcohol test conducted pursuant to this subsection shall not be admissible in any judicial proceeding other than for the imposition of sanctions for a violation of a condition of release. 3163 3164

C. [Repealed.]

3165 D. Nothing in this section shall be construed to prevent an officer taking a juvenile into custody 3166 from releasing that juvenile pursuant to § 16.1-247. If any condition of release imposed under the provisions of this section is violated, a judicial officer may issue a capias or order to show cause why 3167 3168 the recognizance should not be revoked.

3169 § 19.2-169.1. Raising question of competency to stand trial or plead; evaluation and determination of 3170 competency.

A. Raising competency issue; appointment of evaluators. - If, at any time after the attorney for the 3171 3172 defendant has been retained or appointed and before the end of trial, the court finds, upon hearing 3173 evidence or representations of counsel for the defendant or the attorney for the Commonwealth, that 3174 there is probable cause to believe that the defendant, whether a juvenile transferred pursuant to § 16.1-269.1 or adult, lacks substantial capacity to understand the proceedings against him or to assist 3175 3176 his attorney in his own defense, the court shall order that a competency evaluation be performed by at 3177 least one psychiatrist or clinical psychologist who is qualified by training and experience in forensic 3178 evaluation.

3179 B. Location of evaluation. - The evaluation shall be performed on an outpatient basis at a mental 3180 health facility or in jail unless the court specifically finds that outpatient evaluation services are 3181 unavailable or unless the results of outpatient evaluation indicate that hospitalization of the defendant for 3182 evaluation on competency is necessary. If the court finds that hospitalization is necessary, the court, 3183 under authority of this subsection, may order the defendant sent to a hospital designated by the 3184 Commissioner of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services 3185 as appropriate for evaluations of persons under criminal charge. The defendant shall be hospitalized for 3186 such time as the director of the hospital deems necessary to perform an adequate evaluation of the defendant's competency, but not to exceed 30 days from the date of admission to the hospital. 3187

3188 C. Provision of information to evaluators. - The court shall require the attorney for the 3189 Commonwealth to provide to the evaluators appointed under subsection A any information relevant to 3190 the evaluation, including, but not limited to (i) a copy of the warrant or indictment; (ii) the names and 3191 addresses of the attorney for the Commonwealth, the attorney for the defendant, and the judge ordering 3192 the evaluation; (iii) information about the alleged crime; and (iv) a summary of the reasons for the 3193 evaluation request. The court shall require the attorney for the defendant to provide any available psychiatric records and other information that is deemed relevant. The court shall require that 3194 3195 information be provided to the evaluator within 96 hours of the issuance of the court order pursuant to 3196 this section.

D. The competency report. - Upon completion of the evaluation, the evaluators shall promptly submit
a report in writing to the court and the attorneys of record concerning (i) the defendant's capacity to
understand the proceedings against him; (ii) his ability to assist his attorney; and (iii) his need for
treatment in the event he is found incompetent but restorable, or incompetent for the foreseeable future.
No statements of the defendant relating to the time period of the alleged offense shall be included in the
report.

3203 E. The competency determination. - After receiving the report described in subsection D, the court 3204 shall promptly determine whether the defendant is competent to stand trial. A hearing on the defendant's 3205 competency is not required unless one is requested by the attorney for the Commonwealth or the 3206 attorney for the defendant, or unless the court has reasonable cause to believe the defendant will be 3207 hospitalized under § 19.2-169.2. If a hearing is held, the party alleging that the defendant is incompetent 3208 shall bear the burden of proving by a preponderance of the evidence the defendant's incompetency. The 3209 defendant shall have the right to notice of the hearing, the right to counsel at the hearing and the right 3210 to personally participate in and introduce evidence at the hearing.

3211 The fact that the defendant claims to be unable to remember the time period surrounding the alleged
3212 offense shall not, by itself, bar a finding of competency if the defendant otherwise understands the
3213 charges against him and can assist in his defense. Nor shall the fact that the defendant is under the
3214 influence of medication bar a finding of competency if the defendant is able to understand the charges
3215 against him and assist in his defense while medicated.

**3216** § 19.2-169.2. Disposition when defendant found incompetent.

3217 A. Upon finding pursuant to subsection E of § 19.2-169.1 that the defendant, including a juvenile 3218 transferred pursuant to § 16.1-269.1, is incompetent, the court shall order that the defendant receive 3219 treatment to restore his competency on an outpatient basis or, if the court specifically finds that the 3220 defendant requires inpatient hospital treatment, at a hospital designated by the Commissioner of Mental 3221 Health, Mental RetardationIntellectual Disability and Substance Abuse Services as appropriate for 3222 treatment of persons under criminal charge. Any reports submitted pursuant to subsection D of 3223 § 19.2-169.1 shall be made available to the director of the community services board or behavioral 3224 health authority or his designee or to the director of the treating inpatient facility or his designee.

B. If, at any time after the defendant is ordered to undergo treatment under subsection A of this section, the director of the community services board or behavioral health authority or his designee or the director of the treating inpatient facility or his designee believes the defendant's competency is restored, the director or his designee shall immediately send a report to the court as prescribed in subsection D of § 19.2-169.1. The court shall make a ruling on the defendant's competency according to the procedures specified in subsection E of § 19.2-169.1.

§ 19.2-169.3. Disposition of the unrestorably incompetent defendant; capital murder charge; referral
 to Commitment Review Committee.

3233 A. If, at any time after the defendant is ordered to undergo treatment pursuant to subsection A of 3234 § 19.2-169.2, the director of the community services board or behavioral health authority or his designee 3235 or the director of the treating inpatient facility or his designee concludes that the defendant is likely to 3236 remain incompetent for the foreseeable future, he shall send a report to the court so stating. The report 3237 shall also indicate whether, in the board, authority, or inpatient facility director's or his designee's 3238 opinion, the defendant should be released, committed pursuant to Article 5 (§ 37.2-814 et seq.) of 3239 Chapter 8 of Title 37.2, committed pursuant to Chapter 9 (§ 37.2-900 et seq.) of Title 37.2, or certified 3240 pursuant to § 37.2-806 in the event he is found to be unrestorably incompetent. Upon receipt of the 3241 report, the court shall make a competency determination according to the procedures specified in 3242 subsection E of § 19.2-169.1. If the court finds that the defendant is incompetent and is likely to remain 3243 so for the foreseeable future, it shall order that he be (i) released, (ii) committed pursuant to Article 5 3244 (§ 37.2-814 et seq.) of Chapter 8 of Title 37.2, or (iii) certified pursuant to § 37.2-806. However, if the 3245 court finds that the defendant is incompetent and is likely to remain so for the foreseeable future and the 3246 defendant has been charged with a sexually violent offense, as defined in § 37.2-900, he shall be 3247 reviewed for commitment pursuant to Chapter 9 (§ 37.2-900 et seq.) of Title 37.2. If the court finds the 3248 defendant incompetent but restorable to competency in the foreseeable future, it may order treatment 3249 continued until six months have elapsed from the date of the defendant's initial admission under 3250 subsection A of § 19.2-169.2.

B. At the end of six months from the date of the defendant's initial admission under subsection A of [3252] B. At the end of six months from the date of the defendant's initial admission under subsection A of [3253] In 19.2-169.2 if the defendant remains incompetent in the opinion of the board, authority, or inpatient [3254] facility director or his designee, the director or his designee shall so notify the court and make [3255] recommendations concerning disposition of the defendant as described in subsection A. The court shall [3256] hold a hearing according to the procedures specified in subsection E of § 19.2-169.1 and, if it finds the [3257] defendant unrestorably incompetent, shall order one of the dispositions described in subsection A. If the [3257] court finds the defendant incompetent but restorable to competency, it may order continued treatment 3258 under subsection A of § 19.2-169.2 for additional six-month periods, provided a hearing pursuant to 3259 subsection E of § 19.2-169.1 is held at the completion of each such period and the defendant continues 3260 to be incompetent but restorable to competency in the foreseeable future.

3261 C. Unless an incompetent defendant is charged with capital murder or the charges against an incompetent criminal defendant have been previously dismissed, charges against an unrestorably 3262 3263 incompetent defendant shall be dismissed on the date upon which his sentence would have expired had 3264 he been convicted and received the maximum sentence for the crime charged, or on the date five years 3265 from the date of his arrest for such charges, whichever is sooner.

3266 D. If the court orders an unrestorably incompetent defendant to be reviewed for commitment 3267 pursuant to § 37.2-904, it shall order the attorney for the Commonwealth in the jurisdiction wherein the 3268 defendant was charged and the Commissioner of the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services to provide the Commitment Review 3269 3270 Committee established pursuant to § 37.2-902 with any information relevant to the review, including, but 3271 not limited to: (i) a copy of the warrant or indictment, (ii) a copy of the defendant's criminal record, (iii) 3272 information about the alleged crime, (iv) a copy of the competency report completed pursuant to 3273 § 19.2-169.1, and (v) a copy of the report prepared by the director of the defendant's community 3274 services board, behavioral health authority, or treating inpatient facility or his designee pursuant to this 3275 section. The court shall further order that the defendant be held in the custody of the Department of 3276 Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services for secure 3277 confinement and treatment until the Commitment Review Committee's and Attorney General's review 3278 and any subsequent hearing or trial are completed. If the court receives notice that the Attorney General 3279 has declined to file a petition for the commitment of an unrestorably incompetent defendant as a sexually violent predator after conducting a review pursuant to § 37.2-905, the court shall order that the 3280 defendant be released, committed pursuant to Article 5 (§ 37.2-814 et seq.) of Chapter 8 of Title 37.2, 3281 3282 or certified pursuant to § 37.2-806.

3283 E. In any case when an incompetent defendant is charged with capital murder, notwithstanding any 3284 other provision of this section, the charge shall not be dismissed and the court having jurisdiction over 3285 the capital murder case may order that the defendant receive continued treatment under subsection A of § 19.2-169.2 for additional six-month periods without limitation, provided that (i) a hearing pursuant to 3286 3287 subsection E of § 19.2-169.1 is held at the completion of each such period, (ii) the defendant remains 3288 incompetent, (iii) the court finds continued treatment to be medically appropriate, and (iv) the defendant 3289 presents a danger to himself or others.

3290 F. The attorney for the Commonwealth may bring charges that have been dismissed against the 3291 defendant when he is restored to competency. 3292

§ 19.2-169.5. Evaluation of sanity at the time of the offense; disclosure of evaluation results.

3293 A. Raising issue of sanity at the time of offense; appointment of evaluators. - If, at any time before 3294 trial, the court finds, upon hearing evidence or representations of counsel for the defendant, that there is 3295 probable cause to believe that the defendant's sanity will be a significant factor in his defense and that 3296 the defendant is financially unable to pay for expert assistance, the court shall appoint one or more 3297 qualified mental health experts to evaluate the defendant's sanity at the time of the offense and, where appropriate, to assist in the development of an insanity defense. Such mental health expert shall be (i) a 3298 3299 psychiatrist, a clinical psychologist, or an individual with a doctorate degree in clinical psychology who 3300 has successfully completed forensic evaluation training as approved by the Commissioner of Mental 3301 Health, Mental RetardationIntellectual Disability and Substance Abuse Services and (ii) qualified by 3302 specialized training and experience to perform forensic evaluations. The defendant shall not be entitled 3303 to a mental health expert of his own choosing or to funds to employ such expert.

3304 B. Location of evaluation. - The evaluation shall be performed on an outpatient basis, at a mental health facility or in jail, unless the court specifically finds that outpatient services are unavailable, or 3305 3306 unless the results of the outpatient evaluation indicate that hospitalization of the defendant for further 3307 evaluation of his sanity at the time of the offense is necessary. If either finding is made, the court, under 3308 authority of this subsection, may order that the defendant be sent to a hospital designated by the 3309 Commissioner of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services 3310 as appropriate for evaluation of the defendant under criminal charge. The defendant shall be hospitalized 3311 for such time as the director of the hospital deems necessary to perform an adequate evaluation of the 3312 defendant's sanity at the time of the offense, but not to exceed 30 days from the date of admission to 3313 the hospital.

3314 C. Provision of information to evaluator. - The court shall require the party making the motion for 3315 the evaluation, and such other parties as the court deems appropriate, to provide to the evaluators 3316 appointed under subsection A any information relevant to the evaluation, including, but not limited to (i) 3317 copy of the warrant or indictment; (ii) the names and addresses of the attorney for the Commonwealth, 3318 the attorney for the defendant and the judge who appointed the expert; (iii) information pertaining to the 3319 alleged crime, including statements by the defendant made to the police and transcripts of preliminary

hearings, if any; (iv) a summary of the reasons for the evaluation request; (v) any available psychiatric,
psychological, medical or social records that are deemed relevant; and (vi) a copy of the defendant's
criminal record, to the extent reasonably available.

3323 D. The evaluators shall prepare a full report concerning the defendant's sanity at the time of the offense, including whether he may have had a significant mental disease or defect which rendered him insane at the time of the offense. The report shall be prepared within the time period designated by the court, said period to include the time necessary to obtain and evaluate the information specified in subsection C.

E. Disclosure of evaluation results. - The report described in subsection D shall be sent solely to the attorney for the defendant and shall be deemed to be protected by the lawyer-client privilege. However, the Commonwealth shall be given the report in all felony cases, the results of any other evaluation of the defendant's sanity at the time of the offense, and copies of psychiatric, psychological, medical, or other records obtained during the course of any such evaluation, after the attorney for the defendant gives notice of an intent to present psychiatric or psychological evidence pursuant to § 19.2-168.

F. In any case where the defendant obtains his own expert to evaluate the defendant's sanity at thetime of the offense, the provisions of subsections D and E, relating to the disclosure of the evaluationresults, shall apply.

**3337** § 19.2-175. Compensation of experts.

3338 Each psychiatrist, clinical psychologist or other expert appointed by the court to render professional 3339 service pursuant to §§ 19.2-168.1, 19.2-169.1, 19.2-169.5, subsection A of § 19.2-176, §§ 19.2-182.8, 3340 19.2-182.9, 19.2-264.3:1, 19.2-264.3:3 or § 19.2-301, who is not regularly employed by the 3341 Commonwealth of Virginia except by the University of Virginia School of Medicine and the Medical 3342 College of Virginia Commonwealth University, shall receive a reasonable fee for such service. For any 3343 psychiatrist, clinical psychologist, or other expert appointed by the court to render such professional services who is regularly employed by the Commonwealth of Virginia, except by the University of 3344 3345 Virginia School of Medicine or the Medical College of Virginia Commonwealth University, the fee shall 3346 be paid only for professional services provided during nonstate hours that have been approved by his employing agency as being beyond the scope of his state employment duties. The fee shall be 3347 3348 determined in each instance by the court that appointed the expert, in accordance with guidelines 3349 established by the Supreme Court after consultation with the Department of Mental Health, Mental 3350 RetardationIntellectual Disability and Substance Abuse Services. Except in capital murder cases the fee 3351 shall not exceed \$750, but in addition if any such expert is required to appear as a witness in any 3352 hearing held pursuant to such sections, he shall receive mileage and a fee of \$100 for each day during 3353 which he is required so to serve. An itemized account of expense, duly sworn to, must be presented to 3354 the court, and when allowed shall be certified to the Supreme Court for payment out of the state 3355 treasury, and be charged against the appropriations made to pay criminal charges. Allowance for the fee 3356 and for the per diem authorized shall also be made by order of the court, duly certified to the Supreme 3357 Court for payment out of the appropriation to pay criminal charges.

3358 § 19.2-182.2. Verdict of acquittal by reason of insanity to state the fact; temporary custody andacquittal by reason of insanity to state the fact; temporary custody andevaluation.

3360 When the defense is insanity of the defendant at the time the offense was committed, the jurors shall 3361 be instructed, if they acquit him on that ground, to state the fact with their verdict. The court shall place 3362 the person so acquitted ("the acquittee") in temporary custody of the Commissioner of Mental Health, 3363 Mental RetardationIntellectual Disability and Substance Abuse Services (hereinafter referred to in this 3364 chapter as the "Commissioner") for evaluation as to whether the acquittee may be released with or without conditions or requires commitment. The evaluation shall be conducted by (i) one psychiatrist 3365 3366 and (ii) one clinical psychologist. The psychiatrist or clinical psychologist shall be skilled in the 3367 diagnosis of mental illness and mental retardationintellectual disability and qualified by training and 3368 experience to perform such evaluations. The Commissioner shall appoint both evaluators, at least one of 3369 whom shall not be employed by the hospital in which the acquittee is primarily confined. The evaluators 3370 shall determine whether the acquittee is currently mentally ill or mentally retarded has intellectual 3371 disability and shall assess the acquittee and report on his condition and need for hospitalization with 3372 respect to the factors set forth in § 19.2-182.3. The evaluators shall conduct their examinations and 3373 report their findings separately within forty-five days of the Commissioner's assumption of custody. 3374 Copies of the report shall be sent to the acquittee's attorney, the attorney for the Commonwealth for the 3375 jurisdiction where the person was acquitted and the community services board or behavioral health 3376 authority as designated by the Commissioner. If either evaluator recommends conditional release or 3377 release without conditions of the acquittee, the court shall extend the evaluation period to permit the 3378 hospital in which the acquittee is confined and the appropriate community services board or behavioral 3379 health authority to jointly prepare a conditional release or discharge plan, as applicable, prior to the 3380 hearing.

3381 § 19.2-182.3. Commitment; civil proceedings.

3382 Upon receipt of the evaluation report and, if applicable, a conditional release or discharge plan, the 3383 court shall schedule the matter for hearing on an expedited basis, giving the matter priority over other 3384 civil matters before the court, to determine the appropriate disposition of the acquittee. Except as 3385 otherwise ordered by the court, the attorney who represented the defendant at the criminal proceedings 3386 shall represent the acquittee through the proceedings pursuant to this section. The matter may be 3387 continued on motion of either party for good cause shown. The acquittee shall be provided with 3388 adequate notice of the hearing, of the right to be present at the hearing, the right to the assistance of 3389 counsel in preparation for and during the hearing, and the right to introduce evidence and cross-examine 3390 witnesses at the hearing. The hearing is a civil proceeding.

3391 At the conclusion of the hearing, the court shall commit the acquittee if it finds that he has mental 3392 illness or mental retardation intellectual disability and is in need of inpatient hospitalization. For the 3393 purposes of this chapter, mental illness includes any mental illness, as defined in § 37.2-100, in a state 3394 of remission when the illness may, with reasonable probability, become active. The decision of the court 3395 shall be based upon consideration of the following factors:

3396 1. To what extent the acquittee has mental illness or mental retardation intellectual disability, as 3397 those terms are defined in § 37.2-100;

3398 2. The likelihood that the acquittee will engage in conduct presenting a substantial risk of bodily 3399 harm to other persons or to himself in the foreseeable future;

3400 3. The likelihood that the acquittee can be adequately controlled with supervision and treatment on 3401 an outpatient basis; and 3402

4. Such other factors as the court deems relevant.

3403 If the court determines that an acquittee does not need inpatient hospitalization solely because of 3404 treatment or habilitation he is currently receiving, but the court is not persuaded that the acquittee will 3405 continue to receive such treatment or habilitation, it may commit him for inpatient hospitalization. The 3406 court shall order the acquittee released with conditions pursuant to §§ 19.2-182.7 through 19.2-182.9 if it 3407 finds that he is not in need of inpatient hospitalization but that he meets the criteria for conditional 3408 release set forth in § 19.2-182.7. If the court finds that the acquittee does not need inpatient 3409 hospitalization nor does he meet the criteria for conditional release, it shall release him without 3410 conditions, provided the court has approved a discharge plan prepared by the appropriate community 3411 services board or behavioral health authority in consultation with the appropriate hospital staff. 3412

§ 19.2-182.8. Revocation of conditional release.

3413 If at any time the court that released an acquittee pursuant to § 19.2-182.7 finds reasonable ground to 3414 believe that an acquittee on conditional release (i) has violated the conditions of his release or is no 3415 longer a proper subject for conditional release based on application of the criteria for conditional release 3416 and (ii) requires inpatient hospitalization, it may order an evaluation of the acquittee by a psychiatrist or 3417 clinical psychologist, provided the psychiatrist or clinical psychologist is qualified by training and experience to perform forensic evaluations. If the court, based on the evaluation and after hearing 3418 3419 evidence on the issue, finds by a preponderance of the evidence that an acquittee on conditional release 3420 (i) has violated the conditions of his release or is no longer a proper subject for conditional release 3421 based on application of the criteria for conditional release and (ii) is mentally ill or mentally retarded 3422 has intellectual disability and requires inpatient hospitalization, the court may revoke the acquittee's 3423 conditional release and order him returned to the custody of the Commissioner. An acquittee's 3424 conditional release shall not be revoked solely because of his voluntary hospital admission.

3425 At any hearing pursuant to this section, the acquittee shall be provided with adequate notice of the 3426 hearing, of the right to be present at the hearing, the right to the assistance of counsel in preparation for 3427 and during the hearing, and the right to introduce evidence and cross-examine witnesses at the hearing. 3428 The hearing shall be scheduled on an expedited basis and shall be given priority over other civil matters 3429 before the court. Written notice of the hearing shall be provided to the attorney for the Commonwealth 3430 for the committing jurisdiction. The hearing is a civil proceeding. 3431

§ 19.2-182.9. Emergency custody of conditionally released acquittee.

3432 When exigent circumstances do not permit compliance with revocation procedures set forth in 3433 § 19.2-182.8, any district court judge or a special justice, as defined in § 37.2-100, or a magistrate may 3434 issue an emergency custody order, upon the sworn petition of any responsible person or upon his own 3435 motion based upon probable cause to believe that an acquittee on conditional release (i) has violated the 3436 conditions of his release or is no longer a proper subject for conditional release and (ii) requires 3437 inpatient hospitalization. The emergency custody order shall require the acquittee within his judicial 3438 district to be taken into custody and transported to a convenient location where a person designated by 3439 the community services board or behavioral health authority who is skilled in the diagnosis and 3440 treatment of mental illness shall evaluate such acquittee and assess his need for inpatient hospitalization. 3441 A law-enforcement officer who, based on his observation or the reliable reports of others, has probable 3442 cause to believe that any acquittee on conditional release has violated the conditions of his release and is

3443 no longer a proper subject for conditional release and requires emergency evaluation to assess the need 3444 for inpatient hospitalization, may take the acquittee into custody and transport him to an appropriate 3445 location to assess the need for hospitalization without prior judicial authorization. The evaluation shall 3446 be conducted immediately. The acquittee shall remain in custody until a temporary detention order is 3447 issued or until he is released, but in no event shall the period of custody exceed four hours. If it appears 3448 from all evidence readily available (i) that the acquittee has violated the conditions of his release or is 3449 no longer a proper subject for conditional release and (ii) that he requires emergency evaluation to 3450 assess the need for inpatient hospitalization, the district court judge or a special justice, as defined in 3451 § 37.2-100, or magistrate, upon the advice of such person skilled in the diagnosis and treatment of 3452 mental illness, may issue a temporary detention order authorizing the executing officer to place the 3453 acquittee in an appropriate institution for a period not to exceed 48 hours prior to a hearing. If the 3454 48-hour period terminates on a Saturday, Sunday, legal holiday, or day on which the court is lawfully 3455 closed, the acquittee may be detained until the next day which is not a Saturday, Sunday, legal holiday, 3456 or day on which the court is lawfully closed.

3457 The committing court or any district court judge or a special justice, as defined in § 37.2-100, shall 3458 have jurisdiction to hear the matter. Prior to the hearing, the acquittee shall be examined by a 3459 psychiatrist or licensed clinical psychologist, provided the psychiatrist or clinical psychologist is skilled 3460 in the diagnosis of mental illness, who shall certify whether the person is in need of hospitalization. At 3461 the hearing the acquittee shall be provided with adequate notice of the hearing, of the right to be present 3462 at the hearing, the right to the assistance of counsel in preparation for and during the hearing, and the 3463 right to introduce evidence and cross-examine witnesses at the hearing. Following the hearing, if the 3464 court determines, based on a preponderance of the evidence presented at the hearing, that the acquittee 3465 (i) has violated the conditions of his release or is no longer a proper subject for conditional release and 3466 (ii) has mental illness or mental retardation intellectual disability and is in need of inpatient 3467 hospitalization, the court shall revoke the acquittee's conditional release and place him in the custody of 3468 the Commissioner. An acquittee's conditional release shall not be revoked solely because of his 3469 voluntary hospital admission.

3470 When an acquittee on conditional release pursuant to this chapter is taken into emergency custody, 3471 detained, or hospitalized, such action shall be considered to have been taken pursuant to this section, 3472 notwithstanding the fact that his status as an insanity acquittee was not known at the time of custody, 3473 detention, or hospitalization. Detention or hospitalization of an acquittee pursuant to provisions of law 3474 other than those applicable to insanity acquittees pursuant to this chapter shall not render the detention 3475 or hospitalization invalid. If a person's status as an insanity acquittee on conditional release is not 3476 recognized at the time of emergency custody or detention, at the time his status as such is verified, the 3477 provisions applicable to such persons shall be applied and the court hearing the matter shall notify the 3478 committing court of the proceedings.

3479 § 19.2-182.13. Authority of Commissioner; delegation to board; liability.

3480 The Commissioner may delegate any of the duties and powers imposed on or granted to him by this 3481 chapter to an administrative board composed of persons with demonstrated expertise in such matters. 3482 The Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 3483 Services shall assist the board in its administrative and technical duties. Members of the board shall 3484 exercise their powers and duties without compensation and shall be immune from personal liability 3485 while acting within the scope of their duties except for intentional misconduct. § 19.2-182.16. Copies of orders to Commissioner.

3487 Copies of all orders and notices issued pursuant to this chapter shall be sent to the Commissioner of 3488 the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 3489 Services.

  - § 19.2-218.1. Preliminary hearings involving certain sexual crimes against spouses.

3491 A. In any preliminary hearing of a charge for a violation under § 18.2-61, 18.2-67.1, or 18.2-67.2 3492 where the complaining witness is the spouse of the accused, upon a finding of probable cause the court 3493 may request that its court services unit, in consultation with any appropriate social services organization, 3494 local board of mental health and mental retardationintellectual disability, or other community mental 3495 health services organization, prepare a report analyzing the feasibility of providing counseling or other 3496 forms of therapy for the accused and the probability such treatment will be successful. Based upon this 3497 report and any other relevant evidence, the court may, with the consent of the accused, the complaining 3498 witness and the attorney for the Commonwealth in any case involving a violation of § 18.2-61, 3499 18.2-67.1 or 18.2-67.2, authorize the accused to submit to and complete a designated course of 3500 counseling or therapy. In such case, the hearing shall be adjourned until such time as counseling or 3501 therapy is completed or terminated. Upon the completion of counseling or therapy by the accused and 3502 after consideration of a final evaluation to be furnished to the court by the person responsible for 3503 conducting such counseling or therapy and such further report of the court services unit as the court

may require, and after consideration of the views of the complaining witness, the court, in its discretion,
may discharge the accused if the court finds such action will promote maintenance of the family unit
and be in the best interest of the complaining witness.

B. No statement or disclosure by the accused concerning the alleged offense made during counseling
or any other form of therapy ordered pursuant to this section or § 18.2-61, 18.2-67.1, 18.2-67.2, or
19.2-218.2 may be used against the accused in any trial as evidence, nor shall any evidence against the
accused be admitted which was discovered through such statement or disclosure.

§ 19.2-264.3:1. Expert assistance when defendant's mental condition relevant to capital sentencing.

3512 A. Upon (i) motion of the attorney for a defendant charged with or convicted of capital murder and 3513 (ii) a finding by the court that the defendant is financially unable to pay for expert assistance, the court 3514 shall appoint one or more qualified mental health experts to evaluate the defendant and to assist the 3515 defense in the preparation and presentation of information concerning the defendant's history, character, 3516 or mental condition, including (i) whether the defendant acted under extreme mental or emotional 3517 disturbance at the time of the offense; (ii) whether the capacity of the defendant to appreciate the 3518 criminality of his conduct or to conform his conduct to the requirements of the law was significantly 3519 impaired at the time of the offense; and (iii) whether there are any other factors in mitigation relating to 3520 the history or character of the defendant or the defendant's mental condition at the time of the offense. 3521 The mental health expert appointed pursuant to this section shall be (i) a psychiatrist, a clinical 3522 psychologist, or an individual with a doctorate degree in clinical psychology who has successfully 3523 completed forensic evaluation training as approved by the Commissioner of Mental Health, Mental 3524 RetardationIntellectual Disability and Substance Abuse Services and (ii) qualified by specialized training 3525 and experience to perform forensic evaluations. The defendant shall not be entitled to a mental health 3526 expert of the defendant's own choosing or to funds to employ such expert.

B. Evaluations performed pursuant to subsection A may be combined with evaluations performed pursuant to § 19.2-169.5 and shall be governed by subsections B and C of § 19.2-169.5.

3529 C. The expert appointed pursuant to subsection A shall submit to the attorney for the defendant a 3530 report concerning the history and character of the defendant and the defendant's mental condition at the 3531 time of the offense. The report shall include the expert's opinion as to (i) whether the defendant acted under extreme mental or emotional disturbance at the time of the offense, (ii) whether the capacity of 3532 3533 the defendant to appreciate the criminality of his conduct or to conform his conduct to the requirements 3534 of the law was significantly impaired, and (iii) whether there are any other factors in mitigation relating 3535 to the history or character of the defendant or the defendant's mental condition at the time of the 3536 offense.

3537 D. The report described in subsection C shall be sent solely to the attorney for the defendant and
3538 shall be protected by the attorney-client privilege. However, the Commonwealth shall be given the report
and the results of any other evaluation of the defendant's mental condition conducted relative to the
sentencing proceeding and copies of psychiatric, psychological, medical or other records obtained during
the course of such evaluation, after the attorney for the defendant gives notice of an intent to present
sychiatric or psychological evidence in mitigation pursuant to subsection E.

3543 E. In any case in which a defendant charged with capital murder intends, in the event of conviction, 3544 to present testimony of an expert witness to support a claim in mitigation relating to the defendant's history, character or mental condition, he or his attorney shall give notice in writing to the attorney for 3545 3546 the Commonwealth, at least 21 days before trial, of his intention to present such testimony. In the event 3547 that such notice is not given and the defendant tenders testimony by an expert witness at the sentencing 3548 phase of the trial, then the court may, in its discretion, upon objection of the Commonwealth, either 3549 allow the Commonwealth a continuance or, under appropriate circumstances, bar the defendant from 3550 presenting such evidence.

3551 F. 1. If the attorney for the defendant gives notice pursuant to subsection E and the Commonwealth 3552 thereafter seeks an evaluation concerning the existence or absence of mitigating circumstances relating to 3553 the defendant's mental condition at the time of the offense, the court shall appoint one or more qualified 3554 experts to perform such an evaluation. **3568** § 19.2-264.3:1.1. Capital cases; determination of mental retardation.

A. As used in this section and § 19.2-264.3:1.2, the following definition applies:

3570 "Mentally retarded" means a disability, originating before the age of 18 years, characterized
3571 concurrently by (i) significantly subaverage intellectual functioning as demonstrated by performance on a standardized measure of intellectual functioning administered in conformity with accepted professional practice, that is at least two standard deviations below the mean and (ii) significant limitations in adaptive behavior as expressed in conceptual, social and practical adaptive skills.

**3575** B. Assessments of mental retardation under this section and § 19.2-264.3:1.2 shall conform to the following requirements:

3577 1. Assessment of intellectual functioning shall include administration of at least one standardized 3578 measure generally accepted by the field of psychological testing and appropriate for administration to the 3579 particular defendant being assessed, taking into account cultural, linguistic, sensory, motor, behavioral 3580 and other individual factors. Testing of intellectual functioning shall be carried out in conformity with 3581 accepted professional practice, and whenever indicated, the assessment shall include information from 3582 multiple sources. The Commissioner of Mental Health, Mental RetardationIntellectual Disability and 3583 Substance Abuse Services shall maintain an exclusive list of standardized measures of intellectual 3584 functioning generally accepted by the field of psychological testing.

3585 2. Assessment of adaptive behavior shall be based on multiple sources of information, including 3586 clinical interview, psychological testing and educational, correctional and vocational records. The 3587 assessment shall include at least one standardized measure generally accepted by the field of 3588 psychological testing for assessing adaptive behavior and appropriate for administration to the particular 3589 defendant being assessed, unless not feasible. In reaching a clinical judgment regarding whether the 3590 defendant exhibits significant limitations in adaptive behavior, the examiner shall give performance on 3591 standardized measures whatever weight is clinically appropriate in light of the defendant's history and 3592 characteristics and the context of the assessment.

3593 3. Assessment of developmental origin shall be based on multiple sources of information generally accepted by the field of psychological testing and appropriate for the particular defendant being assessed, including, whenever available, educational, social service, medical records, prior disability assessments, parental or caregiver reports, and other collateral data, recognizing that valid clinical assessment conducted during the defendant's childhood may not have conformed to current practice standards.

3598 C. In any case in which the offense may be punishable by death and is tried before a jury, the issue of mental retardation, if raised by the defendant in accordance with the notice provisions of subsection E of § 19.2-264.3:1.2, shall be determined by the jury as part of the sentencing proceeding required by § 19.2-264.4.

In any case in which the offense may be punishable by death and is tried before a judge, the issue of mental retardation, if raised by the defendant in accordance with the notice provisions of subsection E of \$ 19.2-264.3:1.2, shall be determined by the judge as part of the sentencing proceeding required by \$ 19.2-264.4.

**3606** The defendant shall bear the burden of proving that he is mentally retarded by a preponderance of the evidence.

3608 D. The verdict of the jury, if the issue of mental retardation is raised, shall be in writing, and, in addition to the forms specified in § 19.2-264.4, shall include one of the following forms:

Upon (i) motion of the attorney for a defendant charged with or convicted of capital murder and (ii) a finding by the court that the defendant is financially unable to pay for expert assistance, the court shall appoint one or more qualified mental health experts to assess whether or not the defendant is mentally retarded and to assist the defense in the preparation and presentation of information concerning the defendant's mental retardation. The mental health expert appointed pursuant to this section shall be

3627 (a) a psychiatrist, a clinical psychologist or an individual with a doctorate degree in clinical psychology,

3628 (b) skilled in the administration, scoring and interpretation of intelligence tests and measures of adaptive 3629 behavior and (c) qualified by experience and by specialized training, approved by the Commissioner of

E. Such other individuals and agencies that require criminal history record information to implement 3713 a state or federal statute or executive order of the President of the United States or Governor that 3714 expressly refers to criminal conduct and contains requirements or exclusions expressly based upon such 3715 conduct, except that information concerning the arrest of an individual may not be disseminated to a noncriminal justice agency or individual if an interval of one year has elapsed from the date of the 3716 3717 arrest and no disposition of the charge has been recorded and no active prosecution of the charge is 3718 pending;

3719 3. Individuals and agencies pursuant to a specific agreement with a criminal justice agency to provide 3720 services required for the administration of criminal justice pursuant to that agreement which shall 3721 specifically authorize access to data, limit the use of data to purposes for which given, and ensure the 3722 security and confidentiality of the data;

3723 4. Individuals and agencies for the express purpose of research, evaluative, or statistical activities 3724 pursuant to an agreement with a criminal justice agency that shall specifically authorize access to data, 3725 limit the use of data to research, evaluative, or statistical purposes, and ensure the confidentiality and 3726 security of the data;

Agencies of state or federal government that are authorized by state or federal statute or executive 3728 order of the President of the United States or Governor to conduct investigations determining 3729 employment suitability or eligibility for security clearances allowing access to classified information; 3730

6. Individuals and agencies where authorized by court order or court rule;

Agencies of any political subdivision of the Commonwealth for the conduct of investigations of 3732 applicants for public employment, permit, or license whenever, in the interest of public welfare or 3733 safety, it is necessary to determine under a duly enacted ordinance if the past criminal conduct of a 3734 person with a conviction record would be compatible with the nature of the employment, permit, or 3735 license under consideration;

Public or private agencies when authorized or required by federal or state law or interstate 3737 compact to investigate (i) applicants for foster or adoptive parenthood or (ii) any individual, and the 3738 adult members of that individual's household, with whom the agency is considering placing a child or 3739 from whom the agency is considering removing a child due to abuse or neglect, on an emergency, temporary, or permanent basis pursuant to §§ 63.2-901.1 and 63.2-1505, subject to the restriction that 3740 3741 the data shall not be further disseminated to any party other than a federal or state authority or court as 3742 may be required to comply with an express requirement of law;

3743 9. To the extent permitted by federal law or regulation, public service companies as defined in 3744 § 56-1, for the conduct of investigations of applicants for employment when such employment involves 3745 personal contact with the public or when past criminal conduct of an applicant would be incompatible 3746 with the nature of the employment under consideration;

3747 10. The appropriate authority for purposes of granting citizenship and for purposes of international 3748 travel, including but not limited to, issuing visas and passports;

A person requesting a copy of his own criminal history record information as defined in § 9.1-101 at his cost, except that criminal history record information shall be supplied at no charge to a person who has applied to be a volunteer with (i) a Virginia affiliate of Big Brothers/Big Sisters of America; (ii) a volunteer fire company or volunteer rescue squad; (iii) the Volunteer Emergency
Families for Children; (iv) any affiliate of Prevent Child Abuse, Virginia; (v) any Virginia affiliate of Compeer; or (vi) any board member or any individual who has been offered membership on the board of a Crime Stoppers, Crime Solvers or Crime Line program as defined in § 15.2-1713.1;

3756 12. Administrators and board presidents of and applicants for licensure or registration as a child welfare agency as defined in § 63.2-100 for dissemination to the Commissioner of Social Services' 3757 3758 representative pursuant to § 63.2-1702 for the conduct of investigations with respect to employees of and 3759 volunteers at such facilities, caretakers, and other adults living in family day-care homes or homes 3760 approved by family day-care systems, and foster and adoptive parent applicants of private child-placing agencies, pursuant to §§ 63.2-1719 through 63.2-1721, subject to the restriction that the data shall not be 3761 3762 further disseminated by the facility or agency to any party other than the data subject, the Commissioner of Social Services' representative or a federal or state authority or court as may be required to comply 3763 3764 with an express requirement of law for such further dissemination;

3822 and 21 (§ 46.2-2100 et seq.) of Title 46.2;

3823 30. The chairmen of the Committees for Courts of Justice of the Senate or the House of Delegates
3824 for the purpose of determining if any person being considered for election to any judgeship has been convicted of a crime;

Heads of state agencies in which positions have been identified as sensitive for the purpose of determining an individual's fitness for employment in positions designated as sensitive under Department of Human Resource Management policies developed pursuant to § 2.2-1201.1. Dissemination of criminal history record information to the agencies shall be limited to those positions generally described as directly responsible for the health, safety and welfare of the general populace or protection of critical infrastructures;

subdivision A 1 and for purposes of performing duties required by the Civil Commitment of Sexually
Violent Predators Act (§ 37.2-900 et seq.);

Shipyards, to the extent permitted by federal law or regulation, engaged in the design, construction, overhaul, or repair of nuclear vessels for the United States Navy, including their subsidiary companies, for the conduct of investigations of applications for employment or for access to facilities, by contractors, leased laborers, and other visitors;

3853 Upon an ex parte motion of a defendant in a felony case and upon the showing that the records
3854 requested may be relevant to such case, the court shall enter an order requiring the Central Criminal
3855 Records Exchange to furnish the defendant, as soon as practicable, copies of any records of persons
3856 designated in the order on whom a report has been made under the provisions of this chapter.

3857 Notwithstanding any other provision of this chapter to the contrary, upon a written request sworn to 3858 before an officer authorized to take acknowledgments, the Central Criminal Records Exchange, or the 3859 criminal justice agency in cases of offenses not required to be reported to the Exchange, shall furnish a 3860 copy of conviction data covering the person named in the request to the person making the request; 3861 however, such person on whom the data is being obtained shall consent in writing, under oath, to the 3862 making of such request. Dissemination of information regarding offenses not required to be reported to the Exchange shall be 3877 3878 made by the criminal justice agency maintaining the record as required by § 15.2-1722.

3879 E. Criminal history information provided to licensed nursing homes, hospitals and to home care 3880 organizations pursuant to subdivision 15 of subsection A shall be limited to the convictions on file with 3881 the Exchange for any offense specified in §§ 32.1-126.01, 32.1-126.02 and 32.1-162.9:1.

Criminal history information provided to licensed assisted living facilities, licensed district homes for adults, and licensed adult day-care centers pursuant to subdivision 16 of subsection A shall be 3883 3884 limited to the convictions on file with the Exchange for any offense specified in § 63.1-189.1 or 3885 63.2-1720.

3886 G. Criminal history information provided to public agencies pursuant to subdivision 35 of subsection A shall be limited to the convictions on file with the Exchange for any offense specified in § 63.2-1719. 3887

3888 H. Upon receipt of a written request from an employer or prospective employer, the Central Criminal 3889 Records Exchange, or the criminal justice agency in cases of offenses not required to be reported to the 3890 Exchange, shall furnish at the employer's cost a copy of conviction data covering the person named in 3891 the request to the employer or prospective employer making the request; provided that the person on 3892 whom the data is being obtained has consented in writing to the making of such request and has 3893 presented a photo-identification to the employer or prospective employer. In the event no conviction data 3894 is maintained on the person named in the request, the requesting employer or prospective employer shall 3895 be furnished at his cost a certification to that effect. The criminal history record search shall be 3896 conducted on forms provided by the Exchange.

3897 § 19.2-390. Reports to be made by local law-enforcement officers, conservators of the peace, clerks 3898 of court, Secretary of the Commonwealth and Corrections officials to State Police; material submitted by 3899 other agencies.

3900 A. 1. Every state official or agency having the power to arrest, the sheriffs of counties, the police 3901 officials of cities and towns, and any other local law-enforcement officer or conservator of the peace 3902 having the power to arrest for a felony shall make a report to the Central Criminal Records Exchange, 3903 on forms provided by it, of any arrest, including those arrests involving the taking into custody of, or 3904 service of process upon, any person on charges resulting from an indictment, presentment or 3905 information, the arrest on capias or warrant for failure to appear, and the service of a warrant for 3906 another jurisdiction, on any of the following charges: 3907

a. Treason;

3908 b. Any felony; 3909

c. Any offense punishable as a misdemeanor under Title 54.1; or

3910 d. Any misdemeanor punishable by confinement in jail (i) under Title 18.2 or 19.2, except an arrest 3911 for a violation of § 18.2-119, Article 2 (§ 18.2-415 et seq.) of Chapter 9 of Title 18.2, or any similar 3912 ordinance of any county, city or town, or (ii) under § 20-61.

3913 The reports shall contain such information as is required by the Exchange and shall be accompanied 3914 by fingerprints of the individual arrested. Effective January 1, 2006, the corresponding photograph of the 3915 individual arrested shall accompany the report. Fingerprint cards prepared by a law-enforcement agency 3916 for inclusion in a national criminal justice file shall be forwarded to the Exchange for transmittal to the 3917 appropriate bureau. Nothing in this section shall preclude each local law-enforcement agency from 3918 maintaining its own separate photographic database.

3919 2. For persons arrested and released on summonses in accordance with § 19.2-74, such report shall 3920 not be required until (i) a conviction is entered and no appeal is noted or if an appeal is noted, the 3921 conviction is upheld upon appeal or the person convicted withdraws his appeal; (ii) the court dismisses 3922 the proceeding pursuant to § 18.2-251; or (iii) an acquittal by reason of insanity pursuant to § 19.2-182.2 3923 is entered. Upon such conviction or acquittal, the court shall remand the individual to the custody of the 3924 office of the chief law-enforcement officer of the county or city. It shall be the duty of the chief law-enforcement officer, or his designee who may be the arresting officer, to ensure that such report is 3925 3926 completed after a determination of guilt or acquittal by reason of insanity. The court shall require the 3927 officer to complete the report immediately following the person's conviction or acquittal, and the 3928 individual shall be discharged from custody forthwith, unless the court has imposed a jail sentence to be 3929 served by him or ordered him committed to the custody of the Commissioner of the Department of 3930 Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services.

B. Within 72 hours following the receipt of (i) a warrant or capias for the arrest of any person on a 3931 charge of a felony or (ii) a Governor's warrant of arrest of a person issued pursuant to § 19.2-92, the 3932 3933 law-enforcement agency which received the warrant shall enter the person's name and other appropriate information required by the Department of State Police into the "information systems" known as the 3934

3935 Virginia Criminal Information Network (VCIN), established and maintained by the Department pursuant 3936 to Chapter 2 (§ 52-12 et seq.) of Title 52 and the National Crime Information Center (NCIC), 3937 maintained by the Federal Bureau of Investigation. The report shall include the person's name, date of 3938 birth, social security number and such other known information which the State Police or Federal 3939 Bureau of Investigation may require. Where feasible and practical, the magistrate or court issuing the 3940 warrant or capias may transfer information electronically into VCIN. When the information is 3941 electronically transferred to VCIN, the court or magistrate shall forthwith forward the warrant or capias 3942 to the local police department or sheriff's office. When criminal process has been ordered destroyed 3943 pursuant to § 19.2-76.1, the law-enforcement agency destroying such process shall ensure the removal of 3944 any information relating to the destroyed criminal process from the VCIN and NCIC systems.

3945 C. The clerk of each circuit court and district court shall make a report to the Central Criminal 3946 Records Exchange of (i) any dismissal, indefinite postponement or continuance, charge still pending due 3947 to mental incompetency or incapacity, nolle prosequi, acquittal, or conviction of, including any sentence 3948 imposed, or failure of a grand jury to return a true bill as to, any person charged with an offense listed 3949 in subsection A, including any action which may have resulted from an indictment, presentment or 3950 information, and (ii) any adjudication of delinquency based upon an act which, if committed by an 3951 adult, would require fingerprints to be filed pursuant to subsection A. In the case of offenses not 3952 required to be reported to the Exchange by subsection A, the reports of any of the foregoing dispositions 3953 shall be filed by the law-enforcement agency making the arrest with the arrest record required to be 3954 maintained by § 15.2-1722. Upon conviction of any person, including juveniles tried and convicted in 3955 the circuit courts pursuant to § 16.1-269.1, whether sentenced as adults or juveniles, for an offense for 3956 which registration is required as defined in § 9.1-902, the clerk shall within seven days of sentencing 3957 submit a report to the Sex Offender and Crimes Against Minors Registry. The report to the Registry 3958 shall include the name of the person convicted and all aliases which he is known to have used, the date 3959 and locality of the conviction for which registration is required, his date of birth, social security number, 3960 last known address, and specific reference to the offense for which he was convicted. No report of 3961 conviction or adjudication in a district court shall be filed unless the period allowed for an appeal has 3962 elapsed and no appeal has been perfected. In the event that the records in the office of any clerk show 3963 that any conviction or adjudication has been nullified in any manner, he shall also make a report of that 3964 fact to the Exchange and, if appropriate, to the Registry. In addition, each clerk of a circuit court, upon 3965 receipt of certification thereof from the Supreme Court, shall report to the Exchange or the Registry, or 3966 to the law-enforcement agency making the arrest in the case of offenses not required to be reported to 3967 the Exchange, on forms provided by the Exchange or Registry, as the case may be, any reversal or other 3968 amendment to a prior sentence or disposition previously reported. When criminal process is ordered 3969 destroyed pursuant to § 19.2-76.1, the clerk shall report such action to the law-enforcement agency that 3970 entered the warrant or capias into the VCIN system.

3971 D. In addition to those offenses enumerated in subsection A of this section, the Central Criminal
3972 Records Exchange may receive, classify and file any other fingerprints, photographs, and records of
3973 arrest or confinement submitted to it by any law-enforcement agency or any correctional institution.

E. Corrections officials, sheriffs, and jail superintendents of regional jails, responsible for maintaining correctional status information, as required by the regulations of the Department of Criminal Justice Services, with respect to individuals about whom reports have been made under the provisions of this chapter shall make reports of changes in correctional status information to the Central Criminal Records Exchange. The reports to the Exchange shall include any commitment to or release or escape from a state or local correctional facility, including commitment to or release from a parole or probation agency.

3981 F. Any pardon, reprieve or executive commutation of sentence by the Governor shall be reported to3982 the Exchange by the office of the Secretary of the Commonwealth.

3983 G. Officials responsible for reporting disposition of charges, and correctional changes of status of
3984 individuals under this section, including those reports made to the Registry, shall adopt procedures
3985 reasonably designed at a minimum (i) to ensure that such reports are accurately made as soon as feasible
by the most expeditious means and in no instance later than 30 days after occurrence of the disposition
3987 or correctional change of status; and (ii) to report promptly any correction, deletion, or revision of the
3988 information.

3989 H. Upon receiving a correction, deletion, or revision of information, the Central Criminal Records3990 Exchange shall notify all criminal justice agencies known to have previously received the information.

As used in this section, the term "chief law-enforcement officer" means the chief of police of cities
and towns and sheriffs of counties, unless a political subdivision has otherwise designated its chief
law-enforcement officer by appropriate resolution or ordinance, in which case the local designation shall
be controlling.

4000 If there be more than one person bound to support the same parent or parents, the persons so bound 4001 to support shall jointly and severally share equitably in the discharge of such duty. Taking into 4002 consideration the needs of the parent or parents and the circumstances affecting the ability of each person to discharge the duty of support, the court having jurisdiction shall have the power to determine 4003 4004 and order the payment, by such person or persons so bound to support, of that amount for support and 4005 maintenance which to the court may seem just. Prosecutions under 4017 this section shall be in the jurisdiction where the parent or parents reside.

4018 This section shall not apply if there is substantial evidence of desertion, neglect, abuse or willful

**4037** § 22.1-7. Responsibility of each state board, agency and institution having children in residence or in custody.

4039 Each state board, state agency and state institution having children in residence or in custody shall 4040 have responsibility for providing for the education and training to such children which is at least 4041 comparable to that which would be provided to such children in the public school system. Such board, 4042 agency or institution may provide such education and training either directly with its own facilities and 4043 personnel in cooperation with the Board of Education or under contract with a school division or any 4044 other public or private nonreligious school, agency or institution. The Board of Education shall supervise the education and training provided to school-age residents in state mental retardation facilities for 4045 4046 persons with intellectual disability and provide for and direct the education for school-age residents in 4047 state mental health facilities in cooperation with the Department of Mental Health, Mental 4048 RetardationIntellectual Disability and Substance Abuse Services. The Board shall prescribe standards and 4049 regulations for all such education and training provided directly by a state board, state agency or state 4050 institution. Each state board, state agency or state institution providing such education and training shall 4051 submit annually its program therefor to the Board of Education for approval in accordance with 4052 regulations of the Board. If any child in the custody of any state board, state agency or state institution 4053 is a child with disabilities as defined in § 22.1-213 and such board, agency or institution must contract 4054 with a private nonreligious school to provide special education as defined in § 22.1-213 for such child, 4055 the state board, state agency or state institution may proceed as a guardian pursuant to the provisions of 4056 subsection A of § 22.1-218.

**4057** § 22.1-205. Driver education programs.

4058 A. The Board of Education shall establish for the public school system a standardized program of 4059 driver education in the safe operation of motor vehicles. Such program shall consist of classroom 4060 training and behind-the-wheel driver training. However, any student who participates in such a program 4061 of driver education shall meet the academic requirements established by the Board, and no student in a 4062 course shall be permitted to operate a motor vehicle without a license or permit to do so issued by the 4063 Department of Motor Vehicles. The program shall include instruction concerning (i) alcohol and drug 4064 abuse, (ii) aggressive driving, (iii) distracted driving, (iv) motorcycle awareness, and (v) organ and tissue 4065 donor awareness. Such instruction shall be developed by the Department in cooperation with the 4066 Virginia Alcohol Safety Action Program, the Department of Health, and the Department of Mental 4067 Health, Mental RetardationIntellectual Disability and Substance Abuse Services, as appropriate. Such 4068 program shall require a minimum number of miles driven during the behind-the-wheel driver training.

4069 B. The Board shall assist school divisions by preparation, publication and distribution of competent
4070 driver education instructional materials to ensure a more complete understanding of the responsibilities
4071 and duties of motor vehicle operators.

4072 C. Each school board shall determine whether to offer the program of driver education in the safe 4073 operation of motor vehicles and, if offered, whether such program shall be an elective or a required 4074 course. In addition to the fee approved by the Board of Education pursuant to the appropriation act that 4075 allows local school boards to charge a per pupil fee for behind-the-wheel driver education, the Board of 4076 Education may authorize a local school board's request to assess a surcharge in order to further recover 4077 program costs that exceed state funds distributed through basic aid to school divisions offering driver 4078 education programs. Each school board may waive the fee or the surcharge in total or in part for those 4079 students it determines cannot pay the fee or surcharge. Only school divisions complying with the 4080 standardized program and regulations established by the Board of Education and the provisions of 4081 § 46.2-335 shall be entitled to participate in the distribution of state funds appropriated for driver 4082 education.

4083 D. The actual initial driving instruction shall be conducted, with motor vehicles equipped as may be 4084 required by regulation of the Board of Education, on private or public property removed from public 4085 highways if practicable; if impracticable, then, at the request of the school board, the Commonwealth 4086 Transportation Board shall designate a suitable section of road near the school to be used for such 4087 instruction. Such section of road shall be marked with signs, which the Commonwealth Transportation 4088 Board shall supply, giving notice of its use for driving instruction. Such signs shall be removed at the 4089 close of the instruction period. No vehicle other than those used for driver training shall be operated 4090 between such signs at a speed in excess of 25 miles per hour. Violation of this limit shall be a Class 4 4091 misdemeanor.

4092 E. The Board of Education may, in its discretion, promulgate regulations for the use and certification4093 of paraprofessionals as teaching assistants in the driver education programs of school divisions.

4094 F. The Board of Education shall approve correspondence courses for the classroom training component of driver education. These correspondence courses shall be consistent in quality with 4095 4096 instructional programs developed by the Board for classroom training in the public schools. Students 4097 completing the correspondence courses for classroom training, who are eligible to take behind-the-wheel 4098 driver training, may receive behind-the-wheel driver training (i) from a public school, upon payment of 4099 the required fee, if the school division offers behind-the-wheel driver training and space is available, (ii) 4100 from a driver training school licensed by the Department of Motor Vehicles, or (iii) in the case of a 4101 home schooling parent or guardian instructing his own child who meets the requirements for home 4102 school instruction under § 22.1-254.1 or subdivision B 1 of § 22.1-254, from a behind-the-wheel training 4103 course approved by the Board. Nothing herein shall be construed to require any school division to 4104 provide behind-the-wheel driver training to nonpublic school students.

**4105** § 22.1-209.2. Programs and teachers in regional detention homes, certain local detention homes and **4106** state agencies and institutions.

4107 The Board of Education shall prepare and supervise the implementation in the regional detention 4108 homes and those local detention homes having teachers whose salaries were being funded by the 4109 Commonwealth on January 1, 1984, a program designed to educate and train the children detained in the 4110 homes. In addition, the Board shall supervise those programs of evaluation, education and training provided to school-age children by the Department of Health, the Department of Mental Health, Mental 4111 4112 RetardationIntellectual Disability and Substance Abuse Services, the children's teaching hospital 4113 associated with the Eastern Virginia Medical School, the Virginia Commonwealth University Health 4114 System Authority, and the University of Virginia Hospitals pursuant to the Board's standards and 4115 regulations as required by § 22.1-7.

4116 The Board shall promulgate such rules and regulations as may be necessary to conform these4117 programs with the applicable federal and state laws and regulations including, but not limited to,4118 teacher/student ratios and special education requirements for children with disabilities. 4119 programs in the relevant detention homes and state agencies and institutions shall be approved by the 4120 Board and the Board shall prepare a budget for these educational programs which shall be solely 4121 supported by such general funds as are appropriated by the General Assembly for this purpose. Teacher 4122 staffing ratios for regional or local detention homes shall be based on a ratio of one teacher for every 4123 twelve beds based on the capacity of the facility; however, if the previous year's average daily 4124 attendance exceeds this bed capacity, the ratio shall be based on the average daily attendance at the 4125 facility as calculated by the Department of Education from the previous school year.

4126 The Board of Education shall enter into contracts with the relevant state agency or institution or
4127 detention facility or the local school divisions in which the state agencies or institutions or the regional

4130 In any case in which the Board enters into a contract with the relevant state agency or institution, the

§ 22.1-213. Definitions.

As used in this article:

"Children with disabilities" means those persons (i) who are aged two to twenty-one, inclusive,
having reached the age of two by the date specified in § 22.1-254, (ii) who are mentally retarded have *intellectual disability*, physically disabled, seriously emotionally disturbed, speech impaired, hearing
specific learning disability or who are otherwise disabled as defined by the Board of Education and (iii)
who because of such impairments need special education.

4141 "Intellectual Disability" means a disability, originating before the age of 18 years, characterized
4142 concurrently by (i) significantly subaverage intellectual functioning as demonstrated by performance on
4143 a standardized measure of intellectual functioning, administered in conformity with accepted professional
4144 practice, that is at least two standard deviations below the mean and (ii) significant limitations in
4145 adaptive behavior as expressed in conceptual, social, and practical adaptive skills.

<sup>4146</sup> "Related services" means transportation and such developmental, corrective, and other supportive
<sup>4147</sup> services as are required to assist a disabled child to benefit from special education, including speech
<sup>4148</sup> pathology and audiology, psychological services, physical and occupational therapy, recreation, early
<sup>4149</sup> identification and assessment of disabilities in children, counseling services and medical services for
<sup>4150</sup> diagnostic or evaluation purposes. The term also includes school health services, social work services in
<sup>4151</sup> schools, and parent counseling and training.

4152 "Special education" means specially designed instruction at no cost to the parent, to meet the unique
4153 needs of a disabled child, including classroom instruction, home instruction, instruction provided in
4154 hospitals and institutions, instruction in physical education and instruction in career and technical
4155 education.

"Specific learning disability" means a disorder in one or more of the basic psychological processes
involved in understanding or using language, spoken or written, which may manifest itself in an
imperfect ability to listen, think, speak, read, write, spell or do mathematical calculations. The term does
not include children who have learning problems that are primarily the result of visual, hearing or motor
handicaps, of mental retardationintellectual disability, or of environmental, cultural or economic
disadvantage.

4162 § 22.1-214.2. Definition of "supervise" as related to educational programs provided for or by
4163 Department of Mental Health, Intellectual Disability and Substance Abuse Services.

For the purposes of subsection F of § 22.1-214 as related to the educational programs provided for or 4164 by the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 4165 Services, "supervise" shall mean providing active support in (i) designing mechanisms for maintaining 4166 4167 constant direct contact and the sharing of ideas, approaches and innovations between the Department of 4168 Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services and the facility 4169 staff responsible for providing educational services; (ii) providing consistent oversight, with particular 4170 attention to the mental health programs, to ensure that the availability of educational resources and the 4171 distribution of funds clearly reflect the needs of the different student populations residing in the various 4172 facilities; (iii) developing guidelines, in cooperation with the Department of Mental Health, Mental 4173 RetardationIntellectual Disability and Substance Abuse Services for the evaluation of the performance of 4174 the education directors or other education supervisors employed by the Department of Mental Health, 4175 Mental RetardationIntellectual Disability and Substance Abuse Services; (iv) developing and implementing, in cooperation with the Department of Mental Health, Mental RetardationIntellectual 4176 4177 Disability and Substance Abuse Services, programs to ensure that the educational and treatment needs of 4178 dually diagnosed children in state institutions are met; (v) ensuring that the expertise of the Department 4179 of Education is utilized by providing technical assistance to the education programs provided for or by the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 4180

**4181** Services in the areas of selection and acquisition of educational materials, curriculum development **4182** including career and technical education, when appropriate, and applications for federal grants.

**4183** § 22.1-214.3. Department to develop certain curriculum guidelines; Board to approve.

4184 The Department of Education shall develop curricula for the school-age residents of the state training 4185 centers for the mentally retarded persons with intellectual disability and curriculum guidelines for the school-age residents of the state mental health facilities in cooperation with the Department of Mental 4187 Health, Mental RetardationIntellectual Disability and Substance Abuse Services and representatives of 4188 the teachers employed to provide instruction to the children. Prior to implementation, the Board of 4189 Education shall approve these curricula and curriculum guidelines.

4190 These curricula and curriculum guidelines shall be designed to provide a range of programs and 4191 suggested program sequences for different functioning levels and handicaps and shall be reviewed and 4192 revised at least every three years. In addition to academic programming, the curriculum guidelines for 4193 the school-age residents of the state mental health facilities shall include affective education and physical 4194 education as well as independent living and career and technical education, with particular emphasis on 4195 the needs of older adolescents and young adults.

4196 § 22.1-215. School divisions to provide special education; plan to be submitted to Board.

4197 Each school division shall provide free and appropriate education, including special education, for the4198 children with disabilities residing within its jurisdiction in accordance with regulations of the Board of4199 Education.

4200 For the purposes of this section, "children with disabilities, residing within its jurisdiction" shall 4201 include: (i) those individuals of school age identified as appropriate to be placed in public school 4202 programs, who are residing in a state institution operated by the Department of Mental Health, Mental 4203 RetardationIntellectual Disability and Substance Abuse Services located within the school division, or 4204 (ii) those individuals of school age who are Virginia residents and are placed and living in a foster care 4205 home or child-caring institution or group home located within the school division and licensed under the 4206 provisions of Chapter 17 (§ 63.2-1700 et seq.) of Title 63.2 as a result of being in the custody of a local 4207 department of social services or welfare or being privately placed, not solely for school purposes.

4208 The Board of Education shall promulgate regulations to identify those children placed within
4209 facilities operated by the Department of Mental Health, Mental RetardationIntellectual Disability and
4210 Substance Abuse Services who are eligible to be appropriately placed in public school programs.

4211 The cost of the education provided to children residing in the state institutions, who are appropriate 4212 to place within the public schools, shall remain the responsibility of the Department of Mental Health, 4213 Mental RetardationIntellectual Disability and Substance Abuse Services. The cost of the education 4214 provided to children who are not residents of the Commonwealth and are placed and living in a foster 4215 care home or child-caring institution or group home located within the school division and licensed 4216 under the provisions of Chapter 17 (§ 63.2-1700 et seq.) of Title 63.2 shall be billed to the sending 4217 agency or person by the school division as provided in subsection C of § 22.1-5. No school division 4218 shall refuse to educate any such child or charge tuition to any such child.

4219 Each school division shall submit to the Board of Education in accordance with the schedule and by
4220 the date specified by the Board, a plan acceptable to the Board for such education for the period
4221 following and a report indicating the extent to which the plan required by law for the preceding period
4222 has been implemented. However, the schedule specified by the Board shall not require plans to be
4223 submitted more often than annually unless changes to the plan are required by federal or state law or
4224 regulation.

**4225** § 22.1-217.1. Programs for the research and development of innovative methods of teaching **4226** intellectually disabled, mentally ill or emotionally disturbed children.

4227 For the purpose of improving the quality of the education and training provided to the school-age 4228 residents of the state mental health and mental retardation facilities and facilities for persons with 4229 intellectual disability, there is hereby established a program of grants, from such funds as are 4230 appropriated by the General Assembly, to promote the research and development of innovative methods 4231 of teaching mentally retarded, mentally ill children with intellectual disability or mental illness or 4232 emotionally disturbed children in residential settings. This program shall be available to the education 4233 directors and instructional staffs of the institutions administered by the Department of Mental Health, 4234 Mental RetardationIntellectual Disability and Substance Abuse Services. The Board of Education shall 4235 award these grants on the basis of the recommendations of an advisory committee composed of the 4236 Director of the Virginia Treatment Center for Children, two representatives of the Department of 4237 Education and two representatives of the Department of Mental Health, Mental RetardationIntellectual 4238 Disability and Substance Abuse Services. The advisory committee shall establish objectives for these 4239 grants, develop requests for proposals and set criteria for evaluating the applications for funds.

4240 § 22.1-253.13:2. Standard 2. Instructional, administrative, and support personnel.

4241 A. The Board shall establish requirements for the licensing of teachers, principals, superintendents,

4242 and other professional personnel.

4243 B. School boards shall employ licensed instructional personnel qualified in the relevant subject areas. 4244 C. Each school board shall assign licensed instructional personnel in a manner that produces 4245 divisionwide ratios of students in average daily membership to full-time equivalent teaching positions, 4246 excluding special education teachers, principals, assistant principals, counselors, and librarians, that are 4247 not greater than the following ratios: (i) 24 to one in kindergarten with no class being larger than 29 4248 students; if the average daily membership in any kindergarten class exceeds 24 pupils, a full-time 4249 teacher's aide shall be assigned to the class; (ii) 24 to one in grades one, two, and three with no class 4250 being larger than 30 students; (iii) 25 to one in grades four through six with no class being larger than 4251 35 students; and (iv) 24 to one in English classes in grades six through 12.

4252 Within its regulations governing special education programs, the Board shall seek to set pupil/teacher 4253 ratios for pupils with mental retardationintellectual disability that do not exceed the pupil/teacher ratios 4254 for self-contained classes for pupils with specific learning disabilities.

Further, school boards shall assign instructional personnel in a manner that produces schoolwide
ratios of students in average daily memberships to full-time equivalent teaching positions of 21 to one in
middle schools and high schools. School divisions shall provide all middle and high school teachers with
one planning period per day or the equivalent, unencumbered of any teaching or supervisory duties.

4259 D. Each local school board shall employ with state and local basic, special education, gifted, and 4260 career and technical education funds a minimum number of licensed, full-time equivalent instructional 4261 personnel for each 1,000 students in average daily membership (ADM) as set forth in the appropriation 4262 act. Calculations of kindergarten positions shall be based on full-day kindergarten programs. Beginning 4263 with the March 31 report of average daily membership, those school divisions offering half-day 4264 kindergarten with pupil/teacher ratios that exceed 30 to one shall adjust their average daily membership for kindergarten to reflect 85 percent of the total kindergarten average daily memberships, as provided in 4265 4266 the appropriation act.

E. In addition to the positions supported by basic aid and in support of regular school year programs of prevention, intervention, and remediation, state funding, pursuant to the appropriation act, shall be provided to fund certain full-time equivalent instructional positions for each 1,000 students in grades K through 12 who are identified as needing prevention, intervention, and remediation services. State funding for prevention, intervention, and remediation programs provided pursuant to this subsection and the appropriation act may be used to support programs for educationally at-risk students as identified by the local school boards.

F. In addition to the positions supported by basic aid and those in support of regular school year
programs of prevention, intervention, and remediation, state funding, pursuant to the appropriation act,
shall be provided to support 17 full-time equivalent instructional positions for each 1,000 students
identified as having limited English proficiency.

4278 G. In addition to the full-time equivalent positions required elsewhere in this section, each local
4279 school board shall employ the following reading specialists in elementary schools, one full-time in each
4280 elementary school at the discretion of the local school board.

4296 period per 80 students or major fraction thereof; guidance counselors in high schools, one period per 70

5. Clerical personnel in elementary schools, part-time to 299 students, one full-time at 300 students;
clerical personnel in middle schools, one full-time and one additional full-time for each 600 students beyond 200 students and one full-time for the library at 750 students; clerical personnel in high schools, one full-time and one additional full-time for each 600 students beyond 200 students and one full-time for each 600 students.

4304 I. Local school boards shall employ five full-time equivalent positions per 1,000 students in grades4305 kindergarten through five to serve as elementary resource teachers in art, music, and physical education.

4306 J. Local school boards shall employ two full-time equivalent positions per 1,000 students in grades
4307 kindergarten through 12, one to provide technology support and one to serve as an instructional
4308 technology resource teacher.

4309 K. Local school boards may employ additional positions that exceed these minimal staffing
4310 requirements. These additional positions may include, but are not limited to, those funded through the
4311 state's incentive and categorical programs as set forth in the appropriation act.

L. A combined school, such as kindergarten through 12, shall meet at all grade levels the staffing requirements for the highest grade level in that school; this requirement shall apply to all staff, except for guidance counselors, and shall be based on the school's total enrollment; guidance counselor staff requirements shall, however, be based on the enrollment at the various school organization levels, i.e., elementary, middle, or high school. The Board of Education may grant waivers from these staffing levels upon request from local school boards seeking to implement experimental or innovative programs that are not consistent with these staffing levels.

School boards shall, however, annually, on or before January 1, report to the public the actual 4320 pupil/teacher ratios in elementary school classrooms by school for the current school year. Such actual 4321 ratios shall include only the teachers who teach the grade and class on a full-time basis and shall 4322 exclude resource personnel. School boards shall report pupil/teacher ratios that include resource teachers 4323 in the same annual report. Any classes funded through the voluntary kindergarten through third grade 4324 class size reduction program shall be identified as such classes. Any classes having waivers to exceed 4325 the requirements of this subsection shall also be identified. Schools shall be identified; however, the data 4326 shall be compiled in a manner to ensure the confidentiality of all teacher and pupil identities.

Each such course 4333 enrollment by such students shall be counted as 0.25 in the ADM; however, no such nonpublic or home 4334 school student shall be counted as more than one-half a student for purposes of such pro rata 4335 calculation. 4337 O. Each local school board shall provide those support services that are necessary for the efficient4338 and cost-effective operation and maintenance of its public schools.

For the purposes of this title, unless the context otherwise requires, "support services" shall include
services provided by the school board members; the superintendent; assistant superintendents; student
services (including guidance counselors, social workers, and homebound, improvement, principal's office,
and library-media positions); attendance and health positions; administrative, technical, and clerical
positions; operation and maintenance positions; educational technology positions; school nurses; and

**4345** Pursuant to the appropriation act, support services shall be funded from basic school aid on the basis **4346** of prevailing statewide costs.

4347 § 22.1-272.1. Responsibility to contact parent of student at imminent risk of suicide; notice to be
4348 given to social services if parental abuse or neglect; Board of Education, in cooperation with the
4349 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services
4350 and the Department of Health, to develop guidelines for parental contact.

A. Any person licensed as administrative or instructional personnel by the Board of Education and
employed by a local school board who, in the scope of his employment, has reason to believe, as a
result of direct communication from a student, that such student is at imminent risk of suicide, shall, as
soon as practicable, contact at least one of such student's parents to ask whether such parent is aware of
the student's mental state and whether the parent wishes to obtain or has already obtained counseling for
such student. Such contact shall be made in accordance with the provisions of the guidelines required by
subsection C.

B. If the student has indicated that the reason for being at imminent risk of suicide relates to parental abuse or neglect, this contact shall not be made with the parent. Instead, the person shall, as soon as practicable, notify the local department of social services of the county or city wherein the child resides or wherein the abuse or neglect is believed to have occurred or the state Department of Social Services' toll-free child abuse and neglect hotline, as required by § 63.2-1509. When giving this notice to the local or state department, the person shall stress the need to take immediate action to protect the child from harm.

4365 C. The Board of Education, in cooperation with the Department of Mental Health, Mental 4366 RetardationIntellectual Disability and Substance Abuse Services and the Department of Health, shall 4367 develop guidelines for making the contact required by subsection A. 4379 As used in this chapter unless the context requires a different meaning:

4380 "Board" means the Virginia Board of Education.

4381 "Department" means the Department of Education.

4382 "Person" means any individual, group of individuals, partnership, association, business trust, 4383 corporation, or other business entity.

§ 25.1-100. Definitions.

4417 "Body determining just compensation" means a jury selected pursuant to § 25.1-229, or the court if a jury is not empanelled. 4418 4419

"Court" means the court having jurisdiction as provided in § 25.1-201.

4427 "Owner" means any person who owns property, provided that the person's ownership of the property 4428 is of record in the land records of the clerk's office of the circuit court of the county or city where the 4429 property is located. § 29.1-313. Issuance of licenses for use of patients in certain state institutions.

4450 The Director shall have authority to issue at the regular fee, up to twenty-five state resident licenses to fish in the name of any state institution operated by the Department of Mental Health, Mental 4451 4452 RetardationIntellectual Disability and Substance Abuse Services for use by patients of the institution.

Whenever any health care provider, or any person employed by or under the direction and control 4456 of a health care provider, is directly exposed to body fluids of a patient in a manner which may, 4457 according to the then current guidelines of the Centers for Disease Control, transmit human 4458 immunodeficiency virus or hepatitis B or C viruses, the patient whose body fluids were involved in the 4459 exposure shall be deemed to have consented to testing for infection with human immunodeficiency virus 4460 or hepatitis B or C viruses. Such patient shall also be deemed to have consented to the release of such 4461 test results to the person who was exposed. In other than emergency situations, it shall be the 4462 responsibility of the health care provider to inform patients of this provision prior to providing them 4463 with health care services which create a risk of such exposure.

4464 B. Whenever any patient is directly exposed to body fluids of a health care provider, or of any 4465 person employed by or under the direction and control of a health care provider, in a manner which may, according to the then current guidelines of the Centers for Disease Control, transmit human 4466 4467 immunodeficiency virus or hepatitis B or C viruses, the person whose body fluids were involved in the 4468 exposure shall be deemed to have consented to testing for infection with human immunodeficiency virus 4469 or hepatitis B or C viruses. Such person shall also be deemed to have consented to the release of such 4470 test results to the patient who was exposed.

C. For the purposes of this section, "health care provider" means any person, facility or agency 4471 4472 licensed or certified to provide care or treatment by the Department of Health, Department of Mental 4473 Health, Mental RetardationIntellectual Disability and Substance Abuse Services, Department of 4474 Rehabilitative Services, or the Department of Social Services, any person licensed or certified by a 4475 health regulatory board within the Department of Health Professions except for the Boards of Funeral 4476 Directors and Embalmers and Veterinary Medicine or any personal care agency contracting with the 4477 Department of Medical Assistance Services.

Whenever a person is directly exposed to the body fluids of a law-enforcement officer in a manner which may, according to the then current guidelines of the Centers for Disease Control, transmit human immunodeficiency virus or hepatitis B or C viruses, the law-enforcement officer whose body fluids were involved in the exposure shall be deemed to have consented to testing for infection with human immunodeficiency virus or hepatitis B or C viruses. The law-enforcement officer shall also be deemed to have consented to the release of such test results to the person.

4498 G. For the purposes of this section, "law-enforcement officer" means a person who is both (i) 4499 engaged in his public duty at the time of such exposure and (ii) employed by any sheriff's office, any 4500 adult or youth correctional facility, or any state or local law-enforcement agency, or any agency or 4501 department under the direction and control of the Commonwealth or any local governing body that 4502 employs persons who have law-enforcement authority.

In other than 4509 emergency situations, it shall be the responsibility of the school board employee to inform the person of 4510 this provision prior to the contact that creates a risk of such exposure.

I. Whenever any person is directly exposed to the body fluids of a school board employee in a manner that may, according to the then current guidelines of the Centers for Disease Control, transmit human immunodeficiency virus or hepatitis B or C viruses, the school board employee whose body fluids were involved in the exposure shall be deemed to have consented to testing for infection with human immunodeficiency virus or hepatitis B or C viruses. The school board employee shall also be deemed to have consented to the release of such test results to the person.

4517 J. For the purposes of this section, "school board employee" means a person who is both (i) acting in 4518 the course of employment at the time of such exposure and (ii) employed by any local school board in 4519 the Commonwealth.

4520 K. For purposes of subsection H, if the person to be tested is a minor, consent for such testing shall
4521 be obtained from the parent, guardian, or person standing in loco parentis of such minor prior to

If any such person is found to be infected with a 4540 venereal disease, the person in charge of such institution shall promptly provide treatment and shall 4541 report such case as provided in § 32.1-37.

§ 32.1-64.1. Virginia Hearing Impairment Identification and Monitoring System.

A. In order to identify hearing loss at the earliest possible age among newborns and to provide early
intervention for all infants so identified as having hearing impairment, the Commissioner shall establish
and maintain the Virginia Hearing Impairment Identification and Monitoring System. This system shall
be for the purpose of identifying and monitoring infants with hearing impairment to ensure that such
infants receive appropriate early intervention through treatment, therapy, training and education.

**4548** B. The Virginia Hearing Impairment Identification and Monitoring System shall be initiated in all hospitals with neonatal intensive care services, in all hospitals in the Commonwealth having newborn

4550 nurseries, and in other birthing places or centers in the Commonwealth having newborn nurseries.

4551 C. In all hospitals with neonatal intensive care services, the chief medical officer of such hospitals or 4552 his designee shall identify infants at risk of hearing impairment using criteria established by the Board. 4553 Beginning on July 1, 1999, all infants shall be given a hearing screening test, regardless of whether or 4554 not the infant is at risk of hearing impairment, by the chief medical officer or his designee using 4555 methodology approved by the Board. The test shall take place before the infant is discharged from the 4556 hospital to the care of the parent or guardian, or as the Board may by regulation provide.

4557 In all other hospitals and other birthing places or centers, the chief medical officer or his designee or 4558 the attending practitioner shall identify infants at risk of hearing impairment using criteria established by 4559 the Board.

4560 D. Beginning on July 1, 2000, the Board shall provide by regulation for the giving of hearing screening tests for all infants born in all hospitals. The Board's regulations shall establish when the 4561 4562 testing shall be offered and performed and procedures for reporting.

4563 An infant whose hearing screening indicates the need for a diagnostic audiological examination shall 4564 be offered such examination at a center approved by the Board of Health. As a condition of such 4565 approval, such centers shall maintain suitable audiological support and medical and educational referral 4566 practices.

4567 E. The Commissioner shall appoint an advisory committee to assist in the design, implementation, 4568 and revision of this identification and monitoring system. The advisory committee shall meet at least 4569 four times per year. A chairman shall be elected annually by the advisory committee. The Department of 4570 Health shall provide support services to the advisory committee. The advisory committee shall consist of 4571 representatives from relevant groups including, but not limited to, the health insurance industry; 4572 physicians, including at least one pediatrician or family practitioner, one otolaryngologist, and one 4573 neonatologist; nurses representing newborn nurseries; audiologists; hearing aid dealers and fitters; 4574 teachers of the deaf and hard-of-hearing; parents of children who are deaf or hard-of-hearing; adults who are deaf or hard-of-hearing; hospital administrators; and personnel of appropriate state agencies, including the Department of Medical Assistance Services, the Department of Education, and the 4575 4576 4577 Department for the Deaf and Hard-of-Hearing. The Department of Education, the Department for the 4578 Deaf and Hard-of-Hearing, and the Department of Mental Health, Mental RetardationIntellectual 4579 Disability and Substance Abuse Services shall cooperate with the Commissioner and the Board in 4580 implementing this system.

4581 F. With the assistance of the advisory committee, the Board shall promulgate such rules and 4582 regulations as may be necessary to implement this identification and monitoring system. These rules and 4583 regulations shall include criteria, including current screening methodology, for the identification of 4584 infants (i) with hearing impairment and (ii) at risk of hearing impairment and shall include the scope of 4585 the information to be reported, reporting forms, screening protocols, appropriate mechanisms for follow-up, relationships between the identification and monitoring system and other state agency programs or activities and mechanisms for review and evaluation of the activities of the system. The 4586 4587 4588 identification and monitoring system shall collect the name, address, sex, race, and any other information 4589 determined to be pertinent by the Board, regarding infants determined to be at risk of hearing 4590 impairment or to have hearing loss.

4591 G. In addition, the Board's regulations shall provide that any person making a determination that an 4592 infant (i) is at risk for hearing impairment, (ii) has failed to pass a hearing screening, or (iii) was not 4593 successfully tested shall notify the parent or guardian of the infant, the infant's primary care practitioner, 4594 and the Commissioner.

H. No testing required to be performed or offered by this section shall be performed if the parents of 4595 4596 the infant object to the test based on their bona fide religious convictions. 4597

§ 32.1-65. Certain newborn screening required.

4598 In order to prevent mental retardationintellectual disability and permanent disability or death, every 4599 infant who is born in the Commonwealth shall be subjected to screening tests for various disorders 4600 consistent with, but not necessarily identical to, the uniform condition panel recommended by the 4601 American College of Medical Genetics in its report, Newborn Screening: Toward a Uniform Screening 4602 Panel and System, that was produced for the U.S. Department of Health and Human Services. Further, 4603 upon the issuance of guidance for states' newborn screening programs by the federal Department of 4604 Health and Human Services, every infant who is born in the Commonwealth shall be screened for a 4605 panel of disorders consistent with, but not necessarily identical to, the federal guidance document.

4606 Any infant whose parent or guardian objects thereto on the grounds that such tests conflict with his 4607 religious practices or tenets shall not be required to receive such screening tests.

4608 The physician or certified nurse midwife in charge of the infant's care after delivery shall cause such tests to be performed. The screening tests shall be performed by the Division of Consolidated 4609 Laboratory Services or any other laboratory the Department of Health has contracted with to provide this 4610

4611 service.

4612 The program for screening infants for sickle cell diseases shall be conducted in addition to the 4613 programs provided for in Article 8 (§ 32.1-68 et seq.) of this chapter.

4614 § 32.1-73.7. Department to be lead agency for youth suicide prevention.

With such funds as may be appropriated for this purpose, the Department, in consultation with the 4615 4616 Department of Education, the Department of Mental Health, Mental RetardationIntellectual Disability 4617 and Substance Abuse Services, community services boards and behavioral health authorities, and local 4618 departments of health, shall have the lead responsibility for the youth suicide prevention program within 4619 the Commonwealth. This responsibility includes coordination of the activities of the agencies of the Commonwealth pertaining to youth suicide prevention in order to develop and carry out comprehensive 4620 youth suicide prevention strategies addressing public awareness, the promotion of health development, 4621 early identification, intervention and treatment, and support to survivors. The strategies shall be targeted 4622 4623 to the specific needs of children and adolescents. The Department shall cooperate with federal, state and 4624 local agencies, private and public agencies, survivor groups and other interested persons in order to 4625 prevent youth suicide within the Commonwealth.

4626 The provisions of this section shall not limit the powers and duties of other state agencies.

4627 § 32.1-102.1. Definitions.

4628 As used in this article, unless the context indicates otherwise:

4629 "Certificate" means a certificate of public need for a project required by this article.

4630 "Clinical health service" means a single diagnostic, therapeutic, rehabilitative, preventive or palliative 4631 procedure or a series of such procedures that may be separately identified for billing and accounting 4632 purposes.

4633 "Health planning region" means a contiguous geographical area of the Commonwealth with a 4634 population base of at least 500,000 persons which is characterized by the availability of multiple levels 4635 of medical care services, reasonable travel time for tertiary care, and congruence with planning districts.

4636 "Medical care facility," as used in this title, means any institution, place, building or agency, whether 4637 or not licensed or required to be licensed by the Board or the State Mental Health, Mental 4638 RetardationIntellectual Disability and Substance Abuse Services Board, whether operated for profit or 4639 nonprofit and whether privately owned or privately operated or owned or operated by a local 4640 governmental unit, (i) by or in which health services are furnished, conducted, operated or offered for 4641 the prevention, diagnosis or treatment of human disease, pain, injury, deformity or physical condition, 4642 whether medical or surgical, of two or more nonrelated mentally or physically sick or injured persons, 4643 or for the care of two or more nonrelated persons requiring or receiving medical, surgical or nursing 4644 attention or services as acute, chronic, convalescent, aged, physically disabled or crippled or (ii) which is 4645 the recipient of reimbursements from third-party health insurance programs or prepaid medical service 4646 plans. For purposes of this article, only the following medical care facilities shall be subject to review: 4647

1. General hospitals.

2. Sanitariums.

3. Nursing homes.

4650 4. Intermediate care facilities, except those intermediate care facilities established for the mentally 4651 retarded persons with intellectual disability that have no more than 12 beds and are in an area identified 4652 as in need of residential services for people persons with mental retardationintellectual disability in any 4653 plan of the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 4654 Services.

- 5. Extended care facilities.
- 4656 6. Mental hospitals.
  - 7. Mental retardation facilities Facilities for persons with intellectual disability.

4658 8. Psychiatric hospitals and intermediate care facilities established primarily for the medical, 4659 psychiatric or psychological treatment and rehabilitation of alcoholics or drug addicts.

4660 9. Specialized centers or clinics or that portion of a physician's office developed for the provision of 4661 outpatient or ambulatory surgery, cardiac catheterization, computed tomographic (CT) scanning, gamma 4662 knife surgery, lithotripsy, magnetic resonance imaging (MRI), magnetic source imaging (MSI), positron 4663 emission tomographic (PET) scanning, radiation therapy, nuclear medicine imaging, except for the 4664 purpose of nuclear cardiac imaging, or such other specialty services as may be designated by the Board 4665 by regulation. 4666

10. Rehabilitation hospitals.

11. Any facility licensed as a hospital.

The term "medical care facility" shall not include any facility of (i) the Department of Mental Health, 4668 4669 Mental RetardationIntellectual Disability and Substance Abuse Services; (ii) any nonhospital substance 4670 abuse residential treatment program operated by or contracted primarily for the use of a community services board under the Department of Mental Health, Mental RetardationIntellectual Disability and 4671 4672 Substance Abuse Services' Comprehensive Plan; (iii) an intermediate care facility for the mentally

retarded persons with intellectual disability that has no more than 12 beds and is in an area identified as
in need of residential services for people persons with mental retardationintellectual disability in any

subdivision 9 of the definition of "medical care facility"; or (v) the Woodrow Wilson Rehabilitation

- **4681** 1. Establishment of a medical care facility;
- 4682 2. An increase in the total number of beds or operating rooms in an existing medical care facility;

3. Relocation at the same site of 10 beds or 10 percent of the beds, whichever is less, from one existing physical facility to another in any two-year period; however, a hospital shall not be required to obtain a certificate for the use of 10 percent of its beds as nursing home beds as provided in § 32.1-132;

4687 Introduction into an existing medical care facility of any new nursing home service, such as intermediate care facility services, extended care facility services, or skilled nursing facility services, regardless of the type of medical care facility in which those services are provided;

4689 5. Introduction into an existing medical care facility of any new cardiac catheterization, computed tomographic (CT) scanning, gamma knife surgery, lithotripsy, magnetic resonance imaging (MRI), magnetic source imaging (MSI), medical rehabilitation, neonatal special care, obstetrical, open heart surgery, positron emission tomographic (PET) scanning, psychiatric, organ or tissue transplant service, radiation therapy, nuclear medicine imaging, except for the purpose of nuclear cardiac imaging, substance abuse treatment, or such other specialty clinical services as may be designated by the Board by regulation, which the facility has never provided or has not provided in the previous 12 months;

**4696** 6. Conversion of beds in an existing medical care facility to medical rehabilitation beds or **4697** psychiatric beds;

4698 7. The addition by an existing medical care facility of any medical equipment for the provision of cardiac catheterization, computed tomographic (CT) scanning, gamma knife surgery, lithotripsy, magnetic resonance imaging (MRI), magnetic source imaging (MSI), open heart surgery, positron emission tomographic (PET) scanning, radiation therapy, or other specialized service designated by the Board by regulation. Replacement of existing equipment shall not require a certificate of public need; or

8. Any capital expenditure of \$15 million or more, not defined as reviewable in subdivisions 1
through 7 of this definition, by or in behalf of a medical care facility. However, capital expenditures
between \$5 and \$15 million shall be registered with the Commissioner pursuant to regulations developed
by the Board. The amounts specified in this subdivision shall be revised effective July 1, 2008, and
annually thereafter to reflect inflation using appropriate measures incorporating construction costs and
medical inflation.

4709 "Regional health planning agency" means the regional agency, including the regional health planning
4710 board, its staff and any component thereof, designated by the Virginia Health Planning Board to perform
4711 the health planning activities set forth in this chapter within a health planning region.

4712 "State Medical Facilities Plan" means the planning document adopted by the Board of Health which
4713 shall include, but not be limited to, (i) methodologies for projecting need for medical care facility beds
4714 and services; (ii) statistical information on the availability of medical care facilities and services; and
4715 (iii) procedures, criteria and standards for review of applications for projects for medical care facilities
4716 and services.

4717 "Virginia Health Planning Board" means the statewide health planning body established pursuant to
4718 § 32.1-122.02 which serves as the analytical and technical resource to the Secretary of Health and
4719 Human Resources in matters requiring health analysis and planning.

**4720** § 32.1-122.5. Criteria to identify underserved areas.

4721 The Board of Health shall establish criteria to identify medically underserved areas within the Commonwealth. These criteria shall consist of quantifiable measures sensitive to the unique 4722 4723 characteristics of urban and rural jurisdictions which may include the incidence of infant mortality, the 4724 availability of primary care resources, poverty levels, and other measures indicating the inadequacy of 4725 the primary health care system as determined by the Board. The Board shall also include in these 4726 criteria the need for medical care services in the state facilities operated by the Departments of 4727 Corrections, Juvenile Justice, and Mental Health, Mental RetardationIntellectual Disability and Substance 4728 Abuse Services.

**4729** § 32.1-124. Exemptions.

4730 The provisions of §§ 32.1-123 through 32.1-136 shall not be applicable to: (i) a dispensary or
4731 first-aid facility maintained by any commercial or industrial plant, educational institution or convent; (ii)
4732 an institution licensed by the State Mental Health, Mental RetardationIntellectual Disability and
4733 Substance Abuse Services Board; (iii) an institution or portion thereof licensed by the State Board of

4734 Social Services; (iv) a hospital or nursing home owned or operated by an agency of the United States 4735 government; (v) an office of one or more physicians or surgeons unless such office is used principally 4736 for performing surgery; and (vi) a hospital or nursing home, as defined in § 32.1-123, owned or operated

4739 § 32.1-125.1. Inspection of hospitals by state agencies generally.

4740 As used in this section unless the context requires a different meaning, "hospital" means a hospital as 4741 defined in § 32.1-123 or § 37.2-100.

4742 State agencies shall make or cause to be made only such inspections of hospitals as are necessary to 4743 carry out the various obligations imposed on each agency by applicable state and federal laws and 4744 regulations. Any on-site inspection by a state agency or a division or unit thereof that substantially complies with the inspection requirements of any other state agency or any other division or unit of the 4745 4746 inspecting agency charged with making similar inspections shall be accepted as an equivalent inspection in lieu of an on-site inspection by said agency or by a division or unit of the inspecting agency. A state 4747 4748 agency shall coordinate its hospital inspections both internally and with those required by other state 4749 agencies so as to ensure that the requirements of this section are met.

Notwithstanding any provision of law to the contrary, all hospitals licensed by the Department of 4750 Health or Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 4751 4752 Services which have been certified under the provisions of Title XVIII of the Social Security Act for 4753 hospital or psychiatric services or which have obtained accreditation from the Joint Commission on 4754 Accreditation of Healthcare Organizations may be subject to inspections so long as such certification or 4755 accreditation is maintained but only to the extent necessary to ensure the public health and safety. 4756

§ 32.1-127.01. Regulations to authorize certain sanctions and guidelines.

4757 The regulations established pursuant to § 32.1-127 shall authorize the Commissioner to initiate court 4758 proceedings against nursing homes and certified nursing facilities, except for facilities or units certified as facilities for the mentally retarded persons with intellectual disability. Such proceedings may be 4759 4760 initiated by themselves or in conjunction with the administrative sanctions provided in § 32.1-135.

4761 The Board shall promulgate guidelines for the Commissioner to determine when the imposition of 4762 administrative sanctions or initiation of court proceedings as specified in § 32.1-27.1, or both, are 4763 appropriate in order to ensure prompt correction of violations involving noncompliance with 4764 requirements of state or federal law or regulation as discovered on any inspection conducted by the 4765 Department of Health pursuant to the provisions of this article or the provisions of Title XVIII or Title 4766 XIX of the Social Security Act or as discovered on any inspection conducted by the Department of 4767 Medical Assistance Services pursuant to Title XIX of the Social Security Act. 4768

§ 32.1-127.1:03. Health records privacy.

4769 A. There is hereby recognized an individual's right of privacy in the content of his health records. 4770 Health records are the property of the health care entity maintaining them, and, except when permitted 4771 or required by this section or by other provisions of state law, no health care entity, or other person 4772 working in a health care setting, may disclose an individual's health records. 4773

Pursuant to this subsection:

4774 1. Health care entities shall disclose health records to the individual who is the subject of the health 4775 record, except as provided in subsections E and F of this section and subsection B of § 8.01-413.

4776 2. Health records shall not be removed from the premises where they are maintained without the 4777 approval of the health care entity that maintains such health records, except in accordance with a court 4778 order or subpoena consistent with subsection C of § 8.01-413 or with this section or in accordance with 4779 the regulations relating to change of ownership of health records promulgated by a health regulatory 4780 board established in Title 54.1.

4781 3. No person to whom health records are disclosed shall redisclose or otherwise reveal the health 4782 records of an individual, beyond the purpose for which such disclosure was made, without first 4783 obtaining the individual's specific authorization to such redisclosure. This redisclosure prohibition shall 4784 not, however, prevent (i) any health care entity that receives health records from another health care 4785 entity from making subsequent disclosures as permitted under this section and the federal Department of 4786 Health and Human Services regulations relating to privacy of the electronic transmission of data and protected health information promulgated by the United States Department of Health and Human 4787 4788 Services as required by the Health Insurance Portability and Accountability Act (HIPAA) (42 U.S.C. 4789 § 1320d et seq.) or (ii) any health care entity from furnishing health records and aggregate or other data, 4790 from which individually identifying prescription information has been removed, encoded or encrypted, to 4791 qualified researchers, including, but not limited to, pharmaceutical manufacturers and their agents or 4792 contractors, for purposes of clinical, pharmaco-epidemiological, pharmaco-economic, or other health 4793 services research.

4794 B. As used in this section:

4795 "Agent" means a person who has been appointed as an individual's agent under a power of attorney

4796 for health care or an advance directive under the Health Care Decisions Act (§ 54.1-2981 et seq.).

4797 "Certification" means a written representation that is delivered by hand, by first-class mail, by 4798 overnight delivery service, or by facsimile if the sender obtains a facsimile-machine-generated 4799 confirmation reflecting that all facsimile pages were successfully transmitted.

4800 "Guardian" means a court-appointed guardian of the person."

4801 "Health care clearinghouse" means, consistent with the definition set out in 45 C.F.R. § 160.103, a 4802 public or private entity, such as a billing service, repricing company, community health management 4803 information system or community health information system, and "value-added" networks and switches, 4804 that performs either of the following functions: (i) processes or facilitates the processing of health 4805 information received from another entity in a nonstandard format or containing nonstandard data content 4806 into standard data elements or a standard transaction; or (ii) receives a standard transaction from another entity and processes or facilitates the processing of health information into nonstandard format or 4807 4808 nonstandard data content for the receiving entity. 4809

"Health care entity" means any health care provider, health plan or health care clearinghouse.

"Health care provider" means those entities listed in the definition of "health care provider" in 4810 4811 § 8.01-581.1, except that state-operated facilities shall also be considered health care providers for the 4812 purposes of this section. Health care provider shall also include all persons who are licensed, certified, 4813 registered or permitted or who hold a multistate licensure privilege issued by any of the health 4814 regulatory boards within the Department of Health Professions, except persons regulated by the Board of 4815 Funeral Directors and Embalmers or the Board of Veterinary Medicine.

4816 "Health plan" means an individual or group plan that provides, or pays the cost of, medical care. 4817 "Health plan" shall include any entity included in such definition as set out in 45 C.F.R. § 160.103.

4818 "Health record" means any written, printed or electronically recorded material maintained by a health 4819 care entity in the course of providing health services to an individual concerning the individual and the services provided. "Health record" also includes the substance of any communication made by an 4820 4821 individual to a health care entity in confidence during or in connection with the provision of health 4822 services or information otherwise acquired by the health care entity about an individual in confidence 4823 and in connection with the provision of health services to the individual.

4824 "Health services" means, but shall not be limited to, examination, diagnosis, evaluation, treatment, 4825 pharmaceuticals, aftercare, habilitation or rehabilitation and mental health therapy of any kind, as well as 4826 payment or reimbursement for any such services.

4827 "Individual" means a patient who is receiving or has received health services from a health care 4828 entity.

4829 "Individually identifying prescription information" means all prescriptions, drug orders or any other 4830 prescription information that specifically identifies an individual.

"Parent" means a biological, adoptive or foster parent. 4831

4832 "Psychotherapy notes" means comments, recorded in any medium by a health care provider who is a 4833 mental health professional, documenting or analyzing the contents of conversation during a private counseling session with an individual or a group, joint, or family counseling session that are separated from the rest of the individual's health record. "Psychotherapy notes" shall not include annotations 4834 4835 4836 relating to medication and prescription monitoring, counseling session start and stop times, treatment 4837 modalities and frequencies, clinical test results, or any summary of any symptoms, diagnosis, prognosis, 4838 functional status, treatment plan, or the individual's progress to date.

4839 C. The provisions of this section shall not apply to any of the following:

4840 1. The status of and release of information governed by §§ 65.2-604 and 65.2-607 of the Virginia 4841 Workers' Compensation Act;

4842 2. Except where specifically provided herein, the health records of minors; or

4843 3. The release of juvenile health records to a secure facility or a shelter care facility pursuant to 4844 § 16.1-248.3.

4845 D. Health care entities may, and, when required by other provisions of state law, shall, disclose 4846 health records:

4847 1. As set forth in subsection E, pursuant to the written authorization of (i) the individual or (ii) in the 4848 case of a minor, (a) his custodial parent, guardian or other person authorized to consent to treatment of 4849 minors pursuant to § 54.1-2969 or (b) the minor himself, if he has consented to his own treatment 4850 pursuant to § 54.1-2969, or (iii) in emergency cases or situations where it is impractical to obtain an 4851 individual's written authorization, pursuant to the individual's oral authorization for a health care 4852 provider or health plan to discuss the individual's health records with a third party specified by the 4853 individual;

4854 2. In compliance with a subpoena issued in accord with subsection H, pursuant to a search warrant 4855 or a grand jury subpoena, pursuant to court order upon good cause shown or in compliance with a 4856 subpoena issued pursuant to subsection C of § 8.01-413;

4857 3. In accord with subsection F of § 8.01-399 including, but not limited to, situations where disclosure 4858 is reasonably necessary to establish or collect a fee or to defend a health care entity or the health care 4859 entity's employees or staff against any accusation of wrongful conduct; also as required in the course of 4860 an investigation, audit, review or proceedings regarding a health care entity's conduct by a duly 4861 authorized law-enforcement, licensure, accreditation, or professional review entity;

4862 4. In testimony in accordance with §§ 8.01-399 and 8.01-400.2;

4864 6. 7. Where necessary in connection with the care of the individual;

4871 8. In connection with the health care entity's own health care operations or the health care operations of another health care entity, as specified in 45 C.F.R. § 164.501, or in the normal course of business in 4872 4873 accordance with accepted standards of practice within the health services setting; however, the maintenance, storage, and disclosure of the mass of prescription dispensing records maintained in a 4874 4875 pharmacy registered or permitted in Virginia shall only be accomplished in compliance with 4876 §§ 54.1-3410, 54.1-3411, and 54.1-3412;

9. When the individual has waived his right to the privacy of the health records;

4878 10. When examination and evaluation of an individual are undertaken pursuant to judicial or 4879 administrative law order, but only to the extent as required by such order;

11. To the guardian ad litem and any attorney representing the respondent in the course of a 4880 4881 guardianship proceeding of an adult patient who is the respondent in a proceeding under Chapter 10 4882 (§ 37.2-1000 et seq.) of Title 37.2;

4883 12. To the attorney appointed by the court to represent an individual who is or has been a patient 4884 who is the subject of a civil commitment proceeding under Article 5 (§ 37.2-814 et seq.) of Chapter 8 4885 of Title 37.2 or a judicial authorization for treatment proceeding pursuant to Chapter 11 (§ 37.2-1100 et seq.) of Title 37.2: 4886

4887 13. To the attorney and/or guardian ad litem of a minor who represents such minor in any judicial or 4888 administrative proceeding, if the court or administrative hearing officer has entered an order granting the 4889 attorney or guardian ad litem this right and such attorney or guardian ad litem presents evidence to the 4890 health care entity of such order;

4891 14. With regard to the Court-Appointed Special Advocate (CASA) program, a minor's health records 4892 in accord with § 9.1-156;

4893 15. To an agent appointed under an individual's power of attorney or to an agent or decision maker 4894 designated in an individual's advance directive for health care or for decisions on anatomical gifts and 4895 organ, tissue or eye donation or to any other person consistent with the provisions of the Health Care 4896 Decisions Act (§ 54.1-2981 et seq.);

16. To third-party payors and their agents for purposes of reimbursement;

4898 17. As is necessary to support an application for receipt of health care benefits from a governmental 4899 agency or as required by an authorized governmental agency reviewing such application or reviewing 4900 benefits already provided or as necessary to the coordination of prevention and control of disease, 4901 injury, or disability and delivery of such health care benefits pursuant to § 32.1-127.1:04;

4902 18. Upon the sale of a medical practice as provided in § 54.1-2405; or upon a change of ownership 4903 or closing of a pharmacy pursuant to regulations of the Board of Pharmacy;

19. In accord with subsection B of § 54.1-2400.1, to communicate an individual's specific and 4904 4905 immediate threat to cause serious bodily injury or death of an identified or readily identifiable person;

4906 20. Where necessary in connection with the implementation of a hospital's routine contact process for organ donation pursuant to subdivision B 4 of § 32.1-127; 4907

4908 21. In the case of substance abuse records, when permitted by and in conformity with requirements 4909 of federal law found in 42 U.S.C. § 290dd-2 and 42 C.F.R. Part 2;

4910 22. In connection with the work of any entity established as set forth in § 8.01-581.16 to evaluate the 4911 adequacy or quality of professional services or the competency and qualifications for professional staff 4912 privileges;

4913 23. If the health records are those of a deceased or mentally incapacitated individual to the personal 4914 representative or executor of the deceased individual or the legal guardian or committee of the 4915 incompetent or incapacitated individual or if there is no personal representative, executor, legal guardian 4916 or committee appointed, to the following persons in the following order of priority: a spouse, an adult 4917 son or daughter, either parent, an adult brother or sister, or any other relative of the deceased individual 4918 in order of blood relationship;

4919 24. For the purpose of conducting record reviews of inpatient hospital deaths to promote
4920 identification of all potential organ, eye, and tissue donors in conformance with the requirements of
4921 applicable federal law and regulations, including 42 C.F.R. § 482.45, (i) to the health care provider's
4922 designated organ procurement organization certified by the United States Health Care Financing
4923 Administration and (ii) to any eye bank or tissue bank in Virginia certified by the Eye Bank Association
4924 of America or the American Association of Tissue Banks;

**4925** 25. To the Office of the Inspector General for Mental Health, Mental RetardationIntellectual **4926** Disability and Substance Abuse Services pursuant to Article 3 (§ 37.2-423 et seq.) of Chapter 4 of Title **4927** 37.2;

4928 26. To an entity participating in the activities of a local health partnership authority established
4929 pursuant to Article 6.1 (§ 32.1-122.10:001 et seq.) of Chapter 4 of this title, pursuant to subdivision 1 of this subsection;

4931 27. To law-enforcement officials by each licensed emergency medical services agency, (i) when the individual is the victim of a crime or (ii) when the individual has been arrested and has received emergency medical services or has refused emergency medical services and the health records consist of the prehospital patient care report required by § 32.1-116.1;

4935 28. To law-enforcement officials, in response to their request, for the purpose of identifying or 4936 locating a suspect, fugitive, person required to register pursuant to § 9.1-901 of the Sex Offender and 4937 Crimes Against Minors Registry Act, material witness, or missing person, provided that only the 4938 following information may be disclosed: (i) name and address of the person, (ii) date and place of birth 4939 of the person, (iii) social security number of the person, (iv) blood type of the person, (v) date and time 4940 of treatment received by the person, (vi) date and time of death of the person, where applicable, (vii) 4941 description of distinguishing physical characteristics of the person, and (viii) type of injury sustained by 4942 the person.

4943 29. To law-enforcement officials regarding the death of an individual for the purpose of alerting law
4944 enforcement of the death if the health care entity has a suspicion that such death may have resulted
4945 from criminal conduct;

**4946** 30. To law-enforcement officials if the health care entity believes in good faith that the information disclosed constitutes evidence of a crime that occurred on its premises;

4948 31. To the State Health Commissioner pursuant to § 32.1-48.015 when such records are those of a person or persons who are subject to an order of quarantine or an order of isolation pursuant to Article 3.02 (§ 32.1-48.05 et seq.) of Chapter 2 of this title; and

4951 32. To the Commissioner of the Department of Labor and Industry or his designee by each licensed
4952 emergency medical services agency when the records consist of the prehospital patient care report
4953 required by § 32.1-116.1 and the patient has suffered an injury or death on a work site while performing
4954 duties or tasks that are within the scope of his employment.

4955 Notwithstanding the provisions of subdivisions 1 through 32 of this subsection, a health care entity 4956 shall obtain an individual's written authorization for any disclosure of psychotherapy notes, except when 4957 disclosure by the health care entity is (i) for its own training programs in which students, trainees, or 4958 practitioners in mental health are being taught under supervision to practice or to improve their skills in 4959 group, joint, family, or individual counseling; (ii) to defend itself or its employees or staff against any 4960 accusation of wrongful conduct; (iii) in the discharge of the duty, in accordance with subsection B of 4961 § 54.1-2400.1, to take precautions to protect third parties from violent behavior or other serious harm; 4962 (iv) required in the course of an investigation, audit, review, or proceeding regarding a health care 4963 entity's conduct by a duly authorized law-enforcement, licensure, accreditation, or professional review 4964 entity; or (v) otherwise required by law.

4965 E. Requests for copies of health records shall (i) be in writing, dated and signed by the requester; (ii) 4966 identify the nature of the information requested; and (iii) include evidence of the authority of the 4967 requester to receive such copies and identification of the person to whom the information is to be 4968 disclosed. The health care entity shall accept a photocopy, facsimile, or other copy of the original signed 4969 by the requestor as if it were an original. Within 15 days of receipt of a request for copies of health records, the health care entity shall do one of the following: (i) furnish such copies to any requester 4970 4971 authorized to receive them; (ii) inform the requester if the information does not exist or cannot be 4972 found; (iii) if the health care entity does not maintain a record of the information, so inform the 4973 requester and provide the name and address, if known, of the health care entity who maintains the 4974 record; or (iv) deny the request (a) under subsection F, (b) on the grounds that the requester has not 4975 established his authority to receive such health records or proof of his identity, or (c) as otherwise 4976 provided by law. Procedures set forth in this section shall apply only to requests for health records not 4977 specifically governed by other provisions of state law.

**4978** F. Except as provided in subsection B of § 8.01-413, copies of an individual's health records shall not be furnished to such individual or anyone authorized to act on the individual's behalf when the

4980 individual's treating physician or the individual's treating clinical psychologist has made a part of the 4981 individual's record a written statement that, in the exercise of his professional judgment, the furnishing 4982 to or review by the individual of such health records would be reasonably likely to endanger the life or 4983 physical safety of the individual or another person, or that such health record makes reference to a 4984 person other than a health care provider and the access requested would be reasonably likely to cause 4985 substantial harm to such referenced person. If any health care entity denies a request for copies of health 4986 records based on such statement, the health care entity shall inform the individual of the individual's 4987 right to designate, in writing, at his own expense, another reviewing physician or clinical psychologist, 4988 whose licensure, training and experience relative to the individual's condition are at least equivalent to 4989 that of the physician or clinical psychologist upon whose opinion the denial is based. The designated 4990 reviewing physician or clinical psychologist shall make a judgment as to whether to make the health 4991 record available to the individual.

4992 The health care entity denying the request shall also inform the individual of the individual's right to 4993 request in writing that such health care entity designate, at its own expense, a physician or clinical 4994 psychologist, whose licensure, training, and experience relative to the individual's condition are at least 4995 equivalent to that of the physician or clinical psychologist upon whose professional judgment the denial 4996 is based and who did not participate in the original decision to deny the health records, who shall make a judgment as to whether to make the health record available to the individual. The health care entity 4997 4998 shall comply with the judgment of the reviewing physician or clinical psychologist. The health care 4999 entity shall permit copying and examination of the health record by such other physician or clinical psychologist designated by either the individual at his own expense or by the health care entity at its 5000 5001 expense.

5002 Any health record copied for review by any such designated physician or clinical psychologist shall be accompanied by a statement from the custodian of the health record that the individual's treating 5003 5004 physician or clinical psychologist determined that the individual's review of his health record would be reasonably likely to endanger the life or physical safety of the individual or would be reasonably likely 5005 to cause substantial harm to a person referenced in the health record who is not a health care provider. 5006

5007 Further, nothing herein shall be construed as giving, or interpreted to bestow the right to receive 5008 copies of, or otherwise obtain access to, psychotherapy notes to any individual or any person authorized 5009 to act on his behalf.

5010 G. A written authorization to allow release of an individual's health records shall substantially include 5011 the following information:

5042 H. Pursuant to this subsection:

5043 1. Unless excepted from these provisions in subdivision 9 of this subsection, no party to a civil, 5044 criminal or administrative action or proceeding shall request the issuance of a subpoena duces tecum for 5045 another party's health records or cause a subpoena duces tecum to be issued by an attorney unless a 5046 copy of the request for the subpoena or a copy of the attorney-issued subpoena is provided to the other 5047 party's counsel or to the other party if pro se, simultaneously with filing the request or issuance of the 5048 subpoena. No party to an action or proceeding shall request or cause the issuance of a subpoena duces 5049 tecum for the health records of a nonparty witness unless a copy of the request for the subpoena or a 5050 copy of the attorney-issued subpoena is provided to the nonparty witness simultaneously with filing the 5051 request or issuance of the attorney-issued subpoena.

5052 No subpoena duces tecum for health records shall set a return date earlier than 15 days from the date 5053 of the subpoena except by order of a court or administrative agency for good cause shown. When a 5054 court or administrative agency directs that health records be disclosed pursuant to a subpoena duces 5055 tecum earlier than 15 days from the date of the subpoena, a copy of the order shall accompany the 5056 subpoena.

5057 Any party requesting a subpoena duces tecum for health records or on whose behalf the subpoena duces tecum is being issued shall have the duty to determine whether the individual whose health records are being sought is pro se or a nonparty.

5060 In instances where health records being subpoenaed are those of a pro se party or nonparty witness, 5061 the party requesting or issuing the subpoena shall deliver to the pro se party or nonparty witness 5062 together with the copy of the request for subpoena, or a copy of the subpoena in the case of an 5063 attorney-issued subpoena, a statement informing them of their rights and remedies. The statement shall 5064 include the following language and the heading shall be in boldface capital letters:

5065 NOTICE TO INDIVIDUAL

5066 The attached document means that (insert name of party requesting or causing issuance of the 5067 subpoena) has either asked the court or administrative agency to issue a subpoena or a subpoena has 5068 been issued by the other party's attorney to your doctor, other health care providers (names of health 5069 care providers inserted here) or other health care entity (name of health care entity to be inserted here) 5070 requiring them to produce your health records. Your doctor, other health care provider or other health 5071 care entity is required to respond by providing a copy of your health records. If you believe your health 5072 records should not be disclosed and object to their disclosure, you have the right to file a motion with 5073 the clerk of the court or the administrative agency to quash the subpoena. If you elect to file a motion 5074 to quash, such motion must be filed within 15 days of the date of the request or of the attorney-issued 5075 subpoena. You may contact the clerk's office or the administrative agency to determine the requirements 5076 that must be satisfied when filing a motion to quash and you may elect to contact an attorney to 5077 represent your interest. If you elect to file a motion to quash, you must notify your doctor, other health care provider(s), or other health care entity, that you are filing the motion so that the health care 5078 provider or health care entity knows to send the health records to the clerk of court or administrative 5079 5080 agency in a sealed envelope or package for safekeeping while your motion is decided.

5081 2. Any party filing a request for a subpoend duces tecum or causing such a subpoend to be issued
5082 for an individual's health records shall include a Notice in the same part of the request in which the
5083 recipient of the subpoend duces tecum is directed where and when to return the health records. Such notice shall be in boldface capital letters and shall include the following language:

5085 NOTICE TO HEALTH CARE ENTITIES

5086 A COPY OF THIS SUBPOENA DUCES TECUM HAS BEEN PROVIDED TO THE INDIVIDUAL

5111 3. Upon receiving a valid subpoena duces tecum for health records, health care entities shall have the duty to respond to the subpoena in accordance with the provisions of subdivisions 4, 5, 6, 7, and 8 of this subsection.

5114 4. Except to deliver to a clerk of the court or administrative agency subpoenaed health records in a
5115 sealed envelope as set forth, health care entities shall not respond to a subpoena duces tecum for such health records until they have received a certification as set forth in subdivision 5 or 8 of this subsection
5117 from the party on whose behalf the subpoena duces tecum was issued.

5118 If the health care entity has actual receipt of notice that a motion to quash the subpoena has been 5119 filed or if the health care entity files a motion to quash the subpoena for health records, then the health 5120 care entity shall produce the health records, in a securely sealed envelope, to the clerk of the court or 5121 administrative agency issuing the subpoena or in whose court or administrative agency the action is pending. The court or administrative agency shall place the health records under seal until a 5122 determination is made regarding the motion to quash. The securely sealed envelope shall only be opened 5123 5124 on order of the judge or administrative agency. In the event the court or administrative agency grants 5125 the motion to quash, the health records shall be returned to the health care entity in the same sealed 5126 envelope in which they were delivered to the court or administrative agency. In the event that a judge or 5127 administrative agency orders the sealed envelope to be opened to review the health records in camera, a 5128 copy of the order shall accompany any health records returned to the health care entity. The health 5129 records returned to the health care entity shall be in a securely sealed envelope.

5130 5. If no motion to quash is filed within 15 days of the date of the request or of the attorney-issued 5131 subpoena, the party on whose behalf the subpoena was issued shall have the duty to certify to the 5132 subpoenaed health care entity that the time for filing a motion to quash has elapsed and that no motion 5133 to quash was filed. Any health care entity receiving such certification shall have the duty to comply 5134 with the subpoena duces tecum by returning the specified health records by either the return date on the 5135 subpoena or five days after receipt of the certification, whichever is later.

5136 6. In the event that the individual whose health records are being sought files a motion to quash the 5137 subpoena, the court or administrative agency shall decide whether good cause has been shown by the 5138 discovering party to compel disclosure of the individual's health records over the individual's objections. 5139 In determining whether good cause has been shown, the court or administrative agency shall consider (i) 5140 the particular purpose for which the information was collected; (ii) the degree to which the disclosure of 5141 the records would embarrass, injure, or invade the privacy of the individual; (iii) the effect of the 5142 disclosure on the individual's future health care; (iv) the importance of the information to the lawsuit or 5143 proceeding; and (v) any other relevant factor.

5144 7. Concurrent with the court or administrative agency's resolution of a motion to quash, if 5145 subpoenaed health records have been submitted by a health care entity to the court or administrative 5146 agency in a sealed envelope, the court or administrative agency shall: (i) upon determining that no submitted health records should be disclosed, return all submitted health records to the health care entity 5147 5148 in a sealed envelope; (ii) upon determining that all submitted health records should be disclosed, provide 5149 all the submitted health records to the party on whose behalf the subpoena was issued; or (iii) upon 5150 determining that only a portion of the submitted health records should be disclosed, provide such portion 5151 to the party on whose behalf the subpoena was issued and return the remaining health records to the 5152 health care entity in a sealed envelope.

8. Following the court or administrative agency's resolution of a motion to quash, the party on whose
behalf the subpoena duces tecum was issued shall have the duty to certify in writing to the subpoenaed
health care entity a statement of one of the following:

a. All filed motions to quash have been resolved by the court or administrative agency and the disclosures sought in the subpoena duces tecum are consistent with such resolution; and, therefore, the health records previously delivered in a sealed envelope to the clerk of the court or administrative agency will not be returned to the health care entity;

5160 b. All filed motions to quash have been resolved by the court or administrative agency and the 5161 disclosures sought in the subpoena duces tecum are consistent with such resolution and that, since no

health records have previously been delivered to the court or administrative agency by the health care
entity, the health care entity shall comply with the subpoena duces tecum by returning the health records
designated in the subpoena by the return date on the subpoena or five days after receipt of certification,
whichever is later;

5166 c. All filed motions to quash have been resolved by the court or administrative agency and the
5167 disclosures sought in the subpoena duces tecum are not consistent with such resolution; therefore, no
5168 health records shall be disclosed and all health records previously delivered in a sealed envelope to the
5169 clerk of the court or administrative agency will be returned to the health care entity;

5170 d. All filed motions to quash have been resolved by the court or administrative agency and the 5171 disclosures sought in the subpoena duces tecum are not consistent with such resolution and that only 5172 limited disclosure has been authorized. The certification shall state that only the portion of the health 5173 records as set forth in the certification, consistent with the court or administrative agency's ruling, shall 5174 be disclosed. The certification shall also state that health records that were previously delivered to the 5175 court or administrative agency for which disclosure has been authorized will not be returned to the 5176 health care entity; however, all health records for which disclosure has not been authorized will be 5177 returned to the health care entity; or

e. All filed motions to quash have been resolved by the court or administrative agency and the disclosures sought in the subpoena duces tecum are not consistent with such resolution and, since no health records have previously been delivered to the court or administrative agency by the health care entity, the health care entity shall return only those health records specified in the certification, consistent with the court or administrative agency's ruling, by the return date on the subpoena or five days after receipt of the certification, whichever is later.

5184 A copy of the court or administrative agency's ruling shall accompany any certification made 5185 pursuant to this subdivision.

5186 9. The provisions of this subsection have no application to subpoenas for health records requested under § 8.01-413, or issued by a duly authorized administrative agency conducting an investigation, audit, review or proceedings regarding a health care entity's conduct.

**5189** The provisions of this subsection shall apply to subpoen as for the health records of both minors and adults.

5191 Nothing in this subsection shall have any effect on the existing authority of a court or administrative
5192 agency to issue a protective order regarding health records, including, but not limited to, ordering the
5193 return of health records to a health care entity, after the period for filing a motion to quash has passed.

5194 A subpoena for substance abuse records must conform to the requirements of federal law found in 42 5195 C.F.R. Part 2, Subpart E.

**5196** I. Health care entities may testify about the health records of an individual in compliance with \$\$ 8.01-399 and 8.01-400.2.

5198 J. If an individual requests a copy of his health record from a health care entity, the health care 5199 entity may impose a reasonable cost-based fee, which shall include only the cost of supplies for and 5200 labor of copying the requested information, postage when the individual requests that such information 5201 be mailed, and preparation of an explanation or summary of such information as agreed to by the 5202 individual. For the purposes of this section, "individual" shall subsume a person with authority to act on 5203 behalf of the individual who is the subject of the health record in making decisions related to his health 5204 care.

**5205** § 32.1-127.1:04. Use or disclosure of certain protected health information required.

A. The coordination of prevention and control of disease, injury, or disability and the delivery of
health care benefits are hereby declared to be (i) necessary public health activities; (ii) necessary health
oversight activities for the integrity of the health care system; and (iii) necessary to prevent serious harm
and serious threats to the health and safety of individuals and the public.

5210 B. The Departments of Health, Medical Assistance Services, Mental Health, Mental 5211 RetardationIntellectual Disability and Substance Abuse Services, Rehabilitative Services, and Social 5212 Services, and the Departments for the Aging, the Blind and Vision Impaired, and the Deaf and 5213 Hard-of-Hearing, or any successors in interest thereof shall establish a secure system for sharing 5214 protected health information that may be necessary for the coordination of prevention and control of 5215 disease, injury, or disability and for the delivery of health care benefits when such protected information 5216 concerns individuals who (i) have contracted a reportable disease, including exposure to a toxic substance, as required by the Board of Health pursuant to § 32.1-35 or other disease or disability 5217 5218 required to be reported by law; (ii) are the subjects of public health surveillance, public health 5219 investigations, or public health interventions or are applicants for or recipients of medical assistance 5220 services; (iii) have been or are the victims of child abuse or neglect or domestic violence; or (iv) may 5221 present a serious threat to health or safety of a person or the public or may be subject to a serious threat to their health or safety. For the purposes of this section, "public health interventions" shall include the 5222

5223 services provided through the Department of Rehabilitative Services, and the Departments for the Aging, 5224 the Blind and Vision Impaired, and the Deaf and Hard-of-Hearing, or any successors in interest thereof.

5225 Pursuant to the regulations concerning patient privacy promulgated by the federal Department of 5226 Health and Human Services, covered entities may disclose protected health information to the secure 5227 system without obtaining consent or authorization for such disclosure. Such protected health information 5228 shall be used exclusively for the purposes established in this section.

5229 C. The Office of the Attorney General shall advise the Departments of Health, Medical Assistance 5230 Services, Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, 5231 Rehabilitative Services, and Social Services and the Departments for the Aging, the Blind and Vision 5232 Impaired, and the Deaf and Hard-of-Hearing, or any successors in interest thereof in the implementation 5233 of this section. 5234

§ 32.1-135.2. Offer or payment of remuneration in exchange for referral prohibited.

5235 No hospital licensed pursuant to this chapter shall knowingly and willfully offer or pay any 5236 remuneration directly or indirectly, in cash or in kind, to induce any practitioner of the healing arts or 5237 any clinical psychologist to refer an individual or individuals to such hospital. The Board shall adopt 5238 regulations as necessary to carry out the provisions of this section. Such regulations shall be developed 5239 in conjunction with the State Mental Health, Mental RetardationIntellectual Disability and Substance 5240 Abuse Services Board and shall be consistent with regulations adopted by such Board pursuant to 5241 § 37.2-420. Such regulations shall exclude from the definition of "remuneration" any payments, business 5242 arrangements, or payment practices not prohibited by 42 U.S.C. § 1320a, as amended, or any regulations 5243 promulgated pursuant thereto.

5244 § 32.1-276.3. Definitions.

5245 As used in this chapter: 5246

"Board" means the Board of Health.

5247 "Consumer" means any person (i) whose occupation is other than the administration of health activities or the provision of health services, (ii) who has no fiduciary obligation to a health care 5248 5249 institution or other health agency or to any organization, public or private, whose principal activity is an 5250 adjunct to the provision of health services, or (iii) who has no material financial interest in the rendering 5251 of health services.

5252 "Health care provider" means (i) a general hospital, ordinary hospital, outpatient surgical hospital, 5253 nursing home or certified nursing facility licensed or certified pursuant to Article 1 (§ 32.1-123 et seq.) 5254 of Chapter 5 of this title; (ii) a mental or psychiatric hospital licensed pursuant to Article 2 (§ 37.2-403 5255 et seq.) of Chapter 4 of Title 37.2; (iii) a hospital operated by the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services; (iv) a hospital operated by the 5256 University of Virginia or the Virginia Commonwealth University Health System Authority; (v) any 5257 5258 person licensed to practice medicine or osteopathy in the Commonwealth pursuant to Chapter 29 (§ 54.1-2900 et seq.) of Title 54.1; (vi) any person licensed to furnish health care policies or plans 5259 pursuant to Chapter 34 (§ 38.2-3400 et seq.), Chapter 42 (§ 38.2-4200), or Chapter 43 (§ 38.2-4300) of 5260 5261 Title 38.2; or (vii) any person licensed to practice dentistry pursuant to Chapter 27 (§ 54.1-2700 et seq.) of Title 54.1 who is registered with the Board of Dentistry as an oral and maxillofacial surgeon and 5262 5263 certified by the Board of Dentistry to perform certain procedures pursuant to § 54.1-2709.1. In no event 5264 shall such term be construed to include continuing care retirement communities which file annual 5265 financial reports with the State Corporation Commission pursuant to Chapter 49 (§ 38.2-4900 et seq.) of 5266 Title 38.2 or any nursing care facility of a religious body which depends upon prayer alone for healing.

"Health maintenance organization" means any person who undertakes to provide or to arrange for 5267 5268 one or more health care plans pursuant to Chapter 43 (§ 38.2-4300 et seq.) of Title 38.2.

"Inpatient hospital" means a hospital providing inpatient care and licensed pursuant to Article 1 5269 (§ 32.1-123 et seq.) of Chapter 5 of this title, a hospital licensed pursuant to Article 2 (§ 37.2-403 et 5270 5271 seq.) of Chapter 4 of Title 37.2, a hospital operated by the Department of Mental Health, Mental 5272 RetardationIntellectual Disability and Substance Abuse Services for the care and treatment of the 5273 mentally ill, or a hospital operated by the University of Virginia or the Virginia Commonwealth 5274 University Health System Authority.

5275 "Nonprofit organization" means a nonprofit, tax-exempt health data organization with the 5276 characteristics, expertise, and capacity to execute the powers and duties set forth for such entity in this 5277 chapter.

5278 'Oral and maxillofacial surgeon" means, for the purposes of this chapter, a person who is licensed to 5279 practice dentistry in Virginia, registered with the Board of Dentistry as an oral and maxillofacial 5280 surgeon, and certified to perform certain procedures pursuant to § 54.1-2709.1.

'Oral and maxillofacial surgeon's office" means a place (i) owned or operated by a licensed and 5281 5282 registered oral and maxillofacial surgeon who is certified to perform certain procedures pursuant to 5283 § 54.1-2709.1 or by a group of oral and maxillofacial surgeons, at least one of whom is so certified, 5284 practicing in any legal form whatsoever or by a corporation, partnership, limited liability company or

5285 other entity that employs or engages at least one oral and maxillofacial surgeon who is so certified, and
(ii) designed and equipped for the provision of oral and maxillofacial surgery services to ambulatory
5287 patients.

5288 "Outpatient surgery" means all surgical procedures performed on an outpatient basis in a general hospital, ordinary hospital, outpatient surgical hospital or other facility licensed or certified pursuant to Article 1 (§ 32.1-123 et seq.) of Chapter 5 of this title or in a physician's office or oral and maxillofacial surgeon's office, as defined above. Outpatient surgery refers only to those surgical procedure groups on which data are collected by the nonprofit organization as a part of a pilot study.

**5293** "Physician" means a person licensed to practice medicine or osteopathy in the Commonwealth pursuant to Chapter 29 (§ 54.1-2900 et seq.) of Title 54.1.

5295 "Physician's office" means a place (i) owned or operated by a licensed physician or group of
5296 physicians practicing in any legal form whatsoever or by a corporation, partnership, limited liability
5297 company or other entity that employs or engages physicians, and (ii) designed and equipped solely for
5298 the provision of fundamental medical care, whether diagnostic, therapeutic, rehabilitative, preventive or
5299 palliative, to ambulatory patients.

"Surgical procedure group" means at least five procedure groups, identified by the nonprofit organization designated pursuant to § 32.1-276.4 in compliance with regulations adopted by the Board, based on criteria that include, but are not limited to, the frequency with which the procedure is performed, the clinical severity or intensity, and the perception or probability of risk. The nonprofit organization shall form a technical advisory group consisting of members nominated by its Board of Directors' nominating organizations to assist in selecting surgical procedure groups to recommend to the Board for adoption.

5307 "System" means the Virginia Patient Level Data System.

**5308** § 32.1-276.8. Fees for processing, verification, and dissemination of data.

A. The Board shall prescribe a reasonable fee for each affected health care provider to cover the costs of the reasonable expenses of establishing and administering the methodology developed pursuant to § 32.1-276.7. The payment of such fees shall be at such time as the Board designates. The Board may assess a late charge on any fees paid after their due date.

5313 In addition, the Board shall prescribe a tiered-fee structure based on the number of enrollees for each health maintenance organization to cover the costs of collecting and making available such data. Such fees shall not exceed \$3,000 for each health maintenance organization required to provide information pursuant to this chapter. The payment of such fees shall also be at such time as the Board designates. The Board may also assess a late charge on any fees paid by health maintenance organizations after their due dates.

B. Except for the fees assessed pursuant to subsection A, the nonprofit organization providing
services pursuant to an agreement or contract as provided in § 32.1-276.4 shall not assess any fee
against any health care provider that submits data under this chapter that is processed, verified, and
timely in accordance with standards established by the Board. The Board shall establish penalties for
submission of data in a manner that is inconsistent with such standards.

5324 C. State agencies shall not be assessed fees for the submission of patient level data required by
5325 subsection C of § 32.1-276.6. Individual employers, insurers, and other organizations may voluntarily
5326 provide the nonprofit organization with outpatient data for processing, storage, and comparative analysis
5327 and shall be subject to fees negotiated with and charged by the nonprofit organization for services
5328 provided.

D. The nonprofit organization providing services pursuant to an agreement or contract with the
Commissioner of Health shall be authorized to charge and collect reasonable fees for the dissemination
of patient level data and Health Employer Data and Information Set (HEDIS) data or other approved
quality of care or performance information set data; however, the Commissioner of Health, the State
Corporation Commission, and the Commissioner of Mental Health, Mental RetardationIntellectual
Disability and Substance Abuse Services shall be entitled to receive relevant and appropriate data from
the nonprofit organization at no charge.

5336 E. The Board shall (i) maintain records of its activities; (ii) collect and account for all fees and
5337 deposit the moneys so collected into a special fund from which the expenses attributed to this chapter
5338 shall be paid; and (iii) enforce all regulations promulgated by it pursuant to this chapter.

**5339** § 32.1-283. Investigation of deaths; obtaining consent to removal of organs, etc.; fees.

A. Upon the death of any person from trauma, injury, violence, poisoning, accident, suicide or homicide, or suddenly when in apparent good health, or when unattended by a physician, or in jail, prison, other correctional institution or in police custody, or who is a patient or resident of a state mental health or mental retardationintellectual disability facility, or suddenly as an apparent result of fire, or in any suspicious, unusual or unnatural manner, or the sudden death of any infant less than eighteen months of age whose death is suspected to be attributable to Sudden Infant Death Syndrome

5346 (SIDS), the medical examiner of the county or city in which death occurs shall be notified by the 5347 physician in attendance, hospital, law-enforcement officer, funeral director or any other person having 5348 knowledge of such death. Good faith efforts shall be made by such person or institution having custody 5349 of the dead body to identify the next of kin of the decedent, and such identity, if determined, shall be 5350 provided to the Chief Medical Examiner upon transfer of the dead body. After identification of the next 5351 of kin, the person or institution, or agent of such person or institution, having custody of the dead body 5352 shall attempt to obtain consent for removal of the pituitary or other organs, glands, eyes or tissues for use in transplants or therapy. 5353

B. Upon being notified of a death as provided in subsection A, the medical examiner shall take 5354 5355 charge of the dead body, make an investigation into the cause and manner of death, reduce his findings 5356 to writing, and promptly make a full report to the Chief Medical Examiner. In order to facilitate his 5357 investigation, the medical examiner is authorized to inspect and copy the pertinent medical records of 5358 the decedent whose death he is investigating. Full directions as to the nature, character and extent of the 5359 investigation to be made in such cases shall be furnished each medical examiner by the Chief Medical 5360 Examiner, together with appropriate forms for the required reports and instructions for their use. The 5361 facilities and personnel under the Chief Medical Examiner shall be made available to medical examiners 5362 in such investigations. Reports and findings of the Medical Examiner shall be confidential and shall not 5363 under any circumstance be disclosed or made available for discovery pursuant to a court subpoena or 5364 otherwise, except as provided in this chapter. Nothing in this subsection shall prohibit the Chief Medical 5365 Examiner from releasing the cause or manner of death, or prohibit disclosure of reports or findings to 5366 the parties in a criminal case.

5367 C. A copy of each report pursuant to this section shall be delivered to the appropriate attorney for 5368 the Commonwealth and to the appropriate law-enforcement agency investigating the death. A copy of 5369 any such report regarding the death of a victim of a traffic accident shall be furnished upon request to 5370 the State Police and the Highway Safety Commission. In addition, a copy of any autopsy report concerning a patient or resident of a state mental health or mental retardationintellectual disability 5371 5372 facility shall be delivered to the Commissioner of Mental Health, Mental Retardation Intellectual 5373 Disability and Substance Abuse Services and to the Inspector General for Mental Health, Mental 5374 Retardation Intellectual Disability and Substance Abuse Services. A copy of any autopsy report 5375 concerning a prisoner committed to the custody of the Director of the Department of Corrections shall, 5376 upon request of the Director of the Department of Corrections, be delivered to the Director of the 5377 Department of Corrections. A copy of any autopsy report concerning a prisoner committed to any local 5378 correctional facility shall be delivered to the local sheriff or superintendent. Upon request, the Chief 5379 Medical Examiner shall release such autopsy report to the decedent's attending physician and to the personal representative or executor of the decedent or, if no personal representative or executor is 5380 5381 appointed, then at the discretion of the Chief Medical Examiner, to the following persons in the 5382 following order of priority: (i) the spouse of the decedent, (ii) an adult son or daughter of the decedent, 5383 (iii) either parent of the decedent, (iv) an adult sibling of the decedent, (v) any other adult relative of the 5384 decedent in order of blood relationship, or (vi) any appropriate health facility quality assurance program.

5385 D. For each investigation under this article, including the making of the required reports, the medical 5386 examiner shall receive a fee established by the Board within the limitations of appropriations for the 5387 purpose. Such fee shall be paid by the Commonwealth, if the deceased is not a legal resident of the 5388 county or city in which his death occurred. In the event the deceased is a legal resident of the county or 5389 city in which his death occurred, such county or city shall be responsible for the fee up to \$20. If the deceased is a patient or resident of a state mental health or mental retardationintellectual disability 5390 5391 facility, the fee shall be paid by the Department of Mental Health, Mental Retardation Intellectual 5392 Disability and Substance Abuse Services.

5393 E. Nothing herein shall be construed to interfere with the autopsy procedure or with the routine 5394 obtaining of consent for removal of organs as conducted by surgical teams or others.

5395 § 32.1-283.1. State Child Fatality Review Team established; membership; access to and maintenance
5396 of records; confidentiality; etc.

5397 A. There is hereby created the State Child Fatality Review Team, hereinafter referred to as the 5398 "Team," which shall develop and implement procedures to ensure that child deaths occurring in Virginia 5399 are analyzed in a systematic way. The Team shall review (i) violent and unnatural child deaths, (ii) 5400 sudden child deaths occurring within the first 18 months of life, and (iii) those fatalities for which the 5401 cause or manner of death was not determined with reasonable medical certainty. No child death review 5402 shall be initiated by the Team until conclusion of any law-enforcement investigation or criminal 5403 prosecution. The Team shall (i) develop and revise as necessary operating procedures for the review of 5404 child deaths, including identification of cases to be reviewed and procedures for coordination among the 5405 agencies and professionals involved, (ii) improve the identification, data collection, and record keeping 5406 of the causes of child death, (iii) recommend components for prevention and education programs, (iv) recommend training to improve the investigation of child deaths, and (v) provide technical assistance, 5407

5408 upon request, to any local child fatality teams that may be established. The operating procedures for the
5409 review of child deaths shall be exempt from the Administrative Process Act (§ 2.2-4000 et seq.)
5410 pursuant to subdivision 17 of subsection B of § 2.2-4002.

5411 B. The 16-member Team shall be chaired by the Chief Medical Examiner and shall be composed of 5412 the following persons or their designees: the Commissioner of the Department of Mental Health, Mental 5413 RetardationIntellectual Disability and Substance Abuse Services; the Director of Child Protective 5414 Services within the Department of Social Services; the Superintendent of Public Instruction; the State 5415 Registrar of Vital Records; and the Director of the Department of Criminal Justice Services. In addition, 5416 one representative from each of the following entities shall be appointed by the Governor to serve for a 5417 term of three years: local law-enforcement agencies, local fire departments, local departments of social 5418 services, the Medical Society of Virginia, the Virginia College of Emergency Physicians, the Virginia 5419 Pediatric Society, Virginia Sudden Infant Death Syndrome Alliance, local emergency medical services 5420 personnel, Commonwealth's attorneys, and community services boards.

5421 C. Upon the request of the Chief Medical Examiner in his capacity as chair of the Team, made after 5422 the conclusion of any law-enforcement investigation or prosecution, information and records regarding a 5423 child whose death is being reviewed by the Team may be inspected and copied by the Chief Medical 5424 Examiner or his designee, including, but not limited to, any report of the circumstances of the event 5425 maintained by any state or local law-enforcement agency or medical examiner, and information or 5426 records maintained on such child by any school, social services agency or court. Information, records or 5427 reports maintained by any Commonwealth's Attorney shall be made available for inspection and copying 5428 by the Chief Medical Examiner pursuant to procedures which shall be developed by the Chief Medical 5429 Examiner and the Commonwealth's Attorneys' Services Council established by § 2.2-2617. Any 5430 presentence report prepared pursuant to § 19.2-299 for any person convicted of a crime that led to the 5431 death of the child shall be made available for inspection and copying by the Chief Medical Examiner pursuant to procedures which shall be developed by the Chief Medical Examiner. In addition, the Chief 5432 5433 Medical Examiner may inspect and copy from any Virginia health care provider, on behalf of the Team, 5434 (i) without obtaining consent, the health and mental health records of the child and those perinatal 5435 medical records of the child's mother that related to such child and (ii) upon obtaining consent from 5436 each adult regarding his personal records, or from a parent regarding the records of a minor child, the 5437 health and mental health records of the child's family. All such information and records shall be 5438 confidential and shall be excluded from the Virginia Freedom of Information Act (§ 2.2-3700 et seq.) 5439 pursuant to subdivision 9 of § 2.2-3705.5. Upon the conclusion of the child death review, all information 5440 and records concerning the child and the child's family shall be shredded or otherwise destroyed by the 5441 Chief Medical Examiner in order to ensure confidentiality. Such information or records shall not be 5442 subject to subpoena or discovery or be admissible in any criminal or civil proceeding. If available from 5443 other sources, however, such information and records shall not be immune from subpoena, discovery or 5444 introduction into evidence when obtained through such other sources solely because the information and 5445 records were presented to the Team during a child death review. Further, the findings of the Team may 5446 be disclosed or published in statistical or other form which shall not identify individuals. The portions of meetings in which individual child death cases are discussed by the Team shall be closed pursuant to 5447 5448 subdivision A 21 of § 2.2-3711. In addition to the requirements of § 2.2-3712, all team members, 5449 persons attending closed team meetings, and persons presenting information and records on specific 5450 child deaths to the Team during closed meetings shall execute a sworn statement to honor the 5451 confidentiality of the information, records, discussions, and opinions disclosed during any closed meeting 5452 to review a specific child death. Violations of this subsection shall be punishable as a Class 3 5453 misdemeanor.

5454 D. Upon notification of a child death, any state or local government agency maintaining records on
5455 such child or such child's family which are periodically purged shall retain such records for the longer
5456 of 12 months or until such time as the State Child Fatality Review Team has completed its child death
5457 review of the specific case.

5458 E. The Team shall compile annual data which shall be made available to the Governor and the5459 General Assembly as requested. These statistical data compilations shall not contain any personally5460 identifying information and shall be public records.

§ 32.1-325. Board to submit plan for medical assistance services to Secretary of Health and HumanServices pursuant to federal law; administration of plan; contracts with health care providers.

A. The Board, subject to the approval of the Governor, is authorized to prepare, amend from time to
time and submit to the Secretary of the United States Department of Health and Human Services a state
plan for medical assistance services pursuant to Title XIX of the United States Social Security Act and
any amendments thereto. The Board shall include in such plan:

5467 1. A provision for payment of medical assistance on behalf of individuals, up to the age of 21, 5468 placed in foster homes or private institutions by private, nonprofit agencies licensed as child-placing 5469 agencies by the Department of Social Services or placed through state and local subsidized adoptions to 5470 the extent permitted under federal statute;

5471 2. A provision for determining eligibility for benefits for medically needy individuals which 5472 disregards from countable resources an amount not in excess of \$3,500 for the individual and an amount 5473 not in excess of \$3,500 for his spouse when such resources have been set aside to meet the burial 5474 expenses of the individual or his spouse. The amount disregarded shall be reduced by (i) the face value 5475 of life insurance on the life of an individual owned by the individual or his spouse if the cash surrender 5476 value of such policies has been excluded from countable resources and (ii) the amount of any other 5477 revocable or irrevocable trust, contract, or other arrangement specifically designated for the purpose of 5478 meeting the individual's or his spouse's burial expenses;

5479 3. A requirement that, in determining eligibility, a home shall be disregarded. For those medically 5480 needy persons whose eligibility for medical assistance is required by federal law to be dependent on the 5481 budget methodology for Aid to Families with Dependent Children, a home means the house and lot used 5482 as the principal residence and all contiguous property. For all other persons, a home shall mean the house and lot used as the principal residence, as well as all contiguous property, as long as the value of 5483 5484 the land, exclusive of the lot occupied by the house, does not exceed \$5,000. In any case in which the 5485 definition of home as provided here is more restrictive than that provided in the state plan for medical assistance services in Virginia as it was in effect on January 1, 1972, then a home means the house and 5486 5487 lot used as the principal residence and all contiguous property essential to the operation of the home 5488 regardless of value;

5489 4. A provision for payment of medical assistance on behalf of individuals up to the age of 21, who 5490 are Medicaid eligible, for medically necessary stays in acute care facilities in excess of 21 days per 5491 admission;

5492 5. A provision for deducting from an institutionalized recipient's income an amount for the 5493 maintenance of the individual's spouse at home;

5494 6. A provision for payment of medical assistance on behalf of pregnant women which provides for 5495 payment for inpatient postpartum treatment in accordance with the medical criteria outlined in the most 5496 current version of or an official update to the "Guidelines for Perinatal Care" prepared by the American 5497 Academy of Pediatrics and the American College of Obstetricians and Gynecologists or the "Standards 5498 for Obstetric-Gynecologic Services" prepared by the American College of Obstetricians and Gynecologists. Payment shall be made for any postpartum home visit or visits for the mothers and the 5499 5500 children which are within the time periods recommended by the attending physicians in accordance with 5501 and as indicated by such Guidelines or Standards. For the purposes of this subdivision, such Guidelines 5502 or Standards shall include any changes thereto within six months of the publication of such Guidelines 5503 or Standards or any official amendment thereto;

5504 7. A provision for the payment for family planning services on behalf of women who were 5505 Medicaid-eligible for prenatal care and delivery as provided in this section at the time of delivery. Such 5506 family planning services shall begin with delivery and continue for a period of 24 months, if the woman 5507 continues to meet the financial eligibility requirements for a pregnant woman under Medicaid. For the 5508 purposes of this section, family planning services shall not cover payment for abortion services and no 5509 funds shall be used to perform, assist, encourage or make direct referrals for abortions;

5510 8. A provision for payment of medical assistance for high-dose chemotherapy and bone marrow 5511 transplants on behalf of individuals over the age of 21 who have been diagnosed with lymphoma, breast cancer, myeloma, or leukemia and have been determined by the treating health care provider to have a 5512 5513 performance status sufficient to proceed with such high-dose chemotherapy and bone marrow transplant. 5514 Appeals of these cases shall be handled in accordance with the Department's expedited appeals process;

5515 9. A provision identifying entities approved by the Board to receive applications and to determine 5516 eligibility for medical assistance;

5517 10. A provision for breast reconstructive surgery following the medically necessary removal of a 5518 breast for any medical reason. Breast reductions shall be covered, if prior authorization has been 5519 obtained, for all medically necessary indications. Such procedures shall be considered noncosmetic; 5520

11. A provision for payment of medical assistance for annual pap smears;

5521 12. A provision for payment of medical assistance services for prostheses following the medically 5522 necessary complete or partial removal of a breast for any medical reason;

5523 13. A provision for payment of medical assistance which provides for payment for 48 hours of 5524 inpatient treatment for a patient following a radical or modified radical mastectomy and 24 hours of 5525 inpatient care following a total mastectomy or a partial mastectomy with lymph node dissection for treatment of disease or trauma of the breast. Nothing in this subdivision shall be construed as requiring 5526 5527 the provision of inpatient coverage where the attending physician in consultation with the patient 5528 determines that a shorter period of hospital stay is appropriate;

5529 14. A requirement that certificates of medical necessity for durable medical equipment and any 5530 supporting verifiable documentation shall be signed, dated, and returned by the physician, physician

5531 assistant, or nurse practitioner and in the durable medical equipment provider's possession within 60 5532 days from the time the ordered durable medical equipment and supplies are first furnished by the 5533 durable medical equipment provider;

5534 15. A provision for payment of medical assistance to (i) persons age 50 and over and (ii) persons 5535 age 40 and over who are at high risk for prostate cancer, according to the most recent published 5536 guidelines of the American Cancer Society, for one PSA test in a 12-month period and digital rectal 5537 examinations, all in accordance with American Cancer Society guidelines. For the purpose of this subdivision, "PSA testing" means the analysis of a blood sample to determine the level of prostate 5538 5539 specific antigen;

16. A provision for payment of medical assistance for low-dose screening mammograms for 5540 5541 determining the presence of occult breast cancer. Such coverage shall make available one screening 5542 mammogram to persons age 35 through 39, one such mammogram biennially to persons age 40 through 5543 49, and one such mammogram annually to persons age 50 and over. The term "mammogram" means an 5544 X-ray examination of the breast using equipment dedicated specifically for mammography, including but 5545 not limited to the X-ray tube, filter, compression device, screens, film and cassettes, with an average 5546 radiation exposure of less than one rad mid-breast, two views of each breast;

5547 17. A provision, when in compliance with federal law and regulation and approved by the Centers 5548 for Medicare & Medicaid Services (CMS), for payment of medical assistance services delivered to 5549 Medicaid-eligible students when such services qualify for reimbursement by the Virginia Medicaid 5550 program and may be provided by school divisions;

5551 18. A provision for payment of medical assistance services for liver, heart and lung transplantation 5552 procedures for individuals over the age of 21 years when (i) there is no effective alternative medical or 5553 surgical therapy available with outcomes that are at least comparable; (ii) the transplant procedure and 5554 application of the procedure in treatment of the specific condition have been clearly demonstrated to be medically effective and not experimental or investigational; (iii) prior authorization by the Department of 5555 5556 Medical Assistance Services has been obtained; (iv) the patient selection criteria of the specific 5557 transplant center where the surgery is proposed to be performed have been used by the transplant team 5558 or program to determine the appropriateness of the patient for the procedure; (v) current medical therapy 5559 has failed and the patient has failed to respond to appropriate therapeutic management; (vi) the patient is 5560 not in an irreversible terminal state; and (vii) the transplant is likely to prolong the patient's life and 5561 restore a range of physical and social functioning in the activities of daily living;

5562 19. A provision for payment of medical assistance for colorectal cancer screening, specifically 5563 screening with an annual fecal occult blood test, flexible sigmoidoscopy or colonoscopy, or in 5564 appropriate circumstances radiologic imaging, in accordance with the most recently published 5565 recommendations established by the American College of Gastroenterology, in consultation with the 5566 American Cancer Society, for the ages, family histories, and frequencies referenced in such 5567 recommendations; 5568

20. A provision for payment of medical assistance for custom ocular prostheses;

5569 21. A provision for payment for medical assistance for infant hearing screenings and all necessary 5570 audiological examinations provided pursuant to § 32.1-64.1 using any technology approved by the 5571 United States Food and Drug Administration, and as recommended by the national Joint Committee on 5572 Infant Hearing in its most current position statement addressing early hearing detection and intervention 5573 programs. Such provision shall include payment for medical assistance for follow-up audiological 5574 examinations as recommended by a physician, physician assistant, nurse practitioner, or audiologist and 5575 performed by a licensed audiologist to confirm the existence or absence of hearing loss;

5576 22. A provision for payment of medical assistance, pursuant to the Breast and Cervical Cancer 5577 Prevention and Treatment Act of 2000 (P.L. 106-354), for certain women with breast or cervical cancer 5578 when such women (i) have been screened for breast or cervical cancer under the Centers for Disease 5579 Control and Prevention (CDC) Breast and Cervical Cancer Early Detection Program established under 5580 Title XV of the Public Health Service Act; (ii) need treatment for breast or cervical cancer, including 5581 treatment for a precancerous condition of the breast or cervix; (iii) are not otherwise covered under 5582 creditable coverage, as defined in § 2701 (c) of the Public Health Service Act; (iv) are not otherwise 5583 eligible for medical assistance services under any mandatory categorically needy eligibility group; and 5584 (v) have not attained age 65. This provision shall include an expedited eligibility determination for such 5585 women;

5586 23. A provision for the coordinated administration, including outreach, enrollment, re-enrollment and 5587 services delivery, of medical assistance services provided to medically indigent children pursuant to this 5588 chapter, which shall be called Family Access to Medical Insurance Security (FAMIS) Plus and the 5589 FAMIS Plan program in § 32.1-351. A single application form shall be used to determine eligibility for 5590 both programs; and

5591 24. A provision, when authorized by and in compliance with federal law, to establish a public-private

5592 long-term care partnership program between the Commonwealth of Virginia and private insurance companies that shall be established through the filing of an amendment to the state plan for medical 5593 assistance services by the Department of Medical Assistance Services. The purpose of the program shall 5594 5595 be to reduce Medicaid costs for long-term care by delaying or eliminating dependence on Medicaid for 5596 such services through encouraging the purchase of private long-term care insurance policies that have 5597 been designated as qualified state long-term care insurance partnerships and may be used as the first 5598 source of benefits for the participant's long-term care. Components of the program, including the 5599 treatment of assets for Medicaid eligibility and estate recovery, shall be structured in accordance with 5600 federal law and applicable federal guidelines.

5601

B. In preparing the plan, the Board shall:

1. Work cooperatively with the State Board of Health to ensure that quality patient care is provided 5602 5603 and that the health, safety, security, rights and welfare of patients are ensured.

5604 2. Initiate such cost containment or other measures as are set forth in the appropriation act.

5605 3. Make, adopt, promulgate and enforce such regulations as may be necessary to carry out the 5606 provisions of this chapter.

4. Examine, before acting on a regulation to be published in the Virginia Register of Regulations 5607 5608 pursuant to § 2.2-4007.05, the potential fiscal impact of such regulation on local boards of social 5609 services. For regulations with potential fiscal impact, the Board shall share copies of the fiscal impact 5610 analysis with local boards of social services prior to submission to the Registrar. The fiscal impact 5611 analysis shall include the projected costs/savings to the local boards of social services to implement or 5612 comply with such regulation and, where applicable, sources of potential funds to implement or comply 5613 with such regulation.

5. Incorporate sanctions and remedies for certified nursing facilities established by state law, in 5614 accordance with 42 C.F.R. § 488.400 et seq. "Enforcement of Compliance for Long-Term Care Facilities 5615 5616 With Deficiencies.'

5617 6. On and after July 1, 2002, require that a prescription benefit card, health insurance benefit card, or 5618 other technology that complies with the requirements set forth in § 38.2-3407.4:2 be issued to each 5619 recipient of medical assistance services, and shall upon any changes in the required data elements set 5620 forth in subsection A of § 38.2-3407.4:2, either reissue the card or provide recipients such corrective 5621 information as may be required to electronically process a prescription claim.

5622 C. In order to enable the Commonwealth to continue to receive federal grants or reimbursement for 5623 medical assistance or related services, the Board, subject to the approval of the Governor, may adopt, 5624 regardless of any other provision of this chapter, such amendments to the state plan for medical 5625 assistance services as may be necessary to conform such plan with amendments to the United States Social Security Act or other relevant federal law and their implementing regulations or constructions of 5626 5627 these laws and regulations by courts of competent jurisdiction or the United States Secretary of Health 5628 and Human Services.

5629 In the event conforming amendments to the state plan for medical assistance services are adopted, the 5630 Board shall not be required to comply with the requirements of Article 2 (§ 2.2-4006 et seq.) of Chapter 5631 40 of Title 2.2. However, the Board shall, pursuant to the requirements of § 2.2-4002, (i) notify the Registrar of Regulations that such amendment is necessary to meet the requirements of federal law or 5632 5633 regulations or because of the order of any state or federal court, or (ii) certify to the Governor that the 5634 regulations are necessitated by an emergency situation. Any such amendments that are in conflict with 5635 the Code of Virginia shall only remain in effect until July 1 following adjournment of the next regular 5636 session of the General Assembly unless enacted into law. 5637

D. The Director of Medical Assistance Services is authorized to:

1. Administer such state plan and receive and expend federal funds therefor in accordance with 5638 5639 applicable federal and state laws and regulations; and enter into all contracts necessary or incidental to 5640 the performance of the Department's duties and the execution of its powers as provided by law.

5641 2. Enter into agreements and contracts with medical care facilities, physicians, dentists and other 5642 health care providers where necessary to carry out the provisions of such state plan. Any such agreement 5643 or contract shall terminate upon conviction of the provider of a felony. In the event such conviction is 5644 reversed upon appeal, the provider may apply to the Director of Medical Assistance Services for a new 5645 agreement or contract. Such provider may also apply to the Director for reconsideration of the 5646 agreement or contract termination if the conviction is not appealed, or if it is not reversed upon appeal.

5647 3. Refuse to enter into or renew an agreement or contract with any provider who has been convicted 5648 of a felony.

5649 4. Refuse to enter into or renew an agreement or contract with a provider who is or has been a 5650 principal in a professional or other corporation when such corporation has been convicted of a felony.

5651 E. In any case in which a Medicaid agreement or contract is denied to a provider on the basis of his interest in a convicted professional or other corporation, the Director shall, upon request, conduct a 5652 hearing in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) regarding the provider's 5653

5654 participation in the conduct resulting in the conviction.

5655 The Director's decision upon reconsideration shall be consistent with federal and state laws. The 5656 Director may consider the nature and extent of any adverse impact the agreement or contract denial or 5657 termination may have on the medical care provided to Virginia Medicaid recipients.

5658 F. When the services provided for by such plan are services which a marriage and family therapist, 5659 clinical psychologist, clinical social worker, professional counselor, or clinical nurse specialist is licensed 5660 to render in Virginia, the Director shall contract with any duly licensed marriage and family therapist, duly licensed clinical psychologist, licensed clinical social worker, licensed professional counselor or 5661 5662 licensed clinical nurse specialist who makes application to be a provider of such services, and thereafter shall pay for covered services as provided in the state plan. The Board shall promulgate regulations 5663 which reimburse licensed marriage and family therapists, licensed clinical psychologists, licensed clinical 5664 5665 social workers, licensed professional counselors and licensed clinical nurse specialists at rates based 5666 upon reasonable criteria, including the professional credentials required for licensure.

G. The Board shall prepare and submit to the Secretary of the United States Department of Health 5667 5668 and Human Services such amendments to the state plan for medical assistance services as may be 5669 permitted by federal law to establish a program of family assistance whereby children over the age of 18 5670 years shall make reasonable contributions, as determined by regulations of the Board, toward the cost of 5671 providing medical assistance under the plan to their parents.

5672 H. The Department of Medical Assistance Services shall:

5673 1. Include in its provider networks and all of its health maintenance organization contracts a 5674 provision for the payment of medical assistance on behalf of individuals up to the age of 21 who have 5675 special needs and who are Medicaid eligible, including individuals who have been victims of child abuse 5676 and neglect, for medically necessary assessment and treatment services, when such services are delivered 5677 by a provider which specializes solely in the diagnosis and treatment of child abuse and neglect, or a 5678 provider with comparable expertise, as determined by the Director.

5679 2. Amend the Medallion II waiver and its implementing regulations to develop and implement an 5680 exception, with procedural requirements, to mandatory enrollment for certain children between birth and 5681 age three certified by the Department of Mental Health, Mental RetardationIntellectual Disability and 5682 Substance Abuse Services as eligible for services pursuant to Part C of the Individuals with Disabilities 5683 Education Act (20 U.S.C. § 1471 et seq.).

5684 3. Utilize, to the extent practicable, electronic funds transfer technology for reimbursement to 5685 contractors and enrolled providers for the provision of health care services under Medicaid and the 5686 Family Access to Medical Insurance Security Plan established under § 32.1-351.

5687 I. The Director is authorized to negotiate and enter into agreements for services rendered to eligible 5688 recipients with special needs. The Board shall promulgate regulations regarding these special needs 5689 patients, to include persons with AIDS, ventilator-dependent patients, and other recipients with special 5690 needs as defined by the Board.

J. Except as provided in subdivision A 1 of § 2.2-4345, the provisions of the Virginia Public 5691 5692 Procurement Act (§ 2.2-4300 et seq.) shall not apply to the activities of the Director authorized by 5693 subsection I of this section. Agreements made pursuant to this subsection shall comply with federal law 5694 and regulation. 5695

§ 32.1-351.2. Children's Health Insurance Program Advisory Committee; purpose; membership; etc.

5696 The Department of Medical Assistance Services shall maintain a Children's Health Insurance Program 5697 Advisory Committee to assess the policies, operations, and outreach efforts for Family Access to 5698 Medical Insurance Security (FAMIS) and FAMIS Plus and to evaluate enrollment, utilization of services, 5699 and the health outcomes of children eligible for such programs. The Committee shall consist of no more 5700 than 20 members and shall include membership from appropriate entities, as follows: one representative of the Joint Commission on Health Care, the Department of Social Services, the Department of Health, 5701 5702 the Department of Education, the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, the Virginia Health Care Foundation, various provider associations and 5703 5704 children's advocacy groups; and other individuals with significant knowledge and interest in children's 5705 health insurance. The Committee may report on the current status of FAMIS and FAMIS Plus and make 5706 recommendations as deemed necessary to the Director of the Department of Medical Assistance Services 5707 and the Secretary of Health and Human Resources.

5708 The Department of Medical Assistance Services shall enter into agreements with the Department of 5709 Education and the Department of Health to identify children who are eligible for free or reduced price 5710 school lunches or for services through the Women, Infants, and Children program (WIC) in order that the eligibility of such children for the Virginia Plan for Title XXI of the Social Security Act may be 5711 5712 determined expeditiously.

5713 § 36-96.6. Certain restrictive covenants void; instruments containing such covenants.

5714 A. Any restrictive covenant and any related reversionary interest, purporting to restrict occupancy or 5733

ownership of property on the basis of race, color, religion, national origin, sex, elderliness, familial 5715 5716 status, or handicap, whether heretofore or hereafter included in an instrument affecting the title to real or leasehold property, are declared to be void and contrary to the public policy of this Commonwealth. 5717

B. Any person who is asked to accept a document affecting title to real or leasehold property may 5718 5719 decline to accept the same if it includes such a covenant or reversionary interest until the covenant or 5720 reversionary interest has been removed from the document. Refusal to accept delivery of an instrument 5721 for this reason shall not be deemed a breach of a contract to purchase, lease, mortgage, or otherwise 5722 deal with such property.

5723 C. No person shall solicit or accept compensation of any kind for the release or removal of any 5724 covenant or reversionary interest described in subsection A. Any person violating this subsection shall be 5725 liable to any person injured thereby in an amount equal to the greater of three times the compensation solicited or received, or \$500, plus reasonable attorneys' fees and costs incurred. 5726

5727 D. A family care home, foster home, or group home in which physically handicapped, mentally ill, 5728 mentally retarded, or developmentally disabled persons, or persons with mental illness or intellectual 5729 disability reside, with one or more resident counselors or other staff persons, shall be considered for all 5730 purposes residential occupancy by a single family when construing any restrictive covenant which 5731 purports to restrict occupancy or ownership of real or leasehold property to members of a single family 5732 or to residential use or structure.

§ 37.2-100. Definitions.

As used in this title, unless the context requires a different meaning:

5735 "Abuse" means any act or failure to act by an employee or other person responsible for the care of an individual in a facility or program operated, licensed, or funded by the Department, excluding those 5736 operated by the Department of Corrections, that was performed or was failed to be performed 5737 knowingly, recklessly, or intentionally, and that caused or might have caused physical or psychological 5738 5739 harm, injury, or death to a person receiving care or treatment for mental illness, mental retardationintellectual disability, or substance abuse. Examples of abuse include acts such as: 5740 5741

1. Rape, sexual assault, or other criminal sexual behavior;

2. Assault or battery:

3. Use of language that demeans, threatens, intimidates, or humiliates the person;

5744 4. Misuse or misappropriation of the person's assets, goods, or property; 5745

5. Use of excessive force when placing a person in physical or mechanical restraint;

5746 6. Use of physical or mechanical restraints on a person that is not in compliance with federal and 5747 state laws, regulations, and policies, professionally accepted standards of practice, or the person's 5748 individualized services plan; and

5749 7. Use of more restrictive or intensive services or denial of services to punish the person or that is 5750 not consistent with his individualized services plan.

"Administrative policy community services board" or "administrative policy board" means the public 5751 body organized in accordance with the provisions of Chapter 5 that is appointed by and accountable to 5752 5753 the governing body of each city and county that established it to set policy for and administer the 5754 provision of mental health, mental retardationintellectual disability, and substance abuse services. The 5755 "administrative policy community services board" or "administrative policy board" denotes the board, the members of which are appointed pursuant to § 37.2-501 with the powers and duties enumerated in 5756 5757 subsection A of § 37.2-504 and § 37.2-505. Mental health, mental retardationintellectual disability, and 5758 substance abuse services are provided through local government staff or through contracts with other 5759 organizations and providers.

5760 "Behavioral health authority" or "authority" means a public body and a body corporate and politic 5761 organized in accordance with the provisions of Chapter 6 that is appointed by and accountable to the governing body of the city or county that established it for the provision of mental health, mental 5762 retardationintellectual disability, and substance abuse services. "Behavioral health authority" or 5763 5764 "authority" also includes the organization that provides such services through its own staff or through 5765 contracts with other organizations and providers.

5766 "Board" means the State Mental Health, Mental RetardationIntellectual Disability and Substance 5767 Abuse Services Board.

"Commissioner" means the Commissioner of Mental Health, Mental RetardationIntellectual Disability 5768 5769 and Substance Abuse Services.

"Community services board" means the public body established pursuant to § 37.2-501 that provides 5770 5771 mental health, mental retardationintellectual disability, and substance abuse services within each city and county that established it; the term "community services board" shall include administrative policy 5772 5773 community services boards, operating community services boards, and local government departments 5774 with policy-advisory community services boards.

'Consumer" means a current direct recipient of public or private mental health, mental 5775 5776 retardationintellectual disability, or substance abuse treatment or habilitation services.

5777 "Department" means the Department of Mental Health, Mental RetardationIntellectual Disability and
5778 Substance Abuse Services.

5779 "Facility" means a state or licensed hospital, training center, psychiatric hospital, or other type of
5780 residential or outpatient mental health or mental retardation facility or a facility for persons with
5781 intellectual disability. When modified by the word "state," "facility" means a state hospital or training
5782 center operated by the Department, including the buildings and land associated with it.

5783 "Family member" means an immediate family member of a consumer or the principal caregiver of a consumer. A principal caregiver is a person who acts in the place of an immediate family member, including other relatives and foster care providers, but does not have a proprietary interest in the care of the consumer.

5787 "Hospital", when not modified by the words "state" or "licensed," means a state hospital or licensed5788 hospital that provides care and treatment for persons with mental illness.

5789 "Intellectual Disability" means a disability, originating before the age of 18 years, characterized
5790 concurrently by (i) significantly subaverage intellectual functioning as demonstrated by performance on
5791 a standardized measure of intellectual functioning, administered in conformity with accepted professional
5792 practice, that is at least two standard deviations below the mean and (ii) significant limitations in
5793 adaptive behavior as expressed in conceptual, social, and practical adaptive skills.

5794 "Licensed hospital" means a hospital or institution, including a psychiatric unit of a general hospital,5795 that is licensed pursuant to the provisions of this title.

5796 "Mental illness" means a disorder of thought, mood, emotion, perception, or orientation that
5797 significantly impairs judgment, behavior, capacity to recognize reality, or ability to address basic life
5798 necessities and requires care and treatment for the health, safety, or recovery of the individual or for the
5799 safety of others.

<sup>1</sup>Mental retardation" means a disability, originating before the age of 18 years, characterized concurrently by (i) significantly subaverage intellectual functioning as demonstrated by performance on a standardized measure of intellectual functioning, administered in conformity with accepted professional practice, that is at least two standard deviations below the mean and (ii) significant limitations in adaptive behavior as expressed in conceptual, social, and practical adaptive skills.

<sup>5805</sup> "Neglect" means failure by an individual or a program or facility operated, licensed, or funded by the
<sup>5806</sup> Department, excluding those operated by the Department of Corrections, responsible for providing
<sup>5807</sup> services to do so, including nourishment, treatment, care, goods, or services necessary to the health,
<sup>5808</sup> safety, or welfare of a person receiving care or treatment for mental illness, mental
<sup>5809</sup> retardationintellectual disability, or substance abuse.

"Operating community services board" or "operating board" means the public body organized in accordance with the provisions of Chapter 5 that is appointed by and accountable to the governing body of each city and county that established it for the direct provision of mental health, mental retardationintellectual disability, and substance abuse services. The "operating community services board" or "operating board" denotes the board, the members of which are appointed pursuant to \$37.2-501 with the powers and duties enumerated in subsection A of § 37.2-504 and § 37.2-505.
"Operating community services board" or "operating board" also includes the organization that provides such services, through its own staff or through contracts with other organizations and providers.

5818 "Performance contract" means the annual agreement negotiated and entered into by a community
5819 services board or behavioral health authority with the Department through which it provides state and
5820 federal funds appropriated for mental health, mental retardationintellectual disability, and substance
5821 abuse services to that community services board or behavioral health authority.

5822 "Policy-advisory community services board" or "policy-advisory board" means the public body 5823 organized in accordance with the provisions of Chapter 5 that is appointed by and accountable to the 5824 governing body of each city or county that established it to provide advice on policy matters to the local 5825 government department that provides mental health, mental retardationintellectual disability, and 5826 substance abuse services pursuant to subsection A of § 37.2-504 and § 37.2-505. The "policy-advisory 5827 community services board" or "policy-advisory board" denotes the board, the members of which are appointed pursuant to § 37.2-501 with the powers and duties enumerated in subsection B of § 37.2-504.

5829 "Service area" means the city or county or combination of cities and counties or cities
5830 that is served by a community services board or behavioral health authority or the cities and counties
5831 that are served by a state facility.

5832 "Special justice" means a person appointed by a chief judge of a judicial circuit for the purpose of5833 performing the duties of a judge pursuant to § 37.2-803.

5834 "State hospital" means a hospital, psychiatric institute, or other institution operated by the Department 5835 that provides care and treatment for persons with mental illness.

**5836** "Substance abuse" means the use of drugs, enumerated in the Virginia Drug Control Act (§ 54.1-3400 et seq.), without a compelling medical reason or alcohol that (i) results in psychological or

5838 physiological dependence or danger to self or others as a function of continued and compulsive use or 5839 (ii) results in mental, emotional, or physical impairment that causes socially dysfunctional or socially 5840 disordering behavior and (iii), because of such substance abuse, requires care and treatment for the 5841 health of the individual. This care and treatment may include counseling, rehabilitation, or medical or 5842 psychiatric care.

5843 "Training center" means a facility operated by the Department for the treatment, training, or 5844 habilitation of persons with mental retardationintellectual disability.

§ 37.2-200. State Mental Health, Intellectual Disability and Substance Abuse Services Board.

5846 A. The State Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services 5847 Board is established as a policy board, within the meaning of § 2.2-2100, in the executive branch of 5848 government. The Board shall consist of nine nonlegislative citizen members to be appointed by the Governor, subject to confirmation by the General Assembly. The nine members shall consist of one 5849 5850 consumer or former consumer, one family member of a consumer or former consumer, one consumer or 5851 former consumer or family member of a consumer or former consumer, one elected local government 5852 official, one psychiatrist licensed to practice in Virginia, and four citizens of the Commonwealth at 5853 large. The Governor, in appointing the psychiatrist member, may make his selection from nominations 5854 submitted by the Medical Society of Virginia in collaboration with the Psychiatric Society of Virginia 5855 and the Northern Virginia Chapter of the Washington Psychiatric Society.

5856 B. Appointments shall be made for terms of four years each, except appointments to fill vacancies 5857 that shall be for the unexpired terms of vacated appointments. Vacancies shall be filled in the same manner as the original appointments. All members may be reappointed. However, no member shall be 5858 5859 eligible to serve more than two four-year terms. The remainder of any term to which a member is 5860 appointed to fill a vacancy shall not constitute a term in determining the member's eligibility for 5861 reappointment. No person shall serve more than a total of 12 years. Members of the Board may be 5862 suspended or removed by the Governor at his pleasure.

5863 C. Members of the Board shall receive compensation for their services and shall be reimbursed for 5864 all reasonable and necessary expenses incurred in the performance of their duties as provided in 5865 §§ 2.2-2813 and 2.2-2825. The Board is authorized to employ a secretary to assist in the Board's 5866 administrative duties. The compensation of the secretary shall be fixed by the Board within the specific 5867 limits of the appropriation made therefor by the General Assembly, and the compensation shall be 5868 subject to the provisions of Chapter 29 (§ 2.2-2900 et seq.) of Title 2.2. The secretary shall perform the 5869 duties required of him by the Board. The Department and all other agencies of the Commonwealth shall 5870 provide assistance to the Board upon request.

5871 D. The main office of the Board shall be in the City of Richmond. The Board shall meet quarterly 5872 and at such other times as it deems proper. The Board shall elect a chairman and vice-chairman from among its membership. The meetings of the Board shall be held at the call of the chairman or whenever 5873 5874 the majority of the members so request. Five members shall constitute a quorum.

5875 E. The chairman of the Board shall submit to the Governor and the General Assembly an annual 5876 executive summary of the activity and work of the Board no later than the first day of each regular 5877 session of the General Assembly. The executive summary shall be submitted as provided in the 5878 procedures of the Division of Legislative Automated Systems for the processing of legislative documents 5879 and reports and shall be posted on the General Assembly's website. 5880

§ 37.2-203. Powers and duties of Board.

The Board shall have the following powers and duties:

5882 1. To develop and establish programmatic and fiscal policies governing the operation of state 5883 hospitals, training centers, community services boards, and behavioral health authorities;

5884 2. To ensure the development of long-range programs and plans for mental health, mental retardationintellectual disability, and substance abuse services provided by the Department, community 5885 5886 services boards, and behavioral health authorities;

5887 3. To review and comment on all budgets and requests for appropriations for the Department prior to 5888 their submission to the Governor and on all applications for federal funds;

5889 4. To monitor the activities of the Department and its effectiveness in implementing the policies of 5890 the Board:

5891 5. To advise the Governor, Commissioner, and General Assembly on matters relating to mental 5892 health, mental retardationintellectual disability, and substance abuse;

5893 6. To adopt regulations that may be necessary to carry out the provisions of this title and other laws 5894 of the Commonwealth administered by the Commissioner or the Department;

5895 7. To ensure the development of programs to educate citizens about and elicit public support for the 5896 activities of the Department, community services boards, and behavioral health authorities;

5897 8. To ensure that the Department assumes the responsibility for providing for education and training 5898 of school-age consumers in state facilities, pursuant to § 37.2-312; and

5899 9. To change the names of state facilities.

5900 Prior to the adoption, amendment, or repeal of any regulation regarding substance abuse services, the 5901 Board shall, in addition to the procedures set forth in the Administrative Process Act (§ 2.2-4000 et 5902 seq.), present the proposed regulation to the Substance Abuse Services Council, established pursuant to 5903 § 2.2-2696, at least 30 days prior to the Board's action for the Council's review and comment.

5904 § 37.2-204. Appointments to state and local human rights committees.

5905 The Board shall appoint a state human rights committee that shall appoint local human rights 5906 committees to address alleged violations of consumers' human rights. One-third of the appointments 5907 made to the state or local human rights committees shall be current or former consumers or family 5908 members of current or former consumers, with at least two consumers who are receiving or who have 5909 received within five years of their initial appointment public or private mental health, mental 5910 retardationintellectual disability, or substance abuse treatment or habilitation services on each committee. 5911 In addition, at least one appointment to the state and each local human rights committee shall be a health care provider. Remaining appointments shall include lawyers and persons with interest, 5912 5913 knowledge, or training in the mental health, mental retardationintellectual disability, or substance abuse 5914 field. No current employee of the Department, a community services board, or a behavioral health 5915 authority shall serve as a member of the state human rights committee. No current employee of the 5916 Department, a community services board, a behavioral health authority, or any facility, program, or 5917 organization licensed or funded by the Department or funded by a community services board or 5918 behavioral health authority shall serve as a member of any local human rights committee that serves an 5919 oversight function for the employing facility, program, or organization.

5920 § 37.2-300. Creation and supervision of Department.

5921 The Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 5922 Services is hereby established in the executive branch of government responsible to the Governor. The 5923 Department shall be under the supervision and management of the Commissioner. The Commissioner 5924 shall carry out his management and supervisory responsibilities in accordance with the policies and 5925 regulations of the Board and applicable federal and state statutes and regulations. 5926

§ 37.2-303. Qualifications of Commissioner.

The Commissioner shall be a person of proven executive and administrative ability and shall have 5927 5928 had appropriate education and substantial experience in the fields of mental health, mental 5929 retardationintellectual disability, or substance abuse.

5930 § 37.2-306. Research into causes of mental illness, intellectual disabilities, substance abuse, and 5931 related subjects.

5932 The Commissioner is hereby directed to promote research into the causes of mental illness, mental 5933 retardationintellectual disability, and substance abuse throughout the Commonwealth. The Commissioner 5934 shall encourage the directors of the state facilities and their staffs in the investigation of all subjects 5935 relating to mental illness, mental retardationintellectual disability, and substance abuse. In these research 5936 programs, the Commissioner shall make use, insofar as practicable, of the services and facilities of 5937 medical schools and the hospitals allied with them.

5938 § 37.2-315. Comprehensive State Plan for mental health, intellectual disabilities, and substance abuse 5939 services.

5940 The Department, in consultation with community services boards, behavioral health authorities, state 5941 hospitals and training centers, consumers, consumers' families, advocacy organizations, and other 5942 interested parties, shall develop and update biennially a six-year Comprehensive State Plan for mental 5943 health, mental retardationintellectual disability, and substance abuse services. The Comprehensive State 5944 Plan shall identify the needs of and the resource requirements for providing services and supports to 5945 persons with mental illness, mental retardationintellectual disability, or substance abuse across the 5946 Commonwealth and shall propose strategies to address these needs. The Comprehensive State Plan shall 5947 be used in the development of the Department's biennial budget submission to the Governor.

5948

§ 37.2-316. System restructuring; state and community consensus and planning team required.

5949 A. For the purpose of considering any restructuring of the system of mental health services involving 5950 an existing state hospital, the Commissioner shall establish a state and community consensus and 5951 planning team consisting of Department staff and representatives of the localities served by the state 5952 hospital, including local government officials, consumers, family members of consumers, advocates, state 5953 hospital employees, community services boards, behavioral health authorities, public and private service 5954 providers, licensed hospitals, local health department staff, local social services department staff, sheriffs' 5955 office staff, area agencies on aging, and other interested persons. In addition, the members of the House 5956 of Delegates and the Senate representing the localities served by the affected state hospital may serve on 5957 the state and community consensus and planning team for that state hospital. Each state and community 5958 consensus and planning team, in collaboration with the Commissioner, shall develop a plan that 5959 addresses (i) the types, amounts, and locations of new and expanded community services that would be 5960 needed to successfully implement the closure or conversion of the state hospital to any use other than

5961 the provision of mental health services, including a six-year projection of the need for inpatient 5962 psychiatric beds and related community mental health services; (ii) the development of a detailed 5963 implementation plan designed to build community mental health infrastructure for current and future 5964 capacity needs; (iii) the creation of new and enhanced community services prior to the closure of the 5965 state hospital or its conversion to any use other than the provision of mental health services; (iv) the 5966 transition of state hospital consumers to community services in the locality of their residence prior to 5967 admission or the locality of their choice after discharge; (v) the resolution of issues relating to the 5968 restructuring implementation process, including employment issues involving state hospital employee 5969 transition planning and appropriate transitional benefits; and (vi) a six-year projection comparing the cost 5970 of the current structure and the proposed structure. 5971

B. The Commissioner shall ensure that each plan includes the following components:

5972 1. A plan for community education;

5973 2. A plan for the implementation of required community services, including state-of-the-art practice 5974 models and any models required to meet the unique characteristics of the area to be served, which may 5975 include models for rural areas;

5976 3. A plan for assuring the availability of adequate staff in the affected communities, including 5977 specific strategies for transferring qualified state hospital employees to community services;

5978 4. A plan for assuring the development, funding, and implementation of individualized discharge 5979 plans pursuant to § 37.2-505 for individuals discharged as a result of the closure or conversion of the 5980 state hospital to any use other than the provision of mental health services; and

5981 5. A provision for suspending implementation of the plan if the total general funds appropriated to 5982 the Department for state hospital and community services decrease in any year of plan implementation 5983 by more than 10 percent from the year in which the plan was approved by the General Assembly.

5984 C. At least nine months prior to any proposed state hospital closure or conversion of the state 5985 hospital to any use other than the provision of mental health services, the state and community 5986 consensus and planning team shall submit a plan to the Joint Commission on Health Care and the 5987 Governor for review and recommendation.

5988 D. The Joint Commission on Health Care shall make a recommendation to the General Assembly on 5989 the plan no later than six months prior to the date of the proposed closure or conversion of the state 5990 hospital to any use other than the provision of mental health services.

5991 E. Upon approval of the plan by the General Assembly and the Governor, the Commissioner shall 5992 ensure that the plan components required by subsection B are in place and may thereafter perform all 5993 tasks necessary to implement the closure or conversion of the state hospital to any use other than the 5994 provision of mental health services.

5995 F. Any funds saved by the closure or conversion of the state hospital to any use other than the 5996 provision of mental health services and not allocated to individualized services plans for consumers 5997 being transferred or discharged as a result of the closure or conversion of the state hospital to any use 5998 other than the provision of mental health services shall be invested in the Mental Health, Mental 5999 RetardationIntellectual Disability, and Substance Abuse Services Trust Fund established in Article 4 6000 (§ 37.2-317 et seq.) of this chapter.

G. Nothing in this section shall prevent the Commissioner from leasing unused, vacant space to any 6001 6002 public or private organization. 6003

§ 37.2-317. Definitions.

As used in this article, unless the context requires a different meaning:

"Assets" means the buildings and land of state facilities operated by the Department.

"Fund" means the Mental Health, Mental RetardationIntellectual Disability, and Substance Abuse 6006 **6007** Services Trust Fund.

6008 "Net proceeds" means the gross amount received by the seller on account of the sale of any assets (i) 6009 less costs incurred on behalf of the seller in connection with such sale and (ii), if after the sale the sold 6010 assets will be used by an entity other than a state agency or instrumentality or a local governmental 6011 entity in a governmental activity and debt obligations financed any portion of the sold assets and any 6012 amount of such obligations is outstanding at the time of the sale, less the amount necessary to provide 6013 for the payment or redemption of the portion of such outstanding obligations that financed the sold 6014 assets, which amount shall be used to pay or redeem such obligations or shall be transferred to the third 6015 party issuer of the obligations for a use permitted in accordance with such obligations.

6016 37.2-318. Mental Health, Intellectual Disability, and Substance Abuse Services Trust Fund established; purpose. 6017

6018 There is hereby created in the state treasury a special nonreverting fund to be known as the Mental 6019 Health, Mental RetardationIntellectual Disability, and Substance Abuse Services Trust Fund to enhance and ensure for the coming years the quality of care and treatment provided to consumers of public 6020 mental health, mental retardationintellectual disability, and substance abuse services. The Fund shall be 6021 6022 established on the books of the Comptroller. Notwithstanding the provisions of § 2.2-1156, the Fund

6023 shall consist of the net proceeds of the sale of vacant buildings and land held by the Department. The 6024 Fund shall also consist of such moneys as shall be appropriated by the General Assembly and any 6025 private donations. Interest earned on moneys in the Fund shall remain in the Fund and be credited to it. 6026 Any moneys remaining in the Fund, including interest thereon, at the end of each fiscal year shall not 6027 revert to the general fund but shall remain in the Fund. Moneys in the Fund shall be used solely for the 6028 purposes set forth in this article. Expenditures and disbursements from the Fund shall be made by the 6029 State Treasurer on warrants issued by the Comptroller upon written request signed by the Commissioner. 6030 § 37.2-319. Administration of Mental Health, Intellectual Disability, and Substance Abuse Services

**6030** § 57.2-519. Administration of Mental Health, Intellectual Disability, and Substance Abuse Services **6031** Trust Fund.

6032 The Fund shall be administered by the Commissioner. Moneys in the Fund shall be used solely to 6033 provide mental health, mental retardationintellectual disability, and substance abuse services to enhance 6034 and ensure the quality of care and treatment provided by the Commonwealth to persons with mental 6035 illness, mental retardationintellectual disability, or substance abuse. Notwithstanding any other provision 6036 of law, the net proceeds from the sale of any vacant buildings and land shall first be used to (i) deliver 6037 mental health, mental retardationintellectual disability, and substance abuse services within the same 6038 service area where the sold buildings and land were located to ensure the same level of mental health, 6039 mental retardationintellectual disability, and substance abuse services as before the sale and (ii) provide 6040 benefits to those persons who were employees of the Commonwealth and, as a result of the sale, are no 6041 longer employed by the Commonwealth or are otherwise negatively affected by the sale. Benefits shall 6042 include appropriate transitional benefits.

**6043** § 37.2-403. Definitions.

6044 As used in this article, unless the context requires a different meaning:

6045 "Brain injury" is any injury to the brain that occurs after birth, but before age 65, that is acquired
6046 through traumatic or non-traumatic insults. Non-traumatic insults may include, but are not limited to
6047 anoxia, hypoxia, aneurysm, toxic exposure, encephalopathy, surgical interventions, tumor and stroke.
6048 Brain injury does not include hereditary, congenital or degenerative brain disorders, or injuries induced
6049 by birth trauma.

"Provider" means any person, entity, or organization, excluding an agency of the federal government 6050 6051 by whatever name or designation, that delivers (i) services to persons with mental illness, mental 6052 retardationintellectual disability, or substance abuse, (ii) services to persons who receive day support, 6053 in-home support, or crisis stabilization services funded through the Individual and Families 6054 Developmental Disabilities Support Waiver, (iii) services to persons under the Brain Injury Waiver, or 6055 (iv) residential services for persons with brain injury. The person, entity, or organization shall include a 6056 hospital as defined in § 32.1-123, community services board, behavioral health authority, private 6057 provider, and any other similar or related person, entity, or organization. It shall not include any 6058 individual practitioner who holds a license issued by a health regulatory board of the Department of 6059 Health Professions or who is exempt from licensing pursuant to § 54.1-3501, 54.1-3601, or 54.1-3701. 6060 "Service or services" means:

6061 1. Planned individualized interventions intended to reduce or ameliorate mental illness, mental 6062 retardationintellectual disability, or substance abuse through care, treatment, training, habilitation, or 6063 other supports that are delivered by a provider to individuals with mental illness, mental retardationintellectual disability, or substance abuse. Services include outpatient services, intensive 6064 6065 in-home services, opioid treatment services, inpatient psychiatric hospitalization, community 6066 gero-psychiatric residential services, assertive community treatment, and other clinical services; day support, day treatment, partial hospitalization, psychosocial rehabilitation, and habilitation services; case 6067 6068 management services; and supportive residential, special school, halfway house, and other residential 6069 services;

6070 2. Day support, in-home support, and crisis stabilization services provided to individuals under the6071 Individual and Families Developmental Disabilities Support Waiver; and

6072 3. Planned individualized interventions intended to reduce or ameliorate the effects of brain injury
6073 through care, treatment, or other supports provided under the Brain Injury Waiver or in residential
6074 services for persons with brain injury.

**6075** § 37.2-409. Intermediate care facilities for persons with intellectual disabilities.

6076 The Board may adopt regulations specifying the maximum number of consumers to be served by any intermediate care facility for the mentally retarded *persons with intellectual disability*.

**6078** § 37.2-416. Background checks required.

A. As used in this section, the term "direct consumer care position" means any position that includes
responsibility for (i) treatment, case management, health, safety, development, or well-being of a
consumer or (ii) immediately supervising a person in a position with this responsibility.

6082 As used in this section, "hire for compensated employment" does not include (i) a promotion from 6083 one adult substance abuse treatment position to another such position within the same licensee licensed

6084 pursuant to this article or (ii) new employment in an adult substance abuse treatment position in another 6085 office or program licensed pursuant to this article if the person employed prior to July 1, 1999, in a 6086 licensed program had no convictions in the five years prior to the application date for employment. As used in this section, "hire for compensated employment" includes (a) a promotion or transfer from an **6087** adult substance abuse treatment position to any mental health or mental retardationintellectual disability 6088 6089 services direct consumer care position within the same licensee licensed pursuant to this article or (b) 6090 new employment in any mental health or mental retardationintellectual disability services direct 6091 consumer care position in another office or program of the same licensee licensed pursuant to this article 6092 for which the person has previously worked in an adult substance abuse treatment position.

B. Every provider licensed pursuant to this article shall require any applicant who accepts
employment in any direct consumer care position to submit to fingerprinting and provide personal
descriptive information to be forwarded through the Central Criminal Records Exchange to the Federal
Bureau of Investigation (FBI) for the purpose of obtaining national criminal history record information
regarding the applicant. Except as otherwise provided in subsections C or E, no provider licensed
pursuant to this article shall hire for compensated employment persons who have been convicted of any
offense listed in subsection B of § 37.2-314.

6100 The Central Criminal Records Exchange, upon receipt of an individual's record or notification that no 6101 record exists, shall submit a report to the requesting authorized officer or director of a provider licensed 6102 pursuant to this article. If any applicant is denied employment because of information appearing on the 6103 criminal history record and the applicant disputes the information upon which the denial was based, the Central Criminal Records Exchange shall, upon written request, furnish to the applicant the procedures 6104 6105 for obtaining a copy of the criminal history record from the FBI. The information provided to the 6106 authorized officer or director of a provider licensed pursuant to this article shall not be disseminated 6107 except as provided in this section.

6108 C. Notwithstanding the provisions of subsection B, a provider may hire for compensated employment 6109 at adult substance abuse treatment facilities a person who was convicted of a misdemeanor violation relating to (i) unlawful hazing, as set out in § 18.2-56; or (ii) reckless handling of a firearm, as set out 6110 in § 18.2-56.1; or any misdemeanor or felony violation related to (a) reckless endangerment of others by 6111 throwing objects, as set out in § 18.2-51.3; (b) threat, as set out in § 18.2-60; (c) breaking and entering a 6112 6113 dwelling house with intent to commit other misdemeanor, as set out in § 18.2-92; or (d) possession of burglarious tools, as set out in § 18.2-94; or any felony violation relating to the distribution of drugs, as 6114 set out in Article 1 (§ 18.2-247 et seq.) of Chapter 7 of Title 18.2, except an offense pursuant to 6115 subsections H 1 and H 2 of § 18.2-248; or an equivalent offense in another state, if the hiring provider 6116 determines, based upon a screening assessment, that the criminal behavior was substantially related to 6117 the applicant's substance abuse and that the person has been successfully rehabilitated and is not a risk 6118 6119 to consumers based on his criminal history background and his substance abuse history.

6120 D. The hiring provider and a screening contractor designated by the Department shall screen 6121 applicants who meet the criteria set forth in subsection C to assess whether the applicants have been rehabilitated successfully and are not a risk to consumers based on their criminal history backgrounds 6122 6123 and substance abuse histories. To be eligible for such screening, the applicant shall have completed all 6124 prison or jail terms, shall not be under probation or parole supervision, shall have no pending charges in 6125 any locality, shall have paid all fines, restitution, and court costs for any prior convictions, and shall 6126 have been free of parole or probation for at least five years for all convictions. In addition to any 6127 supplementary information the provider or screening contractor may require or the applicant may wish to 6128 present, the applicant shall provide to the screening contractor a statement from his most recent 6129 probation or parole officer, if any, outlining his period of supervision and a copy of any pre-sentencing 6130 or post-sentencing report in connection with the felony conviction. The cost of this screening shall be 6131 paid by the applicant, unless the licensed provider decides to pay the cost.

E. Notwithstanding the provisions of subsection B, a provider may hire for compensated employment
persons who have been convicted of not more than one misdemeanor offense under § 18.2-57 or
18.2-57.2, if 10 years have elapsed following the conviction, unless the person committed the offense
while employed in a direct consumer care position.

6136 F. Providers licensed pursuant to this article also shall require, as a condition of employment for all applicants, written consent and personal information necessary to obtain a search of the registry of founded complaints of child abuse and neglect that is maintained by the Department of Social Services
6139 pursuant to § 63.2-1515.

6140 G. The cost of obtaining the criminal history record and search of the child abuse and neglect 6141 registry record shall be borne by the applicant, unless the provider licensed pursuant to this article 6142 decides to pay the cost.

6143 H. A person who complies in good faith with the provisions of this section shall not be liable for any civil damages for any act or omission in the performance of duties under this section unless the act or omission was the result of gross negligence or willful misconduct.

6146 § 37.2-423. Office created; appointment of Inspector General for Mental Health, Intellectual 6147 Disability and Substance Abuse Services.

There is hereby created the Office of Inspector General for Mental Health, Mental 6148 6149 RetardationIntellectual Disability and Substance Abuse Services to inspect, monitor, and review the 6150 quality of services provided in state facilities and by providers as defined in § 37.2-403, including 6151 licensed mental health treatment units in state correctional facilities. The Inspector General shall be 6152 appointed by the Governor, subject to confirmation by the General Assembly, and shall report to the 6153 Governor. The Inspector General shall be appointed initially for a term that expires one full year 6154 following the end of the Governor's term of office, and, thereafter, the term shall be for four years. 6155 Vacancies shall be filled by appointment by the Governor for the unexpired term and shall be effective 6156 until 30 days after the next meeting of the ensuing General Assembly and, if confirmed, thereafter for 6157 the remainder of the term.

6158 § 37.2-500. Purpose; community services board; services to be provided.

6159 The Department, for the purposes of establishing, maintaining, and promoting the development of 6160 mental health, mental retardationintellectual disability, and substance abuse services in the Commonwealth, may provide funds to assist any city or county or any combinations of cities or counties 6161 6162 or cities and counties in the provision of these services. Every county or city shall establish a 6163 community services board by itself or in any combination with other cities and counties, unless it 6164 establishes a behavioral health authority pursuant to Chapter 6 (§ 37.2-600 et seq.) of this title. Every 6165 county or city or any combination of cities and counties that has established a community services 6166 board, in consultation with that board, shall designate it as an operating community services board, an 6167 administrative policy community services board or a local government department with a policy-advisory 6168 community services board. The governing body of each city or county that established the community 6169 services board may change this designation at any time by ordinance. In the case of a community 6170 services board established by more than one city or county, the decision to change this designation shall be the unanimous decision of all governing bodies. 6171

6172 The core of services provided by community services boards within the cities and counties that they 6173 serve shall include emergency services and, subject to the availability of funds appropriated for them, 6174 case management services. The core of services may include a comprehensive system of inpatient, 6175 outpatient, day support, residential, prevention, early intervention, and other appropriate mental health, 6176 mental retardationintellectual disability, and substance abuse services necessary to provide individualized 6177 services and supports to persons with mental illnesses, mental retardationintellectual disability, or 6178 substance abuse.

6179 In order to provide comprehensive mental health, mental retardationintellectual disability, and 6180 substance abuse services within a continuum of care, the community services board shall function as the 6181 single point of entry into publicly funded mental health, mental retardationintellectual disability, and 6182 substance abuse services. 6183

§ 37.2-504. Community services boards; local government departments; powers and duties.

6184 A. Every operating and administrative policy community services board and local government 6185 department with a policy-advisory board shall have the following powers and duties:

6186 1. Review and evaluate public and private community mental health, mental retardationintellectual 6187 disability, and substance abuse services and facilities that receive funds from it and advise the governing 6188 body of each city or county that established it as to its findings.

6189 2. Pursuant to § 37.2-508, submit to the governing body of each city or county that established it an 6190 annual performance contract for community mental health, mental retardationintellectual disability, and 6191 substance abuse services for its approval prior to submission of the contract to the Department.

6192 3. Within amounts appropriated for this purpose, provide services authorized under the performance 6193 contract.

6194 4. In accordance with its approved performance contract, enter into contracts with other providers for 6195 the delivery of services or operation of facilities.

6196 5. In the case of operating and administrative policy boards, make policies or regulations concerning 6197 the delivery of services and operation of facilities under its direction or supervision, subject to applicable 6198 policies and regulations adopted by the Board.

6199 6. In the case of an operating board, appoint an executive director of community mental health, 6200 mental retardationintellectual disability, and substance abuse services, who meets the minimum 6201 qualifications established by the Department, and prescribe his duties. The compensation of the executive director shall be fixed by the operating board within the amounts made available by appropriation for 6202 6203 this purpose. The executive director shall serve at the pleasure of the operating board and be employed 6204 under an annually renewable contract that contains performance objectives and evaluation criteria. For an operating board, the Department shall approve the selection of the executive director for adherence to 6205 minimum qualifications established by the Department and the salary range of the executive director. In 6206

6207 the case of an administrative policy board, the board shall participate with local government in the 6208 appointment and annual performance evaluation of an executive director of community mental health, mental retardationintellectual disability, and substance abuse services, who meets the minimum 6209 qualifications established by the Department, and prescribe his duties. The compensation of the executive 6210 director shall be fixed by local government in consultation with the administrative policy board within 6211 6212 the amounts made available by appropriation for this purpose. In the case of a local government 6213 department with a policy-advisory board, the director of the local government department shall serve as the executive director. The policy-advisory board shall participate in the selection and the annual 6214 performance evaluation of the executive director, who meets the minimum qualifications established by 6215 6216 the Department. The compensation of the executive director shall be fixed by local government in 6217 consultation with the policy-advisory board within the amounts made available by appropriation for this purpose. 6218

6219 7. Prescribe a reasonable schedule of fees for services provided by personnel or facilities under the 6220 jurisdiction or supervision of the board and establish procedures for the collection of those fees. All fees 6221 collected shall be included in the performance contract submitted to the local governing body or bodies 6222 pursuant to subdivision 2 of this section and § 37.2-508 and shall be used only for community mental 6223 health, mental retardationintellectual disability, and substance abuse purposes. Every board shall institute 6224 a reimbursement system to maximize the collection of fees from persons receiving services under its 6225 jurisdiction or supervision, consistent with the provisions of § 37.2-511, and from responsible third party 6226 payors. Boards shall not attempt to bill or collect fees for time spent participating in commitment 6227 hearings for involuntary admissions pursuant to Article 5 (§ 37.2-814 et seq.) of Chapter 8.

8. Accept or refuse gifts, donations, bequests, or grants of money or property from any source and utilize them as authorized by the governing body of each city or county that established it.

6230 9. Seek and accept funds through federal grants. In accepting federal grants, the board shall not bind6231 the governing body of any city or county that established it to any expenditures or conditions of6232 acceptance without the prior approval of the governing body.

6233 10. Notwithstanding any provision of law to the contrary, disburse funds appropriated to it in
6234 accordance with such regulations as may be established by the governing body of each city or county
6235 that established it.

6236 11. Apply for and accept loans as authorized by the governing body of each city or county that6237 established it.

6238 12. Develop joint written agreements, consistent with policies adopted by the Board, with local
6239 school divisions; health departments; boards of social services; housing agencies, where they exist;
6240 courts; sheriffs; area agencies on aging; and regional Department of Rehabilitative Services offices. The
6241 agreements shall specify the services to be provided to consumers. All participating agencies shall
6242 develop and implement the agreements and shall review the agreements annually.

6243 13. Develop and submit to the Department the necessary information for the preparation of the
6244 Comprehensive State Plan for mental health, mental retardationintellectual disability, and substance
6245 abuse services pursuant to § 37.2-315.

6246 14. Take all necessary and appropriate actions to maximize the involvement and participation of
6247 consumers and family members of consumers in policy formulation and services planning, delivery, and
6248 evaluation.

6249 15. Institute, singly or in combination with other community services boards or behavioral health
6250 authorities, a dispute resolution mechanism that is approved by the Department and enables consumers
6251 and family members of consumers to resolve concerns, issues, or disagreements about services without
6252 adversely affecting their access to or receipt of appropriate types and amounts of current or future
6253 services from the community services board.

6254 16. Notwithstanding the provisions of § 37.2-400 or any regulations adopted thereunder, release data and information about individual consumers to the Department so long as the Department implements procedures to protect the confidentiality of that data and information.

6257 17. In the case of administrative policy boards and local government departments with
6258 policy-advisory boards, carry out other duties and responsibilities as assigned by the governing body of
6259 each city or county that established it.

6260 18. In the case of operating boards, have authority, notwithstanding any provision of law to the contrary, to receive state and federal funds directly from the Department and act as its own fiscal agent, when authorized to do so by the governing body of each city or county that established it.

6263 By local agreement between the administrative policy board and the governing body of the city or
6264 county that established it, additional responsibilities may be carried out by the local government,
6265 including personnel or financial management. In the case of an administrative policy board established
6266 by more than one city or county, the cities and counties shall designate which local government shall
6267 assume these responsibilities.

B. Every policy-advisory community services board, with staff support provided by the director of

6269 the local government department, shall have the following powers and duties:

6270 1. Advise the local government regarding policies or regulations for the delivery of services and 6271 operation of facilities by the local government department, subject to applicable policies and regulations 6272 adopted by the Board.

6273 2. Review and evaluate the operations of the local government department and advise the local 6274 governing body of each city or county that established it as to its findings.

6275 3. Review the community mental health, mental retardationintellectual disability, and substance abuse 6276 services provided by the local government department and advise the local governing body of each city 6277 or county that established it as to its findings.

4. Review and comment on the annual performance contract, performance reports, and 6278 6279 Comprehensive State Plan information developed by the local government department. The board's 6280 comments shall be attached to the performance contract, performance reports, and Comprehensive State 6281 Plan information prior to their submission to the local governing body of each city or county that 6282 established it and to the Department.

6283 5. Advise the local government as to the necessary and appropriate actions to maximize the 6284 involvement and participation of consumers and family members of consumers in policy formulation and services planning, delivery, and evaluation. 6285

6286 6. Participate in the selection and the annual performance evaluation of the local government 6287 department director employed by the city or county.

6288 7. Carry out other duties and responsibilities as assigned by the governing body of each city or 6289 county that established it. 6290

§ 37.2-505. Coordination of services for preadmission screening and discharge planning.

A. The community services board shall fulfill the following responsibilities:

6291

6292 1. Be responsible for coordinating the community services necessary to accomplish effective preadmission screening and discharge planning for persons referred to the community services board. When preadmission screening reports are required by the court on an emergency basis pursuant to 6293 6294 6295 Article 5 (§ 37.2-814 et seq.) of Chapter 8, the community services board shall ensure the development 6296 of the report for the court. To accomplish this coordination, the community services board shall establish 6297 a structure and procedures involving staff from the community services board and, as appropriate, 6298 representatives from (i) the state hospital or training center serving the board's service area, (ii) the local 6299 department of social services, (iii) the health department, (iv) the Department of Rehabilitative Services 6300 office in the board's service area, (v) the local school division, and (vi) other public and private human 6301 services agencies, including licensed hospitals.

6302 2. Provide preadmission screening services prior to the admission for treatment pursuant to 6303 § 37.2-805 or Article 5 (§ 37.2-814 et seq.) of Chapter 8 of any person who requires emergency mental 6304 health services while in a city or county served by the community services board.

6305 3. Provide, in consultation with the appropriate state hospital or training center, discharge planning 6306 for any person who, prior to admission, resided in a city or county served by the community services 6307 board or who chooses to reside after discharge in a city or county served by the board and who is to be 6308 released from a state hospital or training center pursuant to § 37.2-837. The discharge plan shall be 6309 completed prior to the person's discharge. The plan shall be prepared with the involvement and 6310 participation of the consumer or his representative and must reflect the consumer's preferences to the 6311 greatest extent possible. The plan shall include the mental health, mental retardation intellectual disability, 6312 substance abuse, social, educational, medical, employment, housing, legal, advocacy, transportation, and 6313 other services that the consumer will need upon discharge into the community and identify the public or 6314 private agencies that have agreed to provide these services.

6315 No person shall be discharged from a state hospital or training center without completion by the 6316 community services board of the discharge plan described in this subdivision. If state hospital or training 6317 center staff identify a consumer as ready for discharge and the community services board that is 6318 responsible for the person's care disagrees, the community services board shall document in the 6319 treatment plan within 30 days of the person's identification any reasons for not accepting the person for 6320 discharge. If the state hospital or training center disagrees with the community services board and the 6321 board refuses to develop a discharge plan to accept the person back into the community, the state 6322 hospital or training center or the community services board shall ask the Commissioner to review the 6323 state hospital's or training center's determination that the person is ready for discharge in accordance 6324 with procedures established by the Department in collaboration with state hospitals, training centers, and 6325 community services boards. If the Commissioner determines that the person is ready for discharge, a 6326 discharge plan shall be developed by the Department to ensure the availability of adequate services for 6327 the consumer and the protection of the community. The Commissioner also shall verify that sufficient 6328 state-controlled funds have been allocated to the community services board through the performance 6329 contract. If sufficient state-controlled funds have been allocated, the Commissioner may contract with a

6330 private provider, another community services board, or a behavioral health authority to deliver the
6331 services specified in the discharge plan and withhold allocated funds applicable to that consumer's
6332 discharge plan from the community services board in accordance with subsections C and E of
6333 § 37.2-508.

B. The community services board may perform the functions set out in subdivision A 1 in the case
of children by referring them to the locality's family assessment and planning team and by cooperating
with the community policy and management team in the coordination of services for troubled youths
and their families. The community services board may involve the family assessment and planning team
and the community policy and management team, but it remains responsible for performing the
functions set out in subdivisions A 2 and A 3 in the case of children.

6340 § 37.2-506. Background checks required.

6341 A. As used in this section, the term "direct consumer care position" means any position that includes
6342 responsibility for (i) treatment, case management, health, safety, development, or well-being of a
6343 consumer or (ii) immediately supervising a person in a position with this responsibility.

6344 As used in this section, "hire for compensated employment" does not include (i) a promotion from 6345 one adult substance abuse treatment position to another such position within the same community 6346 services board or (ii) new employment in an adult substance abuse treatment position in another office 6347 or program of the same community services board if the person employed prior to July 1, 1999, had no 6348 convictions in the five years prior to the application date for employment. As used in this section, "hire 6349 for compensated employment" includes (a) a promotion or transfer from an adult substance abuse 6350 treatment position to any mental health or mental retardationintellectual disability service direct 6351 consumer care position within the same community services board or (b) new employment in any 6352 mental health or mental retardationintellectual disability service direct consumer care position in another 6353 office or program of the same community services board for which the person has previously worked in 6354 an adult substance abuse treatment position.

B. Every community services board shall require any applicant who accepts employment in any direct consumer care position with the community services board to submit to fingerprinting and provide personal descriptive information to be forwarded through the Central Criminal Records Exchange to the Federal Bureau of Investigation (FBI) for the purpose of obtaining national criminal history record information regarding the applicant. Except as otherwise provided in subsections C or E, no community services board shall hire for compensated employment persons who have been convicted of any offense listed in subsection B of § 37.2-314.

The Central Criminal Records Exchange, upon receipt of an individual's record or notification that no 6362 record exists, shall submit a report to the requesting executive director or personnel director of the 6363 community services board. If any applicant is denied employment because of information appearing on 6364 6365 the criminal history record and the applicant disputes the information upon which the denial was based, the Central Criminal Records Exchange shall, upon written request, furnish to the applicant the 6366 6367 procedures for obtaining a copy of the criminal history record from the FBI. The information provided to the executive director or personnel director of any community services board shall not be 6368 disseminated except as provided in this section. 6369

6370 C. Notwithstanding the provisions of subsection B, the community services board may hire for 6371 compensated employment at adult substance abuse treatment programs a person who was convicted of a 6372 misdemeanor violation relating to (i) unlawful hazing, as set out in § 18.2-56; or (ii) reckless handling 6373 of a firearm, as set out in § 18.2-56.1; or any misdemeanor or felony violation related to (a) reckless 6374 endangerment of others by throwing objects, as set out in § 18.2-51.3; (b) threat, as set out in § 18.2-60; 6375 (c) breaking and entering a dwelling house with intent to commit other misdemeanor, as set out in 6376 § 18.2-92; or (d) possession of burglarious tools, as set out in § 18.2-94; or any felony violation relating 6377 to the distribution of drugs, as set out in Article 1 (§ 18.2-247 et seq.) of Chapter 7 of Title 18.2, except 6378 an offense pursuant to subsections H 1 or H 2 of § 18.2-248; or an equivalent offense in another state, if 6379 the hiring community services board determines, based upon a screening assessment, that the criminal 6380 behavior was substantially related to the applicant's substance abuse and that the person has been 6381 successfully rehabilitated and is not a risk to consumers based on his criminal history background and 6382 his substance abuse history.

6383 D. The community services board and a screening contractor designated by the Department shall 6384 screen applicants who meet the criteria set forth in subsection C to assess whether the applicants have 6385 been rehabilitated successfully and are not a risk to consumers based on their criminal history 6386 backgrounds and substance abuse histories. To be eligible for such screening, the applicant shall have 6387 completed all prison or jail terms, shall not be under probation or parole supervision, shall have no 6388 pending charges in any locality, shall have paid all fines, restitution, and court costs for any prior convictions, and shall have been free of parole or probation for at least five years for all convictions. In 6389 6390 addition to any supplementary information the community services board or screening contractor may 6391 require or the applicant may wish to present, the applicant shall provide to the screening contractor a statement from his most recent probation or parole officer, if any, outlining his period of supervisionand a copy of any pre-sentencing or post-sentencing report in connection with the felony conviction. Thecost of this screening shall be paid by the applicant, unless the board decides to pay the cost.

E. Notwithstanding the provisions of subsection B, a community services board may hire for compensated employment persons who have been convicted of not more than one misdemeanor offense under § 18.2-57 or 18.2-57.2, if 10 years have elapsed following the conviction, unless the person committed the offense while employed in a direct consumer care position.

6399 F. Community services boards also shall require, as a condition of employment for all applicants,
6400 written consent and personal information necessary to obtain a search of the registry of founded
6401 complaints of child abuse and neglect that is maintained by the Department of Social Services pursuant
6402 to § 63.2-1515.

6403 G. The cost of obtaining the criminal history record and search of the child abuse and neglect 6404 registry record shall be borne by the applicant, unless the community services board decides to pay the 6405 cost.

6406 H. A person who complies in good faith with the provisions of this section shall not be liable for any civil damages for any act or omission in the performance of duties under this section unless the act or omission was the result of gross negligence or willful misconduct.

**6409** § 37.2-508. Performance contract for mental health, intellectual disability, and substance abuse **6410** services.

6411 A. The Department shall develop and initiate negotiation of the performance contracts through which 6412 it provides funds to community services boards to accomplish the purposes set forth in this chapter. In 6413 the case of operating boards, the Department may, notwithstanding any provision of law to the contrary, 6414 disburse state and federal funds appropriated to it for mental health, mental retardationintellectual 6415 disability, or substance abuse services directly to the operating board, when that operating board is 6416 authorized by the governing body of each city or county that established it to receive such funds. Six 6417 months prior to the beginning of each fiscal year, the Department shall make available to the public the 6418 standard performance contract form that it intends to use as the performance contract for that fiscal year 6419 and solicit public comments for a period of 60 days.

6420 B. Any community services board may apply for the assistance provided in this chapter by 6421 submitting annually to the Department its proposed performance contract for the next fiscal year together 6422 with (i) the approval of its board of directors for operating and administrative policy boards or the 6423 comments of the local government department's policy-advisory board and (ii) the approval of the 6424 contract by formal vote of the governing body of each city or county that established it. The community 6425 services board shall make its proposed performance contract available for public review and solicit 6426 public comments for a period of 30 days prior to submitting its proposed contract for the approval of its 6427 board of directors for operating and administrative policy boards or the comments of the local 6428 government department's policy-advisory board. To avoid disruptions in service continuity and allow 6429 sufficient time to complete public review and comment about the contract and negotiation and approval 6430 of the contract, the Department may provide up to six semi-monthly payments of state-controlled funds 6431 to the community services board. If the governing body of each city or county does not approve the 6432 proposed performance contract by September 30 of each year, the performance contract shall be deemed 6433 approved.

6434 C. The performance contract shall (i) delineate the responsibilities of the Department and the 6435 community services board; (ii) specify conditions that must be met for the receipt of state-controlled 6436 funds; (iii) identify the groups of consumers to be served with state-controlled funds; (iv) contain 6437 specific consumer outcome, provider performance, consumer satisfaction, and consumer and family 6438 member participation and involvement measures; (v) contain mechanisms that have been identified or 6439 developed jointly by the Department and community services board and that will be employed 6440 collaboratively by the community services board and the state hospital to manage the utilization of state 6441 hospital beds; (vi) establish an enforcement mechanism, should a community services board fail to be in 6442 substantial compliance with its performance contract, including notice and appeal processes and 6443 provisions for remediation, withholding or reducing funds, methods of repayment of funds, and the 6444 Department's exercise of the provisions of subsection E; and (vii) include reporting requirements and 6445 revenue, cost, service, and consumer information displayed in a consistent, comparable format 6446 determined by the Department.

6447 The Department may provide for performance monitoring in order to determine whether the community services boards are in substantial compliance with their performance contracts.

6449 D. No community services board shall be eligible to receive state-controlled funds for mental health,
6450 mental retardationintellectual disability, or substance abuse services after September 30 of each year
6451 unless (i) its performance contract has been approved by the governing body of each city or county that
6452 established it and by the Department; (ii) it provides service, cost, revenue, and aggregate and individual

6453 consumer data and information, notwithstanding the provisions of § 37.2-400 or any regulations adopted 6454 thereunder, to the Department in the format prescribed by the Department; and (iii) it uses standardized 6455 cost accounting and financial management practices approved by the Department.

E. If, after unsuccessful use of a remediation process described in the performance contract, a 6456 community services board remains in substantial noncompliance with its performance contract with the 6457 6458 Department, the Department may, after affording the community services board an adequate opportunity 6459 to use the appeal process described in the performance contract, terminate all or a portion of the contract. Using the state-controlled resources associated with that contract, the Department, after 6460 6461 consulting with the governing body of each city or county that established the board, may negotiate a 6462 performance contract with another board, a behavioral health authority, or a private nonprofit or 6463 for-profit organization or organizations to obtain services that were the subject of the terminated 6464 performance contract.

6465 § 37.2-509. Mental health, intellectual disability, and substance abuse services; allocation of funds by 6466 Department; reduction of funds.

A. At the beginning of each fiscal year, the Department shall allocate available state-controlled funds 6467 6468 to community services boards for disbursement in accordance with procedures established by the Department and performance contracts approved by the Department. Allocations of state-controlled funds 6469 6470 to each community services board shall be determined by the Department, after careful consideration of 6471 all of the following factors:

6472 1. The total amounts of state-controlled funds appropriated for this purpose;

6473 2. Previous allocations of state-controlled funds to each community services board;

6474 3. Requirements or conditions attached to appropriations of state-controlled funds by the General 6475 Assembly, the Governor, or federal granting authorities;

4. Community services board input about the uses of and methodologies for allocating existing and 6476 6477 new state-controlled funds; and

6478 5. Other relevant and appropriate considerations.

6479 Allocations to any community services board for operating expenses, including salaries and other costs, or the construction of facilities shall not exceed 90 percent of the total amount of state and local 6480 matching funds provided for these expenses or such construction, unless a waiver is granted by the 6481 6482 Department pursuant to policy adopted by the Board.

6483 B. The Department shall notify the governing body of each city or county that established the 6484 community services board before implementing any reduction of state-controlled funds. Before any city 6485 or county reduces local government matching funds, it shall notify its community services board and the 6486 Department.

C. All fees collected by the community services board shall be included in its performance contract 6487 6488 and retained and used by the board for mental health, mental retardationintellectual disability, and 6489 substance abuse purposes. 6490

§ 37.2-600. Definitions.

6491

6503

As used in this chapter, unless the context requires a different meaning:

6492 "Behavioral health" means the full range of mental health, mental retardation intellectual disability, 6493 and substance abuse services and treatment modalities.

"Behavioral health authority board of directors" means the public body organized in accordance with 6494 6495 provisions of this chapter that is appointed by and accountable to the governing body of the city or 6496 county that established it.

6497 "Behavioral health project" means any facility suitable for providing adequate care for concentrated 6498 centers of population and includes structures, buildings, improvements, additions, extensions, 6499 replacements, appurtenances, lands, rights in land, franchises, machinery, equipment, furnishings, 6500 landscaping, approaches, roadways, and other necessary or desirable facilities.

"Member" means a person appointed by the governing body of a city or county to the behavioral 6501 6502 health authority board of directors.

§ 37.2-601. Behavioral health authorities; purpose.

6504 The Department, for the purposes of establishing, maintaining, and promoting the development of behavioral health services in the Commonwealth, may provide funds to assist certain cities or counties in 6505 6506 the provision of these services.

6507 The governing body of the Cities of Virginia Beach or Richmond or the County of Chesterfield may 6508 establish a behavioral health authority and shall declare its intention to do so by resolution.

6509 The behavioral health services provided by behavioral health authorities within the cities or counties 6510 they serve shall include emergency services and, subject to the availability of funds appropriated for them, case management services. The behavioral health services may include a comprehensive system of 6511 6512 inpatient, outpatient, day support, residential, prevention, early intervention, and other appropriate mental health, mental retardationintellectual disability, and substance abuse services necessary to provide 6513 6514 individualized services and supports to persons with mental illnesses, mental retardationintellectual

6515 *disability*, or substance abuse.

6516 In order to provide comprehensive mental health, mental retardationintellectual disability, and
6517 substance abuse services within a continuum of care, the behavioral health authority shall function as the single point of entry into publicly funded mental health, mental retardationintellectual disability, and
6519 substance abuse services.

**6520** § 37.2-605. Behavioral health authorities; powers and duties.

6521 Every authority shall be deemed to be a public instrumentality, exercising public and essential
6522 governmental functions to provide for the public mental health, welfare, convenience, and prosperity of
6523 the residents and such other persons who might be served by the authority and to provide behavioral
6524 health services to those residents and persons. An authority shall have the following powers and duties:

6525

 Review and evaluate public and private community mental health, mental retardationintellectual
 6526 disability, and substance abuse services and facilities that receive funds from the authority and advise
 6527 the governing body of the city or county that established it as to its findings.

6528 2. Pursuant to § 37.2-608, submit to the governing body of the city or county that established the
6529 authority an annual performance contract for community mental health, mental retardationintellectual
6530 disability, and substance abuse services for its approval prior to submission of the contract to the
6531 Department.

6532 3. Within amounts appropriated for this purpose, provide services authorized under the performance contract.

4. In accordance with its approved performance contract, enter into contracts with other providers for the delivery of services or operation of facilities.

5. Make and enter into all other contracts or agreements as the authority may determine that are
necessary or incidental to the performance of its duties and to the execution of powers granted by this
chapter, including contracts with any federal agency, any subdivision or instrumentality of the
Commonwealth, behavioral health providers, insurers, and managed care or health care networks on such
terms and conditions as the authority may approve.

6541 6. Make policies or regulations concerning the delivery of services and operation of facilities under 6542 its direction or supervision, subject to applicable policies and regulations adopted by the Board.

6543 7. Appoint a chief executive officer of the behavioral health authority, who meets the minimum 6544 qualifications established by the Department, and prescribe his duties. The compensation of the chief 6545 executive officer shall be fixed by the authority within the amounts made available by appropriation for 6546 this purpose. The chief executive officer shall serve at the pleasure of the authority's board of directors 6547 and be employed under an annually renewable contract that contains performance objectives and 6548 evaluation criteria. The Department shall approve the selection of the chief executive officer for 6549 adherence to minimum qualifications established by the Department and the salary range of the chief 6550 executive officer.

**6551** 8. Authorize the chief executive officer to maintain a complement of professional staff to operate the behavioral health authority's service delivery system.

6553 9. Prescribe a reasonable schedule of fees for services provided by personnel or facilities under the 6554 jurisdiction or supervision of the authority and establish procedures for the collection of those fees. All 6555 fees collected shall be included in the performance contract submitted to the local governing body 6556 pursuant to subdivision 2 of this section and § 37.2-608 and shall be used only for community mental health, mental retardationintellectual disability, and substance abuse purposes. Every authority shall 6557 institute a reimbursement system to maximize the collection of fees from persons receiving services 6558 6559 under the jurisdiction or supervision of the authority, consistent with the provisions of § 37.2-612, and 6560 from responsible third party payors. Authorities shall not attempt to bill or collect fees for time spent 6561 participating in commitment hearings for involuntary admissions pursuant to Article 5 (§ 37.2-814 et 6562 seq.) of Chapter 8.

6563 10. Accept or refuse gifts, donations, bequests, or grants of money or property or other assistance
6564 from the federal government, the Commonwealth, any municipality thereof, or any other sources, public
6565 or private; utilize them to carry out any of its purposes; and enter into any agreement or contract
6566 regarding or relating to the acceptance, use, or repayment of any such grant or assistance.

6567 11. Seek and accept funds through federal grants. In accepting federal grants, the authority shall not6568 bind the governing body of the city or county that established it to any expenditures or conditions of6569 acceptance without the prior approval of that governing body.

**6570** 12. Notwithstanding any provision of law to the contrary, disburse funds appropriated to it in accordance with applicable regulations.

6572 13. Apply for and accept loans in accordance with regulations established by the board of directors.

6573 14. Develop joint written agreements, consistent with policies adopted by the Board, with local
6574 school divisions; health departments; local boards of social services; housing agencies, where they exist;
6575 courts; sheriffs; area agencies on aging; and regional Department of Rehabilitative Services offices. The

agreements shall specify the services to be provided to consumers. All participating agencies shalldevelop and implement the agreements and shall review the agreements annually.

6578 15. Develop and submit to the Department the necessary information for the preparation of the
6579 Comprehensive State Plan for mental health, mental retardationintellectual disability, and substance
6580 abuse services pursuant to § 37.2-315.

6581 16. Take all necessary and appropriate actions to maximize the involvement and participation of
6582 consumers and family members of consumers in policy formulation and service planning, delivery, and
6583 evaluation.

17. Institute, singly or in combination with community services boards or other behavioral health
authorities, a dispute resolution mechanism that is approved by the Department and enables consumers
and family members of consumers to resolve concerns, issues, or disagreements about services without
adversely affecting their access to or receipt of appropriate types and amounts of current or future
services from the authority.

6589 18. Notwithstanding the provisions of § 37.2-400 and regulations adopted thereunder, release data and
6590 information about individual consumers to the Department, so long as the Department implements
6591 procedures to protect the confidentiality of that data and information. Every authority shall submit data
6592 on children and youth in the same manner as community services boards, as set forth in § 37.2-507.

6593 19. Fulfill all other duties and be subject to applicable provisions specified in the Code of Virginia6594 pertaining to community services boards.

**6595** 20. Make loans and provide other assistance to corporations, partnerships, associations, joint ventures, or other entities in carrying out any activities authorized by this chapter.

6597 21. Transact its business, locate its offices and control, directly or through stock or nonstock
6598 corporations or other entities, facilities that will assist the authority in carrying out the purposes and
6599 intent of this chapter, including without limitations the power to own or operate, directly or indirectly,
6600 behavioral health facilities in its service area.

6601 22. Acquire property, real or personal, by purchase, gift, or devise on such terms and conditions and
in such manner as it may deem proper and such rights, easements, or estates therein as may be
6603 necessary for its purposes and sell, lease, and dispose of the same or any portion thereof or interest
therein, whenever it shall become expedient to do so.

6605 23. Participate in joint ventures with individuals, corporations, partnerships, associations, or other entities for providing behavioral health care or related services or other activities that the authority may undertake to the extent that such undertakings assist the authority in carrying out the purposes and intent of this chapter.

6609 24. Conduct or engage in any lawful business, activity, effort, or project that is necessary or6610 convenient for the purposes of the authority or for the exercise of any of its powers.

6611 25. As a public instrumentality, establish and operate its administrative management infrastructure in
6612 whole or in part independent of the local governing body; however, nothing in the chapter precludes
6613 behavioral health authorities from acquiring support services through existing governmental entities.

6614 26. Carry out capital improvements and bonding through existing economic or industrial development 6615 authorities.

6616 27. Establish retirement, group life insurance, and group accident and sickness insurance plans or systems for its employees in the same manner as cities, counties, and towns are permitted to do under § 51.1-801.

6619 28. Provide an annual report to the Department of the authority's activities.

6620 29. Ensure a continuation of all consumer services during any transition period.

**6621** § 37.2-608. Performance contract for mental health, intellectual disability, and substance abuse services.

A. The Department shall develop and initiate negotiation of the performance contracts through which 6623 6624 it provides funds to behavioral health authorities to accomplish the purposes set forth in this chapter. 6625 The Department may, notwithstanding any provision of law to the contrary, disburse state and federal 6626 funds appropriated to it for mental health, mental retardationintellectual disability, and substance abuse **6627** services directly to the behavioral health authority. Six months prior to the beginning of each fiscal year, 6628 the Department shall make available to the public the standard performance contract form that it intends 6629 to use as the performance contract for that fiscal year and solicit public comments for a period of 60 6630 days.

B. Any behavioral health authority may apply for the assistance provided in this chapter by
submitting annually to the Department its proposed performance contract for the next fiscal year together
with the approval of its board of directors and the approval by formal vote of the governing body of the
city or county that established it. The behavioral health authority shall make its proposed performance
contract available for public review and solicit public comments for a period of 30 days prior to
submitting its proposed contract for the approval of its board of directors. To avoid disruptions in
service continuity and allow sufficient time to complete public review and comment about the contract

6638 and negotiation and approval of the contract, the Department may provide up to six semi-monthly 6639 payments of state-controlled funds to the authority. If the governing body of the city or county does not 6640 approve the proposed performance contract by September 30 of each year, the performance contract 6641 shall be deemed approved.

6642 C. The performance contract shall (i) delineate the responsibilities of the Department and the 6643 behavioral health authority; (ii) specify conditions that must be met for the receipt of state-controlled 6644 funds; (iii) identify the groups of consumers to be served with state-controlled funds; (iv) contain 6645 specific consumer, provider performance, consumer satisfaction, and consumer and family member 6646 participation and involvement measures; (v) contain mechanisms that have been identified or developed 6647 jointly by the Department and the behavioral health authority and that will be employed collaboratively 6648 by the behavioral health authority and the state hospital to manage the utilization of state hospital beds; 6649 (vi) establish an enforcement mechanism, should the behavioral health authority fail to be in substantial compliance with its performance contract, including notice and appeal processes and provisions for remediation, withholding or reducing funds, methods of repayment of funds, and the Department's 6650 6651 6652 exercise of the provisions of subsection E; and (vii) include reporting requirements and revenue, cost, 6653 service, and consumer information displayed in a consistent, comparable format determined by the 6654 Department.

6655 The Department may provide for performance monitoring to determine whether behavioral health 6656 authorities are in substantial compliance with their performance contracts.

6657 D. No behavioral health authority shall be eligible to receive state-controlled funds for mental health, 6658 mental retardationintellectual disability, or substance abuse services after September 30 of each year unless (i) its performance contract has been approved by the governing body of the city or county that 6659 6660 established it and by the Department; (ii) it provides service, cost, revenue, and aggregate and individual 6661 consumer data and information, notwithstanding § 37.2-400 or any regulations adopted thereunder, to the 6662 Department in the format prescribed by the Department; and (iii), it uses standardized cost accounting 6663 and financial management practices approved by the Department.

6664 E. If, after unsuccessful use of a remediation process described in the performance contract, a behavioral health authority remains in substantial noncompliance with its performance contract with the 6665 6666 Department, the Department may, after affording the authority an adequate opportunity to use the appeal 6667 process described in the performance contract, terminate all or a portion of the contract. Using the 6668 state-controlled resources associated with that contract, the Department, after consulting with the 6669 governing body of the city or county that established the behavioral health authority, may negotiate a 6670 performance contract with a community services board, another behavioral health authority, or a private 6671 nonprofit or for-profit organization or organizations to obtain services that were the subject of the 6672 terminated performance contract.

6673 § 37.2-716. Mental Health, Intellectual Disability and Substance Abuse Services Revenue Fund.

6674 All funds collected by the Department pursuant to this article shall be paid into a special fund of the 6675 state treasury that shall be known and referred to as the Mental Health, Mental RetardationIntellectual 6676 Disability and Substance Abuse Services Revenue Fund.

This fund shall be appropriated and used for the operation of the Department and its state facilities 6677 6678 for research and training. Unexpended funds in the Mental Health, Mental RetardationIntellectual 6679 Disability and Substance Abuse Services Revenue Fund at the close of any fiscal year shall be retained 6680 in the fund and be available for expenditure in ensuing years as provided herein.

6681 § 37.2-802. Interpreters in admission or certification proceedings.

6682 A. In any proceeding pursuant to § 37.2-806 or §§ 37.2-809 through 37.2-820 in which a person who 6683 is deaf is alleged to have mental retardation intellectual disability or mental illness, an interpreter for the 6684 person shall be appointed by the district court judge or special justice before whom the proceeding is pending from a list of qualified interpreters provided by the Department for the Deaf and 6685 Hard-of-Hearing. The interpreter shall be compensated as provided for in § 37.2-804. 6686

6687 B. In any proceeding pursuant to § 37.2-806 or §§ 37.2-809 through 37.2-820 in which a 6688 non-English-speaking person is alleged to have mental retardation intellectual disability or mental illness 6689 or is a witness in such proceeding, an interpreter for the person shall be appointed by the district court judge or special justice, or in the case of §§ 37.2-809 through 37.2-813 a magistrate, before whom the 6690 6691 proceeding is pending. Failure to appoint an interpreter when an interpreter is not reasonably available 6692 or when the person's level of English fluency cannot be determined shall not be a basis to dismiss the 6693 petition or void the order entered at the proceeding. The compensation for the interpreter shall be fixed 6694 by the court in accordance with the guidelines set by the Judicial Council of Virginia and shall be paid 6695 out of the state treasury. 6696

§ 37.2-806. Judicial certification of eligibility for admission of persons with intellectual disabilities.

6697 A. Whenever a person alleged to have mental retardation intellectual disability is not capable of requesting admission to a training center pursuant to § 37.2-805, a parent or guardian of the person or 6698

another responsible person may initiate a proceeding to certify the person's eligibility for admissionpursuant to this section.

B. Prior to initiating the proceeding, the parent or guardian or other responsible person seeking the 6701 6702 person's admission shall first obtain (i) a preadmission screening report that recommends admission to a training center from the community services board or behavioral health authority that serves the city or 6703 6704 county where the person who is alleged to have mental retardation intellectual disability resides and (ii) 6705 the approval of the training center to which it is proposed that the person be admitted. The Board shall adopt regulations establishing the procedure and standards for the issuance of such approval. These 6706 6707 regulations may include provision for the observation and evaluation of the person in a training center for a period not to exceed 48 hours. No person alleged to have mental retardation intellectual disability 6708 6709 who is the subject of a proceeding under this section shall be detained on that account pending the hearing except for observation and evaluation pursuant to the provisions of this subsection. 6710

C. Upon the filing of a petition in any city or county alleging that the person has mental retardation 6711 6712 intellectual disability, is in need of training, treatment, or habilitation, and has been approved for 6713 admission pursuant to subsection B of this section, a proceeding to certify the person's eligibility for admission to the training center may be commenced. The petition shall be filed with any district court or 6714 6715 special justice. A copy of the petition shall be personally served on the person named in the petition, his 6716 attorney, and his guardian or conservator. Prior to any hearing under this section, the judge or special 6717 justice shall appoint an attorney to represent the person. However, the person shall not be precluded 6718 from employing counsel of his choosing and at his expense.

b. The person who is the subject of the hearing shall be allowed sufficient opportunity to prepare his
defense, obtain independent evaluations and expert opinion at his own expense, and summons other
witnesses. He shall be present at any hearing held under this section, unless his attorney waives his right
to be present and the judge or special justice is satisfied by a clear showing and after personal
observation that the person's attendance would subject him to substantial risk of physical or emotional
injury or would be so disruptive as to prevent the hearing from taking place.

6725 E. Notwithstanding the above, the judge or special justice shall summons either a physician or a 6726 clinical psychologist who is licensed in Virginia and is qualified in the assessment of persons with mental retardationintellectual disability or a person designated by the local community services board or 6727 6728 behavioral health authority who meets the qualifications established by the Board. The physician, clinical 6729 psychologist, or community services board or behavioral health authority designee may be the one who 6730 assessed the person pursuant to subsection B of this section. The judge or special justice also shall summons other witnesses when so requested by the person or his attorney. The physician, clinical 6731 6732 psychologist, or community services board or behavioral health authority designee shall certify that he 6733 has personally assessed the person and has probable cause to believe that the person (i) does or does not 6734 have mental retardation intellectual disability, (ii) is or is not eligible for a less restrictive service, and 6735 (iii) is or is not in need of training, treatment, or habilitation in a training center. The judge or special 6736 justice may accept written certification of a finding of a physician, clinical psychologist, or community 6737 services board or behavioral health authority designee, provided such assessment has been personally made within the preceding 30 days and there is no objection to the acceptance of the written 6738 6739 certification by the person or his attorney.

F. If the judge or special justice, having observed the person and having obtained the necessary 6740 6741 positive certification and other relevant evidence, specifically finds that (i) the person is not capable of 6742 requesting his own admission, (ii) the training center has approved the proposed admission pursuant to 6743 subsection B of this section, (iii) there is no less restrictive alternative to training center admission, consistent with the best interests of the person who is the subject of the proceeding, and (iv) the person 6744 6745 has mental retardation intellectual disability and is in need of training, treatment, or habilitation in a training center, the judge or special justice shall by written order certify that the person is eligible for 6746 6747 admission to a training center.

6748 G. Certification of eligibility for admission hereunder shall not be construed as a judicial 6749 commitment for involuntary admission of the person but shall authorize the parent or guardian or other 6750 responsible person to admit the person to a training center and shall authorize the training center to 6751 accept the person.

§ 37.2-900. Definitions.

6752

6753

As used in this chapter, unless the context requires a different meaning:

6754 "Commissioner" means the Commissioner of Mental Health, Mental RetardationIntellectual Disability
 6755 and Substance Abuse Services.

6756 "Defendant" means any person charged with a sexually violent offense who is deemed to be an
6757 unrestorably incompetent defendant pursuant to § 19.2-169.3 and is referred for commitment review
6758 pursuant to this chapter.

6759 "Department" means the Department of Mental Health, Mental RetardationIntellectual Disability and6760 Substance Abuse Services.

6761 "Director" means the Director of the Department of Corrections.

"Mental abnormality" or "personality disorder" means a congenital or acquired condition that affects 6762 6763 a person's emotional or volitional capacity and renders the person so likely to commit sexually violent offenses that he constitutes a menace to the health and safety of others. 6764

6765 "Respondent" means the person who is subject of a petition filed under this chapter.

6766 "Sexually violent offense" means a felony under (i) former § 18-54, former § 18.1-44, subdivision 5 6767 of § 18.2-31, § 18.2-61, 18.2-67.1, or 18.2-67.2; (ii) § 18.2-48 (ii), 18.2-48 (iii), 18.2-63, 18.2-64.1, or 6768 18.2-67.3; (iii) subdivision 1 of § 18.2-31 where the abduction was committed with intent to defile the 6769 victim; (iv) § 18.2-32 when the killing was in the commission of, or attempt to commit rape, forcible 6770 sodomy, or inanimate or animate object sexual penetration; (v) the laws of the Commonwealth for a 6771 forcible sexual offense committed prior to July 1, 1981, where the criminal behavior is set forth in 6772 § 18.2-67.1 or 18.2-67.2, or is set forth in § 18.2-67.3; or (vi) conspiracy to commit or attempt to 6773 commit any of the above offenses.

"Sexually violent predator" means any person who (i) has been convicted of a sexually violent 6774 6775 offense or has been charged with a sexually violent offense and is unrestorably incompetent to stand trial pursuant to § 19.2-169.3 and (ii) because of a mental abnormality or personality disorder, finds it 6776 6777 difficult to control his predatory behavior, which makes him likely to engage in sexually violent acts.

6778 § 37.2-900.1. Office of Sexually Violent Predator Services.

6779 There is hereby established within the Department of Mental Health, Mental RetardationIntellectual 6780 Disability and Substance Abuse Services, the Office of Sexually Violent Predator Services for the 6781 purpose of administering the duties of the Department under this chapter.

6782 § 37.2-909. Placement of committed persons.

6783 A. Any person committed pursuant to this chapter shall be placed in the custody of the Department 6784 for control, care, and treatment until such time as the person's mental abnormality or personality disorder 6785 has so changed that the person will not present an undue risk to public safety. The Department shall 6786 provide such control, care, and treatment at a secure facility operated by it or may contract with private 6787 or public entities, in or outside of the Commonwealth, or with other states to provide comparable 6788 control, care, or treatment. At all times, persons committed for control, care, and treatment by the Department pursuant to this chapter shall be kept in a secure facility. Persons committed under this 6789 6790 chapter shall be segregated by sight and sound at all times from prisoners in the custody of a 6791 correctional facility. The Commissioner may make treatment and management decisions regarding 6792 committed persons in his custody without obtaining prior approval of or review by the committing court. 6793 B. Prior to the siting of a new facility or the designation of an existing facility to be operated by the

6794 Department for the control, care, and treatment of persons convicted of a sexually violent offense who 6795 have been referred for civil commitment, the Commissioner shall notify the state elected officials for 6796 and the local governing body of the jurisdiction of the proposed location, designation, or expansion of 6797 the facility. Upon receiving such notice, the local governing body of the jurisdiction of the proposed site 6798 or where the existing facility is located may publish a descriptive notice concerning the proposed site or 6799 existing facility in a newspaper of general circulation in the jurisdiction.

6800 The Commissioner also shall establish an advisory committee relating to any facility for which notice 6801 is required by this subsection or any facility being operated for the purpose of the control, care, and treatment of persons convicted of a sexually violent offense who have been referred for civil 6802 6803 commitment. The advisory committee shall consist of state and local elected officials and representatives 6804 of community organizations serving the jurisdiction in which the facility is proposed to be or is located. 6805 Upon request, the members of the appropriate advisory committee shall be notified whenever the 6806 Department increases the number of beds in the relevant facility.

6807 C. Notwithstanding any other provision of law, when any person is committed under this article, the 6808 Department of Corrections and the Office of the Attorney General shall provide to the Department of 6809 Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, a copy of all 6810 relevant criminal history information, medical and mental health records, presentence or postsentence 6811 reports and victim impact statements, and the mental health evaluations performed pursuant to subsection 6812 B of § 37.2-904 and § 37.2-907, for use in the treatment and evaluation of the committed person. 6813

§ 37.2-912. Conditional release; criteria; conditions; reports.

6814 A. At any time the court considers the respondent's need for secure inpatient treatment pursuant to 6815 this chapter, it shall place the respondent on conditional release if it finds that (i) he does not need **6816** secure inpatient treatment but needs outpatient treatment or monitoring to prevent his condition from 6817 deteriorating to a degree that he would need secure inpatient treatment; (ii) appropriate outpatient 6818 supervision and treatment are reasonably available; (iii) there is significant reason to believe that the 6819 respondent, if conditionally released, would comply with the conditions specified; and (iv) conditional release will not present an undue risk to public safety. In making its determination, the court may 6820 consider (i) the nature and circumstances of the sexually violent offense for which the respondent was 6821

6822 charged or convicted, including the age and maturity of the victim; (ii) the results of any actuarial test, 6823 including the likelihood of recidivism; (iii) the results of any diagnostic tests previously administered to 6824 the respondent under this chapter; (iv) the respondent's mental history, including treatments for mental 6825 illness or mental disorders, participation in and response to therapy or treatment, and any history of 6826 previous hospitalizations; (v) the respondent's present mental condition; (vi) the respondent's response to 6827 treatment while in secure inpatient treatment or on conditional release, including his disciplinary record 6828 and any infractions; (vii) the respondent's living arrangements and potential employment if he were to be 6829 placed on conditional release; (viii) the availability of transportation and appropriate supervision to 6830 ensure participation by the respondent in necessary treatment; and (ix) any other factors that the court 6831 deems relevant. The court shall subject the respondent to the orders and conditions it deems will best meet his need for treatment and supervision and best serve the interests of justice and society. In all 6832 cases of conditional release, the court shall order the respondent to be subject to electronic monitoring of 6833 6834 his location by means of a GPS (Global Positioning System) tracking device, or other similar device, at 6835 all times while he is on conditional release. A continuance extending the review may be granted to 6836 either the Attorney General or the respondent upon good cause shown or by agreement of the parties.

The Department or, if the respondent is on parole or probation, the respondent's parole or probation
officer shall implement the court's conditional release orders and shall submit written reports to the court
on the respondent's progress and adjustment in the community no less frequently than every six months.
The Department of Mental Health, Mental Retardation Intellectual Disability and Substance Abuse
Services is authorized to contract with the Department of Corrections to provide services for the
monitoring and supervision of sexually violent predators who are on conditional release.

6843 The Department or, if the respondent is on parole or probation, the respondent's parole or probation
6844 officer shall send a copy of each written report submitted to the court and copies of all correspondence
6845 with the court pursuant to this section to the Attorney General and the Commissioner.

6846 B. Notwithstanding any other provision of law, when any respondent is placed on conditional release 6847 under this article, the Department of Corrections and the Office of the Attorney General shall provide to 6848 the Department, or if the respondent is on parole or probation, the respondent's parole or probation 6849 officer, all relevant criminal history information, medical and mental health records, presentence and 6850 postsentence reports and victim impact statements, and the mental health evaluations performed pursuant **6851** to this chapter, for use in the management and treatment of the respondent placed on conditional release. 6852 Any information or document provided pursuant to this subsection shall not be subject to disclosure 6853 under the Virginia Freedom of Information Act (§ 2.2-3700 et seq.).

6854 § 37.2-919. Postrelease supervision of Department; commission of new criminal offense by person6855 committed to Department.

A. If a person committed to the Department of Mental Health, Mental RetardationIntellectual *Disability* and Substance Abuse Services, whether in involuntary secure inpatient treatment or on
conditional release, who is also on probation, parole, or postrelease supervision, fails to comply with any
conditions established by the Department, or fails to comply with the terms of a treatment plan, the
Department shall so notify the Department of Corrections or the person's probation and parole officer.

6861 B. If a person committed to the Department of Mental Health, Mental RetardationIntellectual 6862 Disability and Substance Abuse Services is arrested for a felony or Class 1 or 2 misdemeanor offense, 6863 he shall be transported to a judicial officer forthwith for a bond determination in accordance with the 6864 provisions of § 19.2-80. If the judicial officer admits the accused to bail, he shall, upon his admission to 6865 bail, be immediately transported back into the custody of the Department of Mental Health, Mental 6866 RetardationIntellectual Disability and Substance Abuse Services. If, after trial for this offense, no active 6867 period of incarceration is imposed, or if the person is acquitted or the charges are withdrawn or dismissed, he shall be returned to the Department of Mental Health, Mental RetardationIntellectual 6868 6869 Disability and Substance Abuse Services pursuant to his commitment. If a period of active incarceration 6870 of 12 months or longer is imposed or any suspended sentence is revoked resulting in the person being 6871 returned to the Department of Corrections for a period of active incarceration of 12 months or longer, the person shall not be entitled to an annual or biennial review hearing pursuant to § 37.2-910 until 12 6872 6873 months after he has been returned to the custody of the Commissioner. Such reincarceration shall toll **6874** the provisions of § 37.2-910.

6875 § 37.2-1018. Discovery of information and records regarding actions of certain agents and 6876 attorneys-in-fact.

6877 A. For purposes of this section:

(6878 "Member of the principal's family" means an adult who is a parent, brother or sister, niece or nephew, child or other descendent, spouse of a child of the principal, and spouse or surviving spouse of the principal.

6881 "Person who is or was interested in the welfare of a principal" means any member of the principal's
6882 family; a person who is a co-agent or co-attorney-in-fact, an alternate agent or attorney-in-fact, or a
6883 successor agent or attorney-in-fact designated under the power of attorney or other writing described in

6884 § 11-9.1; and, if none of these persons is reasonably available and willing to act, the adult protective
6885 services unit of the local department of social services for the city or county where the principal resides
6886 or is located at the time of the request or where a deceased principal resided at the time of his death.
6887 Further, in the case of a deceased principal, the term also means a personal representative of the estate
6888 of a deceased principal.

(6889 "Principal believed to be unable to properly attend to his affairs" means an individual believed in good faith by the petitioner to be a person who is impaired by reason of mental illness, mental interfact disability, physical illness or disability, substance abuse, or other causes to the extent of lacking sufficient understanding or capacity to make or communicate responsible decisions.

6893 B. After having first made a request to an agent or attorney-in-fact for disclosure under § 11-9.6, any 6894 person interested in the welfare of a principal believed to be unable to properly attend to his affairs 6895 may, for the purpose of obtaining information pertinent to the need or propriety of (i) instituting a 6896 proceeding under this chapter; (ii) terminating, suspending, or limiting the authority of an 6897 attorney-in-fact or other agent; or (iii) bringing a proceeding to hold the attorney-in-fact or other agent, or a transferee from such attorney-in-fact or other agent, liable for breach of duty or to recover 6898 6899 particular assets or the value of such assets of a principal or deceased principal, petition a circuit court 6900 for discovery from the attorney-in-fact or other agent of information and records pertaining to actions 6901 taken pursuant to powers or authority conferred by a power of attorney or other writing described in 6902 § 11-9.1 within the time periods set forth under § 11-9.6.

6903 C. The petition may be filed in the circuit court of the county or city in which the attorney-in-fact or 6904 agent resides or has his principal place of employment, or, if a nonresident, in any court in which a 6905 determination of incompetency or incapacity of the principal is proper under this title, or, if a 6906 conservator or guardian has been appointed for the principal, in the court that made the appointment. 6907 The court, after reasonable notice to the attorney-in-fact or agent and to the principal, if no guardian or 6908 conservator has been appointed, may conduct a hearing on the petition. The court, upon the hearing on the petition and upon consideration of the interest of the principal and his estate, may dismiss the 6909 6910 petition or may enter such order or orders respecting discovery as it may deem appropriate, including an 6911 order that the attorney-in-fact or agent respond to all discovery methods that the petitioner might employ 6912 in a civil action or suit subject to the Rules of the Supreme Court of Virginia. Upon the failure of the 6913 agent or attorney-in-fact to make discovery, the court may make and enforce further orders respecting 6914 discovery that would be proper in a civil action subject to such Rules and may award expenses, 6915 including reasonable attorney's fees, as therein provided. Furthermore, upon completion of discovery, the 6916 court, if satisfied that prior to filing the petition the petitioner had requested the information or records 6917 that are the subject of ordered discovery pursuant to § 11-9.6, may, upon finding that the failure to 6918 comply with the request for information was unreasonable, order the attorney-in-fact or agent to pay the 6919 petitioner's expenses in obtaining discovery, including reasonable attorney's fees.

6920 D. A determination to grant or deny in whole or in part discovery sought hereunder shall not be
6921 considered a finding regarding the competence, capacity, or impairment of the principal, nor shall the
6922 granting or denial of discovery hereunder preclude the availability of other remedies involving protection
6923 of the person or estate of the principal or the rights and duties of the attorney-in-fact or other agent.
6924 § 37.2-1101. Judicial authorization of treatment.

A. An appropriate circuit court or district court judge or special justice may authorize treatment for a mental or physical disorder on behalf of an adult person, in accordance with this section, if it finds upon clear and convincing evidence that (i) the person is either incapable of making an informed decision on his own behalf or is incapable of communicating such a decision due to a physical or mental disorder and (ii) the proposed treatment is in the best interest of the person.

B. Any person may request authorization of treatment for an adult person by filing a petition in the circuit court or district court or with a special justice of the county or city in which the person for whom treatment is sought resides or is located or in the county or city in which the proposed place of treatment is located. Upon filing the petition, the petitioner or the court shall deliver or send a certified copy of the petition to the person for whom treatment is sought and, if the identity and whereabouts of the person's next of kin are known, to the next of kin.

6936  $\overline{C}$ . As soon as reasonably possible after the filing of the petition, the court shall appoint an attorney 6937 to represent the interests of the person for whom treatment is sought at the hearing. However, the 6938 appointment shall not be required in the event that the person or another interested person on behalf of 6939 the person elects to retain private counsel at his own expense to represent the interests of the person at 6940 the hearing. If the person for whom treatment is sought is indigent, his counsel shall be paid by the Commonwealth as provided in § 37.2-804 from funds appropriated to reimburse expenses incurred in the 6941 6942 involuntary admission process. However, this provision shall not be construed to prohibit the direct 6943 payment of an attorney's fee by the person or an interested person on his behalf, which fee shall be 6944 subject to the review and approval of the court.

6945 D. Following the appointment of an attorney pursuant to subsection C, the court shall schedule an 6946 expedited hearing of the matter. The court shall notify the person for whom treatment is sought, his next 6947 of kin, if known, the petitioner, and their respective counsel of the date and time for the hearing. In 6948 scheduling the hearing, the court shall take into account the type and severity of the alleged physical or 6949 mental disorder, as well as the need to provide the person's attorney with sufficient time to adequately 6950 prepare his client's case.

6951 E. Notwithstanding the provisions of subsections B and D regarding delivery or service of the 6952 petition and notice of the hearing to the next of kin of any person for whom consent to treatment is 6953 sought, if the person is a patient in any hospital, including a hospital licensed by the Department of 6954 Health pursuant to § 32.1-123 or a resident in any facility operated by the Department of Mental Health, 6955 Mental RetardationIntellectual Disability and Substance Abuse Services and such person has no known 6956 guardian or legally authorized representative, at the time the petition is filed, the court may dispense 6957 with the requirement of any notice to the next of kin. If treatment is necessary to prevent imminent or 6958 irreversible harm, the court in its discretion may dispense with the requirement of providing notice. This 6959 subsection shall not be construed to interfere with any decision made pursuant to the Health Care 6960 Decisions Act (§ 54.1-2981 et seq.).

6961 F. Prior to the hearing, the attorney shall investigate the risks and benefits of the treatment decision **6962** for which authorization is sought and of alternatives to the proposed decision. The attorney shall make a 6963 reasonable effort to inform the person of this information and to ascertain the person's religious beliefs 6964 and basic values and the views and preferences of the person's next of kin. A health care provider shall 6965 disclose or make available to the attorney, upon request, any information, records, and reports 6966 concerning the person that the attorney determines necessary to perform his duties under this section. 6967 Evidence presented at the hearing may be submitted by affidavit in the absence of objection by the 6968 person for whom treatment is sought, the petitioner, either of their respective counsel, or by any other 6969 interested party. 6970

G. Prior to authorizing treatment pursuant to this section, the court shall find:

6971 1. That there is no legally authorized representative available to give consent;

6972 2. That the person for whom treatment is sought is incapable of making an informed decision 6973 regarding treatment or is physically or mentally incapable of communicating such a decision;

**6974** 3. That the person who is the subject of the petition is unlikely to become capable of making an 6975 informed decision or of communicating an informed decision within the time required for decision; and

6976 4. That the proposed treatment is in the best interest of the person and is medically and ethically 6977 appropriate with respect to (i) the medical diagnosis and prognosis and (ii) any other information **6978** provided by the attending physician of the person for whom treatment is sought. However, the court 6979 shall not authorize a proposed treatment that is proven by a preponderance of the evidence to be 6980 contrary to the person's religious beliefs or basic values, unless the treatment is necessary to prevent 6981 death or a serious irreversible condition. The court shall take into consideration the right of the person 6982 to rely on nonmedical, remedial treatment in the practice of religion in lieu of medical treatment.

6983 H. Any order authorizing treatment pursuant to subsection A shall describe any treatment authorized 6984 and may authorize generally such related examinations, tests, or services as the court may determine to 6985 be reasonably related to the treatment authorized. Treatment authorized by such order may include 6986 palliative care as defined in § 32.1-162.1, if appropriate. The order shall require the treating physician to 6987 review and document the appropriateness of the continued administration of antipsychotic medications 6988 not less frequently than every 30 days. The order shall require the treating physician or other service 6989 provider to report to the court and the person's attorney any change in the person's condition resulting in 6990 probable restoration or development of the person's capacity to make and to communicate an informed 6991 decision prior to completion of any authorized treatment and related services. The order may further 6992 require the treating physician or other service provider to report to the court and the person's attorney 6993 any change in circumstances regarding any authorized treatment or related services that may indicate 6994 that such authorization is no longer in the person's best interests. Upon receipt of such report or upon 6995 the petition of any interested party, the court may enter an order withdrawing or modifying its prior 6996 authorization as it deems appropriate. Any petition or order under this section may be orally presented 6997 or entered, provided a written order shall be subsequently executed.

6998 § 38.2-3323. Group life insurance coverages of spouses and minor dependent children; dependent 6999 handicapped children.

7000 A. Coverage under a group life insurance policy, except a policy issued pursuant to § 38.2-3318.1 B, 7001 may be extended to insure the spouse and any child who is under the age of nineteen years or who is a 7002 dependent and a full-time student under twenty-five years of age, or any class of spouses and dependent 7003 children, of each insured group member who so elects. The amount of insurance on the life of a spouse 7004 or child shall not exceed the amount of insurance on the life of the insured group member.

7005 B. A spouse insured under this section shall have the same conversion right to the insurance on his 7006 or her life as the insured group member.

7007 C. Notwithstanding the provisions of § 38.2-3331, one certificate may be issued for each family unit 7008 if a statement concerning any spouse's or dependent child's coverage is included in the certificate.

7009 D. In addition to the coverages afforded by the provisions of this section, any such plan for group 7010 life insurance which includes coverage for children shall afford coverage to any child who is both (i) 7011 incapable of self-sustaining employment by reason of mental retardationintellectual disability or physical 7012 handicap and (ii) chiefly dependent upon the employee for support and maintenance. Upon request of 7013 the insurer, proof of incapacity and dependency shall be furnished to the insurer by the policyowner 7014 within thirty-one days of the child's attainment of the specified age. Subsequent proof may be required 7015 by the insurer but not more frequently than annually after the two-year period following the child's 7016 attainment of the specified age. The insurer shall be allowed to charge a premium at the insurer's then 7017 customary rate applicable to such group policy for such extended coverage.

- 7018 E. 1. Upon termination of such group coverage of a child, the child shall be entitled to have issued 7019 to him by the insurer, without evidence of insurability, an individual life insurance policy without 7020 disability or other supplementary benefits, if:
- 7021 a. An application for the individual policy is made, and the first premium paid to the insurer, within 7022 thirty-one days after such termination; and
- 7023 b. The individual policy, at the option of such person, is on any one of the forms then customarily 7024 issued by the insurer at the age and for the amount applied for, except that the group policy may 7025 exclude the option to elect term insurance;
- 7026 c. The individual policy is in an amount not in excess of the amount of life insurance which ceases 7027 because of such termination, less the amount of any life insurance for which such person becomes 7028 eligible under the same or any other group policy within thirty-one days after such termination, provided 7029 that any amount of insurance which has matured on or before the date of such termination as an 7030 endowment payable to the person insured, whether in one sum or in installments or in the form of an 7031 annuity, shall not, for the purposes of this provision, be included in the amount which is considered to 7032 cease because of such termination; and
- 7033 d. The premium on the individual policy is at the insurer's then customary rate applicable to the form 7034 and amount of the individual policy, to the class of risk to which such person then belongs, and to the 7035 individual age attained on the effective date of the individual policy.
- 7036 2. Subject to the same conditions set forth above, the conversion privilege shall be available (i) to a 7037 surviving dependent, if any, at the death of the group member, with respect to the coverage under the 7038 group policy which terminates by reason of such death, and (ii) to the dependent of the group member 7039 upon termination of coverage of the dependent, while the group member remains insured under the 7040 group policy, by reason of the dependent ceasing to be a qualified family member under the group 7041 policy. 7042
  - § 38.2-3409. Coverage of dependent children.
- 7043 A. Any group or individual accident and sickness insurance policy or subscription contract delivered 7044 or issued for delivery in this Commonwealth which provides that coverage of a dependent child shall 7045 terminate upon that child's attainment of a specified age, shall also provide in substance that attainment 7046 of the specified age shall not terminate the child's coverage during the continuance of the policy while 7047 the dependent child is and continues to be both: (i) incapable of self-sustaining employment by reason 7048 of mental retardationintellectual disability or physical handicap, and (ii) chiefly dependent upon the 7049 policyowner for support and maintenance.
- 7050 B. Proof of incapacity and dependency shall be furnished to the insurer by the policyowner within 7051 thirty-one days of the child's attainment of the specified age. Subsequent proof may be required by the 7052 insurer but not more frequently than annually after the two-year period following the child's attainment 7053 of the specified age.
- 7054 C. The insurer may charge an additional premium for any continuation of coverage beyond the 7055 specified age. The additional premium shall be determined by the insurer on the basis of the class of 7056 risks applicable to the child.
  - § 38.2-3412.1. Coverage for mental health and substance abuse services.
- 7058 A. As used in this section: 7059

7057

"Adult" means any person who is nineteen years of age or older.

7060 "Alcohol or drug rehabilitation facility" means a facility in which a state-approved program for the 7061 treatment of alcoholism or drug addiction is provided. The facility shall be either (i) licensed by the 7062 State Board of Health pursuant to Chapter 5 (§ 32.1-123 et seq.) of Title 32.1 or by the State Mental 7063 Health, Mental RetardationIntellectual Disability and Substance Abuse Services Board pursuant to 7064 Article 2 (§ 37.2-403 et seq.) of Chapter 4 of Title 37.2 or (ii) a state agency or institution.

7065 "Child or adolescent" means any person under the age of nineteen years.

"Inpatient treatment" means mental health or substance abuse services delivered on a 7066 7067 twenty-four-hour per day basis in a hospital, alcohol or drug rehabilitation facility, an intermediate care

7068 facility or an inpatient unit of a mental health treatment center.

7069 "Intellectual Disability" means a disability, originating before the age of 18 years, characterized 7070 concurrently by (i) significantly subaverage intellectual functioning as demonstrated by performance on 7071 a standardized measure of intellectual functioning, administered in conformity with accepted professional 7072 practice, that is at least two standard deviations below the mean and (ii) significant limitations in 7073 adaptive behavior as expressed in conceptual, social, and practical adaptive skills.

7074 'Intermediate care facility' means a licensed, residential public or private facility that is not a 7075 hospital and that is operated primarily for the purpose of providing a continuous, structured 7076 twenty-four-hour per day, state-approved program of inpatient substance abuse services.

"Medication management visit" means a visit no more than twenty minutes in length with a licensed 7077 7078 physician or other licensed health care provider with prescriptive authority for the sole purpose of 7079 monitoring and adjusting medications prescribed for mental health or substance abuse treatment. 7080

"Mental health services" means treatment for mental, emotional or nervous disorders.

7081 "Mental health treatment center" means a treatment facility organized to provide care and treatment 7082 for mental illness through multiple modalities or techniques pursuant to a written plan approved and 7083 monitored by a physician, clinical psychologist, or a psychologist licensed to practice in this Commonwealth. The facility shall be (i) licensed by the Commonwealth, (ii) funded or eligible for 7084 7085 funding under federal or state law, or (iii) affiliated with a hospital under a contractual agreement with 7086 an established system for patient referral.

7087 "Outpatient treatment" means mental health or substance abuse treatment services rendered to a 7088 person as an individual or part of a group while not confined as an inpatient. Such treatment shall not 7089 include services delivered through a partial hospitalization or intensive outpatient program as defined 7090 herein.

7091 'Partial hospitalization'' means a licensed or approved day or evening treatment program that includes 7092 the major diagnostic, medical, psychiatric and psychosocial rehabilitation treatment modalities designed for patients with mental, emotional, or nervous disorders, and alcohol or other drug dependence who 7093 7094 require coordinated, intensive, comprehensive and multi-disciplinary treatment. Such a program shall 7095 provide treatment over a period of six or more continuous hours per day to individuals or groups of individuals who are not admitted as inpatients. Such term shall also include intensive outpatient 7096 7097 programs for the treatment of alcohol or other drug dependence which provide treatment over a period 7098 of three or more continuous hours per day to individuals or groups of individuals who are not admitted 7099 as inpatients. 7100

"Substance abuse services" means treatment for alcohol or other drug dependence.

7101 "Treatment" means services including diagnostic evaluation, medical, psychiatric and psychological 7102 care, and psychotherapy for mental, emotional or nervous disorders or alcohol or other drug dependence 7103 rendered by a hospital, alcohol or drug rehabilitation facility, intermediate care facility, mental health 7104 treatment center, a physician, psychologist, clinical psychologist, licensed clinical social worker, licensed 7105 professional counselor, licensed substance abuse treatment practitioner, licensed marriage and family 7106 therapist or clinical nurse specialist who renders mental health services. Treatment for physiological or 7107 psychological dependence on alcohol or other drugs shall also include the services of counseling and 7108 rehabilitation as well as services rendered by a state certified alcoholism, drug, or substance abuse 7109 counselor or substance abuse counseling assistant, limited to the scope of practice set forth in 7110 § 54.1-3507.1 or § 54.1-3507.2, respectively, employed by a facility or program licensed to provide such 7111 treatment.

7112 B. Each individual and group accident and sickness insurance policy or individual and group 7113 subscription contract providing coverage on an expense-incurred basis for a family member of the 7114 insured or the subscriber shall provide coverage for inpatient and partial hospitalization mental health 7115 and substance abuse services as follows:

7116 1. Treatment for an adult as an inpatient at a hospital, inpatient unit of a mental health treatment 7117 center, alcohol or drug rehabilitation facility or intermediate care facility for a minimum period of 7118 twenty days per policy or contract year.

7119 2. Treatment for a child or adolescent as an inpatient at a hospital, inpatient unit of a mental health 7120 treatment center, alcohol or drug rehabilitation facility or intermediate care facility for a minimum period 7121 of twenty-five days per policy or contract year.

7122 3. Up to ten days of the inpatient benefit set forth in subdivisions 1 and 2 of this subsection may be 7123 converted when medically necessary at the option of the person or the parent, as defined in § 16.1-336, 7124 of a child or adolescent receiving such treatment to a partial hospitalization benefit applying a formula 7125 which shall be no less favorable than an exchange of 1.5 days of partial hospitalization coverage for 7126 each inpatient day of coverage. An insurance policy or subscription contract described herein which 7127 provides inpatient benefits in excess of twenty days per policy or contract year for adults or twenty-five 7128 days per policy or contract year for a child or adolescent may provide for the conversion of such excess 7129 days on the terms set forth in this subdivision.

4. The limits of the benefits set forth in this subsection shall not be more restrictive than for any other illness, except that the benefits may be limited as set out in this subsection.

5. This subsection shall not apply to short-term travel, accident only, limited or specified disease
policies or contracts, nor to policies or contracts designed for issuance to persons eligible for coverage
under Title XVIII of the Social Security Act, known as Medicare, or any other similar coverage under
state or federal governmental plans.

7136 C. Each individual and group accident and sickness insurance policy or individual and group
7137 subscription contract providing coverage on an expense-incurred basis for a family member of the
7138 insured or the subscriber shall also provide coverage for outpatient mental health and substance abuse
7139 services as follows:

**7140** 1. A minimum of twenty visits for outpatient treatment of an adult, child or adolescent shall be provided in each policy or contract year.

7142 2. The limits of the benefits set forth in this subsection shall be no more restrictive than the limits of
7143 benefits applicable to physical illness; however, the coinsurance factor applicable to any outpatient visit

7155 D. The provisions of this section shall not be applicable to "biologically based mental illnesses," as

7158 E. The requirements of this section shall apply to all insurance policies and subscription contracts
7159 delivered, issued for delivery, reissued, or extended, or at any time when any term of the policy or
7160 contract is changed or any premium adjustment made.

**7161** § 38.2-3418.5. Coverage for early intervention services.

7162 A. Notwithstanding the provisions of § 38.2-3419, each insurer proposing to issue individual or group 7163 accident and sickness insurance policies providing hospital, medical and surgical, or major medical 7164 coverage on an expense-incurred basis; each corporation providing individual or group accident and 7165 sickness subscription contracts; and each health maintenance organization providing a health care plan 7166 for health care services shall provide coverage for medically necessary early intervention services under 7167 such policy, contract or plan delivered, issued for delivery or renewed in this Commonwealth on and 7168 after July 1, 1998. Such coverage shall be limited to a benefit of \$5,000 per insured or member per 7169 policy or calendar year and, except as set forth in subsection C, shall be subject to such dollar limits, 7170 deductibles and coinsurance factors as are no less favorable than for physical illness generally.

7171 B. For the purpose of this section, "early intervention services" means medically necessary speech and language therapy, occupational therapy, physical therapy and assistive technology services and 7172 7173 devices for dependents from birth to age three who are certified by the Department of Mental Health, 7174 Mental RetardationIntellectual Disability and Substance Abuse Services as eligible for services under 7175 Part H of the Individuals with Disabilities Education Act (20 U.S.C. § 1471 et seq.). "Medically necessary early intervention services for the population certified by the Department of Mental Health, 7176 7177 Mental RetardationIntellectual Disability and Substance Abuse Services" shall mean those services 7178 designed to help an individual attain or retain the capability to function age-appropriately within his 7179 environment, and shall include services that enhance functional ability without effecting a cure.

7180 C. The cost of early intervention services shall not be applied to any contractual provision limiting
7181 the total amount of coverage paid by the insurer, corporation or health maintenance organization to or
7182 on behalf of the insured or member during the insured's or member's lifetime.

7183 D. "Financial costs," as used in this section, shall mean any copayment, coinsurance, or deductible in
7184 the policy or plan. Financial costs may be paid through the use of federal Part H program funds, state
7185 general funds, or local government funds appropriated to implement Part H services for families who
7186 may refuse the use of their insurance to pay for early intervention services due to a financial cost.

7187 E. The provisions of this section shall not apply to short-term travel, accident only, limited or

7192 § 46.2-400. Suspension of license of person incompetent because of mental illness, mental deficiency, 7193 inebriety, or drug addiction; return of license; duty of clerk of court.

7194 The Commissioner, on receipt of notice that any person has been legally adjudged to be incapacitated 7195 in accordance with Article 1 (§ 37.2-1000 et seq.) of Chapter 10 of Title 37.2 or that a person 7196 discharged from an institution operated or licensed by the Department of Mental Health, Mental 7197 RetardationIntellectual Disability and Substance Abuse Services is, in the opinion of the authorities of the institution, not competent because of mental illness, mental retardationintellectual disability, 7198 7199 inebriety, or drug addiction to drive a motor vehicle with safety to persons or property, shall forthwith 7200 suspend his license; but he shall not suspend the license if the person has been adjudged competent by 7201 judicial order or decree.

7202 In any case in which the person's license has been suspended prior to his discharge it shall not be 7203 returned to him unless the Commissioner is satisfied, after an examination such as is required of 7204 applicants by § 46.2-325, that the person is competent to drive a motor vehicle with safety to persons 7205 and property.

7206 The clerk of the court in which the adjudication is made shall forthwith send a certified copy or 7207 abstract of such adjudication to the Commissioner. 7208

7219 Any regulations of the State Mental Health, Mental RetardationIntellectual Disability and Substance 7220 Abuse Services Board pursuant to the provisions of § 37.2-203 relating to parking on property owned or 7221 controlled by the Board shall provide:

7222 1. That uncontested citations issued thereunder shall be paid to the administrative official or officials 7223 appointed under the provisions of this section in the locality in which the part of the hospital lies, who 7224 shall promptly deposit the sums into the state treasury as a special revenue of the Board; and

7225 2. That contested or delinquent citations shall be certified or complaint, summons, or warrant shall be 7226 issued as provided in § 46.2-1225 to the general district court in whose jurisdiction the hospital lies. 7227 Any sum collected by the court, minus court costs, shall be promptly deposited by the clerk into the 7228 state treasury as a special revenue of the Board. 7229

§ 51.5-1. Declaration of policy.

7230 It is the policy of this Commonwealth to encourage and enable persons with disabilities to participate 7231 fully and equally in the social and economic life of the Commonwealth and to engage in remunerative 7232 employment. To these ends, the General Assembly directs the Governor, Virginia Office for Protection 7233 and Advocacy, Department for the Aging, Department for the Deaf and Hard-of-Hearing, Department of 7234 Education, Department of Health, Department of Housing and Community Development, Department of 7235 Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, Board for Rights 7236 of Virginians with Disabilities, Department of Rehabilitative Services, Department of Social Services, 7237 Department for the Blind and Vision Impaired, and such other agencies as the Governor deems 7238 appropriate, to provide, in a comprehensive and coordinated manner which makes the best use of 7239 available resources, those services necessary to assure equal opportunity to persons with disabilities in 7240 the Commonwealth.

7241 The provisions of this title shall be known and may be cited as "The Virginians With Disabilities 7242 Act."

§ 51.5-2. Plan of cooperation.

7243

7244 The Virginia Office for Protection and Advocacy, Department for the Aging, Department for the 7245 Deaf and Hard-of-Hearing, Department of Education, Department of Health, Department of Housing and 7246 Community Development, Department of Mental Health, Mental RetardationIntellectual Disability and 7247 Substance Abuse Services, Department of Rehabilitative Services, Department of Social Services, 7248 Department for the Blind and Vision Impaired and such other agencies as are designated by the 7249 Governor which serve persons with disabilities shall formulate a plan of cooperation in accordance with 7250 the provisions of this title and the federal Rehabilitation Act. The goal of this plan shall be to promote 7251 the fair and efficient provision of rehabilitative and other services to persons with disabilities and to 7252 protect the rights of persons with disabilities.

7253 The plan of cooperation shall include an annual update of budgetary commitment under the plan, 7254 specifying how many persons with disabilities, by type of impairment, will be served under the plan. 7255 The plan of cooperation shall include consideration of first pay provisions for entitlement programs of a 7256 cooperating agency. If entitlement services are part of a client's individualized written rehabilitation 7257 program or equivalent plan for services, funds shall be paid from the entitlement program when 7258 possible. The plan and budgetary commitments shall be reviewed by the respective boards of the 7259 cooperating agencies, reviewed by the Virginia Board for People with Disabilities and submitted for 7260 approval to the appropriate secretaries within the Governor's Office before implementation.

7261 § 51.5-3. Definitions.

7262 As used in this title except where the context requires a different meaning or where it is otherwise 7263 provided, the following words shall have the meaning ascribed to them:

"Case management" is a dynamic collaborative process that utilizes and builds on the strengths and 7264 7265 resources of consumers to assist them in identifying their needs, accessing and coordinating services, and achieving their goals. The major collaborative components of case management services include 7266 7267

advocacy, assessment, planning, facilitation, coordination, and monitoring. "Case management system" is a central point of contact linking a wide variety of evolving services 7268 7269 and supports that are (i) available in a timely, coordinated manner, (ii) physically and programmatically 7270 accessible, and (iii) consumer-directed with procedural safeguards to ensure responsiveness and 7271 accountability.

7272 "Client" means any person receiving a service provided by the personnel or facilities of a public or 7273 private agency, whether referred to as a client, participant, patient, resident, or other term.

7274 "Commissioner" means the Commissioner of Rehabilitative Services.

7275 "Consumer" is, with respect to case management services, a person with a disability or his designee, 7276 guardian, conservator or committee.

7277 "Council" means the State Rehabilitation Council.

7278 "Mental impairment" means (i) a disability attributable to mental retardation intellectual disability, 7279 autism, or any other neurologically handicapping condition closely related to mental 7280 retardationintellectual disability and requiring treatment similar to that required by mentally retarded individuals persons with intellectual disability; or (ii) an organic or mental impairment that has 7281 7282 substantial adverse effects on an individual's cognitive or volitional functions, including central nervous 7283 system disorders or significant discrepancies among mental functions of an individual. For the purposes 7284 of § 51.5-41, the term "mental impairment" does not include active alcoholism or current drug addiction

7285 and does not include any mental impairment, disease or defect that has been successfully asserted by an 7286 individual as a defense to any criminal charge. 7287

"Otherwise qualified person with a disability" means a person with a disability who:

7288 1. For the purposes of § 51.5-41, is qualified to perform the duties of a particular job or position; or 7289 2. For the purposes of  $\S$  51.5-42, meets all the requirements for admission to an educational 7290 institution or meets all the requirements for participation in its extracurricular programs.

"Person with a disability" means any person who has a physical or mental impairment that substantially limits one or more of his major life activities or has a record of such impairment and that: 7291 7292

7293 1. For purposes of § 51.5-41, is unrelated to the individual's ability to perform the duties of a 7294 particular job or position, or is unrelated to the individual's qualifications for employment or promotion; 7295 2. For purposes of § 51.5-42, is unrelated to the individual's ability to utilize and benefit from

7296 educational opportunities, programs, and facilities at an educational institution; 7297 3. For purposes of § 51.5-44, is unrelated to the individual's ability to utilize and benefit from a

7298 place of public accommodation or public service;

7299 4. For purposes of § 51.5-45, is unrelated to the individual's ability to acquire, rent, or maintain 7300 property.

7301 "Physical impairment" means any physical condition, anatomic loss, or cosmetic disfigurement that is 7302 caused by bodily injury, birth defect, or illness.

7303 "Rehabilitation technology" means the systematic application of technologies, engineering 7304 methodologies, or scientific principles to meet the needs of and address the barriers confronted by 7305 individuals with disabilities in areas that include education, rehabilitation, employment, transportation, 7306 independent living, and recreation. 7307

§ 51.5-14.1. Cooperation of Department with other state departments.

7308 The Department of Rehabilitative Services shall collaborate with the Department of Mental Health, 7309 Mental RetardationIntellectual Disability and Substance Abuse Services in activities related to licensing 7310 providers of (i) services under the Individual and Families Developmental Disabilities Support Waiver, 7311 (ii) services under the Brain Injury Waiver, and (iii) residential services for individuals with brain injuries as defined in § 37.2-403. These activities include involving advocacy and consumer groups who 7312 7313 represent persons with developmental disabilities or brain injuries in the regulatory process; training the

7314 Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, 7315 local human rights committees and the State Human Rights Committee on the unique needs and preferences of individuals with developmental disabilities or brain injuries; assisting in the development 7316 of regulatory requirements for such providers; and providing technical assistance in the regulatory 7317 7318 process and in performing annual inspections and complaint investigations.

7319 § 51.5-30. Cooperative agreements with community services boards and schools.

7320 No services funded under the authority of this chapter shall be provided to:

7321 1. Persons whose primary impairment is mental illness, mental retardationintellectual disability, or 7322 substance abuse, except by cooperative agreement with the local community services board established pursuant to Chapter 5 (§ 37.2-500 et seq.) of Title 37.2 when that board is currently offering the same 7323 7324 services; or 7325

2. Public school-aged persons, except by cooperative agreement with that person's school.

§ 51.5-31. Board created.

7327 There shall be a Virginia Board for People with Disabilities, responsible to the Secretary of Health 7328 and Human Resources. The Board shall be composed of 40 members, to include the head or a person 7329 designated by the head of the Department for the Aging, Department for the Deaf and Hard-of-Hearing, 7330 Department of Education, Department of Medical Assistance Services, Department of Mental Health, 7331 Mental RetardationIntellectual Disability and Substance Abuse Services, Department of Rehabilitative 7332 Services, and the Department for the Blind and Vision Impaired; one representative of the protection and 7333 advocacy agency; one representative of the university-affiliated facility; one representative each, to be 7334 appointed by the Governor, of a local governmental agency, a manufacturing or a retailing industry, a 7335 high-technology industry, a public transit interest, and a nongovernmental agency or group of agencies 7336 that provide services for persons with developmental disabilities; a banking executive; one person with disabilities other than developmental disabilities; and 24 persons with developmental disabilities or the 7337 parents or guardians of such persons. Of the last 24 persons, at least eight shall be persons with 7338 7339 developmental disabilities; at least eight shall be immediate relatives or guardians of persons with 7340 mentally impairing developmental disabilities; and at least one person shall be an immediate relative or 7341 guardian of an institutionalized person with a developmental disability.

7342 Each member appointed by the Governor shall be appointed for a four-year term, except that of the 7343 members appointed in 1989, eight shall be appointed for a term of four years, eight shall be appointed 7344 for a term of three years, eight shall be appointed for a term of two years, and seven shall be appointed 7345 for a term of one year. Members so appointed shall be subject to removal at the pleasure of the 7346 Governor. Any vacancy other than by expiration of a term shall be filled for the unexpired term. No 7347 person appointed by the Governor shall serve for more than two successive terms. 7348

The Board shall elect its chairman.

7349 § 51.5-39.2. The Virginia Office for Protection and Advocacy; governing board; terms; quorum; 7350 expenses; summary of annual work.

A. The Department for Rights of Virginians with Disabilities is hereby established as an independent 7351 7352 state agency to be known as the Virginia Office for Protection and Advocacy. The Office is designated 7353 as the agency to protect and advocate for the rights of persons with mental, cognitive, sensory, physical 7354 or other disabilities and to receive federal funds on behalf of the Commonwealth of Virginia to implement the federal Protection and Advocacy for Individuals with Mental Illness Act, the federal 7355 7356 Developmental Disabilities Assistance and Bill of Rights Act, the federal Rehabilitation Act, the Virginians with Disabilities Act and such other related programs as may be established by state and 7357 7358 federal law. Notwithstanding any other provision of law, the Office shall be independent of the Office of 7359 the Attorney General and shall have the authority, pursuant to subdivision 5 of § 2.2-510, to employ and 7360 contract with legal counsel to carry out the purposes of this chapter and to employ and contract with legal counsel to advise and represent the Office, to initiate actions on behalf of the Office, and to defend 7361 7362 the Office and its officers, agents and employees in the course and scope of their employment or authorization, in any matter, including state, federal and administrative proceedings. Compensation for 7363 7364 legal counsel shall be paid out of the funds appropriated for the administration of the Office. However, 7365 in the event defense is provided under Article 5 (§ 2.2-1832 et seq.) of Chapter 18 of Title 2.2, counsel 7366 shall be appointed pursuant to subdivision 4 of § 2.2-510. The Office shall provide ombudsman, 7367 advocacy and legal services to persons with disabilities who may be represented by the Office. The 7368 Office is authorized to receive and act upon complaints concerning discrimination on the basis of disability, abuse and neglect or other denial of rights, and practices and conditions in institutions, 7369 7370 hospitals, and programs for persons with disabilities, and to investigate complaints relating to abuse and neglect or other violation of the rights of persons with disabilities in proceedings under state or federal 7371 law, and to initiate any proceedings to secure the rights of such persons. 7372

B. The Office shall be governed by an 11-member board consisting of 11 nonlegislative citizen 7373 7374 members. The members shall be appointed as follows: five citizens at large, of whom one shall be a 7375 person with a developmental disability or the parent, family member, guardian, advocate, or authorized

7376 representative of such an individual, one shall be a person with a physical disability or the parent, 7377 family member, guardian, advocate, or authorized representative of such an individual, one shall be a 7378 person who represents persons with cognitive disabilities, one shall be a person who represents persons 7379 with developmental disabilities, and one shall be a person who represents persons with sensory or 7380 physical disabilities, to be appointed by the Speaker of the House of Delegates; three citizens at large, of 7381 whom one shall be a person with a cognitive disability or the parent, family member, guardian, 7382 advocate, or authorized representative of such an individual, one shall be a person who represents 7383 persons with mental illnesses, and one shall be a person who represents people with mental or 7384 neurological disabilities, to be appointed by the Senate Committee on Rules; and three citizens at large, of whom one shall be a person with a mental illness or the parent, family member, guardian, advocate, 7385 7386 or authorized representative of such an individual, one shall be a person with a sensory disability or the 7387 parent, family member, guardian, advocate, or authorized representative of such an individual, and one 7388 shall be a person with a mental or neurological disability or the parent, family member, guardian, 7389 advocate, or authorized representative of such an individual, to be appointed by the Governor. Persons 7390 appointed to the board to represent individuals with a disability shall be knowledgeable of the broad 7391 range of needs of such persons served by the Office. Persons appointed to the board who have a 7392 disability shall be individuals who are eligible for, are receiving, or have received services through the 7393 state system that protects and advocates for the rights of individuals with disabilities. In appointing the 7394 members of the Board, consideration shall be given to persons nominated by statewide groups that 7395 advocate for the physically, developmentally, and mentally disabled. The Virginia Office for Protection 7396 and Advocacy shall coordinate and provide to the appointing authorities the lists of nominations for each 7397 appointment. The Speaker of the House of Delegates, the Senate Committee on Rules and the Governor 7398 shall not be limited in their appointments to persons so nominated; however, such appointing authorities 7399 shall seriously consider the persons nominated and appoint such persons whenever feasible.

No member of the General Assembly, elected official, or current employee of the Department of
Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services, State Health
Department, Department of Rehabilitative Services, Department for the Blind and Vision Impaired,
Virginia Department for the Deaf and Hard-of-Hearing, a community services board, a behavioral health
authority, or a local government department with a policy-advisory community services board shall be
appointed to the Board.

7406 C. Nonlegislative citizen members shall be appointed for a term of four years, following the initial 7407 staggering of terms. All members may be reappointed, except that any member appointed during the 7408 initial staggering of terms to a four-year term shall not be eligible for reappointment for two years after 7409 the expiration of his term. However, no nonlegislative citizen member shall serve more than two 7410 consecutive four-year terms. The remainder of any term to which a member is appointed to fill a 7411 vacancy shall not constitute a term in determining the member's eligibility for reappointment. Appointments to fill vacancies, other than by expiration of a term, shall be made for the unexpired 7412 7413 terms. Vacancies shall be filled in the same manner as the original appointments. All appointments and 7414 reappointments shall be subject to confirmation at the next session of the General Assembly. All 7415 appointments shall be confirmed by the affirmative vote of a majority of those voting in each house of 7416 the General Assembly. Members shall continue to serve until such time as their successors have been 7417 appointed and duly qualified to serve.

7418 D. The Board shall elect a chairman and a vice-chairman from among its members and appoint a 7419 secretary who may or may not be a member of the Board. A majority of the members of the Board 7420 shall constitute a quorum.

7421 The Board shall meet at least four times each year. The meetings of the Board shall be held at the call of the chairman or whenever the majority of the voting members so request. The chairman shall perform such additional duties as may be established by resolution of the Board.

7424 E. Members shall serve without compensation for their services; however, all members shall be reimbursed for all reasonable and necessary expenses incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the costs of expenses of the members shall be provided by the Virginia Office for Protection and Advocacy.

7428 F. Members of the Board shall be subject to removal from office only as set forth in Article 7
7429 (§ 24.2-230 et seq.) of Chapter 2 of Title 24.2. The Circuit Court of the City of Richmond shall have exclusive jurisdiction over all proceedings for such removal.

G. The chairman of the Board shall submit to the Governor and the General Assembly an annual
executive summary of the interim activity and work of the Board no later than the first day of each
regular session of the General Assembly. The executive summary shall be submitted as provided in the
procedures of the Division of Legislative Automated Systems for the processing of legislative documents
and reports and shall be posted to the General Assembly's website.

**7436** § 51.5-39.7. (See Editor's note) Ombudsman services for persons with disabilities.

7437 A. There is hereby created within the Office an ombudsman section. The Director shall establish 7438 procedures for receiving complaints and conducting investigations for the purposes of resolving and 7439 mediating complaints regarding any activity, practice, policy, or procedure of any hospital, facility or 7440 program operated, funded or licensed by the Department of Mental Health, Mental 7441 RetardationIntellectual Disability and Substance Abuse Services, the Department of Rehabilitative 7442 Services, the Department of Social Services, or any other state or local agency, that is adversely 7443 affecting the health, safety, welfare or civil or human rights of any person with mental, cognitive, 7444 sensory or physical disabilities. After initial investigation, the section may decline to accept any 7445 complaint it determines is frivolous or not made in good faith. The ombudsman section shall attempt to 7446 resolve the complaint at the lowest appropriate level, unless otherwise provided by law. The procedures 7447 shall require the section to:

7448 1. Acknowledge the receipt of a complaint by sending written notice to the complainant within seven 7449 days after receiving the complaint;

7450 2. When appropriate, provide written notice of a complaint to the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services or any other appropriate agency 7451 7452 within seven days after receiving the complaint. The Department or agency shall report its findings and 7453 actions no later than fourteen days after receiving the complaint;

3. Immediately refer a complaint made under this section to the Department of Mental Health. 7454 7455 Mental RetardationIntellectual Disability and Substance Abuse Services or any other appropriate 7456 governmental agency whenever the complaint involves an immediate and substantial threat to the health 7457 or safety of a person with mental retardationintellectual disability, developmental disabilities, mental 7458 illness, or other disability. The Department or agency receiving the complaint shall report its findings 7459 and actions no later than forty-eight hours following its receipt of the complaint;

4. Within seven days after identifying a deficiency in the treatment of a person with a disability that 7460 7461 is in violation of state or federal law or regulation, refer the matter in writing to the appropriate state 7462 agency. The state agency shall report on its findings and actions within seven days of receiving notice 7463 of the matter;

7464 5. Advise the complainant and any person with a disability affected by the complaint, no more than 7465 thirty days after it receives the complaint, of any action it has taken and of any opinions and 7466 recommendations it has with respect to the complaint. The ombudsman section may request any party 7467 affected by the opinions or recommendations to notify the section, within a time period specified by the 7468 section, of any action the party has taken on its recommendation; and

7469 6. Refer any complaint not resolved through negotiation, mediation, or conciliation to the Director or 7470 the Director's designee to determine whether further protection and advocacy services shall be provided 7471 by the Office.

7472 B. The ombudsman section may make public any of its opinions or recommendations concerning a complaint, the responses of persons and governmental agencies to its opinions or recommendations, and 7473 7474 any act, practice, policy, or procedure that adversely affects or may adversely affect the health, safety, 7475 welfare, or civil or human rights of a person with a disability, subject to the provisions of § 51.5-39.8.

7476 C. The Office shall publicize its existence, functions, and activities, and the procedures for filing a 7477 complaint under this section, and send this information in written form to each provider of services to 7478 persons with disabilities, with instructions that the information is to be posted in a conspicuous place 7479 accessible to patients, residents, consumers, clients, visitors, and employees. The Office shall establish, 7480 maintain and publicize a toll-free number for receiving complaints. 7481

§ 51.5-39.8. Confidentiality of information.

7482 A. All documentary and other evidence received or maintained by the Office or its agents in 7483 connection with specific complaints or investigations shall be confidential and not subject to the provisions concerning disclosure of public records under the Virginia Freedom of Information Act 7484 7485 (§ 2.2-3700 et seq.). However, access to one's own records shall not be denied unless otherwise 7486 prohibited by state or federal law. Records concerning closed cases shall be subject to the disclosure 7487 requirements of the Virginia Freedom of Information Act, but in a manner that does not identify any 7488 complainant or any person with mental illness, mental retardationintellectual disability, developmental 7489 disabilities or other disability, unless (i) such complainant or person or his legal representative consents 7490 in writing to such identification or (ii) such identification is required by court order.

7491 B. Communications between employees and agents of the Office and its clients or prospective clients 7492 concerning specific complaints, investigations or cases shall be confidential. 7493

C. Notwithstanding the provisions of this section, the Office shall be permitted to:

7494 1. Issue a public report of the results of an investigation of a founded complaint that does not release 7495 the identity of any complainant or any person with mental illness, mental retardationintellectual disability, developmental disabilities or other disability, unless (a) such complainant or person or his 7496 7497 legal representative consents in writing to such disclosure or (b) such disclosure is required by court 7498 order; and

7499 2. Report the results of an investigation to responsible investigative or enforcement agencies should
7500 an investigation reveal information concerning any hospital, facility or other entity, its staff or
7501 employees, warranting possible sanctions or corrective action. This information may be reported to
7502 agencies responsible for licensing or accreditation, employee discipline, employee licensing or
7503 certification or criminal prosecution.

**7504** § 51.5-39.12. Notification of critical incidents and deaths in state facilities.

7505 Notwithstanding any other provision of law, the directors of the state facilities as defined in 7506 § 37.2-100 shall notify the Director of the Office in writing within forty-eight hours of critical incidents 7507 or deaths of patients or residents in state facilities. For purposes of this section, a critical incident shall be defined as serious bodily injury or loss of consciousness requiring medical treatment. The 7508 Commissioner of the Department of Mental Health, Mental RetardationIntellectual Disability and 7509 7510 Substance Abuse Services shall provide to the Director of the Office a written report setting forth the 7511 known facts of critical incidents or deaths of patients or residents of facilities within fifteen working 7512 days of the critical incident or death.

§ 53.1-32. Treatment and control of prisoners; recreation; religious services.

7513

7531

7514 A. It shall be the general purpose of the state correctional facilities to provide proper employment, 7515 training and education in accordance with Chapter 18 (§ 22.1-339 et seq.) of Title 22.1 and § 53.1-32.1, 7516 medical and mental health care and treatment, discipline and control of prisoners committed or 7517 transferred thereto. The health service program established to provide medical services to prisoners shall 7518 provide for appropriate means by which prisoners receiving nonemergency medical services may pay 7519 fees based upon a portion of the cost of such services. In no event shall any prisoner be denied 7520 medically necessary service due to his inability to pay. The Board shall promulgate regulations 7521 governing such a program.

B. The Director shall provide a program of recreation for prisoners. The Director may establish, with
consultation from the Department of Mental Health, Mental RetardationIntellectual Disability and
Substance Abuse Services, a comprehensive substance abuse treatment program which may include
utilization of acupuncture and other treatment modalities, and may make such program available to any
prisoner requiring the services provided by the program.

7527 C. The Director or his designee who shall be a state employee is authorized to make arrangements
7528 for religious services for prisoners at times as he may deem appropriate. When such arrangements are
7529 made pursuant to a contract or memorandum of understanding, the final authority for such arrangements
7530 shall reside with the Director or his designee.

§ 53.1-40.2. Involuntary admission of prisoners with mental illness.

A. Upon the petition of the Director or his designee, any district court judge or any special justice, as defined by § 37.2-100, of the county or city where the prisoner is located may issue an order authorizing involuntary admission of a prisoner who is sentenced and committed to the Department of Corrections and who is alleged or reliably reported to have a mental illness to a degree that warrants hospitalization.

7537 B. Such prisoner may be involuntarily admitted to a hospital or facility for the care and treatment of persons with mental illness by complying with the following admission procedures:

7539 1. A hearing on the petition shall be scheduled as soon as possible, allowing the prisoner an
7540 opportunity to prepare any defenses which he may have, obtain independent evaluation and expert
7541 opinion at his own expense, and summons other witnesses.

7542 2. Prior to such hearing, the judge or special justice shall fully inform the prisoner of the allegations
7543 of the petition, the standard upon which he may be admitted involuntarily, the right of appeal from such hearing to the circuit court, and the right to jury trial on appeal. The judge or special justice shall
7545 ascertain if the prisoner is represented by counsel, and, if he is not represented by counsel, the judge or special justice shall appoint an attorney to represent the prisoner.

7547 3. The judge or special justice shall require an examination of such prisoner by a psychiatrist who is 7548 licensed in Virginia or a clinical psychologist who is licensed in Virginia or, if such psychiatrist or 7549 clinical psychologist is not available, a physician or psychologist who is licensed in Virginia and who is 7550 qualified in the diagnosis of mental illness. The judge or special justice shall summons the examiner, 7551 who shall certify that he has personally examined the individual and has probable cause to believe that 7552 the prisoner does or does not have mental illness, does or does not present an imminent danger to 7553 himself or others, and does or does not require involuntary hospitalization. The judge or special justice 7554 may accept written certification of the examiner's findings if the examination has been personally made 7555 within the preceding five days and if there is no objection to the acceptance of such written certification 7556 by the prisoner or his attorney.

7557 4. If the judge or special justice, after observing the prisoner and obtaining the necessary positive
7558 certification and other relevant evidence, finds specifically that (i) the prisoner presents an imminent
7559 danger to himself or others as a result of mental illness or has been proven to be so seriously mentally

7560 ill as to be substantially unable to care for himself, and (ii) alternatives to involuntary admission have 7561 been investigated and deemed unsuitable and there is no less restrictive alternative to such admission, the judge or special justice shall by written order and specific findings so certify and order that the 7562 7563 prisoner be placed in a hospital or other facility designated by the Director for a period not to exceed 7564 180 days from the date of the court order. Such placement shall be in a hospital or other facility for the 7565 care and treatment of persons with mental illness that is licensed or operated by the Department of 7566 Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services.

7567 5. The judge or special justice shall also order that the relevant medical records of such prisoner be 7568 released to the hospital, facility, or program in which he is placed upon request of the treating physician 7569 or director of the hospital, facility, or program.

7570 6. The Department shall prepare the forms required in procedures for admission as approved by the 7571 Attorney General. These forms, which shall be the legal forms used in such admissions, shall be 7572 distributed by the Department to the clerks of the general district courts of the various counties and 7573 cities of the Commonwealth and to the directors of the respective state hospitals. 7574

§ 53.1-136. Powers and duties of Board; notice of release of certain inmates.

7601 4. Issue final discharges to persons released by the Board on parole when the Board is of the opinion 7602 that the discharge of the parolee will not be incompatible with the welfare of such person or of society;

7603 5. Make investigations and reports with respect to any commutation of sentence, pardon, reprieve or 7604 remission of fine or penalty when requested by the Governor; and

7605 6. Publish monthly a statement regarding the action taken by the Board on the parole of prisoners. The statement shall list the name of each prisoner considered for parole and indicate whether parole was 7606 granted or denied, as well as the basis for denial of parole as described in subdivision 2 (a). 7607 7608

§ 53.1-145. Powers and duties of probation and parole officers.

7609 In addition to other powers and duties prescribed by this article, each probation and parole officer 7610 shall:

7611 1. Investigate and report on any case pending in any court or before any judge in his jurisdiction 7612 referred to him by the court or judge;

§ 54.1-2970. Medical treatment for certain persons incapable of giving informed consent.

When a delay in treatment might adversely affect recovery, a licensed health professional or licensed 7708 7709 hospital shall not be subject to liability arising out of a claim based on lack of informed consent or be 7710 prohibited from providing surgical, medical or dental treatment to an individual who is a patient or resident of a hospital or facility operated by the Department of Mental Health, Mental 7711 RetardationIntellectual Disability and Substance Abuse Services or to a consumer who is receiving case 7712 7713 management services from a community services board or behavioral health authority and who is 7714 incapable of giving informed consent to the treatment by reason of mental illness or mental 7715 retardationintellectual disability under the following conditions: 7716

1. No legally authorized guardian or committee was available to give consent;

7717 2. A reasonable effort is made to advise a parent or other next of kin of the need for the surgical, 7718 medical or dental treatment:

3. No reasonable objection is raised by or on behalf of the alleged incapacitated person; and

7720 4. Two physicians, or in the case of dental treatment, two dentists or one dentist and one physician, 7721 state in writing that they have made a good faith effort to explain the necessary treatment to the individual, and they have probable cause to believe that the individual is incapacitated and unable to 7722 7723 consent to the treatment by reason of mental illness or mental retardationintellectual disability and that delay in treatment might adversely affect recovery. 7724

7725 The provisions of this section shall apply only to the treatment of physical injury or illness and not to any treatment for mental, emotional or psychological condition. 7726

Treatment pursuant to this section of an individual's mental, emotional or psychological condition 7727 7728 when the individual is unable to make an informed decision and when no legally authorized guardian or 7729 committee is available to provide consent shall be governed by regulations promulgated by the State 7730 Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services Board under 7731 § 37.2-400. 7732

§ 54.1-2982. Definitions.

As used in this article:

7734 "Advance directive" means (i) a witnessed written document, voluntarily executed by the declarant in 7735 accordance with the requirements of § 54.1-2983 or (ii) a witnessed oral statement, made by the declarant subsequent to the time he is diagnosed as suffering from a terminal condition and in 7736 7737 accordance with the provisions of § 54.1-2983.

7738 "Agent" means an adult appointed by the declarant under an advance directive, executed or made in 7739 accordance with the provisions of § 54.1-2983, to make health care decisions for him, including visitation, provided the advance directive makes express provisions for visitation and subject to 7740 physician orders and policies of the institution to which the declarant is admitted. The declarant may 7741 7742 also appoint an adult to make, after the declarant's death, an anatomical gift of all or any part of his 7743 body pursuant to Article 2 (§ 32.1-289.2 et seq.) of Chapter 8 of Title 32.1.

7744 "Attending physician" means the primary physician who has responsibility for the treatment and care

7745 of the patient.

"Declarant" means an adult who makes an advance directive, as defined in this article, while capableof making and communicating an informed decision.

7748 "Durable Do Not Resuscitate Order" means a written physician's order issued pursuant to 7749 § 54.1-2987.1 to withhold cardiopulmonary resuscitation from a particular patient in the event of cardiac 7750 or respiratory arrest. For purposes of this article, cardiopulmonary resuscitation shall include cardiac 7751 compression, endotracheal intubation and other advanced airway management, artificial ventilation, and 7752 defibrillation and related procedures. As the terms "advance directive" and "Durable Do Not Resuscitate 7753 Order" are used in this article, a Durable Do Not Resuscitate Order is not and shall not be construed as an advance directive.

7755 "Incapable of making an informed decision" means the inability of an adult patient, because of 7756 mental illness, mental retardationintellectual disability, or any other mental or physical disorder which 7757 precludes communication or impairs judgment and which has been diagnosed and certified in writing by 7758 his attending physician and a second physician or licensed clinical psychologist after personal 7759 examination of such patient, to make an informed decision about providing, withholding or withdrawing 7760 a specific medical treatment or course of treatment because he is unable to understand the nature, extent 7761 or probable consequences of the proposed medical decision, or to make a rational evaluation of the risks and benefits of alternatives to that decision. For purposes of this article, persons who are deaf, dysphasic 7762 7763 or have other communication disorders, who are otherwise mentally competent and able to communicate 7764 by means other than speech, shall not be considered incapable of making an informed decision.

7765 "Life-prolonging procedure" means any medical procedure, treatment or intervention which (i) utilizes 7766 mechanical or other artificial means to sustain, restore or supplant a spontaneous vital function, or is 7767 otherwise of such a nature as to afford a patient no reasonable expectation of recovery from a terminal 7768 condition and (ii) when applied to a patient in a terminal condition, would serve only to prolong the 7769 dying process. The term includes artificially administered hydration and nutrition. However, nothing in this act shall prohibit the administration of medication or the performance of any medical procedure 7770 7771 deemed necessary to provide comfort care or to alleviate pain, including the administration of pain 7772 relieving medications in excess of recommended dosages in accordance with §§ 54.1-2971.01 and 54.1-3408.1. For purposes of §§ 54.1-2988, 54.1-2989, and 54.1-2991, the term also shall include 7773 7774 cardiopulmonary resuscitation.

"Persistent vegetative state" means a condition caused by injury, disease or illness in which a patient has suffered a loss of consciousness, with no behavioral evidence of self-awareness or awareness of surroundings in a learned manner, other than reflex activity of muscles and nerves for low level conditioned response, and from which, to a reasonable degree of medical probability, there can be no recovery.

"Physician" means a person licensed to practice medicine in the Commonwealth of Virginia or in the jurisdiction where the treatment is to be rendered or withheld.

7782 "Qualified patient" means a patient who has made an advance directive in accordance with this
7783 article and either (i) has been diagnosed and certified in writing by the attending physician and a second physician or licensed clinical psychologist after personal examination to be incapable of making an informed decision about providing, withholding or withdrawing a specific medical treatment or course of treatment, in accordance with § 54.1-2986 or (ii) has been diagnosed and certified in writing by the attending physician to be afflicted with a terminal condition.

7788 "Terminal condition" means a condition caused by injury, disease or illness from which, to a
7789 reasonable degree of medical probability a patient cannot recover and (i) the patient's death is imminent
7790 or (ii) the patient is in a persistent vegetative state.

7791 "Witness" means any person over the age of 18, including a spouse or blood relative of the
7792 declarant. Employees of health care facilities and physician's offices, who act in good faith, shall be
7793 permitted to serve as witnesses for purposes of this article.

54.1-2986. Procedure in absence of an advance directive; procedure for advance directive without agent; no presumption; persons who may authorize treatment for patients incapable of informed decisions; applicability restricted to nonprotesting patients.

7797 A. Whenever (i) the attending physician of an adult patient has determined after personal 7798 examination that such patient, because of mental illness, mental retardationintellectual disability, or any 7799 other mental disorder, or a physical disorder which precludes communication or impairs judgment, is 7800 incapable of making an informed decision about providing, withholding or withdrawing a specific 7801 medical treatment or course of treatment and such adult patient has not made an advance directive in 7802 accordance with this article or (ii) the attending physician of an adult patient has determined after 7803 personal examination that such patient, because of mental illness, mental retardationintellectual disability, 7804 or any other mental disorder, or a physical disorder which precludes communication or impairs 7805 judgment, is incapable of making an informed decision about providing, withholding or withdrawing a

7806 specific medical treatment or course of treatment and the adult patient has made an advance directive in 7807 accordance with this article which does not indicate his wishes with respect to the specific course of 7808 treatment at issue and does not appoint an agent to make health care decisions upon his becoming 7809 incapable of making an informed decision, the attending physician may, upon compliance with the 7810 provisions of this section, provide to, withhold or withdraw from such patient medical or surgical care 7811 or treatment, including, but not limited to, life-prolonging procedures, upon the authorization of any of 7812 the following persons, in the specified order of priority, if the physician is not aware of any available, 7813 willing and competent person in a higher class:

7814 1. A guardian or committee for the patient. This subdivision shall not be construed to require such 7815 appointment in order that a treatment decision can be made under this section; or

7816 2. The patient's spouse except where a divorce action has been filed and the divorce is not final; or

7817 3. An adult child of the patient; or

7818 4. A parent of the patient; or

7819 5. An adult brother or sister of the patient; or 7820

6. Any other relative of the patient in the descending order of blood relationship.

7821 If two or more of the persons listed in the same class in subdivisions A 3 through A 6 with equal 7822 decision-making priority inform the attending physician that they disagree as to a particular treatment 7823 decision, the attending physician may rely on the authorization of a majority of the reasonably available 7824 members of that class.

7825 Any person authorized to consent to the providing, withholding or withdrawing of treatment pursuant 7826 to this article shall (i) prior to giving consent, make a good faith effort to ascertain the risks and 7827 benefits of and alternatives to the treatment and the religious beliefs and basic values of the patient 7828 receiving treatment, and to inform the patient, to the extent possible, of the proposed treatment and the fact that someone else is authorized to make a decision regarding that treatment and (ii) base his 7829 7830 decision on the patient's religious beliefs and basic values and any preferences previously expressed by 7831 the patient regarding such treatment to the extent they are known, and if unknown or unclear, on the 7832 patient's best interests. Regardless of the absence of an advance directive, if the patient has expressed his 7833 intent to be an organ donor in any written document, no person noted in this section shall revoke, or in 7834 any way hinder, such organ donation.

7835 B. The absence of an advance directive by an adult patient shall not give rise to any presumption as 7836 to his intent to consent to or refuse life-prolonging procedures.

7837 C. The provisions of this article shall not apply to authorization of nontherapeutic sterilization, 7838 abortion, psychosurgery, or admission to a facility, as defined in § 37.2-100; however, the provisions of 7839 this article, if otherwise applicable, may be employed to authorize a specific treatment or course of 7840 treatment for a person who has been lawfully admitted to such a facility.

Further, the provisions of this article shall not authorize providing, continuing, withholding or 7841 7842 withdrawing of treatment if the provider of the treatment knows that such an action is protested by the 7843 patient. No person shall authorize treatment, or a course of treatment, pursuant to this article, that such 7844 person knows, or upon reasonable inquiry ought to know, is contrary to the religious beliefs or basic 7845 values of the patient unable to make a decision, whether expressed orally or in writing.

7846 D. Prior to withholding or withdrawing treatment for which authorization has been obtained or will 7847 be sought pursuant to this article and prior to, or as soon as reasonably practicable thereafter, the 7848 initiation of treatment for which authorization has been obtained or will be sought pursuant to this 7849 article, and no less frequently than every 180 days while the treatment continues, the attending physician 7850 shall obtain written certification that the patient is incapable of making an informed decision regarding 7851 the treatment from a licensed physician or clinical psychologist which shall be based on a personal 7852 examination of the patient. Whenever the authorization is being sought for treatment of a mental illness, 7853 the second physician or licensed clinical psychologist shall not be otherwise currently involved in the 7854 treatment of the person assessed. The cost of the assessment shall be considered for all purposes a cost 7855 of the patient's treatment.

E. On petition of any person to the circuit court of the county or city in which any patient resides or 7856 7857 is located for whom treatment will be or is currently being provided, withheld or withdrawn pursuant to 7858 this article, the court may enjoin such action upon finding by a preponderance of the evidence that the 7859 action is not lawfully authorized by this article or by other state or federal law. 7860

§ 54.1-2987.1. Durable Do Not Resuscitate Orders.

7861 A. A Durable Do Not Resuscitate Order may be issued by a physician for his patient with whom he 7862 has a bona fide physician/patient relationship as defined in the guidelines of the Board of Medicine, and 7863 only with the consent of the patient or, if the patient is a minor or is otherwise incapable of making an 7864 informed decision regarding consent for such an order, upon the request of and with the consent of the 7865 person authorized to consent on the patient's behalf.

7866 B. This section shall not authorize any health care provider or practitioner to follow a Durable Do 7867 Not Resuscitate Order for any patient who is able to, and does, express to such health care provider or

7868 practitioner the desire to be resuscitated in the event of cardiac or respiratory arrest.

7869 If the patient is a minor or is otherwise incapable of making an informed decision, the expression of 7870 the desire that the patient be resuscitated by the person authorized to consent on the patient's behalf shall 7871 so revoke the provider's or practitioner's authority to follow a Durable Do Not Resuscitate Order.

7872 The expression of such desire to be resuscitated prior to cardiac or respiratory arrest shall constitute 7873 revocation of the Order; however, a new Order may be issued upon consent of the patient or the person 7874 authorized to consent on the patient's behalf.

7875 C. Durable Do Not Resuscitate Orders issued in accordance with this section shall remain valid and 7876 in effect until revoked. In accordance with this section and regulations promulgated by the Board of Health, (i) qualified emergency medical services personnel as defined in § 32.1-111.1 and (ii) licensed 7877 7878 health care practitioners in any facility, program or organization operated or licensed by the Board of Health or by the Department of Mental Health, Mental RetardationIntellectual Disability and Substance 7879 7880 Abuse Services or operated, licensed or owned by another state agency are authorized to follow Durable 7881 Do Not Resuscitate Orders that are available to them in a form approved by the Board of Health.

D. The provisions of this section shall not authorize any qualified emergency medical services personnel or licensed health care provider or practitioner who is attending the patient at the time of 7882 7883 7884 cardiac or respiratory arrest to provide, continue, withhold or withdraw treatment if such provider or 7885 practitioner knows that taking such action is protested by the patient incapable of making an informed 7886 decision. No person shall authorize providing, continuing, withholding or withdrawing treatment 7887 pursuant to this section that such person knows, or upon reasonable inquiry ought to know, is contrary 7888 to the religious beliefs or basic values of a patient incapable of making an informed decision or the 7889 wishes of such patient fairly expressed when the patient was capable of making an informed decision. 7890 Further, this section shall not authorize the withholding of other medical interventions, such as 7891 intravenous fluids, oxygen or other therapies deemed necessary to provide comfort care or to alleviate 7892 pain. 7893

E. For the purposes of this section:

"Health care provider" includes, but is not limited to, qualified emergency medical services 7894 7895 personnel.

7896 "Person authorized to consent on the patient's behalf" means any person authorized by law to consent 7897 on behalf of the patient incapable of making an informed decision or, in the case of a minor child, the 7898 parent or parents having custody of the child or the child's legal guardian or as otherwise provided by 7899 law.

7900 F. This section shall not prevent, prohibit or limit a physician from issuing a written order, other 7901 than a Durable Do Not Resuscitate Order, not to resuscitate a patient in the event of cardiac or 7902 respiratory arrest in accordance with accepted medical practice.

7903 G. Valid Do Not Resuscitate Orders or Emergency Medical Services Do Not Resuscitate Orders 7904 issued before July 1, 1999, pursuant to the then-current law, shall remain valid and shall be given effect 7905 as provided in this article. 7906

§ 54.1-3408. Professional use by practitioners.

7907 A. A practitioner of medicine, osteopathy, podiatry, dentistry, or veterinary medicine or a licensed 7908 nurse practitioner pursuant to § 54.1-2957.01, a licensed physician assistant pursuant to § 54.1-2952.1, or 7909 a TPA-certified optometrist pursuant to Article 5 (§ 54.1-3222 et seq.) of Chapter 32 of this title shall 7910 only prescribe, dispense, or administer controlled substances in good faith for medicinal or therapeutic 7911 purposes within the course of his professional practice.

7912 B. The prescribing practitioner's order may be on a written prescription or pursuant to an oral 7913 prescription as authorized by this chapter. The prescriber may administer drugs and devices, or he may 7914 cause them to be administered by a nurse, physician assistant or intern under his direction and 7915 supervision, or he may prescribe and cause drugs and devices to be administered to patients in 7916 state-owned or state-operated hospitals or facilities licensed as hospitals by the Board of Health or 7917 psychiatric hospitals licensed by the State Mental Health, Mental RetardationIntellectual Disability and 7918 Substance Abuse Services Board by other persons who have been trained properly to administer drugs 7919 and who administer drugs only under the control and supervision of the prescriber or a pharmacist or a 7920 prescriber may cause drugs and devices to be administered to patients by emergency medical services 7921 personnel who have been certified and authorized to administer such drugs and devices pursuant to 7922 Board of Health regulations governing emergency medical services and who are acting within the scope 7923 of such certification. A prescriber may authorize a licensed respiratory care practitioner as defined in 7924 § 54.1-2954 to administer by inhalation controlled substances used in inhalation or respiratory therapy.

7925 C. Pursuant to an oral or written order or standing protocol, the prescriber, who is authorized by 7926 state or federal law to possess and administer radiopharmaceuticals in the scope of his practice, may 7927 authorize a nuclear medicine technologist to administer, under his supervision, radiopharmaceuticals used 7928 in the diagnosis or treatment of disease.

7929 D. Pursuant to an oral or written order or standing protocol issued by the prescriber within the course of his professional practice, such prescriber may authorize registered nurses and licensed practical nurses to possess (i) epinephrine for administration in treatment of emergency medical conditions and (ii) heparin and sterile normal saline to use for the maintenance of intravenous access lines.

**7933** Pursuant to the regulations of the Board of Health, certain emergency medical services technicians 7934 may possess and administer epinephrine in emergency cases of anaphylactic shock.

7935 E. Pursuant to an oral or written order or standing protocol issued by the prescriber within the course
7936 of his professional practice, such prescriber may authorize licensed physical therapists to possess and
7937 administer topical corticosteroids, topical lidocaine, and any other Schedule VI topical drug.

F. Pursuant to an oral or written order or standing protocol issued by the prescriber within the course
of his professional practice, such prescriber may authorize licensed athletic trainers to possess and
administer topical corticosteroids, topical lidocaine, or other Schedule VI topical drugs, or to possess and
administer epinephrine for use in emergency cases of anaphylactic shock.

G. Pursuant to an oral or written order or standing protocol issued by the prescriber within the 7942 7943 course of his professional practice, and in accordance with policies and guidelines established by the 7944 Department of Health pursuant to § 32.1-50.2, such prescriber may authorize registered nurses or 7945 licensed practical nurses under the immediate and direct supervision of a registered nurse to possess and 7946 administer tuberculin purified protein derivative (PPD) in the absence of a prescriber. The Department of 7947 Health's policies and guidelines shall be consistent with applicable guidelines developed by the Centers 7948 for Disease Control and Prevention for preventing transmission of mycobacterium tuberculosis and shall 7949 be updated to incorporate any subsequently implemented standards of the Occupational Safety and 7950 Health Administration and the Department of Labor and Industry to the extent that they are inconsistent with the Department of Health's policies and guidelines. Such standing protocols shall explicitly describe 7951 the categories of persons to whom the tuberculin test is to be administered and shall provide for 7952 7953 appropriate medical evaluation of those in whom the test is positive. The prescriber shall ensure that the 7954 nurse implementing such standing protocols has received adequate training in the practice and principles 7955 underlying tuberculin screening.

The Health Commissioner or his designee may authorize registered nurses, acting as agents of the
Department of Health, to possess and administer, at the nurse's discretion, tuberculin purified protein
derivative (PPD) to those persons in whom tuberculin skin testing is indicated based on protocols and
policies established by the Department of Health.

7960 H. Pursuant to a written order or standing protocol issued by the prescriber within the course of his 7961 professional practice, such prescriber may authorize, with the consent of the parents as defined in 7962 § 22.1-1, an employee of a school board who is trained in the administration of insulin and glucagon to 7963 assist with the administration of insulin or administer glucagon to a student diagnosed as having diabetes 7964 and who requires insulin injections during the school day or for whom glucagon has been prescribed for 7965 the emergency treatment of hypoglycemia. Such authorization shall only be effective when a licensed 7966 nurse, nurse practitioner, physician or physician assistant is not present to perform the administration of 7967 the medication.

7968 I. A prescriber may authorize, pursuant to a protocol approved by the Board of Nursing, the 7969 administration of vaccines to adults for immunization, when a practitioner with prescriptive authority is 7970 not physically present, (i) by licensed pharmacists, (ii) by registered nurses, or (iii) licensed practical 7971 nurses under the immediate and direct supervision of a registered nurse. A prescriber acting on behalf of 7972 and in accordance with established protocols of the Department of Health may authorize the 7973 administration of vaccines to any person by a pharmacist or nurse when the prescriber is not physically 7974 present.

**7975** J. A dentist may cause Schedule VI topical drugs to be administered under his direction and supervision by either a dental hygienist or by an authorized agent of the dentist.

Further, pursuant to a written order and in accordance with a standing protocol issued by the dentist
in the course of his professional practice, a dentist may authorize a dental hygienist under his general
supervision, as defined in § 54.1-2722, to possess and administer topical oral fluorides, topical oral
anesthetics, topical and directly applied antimicrobial agents for treatment of periodontal pocket lesions,
as well as any other Schedule VI topical drug approved by the Board of Dentistry.

7982 In addition, a dentist may authorize a dental hygienist under his direction to administer Schedule VI
7983 nitrous oxide and oxygen inhalation analgesia and, to persons 18 years of age or older, Schedule VI
7984 local anesthesia.

7985 K. (Contingent expiration date - See Editor's note) This section shall not prevent the administration
7986 of drugs by a person who has satisfactorily completed a training program for this purpose approved by
7987 the Board of Nursing and who administers such drugs in accordance with a physician's instructions
7988 pertaining to dosage, frequency, and manner of administration, and in accordance with regulations
7989 promulgated by the Board of Pharmacy relating to security and record keeping, when the drugs
7990 administered would be normally self-administered by (i) a resident of a facility licensed or certified by

the State Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services Board;
(ii) a resident of any assisted living facility which is licensed by the Department of Social Services; (iii)
a resident of the Virginia Rehabilitation Center for the Blind and Vision Impaired; (iv) a resident of a facility approved by the Board or Department of Juvenile Justice for the placement of children in need of services or delinquent or alleged delinquent youth; (v) a program participant of an adult day-care center licensed by the Department of Social Services; or (vi) a resident of any facility authorized or operated by a state or local government whose primary purpose is not to provide health care services.

7998 K. (Contingent effective date - see Editor's note) This section shall not prevent the administration of 7999 drugs by a person who has satisfactorily completed a training program for this purpose approved by the 8000 Board of Nursing and who administers such drugs in accordance with a physician's instructions 8001 pertaining to dosage, frequency, and manner of administration, and in accordance with regulations 8002 promulgated by the Board of Pharmacy relating to security and record keeping, when the drugs administered would be normally self-administered by (i) a resident of a facility licensed or certified by 8003 the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 8004 Services; (ii) a resident of the Virginia Rehabilitation Center for the Blind and Vision Impaired; (iii) a 8005 8006 resident of a facility approved by the Board or Department of Juvenile Justice for the placement of 8007 children in need of services or delinquent or alleged delinquent youth; (iv) a program participant of an 8008 adult day-care center licensed by the Department of Social Services; or (v) a resident of any facility 8009 authorized or operated by a state or local government whose primary purpose is not to provide health 8010 care services.

8011 L. (Contingent effective date - see Editor's note) Medication aides registered by the Board of Nursing 8012 pursuant to Article 7 (§ 54.1-3041 et seq.) of Chapter 30 may administer drugs that would otherwise be self-administered to residents of any assisted living facility licensed by the Department of Social 8013 Services. A registered medication aide shall administer drugs pursuant to this section in accordance with 8014 8015 the prescriber's instructions pertaining to dosage, frequency, and manner of administration; in accordance with regulations promulgated by the Board of Pharmacy relating to security and recordkeeping; in 8016 8017 accordance with the assisted living facility's Medication Management Plan; and in accordance with such 8018 other regulations governing their practice promulgated by the Board of Nursing.

8019 M. In addition, this section shall not prevent the administration of drugs by a person who administers 8020 such drugs in accordance with a physician's instructions pertaining to dosage, frequency, and manner of 8021 administration and with written authorization of a parent, and in accordance with school board 8022 regulations relating to training, security and record keeping, when the drugs administered would be 8023 normally self-administered by a student of a Virginia public school. Training for such persons shall be 8024 accomplished through a program approved by the local school boards, in consultation with the local 8025 departments of health.

8026 N. In addition, this section shall not prevent the administration of drugs by a person to a child in a 8027 child day program as defined in § 63.2-100 and regulated by the State Board of Social Services or the 8028 Child Day Care Council, provided such person (i) has satisfactorily completed a training program for 8029 this purpose approved by the Board of Nursing and taught by a registered nurse, licensed practical 8030 nurse, doctor of medicine or osteopathic medicine, or pharmacist; (ii) has obtained written authorization 8031 from a parent or guardian; (iii) administers drugs only to the child identified on the prescription label in 8032 accordance with the prescriber's instructions pertaining to dosage, frequency, and manner of 8033 administration; and (iv) administers only those drugs that were dispensed from a pharmacy and 8034 maintained in the original, labeled container that would normally be administered by a parent or 8035 guardian to the child.

8036 O. In addition, this section shall not prevent the administration or dispensing of drugs and devices by 8037 persons if they are authorized by the State Health Commissioner in accordance with protocols 8038 established by the State Health Commissioner pursuant to § 32.1-42.1 when (i) the Governor has 8039 declared a disaster or a state of emergency or the United States Secretary of Health and Human Services 8040 has issued a declaration of an actual or potential bioterrorism incident or other actual or potential public 8041 health emergency; (ii) it is necessary to permit the provision of needed drugs or devices; and (iii) such 8042 persons have received the training necessary to safely administer or dispense the needed drugs or 8043 devices. Such persons shall administer or dispense all drugs or devices under the direction, control and 8044 supervision of the State Health Commissioner.

P. Nothing in this title shall prohibit the administration of normally self-administered oral or topical drugs by unlicensed individuals to a person in his private residence.

8047 Q. This section shall not interfere with any prescriber issuing prescriptions in compliance with his authority and scope of practice and the provisions of this section to a Board agent for use pursuant to subsection G of § 18.2-258.1. Such prescriptions issued by such prescriber shall be deemed to be valid prescriptions.

**8051** R. Nothing in this title shall prevent or interfere with dialysis care technicians or dialysis patient care

8052 technicians who are certified by an organization approved by the Board of Health Professions or persons 8053 authorized for provisional practice pursuant to Chapter 27.01 (§ 54.1-2729.1 et seq.) of this title, in the 8054 ordinary course of their duties in a Medicare-certified renal dialysis facility, from administering heparin, 8055 topical needle site anesthetics, dialysis solutions, sterile normal saline solution, and blood volumizers, for the purpose of facilitating renal dialysis treatment, when such administration of medications occurs under 8056 8057 the orders of a licensed physician, nurse practitioner or physician assistant and under the immediate and 8058 direct supervision of a licensed registered nurse. Nothing in this chapter shall be construed to prohibit a patient care dialysis technician trainee from performing dialysis care as part of and within the scope of 8059 8060 the clinical skills instruction segment of a supervised dialysis technician training program, provided such trainee is identified as a "trainee" while working in a renal dialysis facility. 8061

8062 The dialysis care technician or dialysis patient care technician administering the medications shall have demonstrated competency as evidenced by holding current valid certification from an organization 8063 8064 approved by the Board of Health Professions pursuant to Chapter 27.01 (§ 54.1-2729.1 et seq.) of this 8065 title

8066 S. Persons who are otherwise authorized to administer controlled substances in hospitals shall be 8067 authorized to administer influenza or pneumococcal vaccines pursuant to § 32.1-126.4.

8068 T. Pursuant to a specific order for a patient and under his direct and immediate supervision, a 8069 prescriber may authorize the administration of controlled substances by personnel who have been 8070 properly trained to assist a doctor of medicine or osteopathic medicine, provided the method does not 8071 include intravenous, intrathecal, or epidural administration and the prescriber remains responsible for 8072 such administration.

8073 U. A nurse or a dental hygienist may possess and administer topical fluoride varnish to the teeth of 8074 children aged six months to three years pursuant to an oral or written order or a standing protocol issued 8075 by a doctor of medicine or osteopathic medicine that conforms to standards adopted by the Virginia 8076 Department of Health. 8077

§ 54.1-3408.01. Requirements for prescriptions.

8078 A. The written prescription referred to in § 54.1-3408 shall be written with ink or individually typed 8079 or printed. The prescription shall contain the name, address, and telephone number of the prescriber. A 8080 prescription for a controlled substance other than one controlled in Schedule VI shall also contain the 8081 federal controlled substances registration number assigned to the prescriber. The prescriber's information 8082 shall be either preprinted upon the prescription blank, electronically printed, typewritten, rubber stamped, 8083 or printed by hand.

8084 The written prescription shall contain the first and last name of the patient for whom the drug is 8085 prescribed. The address of the patient shall either be placed upon the written prescription by the 8086 prescriber or his agent, or by the dispenser of the prescription. If not otherwise prohibited by law, the dispenser may record the address of the patient in an electronic prescription dispensing record for that 8087 8088 patient in lieu of recording it on the prescription. Each written prescription shall be dated as of, and 8089 signed by the prescriber on, the day when issued. The prescription may be prepared by an agent for the 8090 prescriber's signature.

8091 This section shall not prohibit a prescriber from using preprinted prescriptions for drugs classified in 8092 Schedule VI if all requirements concerning dates, signatures, and other information specified above are 8093 otherwise fulfilled.

8094 No written prescription order form shall include more than one prescription. However, this provision 8095 shall not apply (i) to prescriptions written as chart orders for patients in hospitals and long-term-care 8096 facilities, patients receiving home infusion services or hospice patients, or (ii) to a prescription ordered 8097 through a pharmacy operated by or for the Department of Corrections or the Department of Juvenile 8098 Justice, the central pharmacy of the Department of Health, or the central outpatient pharmacy operated by the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 8099 8100 Services; or (iii) to prescriptions written for patients residing in adult and juvenile detention centers, 8101 local or regional jails, or work release centers operated by the Department of Corrections.

8102 B. Prescribers' orders, whether written as chart orders or prescriptions, for Schedules II, III, IV and V controlled drugs to be administered to (i) patients or residents of long-term care facilities served by a 8103 8104 Virginia pharmacy from a remote location or (ii) patients receiving parenteral, intravenous, 8105 intramuscular, subcutaneous or intraspinal infusion therapy and served by a home infusion pharmacy 8106 from a remote location, may be transmitted to that remote pharmacy by an electronic communications 8107 device over telephone lines which send the exact image to the receiver in hard copy form, and such facsimile copy shall be treated as a valid original prescription order. If the order is for a 8108 radiopharmaceutical, a physician authorized by state or federal law to possess and administer medical 8109 8110 radioactive materials may authorize a nuclear medicine technologist to transmit a prescriber's verbal or 8111 written orders for radiopharmaceuticals.

8112 C. The oral prescription referred to in § 54.1-3408 shall be transmitted to the pharmacy of the 8113 patient's choice by the prescriber or his authorized agent. For the purposes of this section, an authorized

8114 agent of the prescriber shall be an employee of the prescriber who is under his immediate and personal 8115 supervision, or if not an employee, an individual who holds a valid license allowing the administration 8116 or dispensing of drugs and who is specifically directed by the prescriber.

§ 54.1-3437.1. Limited permit for repackaging drugs. 8117

8118 The Board may issue a limited manufacturing permit for the purpose of repackaging drugs, upon 8119 such terms and conditions approved by the Board, to the pharmacy directly operated by the Department 8120 of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse Services and which 8121 serves clients of the community services boards.

8122 § 54.1-3506. License required.

8123 In order to engage in the practice of counseling or marriage and family therapy or in the independent 8124 practice of substance abuse treatment, as defined in this chapter, it shall be necessary to hold a license; 8125 however, no license shall be required for the practice of marriage and family therapy or the independent 8126 practice of substance abuse treatment until six months after the effective date of regulations governing 8127 marriage and family therapy and substance abuse treatment, respectively, promulgated by the Board 8128 under subdivisions 6 and 7 of § 54.1-3505. The Board may issue a license, without examination, for the 8129 practice of marriage and family therapy or the independent practice of substance abuse treatment to 8130 persons who hold a current and unrestricted license as a professional counselor within the 8131 Commonwealth and who meet the clinical and academic requirements for licensure as a marriage and 8132 family therapist or licensed substance abuse treatment practitioner, respectively. The applicant for such 8133 license shall present satisfactory evidence of qualifications equal to those required of applicants for 8134 licensure as marriage and family therapists or licensed substance abuse treatment practitioners, 8135 respectively, by examination in the Commonwealth.

8136 Any person who renders substance abuse treatment services as defined in this chapter and who is not 8137 licensed to do so, other than a person who is exempt pursuant to § 54.1-3501, shall render such services 8138 only when he is (i) under the supervision and direction of a person licensed under this chapter who shall 8139 be responsible for the services performed by such unlicensed person, or (ii) in compliance with the 8140 regulations governing an organization or a facility licensed by the Department of Mental Health, Mental 8141 RetardationIntellectual Disability and Substance Abuse Services.

8142 § 56-484.19. Definitions. 8143

As used in this article:

"Alternative method of providing call location information" means a method of maintaining and 8144 8145 operating a multiline telephone system that ensures that:

8146 1. Emergency calls from a telephone station provide the PSAP with sufficient location identification 8147 information to ensure that emergency responders are dispatched to a location at the facility from which 8148 the emergency call was placed, from which location emergency responders will be able to ascertain the telephone station where the emergency call was placed (i) by being able to view all of the telephone 8149 8150 stations at the facility or (ii) by the activation of an alerting device, including but not limited to lights or 8151 an alarm, located near the telephone station, which activation is triggered by the placing of the 8152 emergency call;

8153 2. Emergency calls from a telephone station, in addition to reaching a PSAP, connect to or otherwise 8154 notify a switchboard operator, attendant, or other designated on-site individual who is capable of giving 8155 the PSAP the location of the telephone station from which the emergency call was placed; or

8156 3. Calls to the digits "9-1-1" from a telephone station connect to a private emergency answering 8157 point.

8158 An alternative method of providing call location information shall also be deemed to be provided, as 8159 a result of the imputed ability of emergency responders to readily locate all telephone stations at the 8160 facility, when emergency calls are placed from a facility with a contiguous area of fewer than 7,000 8161 square feet, located on one or more floors.

"Automatic location identification" or "ALI" means the automatic display at a PSAP of information 8162 8163 defining the emergency call location, which information shall identify the floor name or number, room 8164 name or number, building name or number, cubicle name or number, and office name or number, as 8165 applicable, or imparts other information that is sufficiently specific to provide the emergency responders 8166 with the ability to locate the telephone station from which the emergency call was placed.

"Automatic number identification" or "ANI" means the automatic display at a PSAP of a telephone 8167 8168 number that a PSAP may use to call the telephone station from which the emergency call was placed.

8169 "Central office system" means a business telephone service offered by a provider of communications 8170 services that provides features similar to a private branch exchange by transmitting data over 8171 telecommunications equipment or cable lines.

8172 "Emergency call" means a telephone call that enables the user to reach a PSAP by dialing the digits 8173 "9-1-1" and, if applicable, any additional digit or digits that must be dialed in order to permit the user to 8174 access the public switched telephone network.

8175 "Emergency call location" means the location of the telephone station on an MLTS from which an 8176 emergency call is placed and to which a PSAP may dispatch emergency responders based upon ALI 8177 provided via the emergency call.

8178 "Emergency responders" means fire services, law enforcement, emergency medical services, and other 8179 public services or agencies that may be dispatched by a PSAP in response to an emergency call.

8180 "Enhanced 9-1-1 service" means a service consisting of telephone network features and PSAPs that 8181 (i) enables users of telephone systems to reach a PSAP by making an emergency call; (ii) automatically directs emergency calls to the appropriate PSAPs by selective routing based on the geographical location 8182 from which the emergency call originated; and (iii) provides the capability for ANI and ALI features. 8183

8184 "Facility" means real estate and improvements used principally for or as a (i) hotel as defined in § 35.1-1, (ii) college or university dormitory, (iii) medical care facility as defined in § 32.1-102.1, (iv) 8185 group home or other residential facility licensed by the Department of Mental Health, Mental 8186 8187 Retardation Intellectual Disability and Substance Abuse Services or Department of Social Services, (v) 8188 assisted living facility as defined in § 63.2-100, (vi) apartment complex or condominium where shared 8189 tenant telephone service is provided, (vii) commercial or government office building, (viii) 8190 manufacturing, processing, assembly, warehouse, or distribution establishment, or (ix) retail 8191 establishment.

8192 "MLTS provider" means a person who operates a facility at which telephone service is provided, 8193 with or without compensation, through a multiline telephone system.

"Multiline telephone system" or "MLTS" means a telephone system, including network-based or premises-based systems, whether owned or leased by a public or private entity, operated in the 8194 8195 8196 Commonwealth, that serves a facility, has more than one telephone station, and is comprised of common 8197 control units, telephones, and control hardware and software that share a common interface to the public switched telephone network, whether by a private branch exchange or central office system, without 8198 8199 regard to whether the system utilizes VoIP technology.

8200 "Person" includes any individual, corporation, partnership, association, cooperative, limited liability 8201 company, trust, joint venture, government, political subdivision, or any other legal or commercial entity and any successor, representative, agent, agency, or instrumentality thereof. 8202

8203 "Private emergency answering point" means an answering point that is equipped and staffed during 8204 all hours that the facility is occupied to provide adequate means of responding to calls to the digits 8205 "9-1-1" from telephones on a multiline telephone system by reporting incidents to a PSAP in a manner 8206 that identifies the emergency response location from which the call to the answering point was placed.

8207 "Public safety answering point" or "PSAP" means a communications operation operated by or on 8208 behalf of a governmental entity that is equipped and staffed on a 24-hour basis to receive and process 8209 telephone calls for emergency assistance from an individual by dialing, in addition to any digits required to obtain an outside line, the digits "9-1-1." 8210

8211 "Public switched telephone network" means the worldwide, interconnected networks of equipment, 8212 lines, and controls assembled to establish circuit-switched voice communication paths between calling 8213 and called parties.

8214 "Retail establishment" means any establishment selling goods or services to the ultimate user or 8215 consumer of those goods or services, not for the purpose of resale, but for that user's or consumer's 8216 personal rather than business use.

8217 "Telephone call" means the use of a telephone to initiate an ordinary voice transmission placed 8218 through the public switched telephone network.

8219 "Telephone station" means a telephone on a multiline telephone system, from which a call may be 8220 placed to a PSAP by dialing, in addition to any digits required to access the public switched telephone network, the digits "9-1-1." However, in any medical care facility or licensed assisted living facility, 8221 8222 "telephone station" includes any telephone on a multiline telephone system located in an administrative 8223 office, nursing station, lobby, waiting area, or other area accessible to the general public but does not 8224 include a telephone located in the room of a patient or resident.

8225 "VoIP service" has the same meaning ascribed to it in § 56-484.12. 8226

§ 57-2.02. Religious freedom preserved; definitions; applicability; construction; remedies.

8227 A. As used in this section:

"Demonstrates" means meets the burdens of going forward with the evidence and of persuasion under 8228 8229 the standard of clear and convincing evidence.

8230 "Exercise of religion" means the exercise of religion under Article I, Section 16 of the Constitution 8231 of Virginia, the Virginia Act for Religious Freedom (§ 57-1 et seq.), and the First Amendment to the 8232 United States Constitution.

8233 "Government entity" means any branch, department, agency, or instrumentality of state government, 8234 or any official or other person acting under color of state law, or any political subdivision of the 8235 Commonwealth and does not include the Department of Corrections, the Department of Juvenile Justice, 8236 and facility of the Department of Mental Health, Mental RetardationIntellectual Disability and Substance

8237 Abuse Services that treats civilly committed sexually violent predators, or any local, regional or federal 8238 correctional facility.

8239 "Prevails" means to obtain "prevailing party" status as defined by courts construing the federal Civil 8240 Rights Attorney's Fees Awards Act of 1976, 42 U.S.C. § 1988.

8241 "Substantially burden" means to inhibit or curtail religiously motivated practice.

8242 B. No government entity shall substantially burden a person's free exercise of religion even if the 8243 burden results from a rule of general applicability unless it demonstrates that application of the burden 8244 to the person is (i) essential to further a compelling governmental interest and (ii) the least restrictive 8245 means of furthering that compelling governmental interest.

8246 C. Nothing in this section shall be construed to (i) authorize any government entity to burden any 8247 religious belief or (ii) affect, interpret or in any way address those portions of Article 1, Section 16 of 8248 the Constitution of Virginia, the Virginia Act for Religious Freedom (§ 57-1 et seq.), and the First 8249 Amendment to the United States Constitution that prohibit laws respecting the establishment of religion. 8250 Granting government funds, benefits or exemptions, to the extent permissible under clause (ii) of this 8251 subsection, shall not constitute a violation of this section. As used in this subsection, "granting" used 8252 with respect to government funding, benefits, or exemptions shall not include the denial of government 8253 funding, benefits, or exemptions.

8254 D. A person whose religious exercise has been burdened by government in violation of this section 8255 may assert that violation as a claim or defense in any judicial or administrative proceeding and may 8256 obtain declaratory and injunctive relief from a circuit court, but shall not obtain monetary damages. A 8257 person who prevails in any proceeding to enforce this section against a government entity may recover 8258 his reasonable costs and attorney fees. The provisions of this subsection relating to attorney fees shall 8259 not apply to criminal prosecutions.

8260 E. Nothing in this section shall prevent any governmental institution or facility from maintaining 8261 health, safety, security or discipline.

8262 F. The decision of the circuit court to grant or deny declaratory and injunctive relief may be 8263 appealed by petition to the Court of Appeals of Virginia. 8264

§ 57-60. Exemptions.

8265 A. The following persons shall be exempt from the registration requirements of § 57-49, but shall 8266 otherwise be subject to the provisions of this chapter:

8267 1. Educational institutions that are accredited by the Board of Education, by a regional accrediting 8268 association or by an organization affiliated with the National Commission on Accrediting, the 8269 Association Montessori Internationale, the American Montessori Society, the Virginia Independent 8270 Schools Association, or the Virginia Association of Independent Schools, any foundation having an 8271 established identity with any of the aforementioned educational institutions, and any other educational 8272 institution confining its solicitation of contributions to its student body, alumni, faculty and trustees, and 8273 their families.

8274 2. Persons requesting contributions for the relief of any individual specified by name at the time of 8275 the solicitation when all of the contributions collected without any deductions whatsoever are turned 8276 over to the named beneficiary for his use.

8277 3. Charitable organizations that do not intend to solicit and receive, during a calendar year, and have 8278 not actually raised or received, during any of the three next preceding calendar years, contributions from 8279 the public in excess of \$5,000, if all of their functions, including fund-raising activities, are carried on 8280 by persons who are unpaid for their services and if no part of their assets or income inures to the 8281 benefit of or is paid to any officer or member. Nevertheless, if the contributions raised from the public, 8282 whether all of such are or are not received by any charitable organization during any calendar year, shall 8283 be in excess of \$5,000, it shall, within 30 days after the date it has received total contributions in excess 8284 of \$5,000, register with and report to the Commissioner as required by this chapter. 8285

4. Organizations that solicit only within the membership of the organization by the members thereof.

8286 5. Organizations that have no office within the Commonwealth, that solicit in the Commonwealth 8287 from without the Commonwealth solely by means of telephone or telegraph, direct mail or advertising in 8288 national media, and that have a chapter, branch, or affiliate within the Commonwealth that has registered 8289 with the Commissioner.

8290 6. Organizations that have been granted tax-exempt status under § 501 (c) (3) of the Internal Revenue 8291 Code and that are organized wholly as Area Health Education Centers in accordance with § 32.1-122.7.

8292 7. Health care institutions defined herein as any facilities that have been granted tax-exempt status 8293 under § 501 (c) (3) of the Internal Revenue Code, and that are (i) licensed by the Department of Health 8294 or the Department of Mental Health, Mental RetardationIntellectual Disability and Substance Abuse 8295 Services; (ii) designated by the Health Care Financing Administration (HCFA) as federally qualified 8296 health centers; (iii) certified by the HCFA as rural health clinics; or (iv) wholly organized for the 8297 delivery of health care services without charge; and any supporting organization that exists solely to

8298 support any such health care institutions. For the purposes of clause (iv), "delivery of health care 8299 services without charge" includes the delivery of dental, medical or other health services where a 8300 reasonable minimum fee is charged to cover administrative costs. 8301

8. Civic organizations as defined herein.

8302 9. Nonprofit debt counseling agencies licensed pursuant to Chapter 10.2 (§ 6.1-363.2 et seq.) of Title 8303 6.1.

8304 10. Agencies designated by the Virginia Department for the Aging pursuant to subdivision A 6 of § 2.2-703 as area agencies on aging. 8305

8306 11. Labor unions, labor associations and labor organizations that have been granted tax-exempt status 8307 under § 501 (c) (5) of the Internal Revenue Code.

8308 12. Trade associations that have been granted tax-exempt status under § 501 (c) (6) of the Internal 8309 Revenue Code.

8310 13. Organizations that have been granted tax-exempt status under § 501 (c) (3) of the Internal 8311 Revenue Code and that are organized wholly as regional emergency medical services councils in 8312 accordance with § 32.1-111.11.

8313 14. Nonprofit organizations that have been granted tax-exempt status under § 501 (c) (3) of the 8314 Internal Revenue Code and that solicit contributions only through (i) grant proposals submitted to 8315 for-profit corporations, (ii) grant proposals submitted to other nonprofit organizations that have been 8316 granted tax-exempt status under § 501 (c) (3) of the Internal Revenue Code, or (iii) grant proposals 8317 submitted to organizations determined to be private foundations under § 509 (a) of the Internal Revenue 8318 Code.

8319 B. A charitable organization shall be subject to the provisions of §§ 57-57 and 57-59, but shall otherwise be exempt from the provisions of this chapter for any year in which it confines its 8320 solicitations in the Commonwealth to five or fewer contiguous cities and counties, and in which it has 8321 8322 registered under the charitable solicitations ordinance, if any, of each such city and county. No 8323 organization shall be exempt under this subsection if, during its next preceding fiscal year, more than 10 8324 percent of its gross receipts were paid to any person or combination of persons, located outside the 8325 boundaries of such cities and counties, other than for the purchase of real property, or tangible personal 8326 property or personal services to be used within such localities. An organization that is otherwise 8327 qualified for exemption under this subsection that solicits by means of a local publication, or radio or 8328 television station, shall not be disqualified solely because the circulation or range of such medium 8329 extends beyond the boundaries of such cities or counties.

8330 C. No charitable or civic organization shall be exempt under this section unless it submits to the 8331 Commissioner, who in his discretion may extend such filing deadline prospectively or retrospectively for good cause shown, on forms to be prescribed by him, the name, address and purpose of the organization 8332 8333 and a statement setting forth the reason for the claim for exemption. Parent organizations may file 8334 consolidated applications for exemptions for any chapters, branches, or affiliates that they believe to be 8335 exempt from the registration provisions of this chapter. If the organization is exempted, the 8336 Commissioner shall issue a letter of exemption, which may be exhibited to the public. A registration fee 8337 of \$10 shall be required of every organization requesting an exemption after June 30, 1984. The letter of 8338 exemption shall remain in effect as long as the organization continues to solicit in accordance with its 8339 claim for exemption.

8340 D. Nothing in this chapter shall be construed as being applicable to the American Red Cross or any 8341 of its local chapters.

8342 § 63.2-100. Definitions.

8344

8343 As used in this title, unless the context requires a different meaning:

'Abused or neglected child" means any child less than 18 years of age:

8345 1. Whose parents or other person responsible for his care creates or inflicts, threatens to create or 8346 inflict, or allows to be created or inflicted upon such child a physical or mental injury by other than 8347 accidental means, or creates a substantial risk of death, disfigurement, or impairment of bodily or mental 8348 functions, including but not limited to, a child who is with his parent or other person responsible for his 8349 care either (i) during the manufacture or attempted manufacture of a Schedule I or II controlled substance, or (ii) during the unlawful sale of such substance by that child's parents or other person 8350 8351 responsible for his care, where such manufacture, or attempted manufacture or unlawful sale would constitute a felony violation of § 18.2-248; 8352

8353 2. Whose parents or other person responsible for his care neglects or refuses to provide care necessary for his health. However, no child who in good faith is under treatment solely by spiritual 8354 8355 means through prayer in accordance with the tenets and practices of a recognized church or religious 8356 denomination shall for that reason alone be considered to be an abused or neglected child. Further, a decision by parents who have legal authority for the child or, in the absence of parents with legal 8357 8358 authority for the child, any person with legal authority for the child, who refuses a particular medical 8359 treatment for a child with a life-threatening condition shall not be deemed a refusal to provide necessary

care if (i) such decision is made jointly by the parents or other person with legal authority and the child;
(ii) the child has reached 14 years of age and is sufficiently mature to have an informed opinion on the subject of his medical treatment; (iii) the parents or other person with legal authority and the child have considered alternative treatment options; and (iv) the parents or other person with legal authority and the child believe in good faith that such decision is in the child's best interest. Nothing in this subdivision shall be construed to limit the provisions of § 16.1-278.4;

3. Whose parents or other person responsible for his care abandons such child;

4. Whose parents or other person responsible for his care commits or allows to be committed any actof sexual exploitation or any sexual act upon a child in violation of the law;

8369 5. Who is without parental care or guardianship caused by the unreasonable absence or the mental or
8370 physical incapacity of the child's parent, guardian, legal custodian or other person standing in loco
8371 parentis; or

8372 6. Whose parents or other person responsible for his care creates a substantial risk of physical or mental injury by knowingly leaving the child alone in the same dwelling, including an apartment as defined in § 55-79.2, with a person to whom the child is not related by blood or marriage and who the parent or other person responsible for his care knows has been convicted of an offense against a minor for which registration is required as a violent sexual offender pursuant to § 9.1-902.

8377 If a civil proceeding under this title is based solely on the parent having left the child at a hospital
8378 or rescue squad, it shall be an affirmative defense that such parent safely delivered the child to a
8379 hospital that provides 24-hour emergency services or to an attended rescue squad that employs
8380 emergency medical technicians, within 14 days of the child's birth. For purposes of terminating parental
8381 rights pursuant to § 16.1-283 and placement for adoption, the court may find such a child is a neglected
8382 child upon the ground of abandonment.

8383 "Adoptive home" means any family home selected and approved by a parent, local board or a8384 licensed child-placing agency for the placement of a child with the intent of adoption.

8385 "Adoptive placement" means arranging for the care of a child who is in the custody of a 8386 child-placing agency in an approved home for the purpose of adoption.

8387 "Adult abuse" means the willful infliction of physical pain, injury or mental anguish or unreasonable8388 confinement of an adult.

8389 "Adult day care center" means any facility that is either operated for profit or that desires licensure 8390 and that provides supplementary care and protection during only a part of the day to four or more aged, 8391 infirm or disabled adults who reside elsewhere, except (i) a facility or portion of a facility licensed by 8392 the State Board of Health or the Department of Mental Health, Mental RetardationIntellectual Disability 8393 and Substance Abuse Services, and (ii) the home or residence of an individual who cares for only 8394 persons related to him by blood or marriage. Included in this definition are any two or more places, 8395 establishments or institutions owned, operated or controlled by a single entity and providing such 8396 supplementary care and protection to a combined total of four or more aged, infirm or disabled adults.

8397 "Adult exploitation" means the illegal use of an incapacitated adult or his resources for another's8398 profit or advantage.

8399 "Adult foster care" means room and board, supervision, and special services to an adult who has a physical or mental condition. Adult foster care may be provided by a single provider for up to three adults.

8402 "Adult neglect" means that an adult is living under such circumstances that he is not able to provide8403 for himself or is not being provided services necessary to maintain his physical and mental health and8404 that the failure to receive such necessary services impairs or threatens to impair his well-being.

8405 "Adult protective services" means services provided by the local department that are necessary to protect an adult from abuse, neglect or exploitation.

8407 "Assisted living care" means a level of service provided by an assisted living facility for adults who
8408 may have physical or mental impairments and require at least a moderate level of assistance with
8409 activities of daily living.

8410 "Assisted living facility" means any congregate residential setting that provides or coordinates 8411 personal and health care services, 24-hour supervision, and assistance (scheduled and unscheduled) for 8412 the maintenance or care of four or more adults who are aged, infirm or disabled and who are cared for 8413 in a primarily residential setting, except (i) a facility or portion of a facility licensed by the State Board 8414 of Health or the Department of Mental Health, Mental RetardationIntellectual Disability and Substance 8415 Abuse Services, but including any portion of such facility not so licensed; (ii) the home or residence of 8416 an individual who cares for or maintains only persons related to him by blood or marriage; (iii) a 8417 facility or portion of a facility serving infirm or disabled persons between the ages of 18 and 21, or 22 8418 if enrolled in an educational program for the handicapped pursuant to § 22.1-214, when such facility is licensed by the Department as a children's residential facility under Chapter 17 (§ 63.2-1700 et seq.) of 8419 8420 this title, but including any portion of the facility not so licensed; and (iv) any housing project for

8421 persons 62 years of age or older or the disabled that provides no more than basic coordination of care 8422 services and is funded by the U.S. Department of Housing and Urban Development, by the U.S. 8423 Department of Agriculture, or by the Virginia Housing Development Authority. Included in this 8424 definition are any two or more places, establishments or institutions owned or operated by a single 8425 entity and providing maintenance or care to a combined total of four or more aged, infirm or disabled 8426 adults. Maintenance or care means the protection, general supervision and oversight of the physical and 8427 mental well-being of an aged, infirm or disabled individual.

8428 "Auxiliary grants" means cash payments made to certain aged, blind or disabled individuals who 8429 receive benefits under Title XVI of the Social Security Act, as amended, or would be eligible to receive these benefits except for excess income. 8430

8431

"Birth family" or "birth sibling" means the child's biological family or biological sibling. "Birth parent" means the child's biological parent and, for purposes of adoptive placement, means 8432 parent(s) by previous adoption. 8433

8434 "Board" means the State Board of Social Services. 8435

"Child" means any natural person under 18 years of age.

8436 "Child day center" means a child day program offered to (i) two or more children under the age of 8437 13 in a facility that is not the residence of the provider or of any of the children in care or (ii) 13 or 8438 more children at any location.

8439 "Child day program" means a regularly operating service arrangement for children where, during the 8440 absence of a parent or guardian, a person or organization has agreed to assume responsibility for the 8441 supervision, protection, and well-being of a child under the age of 13 for less than a 24-hour period.

8442 "Child-placing agency" means any person who places children in foster homes, adoptive homes or independent living arrangements pursuant to § 63.2-1819 or a local board that places children in foster homes or adoptive homes pursuant to §§ 63.2-900, 63.2-903 and 63.2-1221. Officers, employees, or 8443 8444 8445 agents of the Commonwealth, or any locality acting within the scope of their authority as such, who serve as or maintain a child-placing agency, shall not be required to be licensed. 8446

8447 "Child-protective services" means the identification, receipt and immediate response to complaints 8448 and reports of alleged child abuse or neglect for children under 18 years of age. It also includes 8449 assessment, and arranging for and providing necessary protective and rehabilitative services for a child 8450 and his family when the child has been found to have been abused or neglected or is at risk of being 8451 abused or neglected.

8452 "Child support services" means any civil, criminal or administrative action taken by the Division of 8453 Child Support Enforcement to locate parents; establish paternity; and establish, modify, enforce, or 8454 collect child support, or child and spousal support.

8455 "Child-welfare agency" means a child day center, child-placing agency, children's residential facility, family day home, family day system, or independent foster home. 8456

8457 "Children's residential facility" means any facility, child-caring institution, or group home that is 8458 maintained for the purpose of receiving children separated from their parents or guardians for full-time 8459 care, maintenance, protection and guidance, or for the purpose of providing independent living services 8460 to persons between 18 and 21 years of age who are in the process of transitioning out of foster care. Children's residential facility shall not include: 8461

8462 1. A licensed or accredited educational institution whose pupils, in the ordinary course of events, 8463 return annually to the homes of their parents or guardians for not less than two months of summer 8464 vacation; 8465

2. An establishment required to be licensed as a summer camp by § 35.1-18; and

3. A licensed or accredited hospital legally maintained as such.

"Commissioner" means the Commissioner of the Department, his designee or authorized 8467 representative. 8468 8469

"Department" means the State Department of Social Services.

8470 "Department of Health and Human Services" means the Department of Health and Human Services 8471 of the United States government or any department or agency thereof that may hereafter be designated 8472 as the agency to administer the Social Security Act, as amended.

8473 "Disposable income" means that part of the income due and payable of any individual remaining 8474 after the deduction of any amount required by law to be withheld.

8475 "Energy assistance" means benefits to assist low-income households with their home heating and 8476 cooling needs, including, but not limited to, purchase of materials or substances used for home heating, 8477 repair or replacement of heating equipment, emergency intervention in no-heat situations, purchase or repair of cooling equipment, and payment of electric bills to operate cooling equipment, in accordance 8478 8479 with § 63.2-805, or provided under the Virginia Energy Assistance Program established pursuant to the Low-Income Home Energy Assistance Act of 1981 (Title XXVI of Public Law 97-35), as amended. 8480

8481 "Family day home" means a child day program offered in the residence of the provider or the home 8482 of any of the children in care for one through 12 children under the age of 13, exclusive of the

8483 provider's own children and any children who reside in the home, when at least one child receives care 8484 for compensation. The provider of a licensed or registered family day home shall disclose to the parents 8485 or guardians of children in their care the percentage of time per week that persons other than the 8486 provider will care for the children. Family day homes serving six through 12 children, exclusive of the 8487 provider's own children and any children who reside in the home, shall be licensed. However, no family 8488 day home shall care for more than four children under the age of two, including the provider's own 8489 children and any children who reside in the home, unless the family day home is licensed or voluntarily 8490 registered. However, a family day home where the children in care are all grandchildren of the provider 8491 shall not be required to be licensed.

8492 "Family day system" means any person who approves family day homes as members of its system;
8493 who refers children to available family day homes in that system; and who, through contractual
8494 arrangement, may provide central administrative functions including, but not limited to, training of
8495 operators of member homes; technical assistance and consultation to operators of member homes;
8496 inspection, supervision, monitoring, and evaluation of member homes; and referral of children to
8497 available health and social services.

8498 "Foster care placement" means placement of a child through (i) an agreement between the parents or guardians and the local board or the public agency designated by the community policy and management team where legal custody remains with the parents or guardians or (ii) an entrustment or commitment of the child to the local board or licensed child-placing agency.

8502 "Foster home" means the place of residence of any natural person in which any child, other than a child by birth or adoption of such person, resides as a member of the household.

8504 "General relief" means money payments and other forms of relief made to those persons mentioned
8505 in § 63.2-802 in accordance with the regulations of the Board and reimbursable in accordance with
8506 § 63.2-401.

8507 "Independent foster home" means a private family home in which any child, other than a child by
8508 birth or adoption of such person, resides as a member of the household and has been placed therein
8509 independently of a child-placing agency except (i) a home in which are received only children related by
8510 birth or adoption of the person who maintains such home and children of personal friends of such
8511 person and (ii) a home in which is received a child or children committed under the provisions of
8512 subdivision A 4 of § 16.1-278.2, subdivision 6 of § 16.1-278.4, or subdivision A 13 of § 16.1-278.8.

8513 "Independent living" means a program of services and activities for children in foster care who are
8514 16 years of age or older, and persons who are former foster care children between the ages of 18 and
8515 21, that prepares them for the successful transition from foster care to self sufficiency.

8516 "Independent living placement" means placement of a child at least 16 years of age who is in the custody of a local board or licensed child-placing agency and has been placed by the local board or licensed child-placing agency in a living arrangement in which he does not have daily substitute parental supervision.

8520 "Independent physician" means a physician who is chosen by the resident of the assisted living
8521 facility and who has no financial interest in the assisted living facility, directly or indirectly, as an owner, officer, or employee or as an independent contractor with the residence.

8523 "Intercountry placement" means the arrangement for the care of a child in an adoptive home or foster
8524 care placement into or out of the Commonwealth by a licensed child-placing agency, court, or other
8525 entity authorized to make such placements in accordance with the laws of the foreign country under
8526 which it operates.

8527 "Interstate placement" means the arrangement for the care of a child in an adoptive home, foster care
8528 placement or in the home of the child's parent or with a relative or nonagency guardian, into or out of
8529 the Commonwealth, by a child-placing agency or court when the full legal right of the child's parent or
8530 nonagency guardian to plan for the child has been voluntarily terminated or limited or severed by the
8531 action of any court.

8532 "Kinship care" means the full-time care, nurturing, and protection of children by relatives.

8533 "Local board" means the local board of social services representing one or more counties or cities.

8534 "Local department" means the local department of social services of any county or city in this 8535 Commonwealth.

8536 "Local director" means the director or his designated representative of the local department of the city or county.

8538 "Merit system plan" means those regulations adopted by the Board in the development and operation8539 of a system of personnel administration meeting requirements of the federal Office of Personnel8540 Management.

**8541** "Parental placement" means locating or effecting the placement of a child or the placing of a child in a family home by the child's parent or legal guardian for the purpose of foster care or adoption.

8543 "Public assistance" means Temporary Assistance for Needy Families (TANF); auxiliary grants to the

8544 aged, blind and disabled; medical assistance; energy assistance; food stamps; employment services; child care; and general relief. 8545

8546 "Qualified assessor" means an entity contracting with the Department of Medical Assistance Services 8547 to perform nursing facility pre-admission screening or to complete the uniform assessment instrument for a home and community-based waiver program, including an independent physician contracting with the 8548 8549 Department of Medical Assistance Services to complete the uniform assessment instrument for residents 8550 of assisted living facilities, or any hospital that has contracted with the Department of Medical 8551 Assistance Services to perform nursing facility pre-admission screenings.

8552 "Registered family day home" means any family day home that has met the standards for voluntary 8553 registration for such homes pursuant to regulations adopted by the Board and that has obtained a 8554 certificate of registration from the Commissioner.

8555 "Residential living care" means a level of service provided by an assisted living facility for adults 8556 who may have physical or mental impairments and require only minimal assistance with the activities of 8557 daily living. The definition of "residential living care" includes the services provided by independent living facilities that voluntarily become licensed. 8558

8559 "Social services" means foster care, adoption, adoption assistance, adult services, adult protective 8560 services, child-protective services, domestic violence services, or any other services program 8561 implemented in accordance with regulations adopted by the Board.

8562 "Special order" means an order imposing an administrative sanction issued to any party licensed 8563 pursuant to this title by the Commissioner that has a stated duration of not more than 12 months. A 8564 special order shall be considered a case decision as defined in § 2.2-4001.

"Temporary Assistance for Needy Families" or "TANF" means the program administered by the 8565 8566 Department through which a relative can receive monthly cash assistance for the support of his eligible 8567 children.

8568 Temporary Assistance for Needy Families-Unemployed Parent" or "TANF-UP" means the 8569 Temporary Assistance for Needy Families program for families in which both natural or adoptive 8570 parents of a child reside in the home and neither parent is exempt from the Virginia Initiative for Employment Not Welfare (VIEW) participation under § 63.2-609. 8571

8572 'Title IV-E Foster Care" means a federal program authorized under §§ 472 and 473 of the Social 8573 Security Act, as amended, and administered by the Department through which foster care is provided on 8574 behalf of qualifying children. 8575

§ 63.2-1503. Local departments to establish child-protective services; duties.

8576 A. Each local department shall establish child-protective services under a departmental coordinator 8577 within such department or with one or more adjacent local departments that shall be staffed with 8578 qualified personnel pursuant to regulations adopted by the Board. The local department shall be the 8579 public agency responsible for receiving and responding to complaints and reports, except that (i) in cases 8580 where the reports or complaints are to be made to the court and the judge determines that no local 8581 department within a reasonable geographic distance can impartially respond to the report, the court shall assign the report to the court services unit for evaluation; and (ii) in cases where an employee at a 8582 8583 private or state-operated hospital, institution or other facility, or an employee of a school board is suspected of abusing or neglecting a child in such hospital, institution or other facility, or public school, 8584 8585 the local department shall request the Department and the relevant private or state-operated hospital, 8586 institution or other facility, or school board to assist in conducting a joint investigation in accordance 8587 with regulations adopted by the Board, in consultation with the Departments of Education, Health, 8588 Medical Assistance Services, Mental Health, Mental RetardationIntellectual Disability and Substance 8589 Abuse Services, Juvenile Justice and Corrections.

8590 B. The local department shall ensure, through its own personnel or through cooperative arrangements with other local agencies, the capability of receiving reports or complaints and responding to them 8591 8592 promptly on a 24-hours-a-day, seven-days-per-week basis.

8593 C. The local department shall widely publicize a telephone number for receiving complaints and 8594 reports.

8595 D. The local department shall upon receipt of a complaint, report immediately to the attorney for the 8596 Commonwealth and the local law-enforcement agency and make available to them the records of the 8597 local department when abuse or neglect is suspected in any case involving (i) death of a child; (ii) 8598 injury or threatened injury to the child in which a felony or Class 1 misdemeanor is also suspected; (iii) 8599 any sexual abuse, suspected sexual abuse or other sexual offense involving a child, including but not 8600 limited to the use or display of the child in sexually explicit visual material, as defined in § 18.2-374.1; (iv) any abduction of a child; (v) any felony or Class 1 misdemeanor drug offense involving a child; or 8601 (vi) contributing to the delinquency of a minor in violation of § 18.2-371, and provide the attorney for 8602 8603 the Commonwealth and the local law-enforcement agency with records of any complaints of abuse or neglect involving the victim or the alleged perpetrator. The local department shall not allow reports of 8604 8605 the death of the victim from other local agencies to substitute for direct reports to the attorney for the

8606 Commonwealth and the local law-enforcement agency. The local department shall develop, when practicable, memoranda of understanding for responding to reports of child abuse and neglect with local law enforcement and the attorney for the Commonwealth.

8609 E. When abuse or neglect is suspected in any case involving the death of a child, the local8610 department shall report the case immediately to the regional medical examiner and the local8611 law-enforcement agency.

F. The local department shall use reasonable diligence to locate (i) any child for whom a report of suspected abuse or neglect has been received and is under investigation, receiving family assessment, or for whom a founded determination of abuse and neglect has been made and a child-protective services case opened and (ii) persons who are the subject of a report that is under investigation or receiving family assessment, if the whereabouts of the child or such persons are unknown to the local department.

6. When an abused or neglected child and the persons who are the subject of an open child-protective services case have relocated out of the jurisdiction of the local department, the local department shall notify the child-protective services agency in the jurisdiction to which such persons have relocated, whether inside or outside of the Commonwealth, and forward to such agency relevant portions of the case record. The receiving local department shall arrange protective and rehabilitative services as required by this section.

8623 H. When a child for whom a report of suspected abuse or neglect has been received and is under 8624 investigation or receiving family assessment and the child and the child's parents or other persons 8625 responsible for the child's care who are the subject of the report that is under investigation or family 8626 assessment have relocated out of the jurisdiction of the local department, the local department shall 8627 notify the child-protective services agency in the jurisdiction to which the child and such persons have 8628 relocated, whether inside or outside of the Commonwealth, and complete such investigation or family 8629 assessment by requesting such agency's assistance in completing the investigation or family assessment. 8630 The local department that completes the investigation or family assessment shall forward to the receiving 8631 agency relevant portions of the case record in order for the receiving agency to arrange protective and 8632 rehabilitative services as required by this section.

8633 I. Upon receipt of a report of child abuse or neglect, the local department shall determine the validity
8634 of such report and shall make a determination to conduct an investigation pursuant to § 63.2-1505 or, if
8635 designated as a child-protective services differential response agency by the Department according to
8636 § 63.2-1504, a family assessment pursuant to § 63.2-1506.

8637 J. The local department shall foster, when practicable, the creation, maintenance and coordination of 8638 hospital and community-based multidisciplinary teams that shall include where possible, but not be 8639 limited to, members of the medical, mental health, social work, nursing, education, legal and 8640 law-enforcement professions. Such teams shall assist the local departments in identifying abused and 8641 neglected children; coordinating medical, social, and legal services for the children and their families; 8642 developing innovative programs for detection and prevention of child abuse; promoting community 8643 concern and action in the area of child abuse and neglect; and disseminating information to the general 8644 public with respect to the problem of child abuse and neglect and the facilities and prevention and 8645 treatment methods available to combat child abuse and neglect. These teams may be the family 8646 assessment and planning teams established pursuant to § 2.2-5207. Multidisciplinary teams may develop 8647 agreements regarding the exchange of information among the parties for the purposes of the 8648 investigation and disposition of complaints of child abuse and neglect, delivery of services and child 8649 protection. Any information exchanged in accordance with the agreement shall not be considered to be a 8650 violation of the provisions of §§ 63.2-102, 63.2-104 or § 63.2-105.

**8651** The local department shall also coordinate its efforts in the provision of these services for abused and **8652** neglected children with the judge and staff of the court.

K. The local department may develop multidisciplinary teams to provide consultation to the local department during the investigation of selected cases involving child abuse or neglect, and to make recommendations regarding the prosecution of such cases. These teams may include, but are not limited to, members of the medical, mental health, legal and law-enforcement professions, including the attorney for the Commonwealth or his designee; a local child-protective services representative; and the guardian ad litem or other court-appointed advocate for the child. Any information exchanged for the purpose of such consultation shall not be considered a violation of §§ 63.2-102, 63.2-104 or § 63.2-105.

8660 L. The local department shall report annually on its activities concerning abused and neglected8661 children to the court and to the Child-Protective Services Unit in the Department on forms provided by8662 the Department.

8663 M. Statements, or any evidence derived therefrom, made to local department child-protective services
8664 personnel, or to any person performing the duties of such personnel, by any person accused of the abuse, injury, neglect or death of a child after the arrest of such person, shall not be used in evidence in the case-in-chief against such person in the criminal proceeding on the question of guilt or innocence

8667 over the objection of the accused, unless the statement was made after such person was fully advised (i) 8668 of his right to remain silent, (ii) that anything he says may be used against him in a court of law, (iii) 8669 that he has a right to the presence of an attorney during any interviews, and (iv) that if he cannot afford 8670 an attorney, one will be appointed for him prior to any questioning.

N. Notwithstanding any other provision of law, the local department, in accordance with Board 8671 8672 regulations, shall transmit information regarding founded complaints or family assessments and may 8673 transmit other information regarding reports, complaints, family assessments and investigations involving active duty military personnel or members of their household to family advocacy representatives of the 8674 8675 United States Armed Forces.

8676 O. The local department shall notify the custodial parent and make reasonable efforts to notify the noncustodial parent as those terms are defined in § 63.2-1900 of a report of suspected abuse or neglect 8677 of a child who is the subject of an investigation or is receiving family assessment, in those cases in 8678 8679 which such custodial or noncustodial parent is not the subject of the investigation. 8680

§ 63.2-1528. Advisory Committee continued as Advisory Board.

8681 The Advisory Committee on Child Abuse and Neglect is continued and shall hereafter be known as 8682 the Advisory Board on Child Abuse and Neglect. The Advisory Board shall be composed of nine 8683 persons appointed by the Governor for three-year staggered terms, and permanent members including the Superintendent of Public Instruction, the Commissioner of the Department of Health, the Commissioner 8684 8685 of the Department of Mental Health, Mental Retardation Intellectual Disability and Substance Abuse 8686 Services, the Commissioner of the Department of Social Services, the Director of the Department of 8687 Juvenile Justice, the Director of the Department of Corrections, the Director of the Department of Criminal Justice Services, and the Attorney General of Virginia, or their designees. The Advisory Board 8688 shall meet quarterly and, as the need may arise, advise the Department, Board and Governor on matters 8689 concerning programs for the prevention and treatment of abused and neglected children and their 8690 8691 families and child abuse and neglect issues identified by the Commissioner of the Department of Social 8692 Services.

§ 63.2-1603. Protection of adults; definitions.

As used in this article:

8695 "Adult" means any person 60 years of age or older, or any person 18 years of age or older who is incapacitated and who resides in the Commonwealth; provided, however, "adult" may include qualifying 8696 8697 nonresidents who are temporarily in the Commonwealth and who are in need of temporary or 8698 emergency protective services.

8699 "Emergency" means that an adult is living in conditions that present a clear and substantial risk of 8700 death or immediate and serious physical harm to himself or others.

"Incapacitated person" means any adult who is impaired by reason of mental illness, mental 8701 retardation, intellectual disability, physical illness or disability, advanced age or other causes to the 8702 8703 extent that the adult lacks sufficient understanding or capacity to make, communicate or carry out 8704 responsible decisions concerning his or her well-being.

8705 § 63.2-1709. Enforcement and sanctions; assisted living facilities and adult day care centers; interim 8706 administration; receivership, revocation, denial, summary suspension.

8707 A. Upon receipt and verification by the Commissioner of information from any source indicating an 8708 imminent and substantial risk of harm to residents, the Commissioner may require an assisted living 8709 facility to contract with an individual licensed by the Board of Long-Term Care Administrators, to be either selected from a list created and maintained by the Department of Medical Assistance Services or 8710 8711 selected from a pool of appropriately licensed administrators recommended by the owner of the assisted living facility, to administer, manage, or operate the assisted living facility on an interim basis, and to 8712 8713 attempt to bring the facility into compliance with all relevant requirements of law, regulation, or any plan of correction approved by the Commissioner. Such contract shall require the interim administrator 8714 8715 to comply with any and all requirements established by the Department to ensure the health, safety, and 8716 welfare of the residents. Prior to or upon conclusion of the period of interim administration, 8717 management, or operation, an inspection shall be conducted to determine whether operation of the 8718 assisted living facility shall be permitted to continue or should cease. Such interim administration, 8719 management, or operation shall not be permitted when defects in the conditions of the premises of the 8720 assisted living facility (i) present imminent and substantial risks to the health, safety, and welfare of 8721 residents, and (ii) may not be corrected within a reasonable period of time. Any decision by the Commissioner to require the employment of a person to administer, manage, or operate an assisted 8722 8723 living facility shall be subject to the rights of judicial review and appeal as provided in the Administrative Process Act (§ 2.2-4000 et seq.). Actual and reasonable costs of such interim 8724 8725 administration shall be the responsibility of and shall be borne by the owner of the assisted living 8726 facility.

8727 B. The Board shall adopt regulations for the Commissioner to use in determining when the 8728 imposition of administrative sanctions or initiation of court proceedings, severally or jointly, is

8729 appropriate in order to ensure prompt correction of violations in assisted living facilities and adult day 8730 care centers involving noncompliance with state law or regulation as discovered through any inspection 8731 or investigation conducted by the Departments of Social Services, Health, or Mental Health, Mental 8732 Retardation Intellectual Disability and Substance Abuse Services. The Commissioner may impose such 8733 sanctions or take such actions as are appropriate for violation of any of the provisions of this subtitle or 8734 any regulation adopted under any provision of this subtitle that adversely affects the health, safety or 8735 welfare of an assisted living facility resident or an adult day care participant. Such sanctions or actions 8736 may include (i) petitioning the court to appoint a receiver for any assisted living facility or adult day 8737 care center and (ii) revoking or denving renewal of the license for the assisted living facility or adult 8738 day care center for violation of any of the provisions of this subtitle, § 54.1-3408 or any regulation 8739 adopted under this subtitle that violation adversely affects, or is an imminent and substantial threat to, 8740 the health, safety or welfare of the person cared for therein, or for permitting, aiding or abetting the 8741 commission of any illegal act in an assisted living facility or adult day care center.

8742 C. The Commissioner may issue a summary order of suspension of the license to operate the assisted 8743 living facility pursuant to the procedures hereinafter set forth in conjunction with any proceeding for revocation, denial, or other action when conditions or practices exist that pose an imminent and substantial threat to the health, safety, and welfare of the residents. Before a summary order of 8744 8745 8746 suspension shall take effect, the Commissioner shall issue to the assisted living facility a notice of 8747 summary order of suspension setting forth (i) the procedures for the summary order of suspension, (ii) 8748 hearing and appeal rights as provided under this subsection, and (iii) facts and evidence that formed the 8749 basis for which the summary order of suspension is sought. Such notice shall be served on the assisted 8750 living facility or its designee as soon as practicable thereafter by personal service or certified mail, 8751 return receipt requested, to the address of record of the assisted living facility. The order shall state the 8752 time, date, and location of a hearing to determine whether the suspension is appropriate. Such hearing 8753 shall be presided over by a hearing officer selected by the Commissioner from a list prepared by the 8754 Executive Secretary of the Supreme Court of Virginia and shall be held as soon as practicable, but in no 8755 event later than 15 business days following service of the notice of hearing; however, the hearing officer 8756 may grant a written request for a continuance, not to exceed an additional 10 business days, for good 8757 cause shown. After such hearing, the hearing officer shall provide to the Commissioner written findings 8758 and conclusions, together with a recommendation whether the license should be summarily suspended, 8759 whereupon the Commissioner shall adopt the hearing officer's recommended decision unless to do so 8760 would be an error of law or Department policy. Any final agency case decision in which the 8761 Commissioner rejects a hearing officer's recommended decision shall state with particularity the basis for 8762 rejection. The Commissioner shall issue: (a) a final order of summary suspension or (b) an order that 8763 summary suspension is not warranted by the facts and circumstances presented. A final order of 8764 summary suspension shall include notice that the assisted living facility may appeal the Commissioner's 8765 decision to the appropriate circuit court no later than 10 days following service of the order. A copy of 8766 any final order of summary suspension shall be prominently displayed by the provider at each public 8767 entrance of the facility, or in lieu thereof, the provider may display a written statement summarizing the 8768 terms of the order in a prominent location, printed in a clear and legible size and typeface, and 8769 identifying the location within the facility where the final order of summary suspension may be 8770 reviewed.

8771 Upon appeal, the sole issue before the court shall be whether the Department had reasonable grounds 8772 to require the assisted living facility to cease operations during the pendency of the concurrent 8773 revocation, denial, or other proceeding. Any concurrent revocation, denial, or other proceeding shall not 8774 be affected by the outcome of any hearing on the appropriateness of the summary order of suspension. 8775 Failure to comply with the summary order of suspension shall constitute an offense under subdivision 1 8776 of § 63.2-1712. All agencies and subdivisions of the Commonwealth shall cooperate with the 8777 Commissioner in the relocation of residents of an assisted living facility whose license has been 8778 summarily suspended pursuant to this section and in any other actions necessary to reduce the risk of 8779 further harm to residents.

8780 D. Notice of the Commissioner's intent to revoke or deny renewal of the license for the assisted 8781 living facility shall be provided by the Department and a copy of such notice shall be posted in a 8782 prominent place at each public entrance of the licensed premises to advise consumers of serious or 8783 persistent violations. In determining whether to deny, revoke, or summarily suspend a license, the Commissioner may choose to deny, revoke, or summarily suspend only certain authority of the assisted 8784 8785 living facility to operate, and may restrict or modify the assisted living facility's authority to provide 8786 certain services or perform certain functions that the Commissioner determines should be restricted or 8787 modified in order to protect the health, safety, or welfare of the residents. Such denial, revocation, or 8788 summary suspension of certain services or functions may be appealed as otherwise provided in this 8789 subtitle for any denial, revocation, or summary suspension.

**8790** § 63.2-1726. Background check required; children's residential facilities.

8791 A. As a condition of employment, volunteering or providing services on a regular basis, every 8792 children's residential facility that is regulated or operated by the Departments of Social Services; 8793 Education; Military Affairs; or Mental Health, Mental Retardation Intellectual Disability and Substance 8794 Abuse Services shall require any individual who (i) accepts a position of employment at such a facility 8795 who was not employed by that facility prior to July 1, 2007, (ii) volunteers for such a facility on a 8796 regular basis and will be alone with a juvenile in the performance of his duties who was not a volunteer 8797 at such facility prior to July 1, 2007, or (iii) provides contractual services directly to a juvenile for such 8798 facility on a regular basis and will be alone with a juvenile in the performance of his duties who did not 8799 provide such services prior to July 1, 2007; to submit to fingerprinting and to provide personal descriptive information, to be forwarded along with the applicant's fingerprints through the Central 8800 Criminal Records Exchange to the Federal Bureau of Investigation for the purpose of obtaining criminal 8801 8802 history record information regarding such applicant. The children's residential facility shall inform the applicant that he is entitled to obtain a copy of any background check report and to challenge the 8803 8804 accuracy and completeness of any such report and obtain a prompt resolution before a final 8805 determination is made of the applicant's eligibility to have responsibility for the safety and well-being of children. The applicant shall provide the children's residential facility with a written statement or 8806 8807 affirmation disclosing whether he has ever been convicted of or is the subject of pending charges for 8808 any offense within or outside the Commonwealth. The results of the criminal history background check 8809 must be received prior to permitting an applicant to work with children.

8810 The Central Criminal Records Exchange, upon receipt of an individual's record or notification that no 8811 record exists, shall forward it to the state agency which operates or regulates the children's residential facility with which the applicant is affiliated. The state agency shall, upon receipt of an applicant's 8812 8813 record lacking disposition data, conduct research in whatever state and local recordkeeping systems are 8814 available in order to obtain complete data. The state agency shall report to the children's facility whether the applicant is eligible to have responsibility for the safety and well-being of children. Except as 8815 8816 otherwise provided in subsection B, no children's residential facility regulated or operated by the 8817 Departments of Education; Mental Health, Mental Retardation Intellectual Disability and Substance 8818 Abuse Services; Military Affairs; or Social Services shall hire for compensated employment or allow to 8819 volunteer or provide contractual services persons who have been (i) convicted of or are the subject of 8820 pending charges for the following crimes: murder or manslaughter as set out in Article 1 (§ 18.2-30 et 8821 seq.) of Chapter 4 of Title 18.2; malicious wounding by mob as set out in § 18.2-41; abduction as set 8822 out in § 18.2-47 A; abduction for immoral purposes as set out in § 18.2-48; assault and bodily 8823 woundings as set out in Article 4 (§ 18.2-51 et seq.) of Chapter 4 of Title 18.2; robbery as set out in 8824 § 18.2-58; carjacking as set out in § 18.2-58.1; extortion by threat as set out in § 18.2-59; threat as set 8825 out in § 18.2-60; any felony stalking violation as set out in § 18.2-60.3; sexual assault as set out in 8826 Article 7 (§ 18.2-61 et seq.) of Chapter 4 of Title 18.2; arson as set out in Article 1 (§ 18.2-77 et seq.) 8827 of Chapter 5 of Title 18.2; burglary as set out in Article 2 (§ 18.2-89 et seq.) of Chapter 5 of Title 18.2; 8828 any felony violation relating to distribution of drugs as set out in Article 1 (§ 18.2-247 et seq.) of 8829 Chapter 7 of Title 18.2; drive-by shooting as set out in § 18.2-286.1; use of a machine gun in a crime of violence as set out in § 18.2-289; aggressive use of a machine gun as set out in § 18.2-290; use of a 8830 8831 sawed off shotgun in a crime of violence as set out in subsection A of § 18.2-300; pandering as set out 8832 in § 18.2-355; crimes against nature involving children as set out § 18.2-361; taking indecent liberties 8833 with children as set out in § 18.2-370 or § 18.2-370.1; abuse or neglect of children as set out in 8834 § 18.2-371.1, including failure to secure medical attention for an injured child as set out in § 18.2-314; obscenity offenses as set out in § 18.2-374.1; possession of child pornography as set out in § 18.2-374.1:1; electronic facilitation of pornography as set out in § 18.2-374.3; incest as set out in § 18.2-366; abuse or neglect of incapacitated adults as set out in § 18.2-369; employing or permitting a 8835 8836 8837 8838 minor to assist in an act constituting an offense under Article 5 (§ 18.2-372 et seq.) of Chapter 8 of Title 18.2, as set out in § 18.2-379; delivery of drugs to prisoners as set out in § 18.2-474.1; escape 8839 8840 from jail as set out in § 18.2-477; felonies by prisoners as set out in § 53.1-203; or an equivalent offense 8841 in another state; or (ii) convicted of any felony violation relating to possession of drugs set out in Article 1 (§ 18.2-247 et seq.) of Chapter 7 of Title 18.2 in the five years prior to the application date for 8842 8843 employment, to be a volunteer, or to provide contractual services; or (iii) convicted of any felony 8844 violation relating to possession of drugs as set out in Article 1 (§ 18.2-247 et seq.) of Chapter 7 of Title 8845 18.2 and continue on probation or parole or have failed to pay required court costs. The provisions of 8846 this section also shall apply to structured residential programs, excluding secure detention facilities, 8847 established pursuant to § 16.1-309.3 for juvenile offenders cited in a complaint for intake or in a petition 8848 before the court that alleges the juvenile is delinquent or in need of services or supervision.

8849 B. Notwithstanding the provisions of subsection A, a children's residential facility may hire for compensated employment or for volunteer or contractual service purposes persons who have been convicted of not more than one misdemeanor offense under § 18.2-57 or 18.2-57.2, if 10 years have

8852 elapsed following the conviction, unless the person committed such offense in the scope of his8853 employment, volunteer, or contractual services.

8854 If the applicant is denied employment, or the opportunity to volunteer or provide services at a 8855 children's residential facility because of information appearing on his criminal history record, and the 8856 applicant disputes the information upon which the denial was based, upon written request of the 8857 applicant the state agency shall furnish the applicant the procedures for obtaining his criminal history 8858 record from the Federal Bureau of Investigation. If the applicant has been permitted to assume duties 8859 that do not involve contact with children pending receipt of the report, the children's residential facility 8860 is not precluded from suspending the applicant from his position pending a final determination of the 8861 applicant's eligibility to have responsibility for the safety and well-being of children. The information 8862 provided to the children's residential facility shall not be disseminated except as provided in this section. 8863 C. Those individuals listed in clauses (i), (ii) and (iii) of subsection A also shall authorize the children's residential facility to obtain a copy of information from the central registry maintained 8864 pursuant to § 63.2-1515 on any investigation of child abuse or neglect undertaken on him. The applicant 8865 8866 shall provide the children's residential facility with a written statement or affirmation disclosing whether 8867 he has ever been the subject of a founded case of child abuse or neglect within or outside the 8868 Commonwealth. The children's residential facility shall receive the results of the central registry search 8869 prior to permitting an applicant to work alone with children. Children's residential facilities regulated or 8870 operated by the Departments of Education; Mental Health, Mental Retardation Intellectual Disability and 8871 Substance Abuse Services; Military Affairs; and Social Services shall not hire for compensated 8872 employment or allow to volunteer or provide contractual services, persons who have a founded case of 8873 child abuse or neglect. Every residential facility for juveniles which is regulated or operated by the 8874 Department of Juvenile Justice shall be authorized to obtain a copy of the information from the central 8875 registry.

8876 D. The Boards of Social Services; Education; Juvenile Justice; and Mental Health, Mental
8877 Retardation Intellectual Disability and Substance Abuse Services, and the Department of Military
8878 Affairs, may adopt regulations to comply with the provisions of this section. Copies of any information
8879 received by a children's residential facility pursuant to this section shall be available to the agency that
8880 regulates or operates such facility but shall not be disseminated further. The cost of obtaining the
8881 criminal history record and the central registry information shall be borne by the employee or volunteer
8882 unless the children's residential facility, at its option, decides to pay the cost.

**8883** § 63.2-1735. Child Day-Care Council created; members; terms; duties.

8884 The Child Day-Care Council is hereby continued. Its members shall be appointed by the Governor 8885 and serve without compensation. Notwithstanding the provisions of § 2.2-2813, reimbursement for travel 8886 expenses of members shall be limited to in-state travel. The members of the Council shall consist of two nonprofit child day center operators; three private for-profit child day center operators; one representative from each of the Departments of Social Services, Health, Education, Fire Programs, and 8887 8888 8889 Housing and Community Development; one pediatric health professional; one child development 8890 specialist; one parent consumer; one legal professional; one representative of the National Association 8891 for the Education of Young Children; one representative of the National Academy of Early Childhood 8892 Programs; one representative of the Association of Christian Schools International; one representative of 8893 the American Association of Christian Schools; one representative of the National Early Childhood 8894 Program Accreditation; one representative of the National Accreditation Council for Early Childhood 8895 Professional Personnel and Programs; one representative of the International Academy for Private 8896 Education; one representative of the American Montessori Society; one representative of the International Accreditation and Certification of Childhood Educators, Programs, and Trainers; one 8897 8898 representative of the National Accreditation Commission; one representative of the Virginia Council for 8899 Private Education; and one representative each of a child day center offering a seasonal program 8900 emphasizing outdoor activities, a private child day center offering a half-day nursery school program, 8901 and a local governing body all of which operate programs required to be licensed under this chapter. 8902 The membership of the Council shall also include such representatives of state agencies as advisory 8903 members as the Governor deems necessary. The Governor shall designate a member of the Council to 8904 serve as chairman.

**8905** The members of the Council shall be appointed for four-year terms, except appointments to fill vacancies shall be for the unexpired term.

**8907** The Council shall adopt regulations for licensure and operation of child day centers in the **8908** Commonwealth in accordance with the regulations referred to in § 63.2-1734.

8909 The Council shall adopt regulations in collaboration with the Virginia Recreation and Park Society
8910 and the Department of Mental Health, Mental Retardation Intellectual Disability and Substance Abuse
8911 Services for therapeutic recreation programs.

8912 All staff and other support services required by the Council shall be provided by the Department.

8913 § 63.2-1805. Admissions and discharge.

8914 A. The Board shall adopt regulations:

8915 1. Governing admissions to assisted living facilities;

8916 2. Requiring that each assisted living facility prepare and provide a statement, in a format prescribed 8917 by the Department, to any prospective resident and his legal representative, if any, prior to admission 8918 and upon request, that discloses information, fully and accurately in plain language, about the (i) 8919 services; (ii) fees, including clear information about what services are included in the base fee and any 8920 fees for additional services; (iii) admission, transfer, and discharge criteria, including criteria for transfer 8921 to another level of care within the same facility or complex; (iv) general number and qualifications of staff on each shift; (v) range, frequency, and number of activities provided for residents; and (vi) 8922 8923 ownership structure of the facility;

3. Establishing a process to ensure that each resident admitted or retained in an assisted living 8924 8925 facility receives appropriate services and periodic independent reassessments and reassessments when 8926 there is a significant change in the resident's condition in order to determine whether a resident's needs 8927 can continue to be met by the facility and whether continued placement in the facility is in the best 8928 interests of the resident;

8929 4. Governing appropriate discharge planning for residents whose care needs can no longer be met by 8930 the facility: 8931

5. Addressing the involuntary discharge of residents;

8932 6. Requiring that residents are informed of their rights pursuant to § 63.2-1808 at the time of 8933 admission:

8934 7. Establishing a process to ensure that any resident temporarily detained in a facility pursuant to 8935 §§ 37.2-809 through 37.2-813 is accepted back in the assisted living facility if the resident is not involuntarily admitted pursuant to §§ 37.2-814 through 37.2-819; and 8936

8937 8. Requiring that each assisted living facility train all employees who are mandated to report adult 8938 abuse, neglect, or exploitation pursuant to § 63.2-1606 on such reporting procedures and the 8939 consequences for failing to make a required report.

8940 B. If there are observed behaviors or patterns of behavior indicative of mental illness, mental 8941 retardation, intellectual disability, substance abuse, or behavioral disorders, as documented in the 8942 uniform assessment instrument completed pursuant to § 63.2-1804, the facility administrator or 8943 designated staff member shall ensure that an evaluation of the individual is or has been conducted by a 8944 qualified professional as defined in regulations. If the evaluation indicates a need for mental health, 8945 mental retardationintellectual disability, substance abuse, or behavioral disorder services, the facility shall 8946 provide (i) a notification of the resident's need for such services to the authorized contact person of 8947 record when available and (ii) a notification of the resident's need for such services to the community 8948 services board or behavioral health authority established pursuant to Title 37.2 that serves the city or 8949 county in which the facility is located, or other appropriate licensed provider. The Department shall not 8950 take adverse action against a facility that has demonstrated and documented a continual good faith effort 8951 to meet the requirements of this subsection.

8952 C. The Department shall not order the removal of a resident from an assisted living facility if (i) the 8953 resident, the resident's family, the resident's physician, and the facility consent to the resident's continued stay in the assisted living facility and (ii) the facility is capable of providing, obtaining, or arranging for 8954 8955 the provision of necessary services for the resident, including, but not limited to, home health care 8956 and/or hospice care.

8957 D. Notwithstanding the provisions of subsection C above, assisted living facilities shall not admit or 8958 retain an individual with any of the following conditions or care needs: 8959

1. Ventilator dependency.

8960 2. Dermal ulcers III and IV, except those stage III ulcers that are determined by an independent 8961 physician to be healing.

8962 3. Intravenous therapy or injections directly into the vein except for intermittent intravenous therapy 8963 managed by a health care professional licensed in Virginia or as permitted in subsection E.

8964 4. Airborne infectious disease in a communicable state that requires isolation of the individual or 8965 requires special precautions by the caretaker to prevent transmission of the disease, including diseases 8966 such as tuberculosis and excluding infections such as the common cold.

8967 5. Psychotropic medications without appropriate diagnosis and treatment plans.

8968 6. Nasogastric tubes.

8969 7. Gastric tubes except when the individual is capable of independently feeding himself and caring 8970 for the tube or as permitted in subsection E. 8971

8. An imminent physical threat or danger to self or others is presented by the individual.

8972 9. Continuous licensed nursing care (seven-days-a-week, 24-hours-a-day) is required by the 8973 individual. 8974

10. Placement is no longer appropriate as certified by the individual's physician.

8975 11. Maximum physical assistance is required by the individual as documented by the uniform 8976 assessment instrument and the individual meets Medicaid nursing facility level-of-care criteria as defined 8977 in the State Plan for Medical Assistance, unless the individual's independent physician determines 8978 otherwise. Maximum physical assistance means that an individual has a rating of total dependence in 8979 four or more of the seven activities of daily living as documented on the uniform assessment instrument.

8980 12. The assisted living facility determines that it cannot meet the individual's physical or mental 8981 health care needs.

8982 13. Other medical and functional care needs that the Board determines cannot be met properly in an 8983 assisted living facility.

8984 E. Except for auxiliary grant recipients, at the request of the resident in an assisted living facility and 8985 when his independent physician determines that it is appropriate, (i) care for the conditions or care needs 8986 defined in subdivisions D 3 and D 7 may be provided to the resident by a licensed physician, a licensed 8987 nurse or a nurse holding a multistate licensure privilege under a physician's treatment plan, or a home 8988 care organization licensed in Virginia or (ii) care for the conditions or care needs defined in subdivision 8989 D 7 may also be provided to the resident by facility staff if the care is delivered in accordance with the 8990 regulations of the Board of Nursing for delegation by a registered nurse, 18 VAC 90-20-420 et seq.

8991 The Board shall adopt regulations to implement the provisions of this subsection.

8992 F. In adopting regulations pursuant to subsections A, B, C and D, and E the Board shall consult with 8993 the Departments of Health and Mental Health, Mental Retardation Intellectual Disability and Substance 8994 Abuse Services. 8995

§ 66-18. Examination and placing of such children.

8996 The Department shall make a careful physical and mental examination of every child committed to it 8997 by the courts, investigate the personal and family history of the child and his environment, and place 8998 such children at such facilities as are available. Any children committed to the Department and 8999 afterwards found to be eligible for commitment by proper proceedings to any state hospital or admission 9000 to a training center for the mentally retarded persons with intellectual disability shall take precedence as 9001 to admission over all others and shall in all cases be received into the state hospital or training center 9002 within forty-five days.

9003 § 66-20. Observation and treatment of mentally ill and intellectually disabled children.

9004 After commitment of any child to the Department, if the Department finds, as a result of psychiatric 9005 examinations and case study, that such child is mentally ill or mentally retarded has mental illness or 9006 intellectual disability, it shall be the duty of the Department to obtain treatment for the child's mental condition. If the Department determines that transfer to a state hospital, training center, or other 9007 9008 appropriate treatment facility is required to further diagnose or treat the child's mental condition, the 9009 proceedings shall be in accordance with the provisions of § 37.2-806 or §§ 16.1-341 through 16.1-345, 9010 except that provisions requiring consent of the child's parent or guardian for treatment shall not apply in 9011 such cases. No child transferred to a state hospital pursuant to this section or the provisions of Title 37.2 9012 shall, however, be held or cared for in any maximum security unit where adults determined to be 9013 criminally insane reside and such child shall be kept separate and apart from such adults.

9014 2. That the provisions of this act shall become effective on July 1, 2009. Ŋ
