4. Title: Virginia Bicentennial of the American War of 1812 Commission.

5. Summary: Establishes the Virginia Bicentennial of the American War of 1812 Commission to prepare for and commemorate the 200th anniversary of the war. Composed of 12 members, the commission is authorized to plan commemorative events and activities, encourage research to promote historical literacy and understanding of the war, and support organizations throughout the state as they plan commemorative events. A special nonreverting fund is established to support the commission's activities. The commission expires July 1, 2015.

- 7. **Budget Amendment Necessary:** Yes, new item since this is a new commission. The legislation indicates that a new fund will be established, but is unclear about the source of the new appropriations.
- **8. Fiscal Implications:** Staff support is to be provided by the Division of Legislative Services and all agencies of the Commonwealth shall provide assistance to the commission upon request. The cost of staff support is indeterminate and the legislation is unclear if these agencies will be reimbursed for services rendered. The legislation does contain a clause stipulating that if the commission is not funded by a separate appropriation, the commission may be funded from the operating budgets of the Clerks of the House and Senate for the first year and if the commission is not funded by a separate appropriation the following year the commission shall expire.
