Other comments: Under current law, surplus lines brokers are required to make a good faith search for insurance among admitted insurers resulting in declinations of coverage by three unaffiliated admitted insurers licensed and authorized to write in Virginia the insurance coverage sought. Surplus lines brokers may see the three-declination requirement as unnecessary since brokers are already aware of which companies write certain lines of insurance and which do not. House Bill 298 was introduced by the patron at the request of a local agent's association.
