- **5. Summary:** This bill aligns Virginia's eligibility requirements for participation in the Service-Disabled Veteran-Owned Small Business Program with federal eligibility requirements set by the U.S. Department of Veterans Affairs.
- **6.** Fiscal impact estimates are final. See Item #8.
- 7. Budget amendment necessary: Yes, Item 88.
- **8. Fiscal implications:** This bill will require the Department of Veterans Services (DVS) to certify (upon request of a veteran) that an individual holds a certain disabled status. The bill expands the eligibility for the program from those with a disability rating of 50 percent or greater or 10 percent or greater if combat related, as fixed by the United States Veterans Administration, to those with a disability rating. To certify that a veteran does or does not hold special disabled veteran status, his/her records are pulled from files at the Roanoke office of the United States Department of Veterans Affairs and reviewed by DVS.

DVS can accommodate the provisions of this bill within existing resources, assuming that approximately 200 or fewer applications are received annually. Additional administrative positions may be required should the workload impact DVS operations to a greater degree or if there is an initial "rush" by the increased pool of veteran business owners to get certified.

The Department of Minority Business Enterprise (DMBE) has not yet implemented the Service Disabled Veteran program, though it became law following the 2007 Session. No veterans have yet been certified under the present criteria. Despite an offer of one-time resource assistance from DVS, DMBE cites the need for approximately \$20,000 in technological changes to the agency's certification database and \$71,424 annually to fund a certification officer to support the program.

Neither the House nor the Senate included funding in their amendments to the budget for this legislation.

**9. Specific agency or political subdivisions affected:** Department of Veterans Services, Department of Minority Business Enterprise.

**10. Technical amendment necessary:** This bill is similar to HB 1386. However, consideration may be given to consolidating the two bills since HB 1386 has redefined "small business" on line 86 as "a business, independently owned or operated by one or more persons who are citizens of the United States or non-citizens who are in full compliance with United States immigration law," while HB 680 has not.
