That §§ 16.1-69.48:1, 17.1-275.1, 17.1-275.2, 17.1-275.3, 17.1-275.4, 17.1-275.7, 17.1-275.8, and 11 17.1-275.9 of the Code of Virginia are amended and reenacted as follows: 12 § 16.1-69.48:1. Fixed fee for misdemeanors, traffic infractions and other violations in district court; 13 14 additional fees to be added. 15 A. Assessment of the fees provided for in this section shall be based on: (i) an appearance for court 16 hearing in which there has been a finding of guilty; (ii) a written appearance with waiver of court hearing and entry of guilty plea; (iii) for a defendant failing to appear, a trial in his or her absence 17 resulting in a finding of guilty; (iv) an appearance for court hearing in which the court requires that the 18 19 defendant successfully complete traffic school or a driver improvement clinic, in lieu of a finding of 20 guilty; or (v) a deferral of proceedings pursuant to §§ 4.1-305, 16.1-278.8, 16.1-278.9, 18.2-57.3, 21 18.2-251 or 19.2-303.2. 22 In addition to any other fee prescribed by this section, a fee of \$20 shall be taxed as costs whenever 23 a defendant fails to appear, unless, after a hearing requested by such person, good cause is shown for 24 such failure to appear. No defendant with multiple charges arising from a single incident shall be taxed 25 the applicable fixed fee provided in subsection B, C, or D of this section more than once for a single appearance or trial in absence related to that incident. However, when a defendant who has multiple 26 27 charges arising from the same incident and who has been assessed a fixed fee for one of those charges 28 is later convicted of another charge that arises from that same incident and that has a higher fixed fee, 29 he shall be assessed the difference between the fixed fee earlier assessed and the higher fixed fee. 30 A defendant with charges which arise from separate incidents shall be taxed a fee for each incident 31 even if the charges from the multiple incidents are disposed of in a single appearance or trial in absence. 32 In addition to the fixed fees assessed pursuant to this section, in the appropriate cases, the clerk shall 33 also assess any costs otherwise specifically provided by statute.
