| 11 | 1. That § 23-234 of the Code of Virginia is amended and reenacted as follows: |
| 12 | § 23-234. Powers and duties; jurisdiction. |
| 13 | A. A campus police officer appointed as provided in § 23-233 or appointed and activated pursuant to |
| 14 | § 23-233.1 may exercise the powers and duties conferred by law upon police officers of cities, towns, or |
| 15 | counties, and shall be so deemed, including but not limited to the provisions of Chapters 5 (§ 19.2-52 et |
| 16 | seq.), 7 (§ 19.2-71 et seq.), and 23 (§ 19.2-387 et seq.) of Title 19.2, (i) upon any property owned or |
| 17 | controlled by the relevant public or private institution of higher education, or, upon request, any property |
| 18 | owned or controlled by another public or private institution of higher education and upon the streets, |
| 19 | sidewalks, and highways, immediately adjacent thereto, (ii) pursuant to a mutual aid agreement provided |

investigation and shall provide any assistance requested by the State Police.
