2 *An Act to amend and reenact § 60.2-602 of the Code of Virginia, relating to unemployment*  
3 *compensation; weekly benefit amounts.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 60.2-602 of the Code of Virginia is amended and reenacted as follows:**

8 § 60.2-602. Weekly benefit amount.

9 A. Beginning July 3, 2005, for claims effective on or after July 3, 2005, but before July 2, 2006, an  
10 eligible individual's weekly "benefit amount" shall be the amount appearing in Column B in the "Benefit  
11 Table" in this section on the line on which in Column A of such table, there appears the total wages for  
12 insured work paid to such individual in the two quarters of his base period in which such total wages  
13 were highest.

15 B. Beginning July 2, 2006, for claims effective on or after July 2, 2006, but before July 1, 2007, an  
16 eligible individual's weekly "benefit amount" shall be the amount appearing in Column B in the "Benefit  
17 Table" in this section on the line on which in Column A of such table, there appears the total wages for  
18 insured work paid to such individual in the two quarters of his base period in which such total wages  
19 were highest.

21 C. Beginning July 1, 2007, for claims effective on or after July 1, 2007, but before July 6, 2008, an  
22 eligible individual's weekly "benefit amount" shall be the amount appearing in Column B in the "Benefit  
23 Table" in this section on the line on which in Column A of such table, there appears the total wages for  
24 insured work paid to such individual in the two quarters of his base period in which such total wages  
25 were highest.

27 D. Beginning July 6, 2008, for claims effective on or after July 6, 2008, but before July 5 4, 2009  
28 2010, an eligible individual's weekly "benefit amount" shall be the amount appearing in Column B in  
29 the "Benefit Table" in this section on the line on which in Column A of such table, there appears the  
30 total wages for insured work paid to such individual in the two quarters of his base period in which  
31 such total wages were highest.

33 E. Beginning July 5 4, 2009 2010, for claims effective on or after July 5 4, 2009 2010, an eligible  
34 individual's weekly "benefit amount" shall be the amount appearing in Column B in the "Benefit Table"  
35 in this section on the line on which in Column A of such table, there appears the total wages for insured  
36 work paid to such individual in the two quarters of his base period in which such total wages were  
37 highest.

39 **2. That the provisions of this act enhancing the benefits payable to an individual pursuant to Title**  
40 **60.2 may result in a net revenue loss to the Commonwealth of Virginia. Pursuant to**  
41 **§ 30-19.03:1.2, the estimated amount of the annual net revenue loss is \$750.**
