# Be it enacted by the General Assembly of Virginia:

#### 8 1. That §§ 54.1-2103 and 55-526 of the Code of Virginia are amended and reenacted as follows: 9 § 54.1-2103. Exemptions from chapter. 10

A. The provisions of this chapter shall not apply to:

1. Any person, partnership, association or corporation, or their regular employees, who as owner or 11 lessor perform any of the acts enumerated in §§ 54.1-2100 and 54.1-2101 with reference to property 12 13 owned or leased by them, where the acts are performed in the regular course of or incident to the management of the property and the investment therein; 14

15 2. Any person acting without compensation as attorney-in-fact under a power of attorney issued by a 16 property owner solely for the purpose of authorizing the final performance required of such owner under 17 a contract for the sale, lease, purchase, or exchange of real estate; 18

3. Service rendered by an attorney-at-law in the performance of his duties as such;

19 4. A person acting as a receiver, trustee in bankruptcy, administrator or executor, or any person 20 selling real estate under order of any court;

21 5. A trustee acting under a trust agreement, deed of trust, or will, or the regular salaried employees 22 thereof:

23 6. Any corporation managing rental housing when the officers, directors, and members in the 24 ownership corporation and the management corporation are the same and the management corporation 25 manages no other property for other persons, partnerships, associations, or corporations;

26 7. Any existing tenant of a residential dwelling unit who refers a prospective tenant to the owner of 27 the unit or to the owner's duly authorized agent or employee and for the referral receives, or is offered, 28 a referral fee from the owner, agent or employee;

29 8. Any auctioneer licensed in accordance with Chapter 6 (§ 54.1-600 et seq.) of this title selling real 30 estate at public auction when employed for such purpose by the owner of the real estate and provided 31 the bidding at such auction is held open for no longer than forty-eight hours. An auctioneer shall not 32 advertise that he is authorized to sell real estate. An auctioneer may advertise for sale at public auction 33 any real estate when employed to do so as herein provided, and may advertise that he is authorized to 34 auction real estate at public auction-; 35

9. [Expired.]

36 10. Any person who is licensed and is in good standing as a real estate broker or salesperson in 37 another state, and who assists a prospective purchaser, tenant, optionee, or licensee located in another 38 state to purchase, lease, option, or license an interest in commercial real estate, as defined in § 55-526, 39 in the Commonwealth. Such real estate licensee from another state may be compensated by a real estate 40 broker in the Commonwealth. Nothing in this subdivision shall be construed to permit any person not 41 licensed and in good standing as a real estate broker or salesperson in the Commonwealth to otherwise 42 act as a real estate broker or salesperson under this chapter;

43 B. The provisions of this chapter shall not prohibit the selling of real estate (i) by an attorney-at-law in the performance of his duties as such, (ii) by a receiver, trustee in bankruptcy, administrator or 44 45 executor, a special commissioner or any person selling real estate under order of court, or (iii) by a trustee acting under the trust agreement, deed of trust or will, or the regular salaried employees thereof. 46

47 C. The provisions of this chapter shall not apply to any salaried person employed by a licensed real 48 estate broker for and on behalf of the owner of any real estate or the improvements thereon which the 49 licensed broker has contracted to manage for the owner if the actions of such salaried employee are 50 limited to (i) exhibiting residential units on such real estate to prospective tenants, if the employee is employed on the premises of such real estate; (ii) providing prospective tenants with factual information 51 about the lease of residential real estate; (iii) accepting applications for lease of such real estate; and (iv) 52 53 accepting security deposits and rentals for such real estate. Such deposits and rentals shall be made 54 payable to the owner or the broker employed by such owner. The salaried employee shall not negotiate 55 the amounts of such security deposits or rentals and shall not negotiate any leases on behalf of such 56 owner or broker.

57 D. A licensee of the Board shall comply with the Board's regulations, notwithstanding the fact that 58 the licensee would be otherwise exempt from licensure under subsection A. Nothing in this subsection 59 shall be construed to require a person to be licensed in accordance with this chapter if he would be 50 otherwise exempt from such licensure.

**61** § 55-526. Definitions.

As used in this chapter, unless the context requires a different meaning:

63 "Commercial real estate" means any real estate other than (i) real estate containing one to four 64 residential units or (ii) real estate on which no buildings or structures are located, or (iii) real estate 65 classified for assessment purposes under the provisions of Article 4 (§ 58.1-3230 et seq.) of Chapter 32 66 of Title 58.1. Commercial real estate shall not include single family residential units, including 67 condominiums, townhouses, apartments or homes in a subdivision when leased on a unit by unit basis 68 even though these units may be part of a larger building or parcel of real estate containing more than 69 four residential units.

"Principal broker" shall have the same meaning as provided in the regulations promulgated by theReal Estate Board.
