## VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact § 46.2-301 of the Code of Virginia, relating to restricted driver's licenses 3 for persons who have suspended licenses.

### Approved

#### Be it enacted by the General Assembly of Virginia: 6 7

1. That § 46.2-301 of the Code of Virginia is amended and reenacted as follows: § 46.2-301. Driving while license, permit, or privilege to drive suspended or revoked.

8 9 A. In addition to any other penalty provided by this section, any motor vehicle administratively 10 impounded or immobilized under the provisions of § 46.2-301.1 may, in the discretion of the court, be impounded or immobilized for an additional period of up to 90 days upon conviction of an offender for 11 driving while his driver's license, learner's permit, or privilege to drive a motor vehicle has been suspended or revoked for (i) a violation of §§ 18.2-36.1, 18.2-51.4, 18.2-266 or § 46.2-341.24 or a 12 13 substantially similar ordinance or law in any other jurisdiction or (ii) driving after adjudication as an 14 15 habitual offender, where such adjudication was based in whole or in part on an alcohol-related offense, or where such person's license has been administratively suspended under the provisions of § 46.2-391.2. 16 17 However, if, at the time of the violation, the offender was driving a motor vehicle owned by another person, the court shall have no jurisdiction over such motor vehicle but may order the impoundment or 18 19 immobilization of a motor vehicle owned solely by the offender at the time of arrest. All costs of 20 impoundment or immobilization, including removal or storage expenses, shall be paid by the offender 21 prior to the release of his motor vehicle.

B. Except as provided in §§ 46.2-304 and 46.2-357, no resident or nonresident (i) whose driver's 22 23 license, learner's permit, or privilege to drive a motor vehicle has been suspended or revoked or (ii) who 24 has been directed not to drive by any court or by the Commissioner, or (iii) who has been forbidden, as 25 prescribed by operation of any statute of the Commonwealth or a substantially similar ordinance of any 26 county, city or town, to operate a motor vehicle in the Commonwealth shall thereafter drive any motor 27 vehicle or any self-propelled machinery or equipment on any highway in the Commonwealth until the period of such suspension or revocation has terminated or the privilege has been reinstated or a 28 29 restricted license is issued pursuant to subsection E. A clerk's notice of suspension of license for failure 30 to pay fines or costs given in accordance with § 46.2-395 shall be sufficient notice for the purpose of 31 maintaining a conviction under this section. For the purposes of this section, the phrase "motor vehicle 32 or any self-propelled machinery or equipment" shall not include mopeds.

33 C. A violation of subsection B is a Class 1 misdemeanor. A third or subsequent offense occurring 34 within a 10-year period shall include a mandatory minimum term of confinement in jail of 10 days. 35 However, the court shall not be required to impose a mandatory minimum term of confinement in any 36 case where a motor vehicle is operated in violation of this section in a situation of apparent extreme 37 emergency which requires such operation to save life or limb.

38 D. Upon a violation of subsection B, the court shall suspend the person's license or privilege to drive 39 a motor vehicle for the same period for which it had been previously suspended or revoked. In the event 40 the person violated subsection B by driving during a period of suspension or revocation which was not 41 for a definite period of time, the court shall suspend the person's license, permit or privilege to drive for 42 an additional period not to exceed 90 days, to commence upon the expiration of the previous suspension 43 or revocation or to commence immediately if the previous suspension or revocation has expired.

44 E. Any person who is otherwise eligible for a restricted license may petition each court that 45 suspended his license pursuant to subsection D for authorization for a restricted license, provided that the period of time for which the license was suspended by the court pursuant to subsection D, if 46 measured from the date of conviction, has expired, even though the suspension itself has not expired. A 47 court may, for good cause shown, authorize the Department of Motor Vehicles to issue a restricted 48 license for any of the purposes set forth in subsection E of § 18.2-271.1. No restricted license shall be 49 issued unless each court that issued a suspension of the person's license pursuant to subsection D 50 authorizes the Department to issue a restricted license. Any restricted license issued pursuant to this 51 52 subsection shall be in effect until the expiration of any and all suspensions issued pursuant to subsection 53 D, except that it shall automatically terminate upon the expiration, cancellation, suspension, or 54 revocation of the person's license or privilege to drive for any other cause. No restricted license issued 55 pursuant to this subsection shall permit a person to operate a commercial motor vehicle as defined in 56 the Commercial Driver's License Act (§ 46.2-341.1 et seq.). The court shall forward to the

57 Commissioner a copy of its authorization entered pursuant to this subsection, which shall specifically
58 enumerate the restrictions imposed and contain such information regarding the person to whom such a
59 license is issued as is reasonably necessary to identify the person. The court shall also provide a copy
60 of its authorization to the person, who may not operate a motor vehicle until receipt from the
61 Commissioner of a restricted license. A copy of the restricted license issued by the Commissioner shall
62 be carried at all times while operating a motor vehicle.

63 E F. Any person who operates a motor vehicle or any self-propelled machinery or equipment in 64 violation of the terms of a restricted license issued pursuant to subsection E of § 18.2-271.1 is not guilty 65 of a violation of this section but is guilty of a violation of § 18.2-272.
