095867293 **SENATE BILL NO. 1456** 1 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by the House Committee on Science and Technology 4 5 6 7 on February 18, 2009) (Patron Prior to Substitute—Senator Petersen) A BILL to amend and reenact §§ 2.2-225, 2.2-225.1, 2.2-2218, 2.2-2219, 2.2-2220, 2.2-2221, 2.2-2233.1, 2.2-3705.6, 2.2-3711, and 23-4.4 of the Code of Virginia, and to repeal §§ 2.2-2513 through 8 2.2-2517 of the Code of Virginia, relating to oversight of research and development in the 9 Commonwealth. 10 Be it enacted by the General Assembly of Virginia: That §§ 2.2-225, 2.2-225.1, 2.2-2218, 2.2-2219, 2.2-2220, 2.2-2221, 2.2-2233.1, 2.2-3705.6, 11 1. 2.2-3711, and 23-4.4 of the Code of Virginia are amended and reenacted as follows: 12 13 § 2.2-225. Position established; agencies for which responsible; additional powers. 14 The position of Secretary of Technology (the Secretary) is created. The Secretary shall be responsible 15 to the Governor for the following agencies and boards: Information Technology Investment Board, Innovative Technology Innovation and Entrepreneurship Investment Authority, Virginia Information 16 Technologies Agency, Virginia Geographic Information Network Advisory Board, and the Wireless 17 E-911 Services Board, and the Virginia Research and Technology Advisory Commission. The Governor, 18 by executive order, may assign any other state executive agency to the Secretary, or reassign any agency 19 20 listed in this section to another Secretary. 21 Unless the Governor expressly reserves such power to himself, the Secretary may, with regard to 22 strategy development, planning and budgeting for technology programs in the Commonwealth: 1. Monitor trends and advances in fundamental technologies of interest and importance to the 23 24 economy of the Commonwealth and direct and approve a stakeholder-driven technology strategy 25 development process that results in a comprehensive and coordinated view of research and development 26 goals for industry, academia and government in the Commonwealth. This strategy shall be updated 27 biennially and submitted to the Governor, the Speaker of the House of Delegates and the President Pro 28 Tempore of the Senate. 29 2. Work closely with the appropriate federal research and development agencies and program 30 managers to maximize the participation of Commonwealth industries and universities in these programs 31 consistent with agreed strategy goals. 32 3. Direct the development of plans and programs for strengthening the technology resources of the 33 Commonwealth's high technology industry sectors and for assisting in the strengthening and development of the Commonwealth's Regional Technology Councils. 34 35 4. Direct the development of plans and programs for improving access to capital for 36 technology-based entrepreneurs. 37 5. Assist the Joint Commission on Technology and Science created pursuant to § 30-85 in its efforts 38 to stimulate, encourage, and promote the development of technology in the Commonwealth. 39 6. Continuously monitor and analyze the technology investments and strategic initiatives of other 40 states to ensure the Commonwealth remains competitive. 41 7. Strengthen interstate and international partnerships and relationships in the public and private 42 sectors to bolster the Commonwealth's reputation as a global technology center. 8. Develop and implement strategies to accelerate and expand the commercialization of intellectual 43 44 property created within the Commonwealth. 9. Ensure the Commonwealth remains competitive in cultivating and expanding growth industries, 45 including life sciences, advanced materials and nanotechnology, biotechnology, and aerospace. 46 47 10. Monitor the trends in the availability and deployment of and access to broadband communications services, which include, but are not limited to, competitively priced, high-speed data **48** services and Internet access services of general application, throughout the Commonwealth and 49 advancements in communications technology for deployment potential. The Secretary shall report 50 51 annually by December 1 to the Governor and General Assembly on those trends. § 2.2-225.1. (Expires July 1, 2018) Office of Telework Promotion and Broadband Assistance. 52 53 A. There is hereby established the Office of Telework Promotion and Broadband Assistance in the 54 office of the Secretary of Technology, consisting of a director, appointed by the Secretary of Technology, and such additional telework and broadband professionals as deemed necessary. The goals 55 of the Office are to encourage telework as a family-friendly, business-friendly public policy that 56 promotes workplace efficiency and reduces strain on transportation infrastructure. In conjunction with 57 efforts to promote telework, the Office shall work with public and private entities to develop widespread 58 59

access to broadband services. It shall be the duty of the director of the Office to advise the Secretary

60 and the Board of Directors of the Innovative Technology Innovation and Entrepreneurship Investment 61 Authority, generally.

62 B. The director shall have the following duties:

63 1. Promote and encourage use of telework alternatives for public and private employees, including 64 but not limited to appropriate policy and legislative initiatives.

65 2. Assist state agencies in establishing telework policies.

66 3. Support the efforts of both public and private entities within the Commonwealth to enhance or facilitate the deployment of, and access to competitively priced, advanced electronic communications 67 services (commonly known as broadband) and Internet access services of general application throughout 68 69 the Commonwealth.

70 4. Specifically work towards establishing affordable, accessible broadband services to unserved areas 71 of the Commonwealth and monitor advancements in communication that will facilitate this goal.

72 5. Advocate for, and facilitate the development and deployment of, applications, programs, and services including, but not limited to telework, telemedicine, and e-learning that will bolster the usage of 73 74 and demand for broadband level telecommunications.

6. Serve as a broadband information and applications clearinghouse for the Commonwealth and a 75 76 coordination point for broadband-related services and programs in the Commonwealth. 77

7. Advise the Secretary on broadband adoption, deployment, and application issues.

78 8. Coordinate activities regarding telework with, and regularly report to, a panel consisting of the 79 Secretaries of Administration, Commerce and Trade, Finance, Technology, and Transportation. The Secretary of Technology shall serve as chair of the panel. Additional members may be designated by the 80 Governor. Staff support for the panel shall be provided by the offices of the Secretaries of Technology 81 and Transportation and the Governor shall designate additional agencies to provide staff support as 82 83 necessary.

84 C. The Office shall not have the power to consolidate or otherwise have authority over advanced 85 communications projects being conducted by public or private bodies outside of the executive branch of government. 86 87

§ 2.2-2218. Short title; definitions. 88

A. This article may be cited as the "Innovative Technology Authority Act of 1984, as amended."

89 B. As used in this article, unless the context requires a different meaning:

90 "Project" shall mean the construction, improvement, furnishing, maintenance, acquisition or operation 91 of any facility or the provision for or funding of any activity that will further the purposes described in 92 § 2.2-2219. 93

§ 2.2-2219. Declaration of public purpose; Authority created.

94 A. It is found and determined by the General Assembly that there exists in the Commonwealth of Virginia a need to (i) promote the economic development of the Commonwealth by attracting and 95 96 retaining high technology jobs and businesses in Virginia; (ii) increase industry competitiveness by 97 supporting the application of innovative technologies that improve productivity and efficiency; (iii) 98 mobilize support for high technology industries to commercialize new products and processes, including 99 organizing assistance for small business and supporting select industry sectors and regional high technology efforts; (iv) enhance and expand the scientific and technological research and development 100 capabilities of the institutions of higher education in the Commonwealth and coordinate such capabilities 101 102 with the scientific and technological research and development activities and requirements of the public and private sectors, including transferring technological advances to the private sector; (v) expand 103 knowledge pertaining to scientific and technological research and development among public and private 104 entities; (vi) attract research and development (R&D) facilities and contracts from the federal 105 government and private sector, including coordinating efforts to identify and compete for large federal 106 and private sector R&D facilities, tracking federal technology initiatives and recommending state actions, 107 108 and developing a statewide strategy to compete for large R&D contracts; and (vii) facilitate and 109 coordinate the marketing, organization, utilization and development of scientific and technological 110 research and development in the Commonwealth.

111 B. To achieve the objectives of subsection A, there is created and constituted a political subdivision 112 of the Commonwealth to be known as "The Innovative Technology Innovation and Entrepreneurship Investment Authority." The Authority's exercise of powers conferred by this article shall be deemed to 113 114 be the performance of an essential governmental function and matters of public necessity for which public moneys may be spent and private property acquired. 115 116

§ 2.2-2220. Board of directors; members; President.

117 The Authority shall be governed by a board of directors consisting of 13 members appointed by the 118 Governor as follows: (i) two members shall be the presidents of the major research universities state institutions of higher education, and one member shall represent president representing the other public 119 120 colleges or universities in Virginia. After the original appointments, all appointments of presidents shall be for terms of five years, except that appointments to fill vacancies shall be for the unexpired terms. 121

122 No president shall be eligible to serve for more than two successive five year terms; however, after the 123 expiration of a term of four years or less, or after the expiration of the remainder of a term to which 124 appointed to fill a vacancy, two additional terms may be served by such member if appointed thereto. 125 The state institutions of higher education, appointed by the Governor; (ii) three nonlegislative citizen 126 members appointed by the Governor; (iii) six nonlegislative citizen members appointed by the General 127 Assembly as follows: three nonlegislative citizen members appointed by the Speaker of the House from a 128 list recommended by the House Committee on Science and Technology and the Joint Commission on 129 Technology and Science; three nonlegislative citizen members appointed by the Senate Committee on 130 Rules from a list recommended by the Senate Committee on General Laws and Technology and the Joint 131 Commission on Technology and Science; and (iv) the Secretary of Technology, who shall serve on the 132 Board for a term coincident with his term of office ex officio with full voting privileges. The Governor 133 shall appoint the nine other members of the Board who shall be nominated by established industry groups and technology councils within the Commonwealth. These appointees shall include 134 135 representatives of a variety of businesses, industries and corporations of different types, sizes, locations 136 and stages of development. All members of the Board appointed by the Governor shall be confirmed by 137 each house of the General Assembly.

138 One nonlegislative citizen member appointed by the Governor, one nonlegislative citizen member 139 appointed by the Speaker of the House, and one nonlegislative citizen member appointed by the Senate 140 Committee on Rules shall each have experience as a founding member of a technology company based 141 upon intellectual property that has successfully secured a minimum of \$5 million of institutional venture 142 capital. One nonlegislative citizen member appointed by the Governor, one nonlegislative citizen member 143 appointed by the Speaker of the House, and one nonlegislative citizen member appointed by the Senate 144 Committee on Rules shall each have experience as an institutional venture capital investment partner in 145 a fund with a minimum of \$250 million of limited partner investment and a minimum of five years of 146 fund operations. One nonlegislative citizen member appointed by the Governor, one nonlegislative 147 citizen member appointed by the Speaker of the House, and one nonlegislative citizen member appointed 148 by the Senate Committee on Rules shall each have experience as a senior executive in a technology or scientific research and development company with annual revenues in excess of \$50 million. 149

150 The Secretary of Technology shall serve a term coincident with his term of office. After the original 151 appointments initial staggering of terms, the members of the Board nonlegislative citizen members and 152 *presidents* shall be appointed for terms of four two years. Vacancies in the membership of the Board 153 shall be filled by appointment of the Governor in the same manner as the original appointments for the 154 unexpired portion of the term. No nonlegislative citizen member of the Boardor president shall be 155 eligible to serve for more than two three successive two-year terms; however, after the expiration of a 156 term of four years or less one year, or after the expiration of the remainder of a term to which 157 appointed to fill a vacancy, two three additional terms may be served by such member if appointed 158 thereto. Members of the Board shall be subject to removal from office in like manner as are state, 159 county, town and district officers under the provisions of §§ 24.2-230 through 24.2-238. Immediately 160 after appointment, the members of the Board shall enter upon the performance of their duties.

161 The Board shall annually elect from among its members a chairman and a vice-chairman. The Board 162 shall also elect annually a secretary, who need not be a member of the Board, and may also elect such 163 other subordinate officers who need not be members of the Board, as it deems proper. The chairman, or 164 in his absence, the vice-chairman, shall preside at all meetings of the Board. In the absence of both the 165 chairman and vice-chairman, the Board shall appoint a chairman pro tempore, who shall preside at such 166 meetings.

167 The Board shall employ a President of the Authority, who shall serve at the pleasure of the Board, to 168 direct the day-to-day operations and activities of the Authority and carry out such of the powers and 169 duties conferred upon him by the Board. The President and employees of the Authority shall be 170 compensated in the manner provided by the Board and shall not be subject to the provisions of the 171 Virginia Personnel Act (§ 2.2-2900 et seq.) of this title.

172 § 2.2-2221. Powers of the Authority.

173 The Authority is granted all powers necessary or convenient for the carrying out of its statutory 174 purposes, including, but not limited to, the following rights and powers to:

175 1. Sue and be sued, implead and be impleaded, complain and defend in all courts.

176 2. Adopt, use, and alter at will a corporate seal.

177 3. Acquire, purchase, hold, use, lease or otherwise dispose of any project and property, real, personal 178 or mixed, tangible or intangible, or any interest therein necessary or desirable for carrying out the 179 purposes of the Authority, and, without limitation of the foregoing, to lease as lessee, any project and 180 any property, real, personal or mixed, or any interest therein, at such annual rental and on such terms 181 and conditions as may be determined by the Board and to lease as lessor to any person, any project and 182 any property, real, personal or mixed, tangible or intangible, or any interest therein, at any time acquired 183 by the Authority, whether wholly or partially completed, at such annual rental and on such terms and 184 conditions as may be determined by the Board, and to sell, transfer or convey any property, real, 185 personal or mixed, tangible or intangible or any interest therein, at any time acquired or held by the 186 Authority on such terms and conditions as may be determined by the board of the Authority.

187 4. Plan, develop, undertake, carry out, construct, improve, rehabilitate, repair, furnish, maintain, and 188 operate projects.

189 5. Adopt bylaws for the management and regulation of its affairs. 190

6. Establish and maintain satellite offices within the Commonwealth.

191 7. Fix, alter, charge, and collect rates, rentals, and other charges for the use of projects of, or for the 192 sale of products of or for the services rendered by, the Authority, at rates to be determined by it for the 193 purpose of providing for the payment of the expenses of the Authority, the planning, development, construction, improvement, rehabilitation, repair, furnishing, maintenance, and operation of its projects 194 195 and properties, the payment of the costs accomplishing its purposes set forth in § 2.2-2219, the payment of the principal of and interest on its obligations, and to fulfill the terms and provisions of any 196 197 agreements made with the purchasers or holders of any such obligations.

198 8. Borrow money, make and issue bonds including bonds as the Authority may determine to issue 199 for the purpose of accomplishing the purposes set forth in § 2.2-2219 or of refunding bonds previously issued by the Authority, and to secure the payment of all bonds, or any part thereof, by pledge or deed 200 201 of trust of all or any of its revenues, rentals, and receipts or of any project or property, real, personal or 202 mixed, tangible or intangible, or any interest therein, and to make agreements with the purchasers or 203 holders of such bonds or with others in connection with any such bonds, whether issued or to be issued, 204 as the Authority deems advisable, and in general to provide for the security for the bonds and the rights 205 of holders thereof.

9. Make and enter into all contracts and agreements necessary or incidental to the performance of its 206 207 duties, the furtherance of its purposes and the execution of its powers under this article, including 208 agreements with any person or federal agency.

10. Employ, in its discretion, consultants, attorneys, architects, engineers, accountants, financial 209 210 experts, investment bankers, superintendents, managers and such other employees and agents as may be 211 necessary, and to fix their compensation to be payable from funds made available to the Authority.

212 11. Receive and accept from any federal or private agency, foundation, corporation, association or 213 person grants to be expended in accomplishing the objectives of the Authority, and to receive and accept 214 from the Commonwealth or any state, and any municipality, county or other political subdivision thereof 215 and from any other source, aid or contributions of either money, property, or other things of value, to be 216 held, used and applied only for the purposes for which such grants and contributions may be made.

217 12. Render advice and assistance, and to provide services, to institutions of higher education and to other persons providing services or facilities for scientific and technological research or graduate 218 219 education, provided that credit towards a degree, certificate or diploma shall be granted only if such 220 education is provided in conjunction with an institution of higher education authorized to operate in 221 Virginia.

222 13. Develop, undertake and provide programs, alone or in conjunction with any person or federal 223 agency, for scientific and technological research, technology management, continuing education and 224 in-service training, provided that credit towards a degree, certificate or diploma shall be granted only if 225 such education is provided in conjunction with an institution of higher education authorized to operate in 226 Virginia; to foster the utilization of scientific and technological research information, discoveries and data and to obtain patents, copyrights and trademarks thereon; to coordinate the scientific and 227 228 technological research efforts of public institutions and private industry and to collect and maintain data 229 on the development and utilization of scientific and technological research capabilities. The universities 230 set forth in § 2.2-2220 shall be the principal leading universities in the research institutes.

231 14. Pledge or otherwise encumber all or any of the revenues or receipts of the Authority as security 232 for all or any of the obligations of the Authority.

233 15. Receive, administer, and market any interest in patents, copyrights and materials that were 234 potentially patentable or copyrightable developed by or for state agencies, public institutions of higher 235 education and political subdivisions of the Commonwealth. The Authority shall return to the agency, 236 institution or political subdivision any revenue in excess of its administrative and marketing costs. When 237 general funds are used to develop the patent or copyright or material that was potentially patentable or 238 copyrightable, any state agency, except a public institution of higher education in Virginia, shall return 239 any revenues it receives from the Authority to the general fund unless the Governor authorizes a 240 percentage of the net royalties to be shared with the developer of the patented, copyrighted, or 241 potentially patentable or copyrightable property.

242 16. Develop a comprehensive research and development strategic roadmap for the Commonwealth to 243 identify research areas worthy of institutional focus. Such a roadmap shall incorporate the strategic 244 plan for each research university in the Commonwealth, identify common themes, and make

245 recommendations for alignment of research and development and economic growth in the 246 Commonwealth. In developing the strategic roadmap, the Authority shall solicit feedback from both public and private institutions of higher education in the Commonwealth, as well as the private sector. 247 248 The Authority shall review and update the roadmap at least once every three years. The Authority shall 249 submit the roadmap, and any subsequent updates, to the Governor and the chairmen of the Senate 250 Finance Committee, the House Appropriations Committee, the Senate Committee on General Laws and 251 Technology, and the House Committee on Science and Technology, and the Joint Commission on 252 Technology and Science.

17. Foster innovative partnerships and relationships among the Commonwealth, the Commonwealth's 253 254 state institutions of higher education, the private sector, federal labs, and not-for-profit organizations to 255 improve research and development commercialization efforts.

256 18. Receive and review annual reports from state institutions of higher education regarding the 257 progress of projects funded through the Commonwealth Research Initiative or the Commonwealth 258 Technology Research Fund. The Authority shall develop guidelines, methodologies, and criteria for the 259 reports. The Authority shall aggregate the reports and submit an annual omnibus report on the status of research and development initiatives in the Commonwealth to the Governor and the chairmen of the 260 261 Senate Finance Committee, the House Appropriations Committee, the Senate Committee on General 262 Laws and Technology, and the House Committee on Science and Technology, and the Joint Commission 263 on Technology and Science.

264 19. Develop guidelines for the award of funds from the Commonwealth Technology Research Fund 265 pursuant to § 2.2-2233.1. 266

20. Do all acts and things necessary or convenient to carry out the powers granted to it by law.

§ 2.2-2233.1. Commonwealth Technology Research Fund; continued; purposes; report.

267

268 A. From such funds as may be appropriated by the General Assembly and any gifts, grants, or 269 donations from public or private sources, there is created in the state treasury a special nonreverting, 270 permanent fund, to be known as the Commonwealth Technology Research Fund (the Fund), to be 271 administered by the Authority. The Fund shall be established on the books of the Comptroller. Interest 272 earned on moneys in the Fund shall remain in the Fund and be credited to it. Any moneys remaining in 273 the Fund at the end of each fiscal year, including interest thereon, shall not revert to the general fund 274 but shall remain in the Fund. Expenditures and disbursements from the Fund, which may consist of 275 grants or loans, shall be made by the State Treasurer on warrants issued by the Comptroller upon 276 written request bearing the signature of the chairman or the vice-chairman of the Authority, or, if so 277 authorized by the Authority, bearing his facsimile signature, and the official seal of the Authority.

278 B. Moneys in the Fund shall be used for the sole purpose of attracting public and private research 279 funding for institutions of higher education, in order to increase technological and economic 280 development in Virginia. Awards from the Fund shall be made to Virginia public institutions of higher 281 education or to their associated intellectual property foundations.

282 C. For purposes of awards, the Fund shall have four components: (i) a matching funds program to leverage federal and private research dollars; (ii) a strategic enhancement program to upgrade the 283 284 research capacity of those academic departments that have demonstrated the ability to perform 285 innovative research in technology fields that has strong potential to contribute to economic development 286 in the Commonwealth; (iii) a program to upgrade research capacity in key departments of the 287 institutions in order to attract specific companies to locate or expand in Virginia; and (iv) a program to 288 enhance the capability of the institutions of higher education to commercialize technologies developed 289 through their research.

290 Awards for the matching funds component shall be contingent upon the approval of the institution's 291 grant proposal for federal or private funds.

292 Awards from the Fund shall be matched on at least a dollar-for-dollar basis by the respective 293 institution of higher education, with private funds, or combinations thereof. However, for good cause, 294 this requirement may be waived, in whole or in part, by the chairman of the Authority, provided that 295 such action is reported to the Chairmen of the House Appropriations and Senate Finance Committees at 296 least 10 days prior to the award or disbursement of such funds for such purpose.

297 D. Awards shall be based on scientific merit and economic development potential of research 298 programs in the following fields: aerospace, biotechnology, energy, environmental and information 299 technologies, high performance manufacturing, sensor sciences, telecommunications, and transportation. 300 However, for good cause, awards supporting research in other relevant fields or disciplines may be made 301 by the chairman of the Authority, provided that such action is reported to the Chairmen of the House Appropriations and Senate Finance Committees at least 10 days prior to the award or disbursement of 302 303 such funds for such purpose.

304 Specific guidelines for the award of funds from this program shall be established and maintained by 305 the Authority, in consultation with the Virginia Economic Development Partnership and the State

306 Council of Higher Education. These guidelines shall address, at a minimum, the application process, and
307 the composition and operation of proposal review panels, and give special emphasis to fostering
308 collaboration between institutions of higher education and partnerships between institutions of higher
309 education and business and industry.

Awards from the Fund shall be made by the Authority. The chairman of the Authority shall
 coordinate the evaluation of proposals, to be conducted by and may form review panels with the
 appropriate science and technology expertise, drawn from federal agencies and academic and industrial
 research institutions across the country to assist in reviewing applicants for grants from the Fund.

Recommendations on the grants shall be made by representatives from the Virginia Research and
 Technology Advisory Commission pursuant to § 2.2-2515, the Virginia Economic Development
 Partnership, and the State Council of Higher Education based on the recommendations of the review
 panels.

E. The chairman of the Authority shall provide the Governor and the General Assembly with an annual report to include a detailed list of awards committed, the amount of each approved award, a description of the approved proposals, and the amount of federal or private matching funds anticipated where applicable, and an assessment of the effectiveness of the Fund in attracting public and private research funding and increasing technological and economic development in Virginia.

323 § 2.2-3705.6. Exclusions to application of chapter; proprietary records and trade secrets.

The following records are excluded from the provisions of this chapter but may be disclosed by the custodian in his discretion, except where such disclosure is prohibited by law:

326 1. Proprietary information gathered by or for the Virginia Port Authority as provided in § 62.1-132.4327 or 62.1-134.1.

328 2. Financial statements not publicly available filed with applications for industrial development329 financings in accordance with Chapter 49 (§ 15.2-4900 et seq.) of Title 15.2.

330 3. Confidential proprietary records, voluntarily provided by private business pursuant to a promise of confidentiality from the Department of Business Assistance, the Virginia Economic Development 331 332 Partnership, the Virginia Tourism Authority, the Tobacco Indemnification and Community Revitalization 333 Commission, a nonprofit, nonstock corporation created pursuant to § 2.2-2240.1, or local or regional industrial or economic development authorities or organizations, used by the Department, the 334 335 Partnership, the Authority, or such entities for business, trade and tourism development; and memoranda, 336 working papers or other records related to businesses that are considering locating or expanding in 337 Virginia, prepared by such entities, where competition or bargaining is involved and where, if such 338 records are made public, the financial interest of the governmental unit would be adversely affected.

4. Information that was filed as confidential under the Toxic Substances Information Act (§ 32.1-239
et seq.), as such Act existed prior to July 1, 1992.

5. Fisheries data that would permit identification of any person or vessel, except when required by court order as specified in § 28.2-204.

6. Confidential financial statements, balance sheets, trade secrets, and revenue and cost projections
provided to the Department of Rail and Public Transportation, provided such information is exempt
under the federal Freedom of Information Act or the federal Interstate Commerce Act or other laws
administered by the Surface Transportation Board or the Federal Railroad Administration with respect to
data provided in confidence to the Surface Transportation Board and the Federal Railroad

Discussion or consideration by the Department of Business Assistance, the Virginia Economic 676 Development Partnership, the Virginia Tourism Authority, the Tobacco Indemnification and Community Revitalization Commission, a nonprofit, nonstock corporation created pursuant to § 2.2-2240.1, or local 677 or regional industrial or economic development authorities or organizations of records excluded from **678** 679 this chapter pursuant to subdivision 3 of § 2.2-3705.6.

41. Discussion or consideration by the Board of Education of records relating to the denial, 680 681 suspension, or revocation of teacher licenses excluded from this chapter pursuant to subdivision 13 of **682** § 2.2-3705.3.

683 42. Those portions of meetings of the Virginia Military Advisory Council, the Virginia National **684** Defense Industrial Authority, or a local or regional military affairs organization appointed by a local 685 governing body, during which there is discussion of records excluded from this chapter pursuant to 686 subdivision 12 of § 2.2-3705.2.

687 B. No resolution, ordinance, rule, contract, regulation or motion adopted, passed or agreed to in a 688 closed meeting shall become effective unless the public body, following the meeting, reconvenes in open 689 meeting and takes a vote of the membership on such resolution, ordinance, rule, contract, regulation, or 690 motion that shall have its substance reasonably identified in the open meeting.

691 C. Public officers improperly selected due to the failure of the public body to comply with the other **692** provisions of this section shall be de facto officers and, as such, their official actions are valid until they 693 obtain notice of the legal defect in their election.

694 D. Nothing in this section shall be construed to prevent the holding of conferences between two or 695 more public bodies, or their representatives, but these conferences shall be subject to the same 696 procedures for holding closed meetings as are applicable to any other public body.

697 E. This section shall not be construed to (i) require the disclosure of any contract between the Intervention Program Committee within the Department of Health Professions and an impaired **698** 699 practitioner entered into pursuant to Chapter 25.1 (§ 54.1-2515 et seq.) of Title 54.1 or (ii) require the board of directors of any authority created pursuant to the Industrial Development and Revenue Bond 700 701 Act (§ 15.2-4900 et seq.), or any public body empowered to issue industrial revenue bonds by general or 702 special law, to identify a business or industry to which subdivision A 5 applies. However, such business 703 or industry shall be identified as a matter of public record at least 30 days prior to the actual date of the 704 board's authorization of the sale or issuance of such bonds. 705

§ 23-4.4. Authorization to transfer interest; Governor's approval required under certain circumstances.

706 A. The boards of visitors, the State Board for Community Colleges, or their designees are authorized 707 to assign any interest they possess in intellectual property or in materials in which the institution claims an interest, provided such assignment is in accordance with the terms of the institution's intellectual property policies adopted pursuant to subsection A of § 23-4.3. However, the Governor's prior written 708 709 710 approval shall be required for transfers of such property developed wholly or predominately through the 711 use of state general funds, exclusive of capital assets, and either (i) such property was developed by an 712 employee of the institution acting within the scope of his assigned duties, or (ii) such property is to be 713 transferred to an entity other than the Innovative Technology Innovation and Entrepreneurship Investment Authority, an entity whose purpose is to manage intellectual properties on behalf of nonprofit 714 organizations, colleges and universities, or an entity whose purpose is to benefit the respective 715 institutions. The Governor may attach conditions to these transfers as he deems necessary. In the event 716 717 the Governor does not approve such transfer, the materials shall remain the property of the respective 718 institutions and may be used and developed in any manner permitted by law.

B. The president of each state-supported institution of higher education, including the chancellor of 719 720 the Virginia Community College System, shall report annually to the Governor and the Joint 721 Commission on Technology and Science regarding the assignment of any intellectual property interests 722 by that institution.

723 2. That §§ 2.2-2513 through 2.2-2517 of the Code of Virginia are repealed.

724 3. That all appointments to the Innovative Technology Authority, as it exists June 30, 2009, shall 725 expire on July 1, 2009. New appointments shall be made to the Innovation and Entrepreneurship 726 Investment Authority, its successor in interest, pursuant to the provisions of this act. The initial 727 appointment of members in accordance with this act shall be staggered as follows: one of the presidents of a major research state institution of higher education and the president representing 728 729 other state institutions of higher education for terms of one year; one president of a major 730 research state institution of higher education for a term of two years; the Governor's, Speaker's, 731 and Senate Committee on Rules' appointees with entrepreneurial and investment experience for terms of one year; the Governor's, Speaker's, and Senate Committee on Rules' appointees with 732 733 industry experience for terms of two years.

4. That as of the effective date of this act, the Innovation and Entrepreneurship Investment 734 735 Authority shall be deemed the successor in interest to the Innovative Technology Authority. 736 Without limiting the foregoing, all right, title and interest in and to any real or tangible personal

- 737 property vested in the Innovative Technology Authority as of the effective date of this act shall be
- 738 transferred to and taken as standing in the name of the Innovation and Entrepreneurship 739 Investment Authority.
