2 *An Act to amend and reenact § 2.2-2699.1 of the Code of Virginia, relating to the Aerospace Advisory*
3 *Council; membership.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 2.2-2699.1 of the Code of Virginia is amended and reenacted as follows:**

8 § 2.2-2699.1. (Expires July 1, 2010) Aerospace Advisory Council; purpose; membership;
9 compensation; chairman.

10 A. The Aerospace Advisory Council (the Council) is established as an advisory council, within the
11 meaning of § 2.2-2100, in the executive branch of state government. The purpose of the Council shall be
12 to advise the Governor on policy and funding priorities to promote the aerospace and space exploration
13 industry in the Commonwealth.

14 B. The Council shall have a total membership of ~~13~~ 14 members that shall consist of four legislative
15 members and 9 10 nonlegislative citizen members. Members shall be appointed as follows: three
16 members of the House of Delegates to be appointed by the Speaker of the House of Delegates in
17 accordance with the principles of proportional representation contained in the Rules of the House of
18 Delegates; one member of the Senate, to be appointed by the Senate Committee on Rules and ~~nine~~ 10
19 nonlegislative citizen members, of whom one shall represent the Mid-Atlantic Regional Spaceport, one
20 shall represent Old Dominion University, and one shall represent Virginia Tech, to be appointed by the
21 Governor. *The Director of the Virginia Space Grant Consortium shall serve as an ex officio member*
22 *with voting privileges.* A representative of NASA Wallops Flight Facility, a representative of NASA's
23 Langley Research Center, and a representative of the National Institute of Aerospace, all to be appointed
24 by the Governor, shall serve as ex- officio liaisons to the Council with nonvoting privileges. Legislative
25 members shall serve terms coincident with their terms of office. Other members shall be appointed for
26 terms of two years. Appointments to fill vacancies, other than by expiration of a term, shall be for the
27 unexpired terms. Vacancies shall be filled in the same manner as the original appointments. All
28 members may be reappointed.

29 C. Legislative members of the Council shall receive such compensation as provided in § 30-19.12.
30 Nonlegislative citizen members shall serve without compensation. All members shall be reimbursed for
31 all reasonable and necessary expenses incurred in the performance of their duties as provided in
32 §§ 2.2-2813 and 2.2-2825. Funding for compensation and expenses of legislative members shall be
33 provided by the operating budgets of the Clerk of the House of Delegates and the Clerk of the Senate
34 upon approval of the Joint Rules Committee. Funding for the costs of expenses of the nonlegislative
35 citizen members and all other expenses of the Council shall be provided by the Office of the Secretary
36 of Technology.

37 D. The Council shall elect a chairman and a vice-chairman annually from among its membership. A
38 majority of the members shall constitute a quorum. The Council shall meet at such times as may be
39 called by the chairman or a majority of the Council.

40 E. Staff to the Council shall be provided by the Office of the Secretary of Technology.
