10	Be it enacted by the General Assembly of Virginia:
11 12	1. That § 4.1-225 of the Code of Virginia is amended and reenacted as follows:
12	§ 4.1-225. Grounds for which Board may suspend or revoke licenses.
13 14	The Board may suspend or revoke any license other than a brewery license, in which case the Board may impose penalties as provided in § 4.1-227, if it has reasonable cause to believe that:
14	1. The licensee, or if the licensee is a partnership, any general partner thereof, or if the licensee is an
16	association, any member thereof, or a limited partner of 10 percent or more with voting rights, or if the
17	licensee is a corporation, any officer, director, or shareholder owning 10 percent or more of its capital
18	stock, or if the licensee is a limited liability company, any member-manager or any member owning 10
19	percent or more of the membership interest of the limited liability company:
20	a. Has misrepresented a material fact in applying to the Board for such license;
21	b. Has defrauded or attempted to defraud the Board, or any federal, state or local government or
22	governmental agency or authority, by making or filing any report, document or tax return required by
23	statute or regulation which is fraudulent or contains a false representation of a material fact; or has
24	willfully deceived or attempted to deceive the Board, or any federal, state or local government, or
25	governmental agency or authority, by making or maintaining business records required by statute or
26	regulation which are false or fraudulent;
27	c. Within the five years immediately preceding the date of the hearing held in accordance with
28	§ 4.1-227, has (i) been convicted of a violation of any law, ordinance or regulation of the
29	Commonwealth, of any county, city or town in the Commonwealth, of any state, or of the United States,
30	applicable to the manufacture, transportation, possession, use or sale of alcoholic beverages; (ii) violated
31	any provision of Chapter 3 (§ 4.1-300 et seq.) of this title; (iii) committed a violation of the Wine
32 33	Franchise Act (§ 4.1-400 et seq.) or the Beer Franchise Act (§ 4.1-500 et seq.) in bad faith; (iv) violated or failed or refused to comply with any regulation, rule or order of the Board; or (v) failed or refused to
33 34	or failed or refused to comply with any regulation, rule or order of the Board; or (v) failed or refused to comply with any of the conditions or restrictions of the license granted by the Board;
35	d. Has been convicted in any court of a felony or of any crime or offense involving moral turpitude
36	under the laws of any state, or of the United States;
37	e. Is not the legitimate owner of the business conducted under the license granted by the Board, or
38	other persons have ownership interests in the business which have not been disclosed;
39	f. Cannot demonstrate financial responsibility sufficient to meet the requirements of the business
40	conducted under the license granted by the Board;
41	g. Has been intoxicated or under the influence of some self-administered drug while upon the
42	licensed premises;
43	h. Has allowed noisy, lewd or disorderly conduct upon the licensed premises, or has maintained such
44	premises in an unsanitary condition, or allowed such premises to become a meeting place or rendezvous
45	for persons of ill repute, or has allowed any form of illegal gambling to take place upon such premises;
46	i. Knowingly employs in the business conducted under such license, as agent, servant, or employee,
47	other than a busboy, cook or other kitchen help, any person who has been convicted in any court of a
48	felony or of any crime or offense involving moral turpitude, or who has violated the laws of the
49 50	Commonwealth, of any other state, or of the United States, applicable to the manufacture, transportation,
50 51	possession, use or sale of alcoholic beverages;
51 52	j. Subsequent to the granting of his original license, has demonstrated by his police record a lack of respect for law and order:
52 53	respect for law and order; k. Has allowed the consumption of alcoholic beverages upon the licensed premises by any person
55 54	whom he knew or had reason to believe was (i) less than 21 years of age, (ii) interdicted, or (iii)
55	intoxicated, or has allowed any person whom he knew or had reason to believe was intoxicated to loiter
56	upon such licensed premises;

57 1. Has allowed any person to consume upon the licensed premises any alcoholic beverages except as
58 provided under this title;

59 m. Is physically unable to carry on the business conducted under such license or has been 60 adjudicated incapacitated;

61 n. Has allowed any lewd, obscene or indecent literature, pictures or materials upon the licensed 62 premises; 63

o. Has possessed any illegal gambling apparatus, machine or device upon the licensed premises; or

64 p. Has upon the licensed premises (i) illegally possessed, distributed, sold or used, or has knowingly 65 allowed any employee or agent, or any other person, to illegally possess, distribute, sell or use marijuana, controlled substances, imitation controlled substances, drug paraphernalia or controlled paraphernalia as those terms are defined in Articles 1 and 1.1 (§ 18.2-247 et seq.) of Chapter 7 of Title 66 67 18.2 and the Drug Control Act (§ 54.1-3400 et seq.); (ii) laundered money in violation of § 18.2-246.3; 68 or (iii) conspired to commit any drug-related offense in violation of Articles 1 and 1.1 of Chapter 7 69 (§ 18.2-247 et seq.) of Title 18.2 or the Drug Control Act (§ 54.1-3400 et seq.). The provisions of this 70 subdivision shall also apply to any conduct related to the operation of the licensed business which facilitates the commission of any of the offenses set forth herein. 71 72 73

2. The place occupied by the licensee:

74 a. Does not conform to the requirements of the governing body of the county, city or town in which such establishment is located, with respect to sanitation, health, construction or equipment, or to any 75 similar requirements established by the laws of the Commonwealth or by Board regulations; 76 77

b. Has been adjudicated a common nuisance under the provisions of this title or § 18.2-258; or

78 c. Has become a meeting place or rendezvous for illegal gambling, illegal users of narcotics, drunks, 79 prostitutes, pimps, panderers or habitual law violators or has become a place where illegal drugs are regularly used or distributed. The Board may consider the general reputation in the community of such 80 establishment in addition to any other competent evidence in making such determination. 81

3. The licensee or any employee of the licensee discriminated against any member of the armed 82 83 forces of the United States by prices charged or otherwise.

4. The licensee, his employees, or any entertainer performing on the licensed premises has been 84 convicted of a violation of a local public nudity ordinance for conduct occurring on the licensed 85 premises and the licensee allowed such conduct to occur. 86

87 5. Any cause exists for which the Board would have been entitled to refuse to grant such license had 88 the facts been known.

6. Any other cause authorized by this title. 89
