089511216 **SENATE BILL NO. 796** 1 2 FLOOR AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by Senator Cuccinelli 4 on March 4, 2008) 5 (Patron Prior to Substitute—Senator Barker) 6 A BILL to amend and reenact §§ 24.2-603, 24.2-700, and 24.2-701 of the Code of Virginia, relating to 7 elections; polling hours; absentee voting provisions. 8 Be it enacted by the General Assembly of Virginia: 9 1. That §§ 24.2-603, 24.2-700, and 24.2-701 of the Code of Virginia are amended and reenacted as 10 follows: 11 § 24.2-603. Hours polls to be open; closing the polls. 12 At all elections, the polls shall be open at each polling place at 6:00 a.m. on the day of the election and closed at 7:00 8:00 p.m. on the same day. 13 14 At 6:45 7:45 p.m. an officer of election shall announce that the polls will close in fifteen 15 minutes. 15 The officers of election shall list the names of all identify the end of the line of qualified voters in line 16 before the polling place at 7:00 8:00 p.m. and permit those voters and no others to vote after 7:00 8:0017 p.m. 18 The State Board shall prescribe appropriate procedures to implement this section. 19 § 24.2-700. Persons entitled to vote by absentee ballot. 20 The following registered voters may vote by absentee ballot in accordance with the provisions of this 21 chapter in any election in which they are qualified to vote: 1. Any person who, in the regular and orderly course of his business, profession, or occupation or 22 23 while on personal business or vacation, will be absent from the county or city in which he is entitled to 24 vote: 25 2. Any person who is (i) a member of a uniformed service of the United States, as defined in 42 26 U.S.C. § 1973ff-6 (7), on active duty, or (ii) a member of the merchant marine of the United States, or 27 (iii) who temporarily resides outside of the United States, or (iv) the spouse or dependent residing with 28 any person listed in (i), (ii), or (iii), and who will be absent on the day of the election from the county 29 or city in which he is entitled to vote: 30 3. Any student attending a school or institution of learning, or his spouse, who will be absent on the 31 day of election from the county or city in which he is entitled to vote; 32 4. Any person who is unable to go in person to the polls on the day of election because of a 33 physical disability or physical illness; 34 5. Any person who is confined while awaiting trial or for having been convicted of a misdemeanor, 35 provided that the trial or release date is scheduled on or after the third day preceding the election. Any person who is awaiting trial and is a resident of the county or city where he is confined shall, on his 36 37 request, be taken to the polls to vote on election day if his trial date is postponed and he did not have 38 an opportunity to vote absentee; 39 6. Any person who is a member of an electoral board, registrar, officer of election, or custodian of 40 voting equipment; 41 7. Any duly registered person who is unable to go in person to the polls on the day of the election 42 because he is primarily and personally responsible for the care of an ill or disabled family member who 43 is confined at home; 44 8. Any duly registered person who is unable to go in person to the polls on the day of the election 45 because of an obligation occasioned by his religion; or 9. Any person who, in the regular and orderly course of his business, profession, or occupation, will 46 47 be at his place of work and commuting to and from his home to his place of work for eleven 11 or **48** more hours of the thirteen 14 hours that the polls are open pursuant to § 24.2-603. 49 § 24.2-701. Application for absentee ballot. 50 A. The State Board shall furnish each general registrar with a sufficient number of applications for 51 official absentee ballots. The registrars shall furnish applications to persons requesting them. The State Board shall implement a system that enables eligible persons to request and receive an 52 53 absentee ballot application electronically through the Internet. Electronic absentee ballot applications 54 shall be in a form approved by the State Board. Except as provided in § 24.2-703, a separate application shall be completed for each election in 55 which the applicant offers to vote. An application for an absentee ballot may be accepted the later of (i) 56 57 12 months before an election, or (ii) the day following any election held in the twelfth month prior to the election in which the applicant is applying to vote. 58 59 Any application received before the ballots are printed shall be held and processed as soon as the

60 printed ballots for the election are available.

For the purposes of this chapter, the general registrar's office shall be open a minimum of eight 61 hours between the hours of 8:00 a.m. and 5:00 p.m. on the first and second Saturday immediately 62 63 preceding all general elections, except May general elections held in towns, and on the Saturday 64 immediately preceding any primary election, May general election held in a town, or special election.

65 Unless physically disabled, all applications for absentee ballots shall be signed by the applicant who 66 shall state, subject to felony penalties for making false statements pursuant to § 24.2-1016, that to the best of his knowledge and belief the facts contained in the application are true and correct and that he 67 has not and will not vote in the election at any other place in Virginia or in any other state. If the 68 69 applicant is unable to sign the application, a person assisting the applicant will note this fact on the 70 applicant signature line and provide his signature, name, and address. 71

B. Applications for absentee ballots shall be completed in the following manner:

72 1. An application completed in person shall be made not less than three days prior to the election in which the applicant offers to vote and completed only in the office of the general registrar. The 73 74 applicant shall sign the application in the presence of a registrar or a member of the electoral board. The 75 applicant shall provide one of the forms of identification specified in subsection B of § 24.2-643, or if he is unable to present one of the forms of identification listed in that section, he shall sign a statement, 76 77 subject to felony penalties for making false statements pursuant to § 24.2-1016, that he is the named 78 registered voter who he claims to be. An applicant who requires assistance in voting by reason of 79 physical disability or inability to read or write may request assistance pursuant to § 24.2-649 and be 80 assisted in preparation of this statement in accordance with that section. The provisions of § 24.2-649 regarding persons who are unable to sign shall be followed when assisting an applicant in completing 81 82 this statement.

83 For federal elections held after January 1, 2004, this paragraph shall apply in the case of any voter 84 who is required by subparagraph (b) of 42 U.S.C.S. § 15483 of the Help America Vote Act of 2002 to 85 show identification the first time that voter votes in a federal election in the state. After completing an application for an absentee ballot in person, such voter shall present: (i) a current and valid photo 86 87 identification; or (ii) a copy of a current utility bill, bank statement, government check, paycheck or 88 other document that shows the name and address of the voter. Such individual who desires to vote in 89 person but who does not show one of the forms of identification specified in this paragraph shall be 90 offered a provisional ballot under the provisions of § 24.2-653. Neither the identification requirements of subsection B of § 24.2-643, nor the identification requirements of subsection A of § 24.2-653, shall 91 apply to such voter at that election. The State Board of Elections shall provide instructions to the 92 93 electoral boards for the handling and counting of such provisional ballots pursuant to subsection B of 94 § 24.2-653 and this section.

95 2. Any other application may be made by mail, electronic or telephonic transmission to a facsimile 96 device if one is available to the office of the general registrar or the office of the State Board if a device is not available locally, or other means. The application shall be on a form furnished by the registrar or, if made under subdivision 2 of § 24.2-700, may be on a Federal Post Card Application 97 98 99 prescribed pursuant to 42 U.S.C. § 1973ff (b) (2). The Federal Post Card Application may be accepted 100 the later of (i) 12 months before an election, or (ii) the day following any election held in the twelfth month prior to the election in which the applicant is applying to vote. The application shall be made to 101 102 the appropriate registrar no later than 5:00 p.m. on the seventh day prior to the election in which the 103 applicant offers to vote. 104

C. Applications for absentee ballots shall contain the following information:

105 1. The applicant's printed name, the last four digits of the applicant's social security number, and the 106 reason the applicant will be absent or cannot vote at his polling place on the day of the election;

107 2. A statement that he is registered in the county or city in which he offers to vote and his residence 108 address in such county or city. Any person temporarily residing outside the United States shall provide 109 the last date of residency at his Virginia residence address, if that residence is no longer available to him. Any person who makes application under subdivision 2 of § 24.2-700 who is not a registered voter 110 111 may file the applications to register and for a ballot simultaneously;

112 3. The complete address to which the ballot is to be sent directly to the applicant, unless the application is made in person at a time when the printed ballots for the election are available and the 113 114 applicant chooses to vote in person at the time of completing his application. The address given shall be either the address of the applicant on file in the registration records or the address at which he will be 115 116 located while absent from his county or city. No ballot shall be sent to, or in care of, any other person; 117 and

4. In the case of a person, or the spouse or dependent of a person, who is on active service as a 118 119 member of the armed forces of the United States or a member of the merchant marine of the United 120 States, the branch of service to which he or the spouse belongs, and his or the spouse's rank, grade, or rate, and service identification number; or 121

122 5. In the case of a student, or the spouse of a student, who is attending a school or institution of123 learning, the name and address of the school or institution of learning; or

6. In the case of a person who is unable to go in person to the polls on the day of the electionbecause of a physical disability or physical illness, the nature of the illness or disability; or

126 7. In the case of a person who is confined awaiting trial or for having been convicted of a127 misdemeanor, the name and address of the institution of confinement; or

128 8. In the case of a person who will be absent on election day for business reasons, the name of his129 employer or business; or

9. In the case of a person who will be absent on election day for personal business or vacationreasons, the name of the county or city in Virginia or the state or country to which he is traveling; or

132 10. In the case of a person who is unable to go to the polls on the day of election because he is
133 primarily and personally responsible for the care of an ill or disabled family member who is confined at
134 home, the name of the family member and the nature of his illness or disability; or

135 11. In the case of a person who is unable to go to the polls on the day of election because of an obligation occasioned by his religion, his religion and the nature of the obligation; or

137 12. In the case of a person who, in the regular and orderly course of his business, profession, or
138 occupation, will be at his place of work and commuting to and from his home to his place of work for
139 11 or more hours of the 13 14 hours that the polls are open pursuant to § 24.2-603, the name of his
140 business or employer, address of his place of work, and hours he will be at the workplace and
141 commuting on election day.
