4	A BILL to amend and reenact § 30-275 of the Code of Virginia, relating to the membership of the
5	Manufacturing Development Commission.

10	Be it enacted by the General Assembly of Virginia:
11	1. That § 30-275 of the Code of Virginia is amended and reenacted as follows:
12	§ 30-275. (For contingent expiration date - See Editor's note) Manufacturing Development
13	Commission; purpose; membership; terms; compensation and expenses; staff; voting on
14	recommendations.
15	A. The Manufacturing Development Commission (the Commission) is established in the legislative
16	branch of state government. The purpose of the Commission shall be to assess manufacturing needs and
17	formulate legislative and regulatory remedies to ensure the future of the manufacturing sector in
18	Virginia.
19	B. The Commission shall have a total membership of 13 14 that shall consist of eight legislative
20	members, four five nonlegislative citizen members, and one ex officio member. Members shall be
21	appointed as follows: three members of the Senate, to be appointed by the Senate Committee on Rules;
22	five members of the House of Delegates, to be appointed by the Speaker of the House of Delegates in
$\overline{23}$	accordance with the principles of proportional representation contained in the Rules of the House of
24	Delegates; and four five nonlegislative citizen members of whom (i) one shall be a representative of a
25	public institution of higher education other than Norfolk State University or Virginia State University,
26	<i>(ii)</i> one shall be a representative of an entity or organization active in economic development efforts in
27	the Commonwealth, (<i>iii</i>) one shall be a representative of a Virginia manufacturer, and (<i>iv</i>) one shall be
28	the president of the Virginia Manufacturers Association, and (v) one shall be a representative of Norfolk
2 9	State University or Virginia State University, to be appointed by the Governor. The Secretary of
30	Commerce and Trade or his designee shall serve ex officio with voting privileges. Nonlegislative citizen
31	members shall be citizens of the Commonwealth.
32	Nonlegislative citizen members shall be appointed for terms of four years. Legislative members, the
33	president of the Virginia Manufacturers Association, and ex officio members shall serve terms coincident
34	with their terms of office. All members may be reappointed for successive terms. Appointments to fill
35	vacancies, other than by expiration of a term, shall be for the unexpired terms. Vacancies shall be filled
36	in the same manner as the original appointments.
37	C. The members of the Commission shall elect a chairman and a vice-chairman annually, who shall
38	be members of the General Assembly. A majority of the members of the Commission shall constitute a
39	quorum. The Commission shall meet at the call of the chairman or whenever a majority of the members
40	so request.
41	D. Legislative members of the Commission shall receive such compensation as is set forth in
42	§ 30-19.12. Nonlegislative citizen members shall serve without compensation. All members shall be
43	reimbursed for all reasonable and necessary expenses incurred in the performance of their duties as
44	provided in §§ 2.2-2813 and 2.2-2825. Funding for compensation and reimbursement of expenses of the
45	members shall be provided from existing appropriations to the Commission. Costs of this Commission
46	shall not exceed \$12,000 per year.
47	E. Administrative staff support shall be provided by the Office of the Clerk of the Senate or the
48	Office of the Clerk of the House of Delegates as may be appropriate for the house in which the
49	chairman of the Commission serves. The Division of Legislative Services shall provide legal, research,
50	policy analysis, and other services as requested by the Commission. Technical assistance shall be
51	provided by the Department of Mines, Minerals and Energy. All agencies of the Commonwealth shall
52	assist the Commission, upon request.
53	F. No recommendation of the Commission shall be adopted if a majority of the Senate members or a
54	majority of the House members appointed to the Commission (i) votes against the recommendation and
55	(ii) votes for the recommendation to fail notwithstanding the majority vote of the Commission.
