4. Title: Unemployment benefits; minimum earnings requirement

- **5. Summary:** The bill postpones the scheduled increase in the minimum amount of wages an employee must have earned in the two highest earnings quarters of his base period in order to be eligible for unemployment benefits. The increase, from \$2,700 to \$3,000, will apply to claims filed on or after July 4, 2010; it is currently scheduled to apply to claims filed on or after July 5, 2009.

- **7. Budget Amendment Necessary:** No. The increase to Item 125 of Senate Bill 850 for payment of unemployment benefits may be made administratively for fiscal year 2010.
- **8. Fiscal Implications:** The Virginia Employment Commission estimates deferring until July 2010 the increase in minimum earnings requirement from \$2,700 to \$3,000 will increase the unemployment tax cost per employee by an average of \$0.22 in 2012 and \$0.28 in 2013.

Payment of unemployment taxes lowers corporations' taxable income. The impact on general fund revenues is estimated at an average reduction of \$2,000 annually from 2012 to 2014 as a result of the bill
