4. Title: Virginia Retirement System; superintendents and sworn officers of regional jails.

5. Summary: Virginia Retirement System; superintendents and sworn officers of regional jails. Requires localities participating in the Virginia Retirement System and participating in a regional jail to provide retirement benefits comparable to the benefits provided to state police officers to the regional jail's superintendent (1.85% benefit multiplier, 50/25 age and service requirement for unreduced benefits and the annual supplement payable until the member is eligible for unreduced Social Security benefits) and sworn officers (1.70% benefit multiplier, 50/25 age and service requirement for unreduced benefits and the annual supplement payable until the member is eligible for unreduced Social Security benefits). Regional Jails may elect to provide a 1.85% benefit multiplier for the sworn officers.
