3. Committee: Appropriation subcommittee Technology and Government Oversight

4. Title: Government Efficiency Review Commission

5. Summary: Establishes the Government Efficiency Review Commission to review agencies on an eight-year cycle and advise the General Assembly on the elimination of waste, duplication, and inefficiency on the part of such agencies. The bill also repeals the Legislative Program Review and Evaluation Act (§ 30-64 et seq.) and makes some technical amendments. The Commission shall consist of 14 members, including 10 legislative members, as follows: (i) six members of the House of Delegates to be appointed by the Speaker of the House of Delegates, (ii) four members of the Senate to be appointed by the Senate Committee on Rules, (iii) the Lieutenant Governor, and (iv) three citizen members appointed by the Governor. The bill authorizes the Commission to hire an executive director and staff.

8. Fiscal Implications:

HB 2463 sets forth the various duties and responsibilities of the proposed Commission (with the approval of the members of the Commission) and allows for a compensated executive director and "such other persons as it deems necessary" to carry out its duties. As such, the following staff are assumed for the proposed Commission:

Total Personnel Costs	\$383,971

Non personnel costs including office space, phones, leased copier, desktops, printer, office supplies and office furniture are estimated at **\$38,809**.

In addition to professional staff, the proposed Commission would consist of 14 board members. The associated costs for those members are estimated below:

Commission members (10 General Assembly members, three citizens, and the Lieutenant Governor): 14¹

Meetings per year when the GA is not in session: 3

Using the House of Delegates standard estimate, meeting costs are estimated at \$75 per person per meeting. With 13 reimbursement-eligible members meeting about three times during the year, the estimated cost is **\$2,925**.

Total estimate including staff \$425,705

9. Specific Agency or Political Subdivisions Affected:

The Auditor of Public Accounts, the Joint Legislative Audit and Review Commission, and the Department of Planning and Budget would be the primary assisting agencies but all agencies impacted by the Commission's work would be affected." It is not known how much increased workload, if any, would be placed on state agencies providing assistance to the Commission.
