**Be it enacted by the General Assembly of Virginia:**

**1. That §§ 24.2-209, 24.2-216, 24.2-226, 24.2-442, 24.2-443.3, 24.2-507, 24.2-510, 24.2-516, 24.2-522, 24.2-524, 24.2-527, 24.2-536, 24.2-537, 24.2-538, 24.2-612, 24.2-702.1, 24.2-703, 24.2-706, and 24.2-709 of the Code of Virginia are amended and reenacted as follows:**

§ 24.2-209. Filling vacancies in House of Representatives.

When any vacancy occurs in the representation of the Commonwealth of Virginia in the House of Representatives, or when a representative-elect dies or resigns, the Governor shall issue a writ of election to fill the vacancy. Upon receipt of written notification by a representative or representative-elect of his resignation as of a stated date, the Governor may immediately issue a writ to call the election. The representative's or representative-elect's resignation shall not be revocable after the date stated by him for his resignation or after the ~~thirtieth~~ *forty-fifth* day before the date set for the special election.

§ 24.2-216. Filling vacancies in the General Assembly.

When a vacancy occurs in the membership of the General Assembly during the recess of the General Assembly or when a member-elect to the next General Assembly dies, resigns, or becomes legally incapacitated to hold office prior to its meeting, the Governor shall issue a writ of election to fill the vacancy. If the vacancy occurs during the session of the General Assembly, the Speaker of the House of Delegates or the President pro tempore of the Senate, as the case may be, shall issue the writ unless the respective house by rule or resolution shall provide otherwise. Upon receipt of written notification by a member or member-elect of his resignation as of a stated date, the Governor, Speaker, or President Pro Tempore, as the case may be, may immediately issue the writ to call the election. The member's or member-elect's resignation shall not be revocable after the date stated by him for his resignation or after the ~~thirtieth~~ *forty-fifth* day before the date set for the special election.

The writ shall be directed to the secretaries of the electoral boards of the respective counties and cities composing the district for which the election is to be held.

Notwithstanding any provision of law to the contrary, no election to fill a vacancy shall be ordered or held if the general or special election at which it is to be called is scheduled within 75 days of the end of the term of the office to be filled.

§ 24.2-226. Election to fill vacancy.

A. A vacancy in any elected local office, whether occurring when for any reason an officer-elect does not take office or occurring after an officer begins his term, shall be filled by special election except as provided for certain towns by § 24.2-228 or for constitutional officers as provided in § 24.2-228.1, or unless provided otherwise by statute or charter. The governing body or, in the case of an elected school board, the school board of the county, city, or town in which the vacancy occurs shall, within 15 days of the occurrence of the vacancy, petition the circuit court to issue a writ of election to fill the vacancy as set forth in Article 5 (§ 24.2-681 et seq.) of Chapter 6. Either upon receipt of the petition or on its own motion, the court shall issue the writ ordering the election for the next ensuing general election to be held in November in the case of county, city, or town officers regularly elected in November, or in May in the case of other city and town officers. If the vacancy occurs within 120 days prior to that election, however, the writ shall order the election to be held at the second ensuing such general election. Upon receipt of written notification by an officer or officer-elect of his resignation as of a stated date, the governing body or school board, as the case may be, may immediately petition the circuit court to issue a writ of election, and the court may immediately issue the writ to call the election. The officer's or officer-elect's resignation shall not be revocable after the date stated by him for his resignation or after the ~~thirtieth~~ *forty-fifth* day before the date set for the special election. The person so elected shall hold the office for the remaining portion of the regular term of the office for which the vacancy is being filled.

B. Notwithstanding any provision of law or charter to the contrary, no election to fill a vacancy shall be ordered or held if the general election at which it is to be called is scheduled within 60 days of the

57 end of the term of the office to be filled.

58 C. Notwithstanding any provision of law or charter to the contrary, when an interim appointment to a  
59 vacancy in any governing body or elected school board has been made by the remaining members  
60 thereof, no election to fill the vacancy shall be ordered or held if the general election at which it is to  
61 be called is scheduled in the year in which the term expires.

62 § 24.2-442. When registration permitted; lapse of registration.

63 Registration under this article shall be permitted until the registration records are closed pursuant to  
64 § 24.2-416 and shall be valid for all elections for which the voter is eligible through the ~~next two~~  
65 ~~regularly scheduled general elections for federal office following its receipt~~ *end of the federal election*  
66 *cycle in which the voter submits his application or for 365 days, whichever is longer.* After the ~~second~~  
67 ~~federal general election~~ *such period*, registration under this article shall no longer be valid. If an official  
68 reply to the application or an absentee ballot sent to the applicant is returned as undeliverable, no ballots  
69 for subsequent elections shall be sent under that application. No ballot shall be sent to the applicant, and  
70 no voted ballot received from the applicant shall be valid, (i) for any election held after the voter has  
71 notified the registrar that the voter no longer wishes to be registered or (ii) after the registrar has  
72 received notification that the voter has registered to vote in another state.

73 § 24.2-443.3. When registration permitted.

74 Registration under this article shall be permitted until the registration records are closed pursuant to  
75 § 24.2-416 and shall be valid for all elections for which the voter is eligible through the ~~next two~~  
76 ~~regularly scheduled general elections for federal office following its receipt~~ *end of the federal election*  
77 *cycle in which the voter submits his application or for 365 days, whichever is longer.* If an official reply  
78 to the application or an absentee ballot sent to the applicant is returned as undeliverable, no ballots for  
79 subsequent elections shall be sent under that application. No ballot shall be sent to the applicant, and no  
80 voted ballot received from the applicant shall be valid, (i) for any election held after the voter has  
81 notified the registrar that the voter no longer wishes to be registered or (ii) after the registrar has  
82 received notification that the voter has registered to vote in another state.

83 § 24.2-507. Deadlines for filing declarations and petitions of candidacy.

84 For any office, declarations of candidacy and the petitions therefor shall be filed according to the  
85 following schedule:

- 86 1. For a general election in November, by 7:00 p.m. on the second Tuesday in June;
- 87 2. For a general election in May, by 7:00 p.m. on the first Tuesday in March;
- 88 3. For a special election held at the same time as a November general election, either (i) at least  
89 ~~seventy-four~~ 74 days before the election or (ii) if the special election is being held at the second  
90 November election after the vacancy occurred, by 7:00 p.m. on the second Tuesday in June before that  
91 November election;
- 92 4. For a special election held at the same time as a May general election, by 7:00 p.m. on the first  
93 Tuesday in March; or
- 94 5. For a special election held at a time other than a general election, (i) at least ~~thirty~~ 45 days before  
95 the election or (ii) within five days of any writ of election or order calling a special election to be held  
96 less than ~~thirty-five~~ 45 days after the issuance of the writ or order.

97 § 24.2-510. Deadlines for parties to nominate by methods other than primary.

98 For any office, nominations by political parties by methods other than a primary shall be made and  
99 completed in the manner prescribed by law according to the following schedule:

- 100 1. For a general election in November, by 7:00 p.m. on the second Tuesday in June;
- 101 2. For a general election in May, by 7:00 p.m. on the first Tuesday in March;
- 102 3. For a special election held at the same time as a November general election, either (i) at least  
103 ~~seventy-four~~ 74 days before the election or (ii) if the special election is held at the second November  
104 election after the vacancy occurred, by 7:00 p.m. on the second Tuesday in June before that November  
105 election;
- 106 4. For a special election held at the same time as a May general election, by 7:00 p.m. on the first  
107 Tuesday in March; or
- 108 5. For a special election held at a time other than a general election, (i) at least ~~thirty~~ 45 days before  
109 the election or (ii) within five days of any writ of election or order calling a special election to be held  
110 less than ~~thirty-five~~ 45 days after the issuance of the writ or order.

111 In the case of all general elections a party shall nominate its candidate for any office by a  
112 nonprimary method only within the ~~thirty-two~~ 47 days immediately preceding the primary date  
113 established for nominating candidates for the office in question. This limitation shall have no effect,  
114 however, on nominations for special elections or pursuant to § 24.2-539.

115 § 24.2-516. Party to furnish names of chairmen and notify State Board of adoption of direct primary.

116 Each political party within the Commonwealth shall furnish to the State Board the names and  
117 addresses of its state, county, and city party chairmen in January of each year, and during the remainder

118 of the year it shall notify the Board of any changes in such names and addresses.

119 At least ~~120~~ 135 days prior to the regular date for a primary, the Board shall inquire of each state  
120 chairman and each county and city chairman whether a direct primary has been adopted. The Board  
121 shall advise each chairman that notification to the Board of the adoption of a direct primary is required  
122 and must be filed with the Board not more than ~~110~~ 125 days and not less than ~~90~~ 105 days before the  
123 date set for the primaries.

124 Each chairman shall file timely written notice with the Board whether or not a primary has been  
125 adopted and identify each office for which a primary has been adopted. The requirement to notify the  
126 Board of the adoption of a direct primary shall be satisfied when the Board receives by the deadline (i)  
127 written notice from the appropriate party chairman or (ii) a copy of the written notice from an  
128 incumbent officeholder to his party chairman of the incumbent's selection, pursuant to § 24.2-509, of the  
129 primary as the method of nomination.

130 § 24.2-522. When and to whom filings to be made.

131 A. Declarations of candidacy, petitions, and receipts indicating the payment of filing fees shall be  
132 filed not earlier than noon of the ~~seventy-seventh~~ *ninety-second* day and not later than 5:00 p.m. of the  
133 ~~sixtieth~~ *seventy-fifth* day before the primary.

134 B. Except as provided in subsection C, candidates for nomination shall file their declarations,  
135 petitions, and receipts with the chairman or chairmen of the several committees of the respective parties.

136 C. Any candidate for nomination for United States Senator, Governor, Lieutenant Governor, or  
137 Attorney General shall file with the State Board (i) his declaration of candidacy, (ii) the petitions for his  
138 candidacy, sealed in one or more containers to which is attached a written statement under oath by the  
139 candidate giving his name and the number of signatures on the petitions contained in the containers, and  
140 (iii) a receipt indicating the payment of his filing fee.

141 The State Board shall transmit the material so filed to the state chairman of the party of the  
142 candidate on the ~~fifty-ninth~~ *seventy-fourth* day before the primary. The sealed containers containing the  
143 petitions for a candidate may be opened only by the state chairman of the party of the candidate.

144 § 24.2-524. To whom fees paid; refund of fees.

145 A. Candidates for United States Senators, for representatives in Congress, and for the offices of  
146 Governor, Lieutenant Governor, and Attorney General shall pay the primary fee to the State Board of  
147 Elections. The primary fees shall be credited by the Board to a fund to be known as the "state primary  
148 fee fund."

149 The Board shall refund the fee by warrant upon the state primary fee fund in the event the  
150 prospective candidate does not become a candidate, becomes a candidate and is not opposed, or must  
151 refile for any reason. All other primary fees paid to the Board shall be paid or placed to the credit of  
152 the fund out of which the Board pays the Commonwealth's expenses for the primary.

153 B. All other candidates shall pay the fee to the treasurer, or director of finance if there is no  
154 treasurer, of the city or county in which they reside. The treasurer or director of finance shall pay back  
155 the fee in the event the prospective candidate does not become a candidate, or becomes a candidate and  
156 must refile for any reason. In the event the candidate is unopposed, the State Board or the local electoral  
157 board, as appropriate, shall notify, no less than ~~45~~ 60 days before the primary, the treasurer or director  
158 of finance to whom the fee was paid that the candidate is unopposed and shall provide the name and  
159 mailing address for returning the fee to the candidate. The treasurer or director of finance promptly shall  
160 return the fee to the candidate. All other primary fees paid a county or city treasurer or director of  
161 finance shall be paid or placed to the credit of the fund of the county or city out of which the expenses  
162 of the primary were paid by the county or city.

163 C. A receipt for the payment of the fee must be attached to the declaration of candidacy; otherwise  
164 the declaration shall not be received or filed.

165 § 24.2-527. Chairman or official to furnish State Board and local electoral boards with names of  
166 candidates.

167 A. It shall be the duty of the chairman or chairmen of the several committees of the respective  
168 parties to furnish the name of any candidate for nomination for any office to be elected by the qualified  
169 voters of the Commonwealth at large or of a congressional district or of a General Assembly district to  
170 the State Board, and to furnish the name of any candidate for any other office to the State Board and to  
171 the electoral boards charged with the duty of preparing and printing the primary ballots. The chairman  
172 shall also certify the order and date and time of filing for purposes of printing the ballots as prescribed  
173 in § 24.2-528, provided that the State Board shall determine the order and date and time of filing for  
174 candidates for United States Senator, Governor, Lieutenant Governor, and Attorney General for such  
175 purposes. Each chairman shall comply with the provisions of this section not less than ~~fifty-five~~ 70 days  
176 before the primary.

177 B. In no case shall the individual who is a candidate for an office be the person who certifies the  
178 names of candidates for a primary for that same office. In such case the party shall designate an

179 alternate official to certify the candidates.

180 § 24.2-536. Procedure when a vacancy in office occurs less than 75 days before primary date.

181 Whenever, by reason of the death, resignation, or removal of the incumbent, a vacancy in any office  
182 occurs less than ~~sixty~~ 75 but more than ~~thirty~~ 45 days before the regular date for the holding of a  
183 primary, the properly constituted party authorities may permit the filing of declarations and petitions of  
184 candidacy for nomination for that office in the primary. Notice of the vacancy and the right to file  
185 declarations and petitions of candidacy for nomination to fill it shall be advertised by the party  
186 committee or committees in at least one newspaper of general circulation within the Commonwealth if it  
187 is an office filled by election by the people at large, and in the manner prescribed by the properly  
188 constituted party authorities in the case of all other offices. No declaration and petitions of candidacy  
189 shall be filed with the committee or committees until such advertisement is made, nor within ~~twenty~~ 35  
190 days prior to the date for holding the primary. Declarations and petitions of candidacy filed pursuant to  
191 this section shall comply in every respect, except for the time of filing, with the requirements  
192 established generally for such declarations and petitions in this article.

193 If more than one person qualifies, the party chairman shall promptly certify their names to the State  
194 Board and the appropriate electoral boards as having qualified under the provisions of this section. The  
195 electoral boards having charge of the printing of the official ballots for the primary shall either:

- 196 1. Cause to be printed on the ballot the name of each person so certified; or
- 197 2. If the official ballots have already been printed, cause separate ballots to be printed for the office  
198 for which the persons have qualified pursuant to this section.

199 In the event that only one person qualifies as a candidate under the provisions of this section, the  
200 person so qualifying shall be declared the nominee of his party for that office and his name shall not be  
201 printed on the primary ballot.

202 In the event that no person qualifies as a candidate under the provisions of this section, or that the  
203 vacancy occurs less than ~~thirty~~ 45 days before the primary, the appropriate committee of the political  
204 party shall determine the time and method of nominating its candidate for the office.

205 § 24.2-537. Procedure when nominee by default dies or withdraws or nomination is set aside prior to  
206 primary.

207 A. If any person who would have been nominated as the candidate of a political party for any office  
208 in any general election by reason of the fact that he was the only person who filed the required  
209 declaration of and petition for candidacy dies or withdraws as the party candidate, or his nomination is  
210 set aside for any reason, ~~thirty~~ 45 days or more before the day on which the primary would have been  
211 held if two or more candidates had qualified, the appropriate committee of the political party shall  
212 determine the time and method of nominating its candidate for the office.

213 B. If the party committee determines that the party's nominee shall be elected at the scheduled  
214 primary, any person desiring to become a candidate for nomination by the party at that primary who is  
215 otherwise qualified may file a declaration of and petition for his candidacy with the proper chairman of  
216 his party committee. No person whose nomination has been set aside for fraud knowingly participated in  
217 by the candidate, or other person who knowingly participated in such fraud, shall be deemed qualified.  
218 The declaration and petition shall comply in every respect with the requirements established generally  
219 for such declarations and petitions in this article, except that the declaration and petition shall be filed at  
220 least ~~twenty~~ 35 days before the day on which the primary is to be held.

221 If more than one person qualifies, the party chairman shall promptly certify their names to the State  
222 Board and the appropriate electoral boards as having qualified under the provisions of this section. The  
223 electoral boards having charge of the printing of the official ballots for the primary election shall either:

- 224 1. Cause to be printed thereon the name of every person so certified; or
- 225 2. If the official ballots have already been printed, cause separate ballots to be printed for the office  
226 for which two or more persons have qualified pursuant to the provisions of this section.

227 In the event that only one person qualifies as a candidate in accordance with the provisions of this  
228 section, the person so qualifying shall be declared the nominee of his party for that office and his name  
229 shall not be printed on the primary ballot.

230 In the event that no person qualifies as a candidate pursuant to the provisions of this section, or that  
231 the death or withdrawal or setting aside of candidacy of any such party nominee should occur at a time  
232 which is less than ~~thirty~~ 45 days prior to any such primary, the appropriate committee of the political  
233 party shall determine the time and method of nominating its candidate for the office.

234 C. No party shall nominate any person whose nomination has been set aside for fraud knowingly  
235 participated in by the candidate, or any other person who knowingly participated in such fraud.

236 § 24.2-538. Procedure when opposed candidate for nomination dies prior to primary.

237 If any person who is a candidate for nomination by a political party at a primary election, and who,  
238 along with one or more other candidates, has qualified to have his name printed on the official ballot for  
239 the primary, dies ~~thirty~~ 45 days or more before the day on which the primary is to be held, any person

240 otherwise qualified who desires to be a candidate at that primary may file a declaration of and petition  
 241 for his candidacy with the proper chairman of his party committee. The declaration and petition shall  
 242 comply in every respect with the requirements established generally for such declarations and petitions  
 243 by this article, except that the declaration and petition shall be filed at least ~~twenty~~ 35 days before the  
 244 day on which the primary is to be held.

245 The party chairman or chairmen shall promptly certify the names of every such person to the State  
 246 Board and appropriate electoral boards as having qualified under the provisions of this section. Every  
 247 electoral board having charge of the printing of official ballots for the primary election shall either:

248 1. Cause to be printed thereon the name of every person so certified; or

249 2. If the official ballots have already been printed, cause separate ballots to be printed for the office  
 250 containing the names of those candidates other than the decedent who have theretofore qualified and the  
 251 names of those certified to it as having qualified pursuant to the provisions of this section. The board  
 252 may, in its discretion, cause to be stricken from the ballots already printed the title of the office  
 253 involved and the names of all candidates for nomination for the office appearing thereon.

254 Whenever any additional candidate shall qualify pursuant to this section, no ballots theretofore cast  
 255 by absentee vote for a candidate for such office shall be counted, but any person who has so voted shall  
 256 be entitled to receive a new ballot and to vote for his choice among all the candidates for such office.

257 § 24.2-612. List of offices and candidates filed with State Board and checked for accuracy; when  
 258 ballots printed; number required.

259 Immediately after the expiration of the time provided by law for a candidate for any office to qualify  
 260 to have his name printed on the official ballot and prior to printing the ballots for an election, each  
 261 electoral board shall forward to the State Board a list of the county, city, or town offices to be filled at  
 262 the election and the names of all candidates who have filed for each office. In addition, each electoral  
 263 board shall forward the name of any candidate who failed to qualify with the reason for his  
 264 disqualification. The State Board shall promptly advise the electoral board of the accuracy of the list.  
 265 The failure of any electoral board to send the list to the State Board for verification shall not invalidate  
 266 any election.

267 Each electoral board shall have printed the number of ballots it determines will be sufficient to  
 268 conduct the election.

269 Notwithstanding any other provisions of this title, the State Board may print or otherwise provide (i)  
 270 one statewide paper ballot style for each paper ballot style in use for presidential and vice-presidential  
 271 electors for use only by persons eligible to vote for those offices only under § 24.2-402 or clause (iii) or  
 272 (v) of subsection B of § 24.2-416.1, (ii) one statewide paper ballot style for each paper ballot style in  
 273 use for Governor, Lieutenant Governor or Attorney General only for use as the early absentee ballot  
 274 specified in § 24.2-702, and (iii) single paper ballot styles for each ballot style in use for each  
 275 congressional district for federal offices for use only by overseas voters eligible to vote in federal  
 276 elections only pursuant to Article 7 (§ 24.2-440 et seq.) of Chapter 4 of this title. The State Board may  
 277 apportion or authorize the printer or vendor to apportion the costs for these ballots among the localities  
 278 based on the number of ballots ordered. Any printer employed by the State Board shall execute the  
 279 statement required by § 24.2-616. The State Board shall designate a representative to be present at the  
 280 printing of such ballots and deliver them to the appropriate electoral boards pursuant to § 24.2-617.  
 281 Upon receipt of such paper ballots, the electoral board shall affix its seal. Thereafter, such ballots shall  
 282 be handled and accounted for, and the votes counted as the State Board shall specifically direct.

283 The electoral board shall make printed ballots available for absentee voting ~~at least (i) not later than~~  
 284 ~~45 days prior to any November general election or special election held at the same time and (ii) 30~~  
 285 ~~days prior to any other general, special, or primary election.~~ In the case of a special election, *excluding*  
 286 *for federal offices*, if time is insufficient to meet the applicable deadline established herein, then the  
 287 electoral board shall make printed ballots available as soon after the deadline as possible. *For the*  
 288 *purposes of this chapter, making printed ballots available includes mailing of such ballots or electronic*  
 289 *transmission of such ballots pursuant to § 24.2-706 to a qualified absentee voter who is eligible for an*  
 290 *absentee ballot under subdivision 2 of § 24.2-700. Not later than five days after absentee ballots are*  
 291 *made available, each electoral board shall report to the State Board, in writing on a form approved by*  
 292 *the State Board, whether it has complied with the applicable deadline.*

293 Only the names of candidates for offices to be voted on in a particular election district shall be  
 294 printed on the ballots for that election district.

295 The electoral boards shall send to the State Board a statement of the number of paper ballots ordered  
 296 to be printed, proofs of each paper and voting equipment ballot for verification, and copies of each final  
 297 ballot. If the State Board finds that, in its opinion, the number of ballots ordered to be printed by any  
 298 local electoral board is not sufficient, it may direct the local board to order the printing of a reasonable  
 299 number of additional ballots.

300 § 24.2-702.1. Write-in absentee ballots.

301 A. Notwithstanding any other provision of this title, a qualified absentee voter who is eligible for an  
 302 absentee ballot under subdivision 2 of § 24.2-700 may use a federal write-in absentee ballot in ~~general,~~  
 303 ~~special, and primary elections for federal office~~ any election. Such ballot shall be submitted and  
 304 processed in the manner provided by the Uniformed and Overseas Citizens Absentee Voting Act (42  
 305 U.S.C. § 1973ff et seq.) and this article.

306 B. Notwithstanding any other provision of this title, a federal write-in absentee ballot submitted  
 307 pursuant to subsection A shall be considered valid for purposes of simultaneously satisfying both an  
 308 absentee ballot application and a completed absentee ballot for federal offices only, provided that the  
 309 ballot is received no later than the deadline for the return of absentee ballots as provided in § 24.2-709  
 310 for the election in which the voter offers to vote, and the application on the envelope contains the  
 311 following information: (i) the voter's signature; however, if the voter is unable to sign, the person  
 312 assisting the voter will note this fact in the voter signature box; (ii) the voter's printed name; (iii) the  
 313 county or city in which he is registered and offers to vote; (iv) the residence address at which he is  
 314 registered to vote; (v) his current military or overseas address; and (vi) the signature of a witness who  
 315 shall sign the same envelope. If the voter is not currently registered in Virginia and is eligible to be,  
 316 such federal write-in absentee ballot shall also be considered valid for the purpose of serving as a voter  
 317 registration application.

318 § 24.2-703. Application for absentee ballots for multiple elections for uniformed and overseas voters.

319 Any person who is eligible for an absentee ballot under subdivision 2 of § 24.2-700, or for  
 320 temporary registration under Articles 7 (§ 24.2-440 et seq.) or 7.1 (§ 24.2-443.1 et seq.) of Chapter 4 of  
 321 this title, may file a single application to receive ballots for all elections in which he is eligible to vote  
 322 absentee. The application shall be on a Federal Post Card Application. The application from any person  
 323 who is eligible for an absentee ballot under subdivision 2 of § 24.2-700 that is received by the general  
 324 registrar no later than 5:00 p.m. on the seventh day prior to the election shall be valid through the ~~next~~  
 325 ~~two regularly scheduled general elections for federal office following its receipt~~ end of the federal  
 326 election cycle in which the voter submits the application or for 365 days, whichever is longer. The  
 327 application from any person applying for temporary registration under Articles 7 or 7.1 of Chapter 4 of  
 328 this title shall be accepted at any time until the registration records are closed pursuant to § 24.2-416  
 329 and shall be valid through the ~~next two regularly scheduled general elections for federal office following~~  
 330 ~~the receipt of the application by the general registrar~~ end of the federal election cycle in which the voter  
 331 submits the application or for 365 days, whichever is longer.

332 The general registrar shall retain the application and process the applicant's request for an absentee  
 333 ballot for each election in accordance with procedures established by the State Board. The applicant  
 334 shall specify by party designation the primary ballots he is requesting.

335 If an official reply to the application or an absentee ballot sent to the applicant is returned as  
 336 undeliverable, no ballots for subsequent elections shall be sent. No ballot shall be sent to the applicant,  
 337 and no voted ballot received from the applicant shall be valid, (i) for any election held after the voter  
 338 has notified the registrar that the voter no longer wishes to be registered or (ii) after the registrar has  
 339 received notification that the voter has registered to vote in another state.

340 § 24.2-706. Duty of general registrar and electoral board on receipt of application; statement of voter.

341 On receipt of an application for an absentee ballot, the general registrar shall enroll the name and  
 342 address of each registered applicant on an absentee voter applicant list that shall be maintained in the  
 343 office of the general registrar with a file of the applications of the listed applicants. The list and the  
 344 applications shall be available for inspection and copying by any registered voter during regular office  
 345 hours.

346 No list or application containing an individual's social security number, or any part thereof, or the  
 347 individual's day and month of birth, shall be made available for inspection or copying by anyone. The  
 348 State Board of Elections shall prescribe procedures for local electoral boards and general registrars to  
 349 make the information in the lists and applications available in a manner that does not reveal social  
 350 security numbers or parts thereof, or an individual's day and month of birth.

351 The completion and timely delivery of an application for an absentee ballot shall be construed to be  
 352 an offer by the applicant to vote in the election.

353 The general registrar shall note on each application received whether the applicant is or is not a  
 354 registered voter and notify the secretary of the electoral board. In reviewing the application for an  
 355 absentee ballot, the general registrar and electoral board shall not reject the application of any individual  
 356 because of an error or omission on any record or paper relating to the application, if such error or  
 357 omission is not material in determining whether such individual is qualified to vote absentee.

358 If the application has been properly completed and signed and the applicant is a registered voter of  
 359 the precinct in which he offers to vote, the electoral board shall within three business days of receiving  
 360 an application for an absentee ballot, or as soon thereafter as is reasonably possible, send to the  
 361 applicant by mail, obtaining a certificate of mailing, or deliver to him in person in the office of the

362 secretary or registrar, the following items and nothing else:

363 1. An envelope containing the folded ballot, sealed and marked "Ballot within. Do not open except  
364 in presence of a witness."

365 2. An envelope, with printing only on the flap side, for resealing the marked ballot, on which  
366 envelope is printed the following:

367 "Statement of Voter."

368 "I do hereby state, subject to felony penalties for making false statements pursuant to § 24.2-1016,  
369 that my FULL NAME is ..... (last, first, middle); that I am now or have been at some time since  
370 last November's general election a legal resident of ..... (STATE YOUR LEGAL RESIDENCE IN  
371 VIRGINIA including the house number, street name or rural route address, city, zip code); that I  
372 received the enclosed ballot(s) upon application to the registrar of such county or city; that I opened the  
373 envelope marked 'ballot within' and marked the ballot(s) in the presence of the witness, without  
374 assistance or knowledge on the part of anyone as to the manner in which I marked it (or I am returning  
375 the form required to report how I was assisted); that I then sealed the ballot(s) in this envelope; and that  
376 I have not voted and will not vote in this election at any other time or place.

377 Signature of Voter .....

378 Date .....

379 Signature of witness ....."

380 For elections held after January 1, 2004, instead of the envelope containing the above oath, an  
381 envelope containing the standard oath prescribed by the presidential designee under section 101 (b) (7)  
382 of the Uniformed and Overseas Citizens Absentee Voting Act (42 U.S.C. § 1973ff et seq.) shall be sent  
383 to voters who are qualified to vote absentee under that Act.

384 3. A properly addressed envelope for the return of the ballot to the electoral board by mail or by the  
385 applicant in person.

386 4. Printed instructions for completing the ballot and statement on the envelope and returning the  
387 ballot.

388 For federal elections held after January 1, 2004, for any voter who is required by subparagraph (b) of  
389 42 U.S.C.S. § 15483 of the Help America Vote Act of 2002 to show identification the first time the  
390 voter votes in a federal election in the state, the printed instructions shall direct the voter to submit with  
391 his ballot: (i) a copy of a current and valid photo identification; or (ii) a copy of a current utility bill,  
392 bank statement, government check, paycheck or other document that shows the name and address of the  
393 voter. Such individual who desires to vote by mail but who does not submit one of the forms of  
394 identification specified in this paragraph may cast such ballot by mail and the ballot shall be counted as  
395 a provisional ballot under the provisions of § 24.2-653. The State Board of Elections shall provide  
396 instructions to the electoral boards for the handling and counting of such provisional ballots pursuant to  
397 subsection B of § 24.2-653 and this section.

398 5. For any voter entitled to vote absentee under the Uniformed and Overseas Citizens Absentee  
399 Voting Act (42 U.S.C. § 1973ff et seq.), information provided by the State Board specific to the voting  
400 rights and responsibilities for such citizens, or information provided by the registrar specific to the status  
401 of the voter registration and absentee ballot application of such voter, may be included.

402 The envelopes and instructions shall be in the form prescribed by the State Board.

403 If the applicant makes his application to vote in person under § 24.2-701 at a time when the printed  
404 ballots for the election are available, the general registrar or the secretary of the electoral board, on the  
405 determination of the qualifications of the applicant to vote, shall provide to the applicant the items set  
406 forth in subdivisions 1 through 4, and no item shall be removed by the applicant from the office of the  
407 general registrar or the secretary of the electoral board. On the request of the applicant, made no later  
408 than 5:00 p.m. on the seventh day prior to the election in which the applicant offers to vote, the general  
409 registrar or the secretary may send the items set forth in subdivisions 1 through 4 to the applicant by  
410 mail, obtaining a certificate of mailing.

411 If the applicant states as the reason for his absence on election day any of the reasons set forth in  
412 subdivision 2 of § 24.2-700, the electoral board, *at the time when the printed ballots for the election are*  
413 *available*, shall mail *within three business days* or deliver in person to the applicant in the office of the  
414 secretary or general registrar; the items as set forth in subdivisions 1 through 4 and, if necessary, an  
415 application for registration. A certificate of mailing shall not be required. The electoral board, *at the*  
416 *time when the printed ballots for the election are available*, shall send *within three business days* the  
417 blank ballot, the form for the envelope for returning the marked ballot, and instructions to the voter by  
418 electronic transmission if the voter so requests ~~and if the applicant voter is located outside of the~~  
419 ~~Commonwealth~~. The voted ballot shall be returned to the electoral board as otherwise required by this  
420 chapter.

421 When the statement prescribed in subdivision 2 has been properly completed and signed by the  
422 registered voter and witnessed, his ballot shall not be subject to challenge pursuant to § 24.2-651.

423 The circuit courts shall have jurisdiction to issue an injunction to enforce the provisions of this  
424 section upon the application of (i) any aggrieved voter, (ii) any candidate in an election district in whole  
425 or in part in the court's jurisdiction where a violation of this section has occurred, or is likely to occur,  
426 or (iii) the campaign committee or the appropriate district political party chairman of such candidate.

427 § 24.2-709. Ballot to be returned in manner prescribed by law.

428 A. Any ballot returned to the office of the electoral board or general registrar in any manner except  
429 as prescribed by law, shall be void. Absentee ballots shall be returned to the electoral board or general  
430 registrar before the closing of the polls. The board member or registrar receiving the ballot shall mark  
431 on each envelope the date, time, and manner of delivery. For all ballots returned by the general registrar  
432 to the electoral board, the board shall give to the general registrar a receipt showing the time and date  
433 of the return.

434 B. *Notwithstanding the provisions of subsection A, absentee ballots (i) received after the close of the*  
435 *polls on any election day, (ii) received before 5:00 p.m. on the second business day before the State*  
436 *Board meets to ascertain the results of the election pursuant to this title, (iii) requested on or before but*  
437 *not sent by the deadline for making absentee ballots available under § 24.2-612, and (iv) cast by an*  
438 *absentee voter who is eligible for an absentee ballot under subdivision 2 of § 24.2-700 shall be counted*  
439 *pursuant to the procedures set forth in this chapter and, if the voter is found entitled to vote, included*  
440 *in the election returns. The electoral board shall prepare an amended certified abstract, which shall*  
441 *include the results of such ballots, and shall deliver such abstract to the State Board by the business*  
442 *day prior to its meeting pursuant to this title, and shall deliver a copy of such abstract to the general*  
443 *registrar to be available for inspection when his office is open for business.*
