6	A BILL to amend and reenact § 54.1-3005 of the Code of Virginia, relating to rescue medications for
7	students with epilepsy and other seizure disorders.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 54.1-3005 of the Code of Virginia is amended and reenacted as follows:
10	§ 54.1-3005. Specific powers and duties of Board.
11	In addition to the general powers and duties conferred in this title, the Board shall have the
12	following specific powers and duties:
13	1. To prescribe minimum standards and approve curricula for educational programs preparing persons
14	for licensure or certification under this chapter;
15	2. To approve programs that meet the requirements of this chapter and of the Board;
16	3. To provide consultation service for educational programs as requested;
17	4. To provide for periodic surveys of educational programs;
18	5. To deny or withdraw approval from educational programs for failure to meet prescribed standards;
19 20	6. To provide consultation regarding nursing practice for institutions and agencies as requested and
20 21	investigate illegal nursing practices;
$\frac{21}{22}$	7. To keep a record of all its proceedings;8. To certify and maintain a registry of all certified nurse aides and to promulgate regulations
$\frac{22}{23}$	consistent with federal law and regulation. The Board shall require all schools to demonstrate their
$\frac{23}{24}$	compliance with § 54.1-3006.2 upon application for approval or reapproval, during an on-site visit, or in
25	response to a complaint or a report of noncompliance. The Board may impose a fee pursuant to
26	§ 54.1-2401 for any violation thereof. Such regulations may include standards for the authority of
$\overline{27}$	licensed practical nurses to teach nurse aides;
28	9. To approve programs that entitle professional nurses to be registered as clinical nurse specialists
29	and to prescribe minimum standards for such programs;
30	10. To maintain a registry of clinical nurse specialists and to promulgate regulations governing
31	clinical nurse specialists;
32	11. To certify and maintain a registry of all certified massage therapists and to promulgate
33	regulations governing the criteria for certification as a massage therapist and the standards of
34	professional conduct for certified massage therapists;
35	12. To promulgate regulations for the delegation of certain nursing tasks and procedures not
36	involving assessment, evaluation or nursing judgment to an appropriately trained unlicensed person by
37	and under the supervision of a registered nurse, who retains responsibility and accountability for such
38	delegation;
39 40	13. To develop and revise as may be necessary, in coordination with the Boards of Medicine and Education guidelines for the training of amplevers of a school heard in the administration of insulin
40 41	Education, guidelines for the training of employees of a school board in the administration of insulin and glucagon for the purpose of assisting with routine insulin injections and providing emergency
42	treatment for life-threatening hypoglycemia. The first set of such guidelines shall be finalized by
43	September 1, 1999, and shall be made available to local school boards for a fee not to exceed the costs
44	of publication;
45	14. To enter into the Nurse Licensure Compact as set forth in this chapter and to promulgate
46	regulations for its implementation;
47	15. To collect, store and make available nursing workforce information regarding the various
48	categories of nurses certified, licensed or registered pursuant to § 54.1-3012.1;
49	16. To expedite application processing, to the extent possible, for an applicant for licensure or
50	certification by the Board upon submission of evidence that the applicant, who is licensed or certified in
51	another state, is relocating to the Commonwealth pursuant to a spouse's official military orders;
52	17. To register medication aides and promulgate regulations governing the criteria for such
53	registration and standards of conduct for medication aides;
54	18. To approve training programs for medication aides to include requirements for instructional
55 56	personnel, curriculum, continuing education, and a competency evaluation;
56 57	19. To set guidelines for the collection of data by all approved nursing education programs and to compile this data in an annual report. The data shall include but not be limited to enrollment, graduation
57 58	rate, attrition rate, and number of qualified applicants who are denied admission;

60 of child day programs as defined in § 63.2-100 and regulated by the State Board of Social Services or

the Child Day Care Council in the administration of prescription drugs as defined in the Drug Control
Act (§ 54.1-3400 et seq.). Such training programs shall be taught by a registered nurse, licensed practical
nurse, doctor of medicine or osteopathic medicine, or pharmacist; and

64 21. In order to protect the privacy and security of health professionals licensed, registered or certified
65 under this chapter, to promulgate regulations permitting use on identification badges of first name and
66 first letter only of last name and appropriate title when practicing in hospital emergency departments, in
67 psychiatric and mental health units and programs, or in health care facility units offering treatment for
68 patients in custody of state or local law-enforcement agencies; and

69 22. To revise, as may be necessary, guidelines for seizure management, in coordination with the
70 Board of Medicine, including the list of rescue medications for students with epilepsy and other seizure
71 disorders in the public schools. The revised guidelines shall be finalized by September 1, 2010, and
72 shall be made available to local school boards for a fee not to exceed the costs of publication.

73 2. That in promulgating regulations to implement the provisions of this act, the Board of Nursing,

74 in coordination with the Board of Medicine and the Board of Education, shall develop a

75 standardized form to be used for authorizing the administration of such medications in the public

76 schools.
