

## 1 VIRGINIA ACTS OF ASSEMBLY — CHAPTER

2 *An Act to amend and reenact § 24.2-946.2 of the Code of Virginia, relating to campaign finance*  
3 *information and reports; public access.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 24.2-946.2 of the Code of Virginia is amended and reenacted as follows:**

8 § 24.2-946.2. Custody of reports; inspection and copying; exception for certain information.

9 A. All campaign finance reports *required to be filed under this chapter* shall be open to inspection  
10 by any person during the business hours of the office in which they are filed. Copies shall be produced  
11 for any person requesting them who shall pay the reasonable cost of the copies. Copies of such reports  
12 certified by the principal administrative officer in whose office they are kept shall be evidence in all  
13 courts to the same extent as the original report would be if produced and proved.

14 *Nothing in this chapter shall be construed to grant public access to information not required to be*  
15 *entered into the campaign finance database under this chapter that candidates or committees may*  
16 *include in campaign finance report-creation software managed by or for the State Board.*

17 B. The following applies to campaign finance reports filed by candidate campaign committees:

18 1. Every officer or local electoral board, with whom reports are required to be filed by this chapter,  
19 shall file and preserve such reports and keep them as part of the office's records for at least one year  
20 after the final report is filed, or through the next general election for the office to which they pertain,  
21 whichever is later; or in the case of a candidate who has not filed a final report and seeks election to  
22 the same office in a successive election, through the next general election for the office to which they  
23 pertain.

24 2. The State Board shall file and preserve as part of its records the reports required to be filed with  
25 it by this chapter for at least one year after the final report is filed, or through the next general election  
26 for the office to which they pertain, whichever is later; or in the case of a candidate who has not filed a  
27 final report and seeks election to the same office in a successive election, through the next general  
28 election for the office to which they pertain. Thereafter, the State Board shall forward the reports it  
29 preserves to The Library of Virginia for preservation under the Virginia Public Records Act (§ 42.1-76  
30 et seq.).

31 C. The following applies to campaign finance reports filed by political committees:

32 1. Every officer or local electoral board, with whom reports are required to be filed by this chapter,  
33 shall file and preserve such reports as part of the office's records for at least four years after the  
34 reporting deadline or one year after the final report is filed.

35 2. The State Board shall file and preserve as part of its records the reports required to be filed with  
36 it by this chapter for at least four years after the reporting deadline or one year after the final report is  
37 filed. Thereafter, the State Board shall forward the reports it preserves to The Library of Virginia for  
38 preservation under the Virginia Public Records Act (§ 42.1-76 et seq.).
