Be it enacted by the General Assembly of Virginia: 6

7 1. That §§ 54.1-2343 and 54.1-2344 of the Code of Virginia are amended and reenacted as follows: 8 § 54.1-2343. Definitions. 9

As used in this chapter, unless the context requires a different meaning:

10 "Board" means the Fair Housing Board.

"Fair Housing Law" means the provisions of Chapter 5.1 (§ 36-96.1 et seq.) of Title 36. 11

12 "Person in the business or activity of selling or renting dwellings" means any person who is the owner of any combination of residential dwelling units occupied by five or more families. "Person in the 13 business or activity of selling or renting dwellings" shall not include any person involved in the sale of 14 15 a dwelling or interest therein pursuant to a deed of trust, or in full or partial satisfaction of a debt that 16 was secured by such dwelling or interest therein, or other lien on such property. 17

§ 54.1-2344. Fair Housing Board; membership; terms; chairman; powers and duties.

18 A. The Fair Housing Board shall be composed of 12 members, to be appointed by the Governor, as 19 follows: one representative of local government, one architect licensed in accordance with Chapter 4 (§ 54.1-400 et seq.) of this title, one representative of the mortgage lending industry, one representative 20 21 of the property and casualty insurance industry, two representatives of the residential property management industry not licensed in accordance with Chapter 21 (§ 54.1-2100 et seq.) of this title, at 22 23 least one of whom is a member of a property owners' association or condominium unit owners' 24 association, one contractor licensed in accordance with Chapter 11 (§ 54.1-1100 et seq.) of this title, one 25 representative of the disability community, one representative of the residential land lease industry 26 subject to Chapter 13.3 (§ 55-248.41 et seq.) of Title 55, and three citizen members selected in 27 accordance with § 54.1-107. Initial terms of Board members shall be as follows: four members shall be 28 appointed for a term of four years; four members shall be appointed for a term of three years, and three 29 members shall be appointed for a term of two years. Thereafter, all terms of Board members shall be for 30 terms of four years. 31

B. The Board shall elect a chairman from its membership.

C. The Board shall adopt a seal by which it shall authenticate its proceedings.

33 D. The Board shall be responsible for the administration and enforcement of the Fair Housing Law. 34 However, the Board shall have no authority with respect to a real estate broker, real estate salesperson, real estate brokerage firm licensed in accordance with Chapter 21 (§ 54.1-2100 et seq.), or their agents 35 or employees who have allegedly violated, or who have in fact violated, the Fair Housing Law. 36

37 The Board shall have the power and duty to establish, by regulation, an education-based certification 38 or registration program for persons subject to the Fair Housing Law who are involved in the business or 39 activity of selling or renting dwellings. The Board shall also establish, by regulation, educational 40 materials on the Fair Housing Law and require a signed affidavit from persons in the business or 41 activity of selling or renting dwellings, that they have read and understood the provided materials. The 42 Board shall have the authority to approve training courses and instructors in furtherance of the 43 provisions of this chapter.

44 No education-based program established by the Board shall require Board certification or registration 45 where an individual holds a valid license issued by the Real Estate Board. Any courses approved by the Real Estate Board to meet the fair housing requirement of § 54.1-2105.03 and the instructors approved 46 47 by the Real Estate Board to teach continuing education courses in accordance with § 54.1-2105.02 shall 48 not require additional approval by the Fair Housing Board to meet any education requirements in this 49 section and in the regulations of the Fair Housing Board.
