11	Be it enacted by the General Assembly of Virginia:
12 13	1. That the Code of Virginia is amended by adding in Article 15 of Chapter 1 of Title 33.1 a section numbered 33.1-223.2:23 as follows:
13 14	§ 33.1-223.2:23. Transportation services for the transportation disadvantaged.
15	A. As used in this section:
16	"Community transportation coordinator" means a transportation entity recommended by a
17	metropolitan planning organization or by the appropriate designated official planning agency in an area
18	outside the purview of a metropolitan planning organization to ensure that coordinated transportation
19 20	services are provided to the transportation-disadvantaged population in a designated service area.
20 21	"Coordination" means the arrangement for the provision of transportation services to the transportation disadvantaged in a manner that is cost-effective, efficient, and reduces fragmentation and
22	duplication of services.
23	"Local coordinating bodies" means advisory entities in each designated service area composed of
24	representatives appointed by the metropolitan planning organization or designated official planning
25	agency to provide assistance to the community transportation coordinator relative to the coordination of
26 27	transportation services. "Metropolitan planning organization" means the organization responsible for carrying out
<b>27</b> <b>28</b>	transportation planning and programming in accordance with the provisions of 23 U.S.C. § 134, as
29	provided in 23 U.S.C. § $104(f)(3)$ .
30	"Transportation disadvantaged" means those persons who are disabled, 60 years old or older, or low
31	income, who are unable to transport themselves or purchase transportation, and are therefore dependent
32	upon others to obtain access to health care, employment, and shopping for day-to-day essentials such as
33 34	food, medications, and clothing. "Transportation-disadvantaged funds" means any local government, state, or available federal funds
35	that are for the transportation of the transportation disadvantaged, including but not limited to funds for
36	planning, administration, operation, procurement, and maintenance of vehicles or equipment and capital
37	investments, but excluding funds for the transportation of children to public schools.
38	"Transportation operator" means one or more public, private for-profit operators encouraging
39 40	private for-profit participation in providing services for transportation-disadvantaged persons, or private
40 41	nonprofit entities engaged by the community transportation coordinator to provide service to transportation-disadvantaged persons pursuant to a coordinated system service plan.
42	B. Coordination of transportation services provided to the transportation disadvantaged shall include
43	but not be limited to the following:
44	1. Timely, cost-effective, and efficient transportation provided by qualified community transportation
45	coordinators or transportation operators that reduce fragmentation and duplication of services;
46 47	2. The coordination of all transportation-disadvantaged programs with appropriate local, state, and federal agencies and public transit agencies to ensure compatibility with existing transportation systems
48	and the most efficient use of transportation-disadvantaged funds; and
49	3. The development of local coordinating bodies to provide information, advice, and direction to
50	community transportation coordinators.
51	C. The Commonwealth Transportation Board shall seek to ensure that:
52 53	1. All available information on transportation operations for and needs of the transportation disadvantaged in the Commonwealth is compiled:
55 54	<i>disadvantaged in the Commonwealth is compiled;</i> 2. The barriers prohibiting the coordination and accessibility of transportation services to the
55	transportation disadvantaged are identified; and
56	3. The Commonwealth-wide objectives for providing transportation services to the transportation
57	disadvantaged are established and a long-range transportation-disadvantaged plan is developed that:
58	a. Addresses the transportation problems and needs of the transportation disadvantaged;

59 b. Includes policies and procedures for the coordination of local, state, and federal funding for the 60 transportation disadvantaged;

c. Includes mechanisms for providing assistance to communities in developing transportation systems
designed to serve the transportation disadvantaged, including establishment of local coordination bodies
and designation of community transportation coordinators;

64 *d.* Is fully coordinated with local transit plans and compatible with local government comprehensive 65 plans;

66 e. Includes minimum performance standards for the delivery of services to the transportation 67 disadvantaged; and

68 *f.* Ensures that a cost-effective and efficient method of providing transportation to the transportation 69 disadvantaged is developed.

70 D. The Secretary of Transportation and the Secretary of Health and Human Resources shall make an 71 annual report to the Governor regarding progress in establishing a statewide coordinated transportation 72 materia
