## HOUSE BILL NO. 317

AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the House Committee on Commerce and Labor

on February 4, 2010)

(Patron Prior to Substitute—Delegate McClellan)

5 6 A BILL to amend and reenact § 38.2-4319 of the Code of Virginia and to amend the Code of Virginia 7 by adding a section numbered 38.2-3541.2, relating to enrollment in a group health insurance plan 8 upon change in eligibility status under certain assistance programs; notices and disclosures. 9

Be it enacted by the General Assembly of Virginia:

10 1. That § 38.2-4319 of the Code of Virginia is amended and reenacted and that the Code of 11 Virginia is amended by adding a section numbered 38.2-3541.2 as follows:

 $\S$  38.2-3541.2. Enrollment following change in eligibility status under assistance programs.

A. As used in this section, "assistance program" means the Commonwealth's medical assistance 13 14 services program, established pursuant to § 32.1-325, or the Family Access to Medical Insurance Security Plan, established pursuant to § 32.1-351, including under any waiver or demonstration project 15 16 conducted under or in relation thereto.

17 B. Any employer providing health insurance coverage for his employees under a group accident and sickness insurance policy, or subscription contract, or other evidence of coverage shall permit an 18 19 employee who is eligible, but not enrolled, for coverage under the terms of the policy, contract or plan, 20 or a dependent of such an employee, if the dependent is eligible but not enrolled, for coverage under 21 such terms, to enroll for coverage under the terms of the policy, contract or plan, if either of the 22 following conditions is met:

23 1. The employee or dependent has received health insurance coverage under an assistance program, 24 coverage of the employee or dependent under the assistance program is terminated as a result of loss of 25 eligibility for such coverage, and the employee requests coverage under the group policy, contract or 26 plan not later than 60 days after the date of termination of coverage under the assistance program; or

27 2. The employee or dependent becomes eligible under an assistance program for premium assistance 28 for the purchase of coverage under the group policy, contract or plan, including contributions to the 29 cost of employer-sponsored health insurance pursuant to subsection C of § 32.1-351.1, and the employee 30 requests coverage under the group policy, contract or plan not later than 60 days after the date the 31 employee or dependent is determined to be eligible for such premium assistance.

32 C. Any employer providing health insurance coverage for his employees under a group accident and sickness insurance policy, or subscription contract, or other evidence of coverage within the Commonwealth, shall provide to each employee a written notice informing the employee of premium 33 34 35 assistance opportunities currently available for the employee or the employee's dependents through the 36 Commonwealth's assistance programs. For purposes of compliance with this subsection, for employees 37 residing within the Commonwealth, the employer may use a Virginia-specific model notice developed in 38 accordance with section 701(f)(3)(B)(i)(II) of the Employee Retirement Income Security Act of 1974 (29) 39 U.S.C. § 1181(f)(3)(B)(i)(II). An employer may provide the Virginia-specific model notice concurrent 40 with (i) the furnishing of materials notifying the employee of health plan eligibility; (ii) materials 41 provided to the employee in connection with an open season or election process conducted under the 42 plan; or (iii) the furnishing of the summary plan description as provided in section 104(b) of the Employee Retirement Income Security Act of 1974 (29 U.S.C. § 1024). 43

44 D. If an employee or the employee's dependents are covered under an assistance program and potentially eligible for premium assistance for the purchase of coverage under the employer's group 45 health plan, the plan administrator of the group health plan shall disclose to the Department of Medical 46 47 Assistance Services, upon request, information about the benefits available under the group health plan in sufficient specificity, as determined under regulations of the Secretary of Health and Human Services **48** in consultation with the Secretary, that require use of the model coverage coordination disclosure form 49 50 developed under § 311(b)(1)(C) of the Children's Health Insurance Program Reauthorization Act of 51 2009, so as to permit the Department of Medical Assistance Services to make a determination concerning the cost-effectiveness of the provision by the Commonwealth of contributions to the cost of 52 53 employer-sponsored health insurance, through premium assistance for the purchase of coverage under 54 such group health plan, and in order for the Department of Medical Assistance Services to provide any 55 required supplemental benefits under an assistance program. 56

This 91 chapter shall not apply to an insurer or health services plan licensed and regulated in conformance with 92 the insurance laws or Chapter 42 (§ 38.2-4200 et seq.) of this title except with respect to the activities of 93 its health maintenance organization.

94 C. Solicitation of enrollees by a licensed health maintenance organization or by its representatives
95 shall not be construed to violate any provisions of law relating to solicitation or advertising by health
96 professionals.

97 D. A licensed health maintenance organization shall not be deemed to be engaged in the unlawful
98 practice of medicine. All health care providers associated with a health maintenance organization shall
99 be subject to all provisions of law.

E. Notwithstanding the definition of an eligible employee as set forth in § 38.2-3431, a health maintenance organization providing health care plans pursuant to § 38.2-3431 shall not be required to offer coverage to or accept applications from an employee who does not reside within the health maintenance organization's service area.

F. For purposes of applying this section, "insurer" when used in a section cited in subsections A and
 B of this section shall be construed to mean and include "health maintenance organizations" unless the
 section cited clearly applies to health maintenance organizations without such construction.
