7 **Be it enacted by the General Assembly of Virginia:**8 **1. That § 46.2-931 of the Code of Virginia is amended and reenacted as follows:**

9 § 46.2-931. Localities may prohibit or regulate distribution of handbills, etc., solicitation of
10 contributions, and sale of merchandise or services on highways within their boundaries or on public
11 roadways and medians.

12 A. ~~Arlington, Hanover, Henrico, and Spotsylvania Counties, the Cities of Falls Church and~~
13 ~~Richmond, and the Town of Vienna~~ Any county, city, or town is hereby authorized to adopt
14 ~~ordinances an ordinance~~ prohibiting or regulating:

15 1. The distribution of handbills, leaflets, bulletins, literature, advertisements, or similar material to the
16 occupants of motor vehicles on highways located within ~~their~~ its boundaries or on public roadways and
17 medians;

18 2. The solicitation of contributions of any nature from the occupants of motor vehicles on highways
19 located within ~~their~~ its boundaries or on public roadways and medians; and

20 3. The sale of merchandise or services or the attempted sale of merchandise or services to the
21 occupants of motor vehicles on highways located within ~~their~~ its boundaries or on public roadways and
22 medians.

23 B. Albemarle, Greene, Hanover, Loudoun, and Spotsylvania Counties and the Cities of Falls Church
24 and Richmond are hereby authorized to adopt ordinances regulating:

25 1. The distribution of handbills, leaflets, bulletins, literature, advertisements, or similar material to the
26 occupants of motor vehicles on public roadways and medians;

27 2. The solicitation of contributions of any nature from the occupants of motor vehicles on public
28 roadways and medians; and

29 3. The sale of merchandise or the attempted sale of merchandise to the occupants of motor vehicles
30 on public roadways and medians.

31 C. Ordinances adopted pursuant to this section may provide that any person violating the provisions
32 of such ordinances shall be guilty of a traffic infraction.

33 D. C. The Virginia Department of Transportation may regulate activities within such streets and
34 highways under its jurisdiction, subject to regulations promulgated by the Commonwealth Transportation
35 Board. Nothing in this section shall be construed to allow any locality to permit activities within any
36 highway under the maintenance and operational jurisdiction of the Virginia Department of
37 Transportation.
