into prior to August 1, 1987, which were in compliance with either the former Virginia Conflict of 59 60 Interests Act, Chapter 22 (§ 2.1-347 et seq.) or the former Comprehensive Conflict of Interests Act, 61 Chapter 40 (§ 2.1-599 et seq.) of Title 2.1 at the time of their formation and thereafter. Those contracts 62 shall continue to be governed by the provisions of the appropriate prior Act. Notwithstanding the provisions of subdivision (f) (4) of § 2.1-348 of Title 2.1 in effect prior to July 1, 1983, the employment 63 by the same governmental agency of an officer or employee and spouse or any other relative residing in 64 the same household shall not be deemed to create a material financial interest except when one of such 65 66 persons is employed in a direct supervisory or administrative position, or both, with respect to such spouse or other relative residing in his household and the annual salary of such subordinate is \$22,500 67

68 or more.
