## **HOUSE BILL NO. 46**

## AMENDMENT IN THE NATURE OF A SUBSTITUTE (Proposed by the Senate Committee on General laws and Technology

on February 24, 2010)

(Patron Prior to Substitute—Delegate Oder)

- 4 5 6 A BILL to amend and reenact § 44-146.18:1 of the Code of Virginia, relating to the Virginia Disaster 7 Response Fund; hazardous materials in dwellings. 8 Be it enacted by the General Assembly of Virginia:
  - 1. That § 44-146.18:1 of the Code of Virginia is amended and reenacted as follows:
- 9 10 § 44-146.18:1. Virginia Disaster Response Funds disbursements; reimbursements.

11 There is hereby created a nonlapsing revolving fund which shall be maintained as a separate special fund account within the state treasury, and administered by the Coordinator of Emergency Management, 12 13 consistent with the purposes of this chapter. All expenses, costs, and judgments recovered pursuant to this section, and all moneys received as reimbursement in accordance with applicable provisions of 14 15 federal law, shall be paid into the fund. Additionally, an annual appropriation to the fund from the general fund or other unrestricted nongeneral fund, in an amount determined by the Governor, may be 16 17 authorized to carry out the purposes of this chapter. All recoveries from occurrences prior to March 10, 1983, and otherwise qualifying under this section, received subsequent to March 10, 1983, shall be paid 18 into the fund. No moneys shall be credited to the balance in the fund until they have been received by 19 20 the fund. An accounting of moneys received and disbursed shall be kept and furnished to the Governor 21 or the General Assembly upon request. 22

Disbursements from the fund may be made for the following purposes and no others:

23 1. For costs and expenses, including, but not limited to personnel, administrative, and equipment 24 costs and expenses directly incurred by the Department of Emergency Management or by any other state agency or political subdivision or other entity, acting at the direction of the Coordinator of Emergency 25 Management, in and for preventing or alleviating damage, loss, hardship, or suffering caused by 26 27 emergencies, resource shortages, or disasters; and

28 2. For procurement, maintenance, and replenishment of materials, equipment, and supplies, in such 29 quantities and at such location as the Coordinator of Emergency Management may deem necessary to 30 protect the public peace, health, and safety and to preserve the lives and property and economic 31 well-being of the people of the Commonwealth; and

32 3. For costs and expenses incurred by the Department of Emergency Management or by any other 33 state agency or political subdivision or other entity, acting at the direction of the Coordinator of 34 Emergency Management, in the recovery from the effects of a disaster or in the restoration of public 35 property or facilities; and

36 4. To political subdivisions, for costs incurred for the removal of Chinese drywall hazardous 37 materials, from, and subsequent repair of, dwelling units. In order to qualify for disbursements from the 38 fund pursuant to this subdivision, the existence of the hazard in the dwelling unit shall be certified by the political subdivision, and application for the funds shall be made by the political subdivision on 39 40 behalf of the owner of the dwelling unit constructed in the calendar years 2006 and 2007. Any moneys 41 disbursed from the fund shall be paid directly to the political subdivision, and the political subdivision 42 shall decide how and by whom the removal of the hazardous materials and repairs shall be completed. The Coordinator of Emergency Management shall promptly seek reimbursement from any person 43

44 causing or contributing to an emergency or disaster for all sums disbursed from the fund for the protection, relief and recovery from loss or damage caused by such person. In the event a request for 45 reimbursement is not paid within 60 days of receipt of a written demand, the claim shall be referred to 46 the Attorney General for collection. The Coordinator of Emergency Management shall be allowed to 47 recover all legal and court costs and other expenses incident to such actions for collection. The **48** 49 Coordinator is authorized to recover any sums incurred by any other state agency or political subdivision 50 acting at the direction of the Coordinator as provided in this paragraph.
