Any term used in this chapter shall have the same meaning as when used in a comparable context 11 12 in the laws of the United States relating to federal income taxes, unless a different meaning is clearly 13 required. 14 B. Any reference in this chapter to the laws of the United States relating to federal income taxes 15 shall mean the provisions of the Internal Revenue Code of 1954, and amendments thereto, and other provisions of the laws of the United States relating to federal income taxes, as they existed on 16 December 31, 2008 2009, except for: 17 18 1. The special depreciation allowance for certain property provided for under §§ 168(k), 168(l), 19 168(m), 1400L, and 1400N of the Internal Revenue Code; and 20 2. The carry-back of certain net operating losses for five years under § 172(b)(1)(H) of the Internal 21 Revenue Code.:

3. The deferral of certain income under § 108 (i) of the Internal Revenue Code; and
