§ 22.1-261. Attendance officer to make list of children not enrolled; duties of attendance officer.

131 The attendance officer or the division superintendent shall check the reports submitted pursuant to subsection A of § 22.1-260 with the last school census and with reports from the State Registrar of Vital 132 Records and Health Statistics. From these reports and from any other reliable source the attendance 133 134 officer or the division superintendent shall, within five days after receiving all reports submitted 135 pursuant to subsection A of § 22.1-260, make a list of the names of children who are not enrolled in 136 any school and who are not exempt from school attendance. It shall be the duty of the attendance 137 officer, on behalf of the local school board, to investigate all cases of nonenrollment and, when no valid 138 reason is found therefor, to notify the parent, guardian or other person having control of the child to 139 require the attendance of such child at the school within three days from the date of such notice.

140 § 37.2-713. Residence of consumers in state facilities and school-age children in state facilities 141 generally.

142 For purposes of eligibility for and receipt of social services and public assistance, each consumer in a 143 state facility shall be deemed a resident of the county or city in which he resided at the time of his 144 admission to the state facility, and not of the county or city in which the state facility is located. Each 145 person between the ages of two and 21 in the population of any state facility whom the Department 146 determines could benefit from a program of education or training shall be included in the census taken 147 as provided in <u>§ 22.1-281</u>. The Department shall be entitled to receive annually from the Board of 148 Education and the school division where the person is included in the census resided at the time of his 149 admission a sum equal to the required local expenditure per pupil, as set forth in the appropriation act, 150 and an additional payment for special education, as applicable, for support of the person's education. 151 This amount shall be paid by the Board of Education, and the Board shall then deduct that payment 152 from the amount payable by the Board of Education from the basic school aid fund to the school 153 division.

154 § 58.1-605. To what extent and under what conditions cities and counties may levy local sales taxes; 155 collection thereof by Commonwealth and return of revenue to each city or county entitled thereto.

156 A. No county, city or town shall impose any local general sales or use tax or any local general retail 157 sales or use tax except as authorized by this section.

158 B. The council of any city and the governing body of any county may levy a general retail sales tax 159 at the rate of one percent to provide revenue for the general fund of such city or county. Such tax shall 160 be added to the rate of the state sales tax imposed by §§ 58.1-603 and 58.1-604 and shall be subject to 161 all the provisions of this chapter and the rules and regulations published with respect thereto. No 162 discount under § 58.1-622 shall be allowed on a local sales tax.

C. The council of any city and the governing body of any county desiring to impose a local sales tax 163 164 under this section may do so by the adoption of an ordinance stating its purpose and referring to this 165 section, and providing that such ordinance shall be effective on the first day of a month at least 60 days 166 after its adoption. A certified copy of such ordinance shall be forwarded to the Tax Commissioner so 167 that it will be received within five days after its adoption.

168 D. Any local sales tax levied under this section shall be administered and collected by the Tax 169 Commissioner in the same manner and subject to the same penalties as provided for the state sales tax.

170 E. All local sales tax moneys collected by the Tax Commissioner under this section shall be paid 171 into the state treasury to the credit of a special fund which is hereby created on the Comptroller's books under the name "Collections of Local Sales Taxes." Such local sales tax moneys shall be credited to the 172 173 account of each particular city or county levying a local sales tax under this section. The basis of such 174 credit shall be the city or county in which the sales were made as shown by the records of the 175 Department and certified by it monthly to the Comptroller, namely, the city or county of location of 176 each place of business of every dealer paying the tax to the Commonwealth without regard to the city or 177 county of possible use by the purchasers. If a dealer has any place of business located in more than one 178 political subdivision by reason of the boundary line or lines passing through such place of business, the

179 amount of sales tax paid by such a dealer with respect to such place of business shall be treated for the purposes of this section as follows: one-half shall be assignable to each political subdivision where two 180 181 are involved, one-third where three are involved, and one-fourth where four are involved.

182 F. As soon as practicable after the local sales tax moneys have been paid into the state treasury in 183 any month for the preceding month, the Comptroller shall draw his warrant on the Treasurer of Virginia 184 in the proper amount in favor of each city or county entitled to the monthly return of its local sales tax 185 moneys, and such payments shall be charged to the account of each such city or county under the special fund created by this section. If errors are made in any such payment, or adjustments are 186 187 otherwise necessary, whether attributable to refunds to taxpavers, or to some other fact, the errors shall 188 be corrected and adjustments made in the payments for the next six months as follows: one-sixth of the 189 total adjustment shall be included in the payments for the next six months. In addition, the payment 190 shall include a refund of amounts erroneously not paid to the city or county and not previously refunded 191 during the three years preceding the discovery of the error. A correction and adjustment in payments 192 described in this subsection due to the misallocation of funds by the dealer shall be made within three 193 years of the date of the payment error.

194 G. Such payments to counties are subject to the qualification that in any county wherein is situated 195 any incorporated town constituting a special school district and operated as a separate school district 196 under a town school board of three members appointed by the town council, the county treasurer shall 197 pay into the town treasury for general governmental purposes the proper proportionate amount received 198 by him in the ratio that the school age population of such town bears to the school age population of 199 the entire county. If the school age population of any town constituting a separate school district is 200 increased by the annexation of territory since the last preceding estimate of school age population census 201 provided by the Weldon Cooper Center for Public Service, such increase shall, for the purposes of this 202 section, be added to the school age population of such town as shown by the last such eensus estimate 203 and a proper reduction made in the school age population of the county or counties from which the 204 annexed territory was acquired.

205 H. One-half of such payments to counties are subject to the further qualification, other than as set 206 out in subsection G above, that in any county wherein is situated any incorporated town not constituting 207 a separate special school district which has complied with its charter provisions providing for the 208 election of its council and mayor for a period of at least four years immediately prior to the adoption of 209 the sales tax ordinance, the county treasurer shall pay into the town treasury of each such town for general governmental purposes the proper proportionate amount received by him in the ratio that the 210 211 school age population of each such town bears to the school age population of the entire county, based 212 on the latest statewide school census estimate provided by the Weldon Cooper Center for Public Service. 213 The preceding requirement pertaining to the time interval between compliance with election provisions 214 and adoption of the sales tax ordinance shall not apply to a tier-city. If the school age population of any 215 such town not constituting a separate special school district is increased by the annexation of territory or 216 otherwise since the last preceding estimate of school age population census provided by the Weldon Cooper Center for Public Service, such increase shall, for the purposes of this section, be added to the 217 218 school age population of such town as shown by the last such census estimate and a proper reduction 219 made in the school age population of the county or counties from which the annexed territory was 220 acquired.

221 I. Notwithstanding the provisions of subsection H, the board of supervisors of a county may, in its 222 discretion, appropriate funds to any incorporated town not constituting a separate school district within 223 such county which has not complied with the provisions of its charter relating to the elections of its 224 council and mayor, an amount not to exceed the amount it would have received from the tax imposed 225 by this chapter if such election had been held.

226 J. It is further provided that if any incorporated town which would otherwise be eligible to receive 227 funds from the county treasurer under subsection G or H of this section be located in a county which 228 does not levy a general retail sales tax under the provisions of this law, such town may levy a general 229 retail sales tax at the rate of one percent to provide revenue for the general fund of the town, subject to 230 all the provisions of this section generally applicable to cities and counties. Any tax levied under the 231 authority of this subsection shall in no case continue to be levied on or after the effective date of a 232 county ordinance imposing a general retail sales tax in the county within which such town is located. 233

§ 58.1-638. Disposition of state sales and use tax revenue; localities' share; Game Protection Fund.

234 A. The Comptroller shall designate a specific revenue code number for all the state sales and use tax 235 revenue collected under the preceding sections of this chapter.

236 1. The sales and use tax revenue generated by the one-half percent sales and use tax increase enacted 237 by the 1986 Special Session of the General Assembly shall be paid, in the manner hereinafter provided 238 in this section, to the Transportation Trust Fund as defined in § 33.1-23.03:1. Of the funds paid to the Transportation Trust Fund, an aggregate of 4.2 percent shall be set aside as the Commonwealth Port 239

Fund as provided in this section; an aggregate of 2.4 percent shall be set aside as the Commonwealth Airport Fund as provided in this section; and an aggregate of 14.5 percent in fiscal year 1998-1999 and 14.7 percent in fiscal year 1999-2000 and thereafter shall be set aside as the Commonwealth Mass Transit Fund as provided in this section. The Fund's share of such net revenue shall be computed as an estimate of the net revenue to be received into the state treasury each month, and such estimated payment shall be adjusted for the actual net revenue received in the preceding month. All payments shall be made to the Fund on the last day of each month.

247 2. There is hereby created in the Department of the Treasury a special nonreverting fund which shall248 be a part of the Transportation Trust Fund and which shall be known as the Commonwealth Port Fund.

a. The Commonwealth Port Fund shall be established on the books of the Comptroller and the funds
remaining in such Fund at the end of a biennium shall not revert to the general fund but shall remain in
the Fund. Interest earned on such funds shall remain in the Fund and be credited to it. Funds may be
paid to any authority, locality or commission for the purposes hereinafter specified.

b. The amounts allocated pursuant to this section shall be allocated by the Commonwealth
Transportation Board to the Board of Commissioners of the Virginia Port Authority to be used to
support port capital needs and the preservation of existing capital needs of all ocean, river, or tributary
ports within the Commonwealth.

257 c. Commonwealth Port Fund revenue shall be allocated by the Board of Commissioners to the
258 Virginia Port Authority in order to foster and stimulate the flow of maritime commerce through the
259 ports of Virginia, including but not limited to the ports of Richmond, Hopewell and Alexandria.

260 3. There is hereby created in the Department of the Treasury a special nonreverting fund which shall 261 be part of the Transportation Trust Fund and which shall be known as the Commonwealth Airport Fund. 262 The Commonwealth Airport Fund shall be established on the books of the Comptroller and any funds 263 remaining in such Fund at the end of a biennium shall not revert to the general fund but shall remain in the Fund. Interest earned on the funds shall be credited to the Fund. The funds so allocated shall be 264 265 allocated by the Commonwealth Transportation Board to the Virginia Aviation Board. The funds shall 266 be allocated by the Virginia Aviation Board to any Virginia airport which is owned by the Commonwealth, a governmental subdivision thereof, or a private entity to which the public has access 267 268 for the purposes enumerated in § 5.1-2.16, or is owned or leased by the Metropolitan Washington Airports Authority (MWAA), as follows: 269

Any new funds in excess of \$12.1 million which are available for allocation by the Virginia Aviation Board from the Commonwealth Transportation Fund, shall be allocated as follows: 60 percent to MWAA, up to a maximum annual amount of \$2 million, and 40 percent to air carrier airports as provided in subdivision A 3 a. Except for adjustments due to changes in enplaned passengers, no air carrier airport sponsor, excluding MWAA, shall receive less funds identified under subdivision A 3 a than it received in fiscal year 1994-1995.

276 Of the remaining amount:

a. Forty percent of the funds shall be allocated to air carrier airports, except airports owned or leased
by MWAA, based upon the percentage of enplanements for each airport to total enplanements at all air
carrier airports, except airports owned or leased by MWAA. No air carrier airport sponsor, however,
shall receive less than \$50,000 nor more than \$2 million per year from this provision.

281 b. Forty percent of the funds shall be allocated by the Aviation Board for air carrier and reliever282 airports on a discretionary basis, except airports owned or leased by MWAA.

c. Twenty percent of the funds shall be allocated by the Aviation Board for general aviation airportson a discretionary basis.

4. There is hereby created in the Department of the Treasury a special nonreverting fund which shall
be a part of the Transportation Trust Fund and which shall be known as the Commonwealth Mass
Transit Fund.

a. The Commonwealth Mass Transit Fund shall be established on the books of the Comptroller and any funds remaining in such Fund at the end of the biennium shall not revert to the general fund but shall remain in the Fund. Interest earned on such funds shall be credited to the Fund. Funds may be paid to any local governing body, transportation district commission, or public service corporation for the purposes hereinafter specified.

293 b. The amounts allocated pursuant to this section shall be used to support the public transportation 294 administrative costs and the costs borne by the locality for the purchase of fuels, lubricants, tires and 295 maintenance parts and supplies for public transportation at a state share of 80 percent in 2002 and 95 296 percent in 2003 and succeeding years. These amounts may be used to support up to 95 percent of the 297 local or nonfederal share of capital project costs for public transportation and ridesharing equipment, 298 facilities, and associated costs. Capital costs may include debt service payments on local or agency transit bonds. The term "borne by the locality" means the local share eligible for state assistance 299 consisting of costs in excess of the sum of fares and other operating revenues plus federal assistance 300

301 received by the locality.

302 c. Commonwealth Mass Transit Fund revenue shall be allocated by the Commonwealth303 Transportation Board as follows:

304 (1) Funds for special programs, which shall include ridesharing, experimental transit, and technical
 305 assistance, shall not exceed 1.5 percent of the Fund.

306 (2) The Board may allocate these funds to any locality or planning district commission to finance up
 307 to 80 percent of the local share of all costs associated with the development, implementation, and
 308 continuation of ridesharing programs.

309 (3) Funds allocated for experimental transit projects may be paid to any local governing body,
 310 transportation district commission, or public corporation or may be used directly by the Department of
 311 Rail and Public Transportation for the following purposes:

(a) To finance up to 95 percent of the capital costs related to the development, implementation and promotion of experimental public transportation and ridesharing projects approved by the Board.

(b) To finance up to 95 percent of the operating costs of experimental mass transportation andridesharing projects approved by the Board for a period of time not to exceed 12 months.

(c) To finance up to 95 percent of the cost of the development and implementation of any other
 project designated by the Board where the purpose of such project is to enhance the provision and use
 of public transportation services.

d. Funds allocated for public transportation promotion and operation studies may be paid to any local governing body, planning district commission, transportation district commission, or public transit corporation, or may be used directly by the Department of Rail and Public Transportation for the following purposes and aid of public transportation services:

(1) At the approval of the Board to finance a program administered by the Department of Rail and
 Public Transportation designed to promote the use of public transportation and ridesharing throughout
 Virginia.

326 (2) To finance up to 50 percent of the local share of public transportation operations planning and327 technical study projects approved by the Board.

e. At least 73.5 percent of the Fund shall be distributed to each transit property in the same proportion as its operating expenses bear to the total statewide operating expenses and shall be spent for the purposes specified in subdivision 4 b.

f. The remaining 25 percent shall be distributed for capital purposes on the basis of 95 percent of the nonfederal share for federal projects and 95 percent of the total costs for nonfederal projects. In the event that total capital funds available under this subdivision are insufficient to fund the complete list of eligible projects, the funds shall be distributed to each transit property in the same proportion that such capital expenditure bears to the statewide total of capital projects.

336 g. There is hereby created in the Department of the Treasury a special nonreverting fund known as the Commonwealth Transit Capital Fund. The Commonwealth Transit Capital Fund shall be part of the 337 Commonwealth Mass Transit Fund. The Commonwealth Transit Capital Fund subaccount shall be 338 339 established on the books of the Comptroller and consist of such moneys as are appropriated to it by the 340 General Assembly and of all donations, gifts, bequests, grants, endowments, and other moneys given, 341 bequeathed, granted, or otherwise made available to the Commonwealth Transit Capital Fund. Any funds 342 remaining in the Commonwealth Transit Capital Fund at the end of the biennium shall not revert to the 343 general fund, but shall remain in the Commonwealth Transit Capital Fund. Interest earned on funds 344 within the Commonwealth Transit Capital Fund shall remain in and be credited to the Commonwealth 345 Transit Capital Fund. Proceeds of the Commonwealth Transit Capital Fund may be paid to any political 346 subdivision, another public entity created by an act of the General Assembly, or a private entity as 347 defined in § 56-557 and for purposes as enumerated in subdivision 4c of § 33.1-269 or expended by the 348 Department of Rail and Public Transportation for the purposes specified in this subdivision. Revenues of 349 the Commonwealth Transit Capital Fund shall be used to support capital expenditures involving the establishment, improvement, or expansion of public transportation services through specific projects 350 351 approved by the Commonwealth Transportation Board. Projects financed by the Commonwealth Transit 352 Capital Fund shall receive local, regional or private funding for at least 20 percent of the nonfederal 353 share of the total project cost.

5. Funds for Metro shall be paid by the Northern Virginia Transportation Commission (NVTC) to the
Washington Metropolitan Area Transit Authority (WMATA) and be a credit to the Counties of
Arlington and Fairfax and the Cities of Alexandria, Falls Church and Fairfax in the following manner:

a. Local obligations for debt service for WMATA rail transit bonds apportioned to each locality
using WMATA's capital formula shall be paid first by NVTC. NVTC shall use 95 percent state aid for
these payments.

b. The remaining funds shall be apportioned to reflect WMATA's allocation formulas by using therelated WMATA-allocated subsidies and relative shares of local transit subsidies. Capital costs shall

include 20 percent of annual local bus capital expenses. Hold harmless protections and obligations forNVTC's jurisdictions agreed to by NVTC on November 5, 1998, shall remain in effect.

364 Appropriations from the Commonwealth Mass Transit Fund are intended to provide a stable and 365 reliable source of revenue as defined by Public Law 96-184.

366 B. The sales and use tax revenue generated by a one percent sales and use tax shall be distributed 367 among the counties and cities of this Commonwealth in the manner provided in subsections C and D.

368 C. The localities' share of the net revenue distributable under this section among the counties and 369 cities shall be apportioned by the Comptroller and distributed among them by warrants of the 370 Comptroller drawn on the Treasurer of Virginia as soon as practicable after the close of each month 371 during which the net revenue was received into the state treasury. The distribution of the localities' share 372 of such net revenue shall be computed with respect to the net revenue received into the state treasury 373 during each month, and such distribution shall be made as soon as practicable after the close of each 374 such month.

375 D. The net revenue so distributable among the counties and cities shall be apportioned and 376 distributed upon the basis as certified to the Comptroller by the Department of Education, of the number 377 of children in each county and city according to the most recent statewide census of school population taken by the Department of Education pursuant to §-22.1-284, as adjusted in the manner hereinafter 378 379 provided. No special school population census, other than a statewide census, shall be used as the basis 380 of apportionment and distribution except that in any calendar year in which a statewide census is not 381 reported, the Department of Education shall adjust such school population figures by the same percent of 382 annual change in total population estimated for each locality by The of the latest yearly estimate of the 383 population of cities and counties ages five to 19, provided by the Weldon Cooper Center for Public 384 Service of the University of Virginia. Such population estimate produced by the Weldon Cooper Center for Public Service of the University of Virginia shall account for persons who are domiciled in 385 orphanages or charitable institutions or who are dependents living on any federal military or naval 386 reservation or other federal property within the school division in which the institutions or federal 387 388 military or naval reservation or other federal property is located. Such population estimate produced by 389 the Weldon Cooper Center for Public Service of the University of Virginia shall account for members of 390 the military services who are under 20 years of age within the school division in which the parents or 391 guardians of such persons legally reside. Such population estimate produced by the Weldon Cooper 392 Center for Public Service of the University of Virginia shall account for persons who are confined in 393 state hospitals, state training schools, or state training centers for the mentally retarded, mental 394 institutions, or state or federal correctional institutions or who attend the Virginia School for the Deaf 395 and the Blind within the school division in which the parents or guardians of such persons legally 396 reside. Such population estimate produced by the Weldon Cooper Center for Public Service of the University of Virginia shall account for persons who attend institutions of higher education within the school division in which the student's parents or guardians legally reside. To such estimate, the Department of Education shall add the population of students with disabilities, ages two through four 397 398 399 400 and 20 through 21, as provided to the Department of Education by school divisions. The revenue so 401 apportionable and distributable is hereby appropriated to the several counties and cities for maintenance, 402 operation, capital outlays, debt and interest payments, or other expenses incurred in the operation of the 403 public schools, which shall be considered as funds raised from local resources. In any county, however, **404** wherein is situated any incorporated town constituting a school division, the county treasurer shall pay 405 into the town treasury for maintenance, operation, capital outlays, debt and interest payments, or other 406 expenses incurred in the operation of the public schools, the proper proportionate amount received by him in the ratio that the school population of such town bears to the school population of the entire 407 408 county. If the school population of any city or of any town constituting a school division is increased by 409 the annexation of territory since the last preceding estimate of school population census provided by the 410 Weldon Cooper Center for Public Service, such increase shall, for the purposes of this section, be added 411 to the school population of such city or town as shown by the last such census estimate and a proper 412 reduction made in the school population of the county or counties from which the annexed territory was 413 acquired.

414 E. Beginning July 1, 2000, of the remaining sales and use tax revenue, the revenue generated by a 415 two percent sales and use tax, up to an annual amount of \$13 million, collected from the sales of 416 hunting equipment, auxiliary hunting equipment, fishing equipment, auxiliary fishing equipment, 417 wildlife-watching equipment, and auxiliary wildlife-watching equipment in Virginia, as estimated by the 418 most recent U.S. Department of the Interior, Fish and Wildlife Service and U.S. Department of 419 Commerce, Bureau of the Census National Survey of Fishing, Hunting, and Wildlife-Associated Recreation, shall be paid into the Game Protection Fund established under § 29.1-101 and shall be used, 420 in part, to defray the cost of law enforcement. Not later than 30 days after the close of each quarter, the 421 Comptroller shall transfer to the Game Protection Fund the appropriate amount of collections to be 422

423 dedicated to such Fund. At any time that the balance in the Capital Improvement Fund, established 424 under § 29.1-101.1, is equal to or in excess of \$35 million, any portion of sales and use tax revenues 425 that would have been transferred to the Game Protection Fund, established under § 29.1-101, in excess 426 of the net operating expenses of the Board, after deduction of other amounts which accrue to the Board 427 and are set aside for the Game Protection Fund, shall remain in the general fund until such time as the 428 balance in the Capital Improvement Fund is less than \$35 million.

429 F. 1. Of the net revenue generated from the one-half percent increase in the rate of the state sales 430 and use tax effective August 1, 2004, pursuant to enactments of the 2004 Special Session I of the 431 General Assembly, the Comptroller shall transfer from the general fund of the state treasury to the 432 Public Education Standards of Quality/Local Real Estate Property Tax Relief Fund established under 433 § 58.1-638.1 an amount equivalent to one-half of the net revenue generated from such one-half percent increase as provided in this subdivision. The transfers to the Public Education Standards of 434 Quality/Local Real Estate Property Tax Relief Fund under this subdivision shall be for one-half of the 435 net revenue generated (and collected in the succeeding month) from such one-half percent increase for 436 437 the month of August 2004 and for each month thereafter.

2. For the purposes of the Comptroller making the required transfers under subdivision 1, the Tax
Commissioner shall make a written certification to the Comptroller no later than the twenty-fifth of each
month certifying the sales and use tax revenues generated in the preceding month. Within three calendar
days of receiving such certification, the Comptroller shall make the required transfers to the Public
Education Standards of Quality/Local Real Estate Property Tax Relief Fund.

443 G. If errors are made in any distribution, or adjustments are otherwise necessary, the errors shall be 444 corrected and adjustments made in the distribution for the next quarter or for subsequent quarters.

445 H. The term "net revenue," as used in this section, means the gross revenue received into the general
446 fund or the Transportation Trust Fund of the state treasury under the preceding sections of this chapter,
447 less refunds to taxpayers.

448 2. That Article 4 (§§ 22.1-281 through 22.1-286) of Chapter 14 of Title 22.1 of the Code of Virginia 449 is repealed.

450 3. That the annual cost incurred by the Weldon Cooper Center for Public Service of the 451 University of Virginia in preparing the projected annual estimates required by this act, not to 452 exceed \$115,000, shall be deducted from the amount appropriated for state sales and use tax 453 distribution to localities based on school age population, with the net amount of funding after such 454 payments to be distributed to localities. Funding not to exceed \$115,000 each year shall be 455 transferred from the amount appropriated in Direct Aid to Public Education for state sales and 456 use tax distribution to localities based on school age population to the Weldon Cooper Center for 457 Public Service at the University of Virginia. The Weldon Cooper Center for Public Service at the University of Virginia shall provide the Department of Education with the yearly population 458 459 estimate by June 30 of each year.

460 4. That the estimate of population provided by the Weldon Cooper Center for Public Service at 461 the University of Virginia be used as the basis for apportionment and distribution of sales tax 462 revenues to public school divisions beginning July 1, 2012.
