## **HOUSE BILL NO. 85**

AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the House Committee on Health, Welfare, and Institutions

on January 26, 2010)

(Patron Prior to Substitute—Delegate Marshall, R.G.)

4 5 6 A BILL to amend the Code of Virginia by adding in Article 8.2 of Chapter 2 of Title 32.1 a section 7 numbered 32.1-69.4 and by adding a section numbered 54.1-2403.02, relating to information about 8 umbilical cord blood.

9 Be it enacted by the General Assembly of Virginia:

1. That the Code of Virginia is amended by adding in Article 8.2 of Chapter 2 of Title 32.1 a 10 11 section numbered 32.1-69.4 and by adding a section numbered 54.1-2403.02 as follows: 12

§ 32.1-69.4. Publication of information regarding cord blood education.

In addition to the requirements of § 32.1-69.3, the Commissioner shall make publicly available, by 13 14 posting on the public website of the Department of Health, resources relating to umbilical cord blood 15 that have been developed by the Parent's Guide to Cord Blood Foundation and include the following 16 information:

17 1. An explanation of the potential value and uses of umbilical cord blood, including cord blood cells 18 and stem cells, for individuals who are, as well as individuals who are not, biologically related to a 19 mother or her newborn child.

20 2. An explanation of the differences between using one's own cord blood cells and using related or 21 unrelated cord blood stem cells in the treatment of disease. 22

3. An explanation of the differences between public and private umbilical cord blood banking.

4. The options available to a mother relating to stem cells that are contained in the umbilical cord 23 24 blood after the delivery of her newborn, including (i) donating the stem cells to a public umbilical cord blood bank where facilities are available; (ii) storing the stem cells in a private family umbilical cord 25 26 blood bank for use by immediate and extended family members; (iii) storing the stem cells for immediate 27 or extended family members through a family or sibling donor banking program that provides free 28 collection, processing, and storage where there is an existing medical need; and (iv) discarding the stem 29 cells. 30

5. The medical processes involved in the collection of cord blood.

31 6. Medical or family history criteria that can impact a family's consideration of umbilical cord blood 32 banking, including the likelihood of using a baby's cord blood to serve as a match for a family member 33 who has a medical condition. 34

7. Options for ownership and future use of donated umbilical cord blood.

8. The average cost of public and private umbilical cord blood banking.

36 9. The availability of public and private cord blood banks to Virginians, including (i) a list of public 37 cord blood banks and the hospitals served by such banks; (ii) a list of private cord blood banks that are 38 available; and (iii) the availability of free family banking and sibling donor programs where there is an 39 existing medical need by a family member.

40 10. An explanation of which racial and ethnic groups are in particular need of publicly donated cord 41 blood samples based upon medical data developed by the U.S. Health Resources and Services 42 Administration. 43

*§54.1-2403.02. Prenatal education; cord blood banking.* 

44 Every practitioner licensed pursuant to this subtitle who renders prenatal care, including any holder of a multistate licensure privilege to practice nursing, regardless of the site of such practice, shall, prior to the beginning of his patient's third trimester of pregnancy or, if later, at the first visit of such 45 46 47 pregnant woman to the provider, make available to the patient information developed pursuant to subsection A of § 32.1-69.4 relating to the women's options with respect to umbilical cord blood **48** 49 banking.
