10	Be it enacted by the General Assembly of Virginia: 1. That the Code of Virginia is amended by adding a section numbered 52-6.2 as follows:
12	§ 52-6.2. Volunteer Chaplaincy Program.
13	The Superintendent of State Police shall have the authority to establish a Volunteer Chaplaincy
14	Program, enabling employees of the Department otherwise trained in ministry to serve as volunteer
15	chaplains, without supplemental compensation. Duties of volunteer chaplains shall be established by
16	order of the Superintendent and may include, but are not limited to, providing employees of the
17	Department and their families with spiritual counseling and guidance and providing invocations and
18	benedictions at Department-sanctioned events and ceremonies. In providing such guidance and
19 20	counseling, the volunteer chaplains shall respect and be sensitive to the religious beliefs of the employees and their families. The Superintendent may establish guidelines regarding the selection and
<b>2</b> 0 <b>2</b> 1	general supervision of the volunteer chaplains in the Volunteer Chaplaincy Program; however, the
22	activities and services of each volunteer chaptains in the volunteer chaptainey Program, nowever, the
23	accordance with the dictates of his own conscience. Neither the Department, the Superintendent, or any
24	other Department official, shall prescribe, proscribe, regulate, limit, or otherwise dictate the religious
25	content of the volunteer chaplains' expressions of religious beliefs, prayers, invocations, benedictions,
26	spiritual counseling, or spiritual guidance. Anytime a volunteer chaplain is called upon to provide an
27	invocation or benediction for the purpose of solemnizing a Department-sanctioned event or ceremony
28 29	and a printed agenda or program is distributed at such event or ceremony, a disclaimer shall be included on the agenda or program to acknowledge that the invocation or benediction is the voluntary
<b>3</b> 0	offering of an individual and that the views or beliefs expressed by such individual have not been
31	previously reviewed, approved, sanctioned, or endorsed by the Department. No employee of the
32	Department shall be compelled or required to attend the prayer, invocation, or benediction of a
33	Department-sanctioned event or ceremony.
