That § 22.1-279.3:1 of the Code of Virginia is amended and reenacted as follows: 11 12 § 22.1-279.3:1. Reports of certain acts to school authorities. 13 A. Reports shall be made to the division superintendent and to the principal or his designee on all 14 incidents involving (i) the assault or assault and battery, without bodily injury, of any person on a 15 school bus, on school property, or at a school-sponsored activity; (ii) the assault and battery that results 16 in bodily injury, sexual assault, death, shooting, stabbing, cutting, or wounding of any person, or stalking of any person as described in § 18.2-60.3, on a school bus, on school property, or at a 17 school-sponsored activity; (iii) any conduct involving alcohol, marijuana, a controlled substance, 18 imitation controlled substance, or an anabolic steroid on a school bus, on school property, or at a 19 20 school-sponsored activity, including the theft or attempted theft of student prescription medications; (iv) 21 any threats against school personnel while on a school bus, on school property or at a school-sponsored 22 activity; (v) the illegal carrying of a firearm, as defined in § 22.1-277.07, onto school property; (vi) any 23 illegal conduct involving firebombs, explosive materials or devices, or hoax explosive devices, as 24 defined in § 18.2-85, or explosive or incendiary devices, as defined in § 18.2-433.1, or chemical bombs, 25 as described in § 18.2-87.1, on a school bus, on school property, or at a school-sponsored activity; (vii) 26 any threats or false threats to bomb, as described in § 18.2-83, made against school personnel or 27 involving school property or school buses; or (viii) the arrest of any student for an incident occurring on 28 a school bus, on school property, or at a school-sponsored activity, including the charge therefor. 29 B. Notwithstanding the provisions of Article 12 (§ 16.1-299 et seq.) of Chapter 11 of Title 16.1, 30 local law-enforcement authorities shall report, and the principal or his designee and the division superintendent shall receive such reports, on offenses, wherever committed, by students enrolled at the 31 school if the offense would be a felony if committed by an adult or would be a violation of the Drug 32 Control Act (§ 54.1-3400 et seq.) and occurred on a school bus, on school property, or at a school-sponsored activity, or would be an adult misdemeanor involving any incidents described in 33 34 35 clauses (i) through (viii) of subsection A, and whether the student is released to the custody of his 36 parent or, if 18 years of age or more, is released on bond. For any report concerning an offense that 37 would be an adult misdemeanor involving an incident described in clauses (i) through (viii) of 38 subsection A, local law-enforcement authorities and attorneys for the Commonwealth shall be authorized 39 to disclose information concerning the student's delinquency case, including adjudication and disposition dates and results, to the superintendent of such student's school division, if, in the determination of the 40 41 law-enforcement authority or attorney for the Commonwealth, such disclosure would not jeopardize the investigation or prosecution of the case. Further, any school superintendent who receives notification 42 that a juvenile has committed an act that would be a crime if committed by an adult pursuant to 43 subsection G of § 16.1-260 shall report such information to the principal of the school in which the 44 45 juvenile is enrolled. 46 C. The principal or his designee shall submit a report of all incidents required to be reported 47 pursuant to this section to the superintendent of the school division. The division superintendent shall 48 annually report all such incidents to the Department of Education for the purpose of recording the 49 frequency of such incidents on forms that shall be provided by the Department and shall make such 50 information available to the public. 51 In submitting reports of such incidents, principals and division superintendents shall accurately

indicate any offenses, arrests, or charges as recorded by law-enforcement authorities and required to be reported by such authorities pursuant to subsection B.

A division superintendent who knowingly fails to comply or secure compliance with the reporting requirements of this subsection shall be subject to the sanctions authorized in § 22.1-65. A principal who knowingly fails to comply or secure compliance with the reporting requirements of this section shall be subject to sanctions prescribed by the local school board, which may include, but need not be limited to, demotion or dismissal. 59 The principal or his designee shall also notify the parent of any student involved in an incident 60 required pursuant to this section to be reported, regardless of whether disciplinary action is taken against 61 such student or the nature of the disciplinary action. Such notice shall relate to only the relevant 62 student's involvement and shall not include information concerning other students.

63 Whenever any student commits any reportable incident as set forth in this section, such student shall
64 be required to participate in such prevention and intervention activities as deemed appropriate by the
65 superintendent or his designee. Prevention and intervention activities shall be identified in the local
66 school division's drug and violence prevention plans developed pursuant to the federal Improving
67 America's Schools Act of 1994 (Title IV - Safe and Drug-Free Schools and Communities Act).

D. Except as may otherwise be required by federal law, regulation, or jurisprudence, the principal shall immediately report to the local law-enforcement agency any act enumerated in clauses (ii) through (vii) of subsection A that may constitute a criminal offense and may report to the local law-enforcement agency any incident described in clause (i) of subsection A.

Further, except as may be prohibited by federal law, regulation, or jurisprudence, the principal shall also immediately report any act enumerated in clauses (ii) through (v) of subsection A that may constitute a criminal offense to the parents of any minor student who is the specific object of such act. Further, the principal shall report that the incident has been reported to local law enforcement as required by law and that the parents may contact local law enforcement for further information, if they so desire.

E. A statement providing a procedure and the purpose for the requirements of this section shall be included in school board policies required by § 22.1-253.13:7.

80 The Board of Education shall promulgate regulations to implement this section, including, but not81 limited to, establishing reporting dates and report formats.

F. For the purposes of this section, "parent" or "parents" means any parent, guardian or other person having control or charge of a child.

G. This section shall not be construed to diminish the authority of the Board of Education or to diminish the Governor's authority to coordinate and provide policy direction on official communications between the Commonwealth and the United States government.
