4	A BILL to amend and reenact § 15.2-2223.1 of the Code of Virginia, relating to urban development

9 10	Be it enacted by the General Assembly of Virginia:
11	1. That § 15.2-2223.1 of the Code of Virginia is amended and reenacted as follows:
12	§ 15.2-2223.1. Comprehensive plan to include urban development areas; new urbanism.
13	A. For purposes of this section:
14	"Commercial" means property devoted to usual and customary business purposes for the sale of
15	goods and services and includes, but is not limited to, retail operations, hotels, motels and offices. "Commercial" does not include residential dwelling units, including apartments and condominiums, or
16 17	agricultural or forestal production, or manufacturing, processing, assembling, storing, warehousing, or
18	distributing.
19	"Commission" means the Commission on Local Government.
20	"Developable acreage," for the purposes of calculating density within the urban development area,
21	means land that is not included in (i) existing parks, rights-of-way of arterial and collector streets,
22 23	railways, and public utilities and (ii) other existing public lands and facilities. "Population growth" means the difference in population from the next-to-latest to the latest decennial
23 24	census year, based on population reported by the United States Bureau of the Census. In computing its
25	population growth, a locality may exclude the inmate population of any new or expanded correctional
26	facility that opened within the time period between the two censuses.
27	"Urban development area" means an area designated by a locality that is (i) appropriate for higher
28 29	density development due to its proximity to transportation facilities, the availability of a public or community water and sewer system, or a developed area and (ii) to the extent feasible, to be used for
30	redevelopment or infill development.
31	B. Every county, city, or town locality that has adopted zoning pursuant to Article 7 (§ 15.2-2280 et
32	seq.) of Chapter 22 of Title 15.2 this chapter and that (i) has a population of at least 20,000 and
33 34	population growth of at least 5% <i>five percent</i> or (ii) has population growth of 15% 15 percent or more, shall, and any county, city or town locality may, amend its comprehensive plan to incorporate one or
35	more urban development areas. For purposes of this section, population growth shall be the difference in
36	population from the next-to-latest to the latest decennial census year, based on population reported by
37	the United States Bureau of the Census. For purposes of this section, an urban development area is an
38	area designated by a locality that is appropriate for higher density development due to proximity to
39 40	transportation facilities, the availability of a public or community water and sewer system, or proximity to a city, town, or other developed area.
4 1	<i>1.</i> The comprehensive plan of a locality having a population of less than 50,000 persons shall
42	provide for commercial and residential densities within urban development areas that are appropriate for
43	reasonably compact development at a density on the developable acreage of at least four residential
44 45	single-family residences, six townhouses, or 12 apartments, condominium units, or cooperative units per
45 46	gross acre, and a minimum an authorized floor area ratio of 0.4 per gross acre for commercial development, or any proportional combination thereof.
47	The urban development areas may provide for a mix of residential housing types, including
48	affordable housing, to meet the projected family income distributions of future residential growth.
49	The comprehensive plan of a locality having a population of 50,000 or more persons shall provide
50 51	for urban development areas that are appropriate for development at a density on the developable
51 52	acreage of at least eight single-family residences, 12 townhouses, or 24 apartments, condominium units, or cooperative units per acre, and an authorized floor area ratio of at least 0.8 per acre for commercial
52 53	development, or any proportional combination thereof.
54	2. The comprehensive plan shall designate one or more urban development areas designated by a
55	locality shall be sufficient to meet projected residential and commercial growth in the locality for an
56	ensuing period of at least 10 but not more than 20 years, which may include phasing of development
57 58	within the urban development areas. Future <i>residential and commercial</i> growth shall be based on official estimates and projections of the Weldon Cooper Center for Public Service of the University of Virginia
50	estimates and projections of the wordon cooper center for rubic service of the Oniversity of Virginia

or other official government sources projections of the Virginia Employment Commission or the United
 States Bureau of the Census.

3. The boundaries and size of each urban development area shall be reexamined and, if necessary, revised every five years in conjunction with the update review of the comprehensive plan and in accordance with the most recent available population growth estimates and projections. Such districts may be areas designated for redevelopment or infill development.

4. The boundaries of each urban development area shall be identified in the locality's comprehensive plan and shall be shown on future land use maps contained in such comprehensive plan.

B5. The comprehensive plan shall further incorporate principles of new urbanism and traditional 67 neighborhood for development in the urban development area, which may include but need not be **68** limited to (i) pedestrian-friendly road design, (ii) interconnection of new local streets with existing local 69 70 streets and roads, (iii) connectivity of road and pedestrian networks, (iv) preservation of natural areas, 71 (v) satisfaction of requirements for stormwater management, (vi) mixed-use neighborhoods, including mixed housing types, (vii) with affordable housing to meet the projected family income distributions of 72 73 future residential growth, (vi) reduction of front and side yard building setbacks, and (viii) (vii) 74 reduction of subdivision street widths and turning radii at subdivision street intersections.

C6. The comprehensive plan shall describe any financial and other incentives for development in the urban development areas.

77 7. A portion of one or more urban development areas shall be designated as a receiving area for 78 any transfer of development rights program established by the locality.

79 DC. No county, city, or town locality that has amended its comprehensive plan in accordance with
80 this section shall limit or prohibit development pursuant to existing zoning or shall refuse to consider
81 any application for rezoning based solely on the fact that the property is located outside the urban development area.

ED. Any county, city, or town locality that would be required to amend its plan pursuant to this
 section subsection B that determines that its plan accommodates growth in a manner consistent with this
 section subsection B, upon adoption of a resolution certifying describing such compliance
 accommodation and describing any financial and other incentives for development in the areas that
 accommodate such growth, shall not be required to further amend its plan pursuant to subsection B.

E. Localities shall consult with adjacent localities, as well as the relevant planning district
 commission and metropolitan planning organization, in establishing the appropriate size and location of
 urban development areas to promote orderly and efficient development of their region.

91 F. Any county that amends its comprehensive plan pursuant to this section subsection B may, by agreement made pursuant to Chapter 34 (§ 15.2-3400 et seq.), designate one or more urban development 92 93 areas in any incorporated town within such county, if the governing body council of the town has also 94 amended its comprehensive plan to designate the same areas as urban development areas with at least the same density designated by the county. However, if a town has established an urban development 95 area within its corporate boundaries, the county within which the town is located shall not include the 96 97 town's projected population and commercial growth when initially determining or reexamining the size 98 and boundary of any other urban development area within the county.

99 G. To the extent possible, *federal*, state and local transportation, housing, and water and sewer
100 *facility*, economic development, and other public infrastructure funding shall be directed to the urban
101 development area, or in the case of a locality that adopts a resolution pursuant to subsection D, to the
102 area that accommodates growth in a manner consistent with this section.

103 H. Documents describing all urban development area designations, as well as any resolution adopted 104 pursuant to subsection D, together with associated written policies, zoning provisions and other ordinances, and the capital improvement program shall be forwarded, electronically or by other means, 105 to the Commission within 90 days of the adoption or amendment of comprehensive plans and other 106 written policies, zoning provisions and other ordinances. The Commission shall annually report to the 107 108 Governor and General Assembly the overall compliance with this section including densities achieved 109 within each urban development area. Before preparing the initial report, the Commission shall develop an appropriate format in concert with the relevant planning district commission. Other than the 110 111 documents, policies, zoning provisions and other ordinances, resolutions, and the capital improvement program forwarded by the locality, the Commission shall not impose an additional administrative 112 113 burden on localities in preparing the annual report required by this subsection.

I. Any locality that becomes subject to this section due to population growth shall have two years
 following the report of the United States Bureau of the Census made pursuant to P.L. 94-171 to amend
 its comprehensive plan in accordance with this section.
