That §§ 16.1-279.1 and 19.2-152.10 of the Code of Virginia are amended and reenacted as 11 12 follows: 13 § 16.1-279.1. Protective order in cases of family abuse. 14 A. In cases of family abuse, including any case involving an incarcerated or recently incarcerated 15 respondent against whom a preliminary protective order has been issued pursuant to § 16.2-253.1, the 16 court may issue a protective order to protect the health and safety of the petitioner and family or household members of the petitioner. A protective order issued under this section may include any one 17 or more of the following conditions to be imposed on the respondent: 18 19 1. Prohibiting acts of family abuse; 20 2. Prohibiting such contacts by the respondent with the petitioner or family or household members of 21 the petitioner as the court deems necessary for the health or safety of such persons; 22 3. Granting the petitioner possession of the residence occupied by the parties to the exclusion of the 23 respondent; however, no such grant of possession shall affect title to any real or personal property; 24 4. Enjoining the respondent from terminating any necessary utility service to the residence to which 25 the petitioner was granted possession pursuant to subdivision 3 or, where appropriate, ordering the 26 respondent to restore utility services to that residence; 27 5. Granting the petitioner temporary possession or use of a motor vehicle owned by the petitioner 28 alone or jointly owned by the parties to the exclusion of the respondent; however, no such grant of 29 possession or use shall affect title to the vehicle; 30 6. Requiring that the respondent provide suitable alternative housing for the petitioner and, if 31 appropriate, any other family or household member and where appropriate, requiring the respondent to 32 pay deposits to connect or restore necessary utility services in the alternative housing provided; 33 7. Ordering the respondent to participate in treatment, counseling or other programs as the court 34 deems appropriate; and 35 8. Any other relief necessary for the protection of the petitioner and family or household members of the petitioner, including a provision for temporary custody or visitation of a minor child. 36 37 A1. If a protective order is issued pursuant to subsection A of this section, the court may also issue a 38 temporary child support order for the support of any children of the petitioner whom the respondent has 39 a legal obligation to support. Such order shall terminate upon the determination of support pursuant to 40 § 20-108.1. 41 B. The protective order may be issued for a specified period; however, unless otherwise authorized by law, a protective order may not be issued under this section for a period longer than two years. The 42 protective order shall expire at 11:59 p.m. on the last day specified or at 11:59 p.m. on the last day of 43 the two-year period if no date is specified. Prior to the expiration of the protective order, a petitioner 44 may request that the court extend the protective order. The order may be extended for a period not 45 46 longer than one year if the respondent continues to pose a threat to the health and safety of the 47 petitioner and family or household members of the petitioner at the time the request for an extension is made. The extension of the protective order shall expire at 11:59 p.m. on the last day specified or at 48 49 11:59 p.m. on the last day of the one-year period if no date is specified. Nothing herein shall limit the 50 number of extensions that may be requested or issued. 51 C. A copy of the protective order shall be served on the respondent and provided to the petitioner as 52 soon as possible. The court shall forthwith, but in all cases no later than the end of the business day on 53 which the order was issued, enter and transfer electronically to the Virginia Criminal Information Network the respondent's identifying information and the name, date of birth, sex, and race of each 54 55 protected person provided to the court and shall forthwith forward the attested copy of the protective 56 order containing any such identifying information to the primary law-enforcement agency responsible for

57 service and entry of protective orders. Upon receipt of the order by the primary law-enforcement agency, 58 the agency shall forthwith verify and enter any modification as necessary to the identifying information

59 and other appropriate information required by the Department of State Police into the Virginia Criminal 60 Information Network established and maintained by the Department pursuant to Chapter 2 (§ 52-12 et seq.) of Title 52 and the order shall be served forthwith upon the respondent and due return made to the 61 court. However, if the order is issued by the circuit court, the clerk of the circuit court shall forthwith 62 63 forward an attested copy of the order containing the respondent's identifying information and the name, 64 date of birth, sex, and race of each protected person provided to the court to the primary 65 law-enforcement agency providing service and entry of protective orders and upon receipt of the order, 66 the primary law-enforcement agency shall enter the name of the person subject to the order and other appropriate information required by the Department of State Police into the Virginia Criminal 67 Information Network established and maintained by the Department pursuant to Chapter 2 (§ 52-12 et 68 69 seq.) of Title 52 and the order shall be served forthwith upon the respondent. Upon service, the agency making service shall enter the date and time of service and other appropriate information required by the 70 71 Department of State Police into the Virginia Criminal Information Network and make due return to the 72 court. If the order is later dissolved or modified, a copy of the dissolution or modification order shall 73 also be attested, forwarded forthwith to the primary law-enforcement agency responsible for service and 74 entry of protective orders, and upon receipt of the order by the primary law-enforcement agency, the 75 agency shall forthwith verify and enter any modification as necessary to the identifying information and other appropriate information required by the Department of State Police into the Virginia Criminal 76 77 Information Network as described above and the order shall be served forthwith and due return made to 78 the court. The provisions of this subsection shall apply to any extension of a protective order issued 79 pursuant to subsection B.

80 CD. Except as otherwise provided in § 16.1-253.2, a violation of a protective order issued under this 81 section shall constitute contempt of court.

DE. The court may assess costs and attorneys' fees against either party regardless of whether an 82 83 order of protection has been issued as a result of a full hearing.

84 EF. Any judgment, order or decree, whether permanent or temporary, issued by a court of appropriate jurisdiction in another state, the United States or any of its territories, possessions or 85 86 Commonwealths, the District of Columbia or by any tribal court of appropriate jurisdiction for the purpose of preventing violent or threatening acts or harassment against or contact or communication 87 88 with or physical proximity to another person, including any of the conditions specified in subsection A, 89 shall be accorded full faith and credit and enforced in the Commonwealth as if it were an order of the 90 Commonwealth, provided reasonable notice and opportunity to be heard were given by the issuing 91 jurisdiction to the person against whom the order is sought to be enforced sufficient to protect such 92 person's due process rights and consistent with federal law. A person entitled to protection under such a foreign order may file the order in any juvenile and domestic relations district court by filing with the court an attested or exemplified copy of the order. Upon such a filing, the clerk shall forthwith forward 93 94 95 an attested copy of the order to the primary law-enforcement agency responsible for service and entry of 96 protective orders which shall, upon receipt, enter the name of the person subject to the order and other appropriate information required by the Department of State Police into the Virginia Criminal 97 98 Information Network established and maintained by the Department pursuant to Chapter 2 (§ 52-12 et 99 seq.) of Title 52. Where practical, the court may transfer information electronically to the Virginia 100 Criminal Information Network.

101 Upon inquiry by any law-enforcement agency of the Commonwealth, the clerk shall make a copy 102 available of any foreign order filed with that court. A law-enforcement officer may, in the performance 103 of his duties, rely upon a copy of a foreign protective order or other suitable evidence which has been 104 provided to him by any source and may also rely upon the statement of any person protected by the 105 order that the order remains in effect.

106 FG. Either party may at any time file a written motion with the court requesting a hearing to 107 dissolve or modify the order. Proceedings to dissolve or modify a protective order shall be given 108 precedence on the docket of the court. 109

GH. As used in this section, "copy" includes a facsimile copy.

HI. Neither a law-enforcement agency, the attorney for the Commonwealth, a court nor the clerk's 110 111 office, nor any employee of them, may disclose, except among themselves, the residential address, 112 telephone number, or place of employment of the person protected by the order or that of the family of 113 such person, except to the extent that disclosure is (i) required by law or the Rules of the Supreme 114 Court, (ii) necessary for law-enforcement purposes, or (iii) permitted by the court for good cause.

115 LJ. No fee shall be charged for filing or serving any petition or order pursuant to this section.

116 § 19.2-152.10. Protective order in cases of stalking, sexual battery and acts of violence.

117 A. The court may issue a protective order pursuant to this chapter to protect the health and safety of the petitioner and family or household members of a petitioner upon (i) the issuance of a warrant for 118 119 sexual battery in violation of § 18.2-67.4, aggravated sexual battery in violation of § 18.2-67.3, a criminal offense resulting in a serious bodily injury to the petitioner, or a violation of § 18.2-60.3, (ii) a 120

hearing held pursuant to subsection D of § 19.2-152.9, or (iii) a conviction for sexual battery in violation of § 18.2-67.4, aggravated sexual battery in violation of § 18.2-67.3, a criminal offense resulting in a serious bodily injury to the petitioner, or a violation of § 18.2-60.3. A protective order issued under this section may include any one or more of the following conditions to be imposed on the respondent:

125 1. Prohibiting criminal offenses that may result in injury to person or property, acts of sexual battery,126 or acts of stalking in violation of § 18.2-60.3;

127 2. Prohibiting such contacts by the respondent with the petitioner or family or household members of128 the petitioner as the court deems necessary for the health or safety of such persons; and

129 3. Any other relief necessary to prevent criminal offenses that may result in injury to person or130 property, acts of sexual battery, or acts of stalking, communication or other contact of any kind by the131 respondent.

132 B. The protective order may be issued for a specified period; however, unless otherwise authorized 133 by law, a protective order may not be issued under this section for a period longer than two years. The 134 protective order shall expire at 11:59 p.m. on the last day specified or at 11:59 p.m. on the last day of 135 the two-year period if no date is specified. Prior to the expiration of the protective order, a petitioner 136 may request that the court extend the protective order. The order may be extended for a period not 137 longer than one year if the respondent continues to pose a threat to the health and safety of the 138 petitioner and family or household members of the petitioner at the time the request for an extension is 139 made. The extension of the protective order shall expire at 11:59 p.m. on the last day specified or at 140 11:59 p.m. on the last day of the one-year period if no date is specified. Nothing herein shall limit the 141 number of extensions that may be requested or issued.

142 C. A copy of the protective order shall be served on the respondent and provided to the petitioner as 143 soon as possible. The court shall forthwith, but in all cases no later than the end of the business day on 144 which the order was issued, enter and transfer electronically to the Virginia Criminal Information 145 Network the respondent's identifying information and the name, date of birth, sex, and race of each protected person provided to the court and shall forthwith forward the attested copy of the protective 146 147 order and containing any such identifying information to the primary law-enforcement agency 148 responsible for service and entry of protective orders. Upon receipt of the order by the primary 149 law-enforcement agency, the agency shall forthwith verify and enter any modification as necessary to the 150 identifying information and other appropriate information required by the Department of State Police 151 into the Virginia Criminal Information Network established and maintained by the Department pursuant 152 to Chapter 2 (§ 52-12 et seq.) of Title 52 and the order shall be served forthwith upon the respondent 153 and due return made to the court. However, if the order is issued by the circuit court, the clerk of the 154 circuit court shall forthwith forward an attested copy of the order containing the respondent's identifying 155 information and the name, date of birth, sex, and race of each protected person provided to the court to 156 the primary law-enforcement agency providing service and entry of protective orders and upon receipt of 157 the order, the primary law-enforcement agency shall enter the name of the person subject to the order 158 and other appropriate information required by the Department of State Police into the Virginia Criminal 159 Information Network established and maintained by the Department pursuant to Chapter 2 (§ 52-12 et 160 seq.) of Title 52 and the order shall be served forthwith on the respondent. Upon service, the agency 161 making service shall enter the date and time of service and other appropriate information required into 162 the Virginia Criminal Information Network and make due return to the court. If the order is later 163 dissolved or modified, a copy of the dissolution or modification order shall also be attested, forwarded 164 forthwith to the primary law-enforcement agency responsible for service and entry of protective orders, 165 and upon receipt of the order by the primary law-enforcement agency, the agency shall forthwith verify and enter any modification as necessary to the identifying information and other appropriate information 166 167 required by the Department of State Police into the Virginia Criminal Information Network as described 168 above and the order shall be served forthwith and due return made to the court. The provisions of this 169 subsection shall apply to any extension of a protective order issued pursuant to subsection B.

170 CD. Except as otherwise provided, a violation of a protective order issued under this section shall
 171 constitute contempt of court.

172 DE. The court may assess costs and attorneys' fees against either party regardless of whether an order of protection has been issued as a result of a full hearing.

174 EF. Any judgment, order or decree, whether permanent or temporary, issued by a court of 175 appropriate jurisdiction in another state, the United States or any of its territories, possessions or 176 Commonwealths, the District of Columbia or by any tribal court of appropriate jurisdiction for the 177 purpose of preventing violent or threatening acts or harassment against or contact or communication 178 with or physical proximity to another person, including any of the conditions specified in subsection A, 179 shall be accorded full faith and credit and enforced in the Commonwealth as if it were an order of the 180 Commonwealth, provided reasonable notice and opportunity to be heard were given by the issuing jurisdiction to the person against whom the order is sought to be enforced sufficient to protect such 181

182 person's due process rights and consistent with federal law. A person entitled to protection under such a foreign order may file the order in any appropriate district court by filing with the court, an attested or 183 184 exemplified copy of the order. Upon such a filing, the clerk shall forthwith forward an attested copy of 185 the order to the primary law-enforcement agency responsible for service and entry of protective orders which shall, upon receipt, enter the name of the person subject to the order and other appropriate 186 187 information required by the Department of State Police into the Virginia Criminal Information Network 188 established and maintained by the Department pursuant to Chapter 2 (§ 52-12 et seq.) of Title 52. Where 189 practical, the court may transfer information electronically to the Virginia Criminal Information Network.

190 Upon inquiry by any law-enforcement agency of the Commonwealth, the clerk shall make a copy available of any foreign order filed with that court. A law-enforcement officer may, in the performance of his duties, rely upon a copy of a foreign protective order or other suitable evidence which has been provided to him by any source and may also rely upon the statement of any person protected by the order that the order remains in effect.

195 FG. Either party may at any time file a written motion with the court requesting a hearing to
196 dissolve or modify the order. Proceedings to modify or dissolve a protective order shall be given
197 precedence on the docket of the court.

198 GH. Neither a law-enforcement agency, the attorney for the Commonwealth, a court nor the clerk's
199 office, nor any employee of them, may disclose, except among themselves, the residential address,
200 telephone number, or place of employment of the person protected by the order or that of the family of
201 such person, except to the extent that disclosure is (i) required by law or the Rules of the Supreme
202 Court, (ii) necessary for law-enforcement purposes, or (iii) permitted by the court for good cause.

203 HI. No fees shall be charged for filing or serving petitions pursuant to this section.
