4. Title: Staffing for certain legislative study commissions.

5. Summary: HB 1053 provides that staffing support for the Virginia State Crime Commission, the Joint Commission on Health Care, the Virginia Commission on Youth, and the Virginia Housing Commission will be provided by the Division of Legislative Services and Clerks Offices of the General Assembly.

7. Budget Amendment Necessary: Yes, Items 6, 11, 17, and 18 of HB/SB 30, the budget bill in the 2010 Session of the General Assembly

8. Fiscal Implications:

The fiscal implications of this bill fall into three categories:

- 1. Savings from reducing the funding for the four commissions to an amount that only leaves \$21,000 each year for each commission to cover per diem costs.
- 2. The severance cost for the staff employed by the commissions.
- 3. The additional cost for the Division of Legislative Services and the Clerks' Offices for the House and Senate.

Row six of the following table shows the anticipated savings from the commissions by shifting the staff support to the Division of Legislative Services (DLS). The amounts in rows one through six are based on two assumptions.

1. Only \$21,000 each year will remain in each commission to pay the cost of per diems. This is evident now in the Virginia Housing Commission, which has an appropriation of \$20,975 (GF) each year for per diems. The appropriation was reduced about four years ago when DLS took over staff support for the Housing Commission. The Joint Commission on Health Care is currently scheduled to sunset on July 1, 2012 (see §30-170, Virginia Code). However, these numbers assume the commission will be continued.

Transferring support to DLS allows for the reduction of 14.00 full-time equivalent positions, 12 of which are filled. Staff at DLS calculated the severance cost for the filled positions and came up with the total of \$528,623, as show on Line 9 of the following table. The costs are for severance under the Workforce Transition Act (Title 2.2, Ch 32) and leave payout. The actual amount will not be known until any severance occurs due to options available to employees and the actual amount of accrued leave that is being paid for.

The bill provides for DLS to provide staff support to the commissions. Staff at DLS estimates they need \$250,000 (GF) and three professional positions. The Senate Clerk's Office reports it doesn't need any additional resources if the bill is implemented; however, the House Clerk's Office may need one position. The cost of that position is not included in the fiscal impact at this time.
