**3. Committee:** Passed both houses.

**4. Title:**            **Saltwater recreational fishing; conformance with national registry.**

**5. Summary:** This bill directs the Virginia Marine Resources Commission to establish the Fisherman Identification Program, which is to be consistent with the National Saltwater Angler Registry Program. In order to pay for the program, a one-time fee increase of not more than \$10 will be placed on the saltwater recreational boat license. Those persons who purchase a saltwater fishing license are not required to register with the program.

**7. Budget Amendment Necessary:** Yes, item 376. However, any budget amendment for nongeneral funds may be made administratively.

- 8. Fiscal Implications:** This bill authorizes Virginia Marine Resources Commission (MRC) to collect all the federally required data necessary to become exempt as a state from the federal registration requirements and registration costs for anglers.

Those individuals who purchase Virginia saltwater fishing licenses will be required to furnish the federally required data when they purchase a recreational license. Individuals who fish legally without a license will be required to register with MRC, provide their contact and the other information required by the National Saltwater Registry, and receive a Virginia fisherman identification number to carry with them while fishing.

As a result of this bill, Virginia's current license structure will remain unchanged. All current exemptions from having to purchase saltwater fishing licenses will remain intact.

Saltwater license fees, however, may increase. MRC expects the administration cost of the Virginia Fisherman Identification Program to be about \$650,000 per year. Per the authority granted in this bill, MRC may raise the cost of the annual boat license by a one-time fee increase of no more than \$10 in addition to raising other annual licenses by \$5 in accordance with §28.2-201. 4., Code of Virginia. This increase in revenue is expected to cover the increased administrative cost to the agency.
